DESCRIPTION

FIG. 1 is a side, top, perspective view of a pen showing our new;

FIG. 2 is a left side view thereof, the right side view being a mirror image of the left side view;

FIG. 3 is a top view thereof;

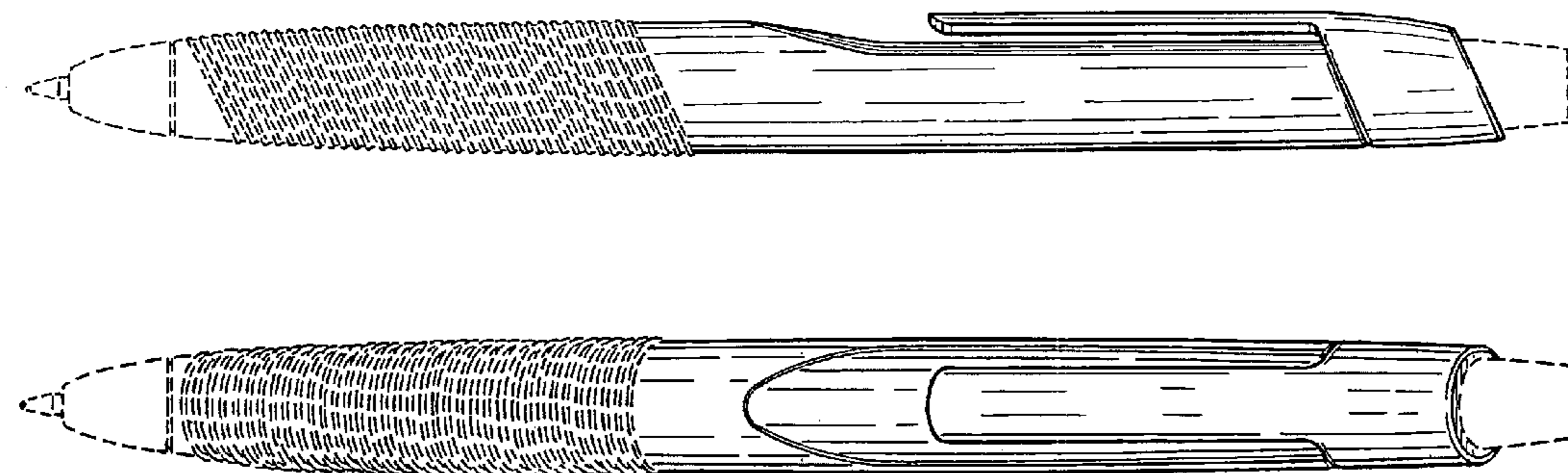
FIG. 4 is a bottom view thereof;

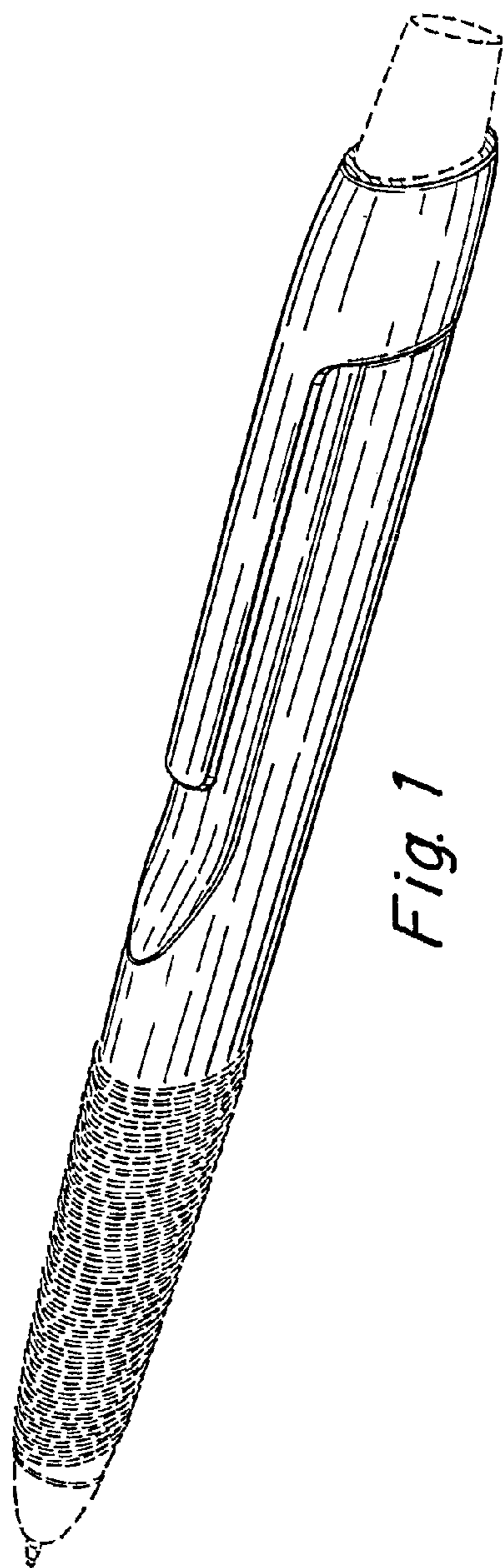

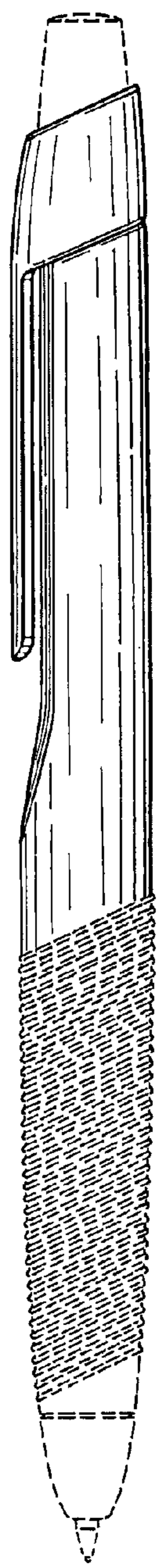

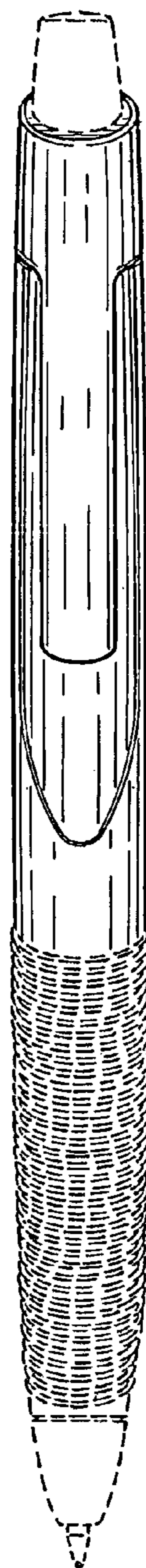

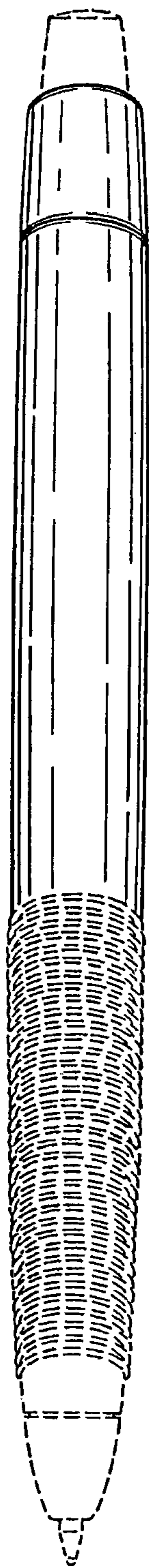

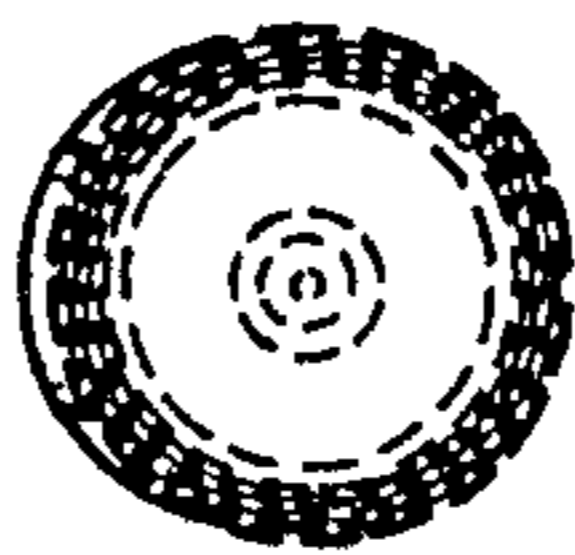

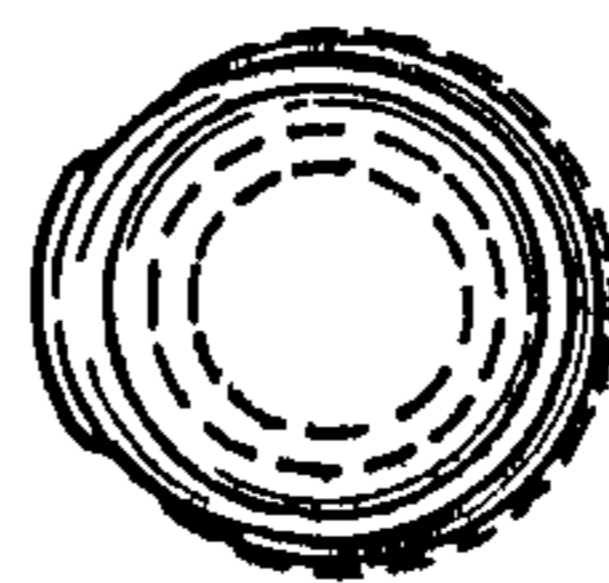
