FIG. 1 is a top view of a design for a kitchen according to the present disclosure.

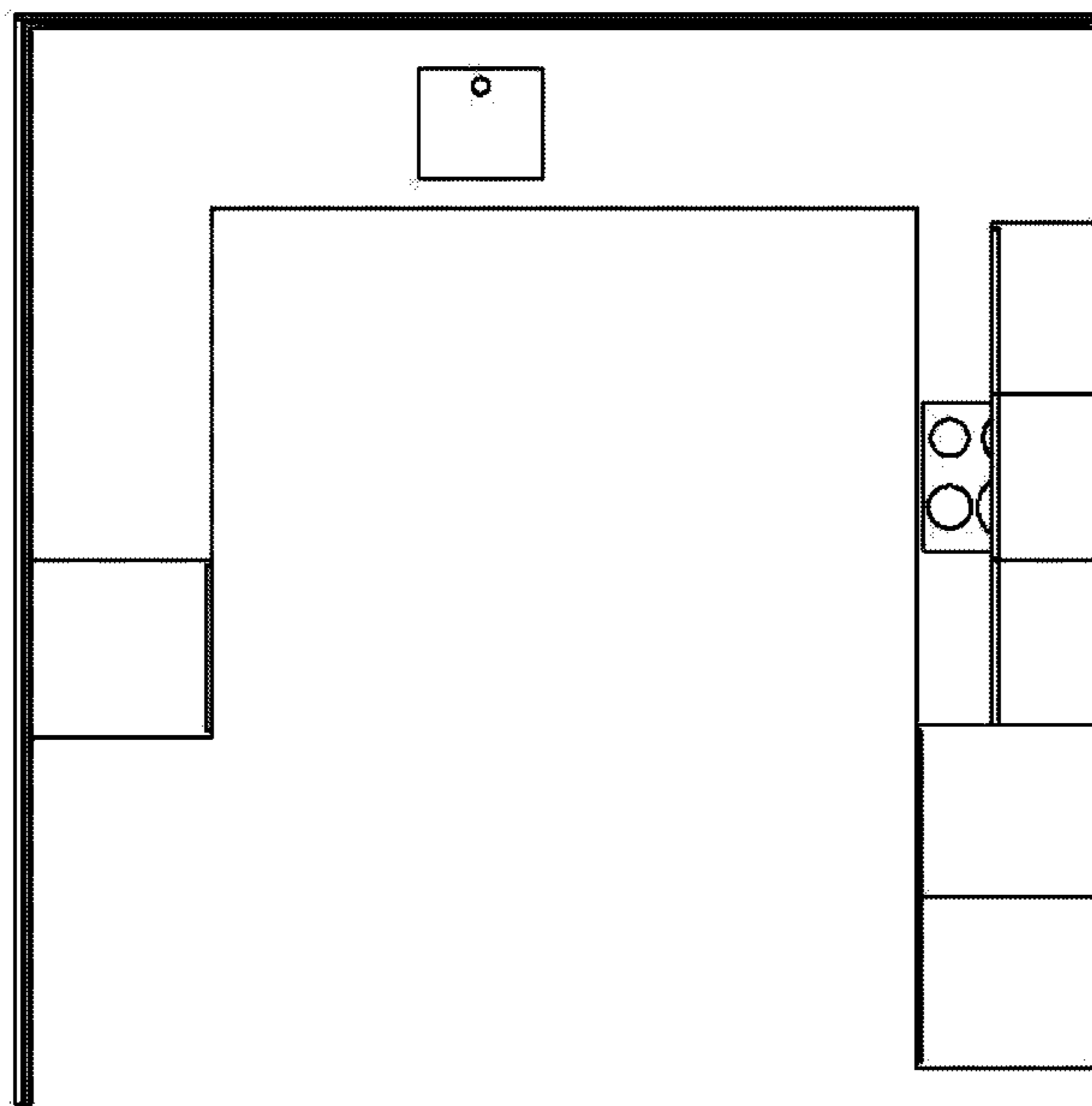
FIG. 2 is a top-front perspective view of the kitchen of FIG. 1.

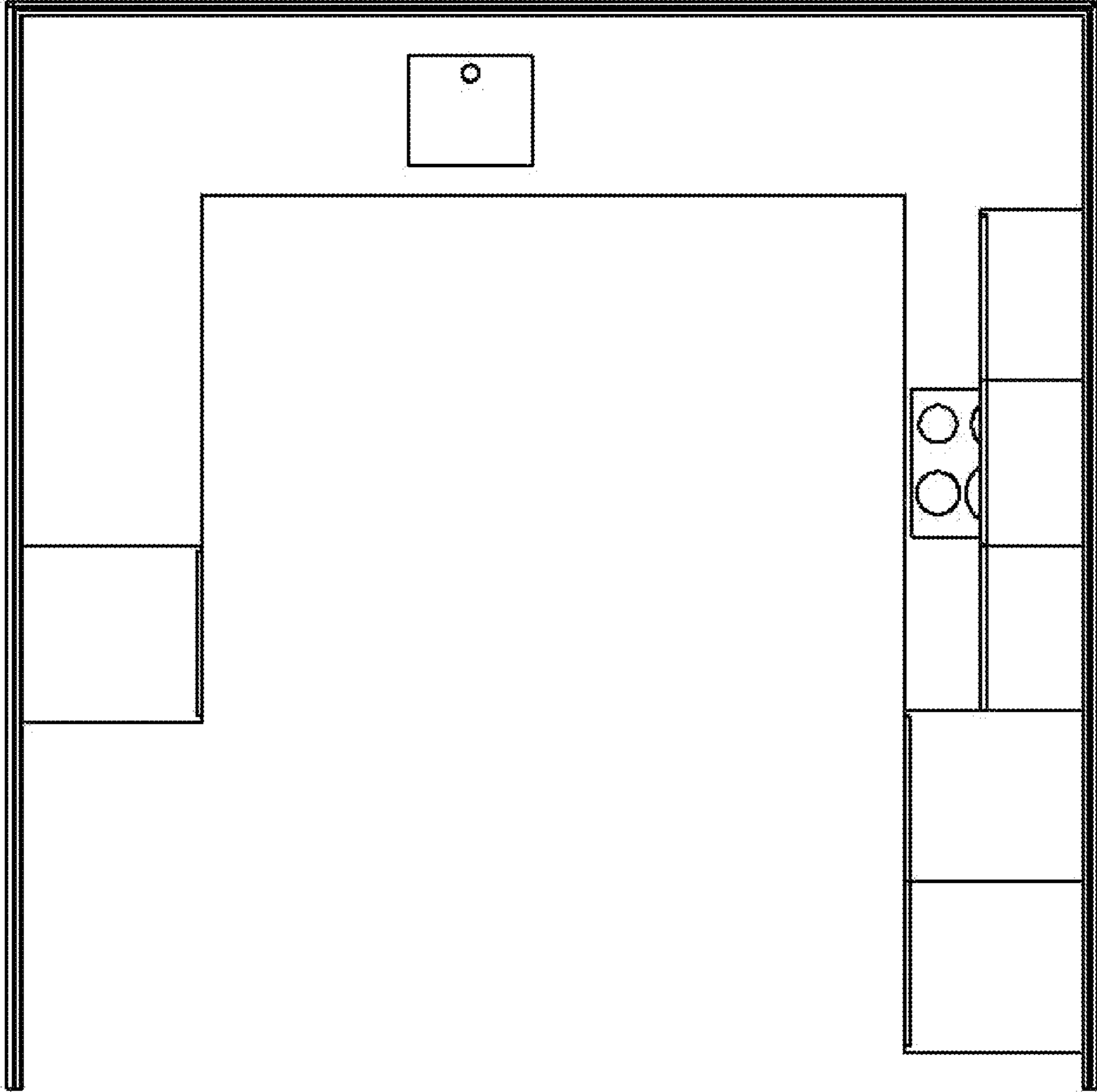

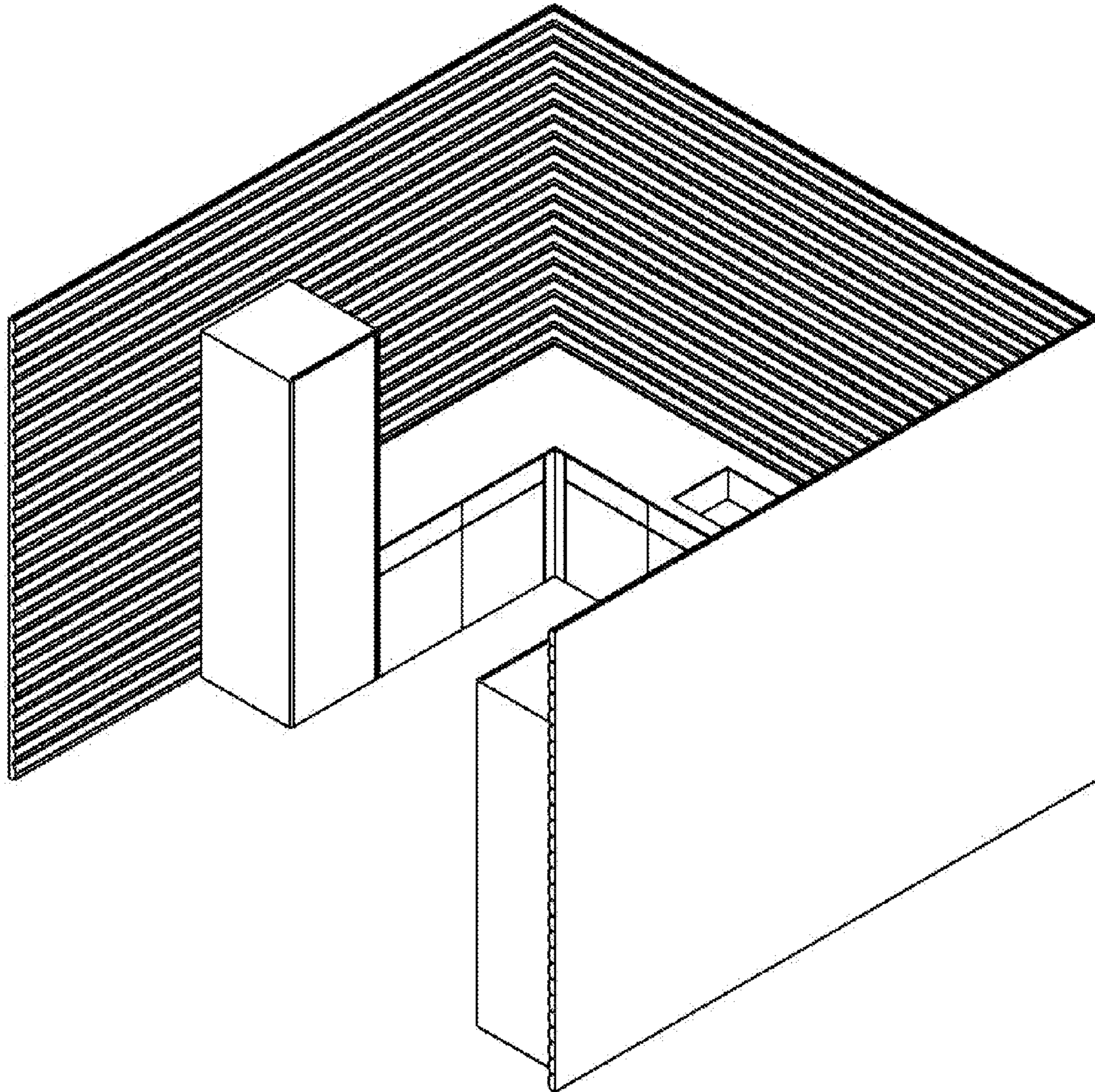

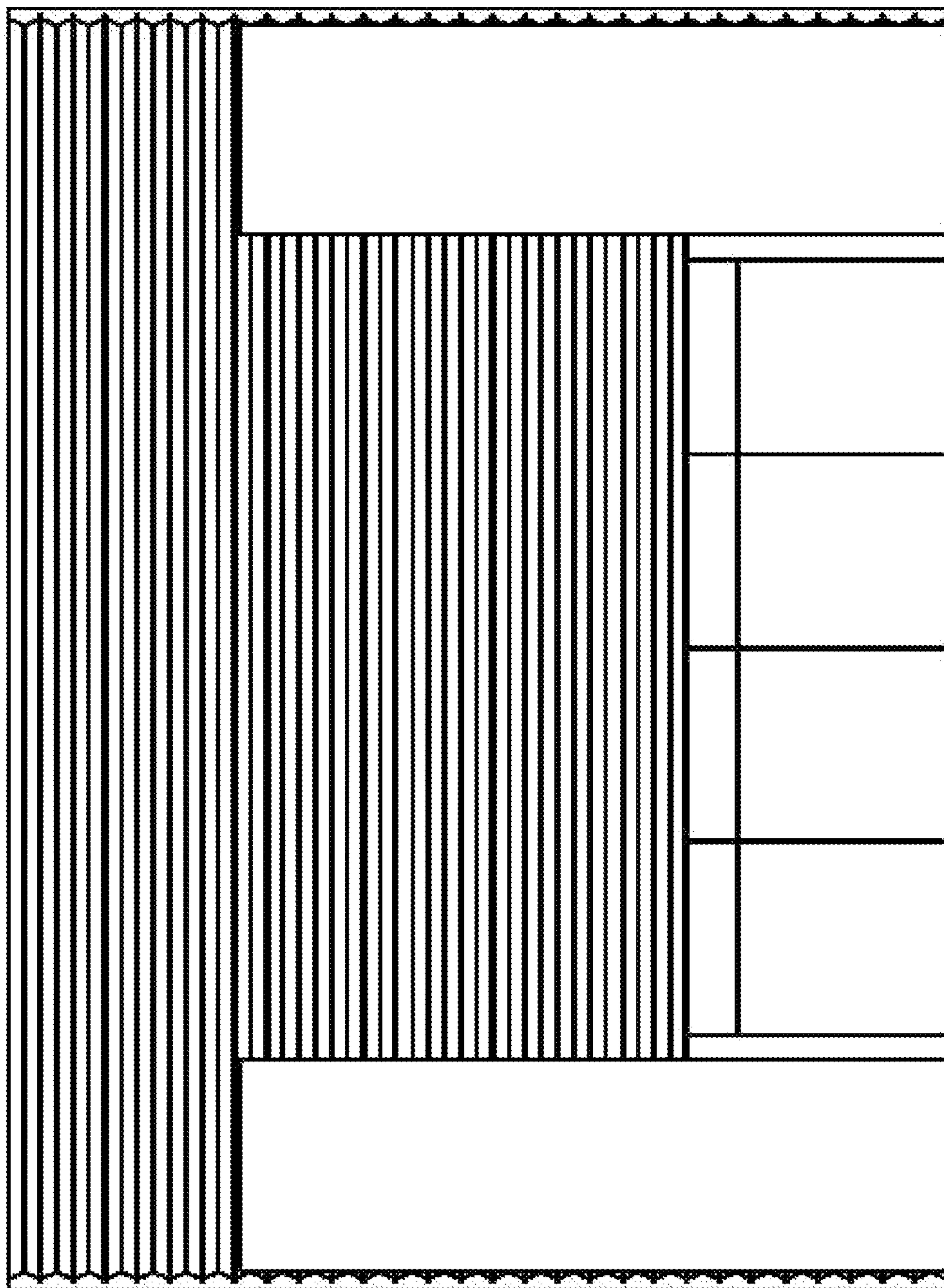

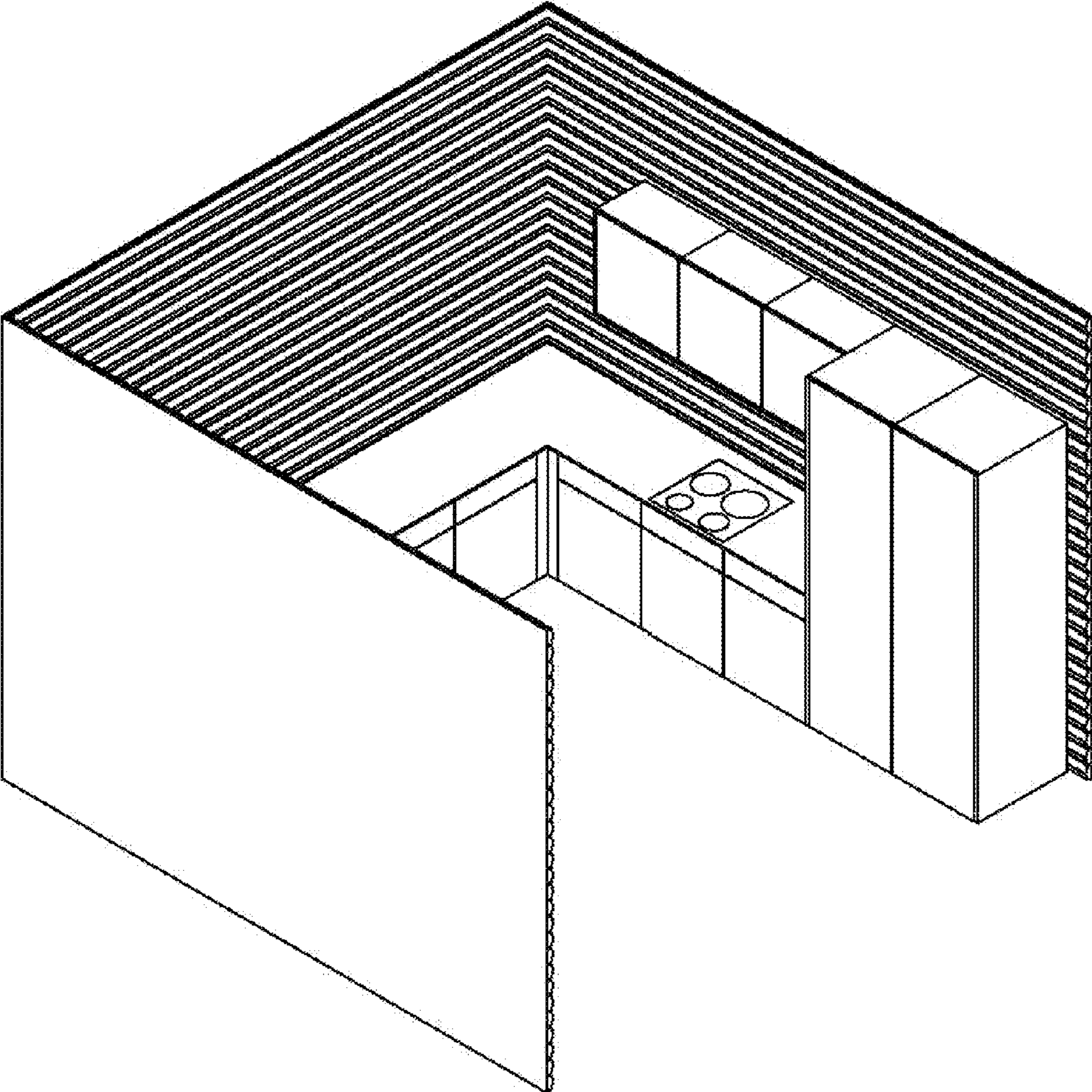
