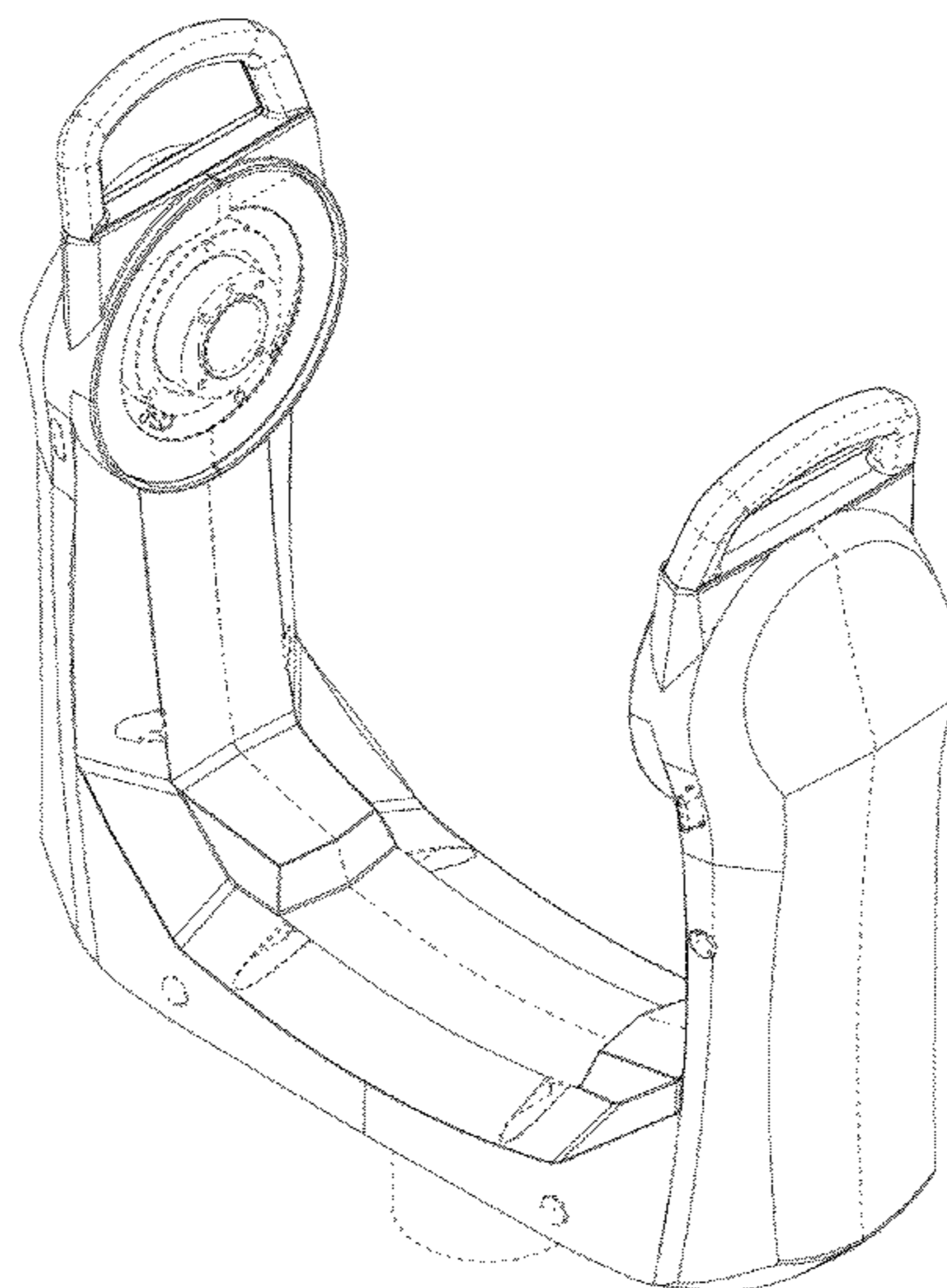

(57) **CLAIM**
I claim an ornamental design for a yoke for a lighting fixture,
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the yoke for a lighting fixture
of the present design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a front view thereof; and,
FIG. 7 is a rear view thereof.
The dashed lines shown in the figures illustrating portions of
the lighting fixture form no part of the claimed design.

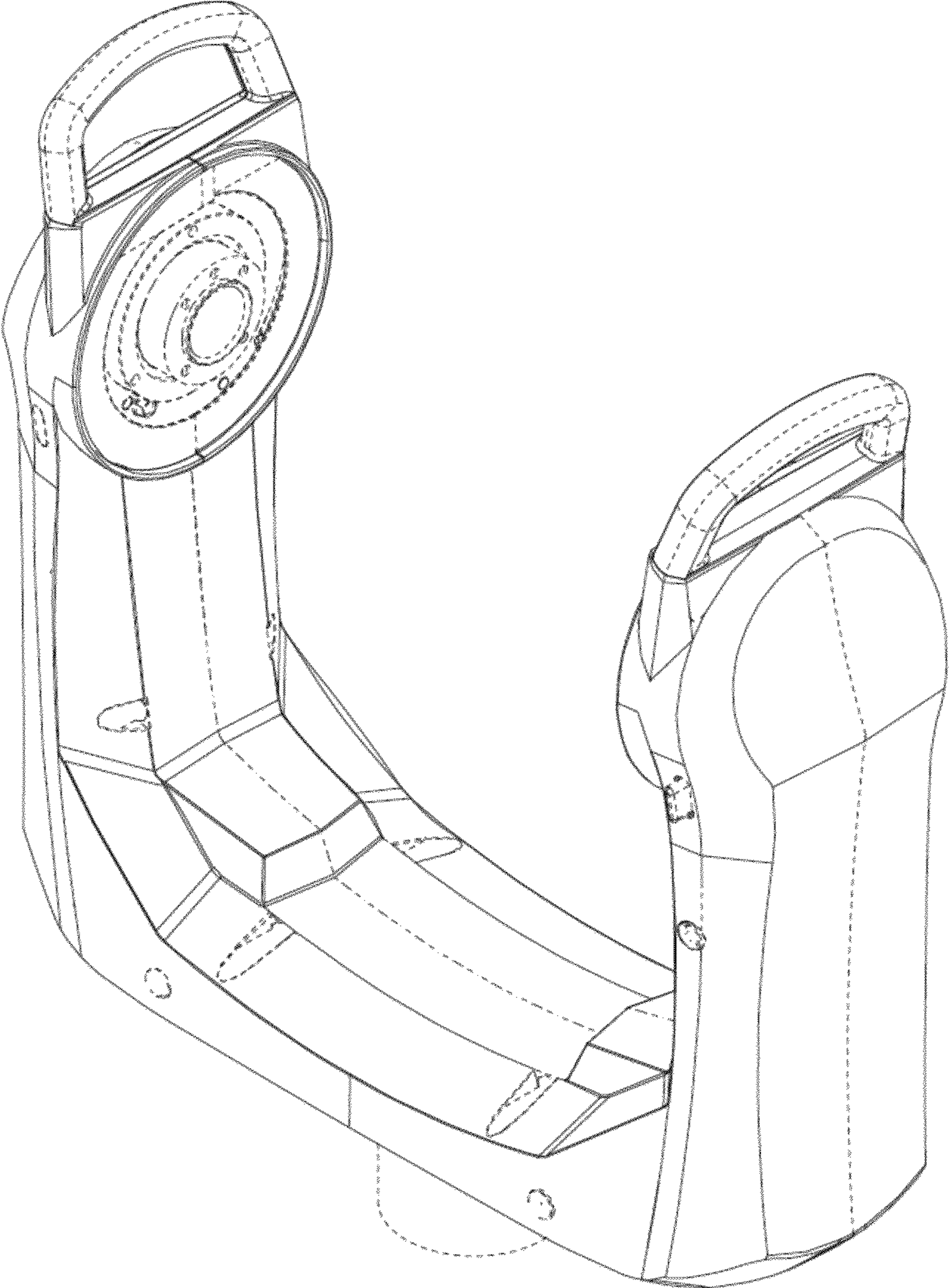

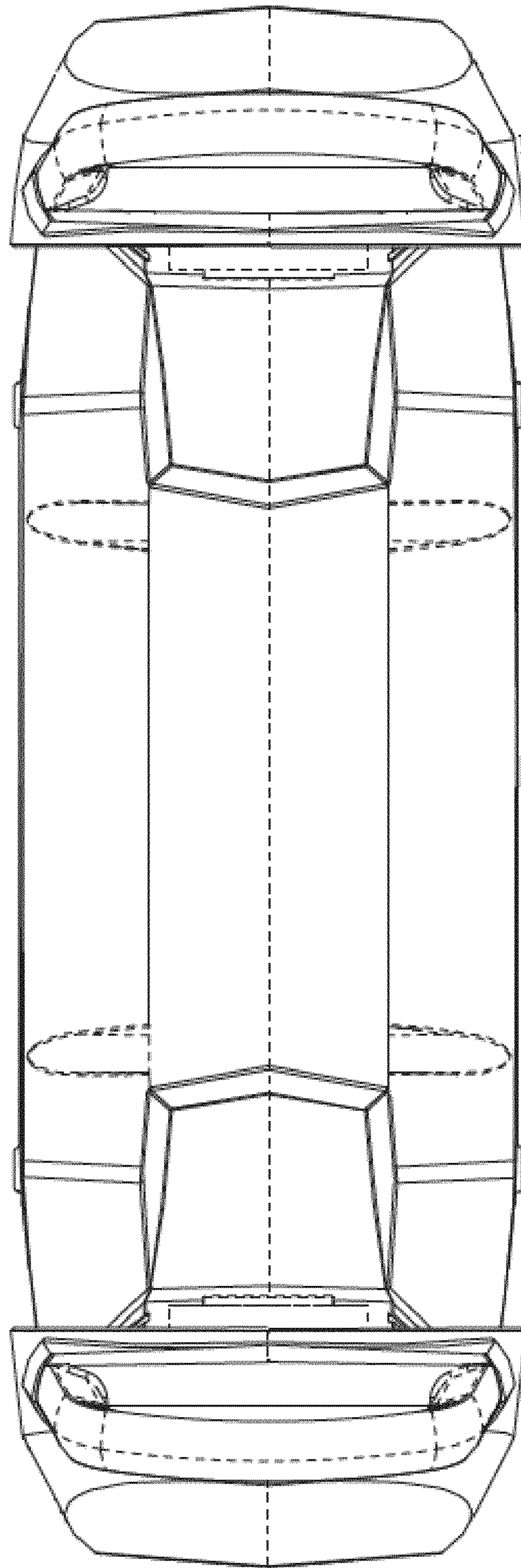

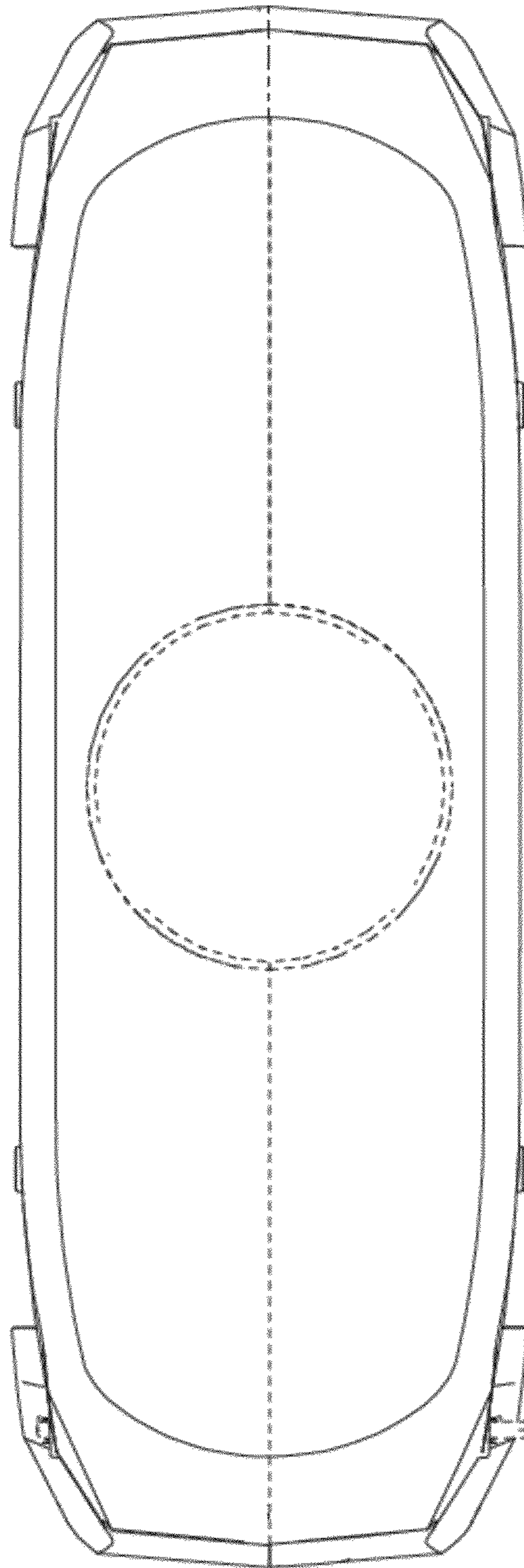

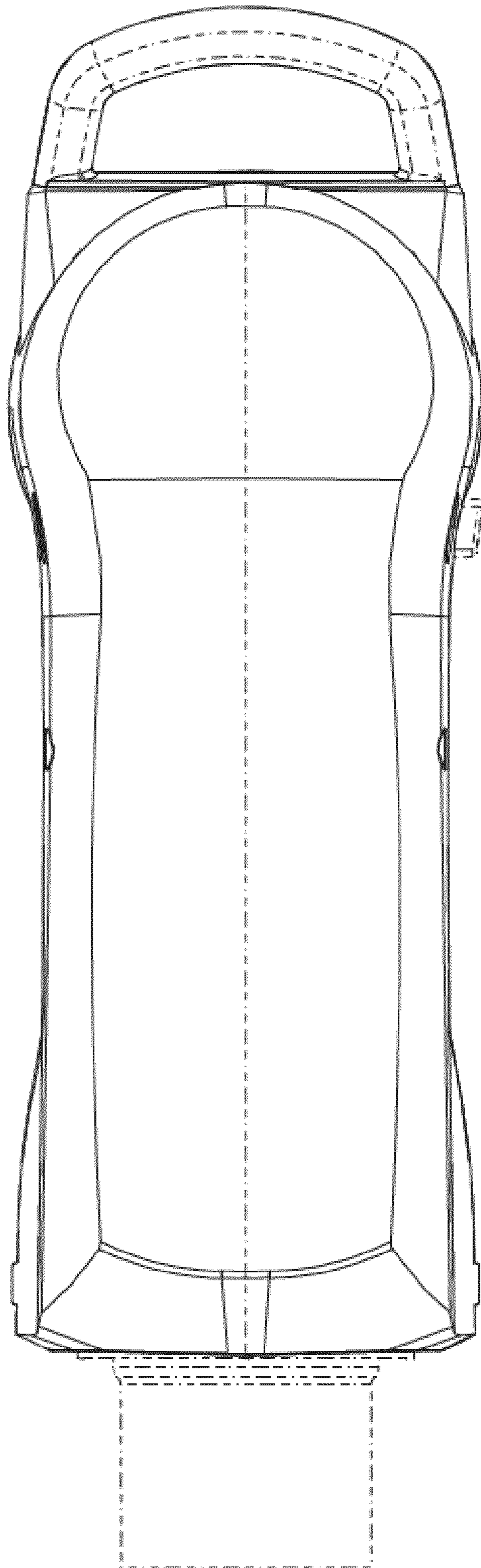

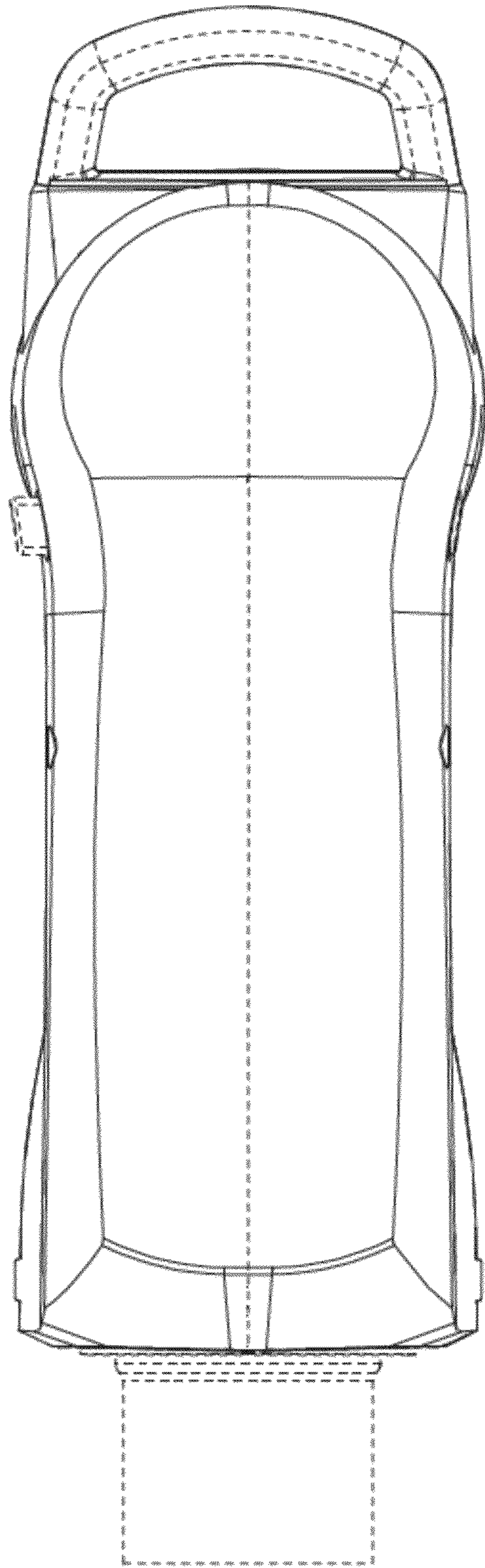

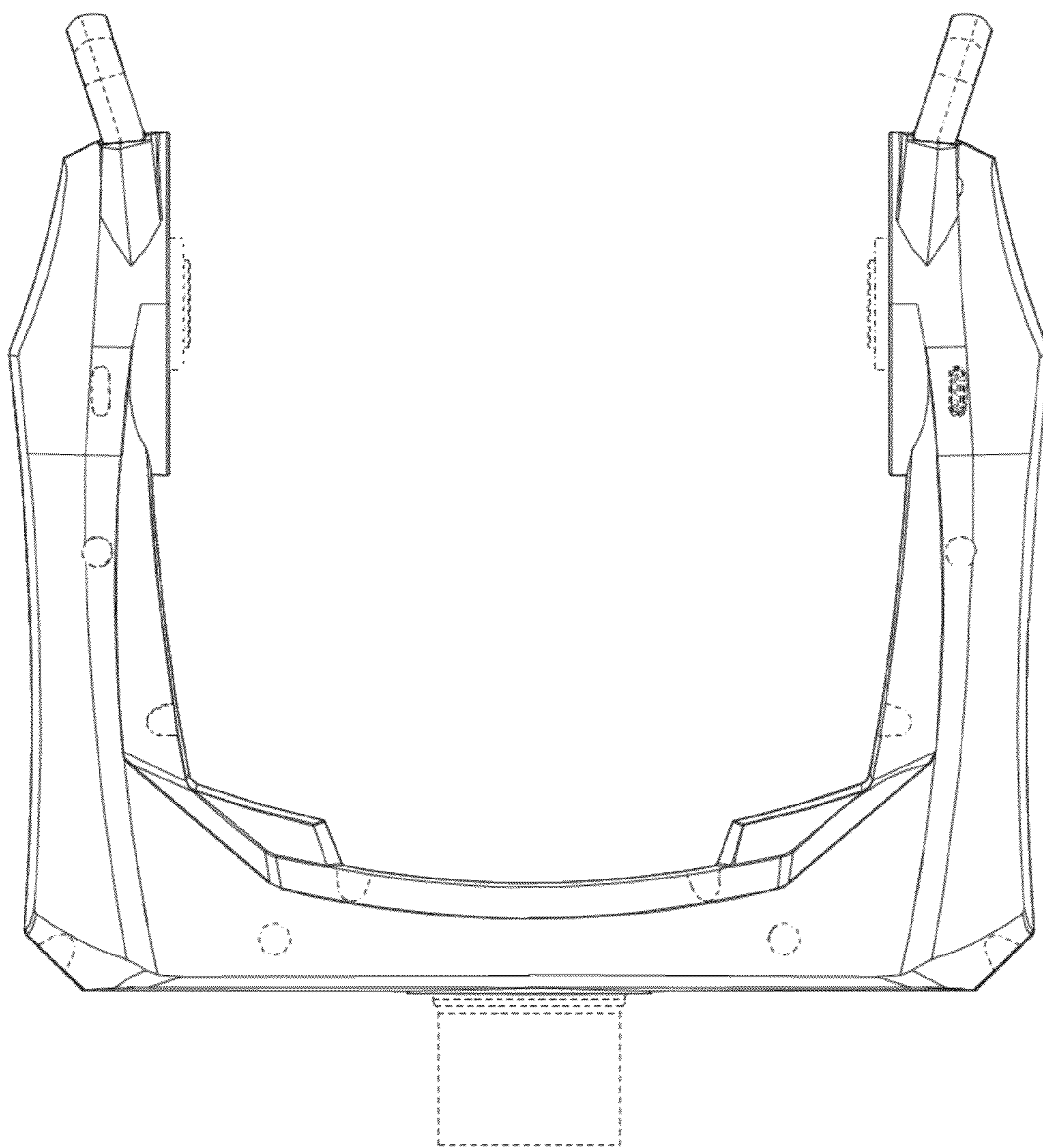

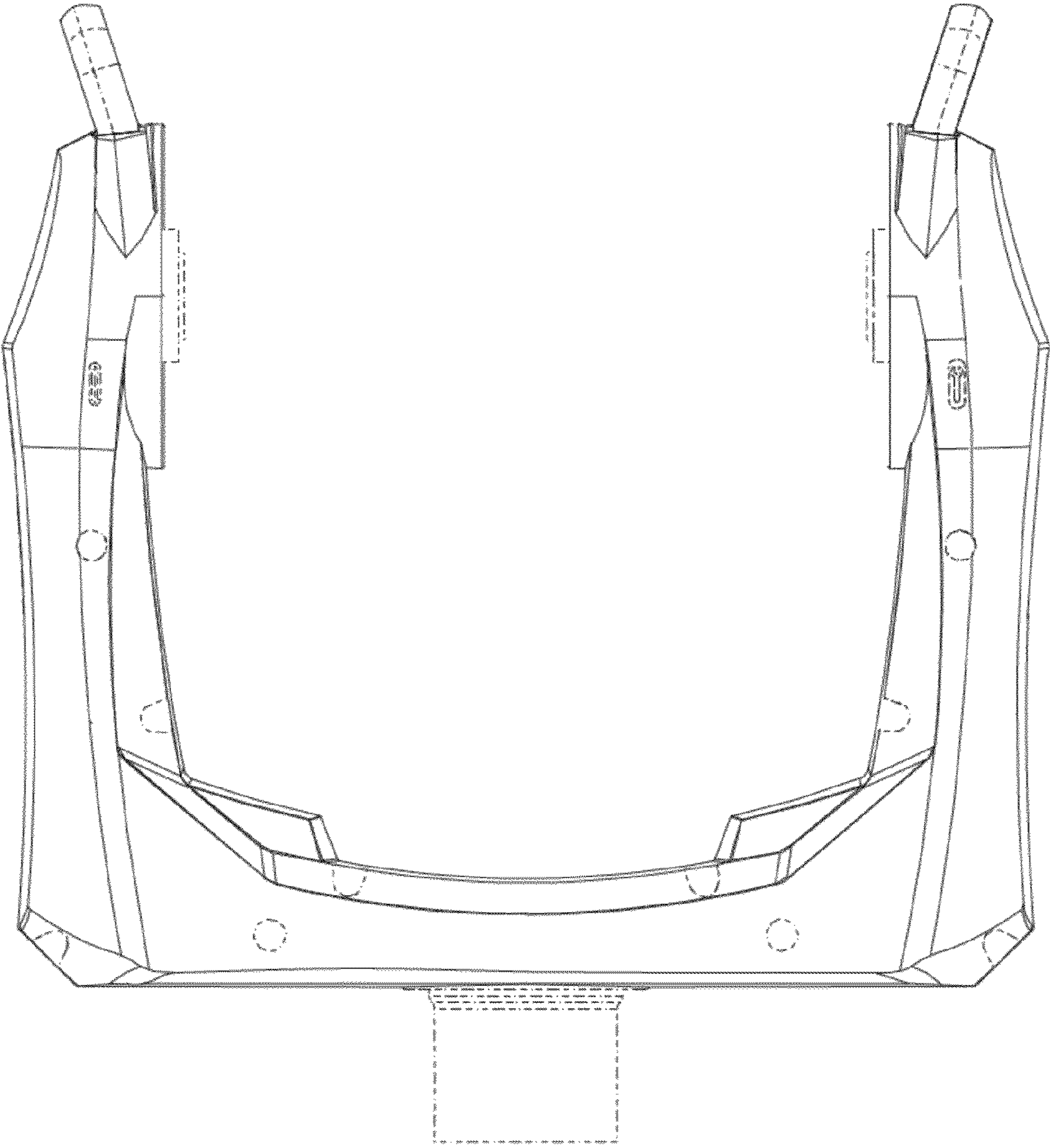
