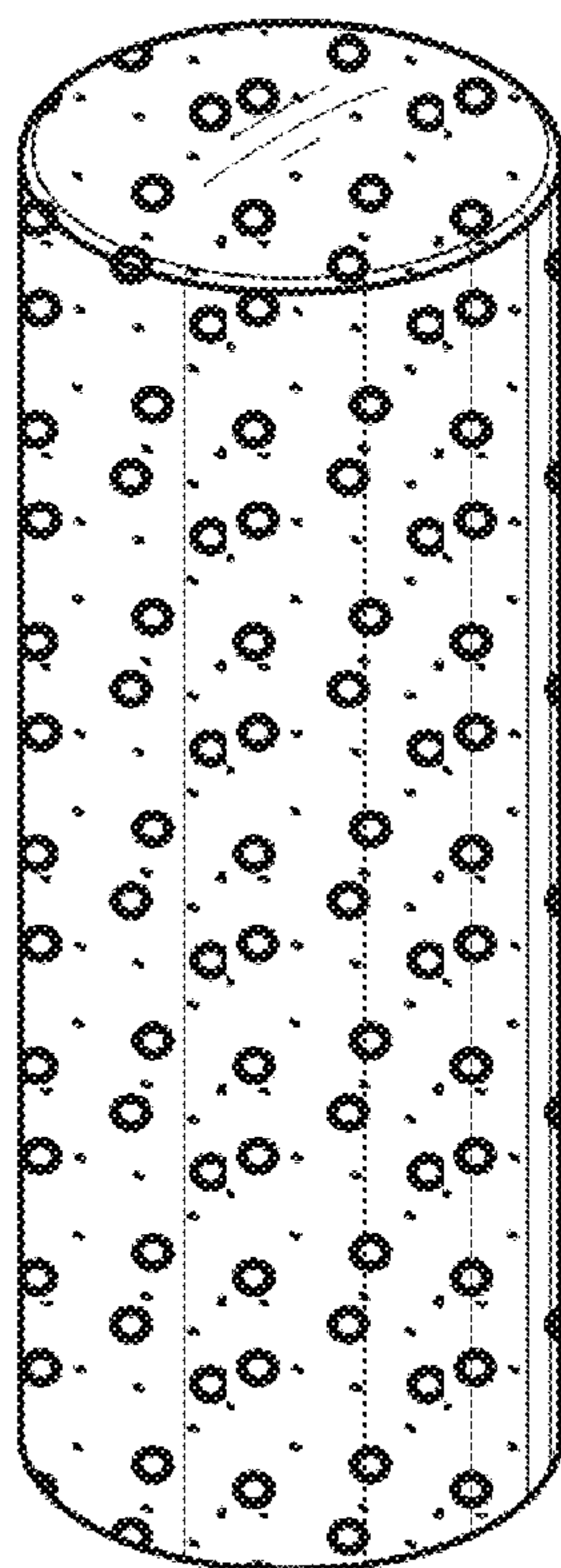
(57) **CLAIM**

The ornamental design for a cap for a cosmetic product, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a cap for a cosmetic product, embodying the new design;  
FIG. 2 is a bottom perspective view of the design shown in FIG. 1;  
FIG. 3 is a front view of the design shown in FIG. 1; the back, right side, and left side views are identical and this not shown;  
FIG. 4 is a top view of the design shown in FIG. 1; and,  
FIG. 5 is a bottom view of the design shown in FIG. 1.  
The broken lines that define the bounds of the claimed design form no part thereof.  
The exterior of the cap comprises stippling which represents color.

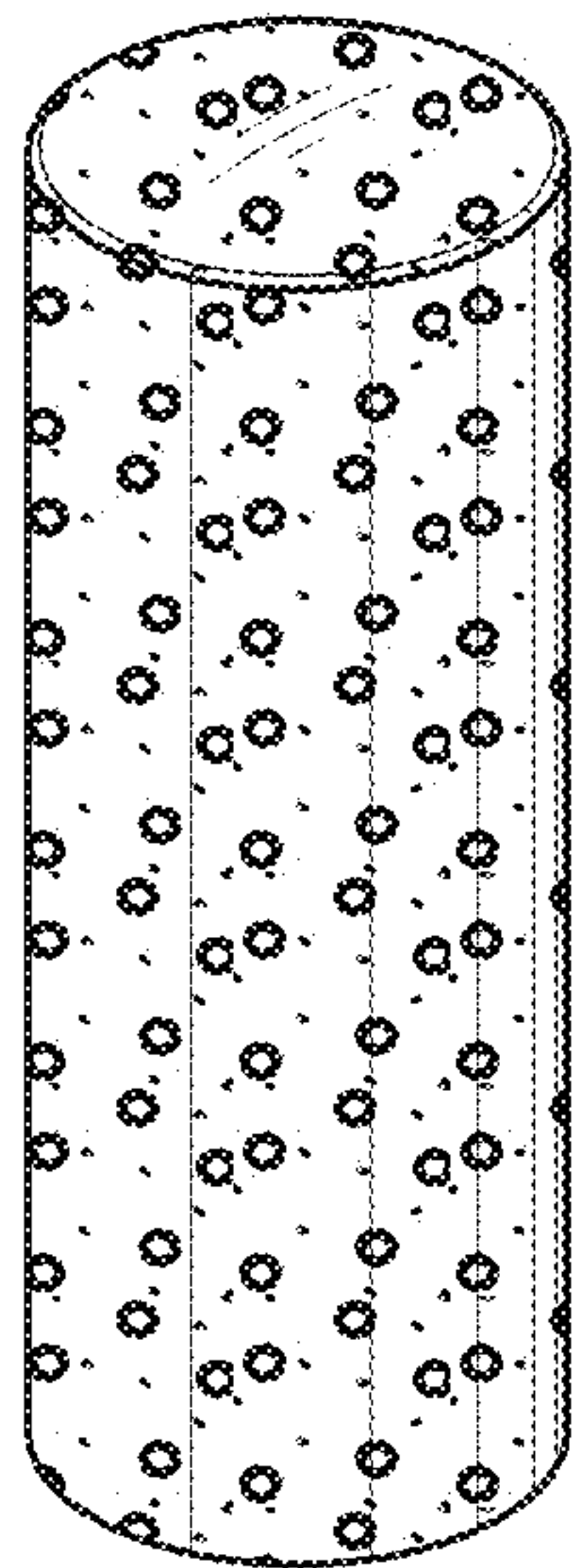

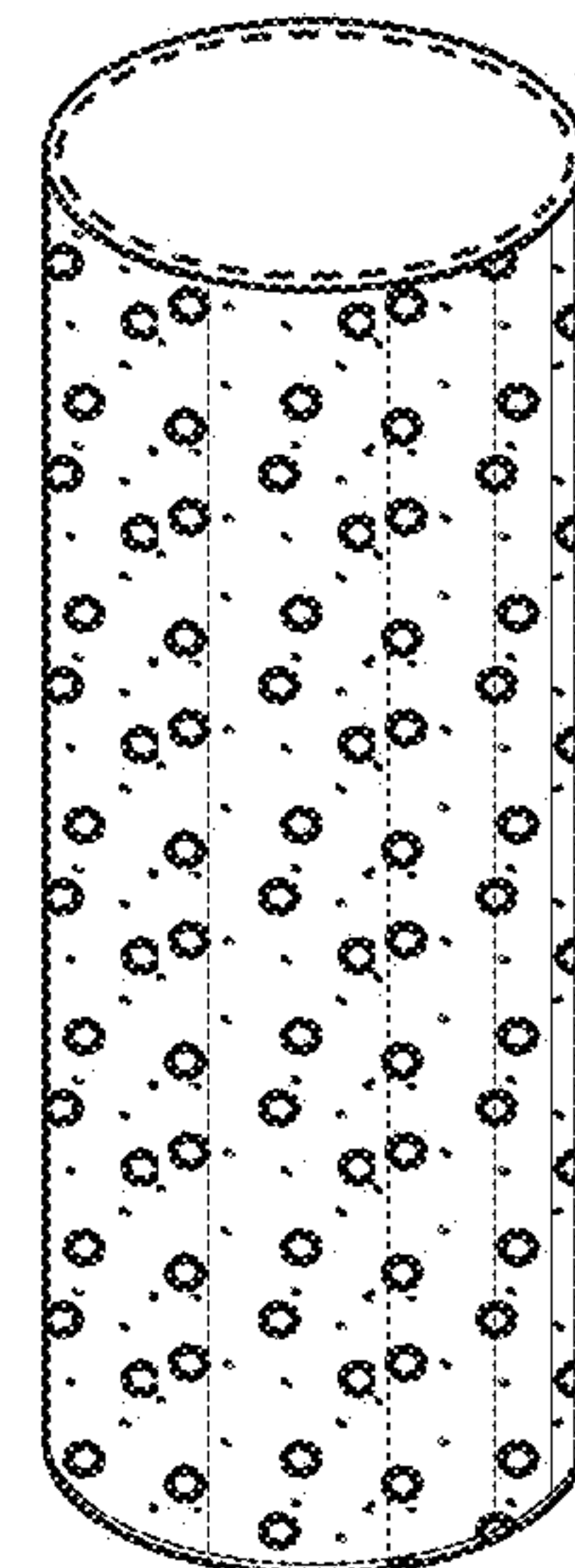

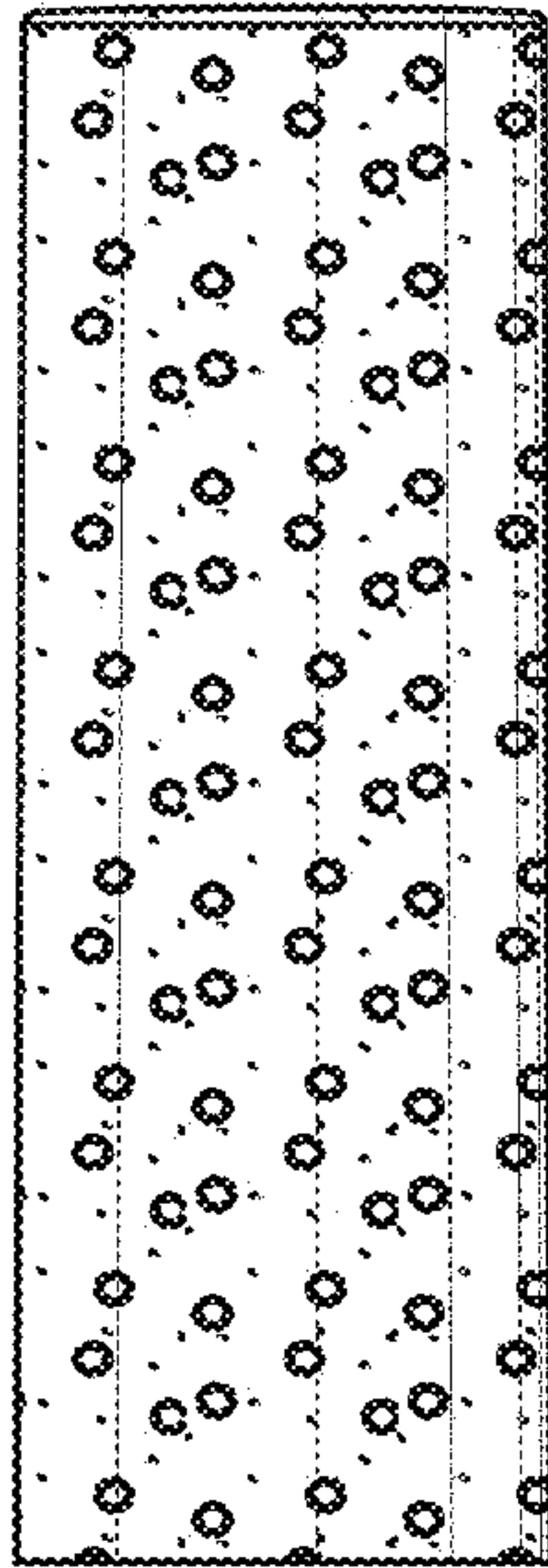

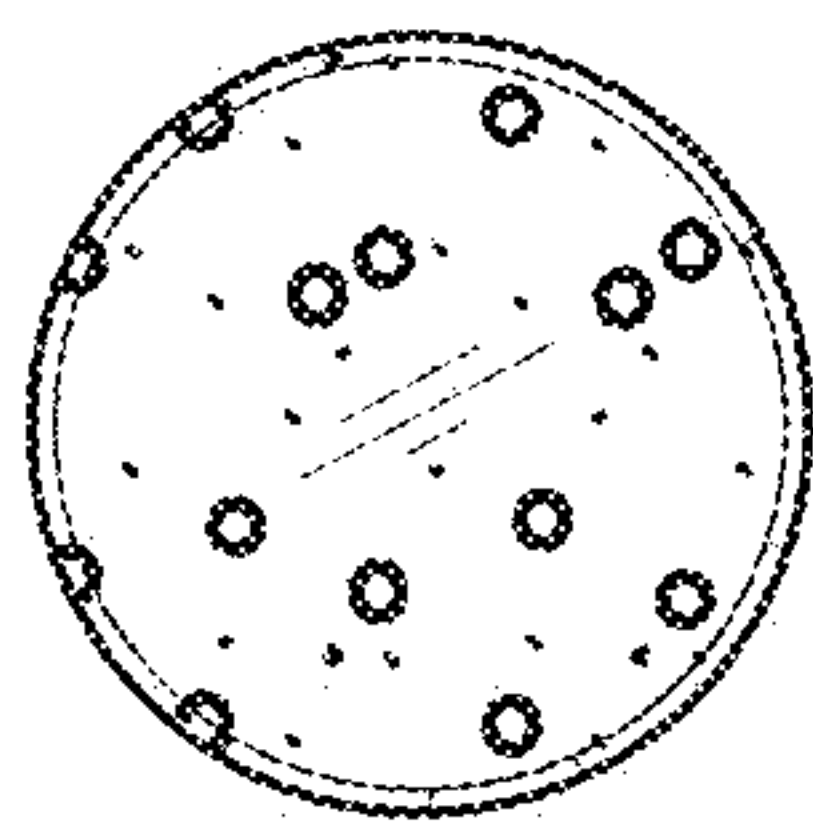

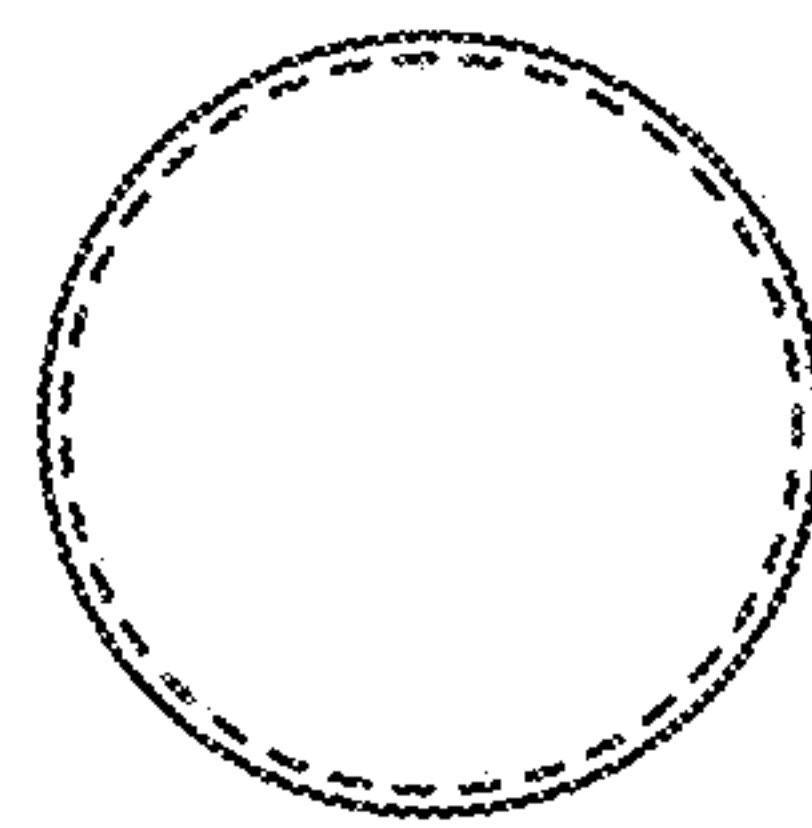
