FIG. 1 illustrates an isometric front view of a safety vest, according to an embodiment of the present disclosure.

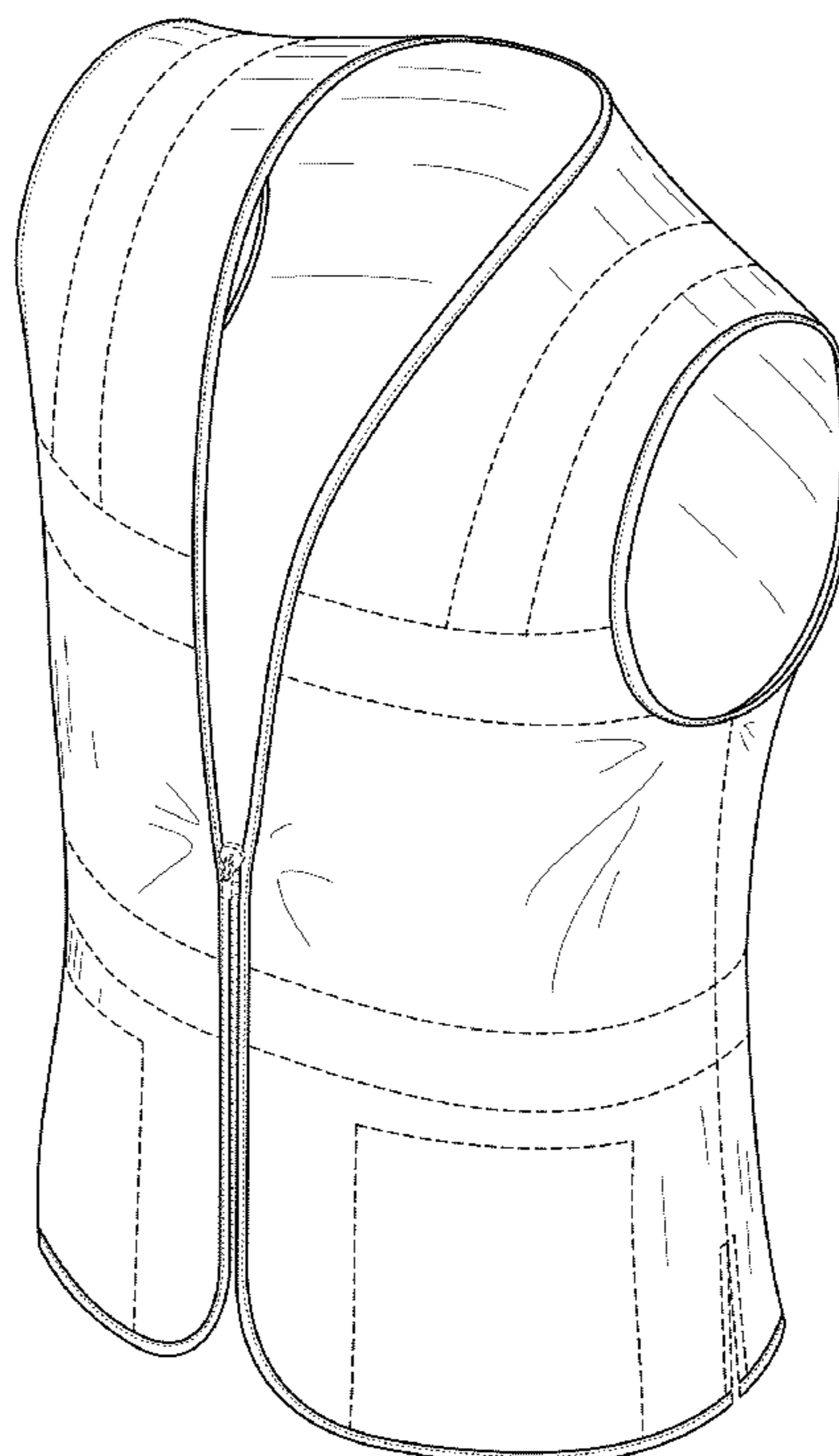
FIG. 2 illustrates a front view of a safety vest, according to an embodiment of the present disclosure.

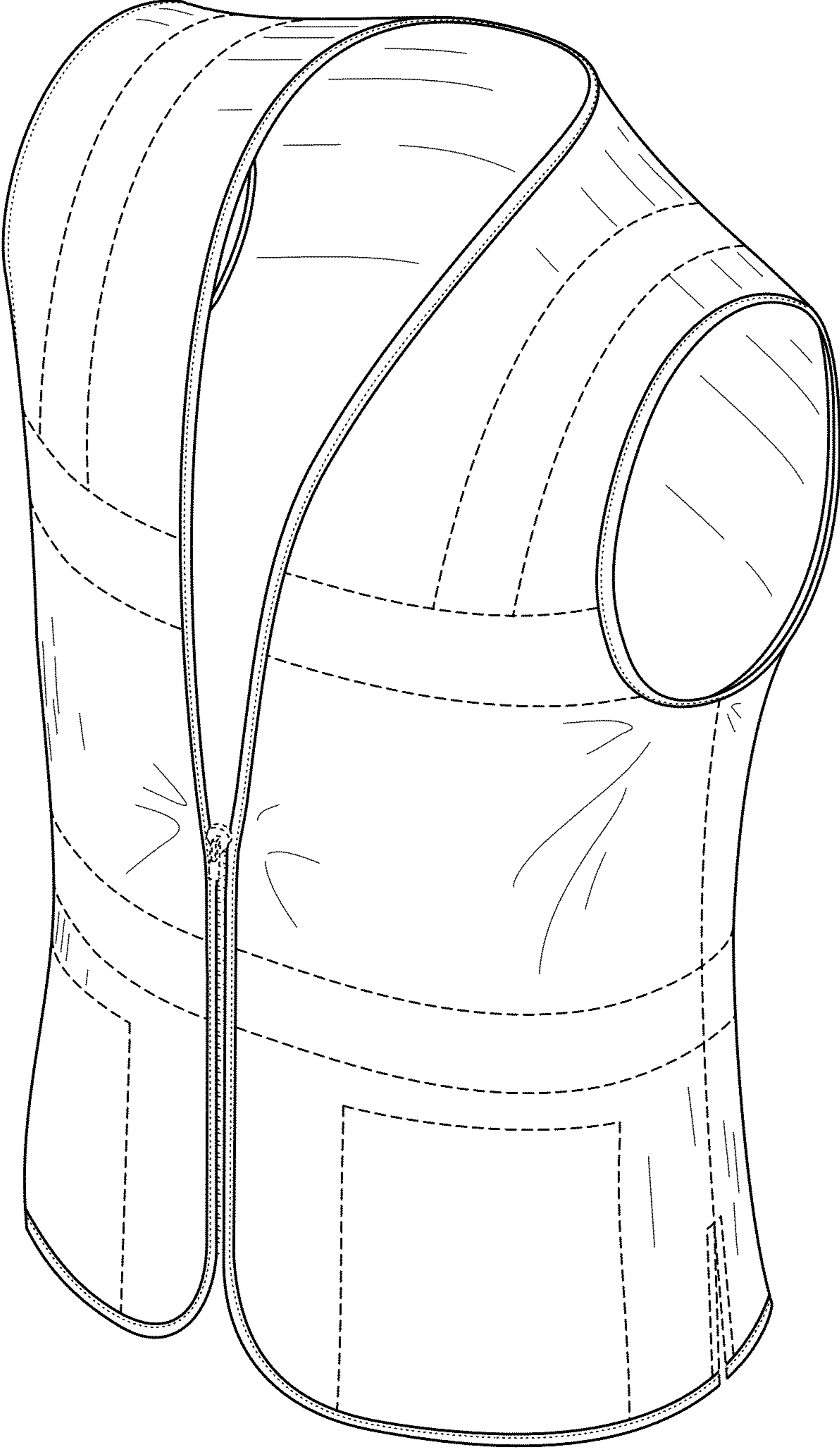

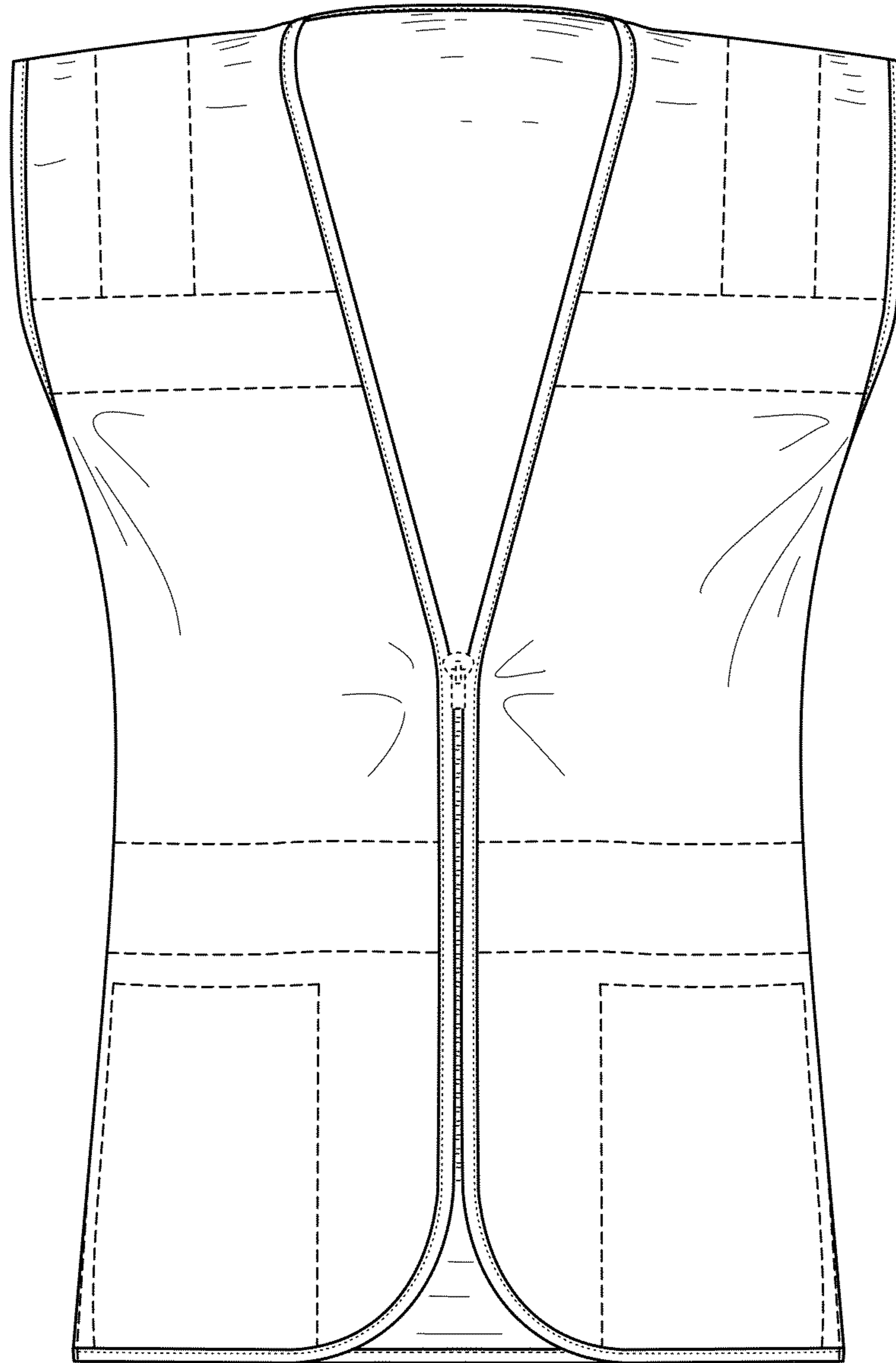

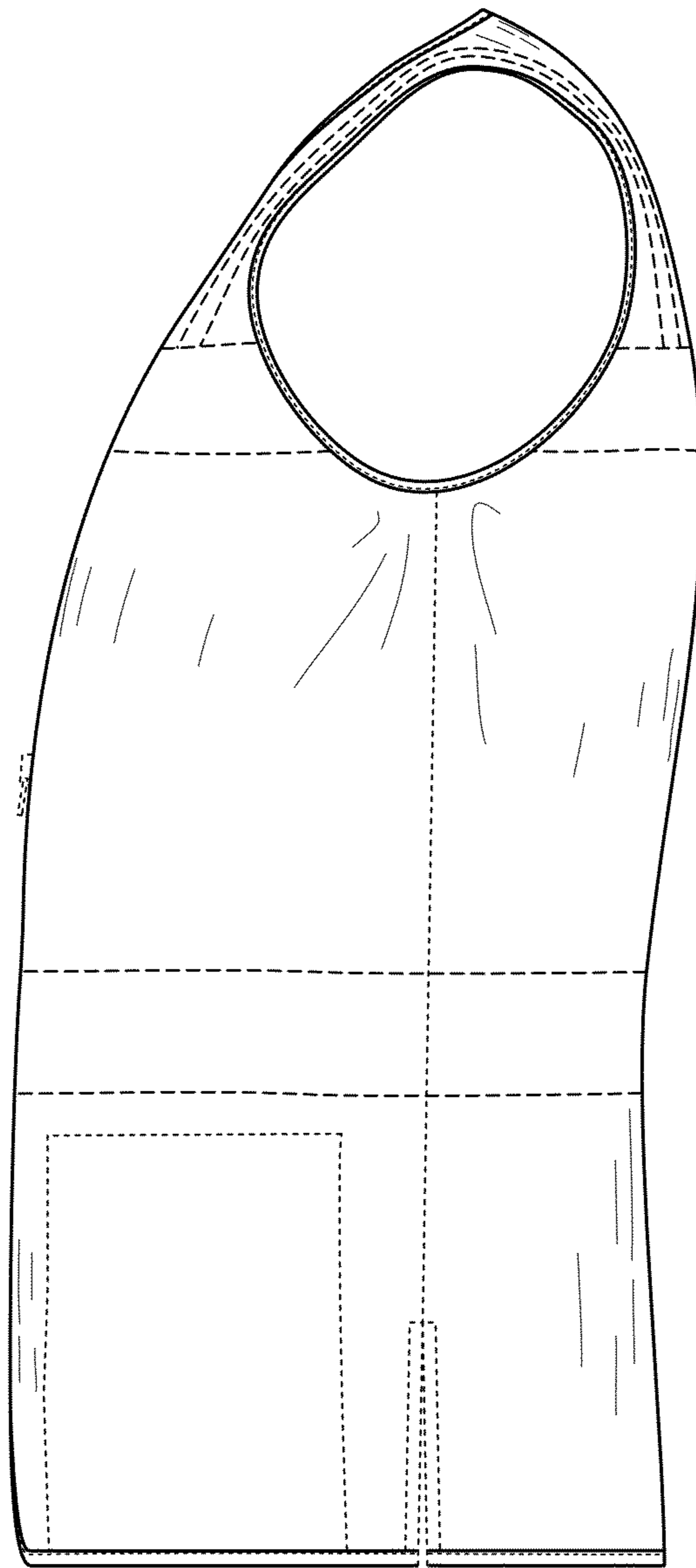

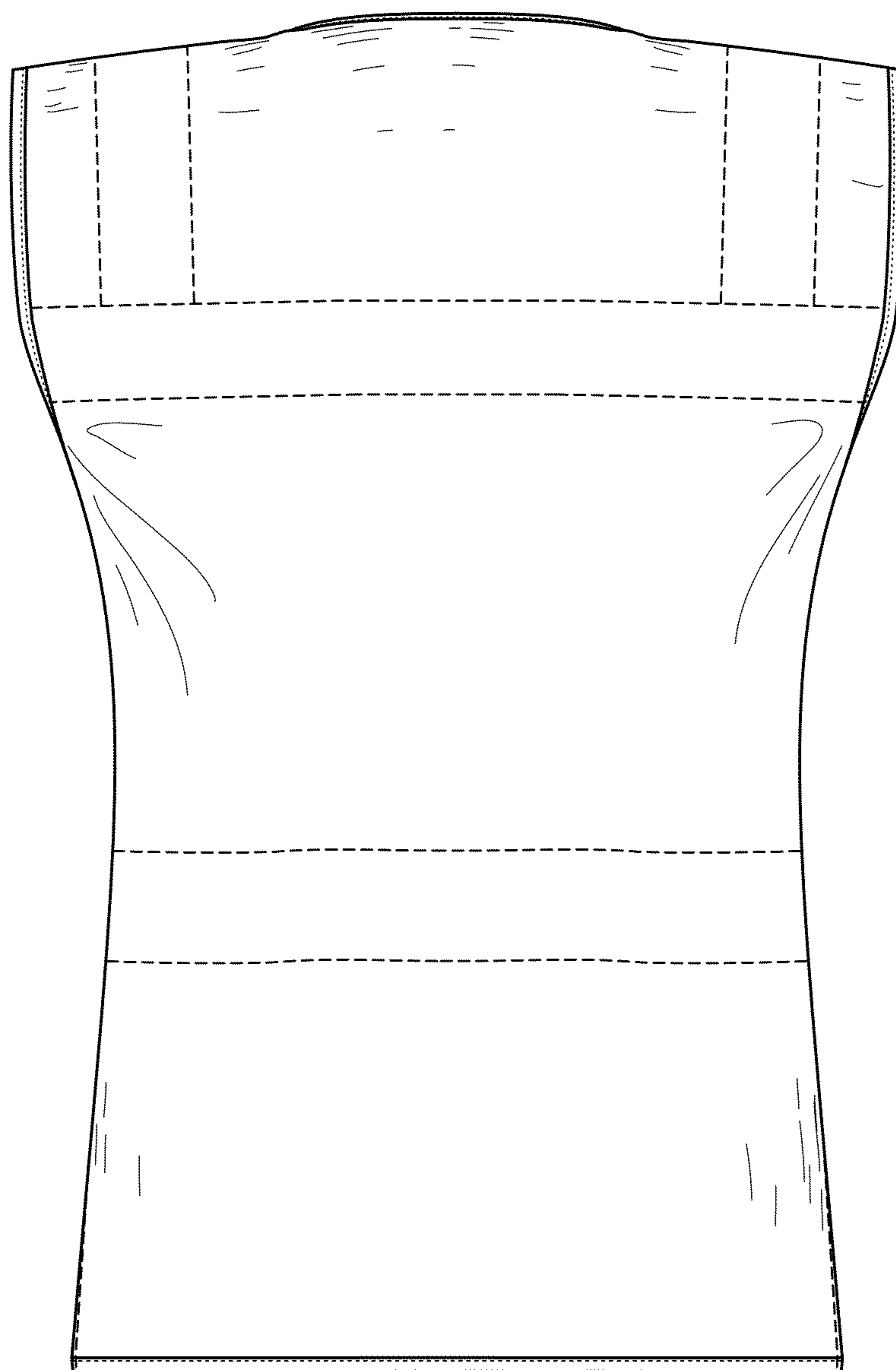
