DESCRIPTION

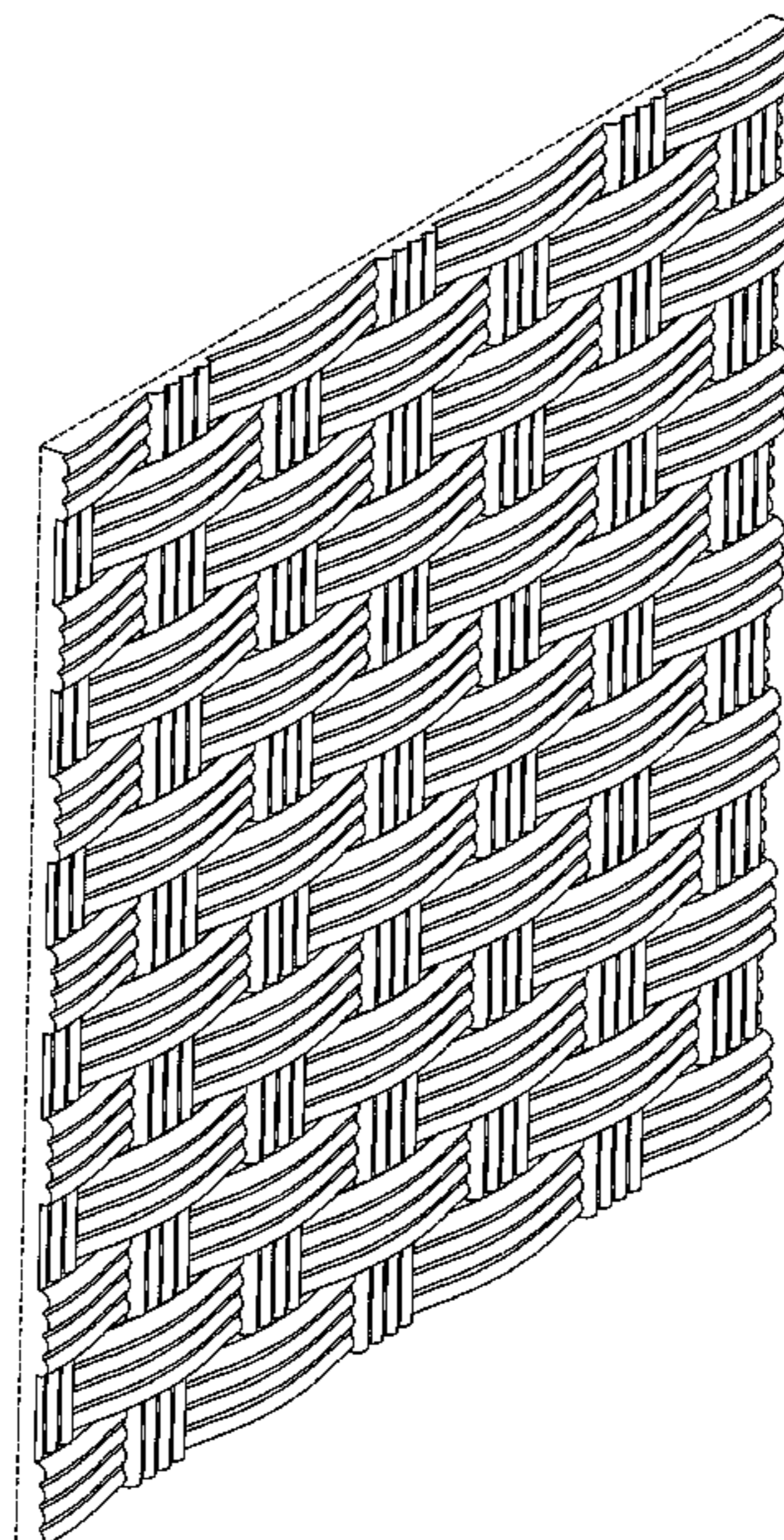
FIG. 1 is a top left perspective view of the resin wicker panel of the instant invention;

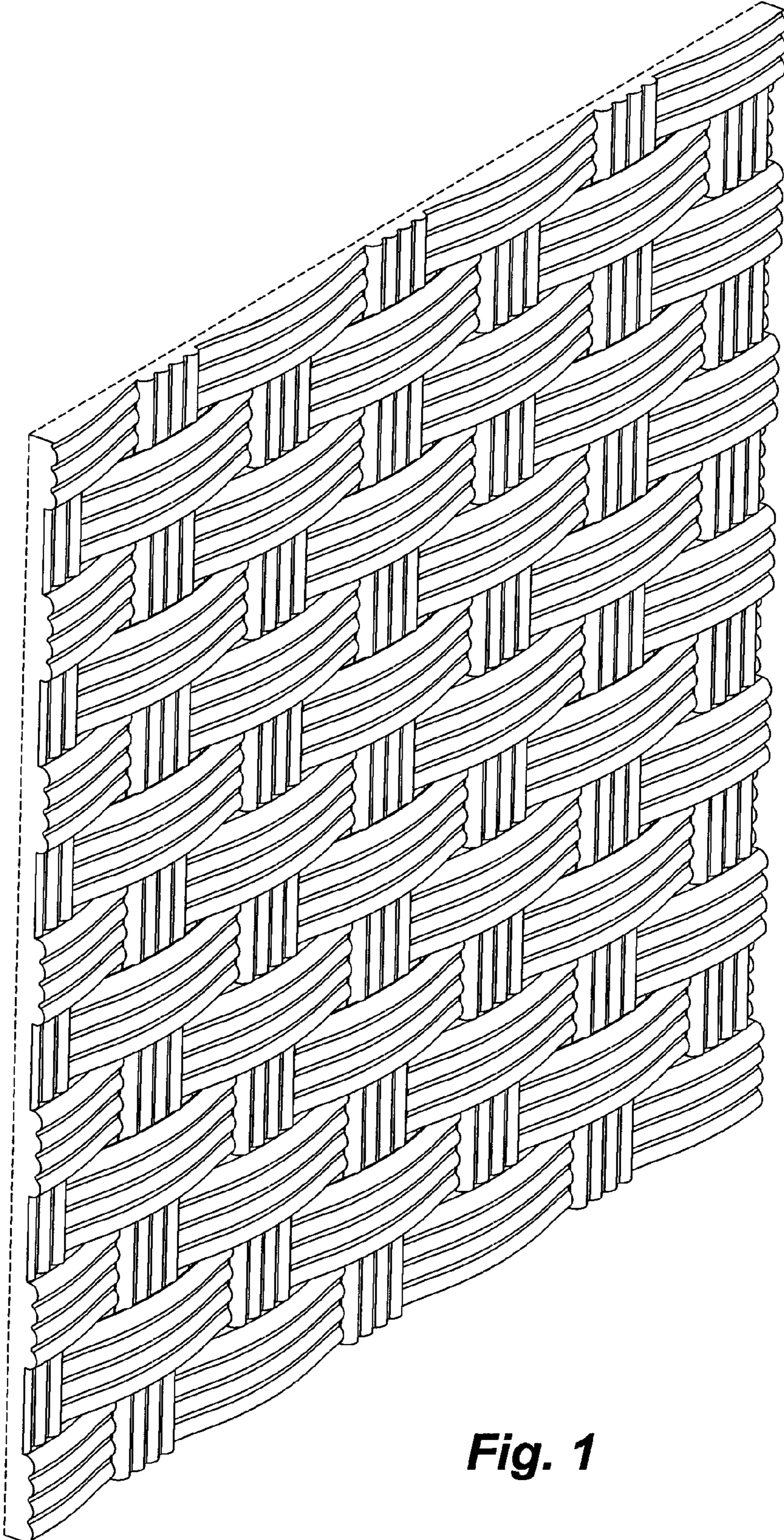

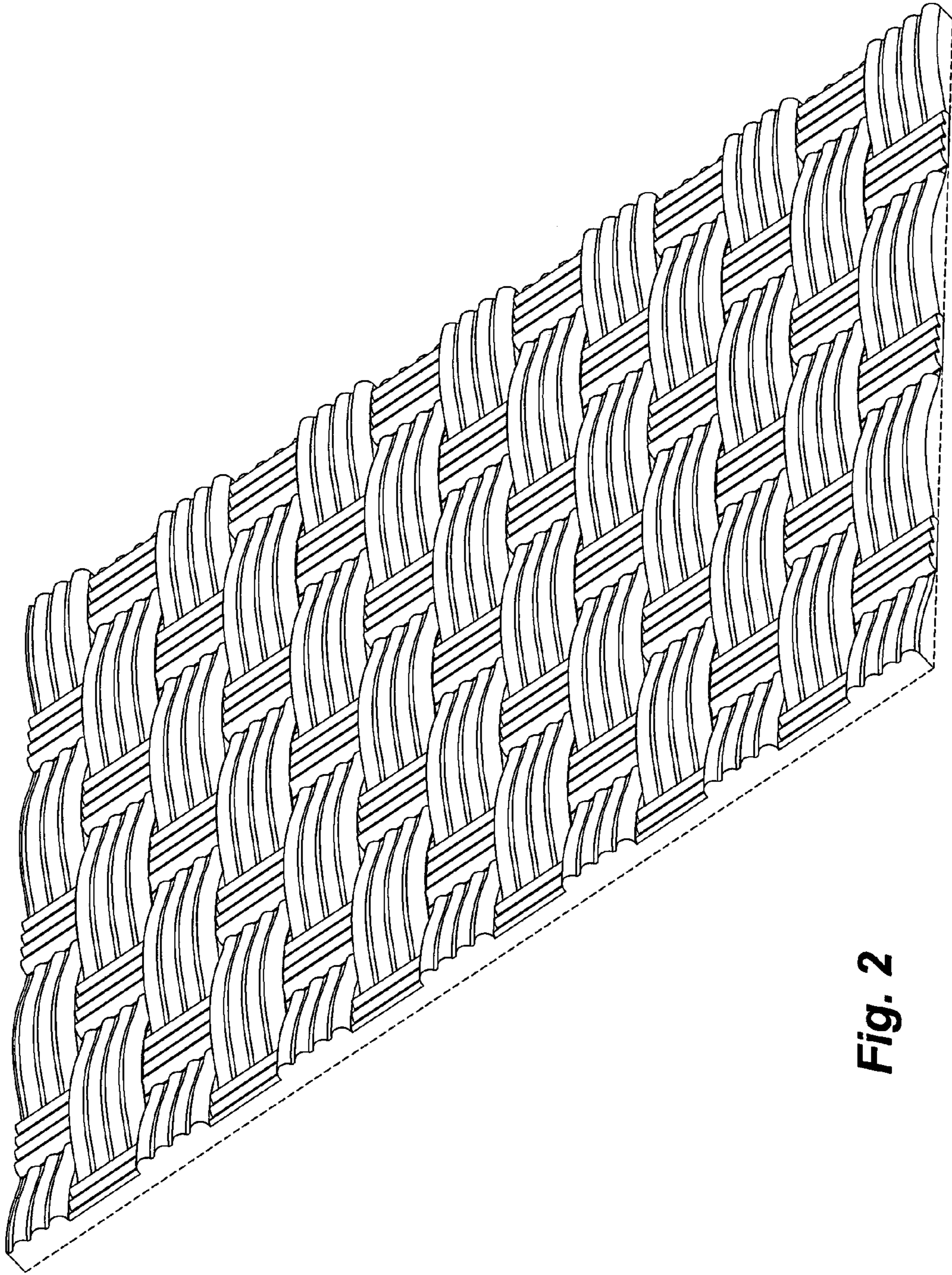

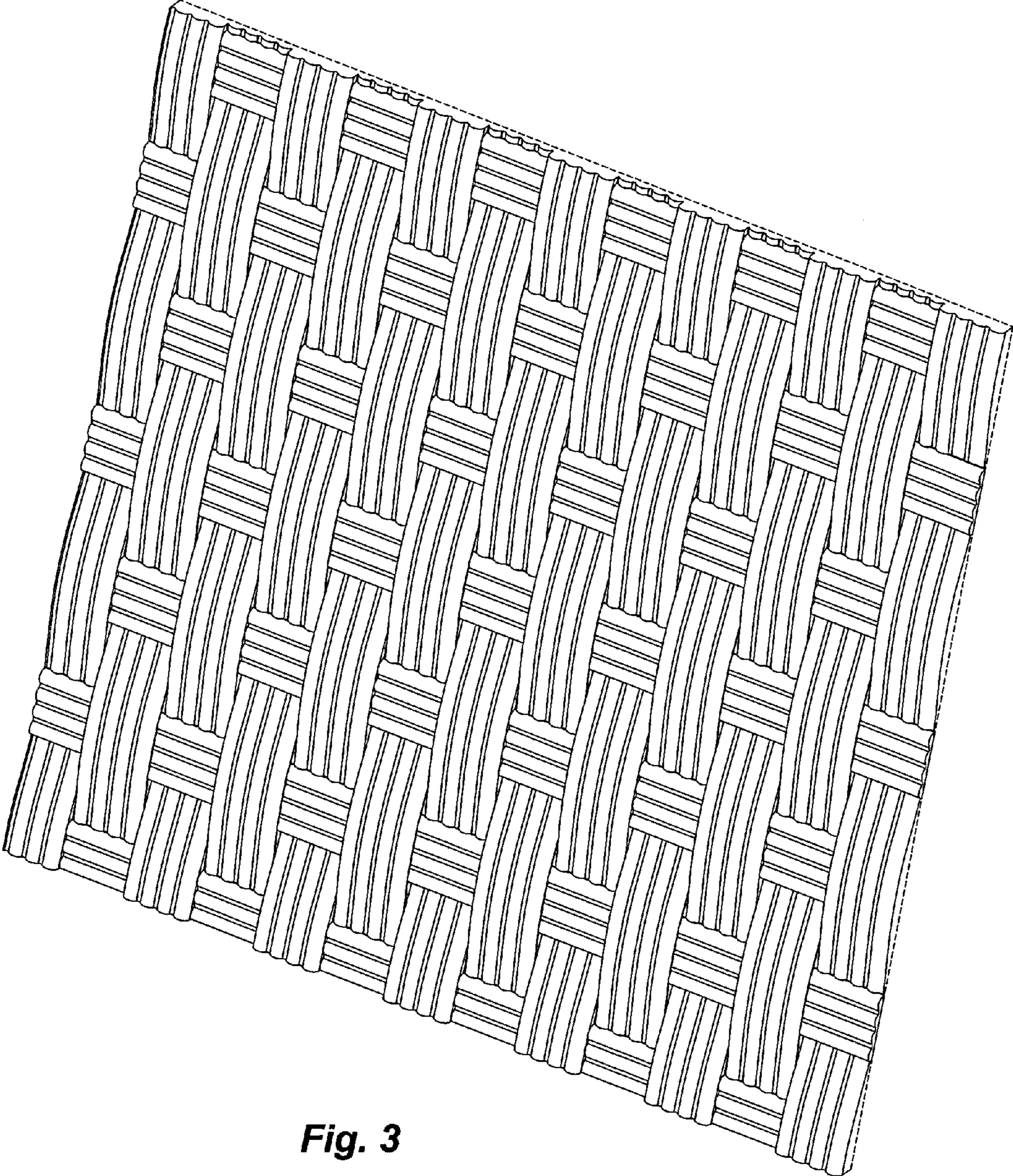

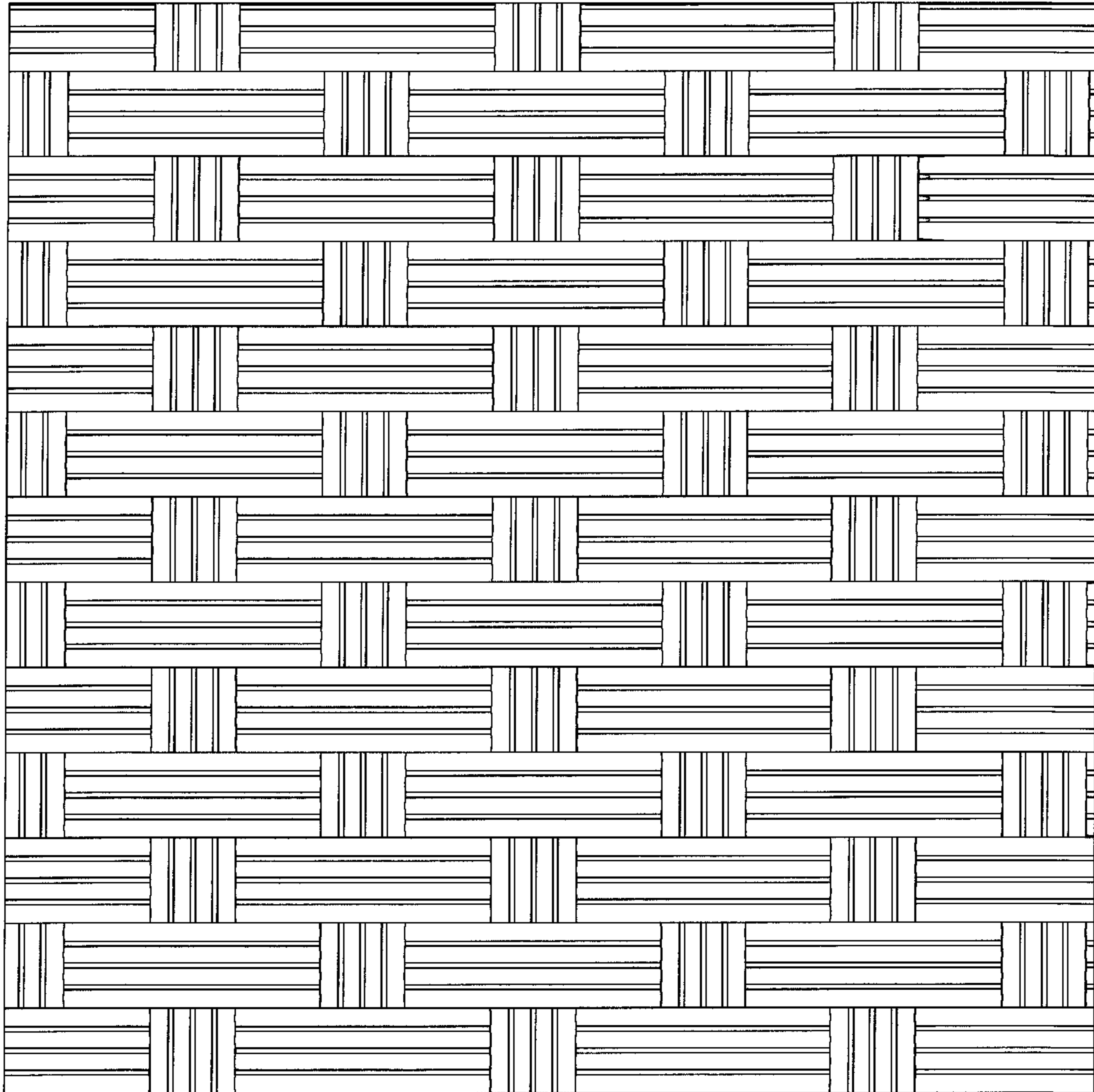

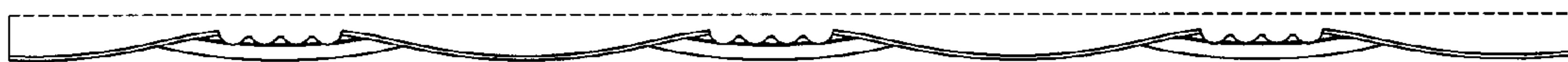

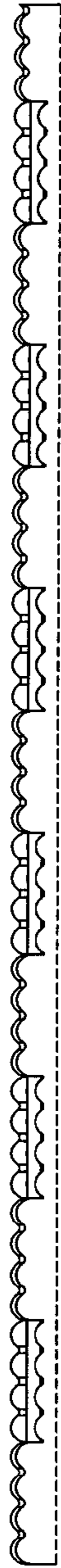
