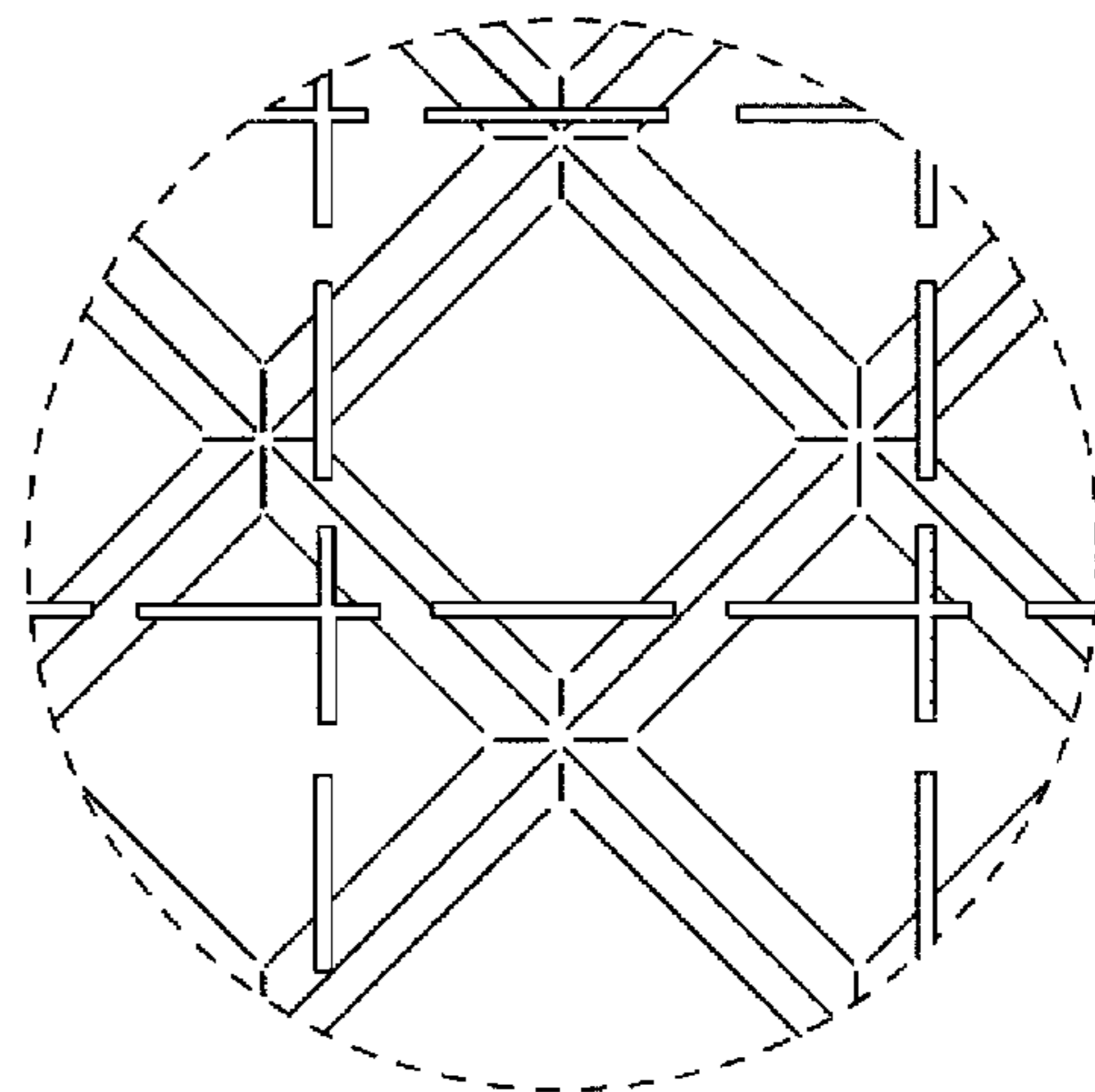
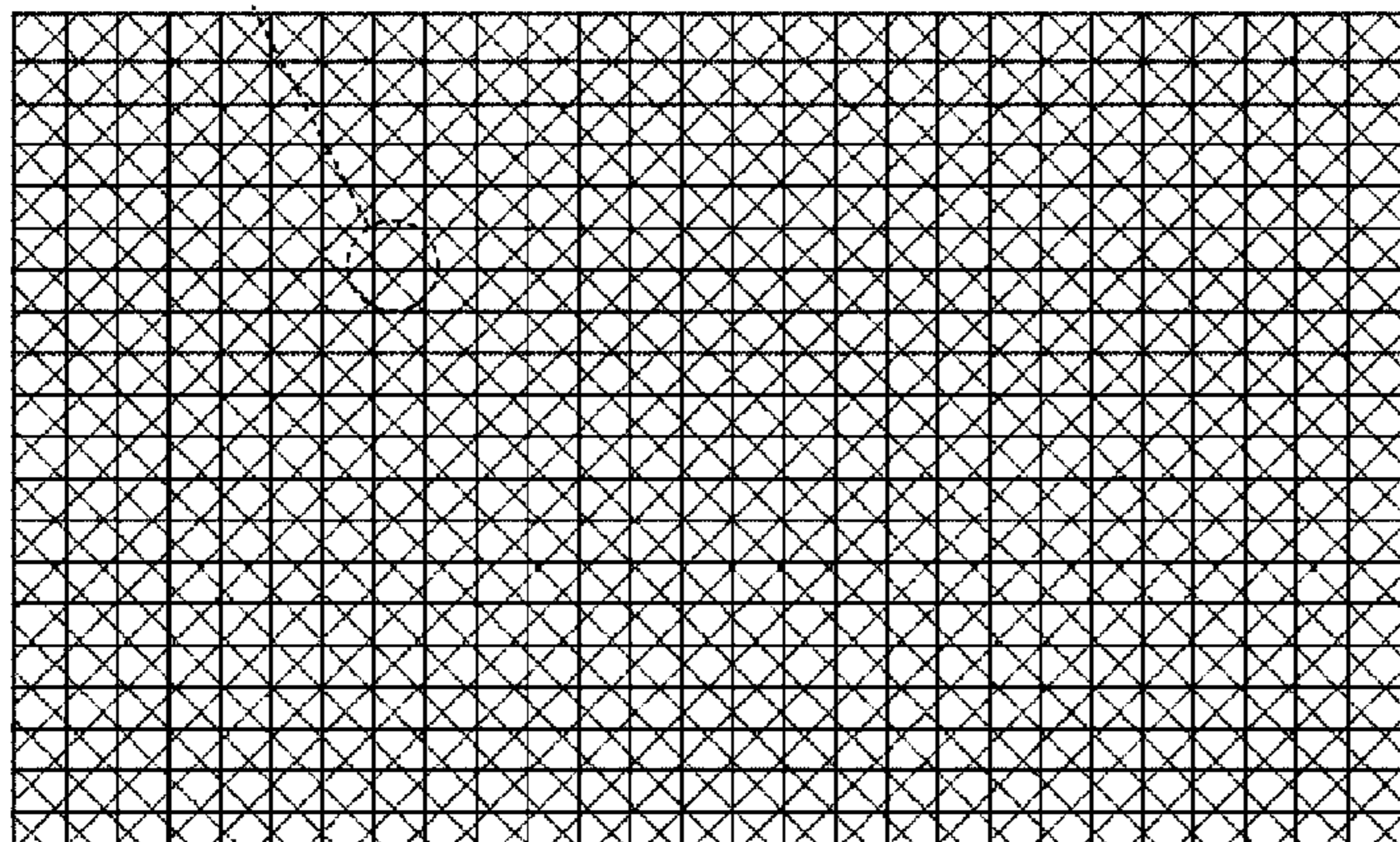
The ornamental design for an opaque mat with diamond pattern, as shown and described.

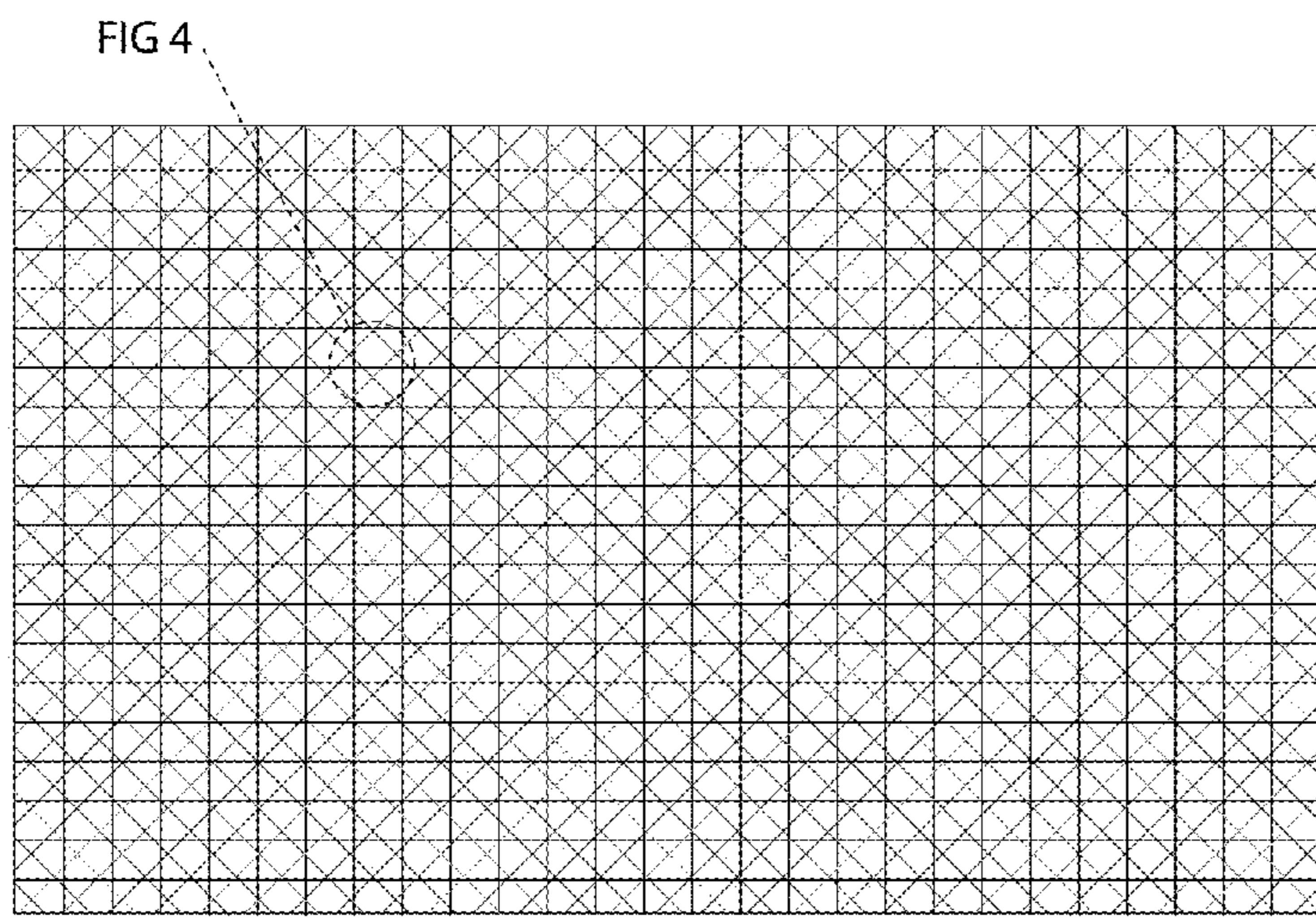

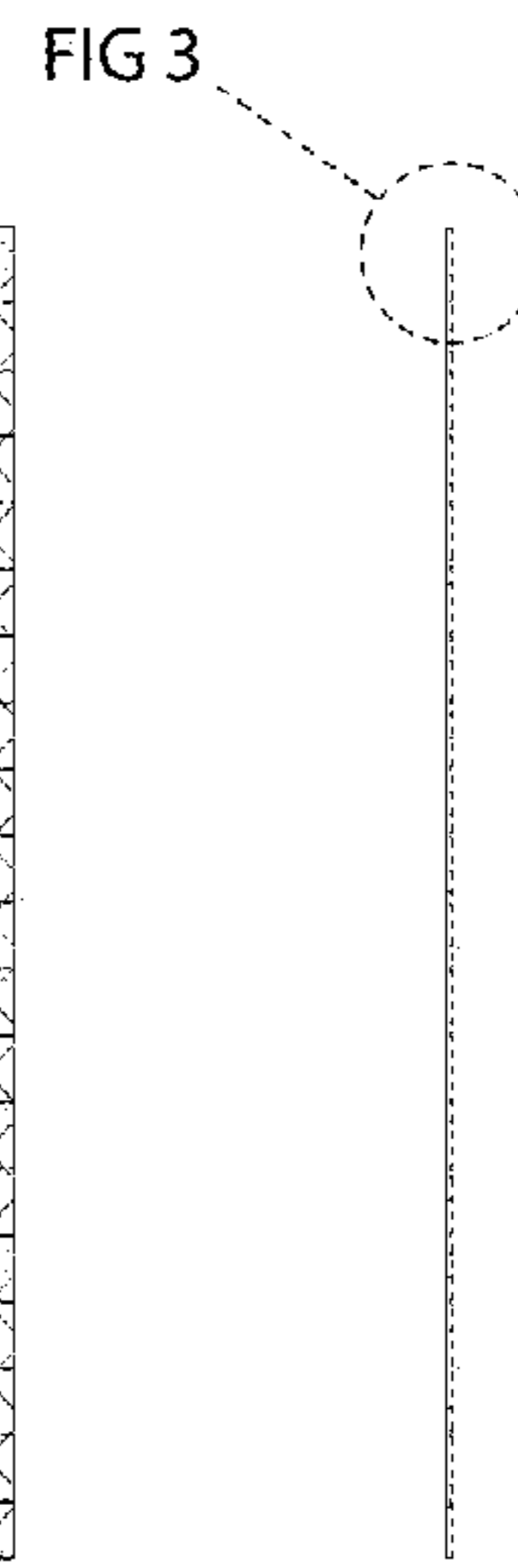

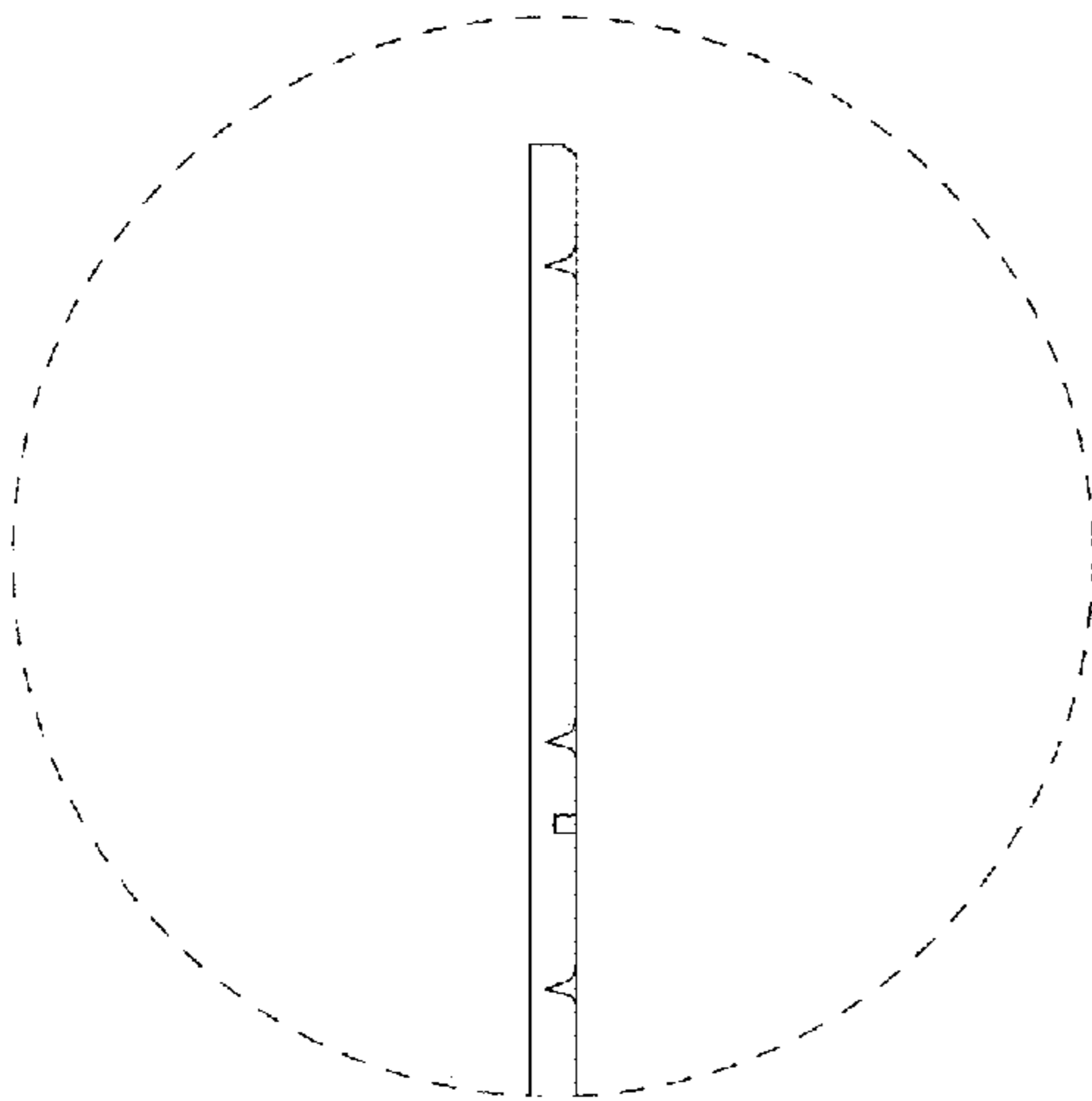

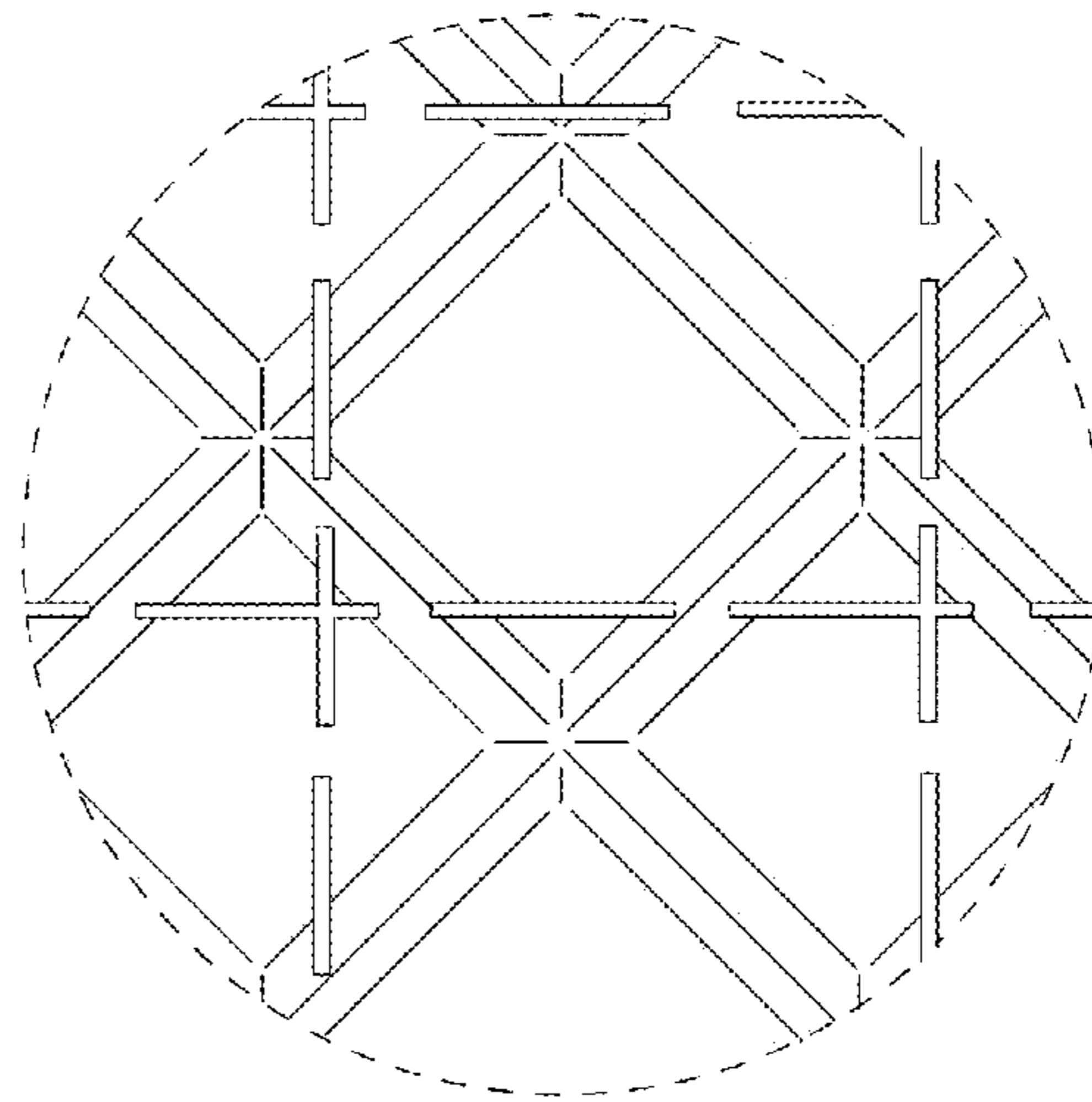
