The ornamental design for a knife blade, as shown and described.

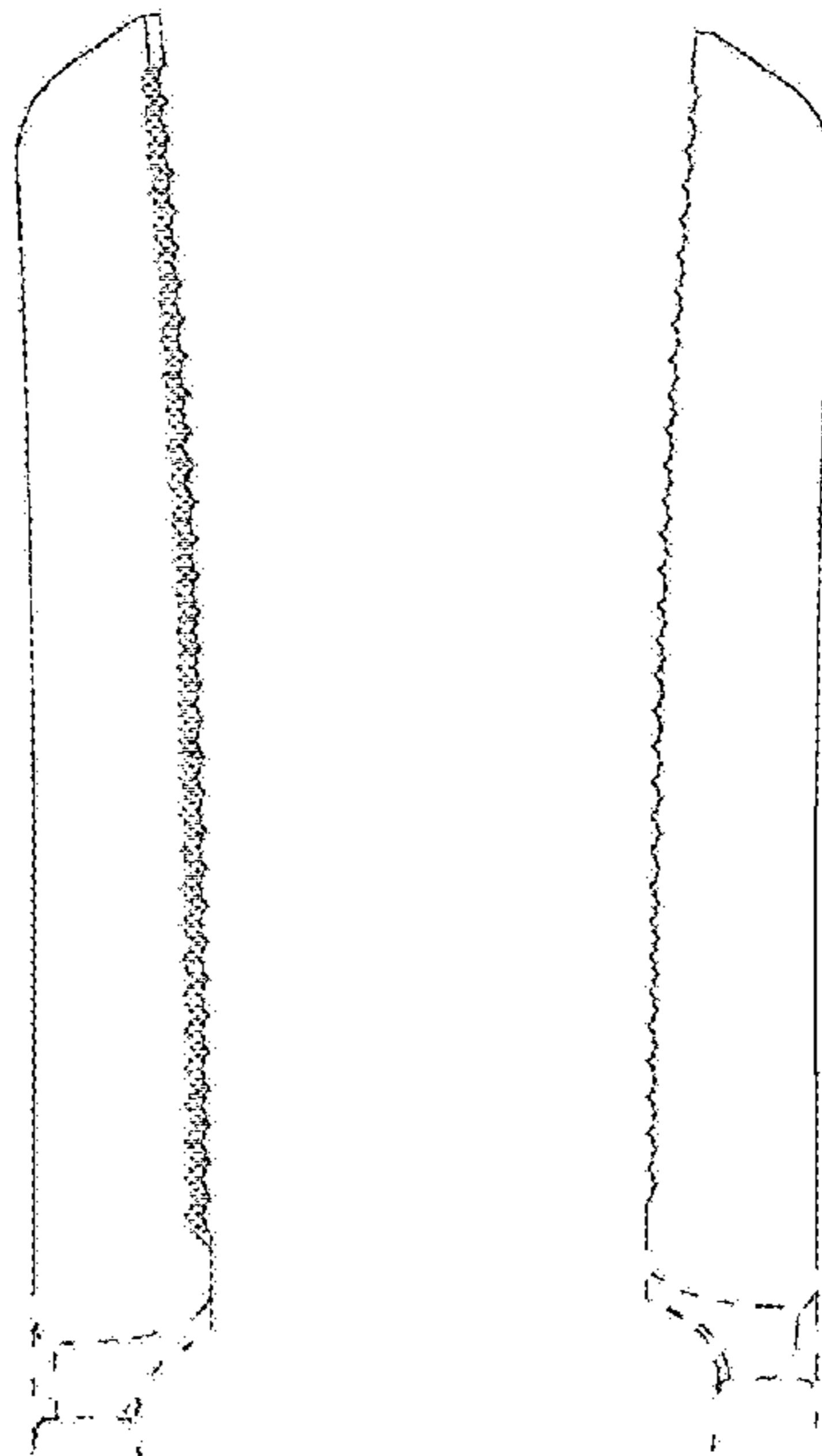
**DESCRIPTION**

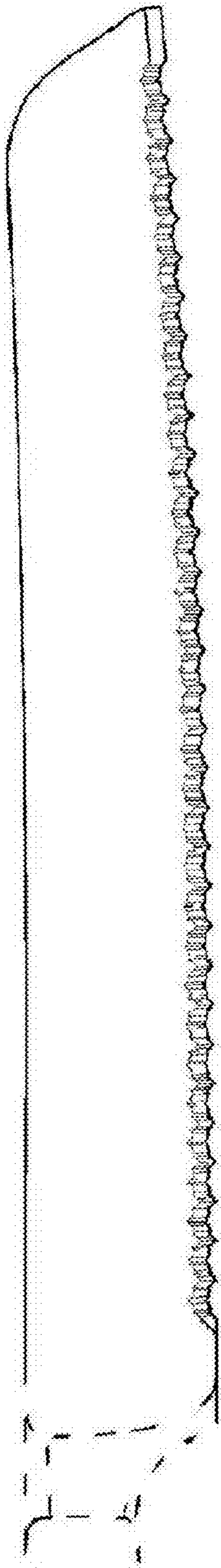

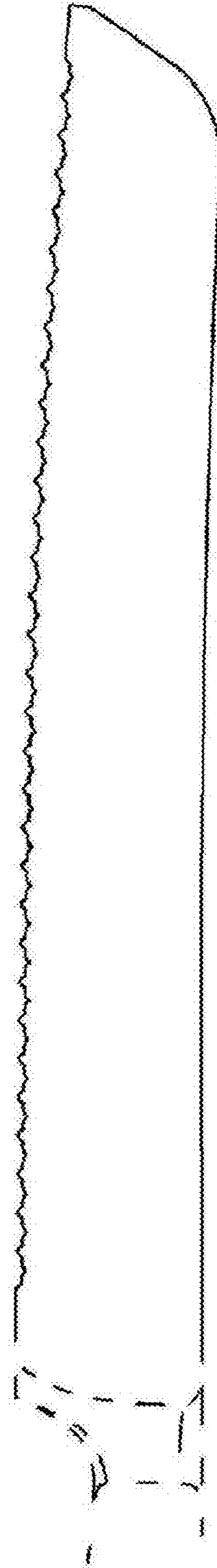
