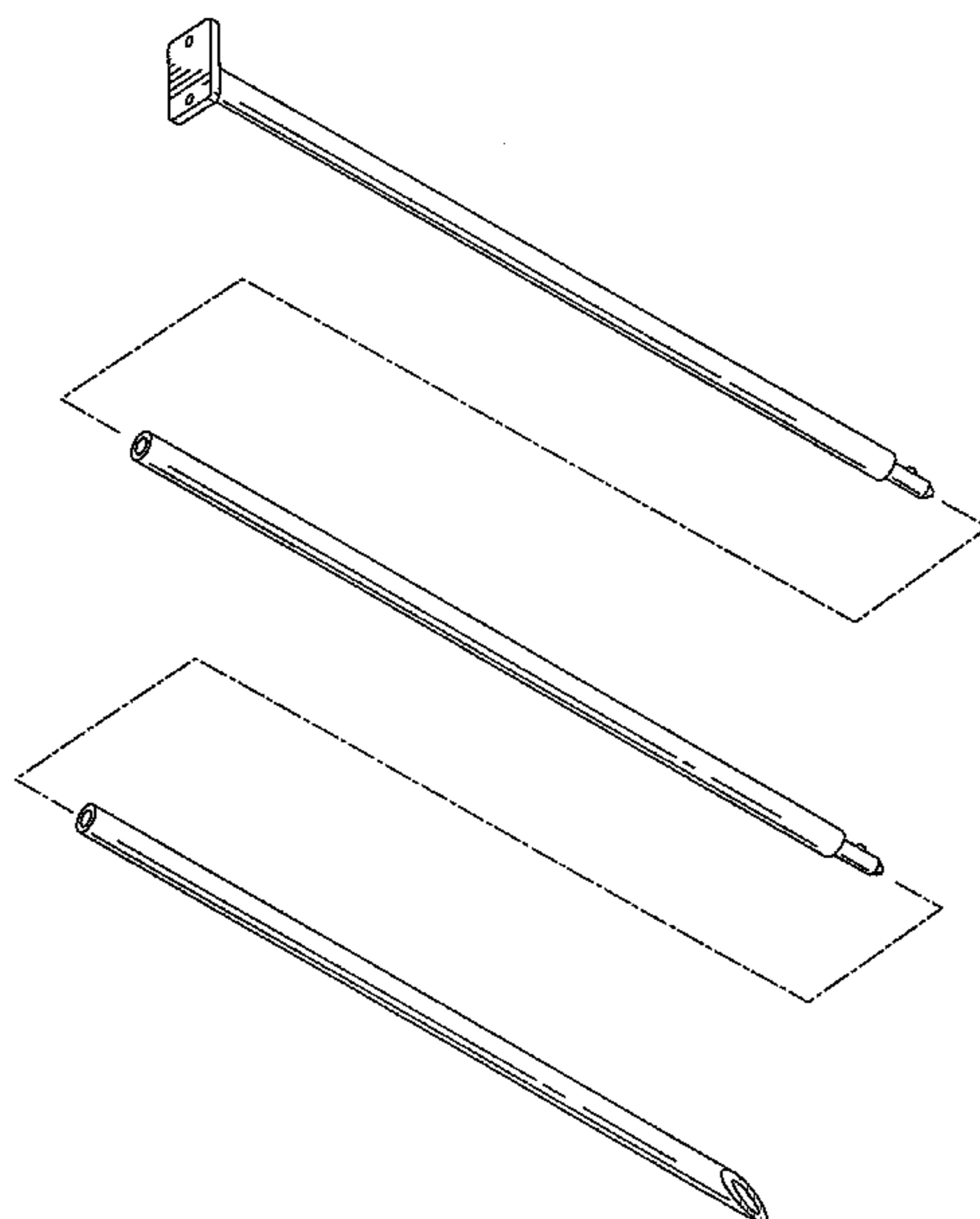
(57) **CLAIM**

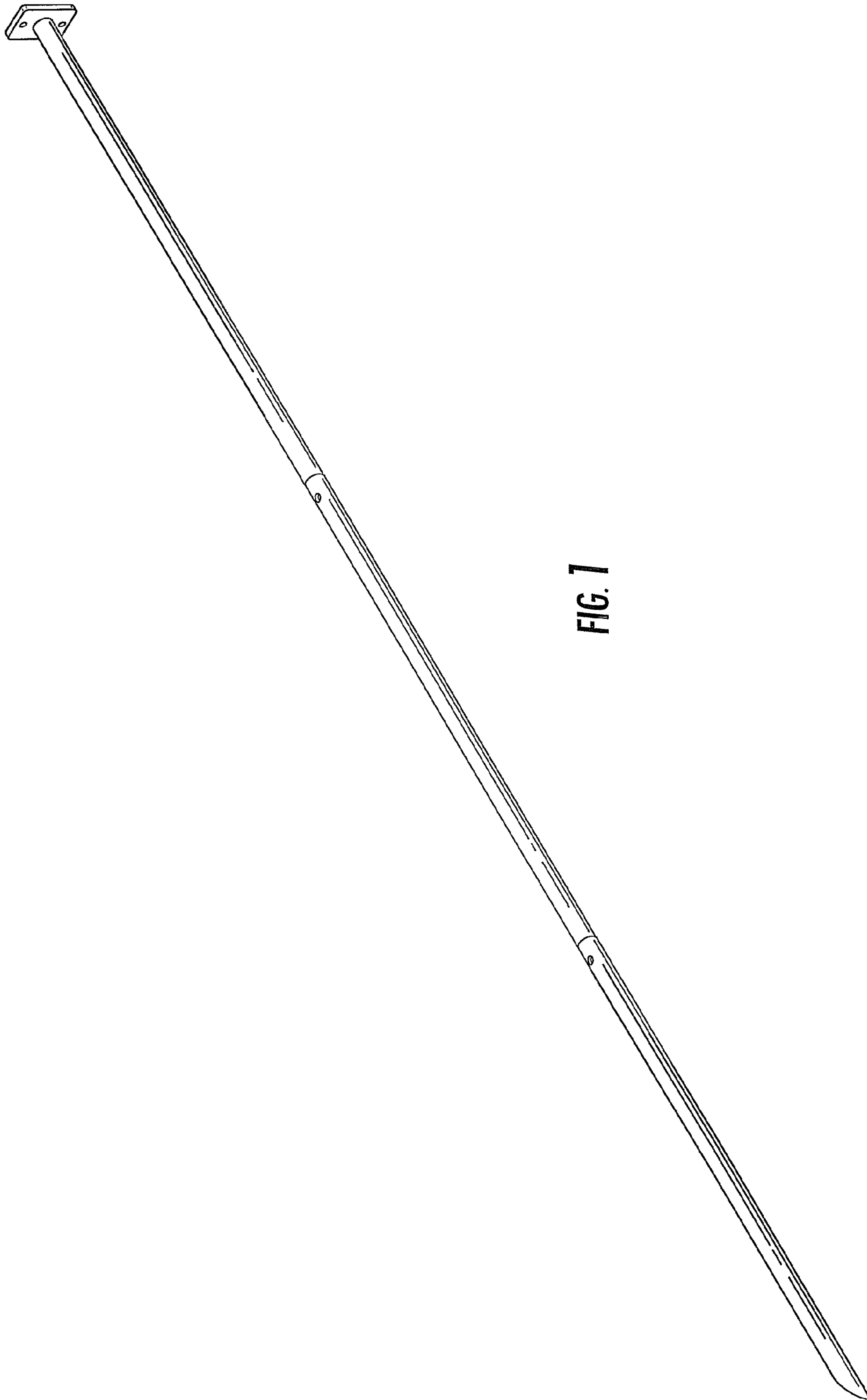
The ornamental design for a shelter support, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom, left, rear perspective view of a shelter support showing my new design;  
 FIG. 2 is a top, right, front perspective view;

 FIG. 5 is a left side view;  
 FIG. 6 is a right side view;  
 FIG. 7 is a top view;

 FIG. 10 is a top, right, front perspective view in the alternate configuration thereof.

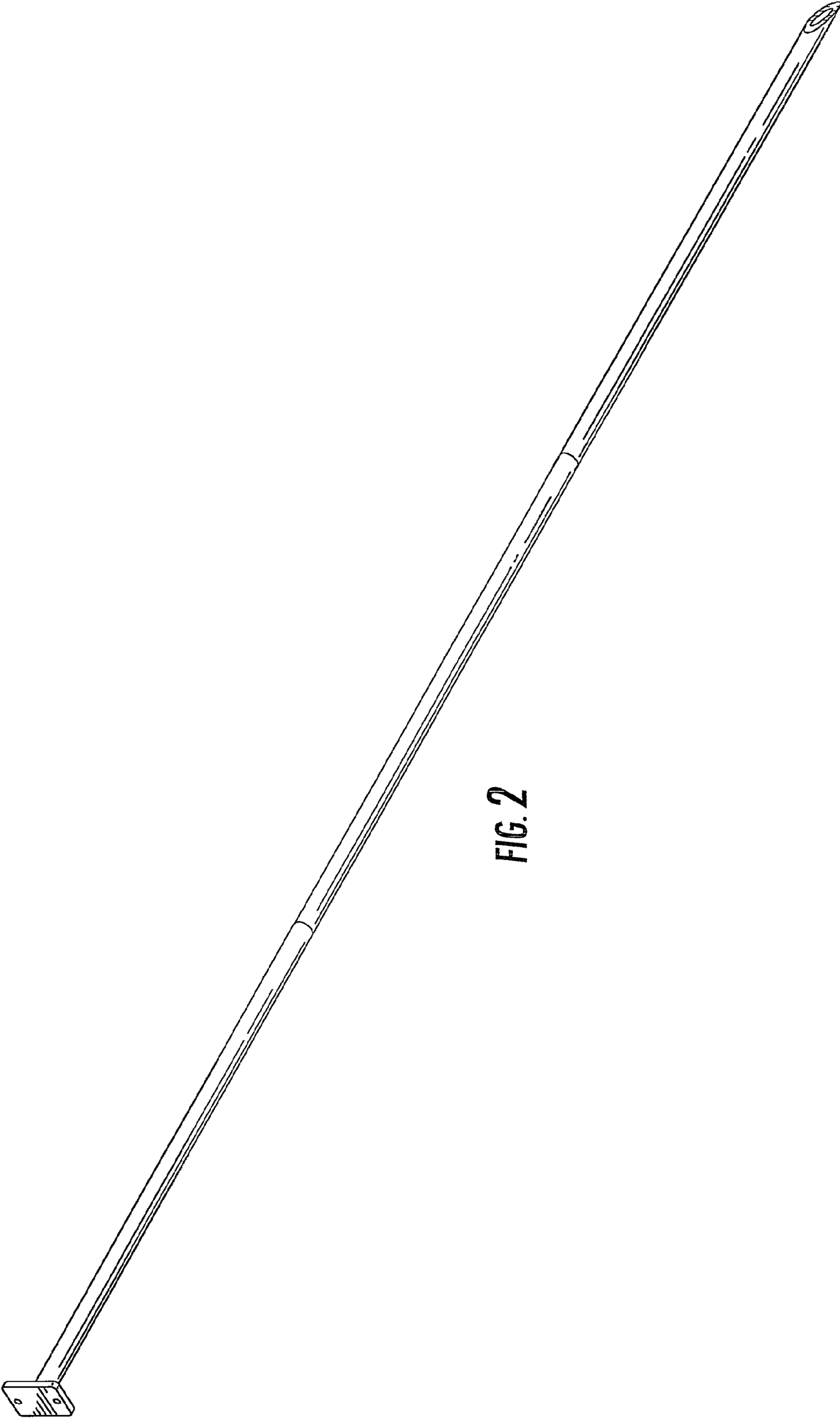
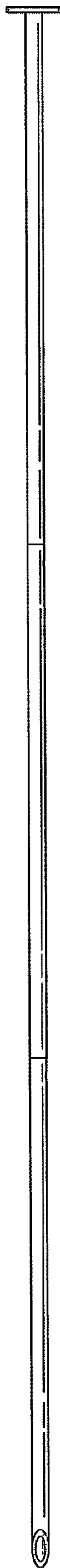
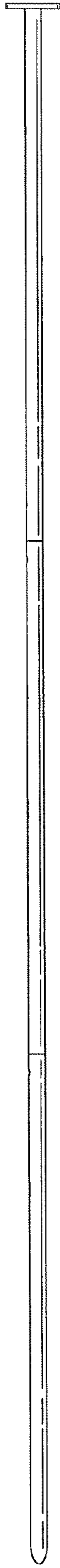

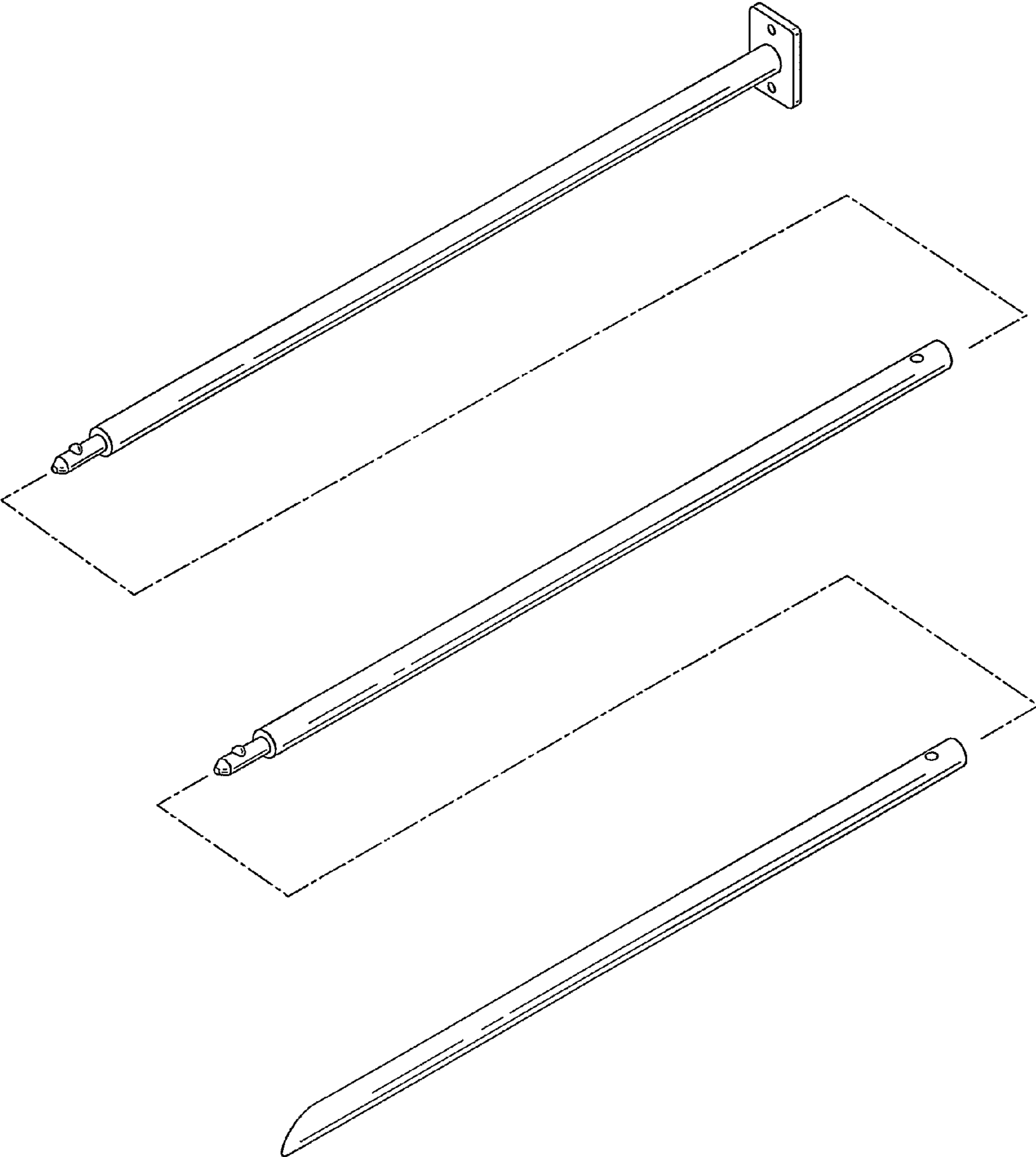

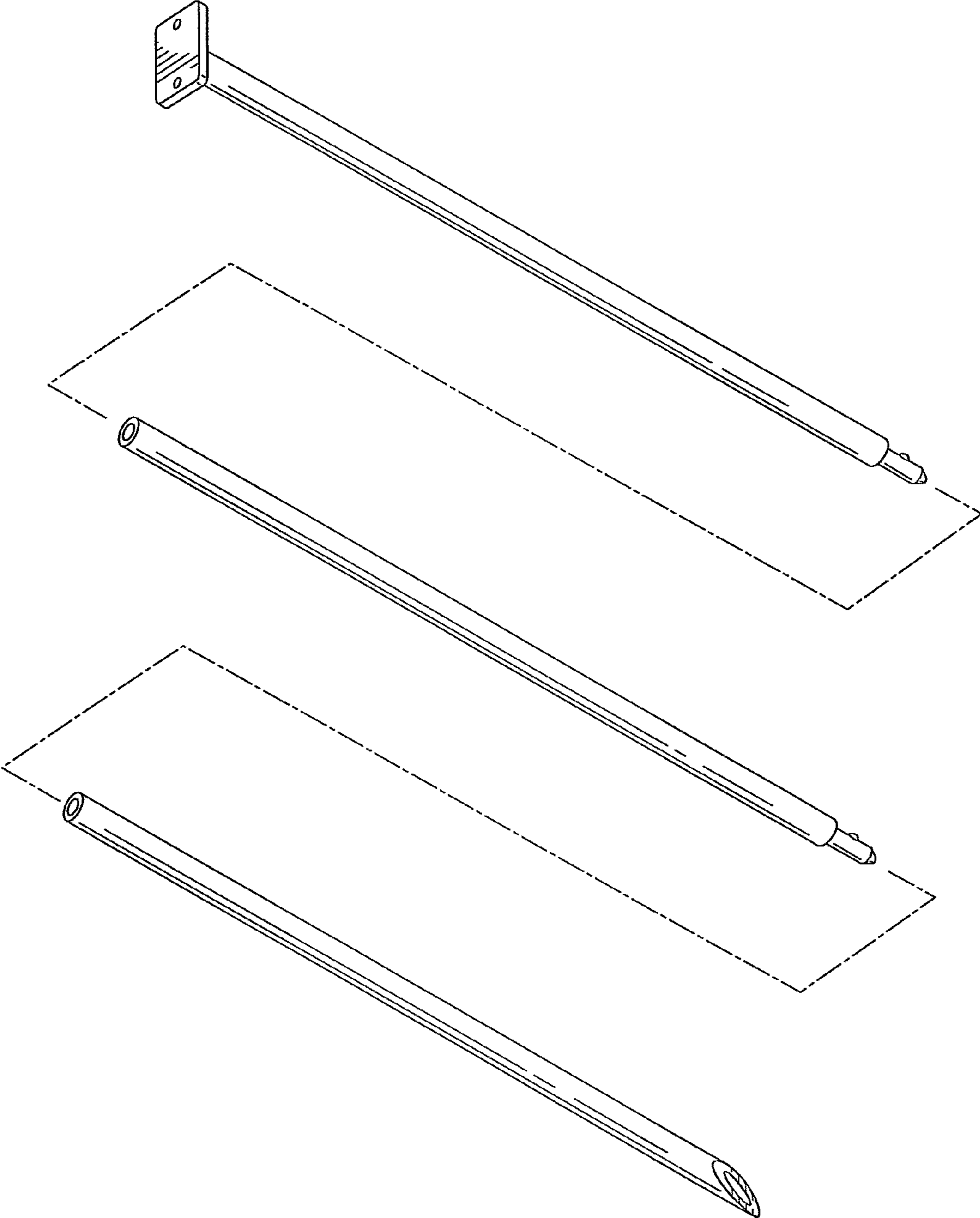
