(57) **CLAIM**

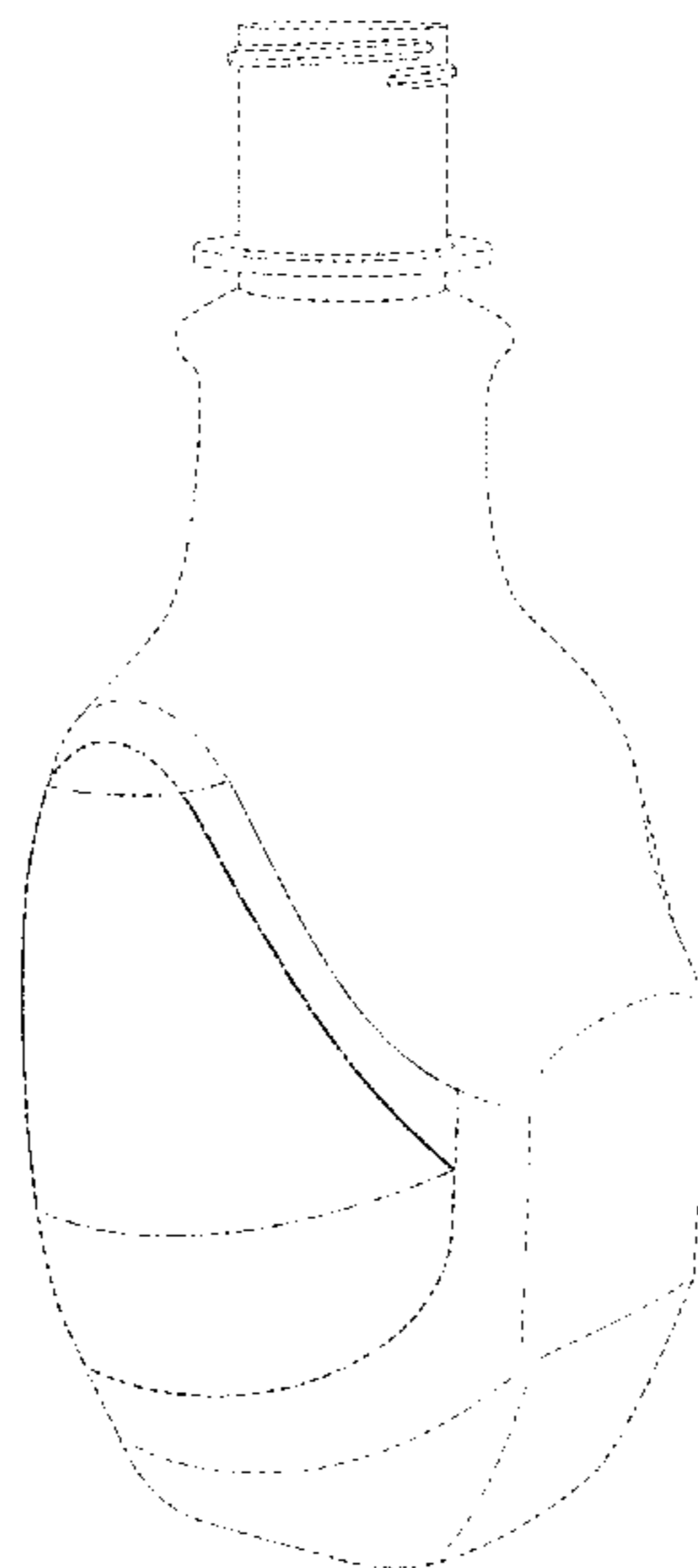
The ornamental design for a combined label and container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a combined label and container incorporating our new design; FIG. 2 is a front view thereof; FIG. 3 is a back view thereof; FIG. 4 is a side view thereof; FIG. 5 is a view of the opposite side thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom view thereof.

The evenly spaced broken lines depict environmental subject matter only and form no part of the claimed design. The dot-dash-dot lines represent the boundaries of the design claimed and form no part thereof.

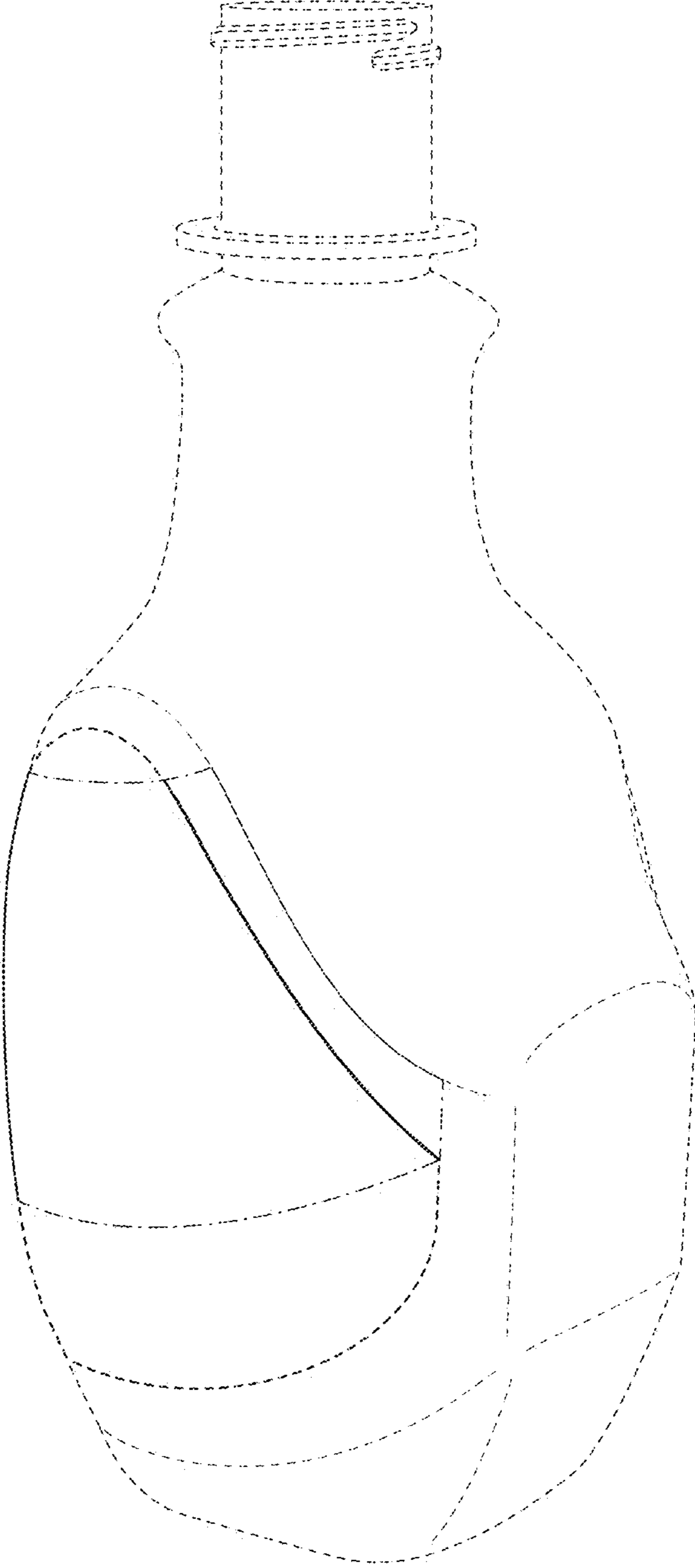

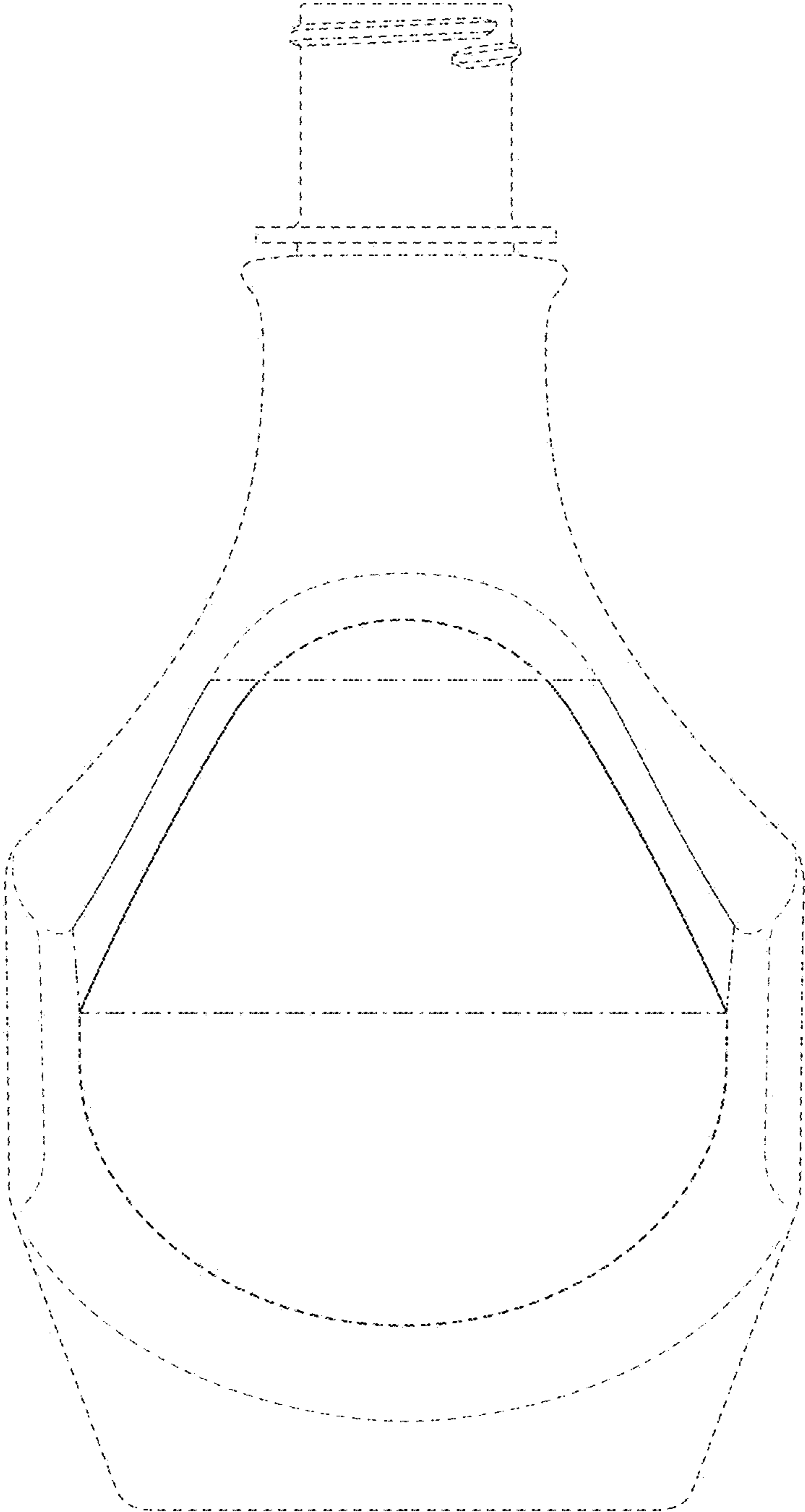

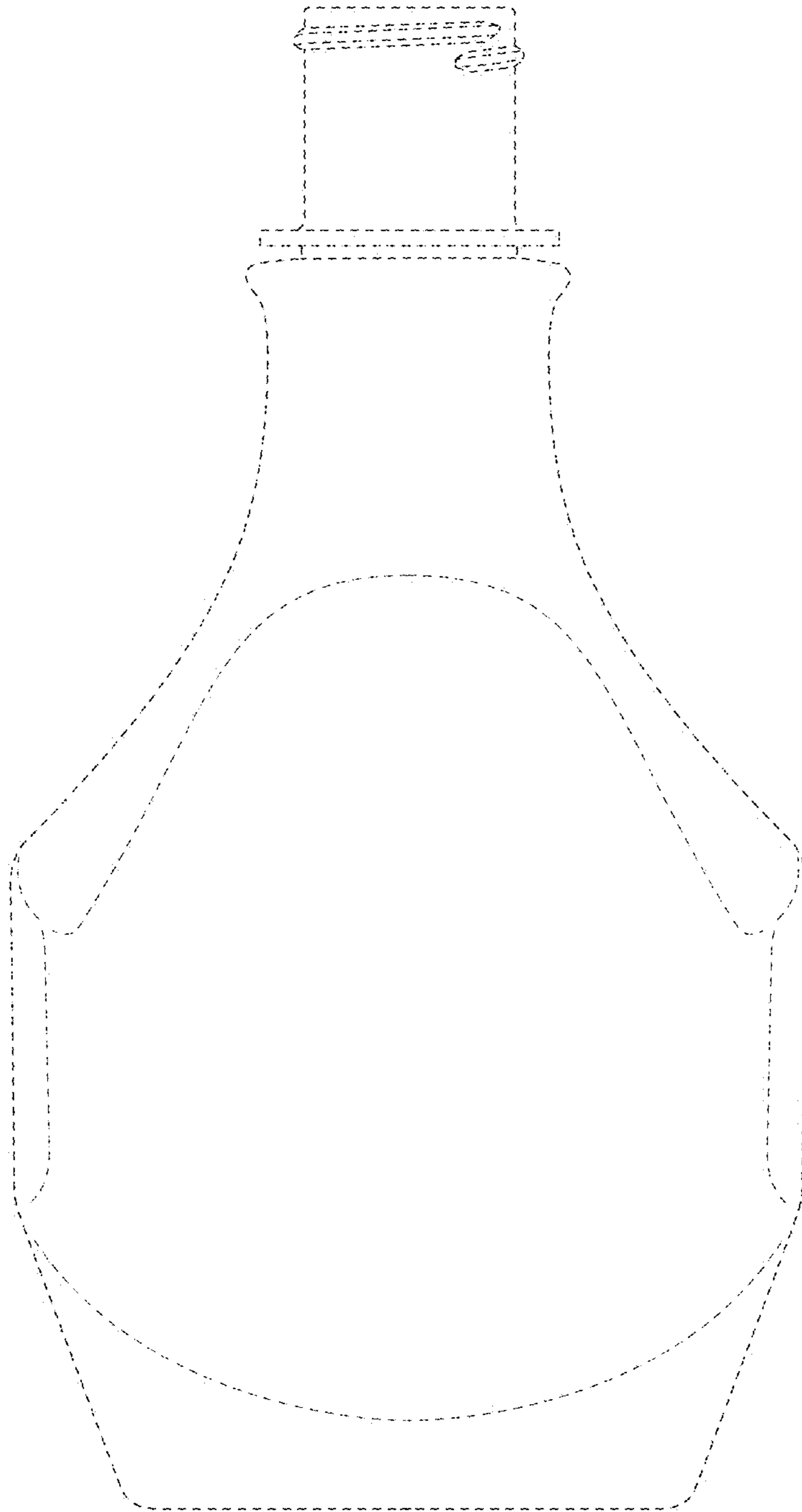

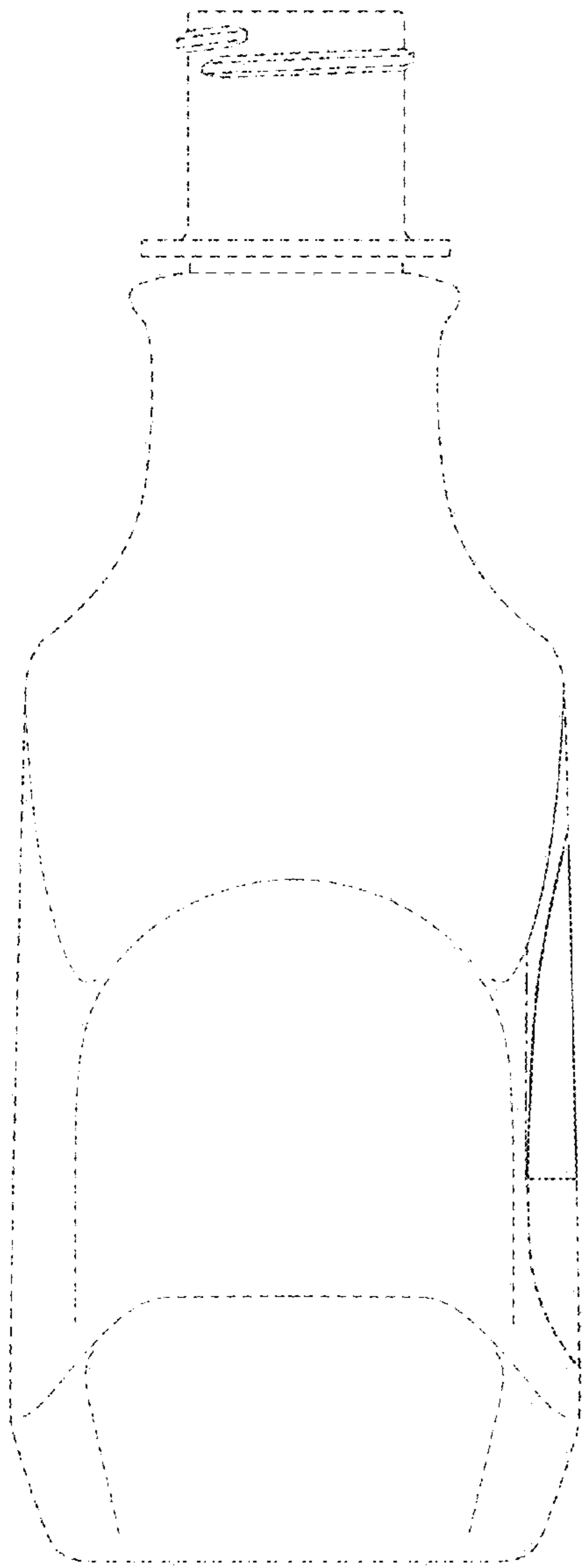

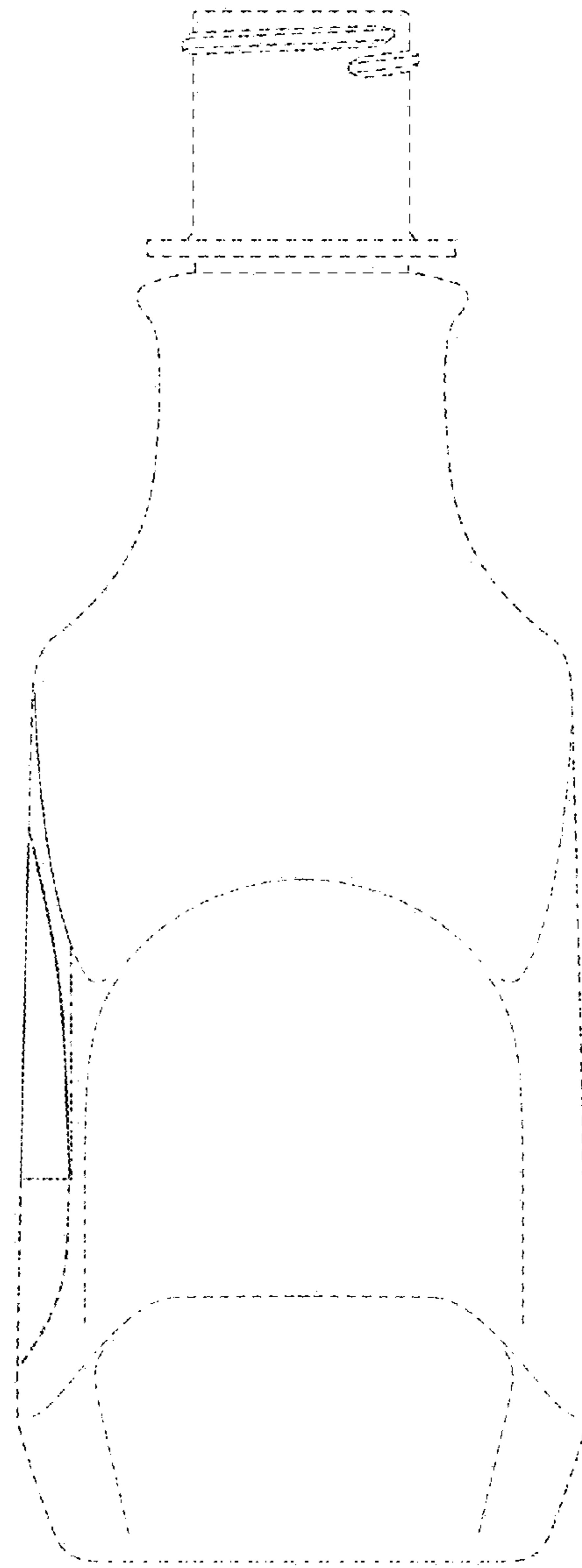

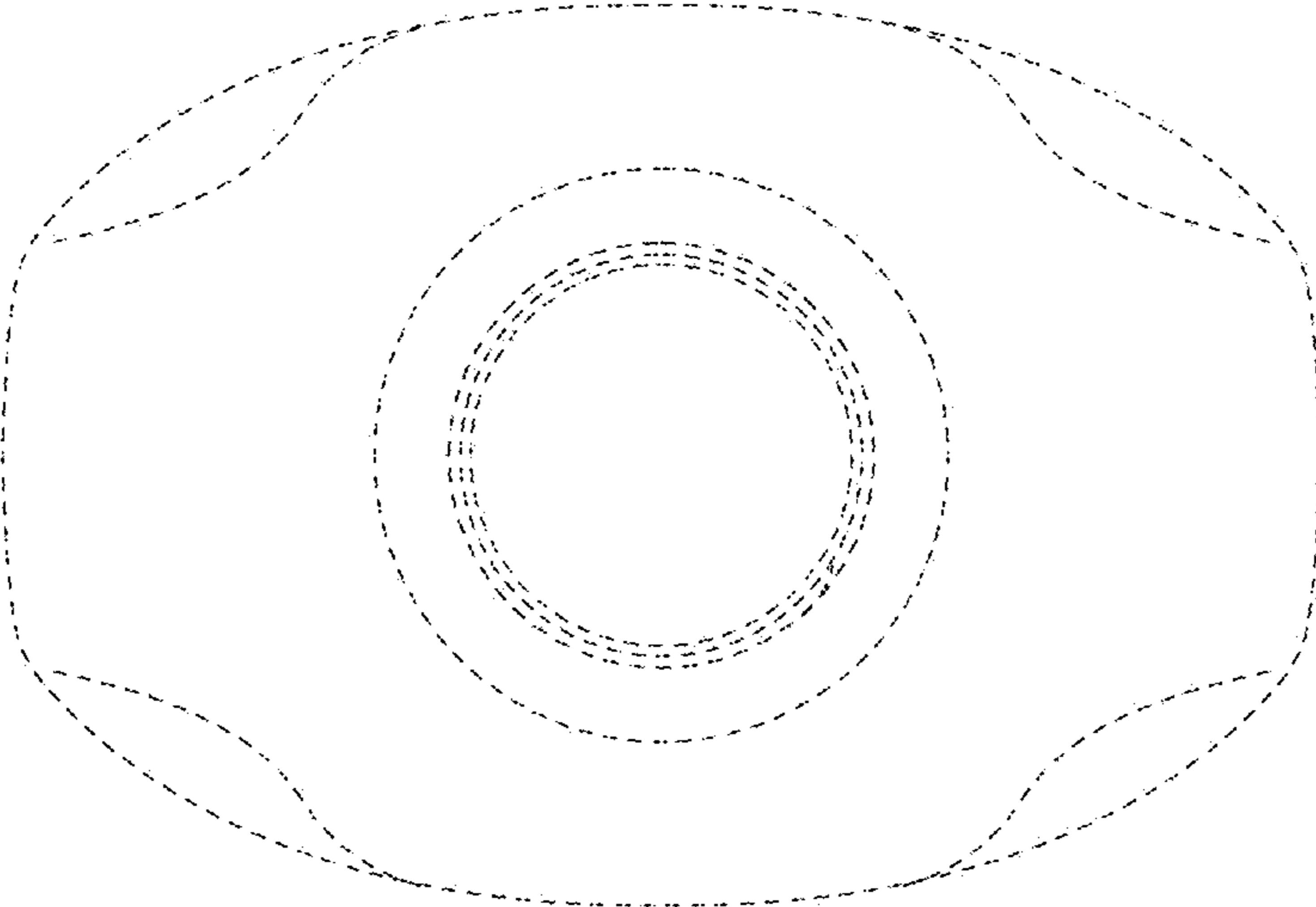

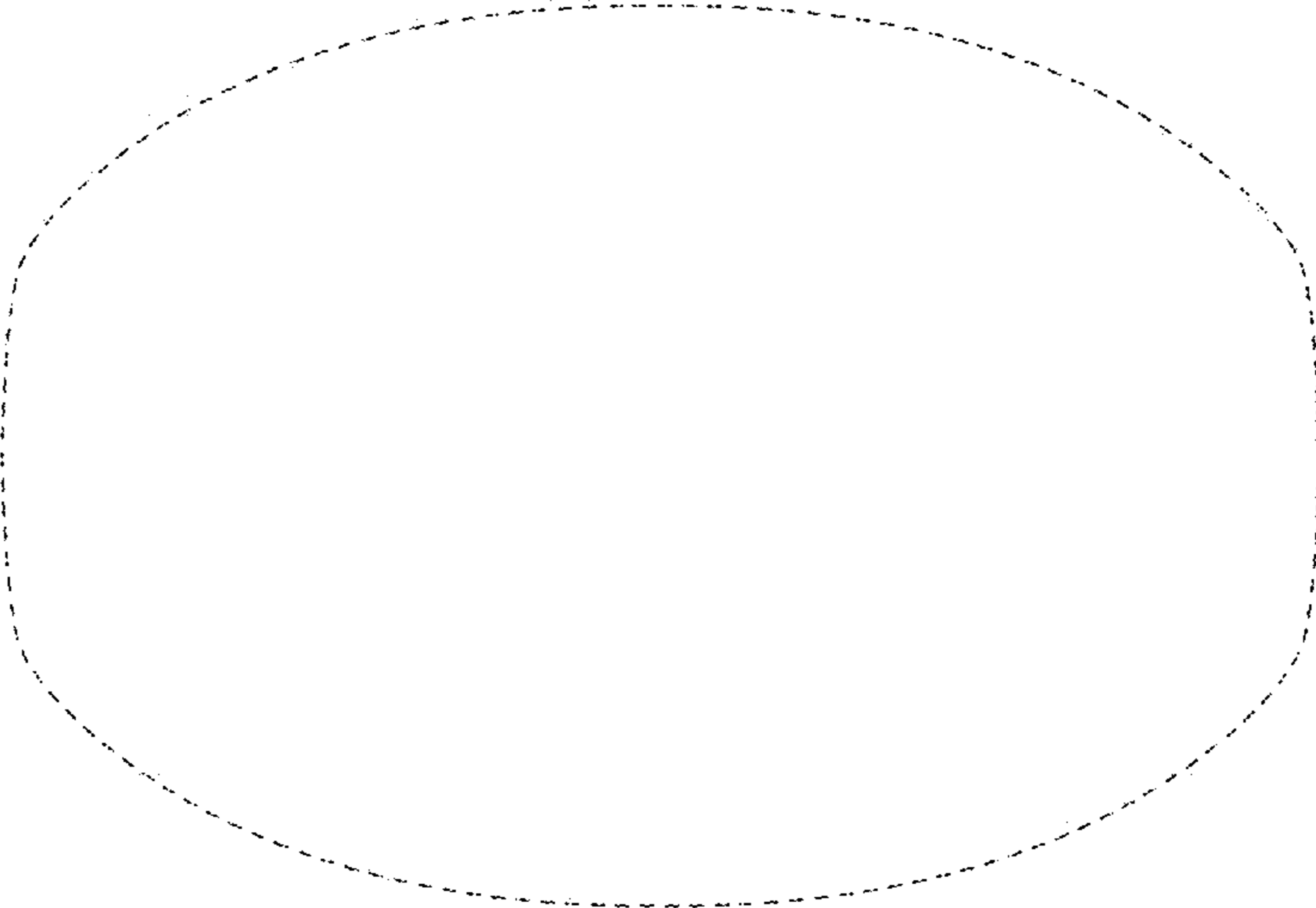
