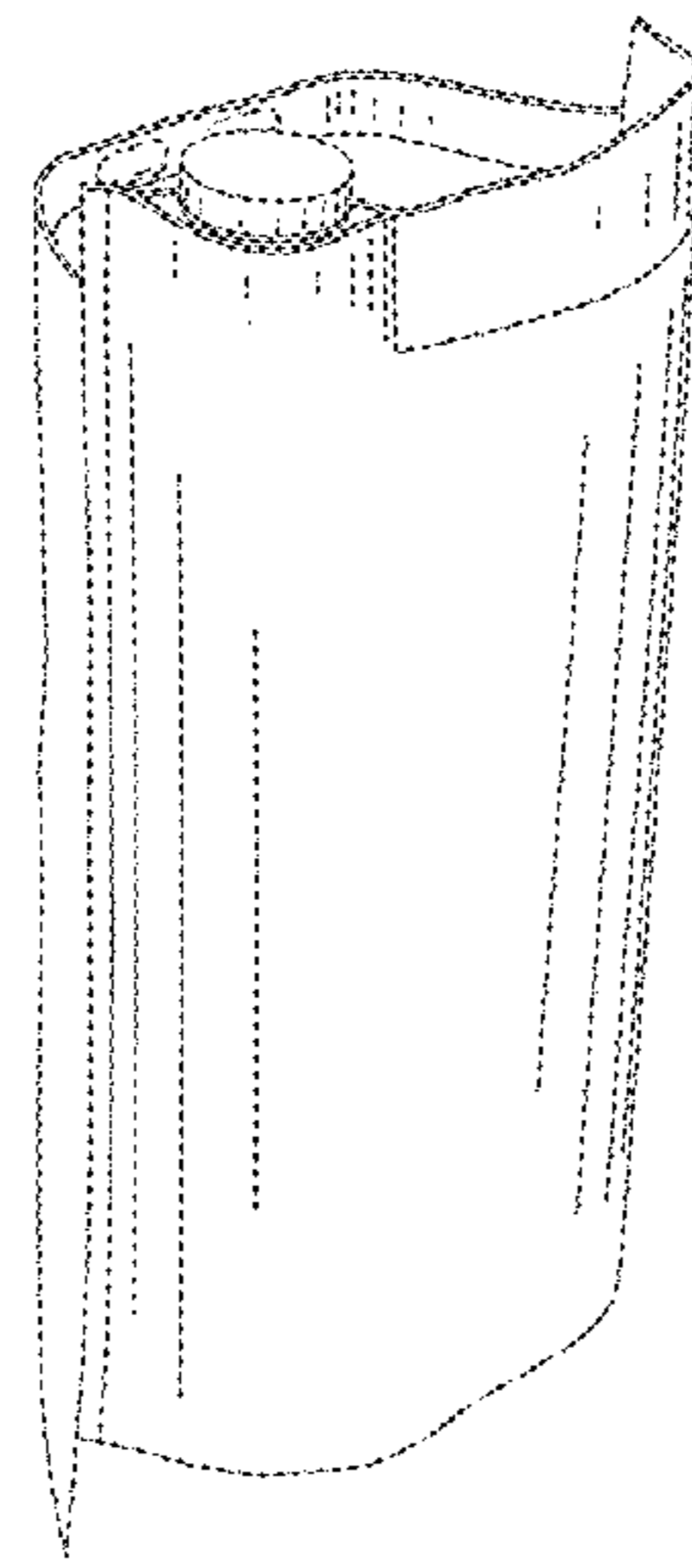
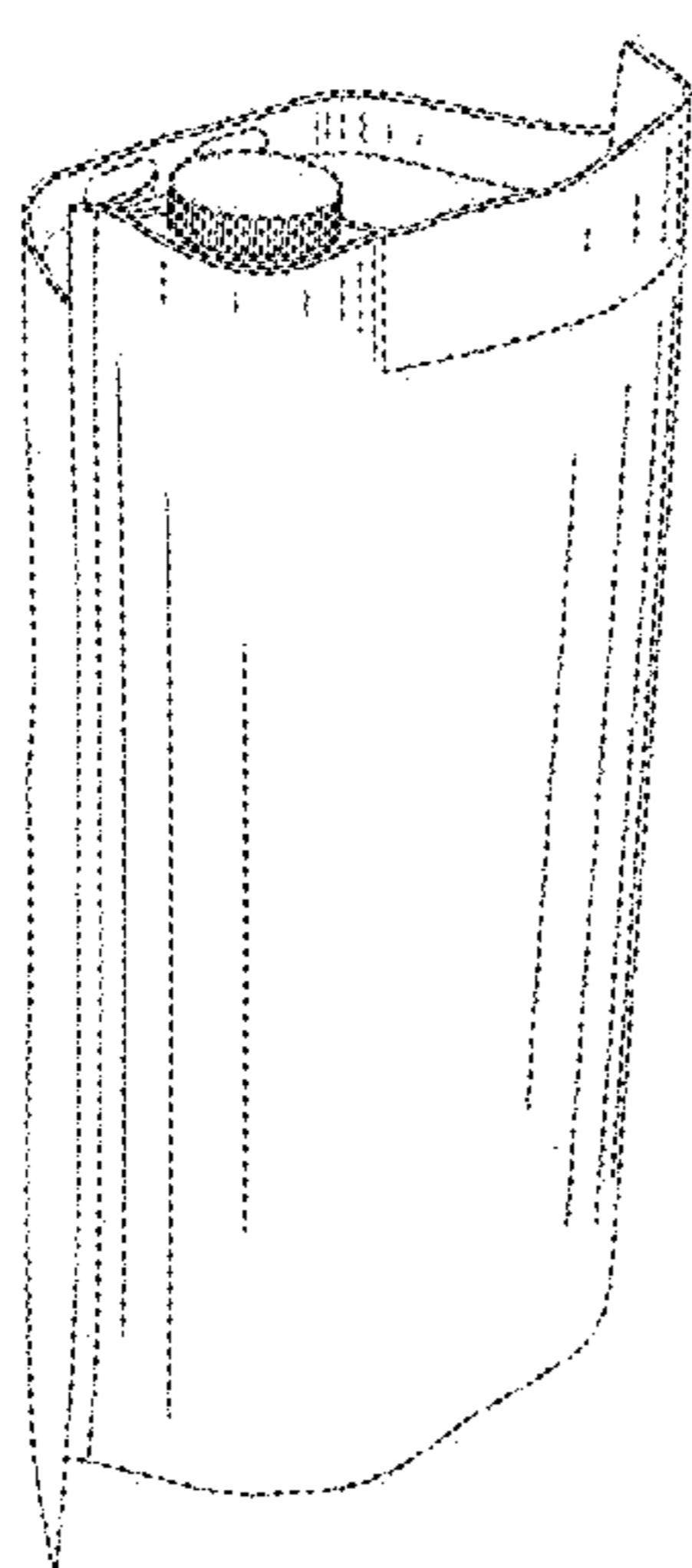
The ornamental design for the bulk consumables pouch, as shown and described.

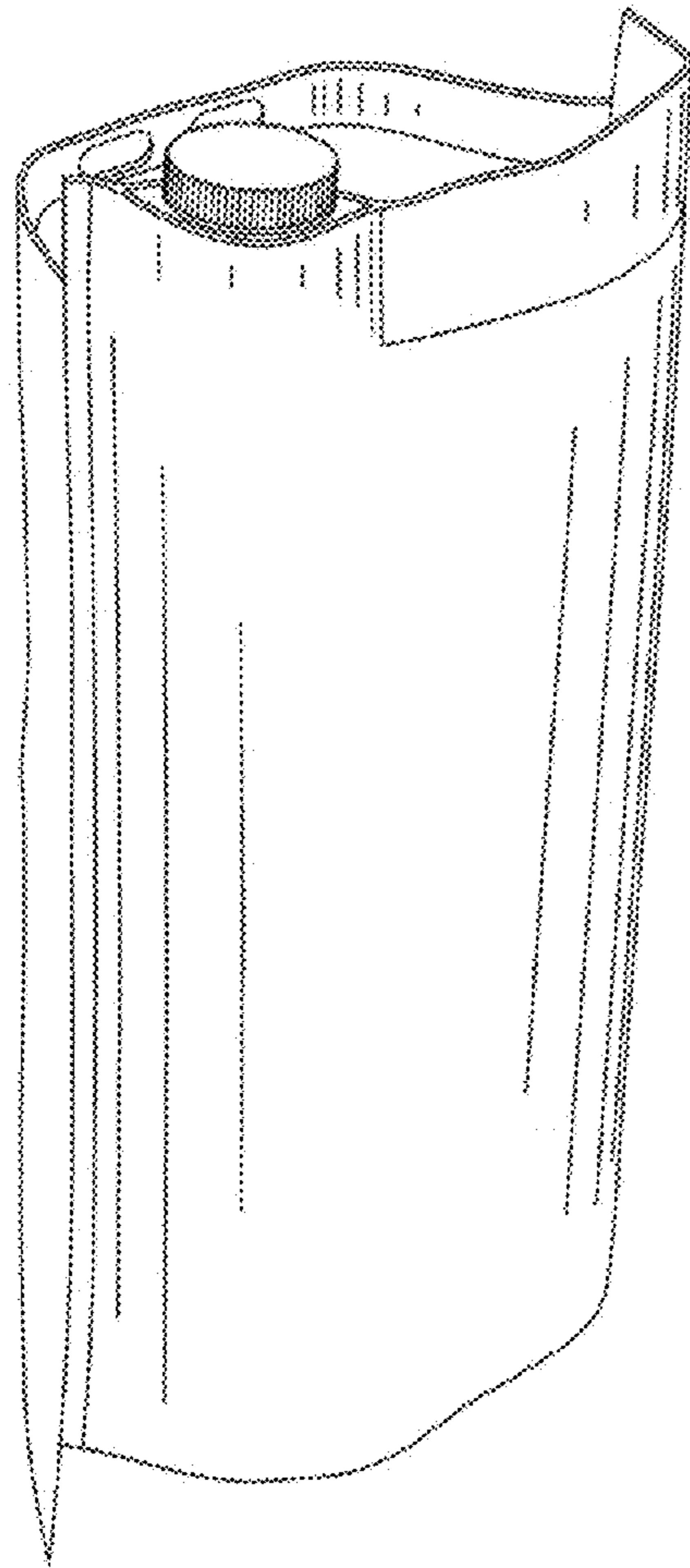

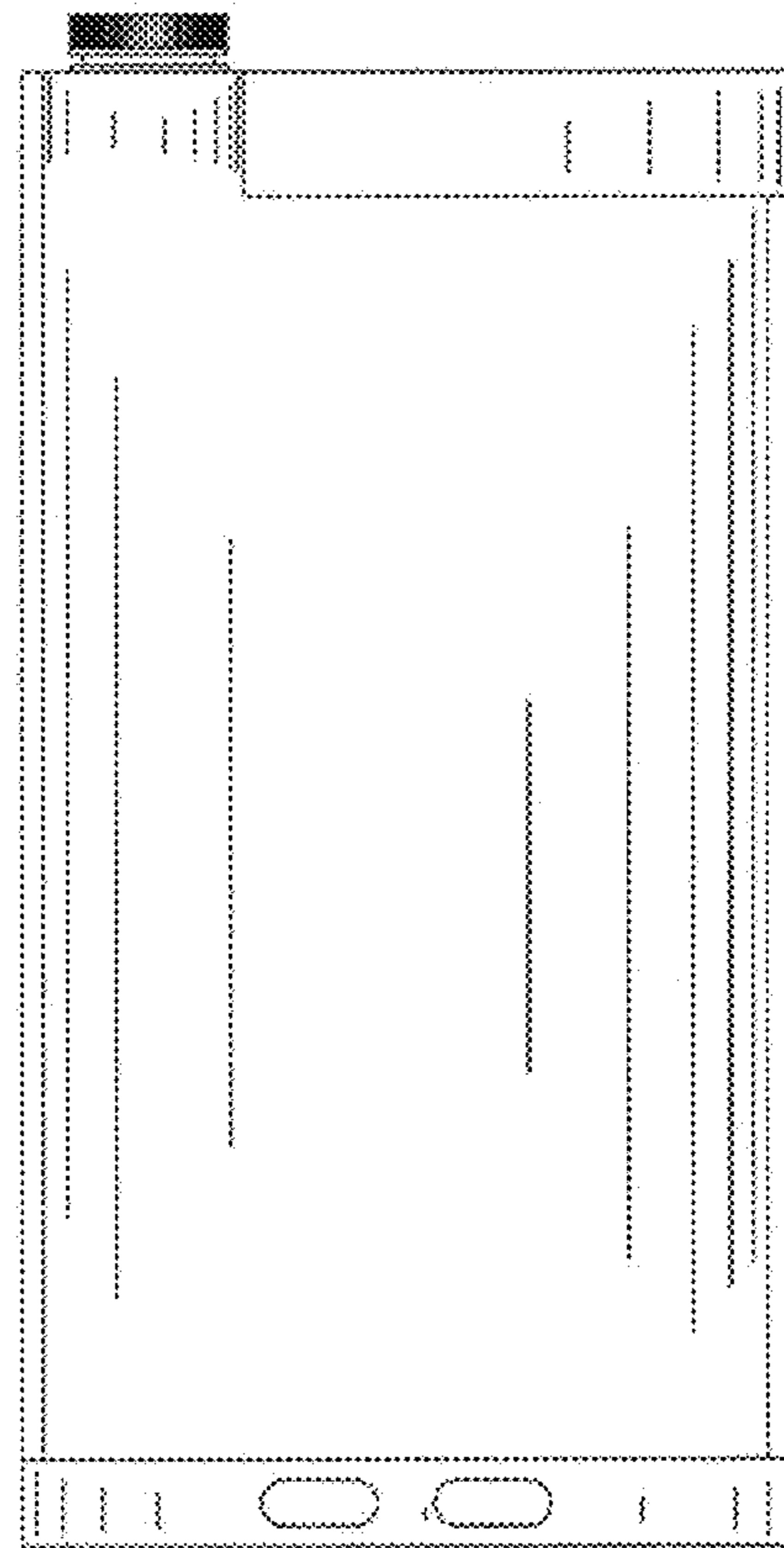

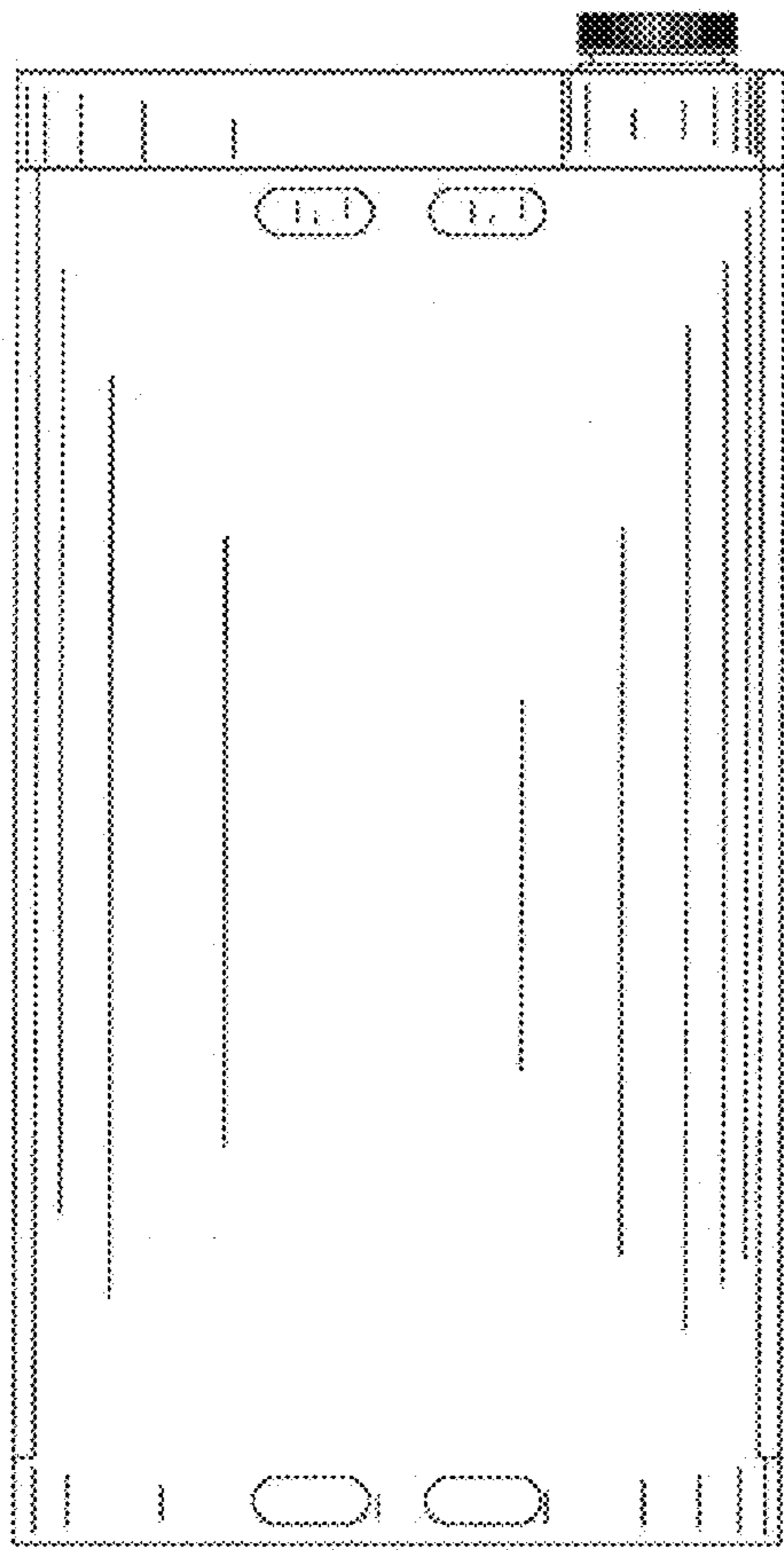

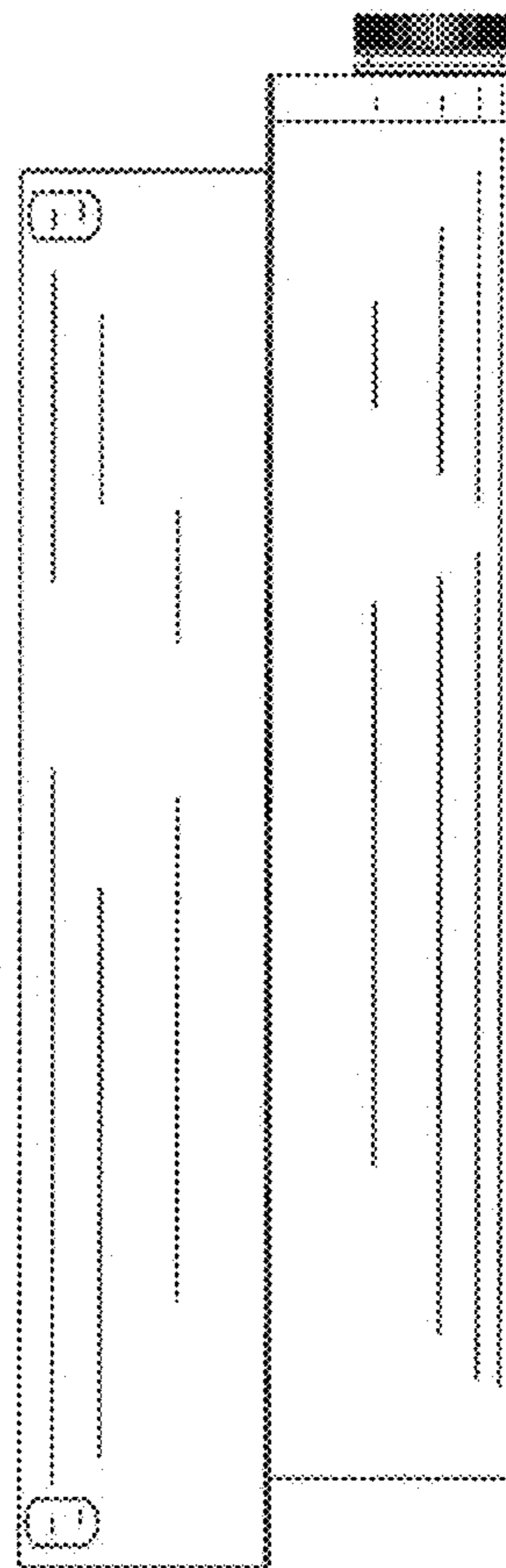

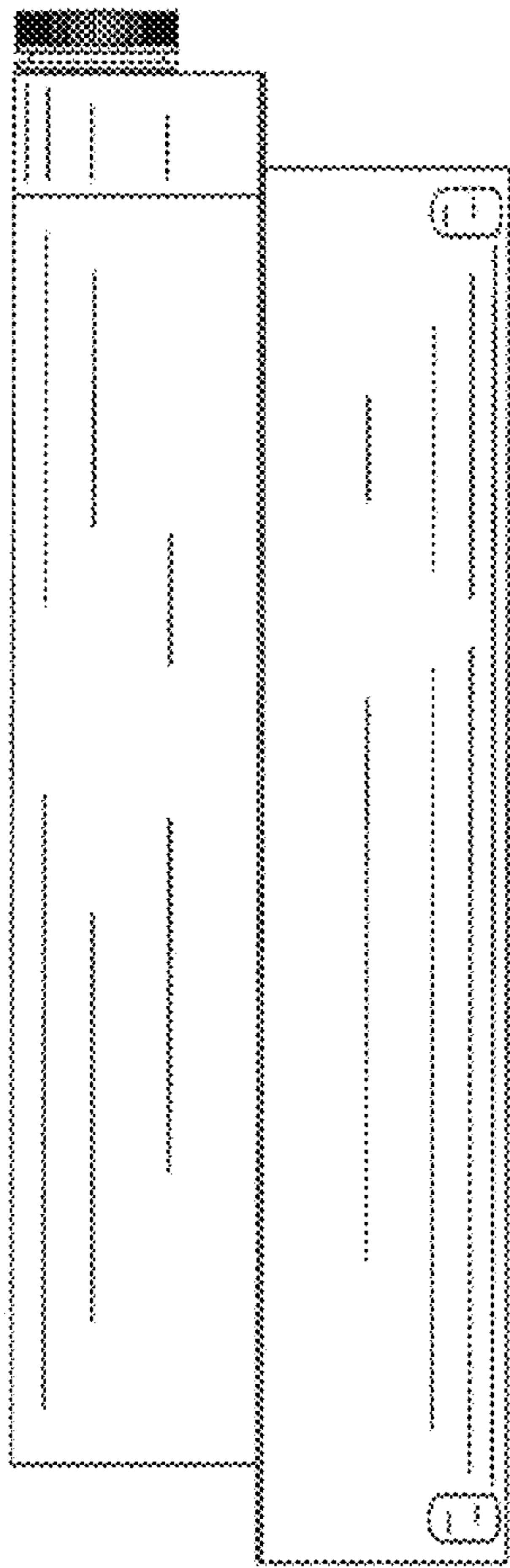

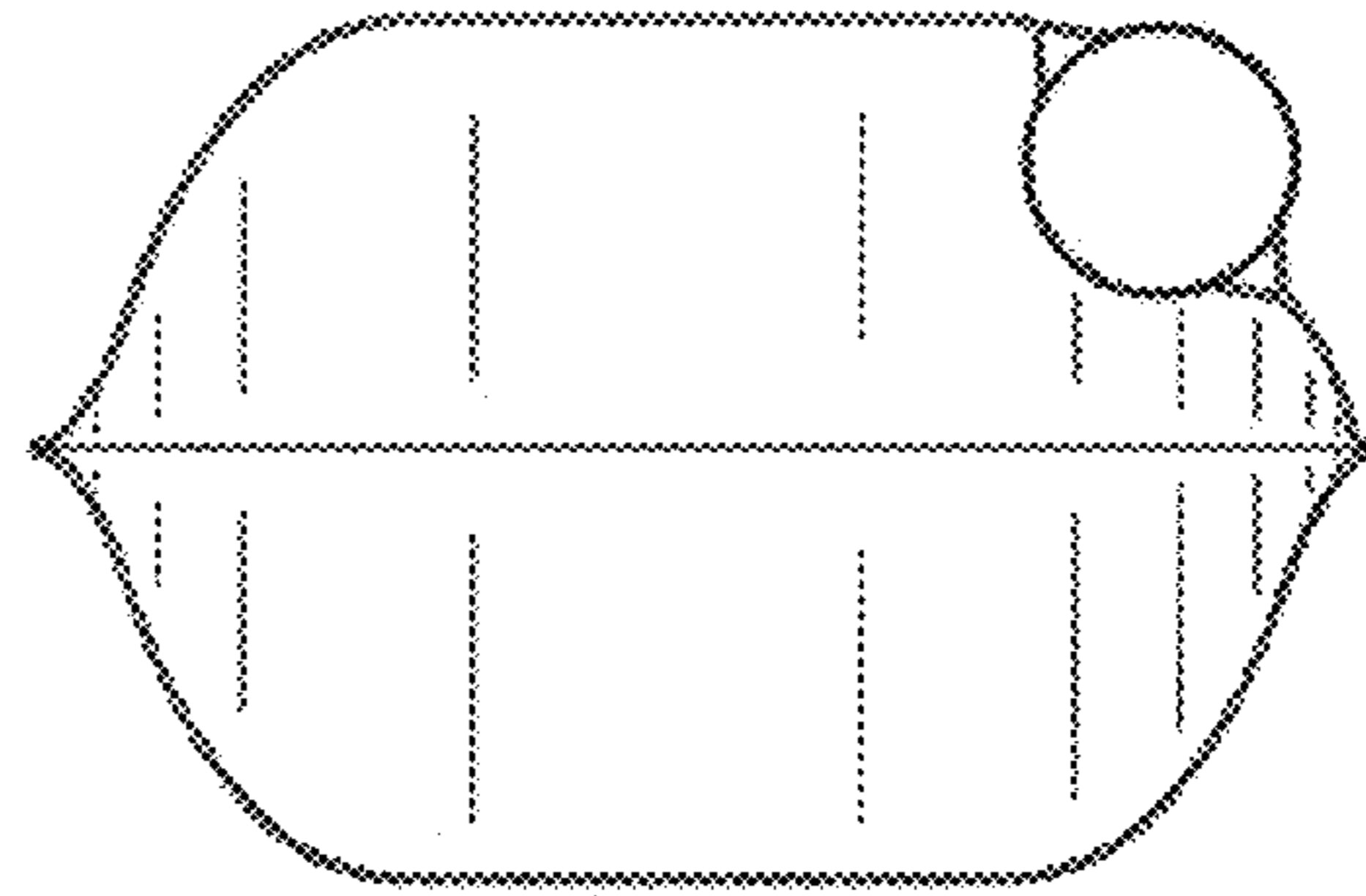

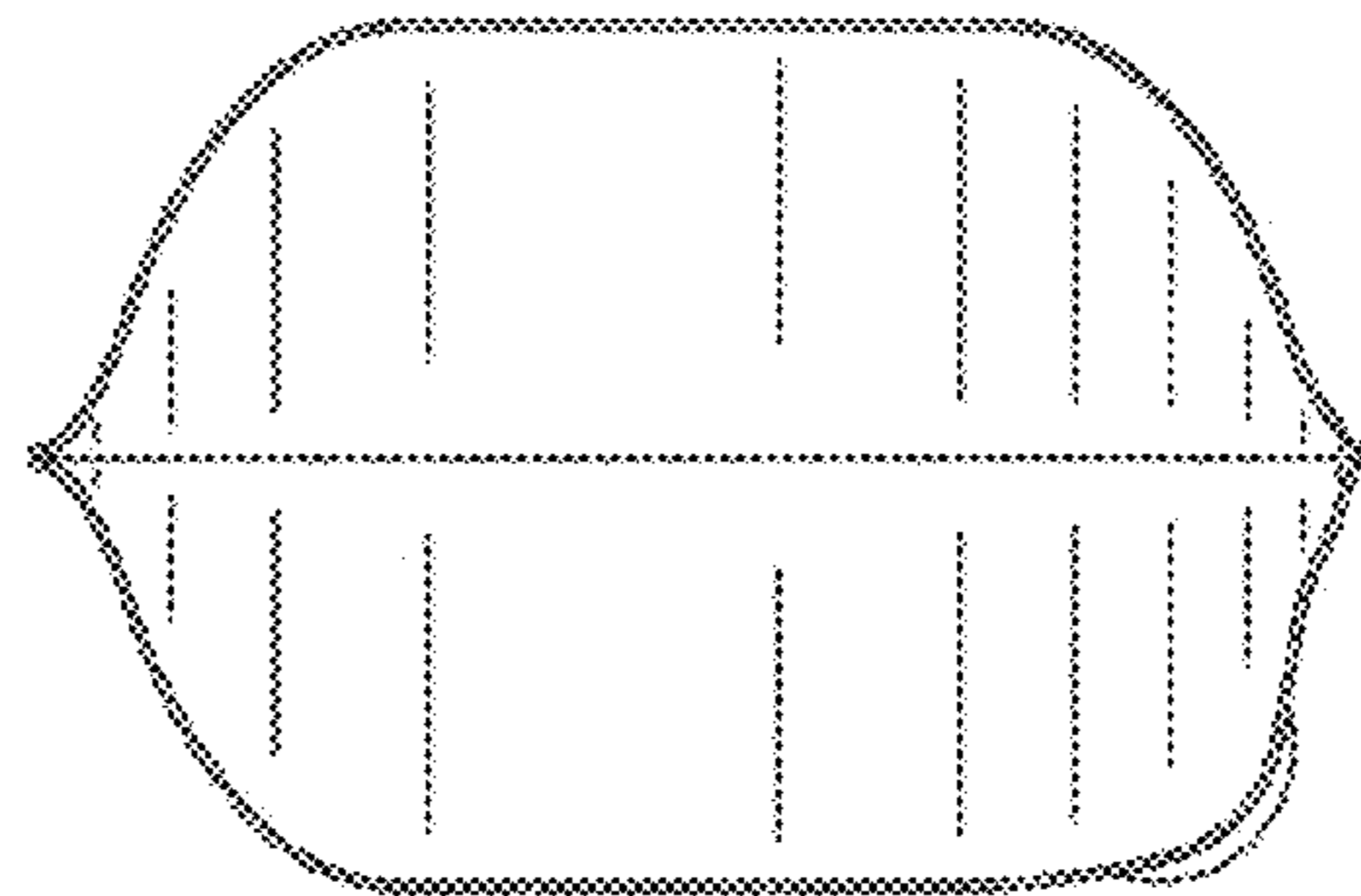

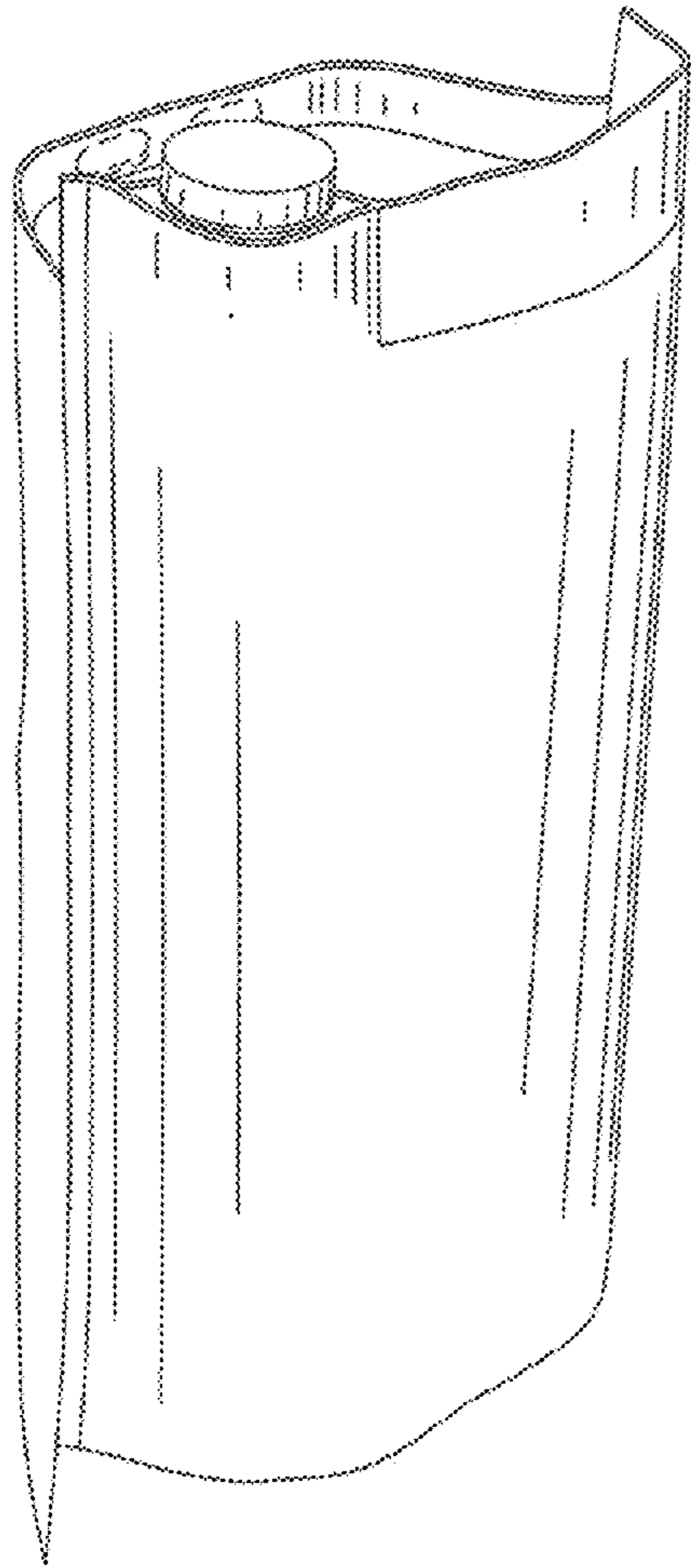

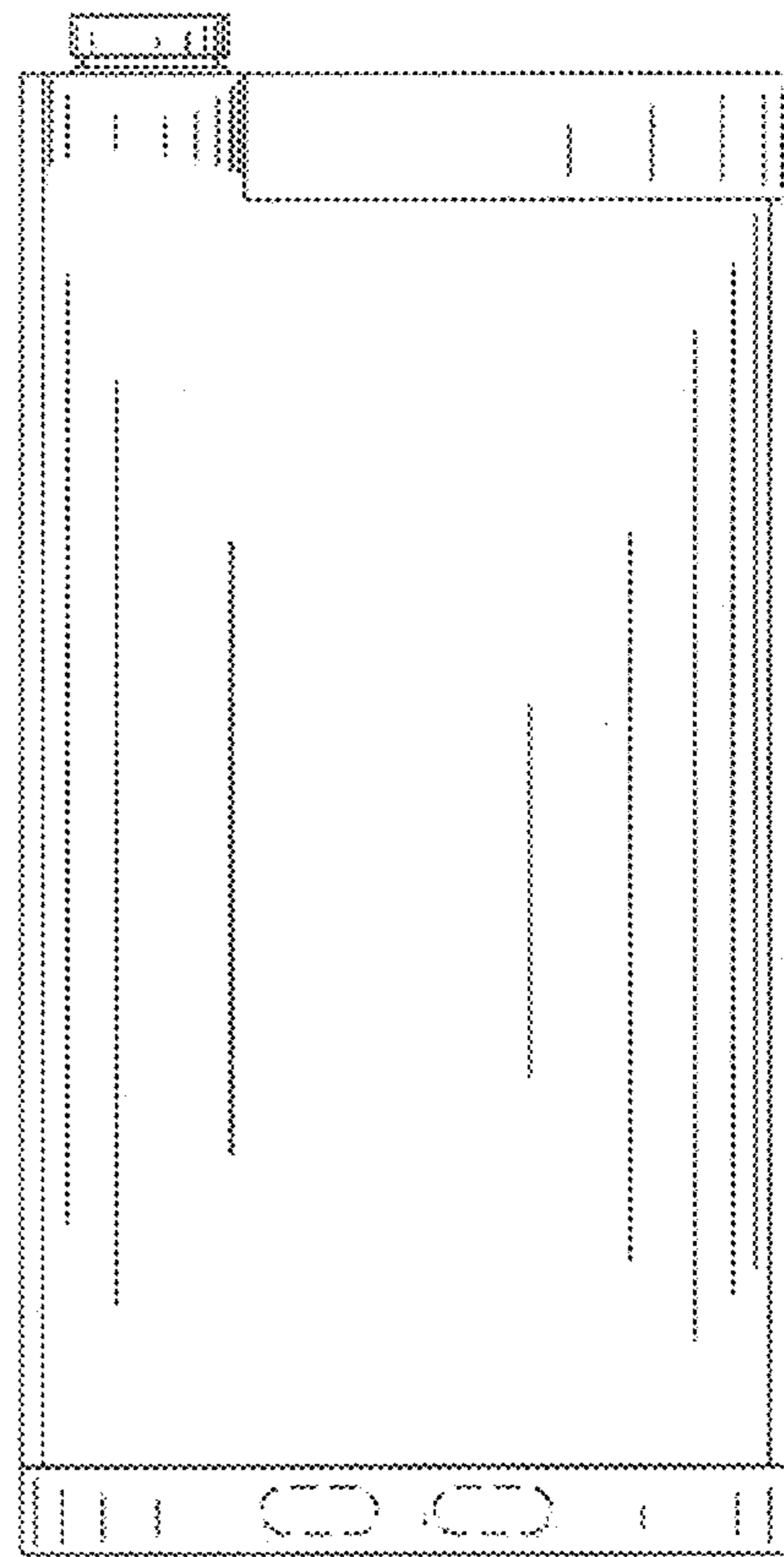

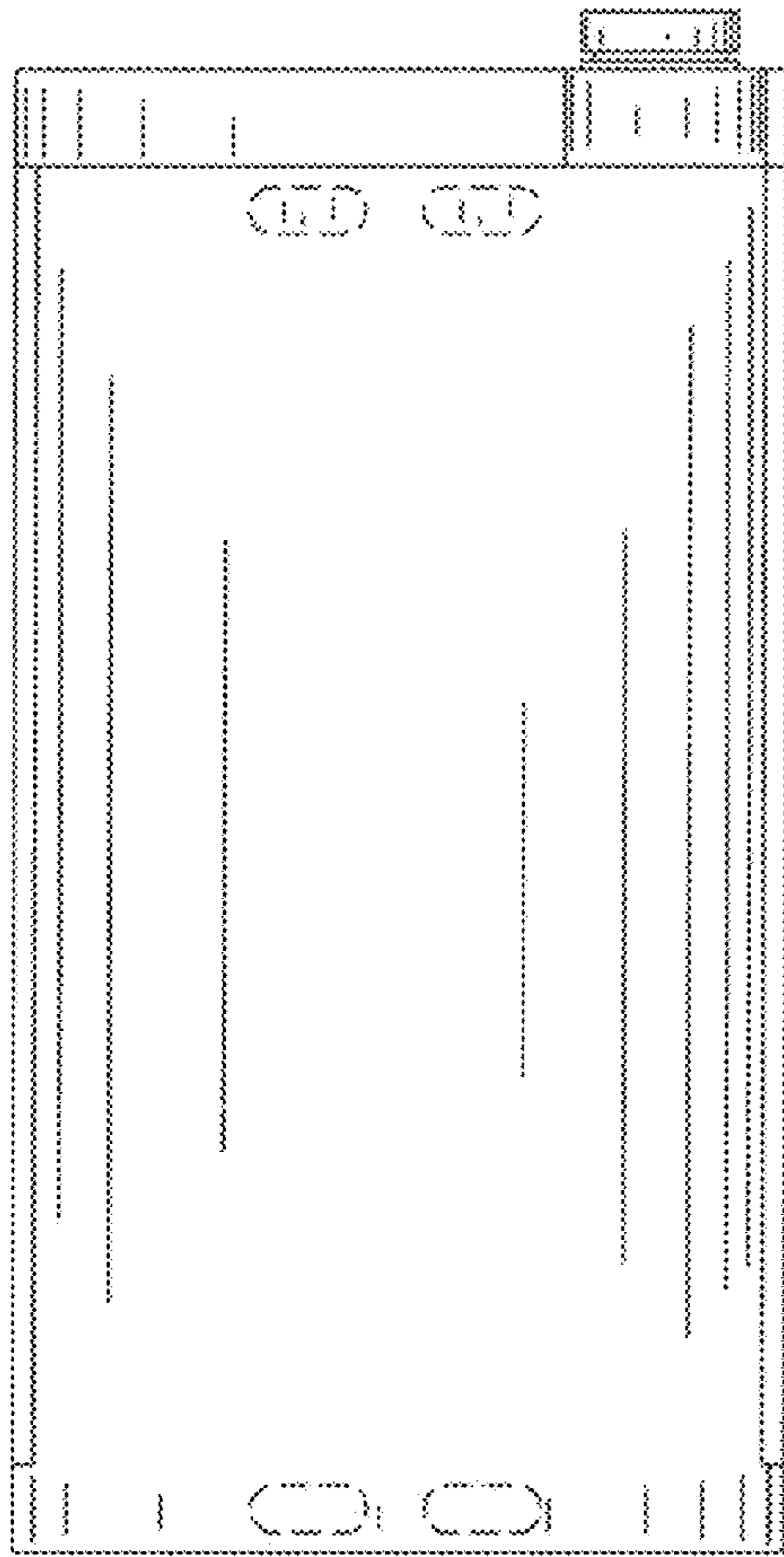

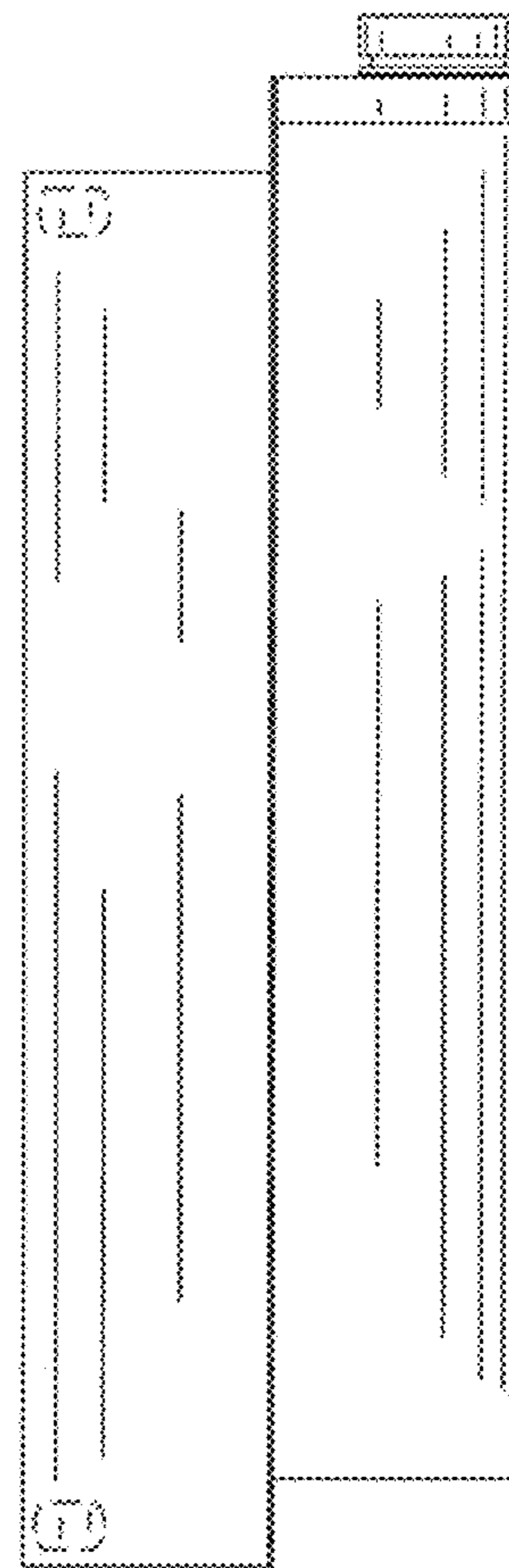

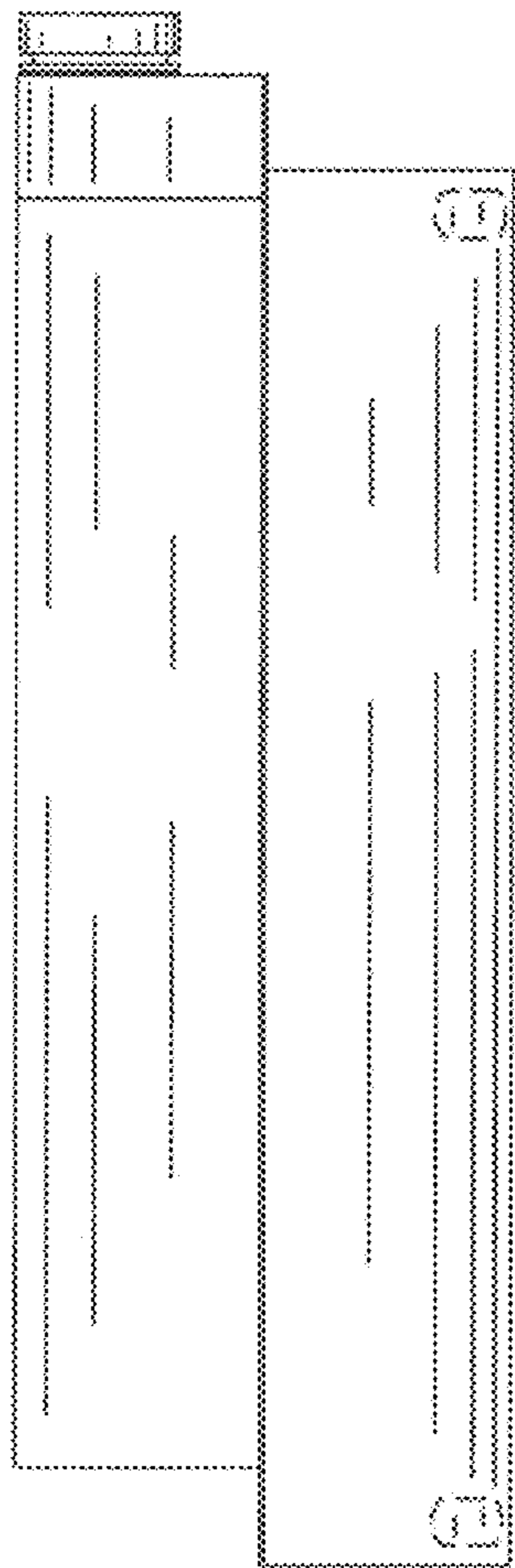

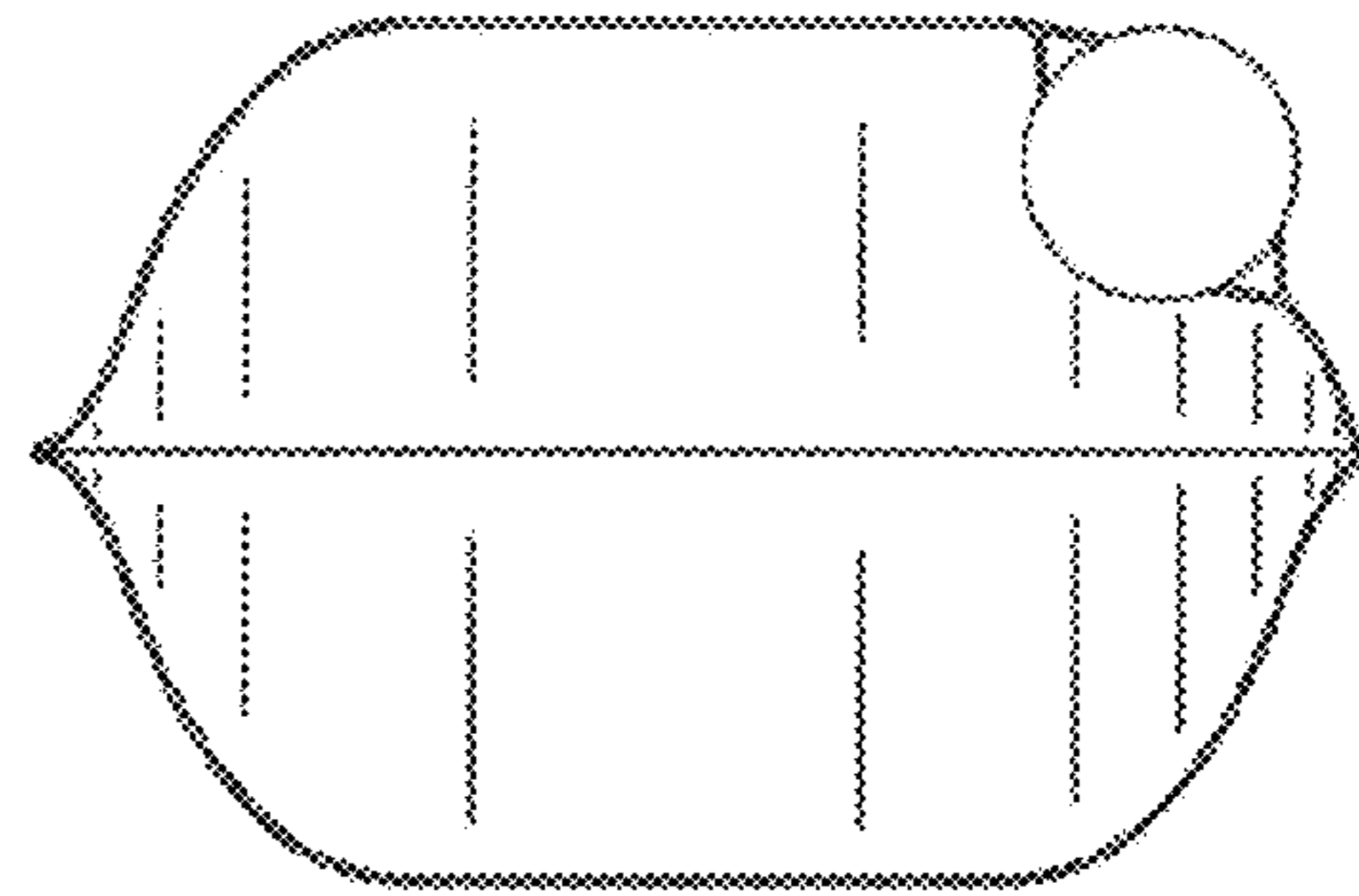

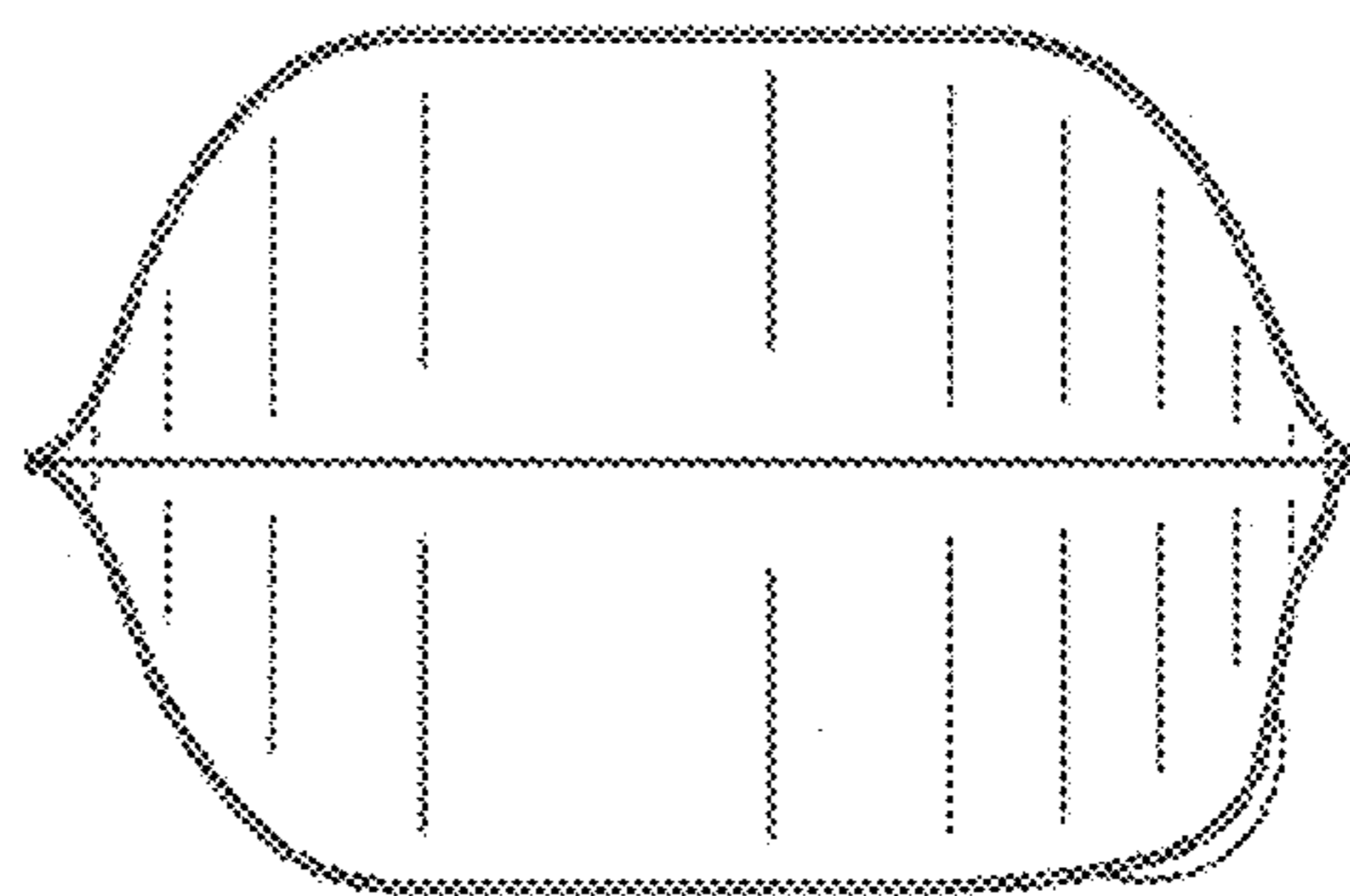
