(57) **CLAIM**

The ornamental design for a battery charger for small electronic appliances, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a battery charger for small electronic appliances showing our new design;

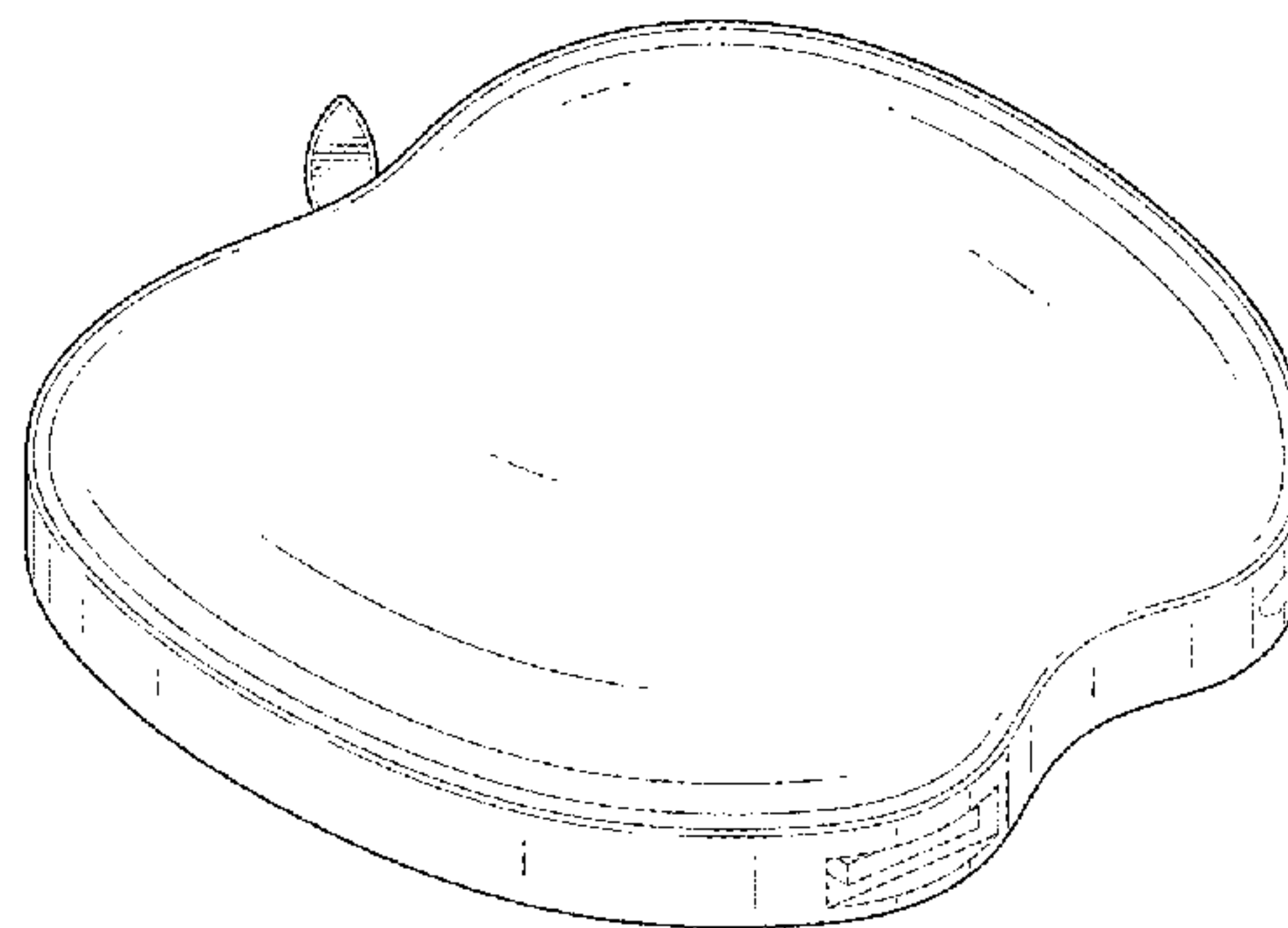
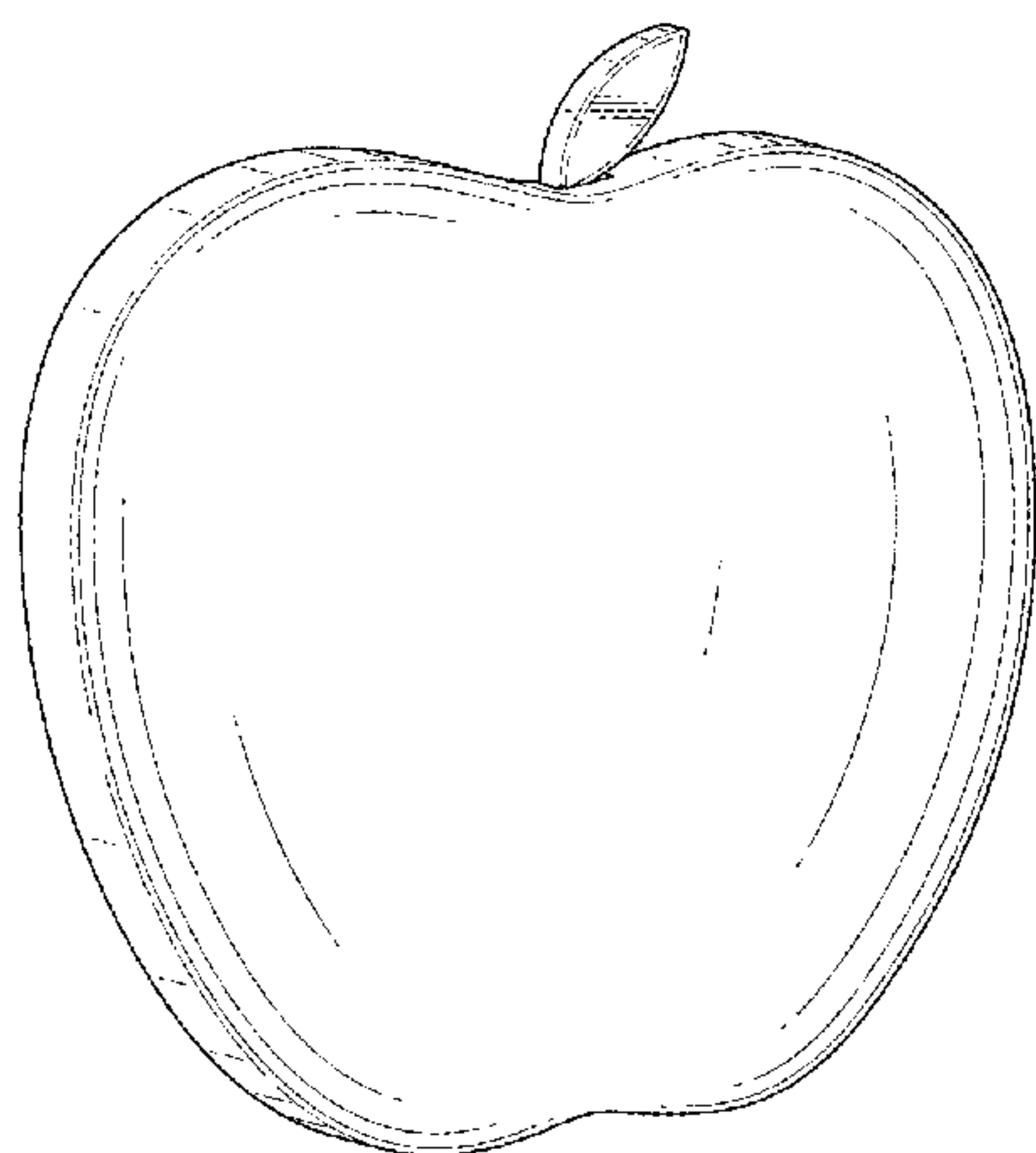

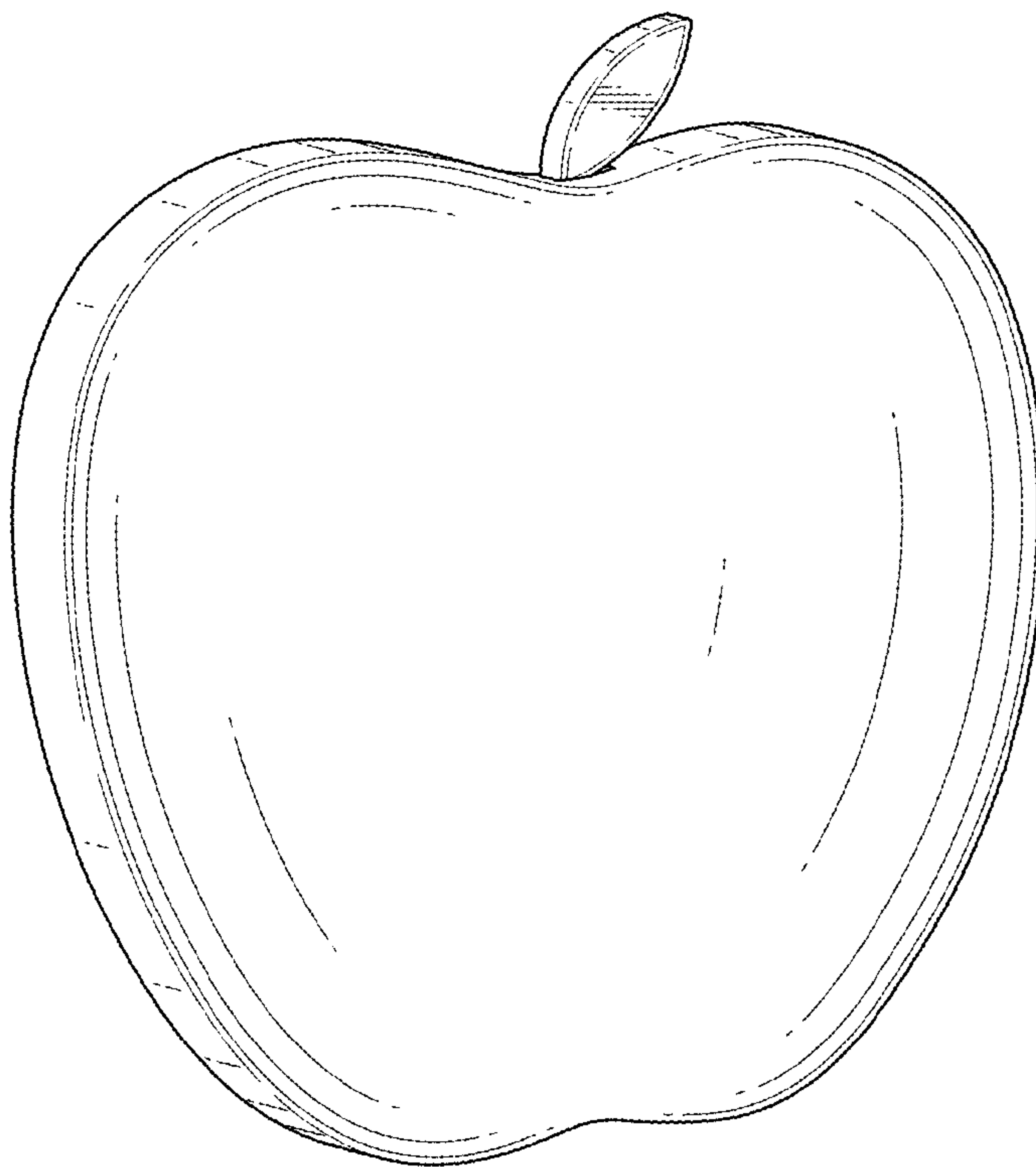
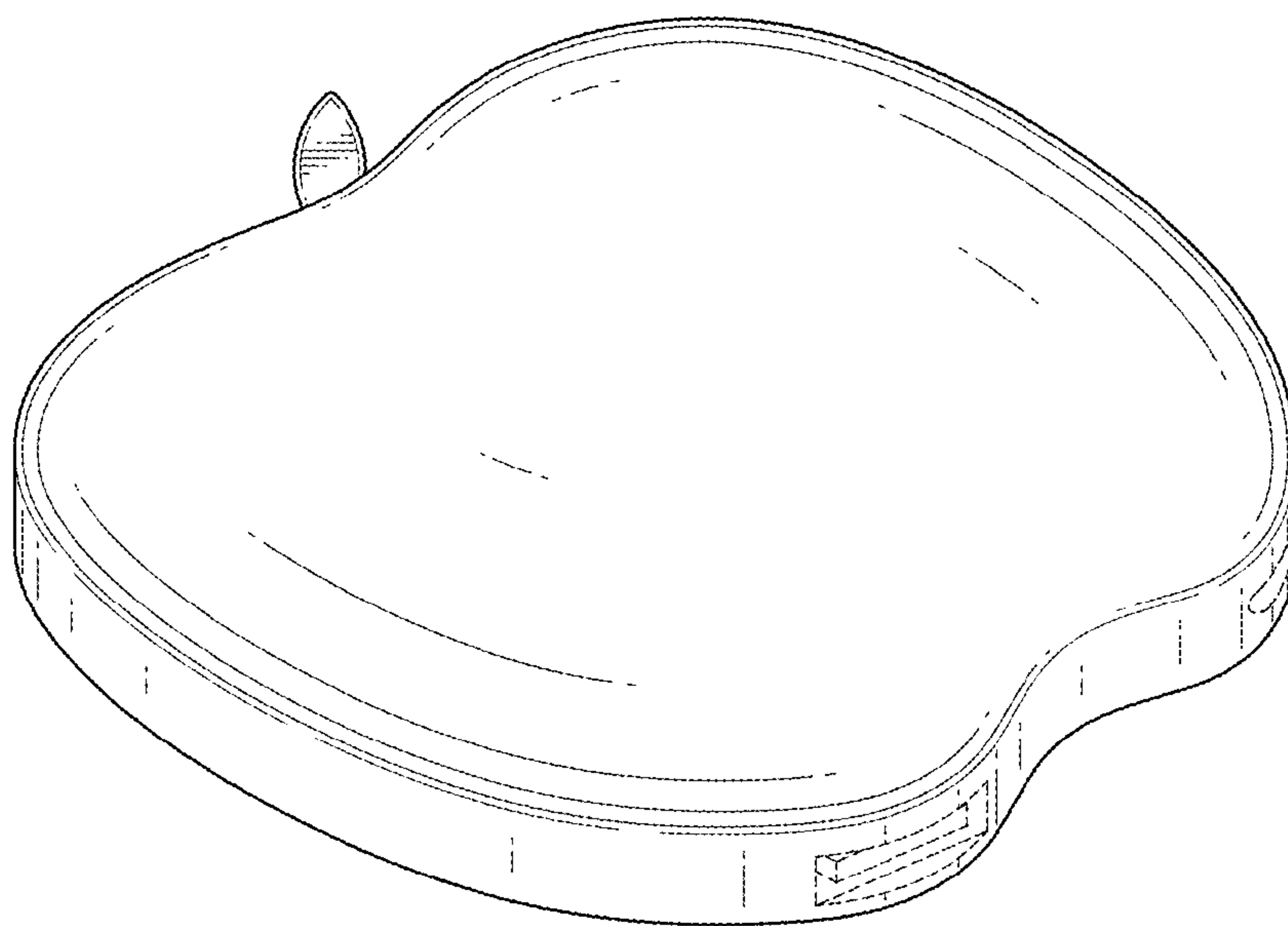

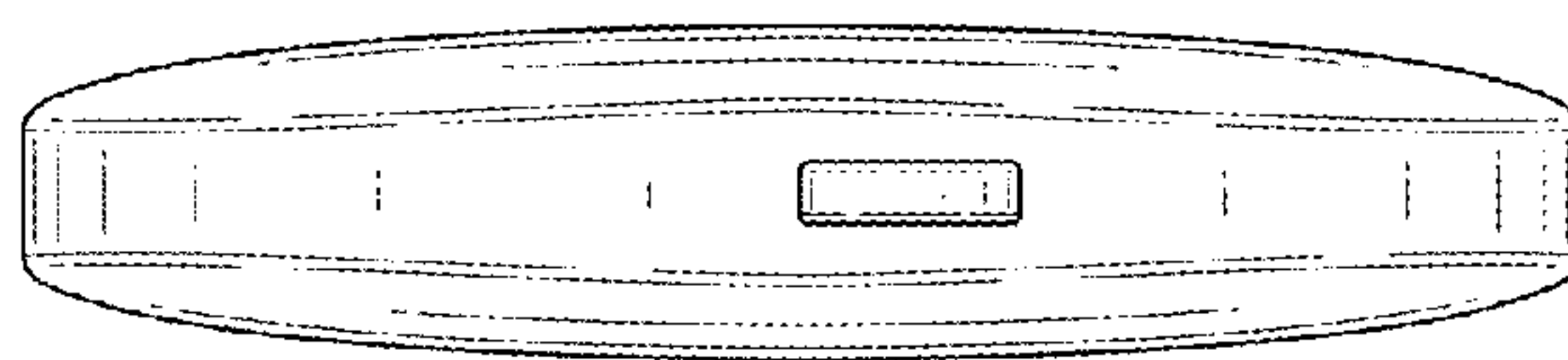

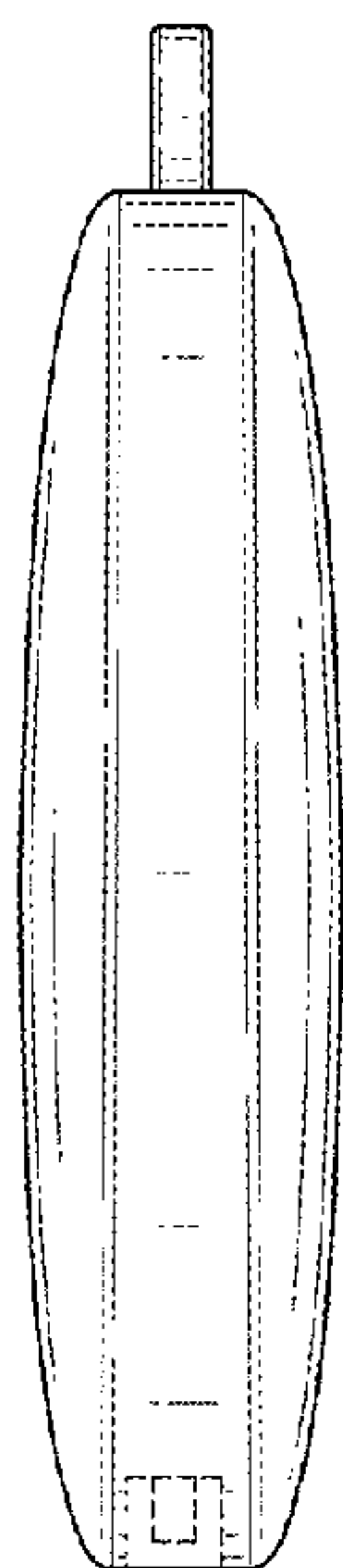

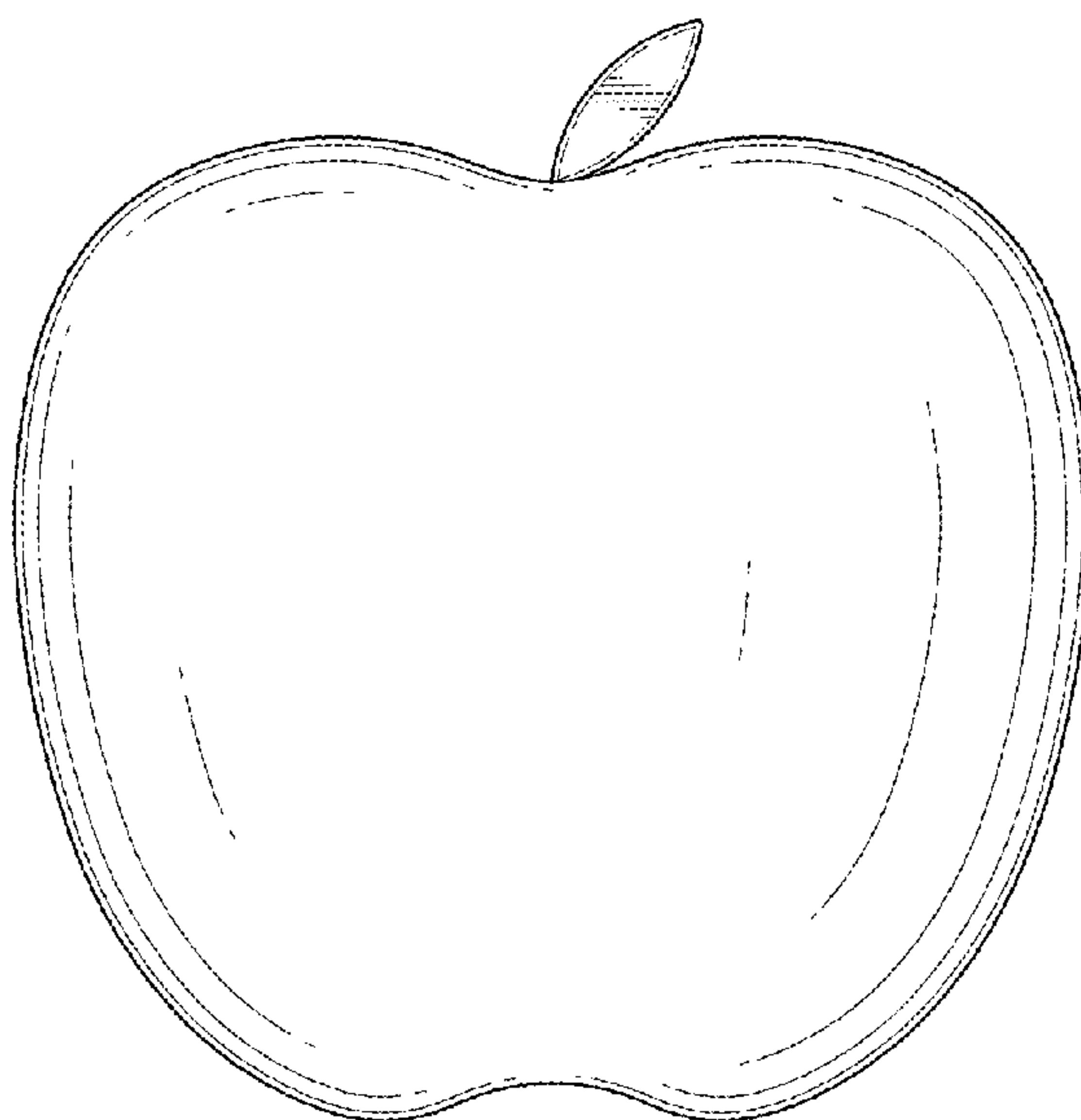

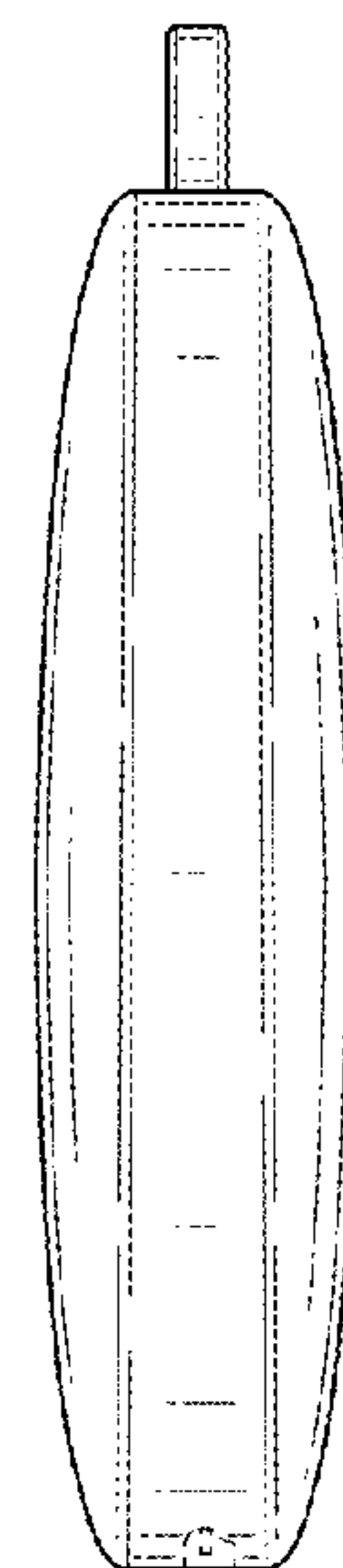

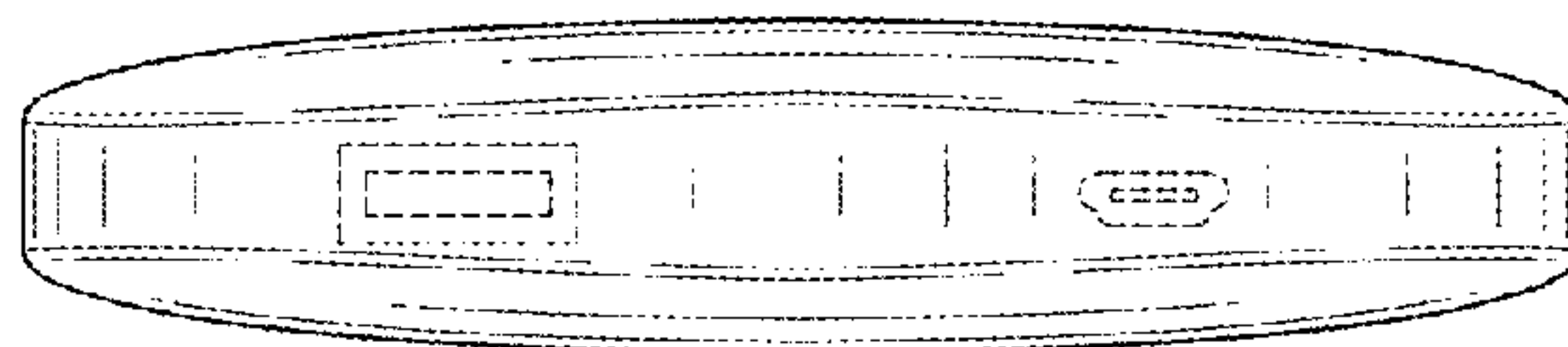
