The ornamental design for a charger for cellular phone, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, perspective view of a charger for cellular phone showing our new design;

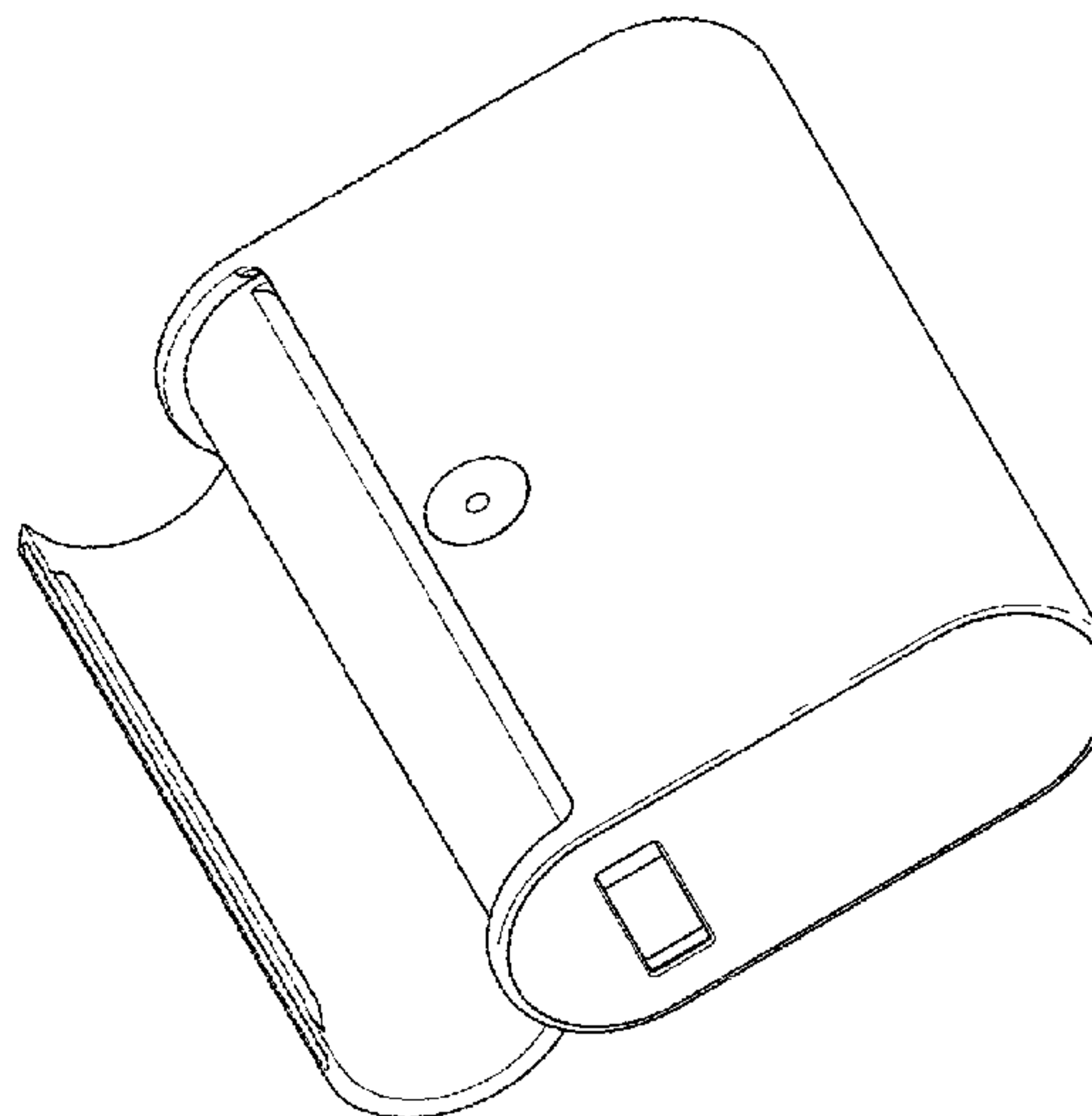
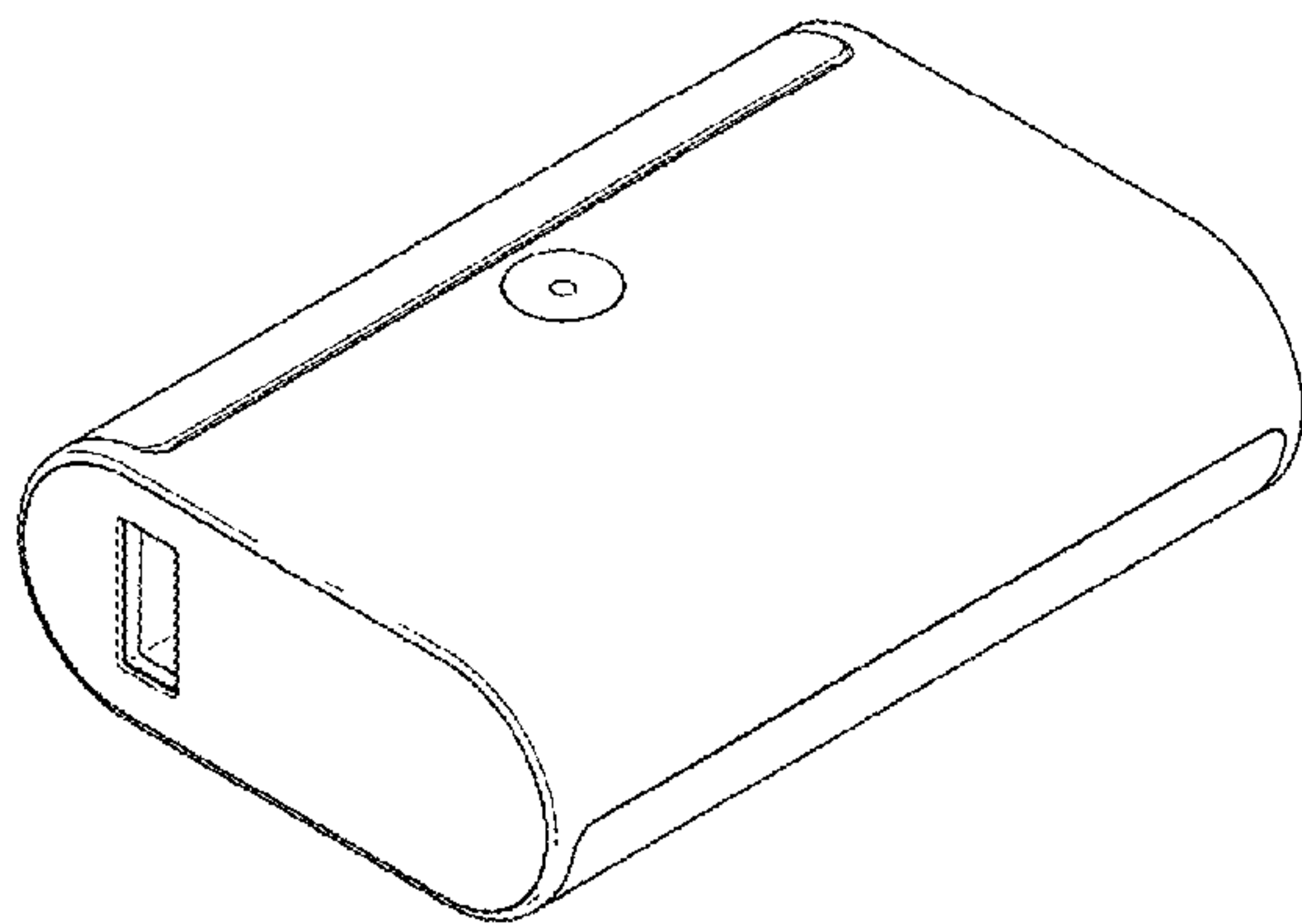

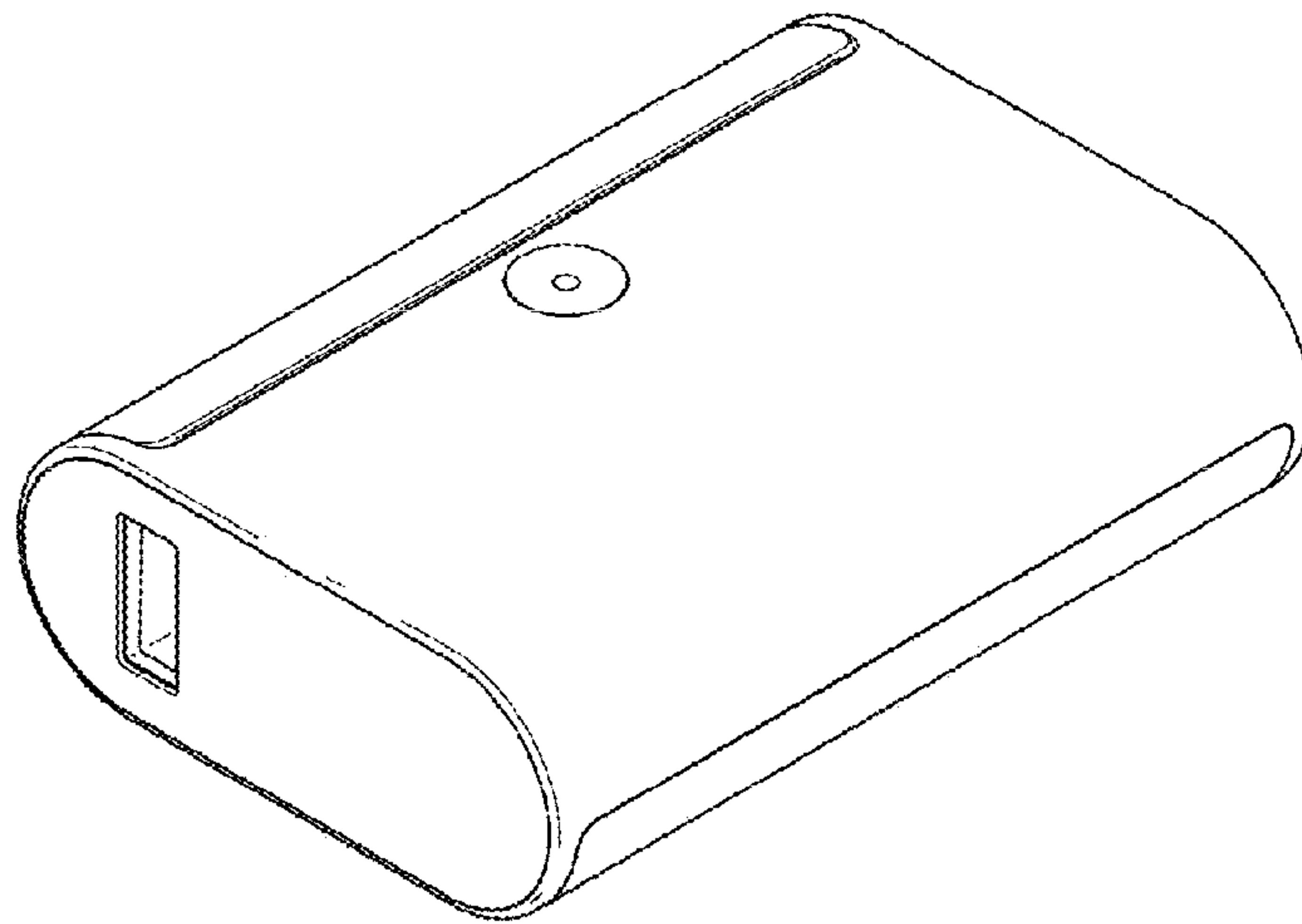

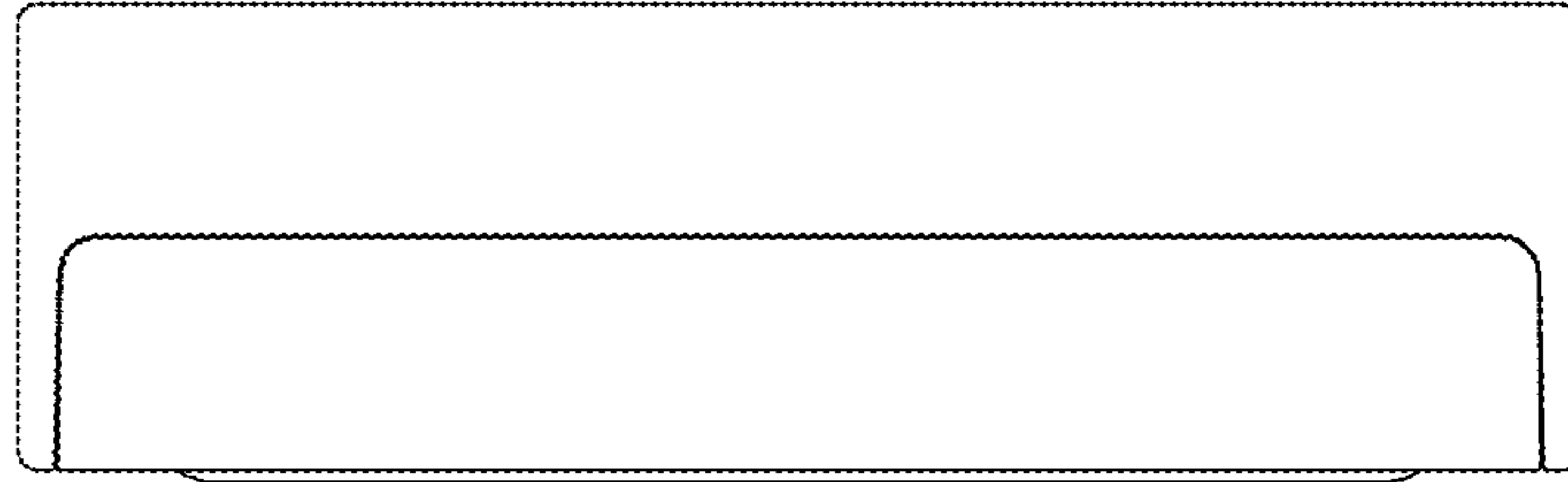

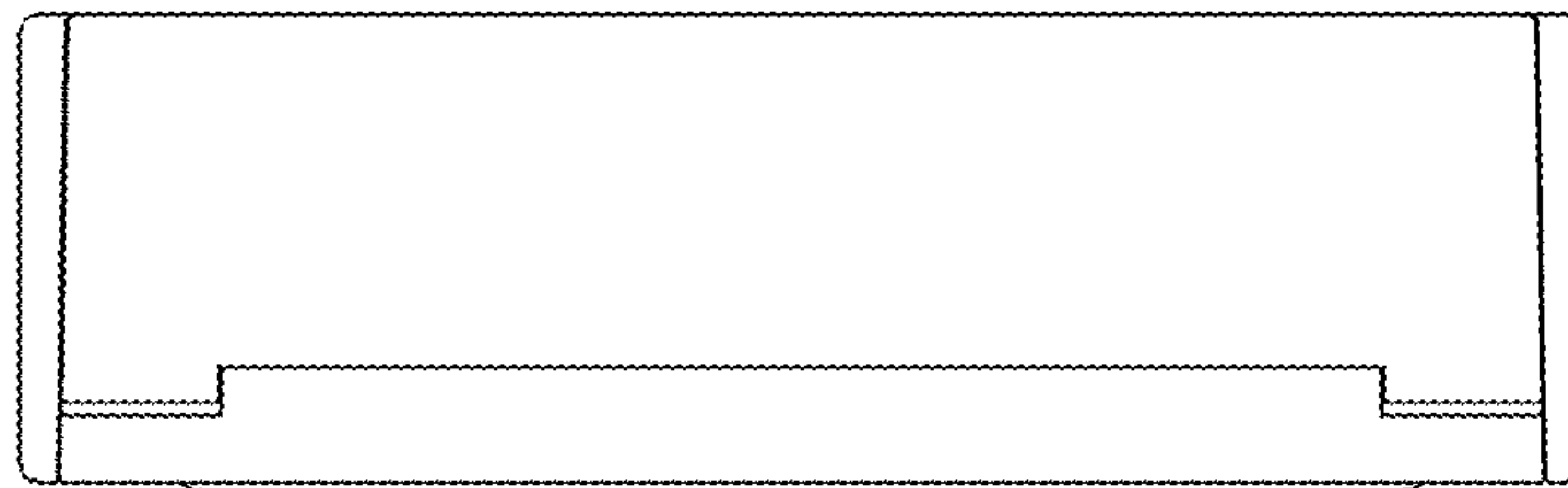

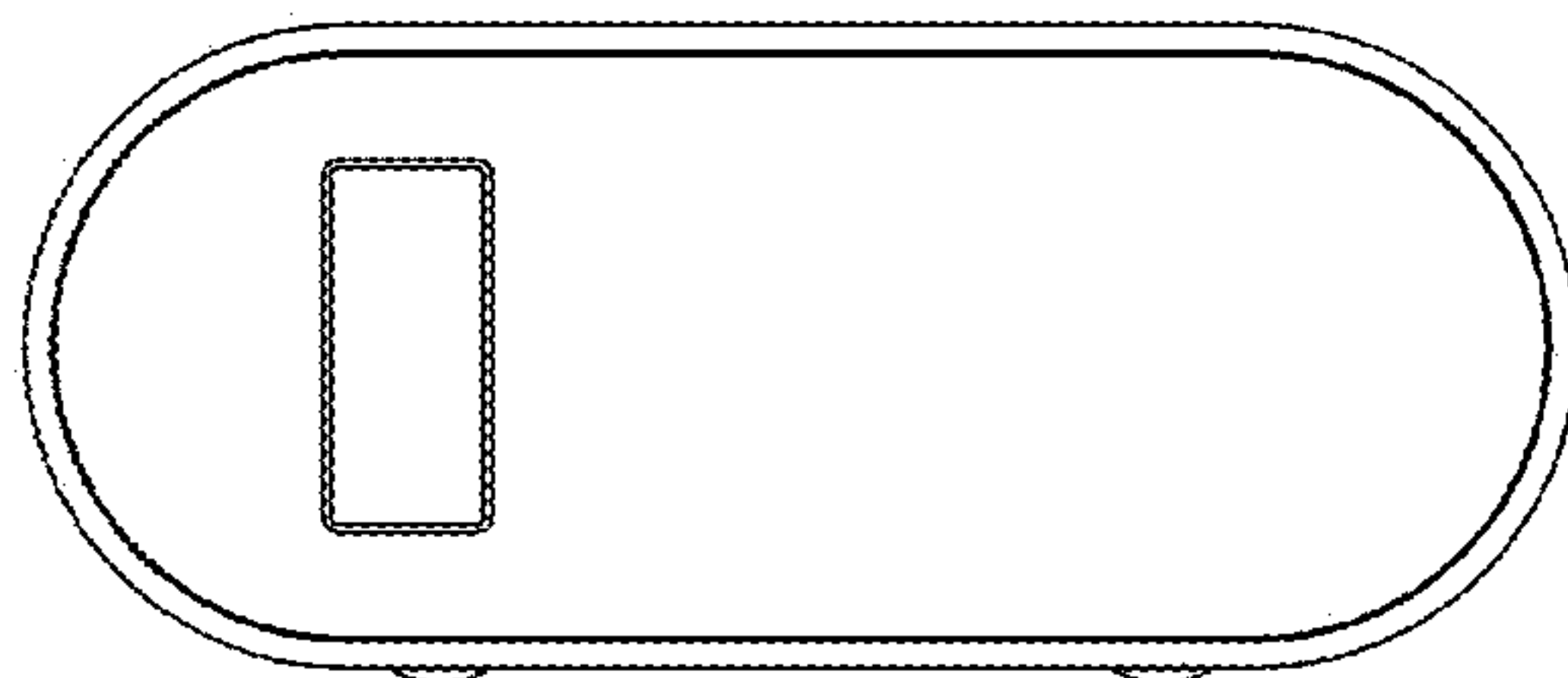

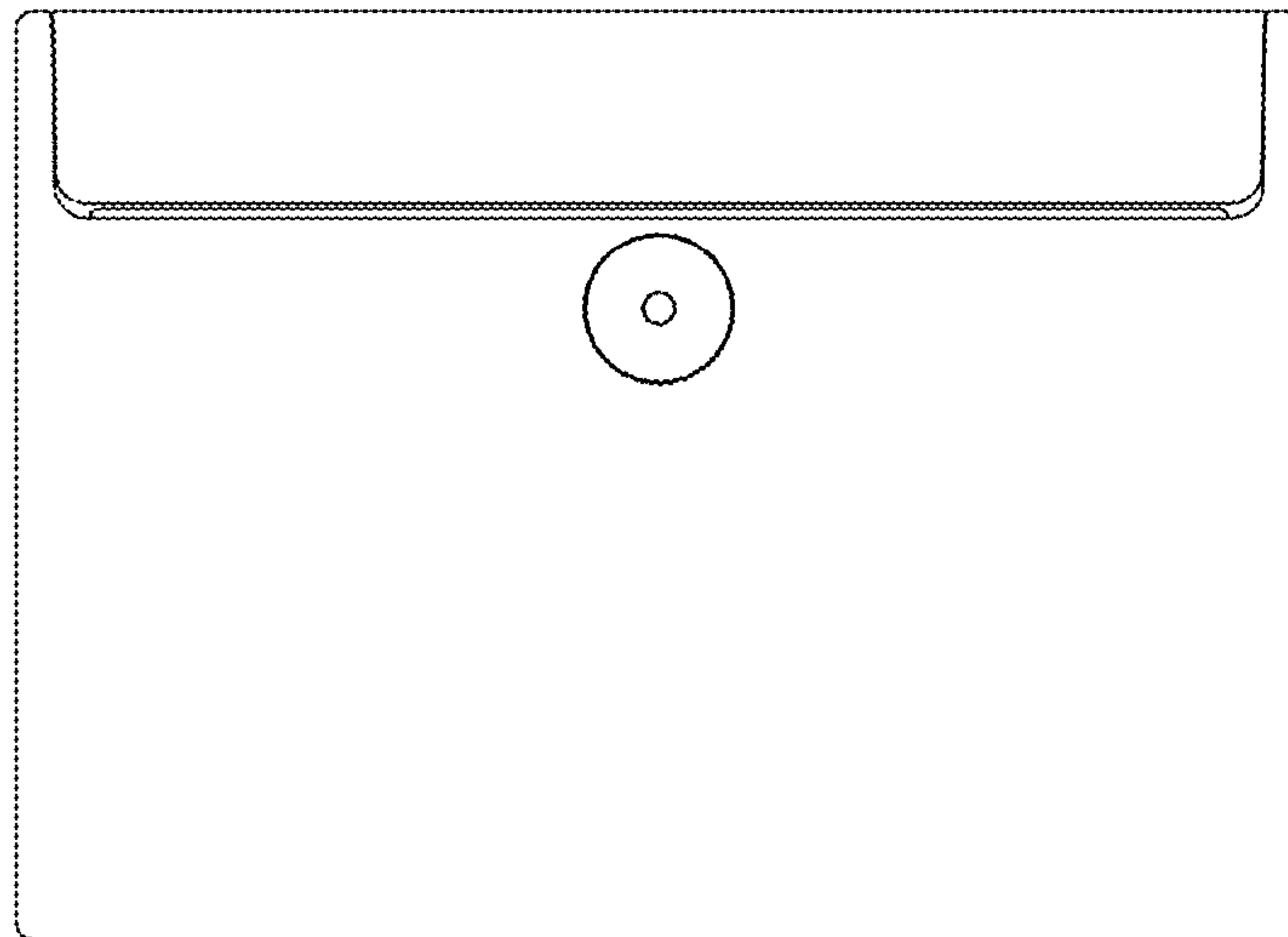

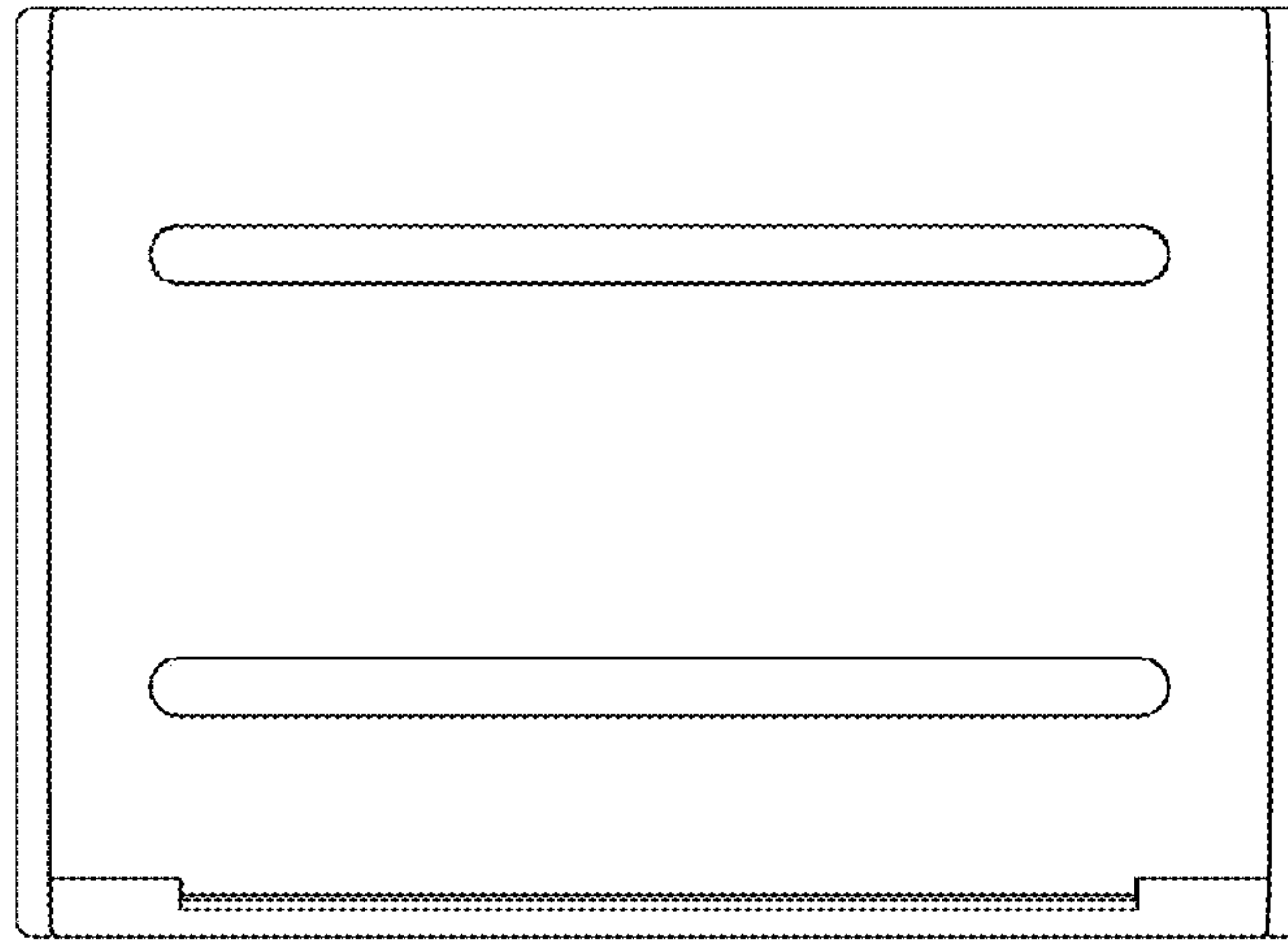

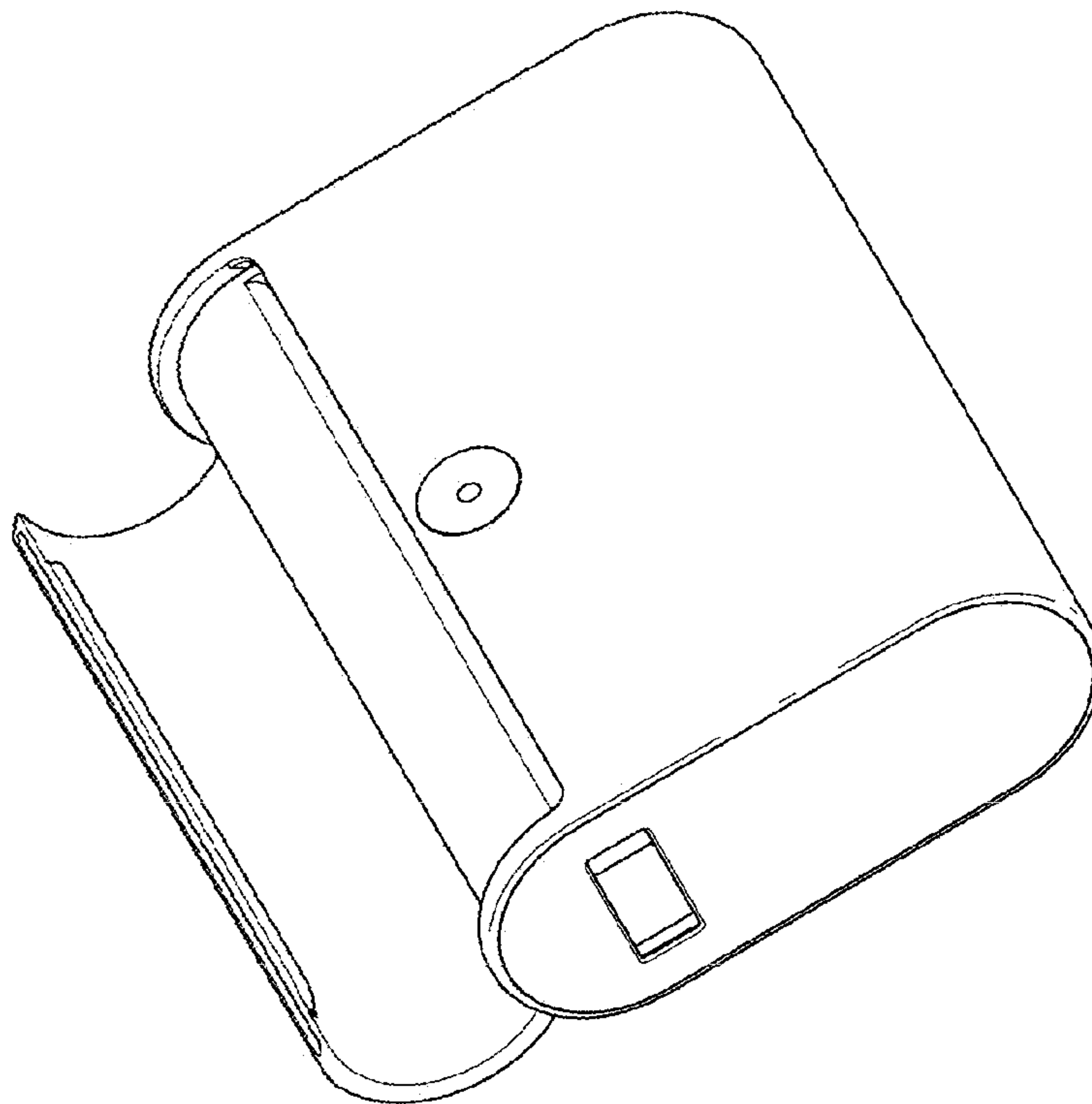
