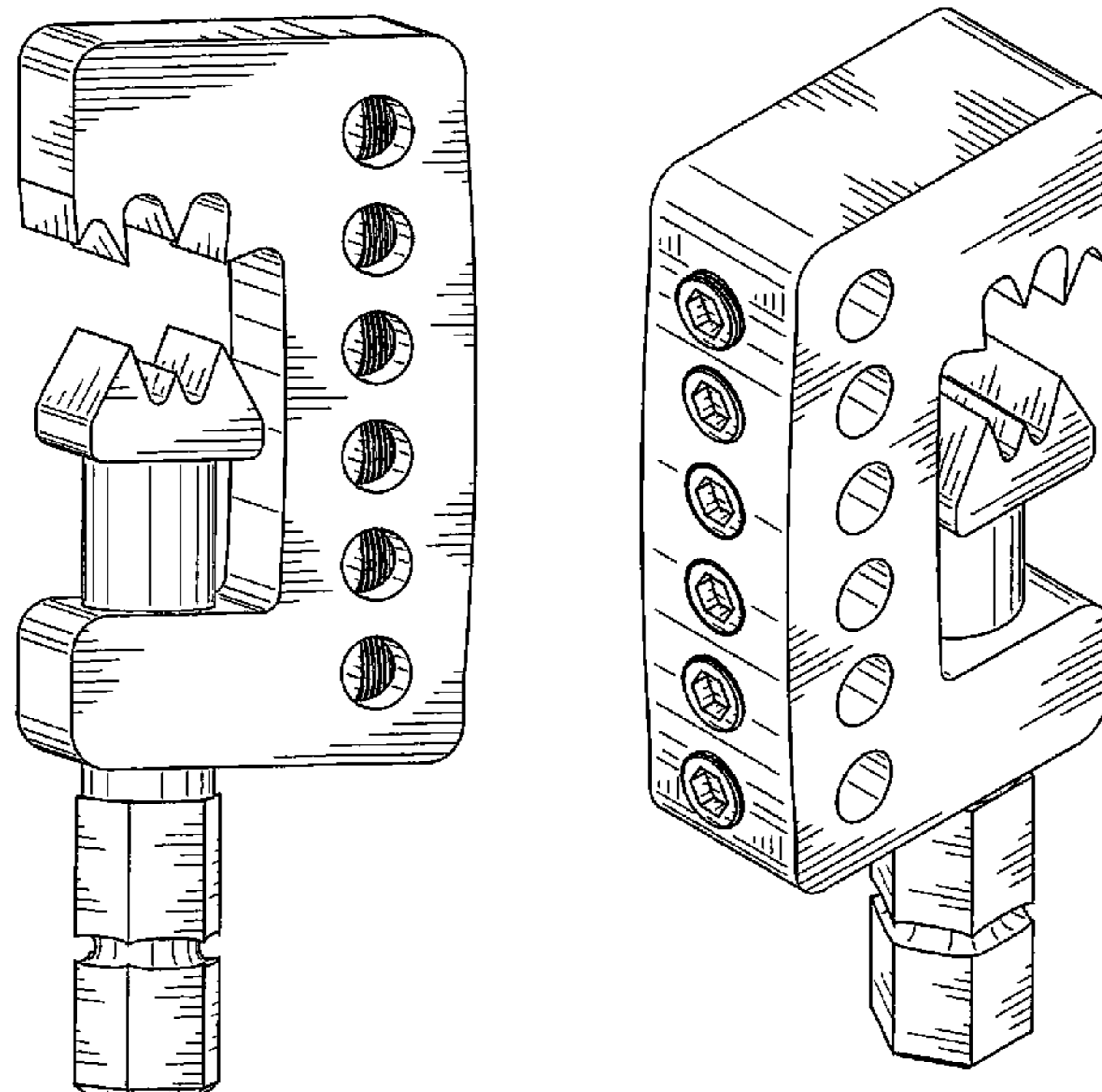
(57) **CLAIM**

The ornamental design for a multiple tap electrical connector, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a multiple tap electrical connector showing my new design in a usage condition with the claimed pressure set screws removed;

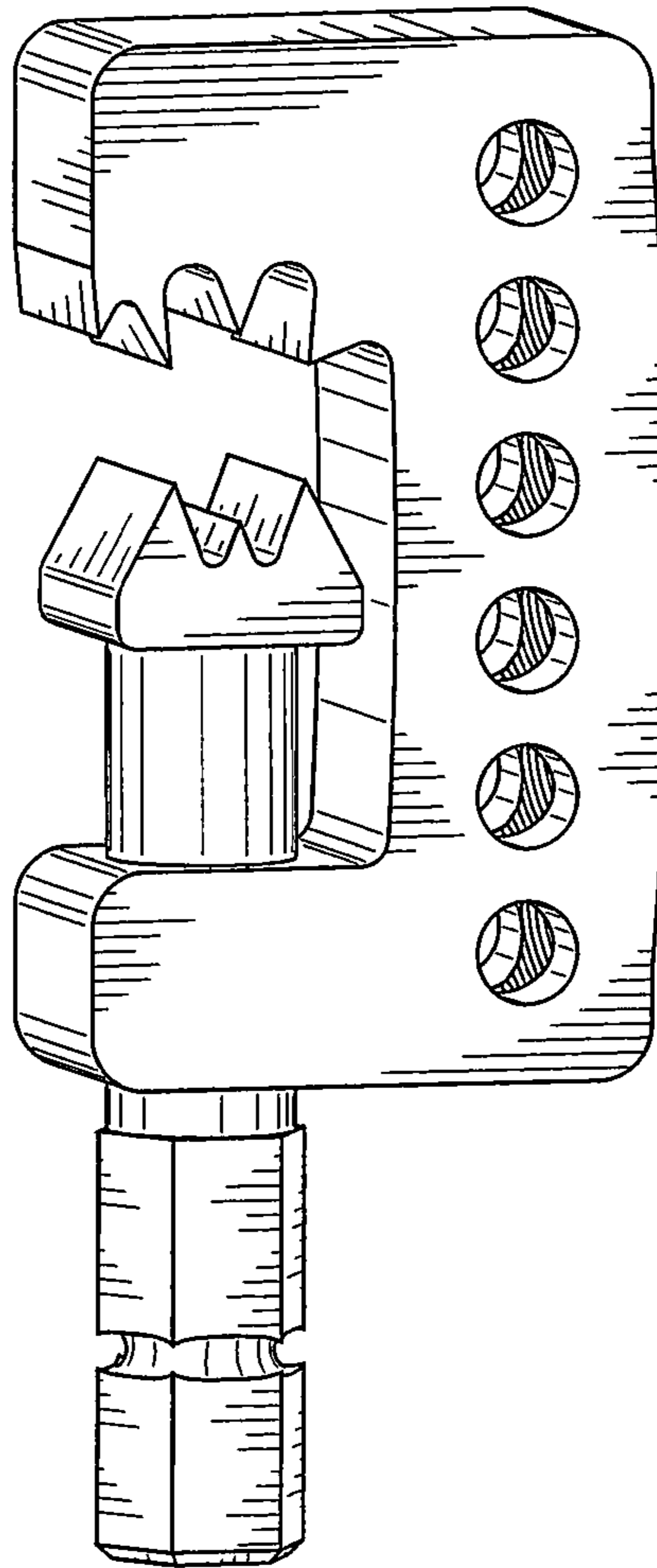

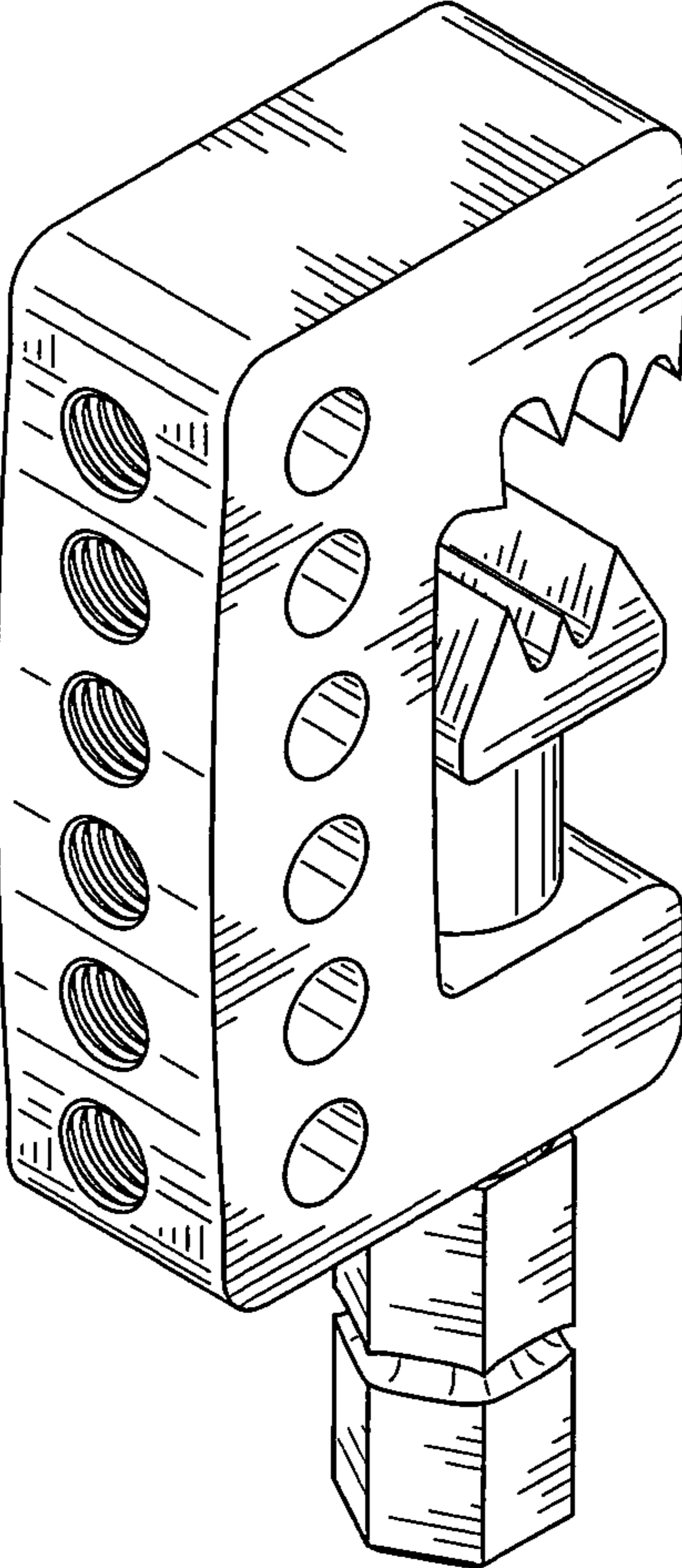

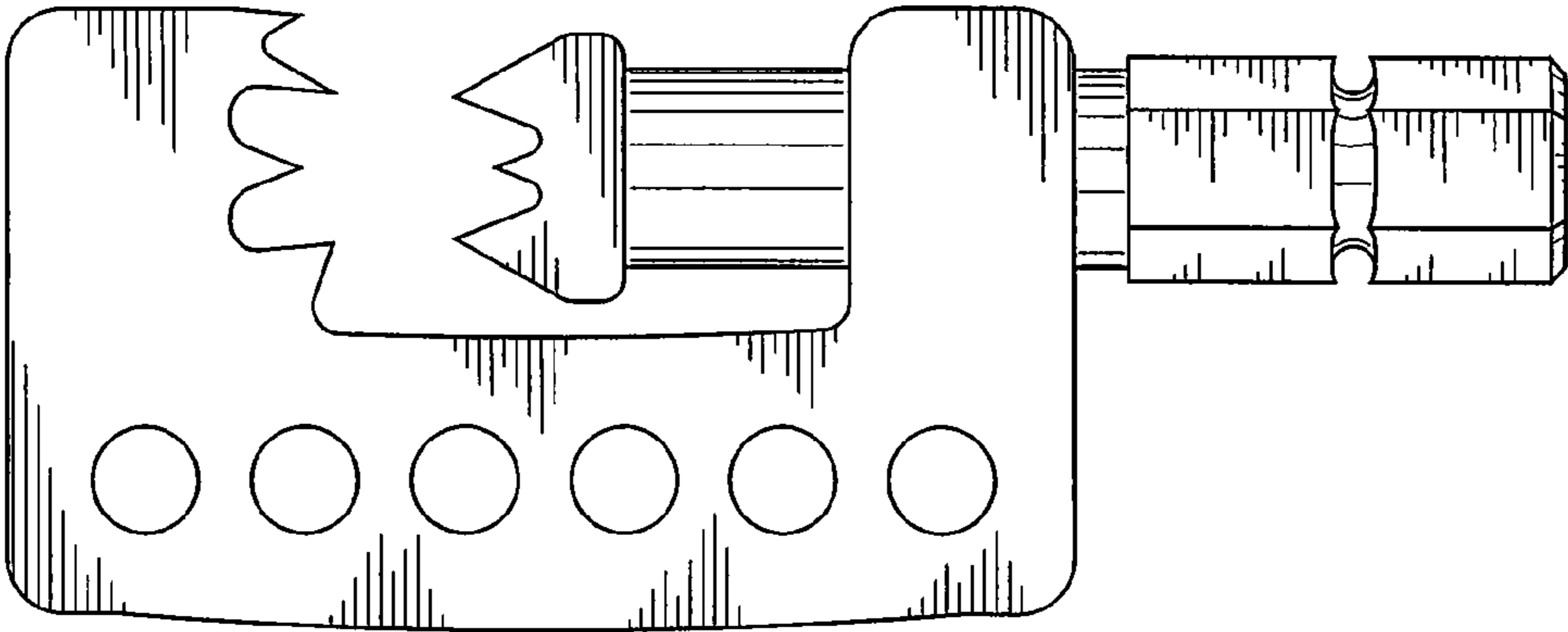

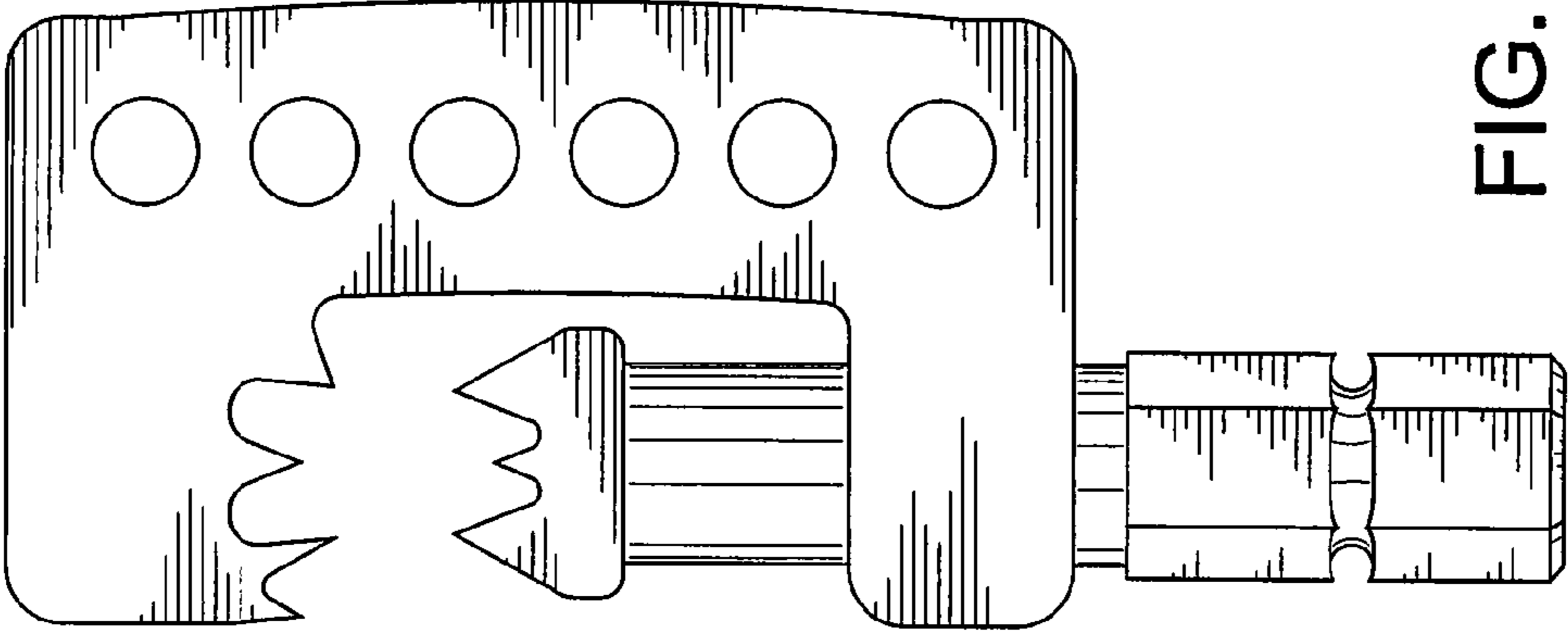

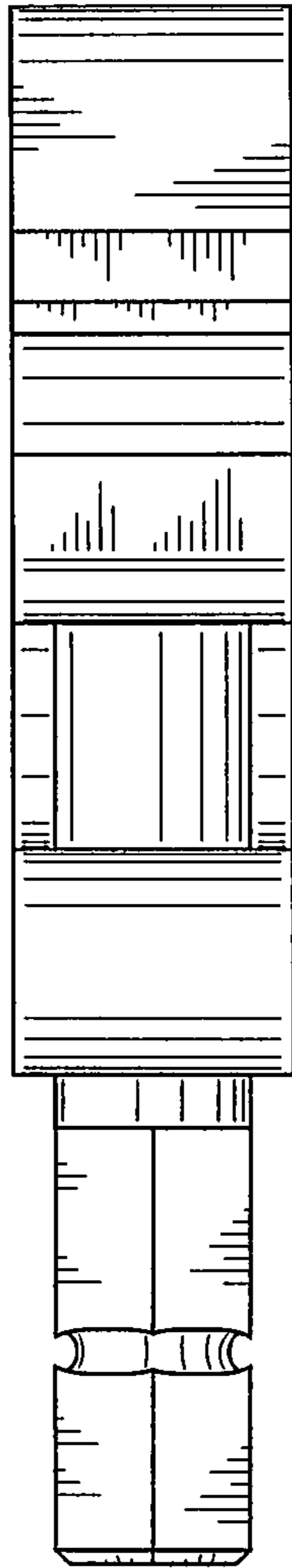

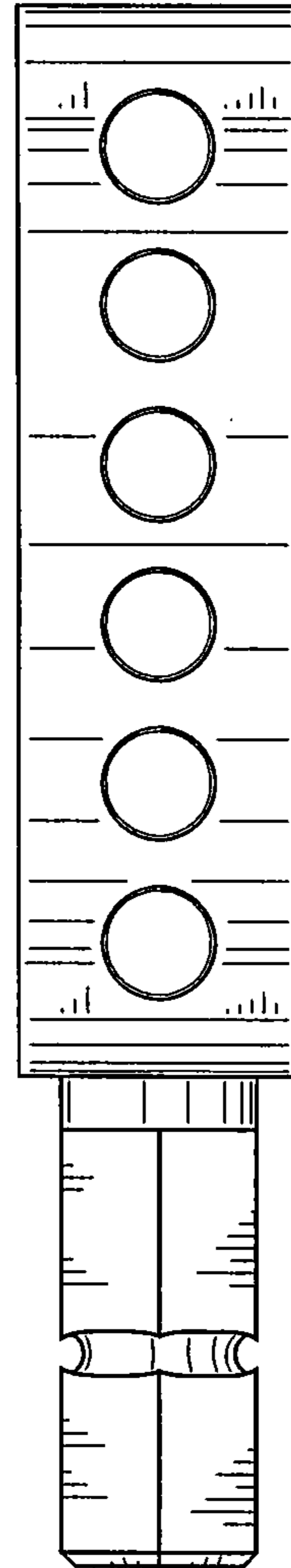

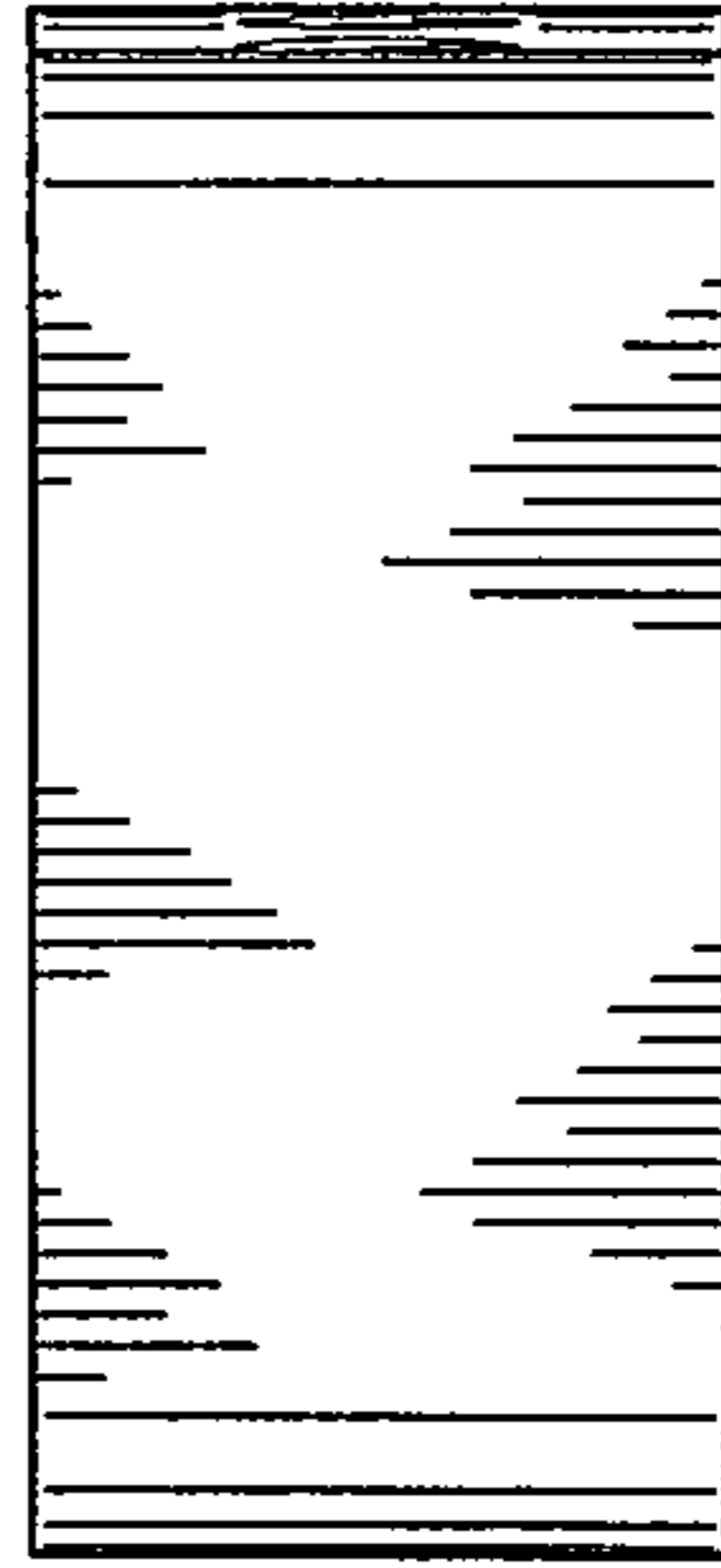

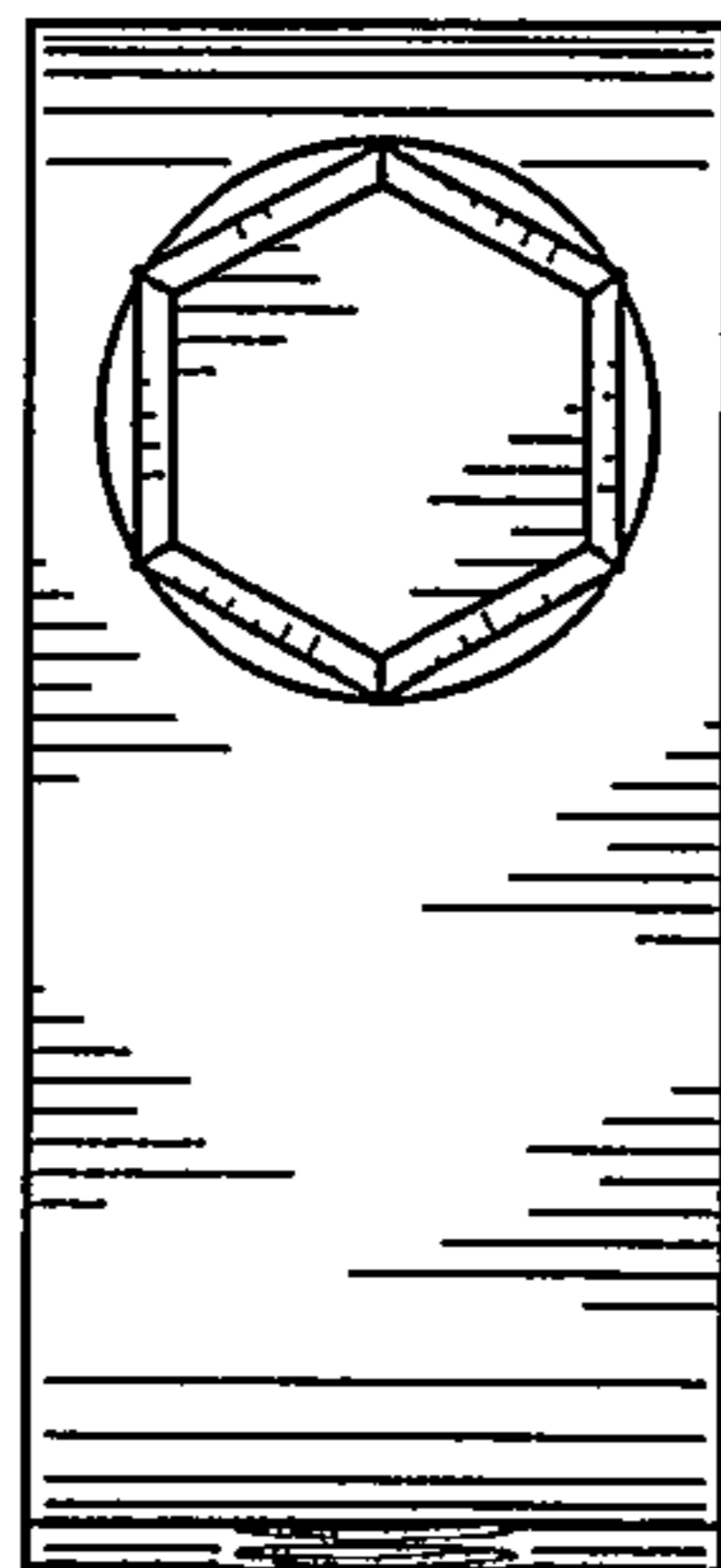

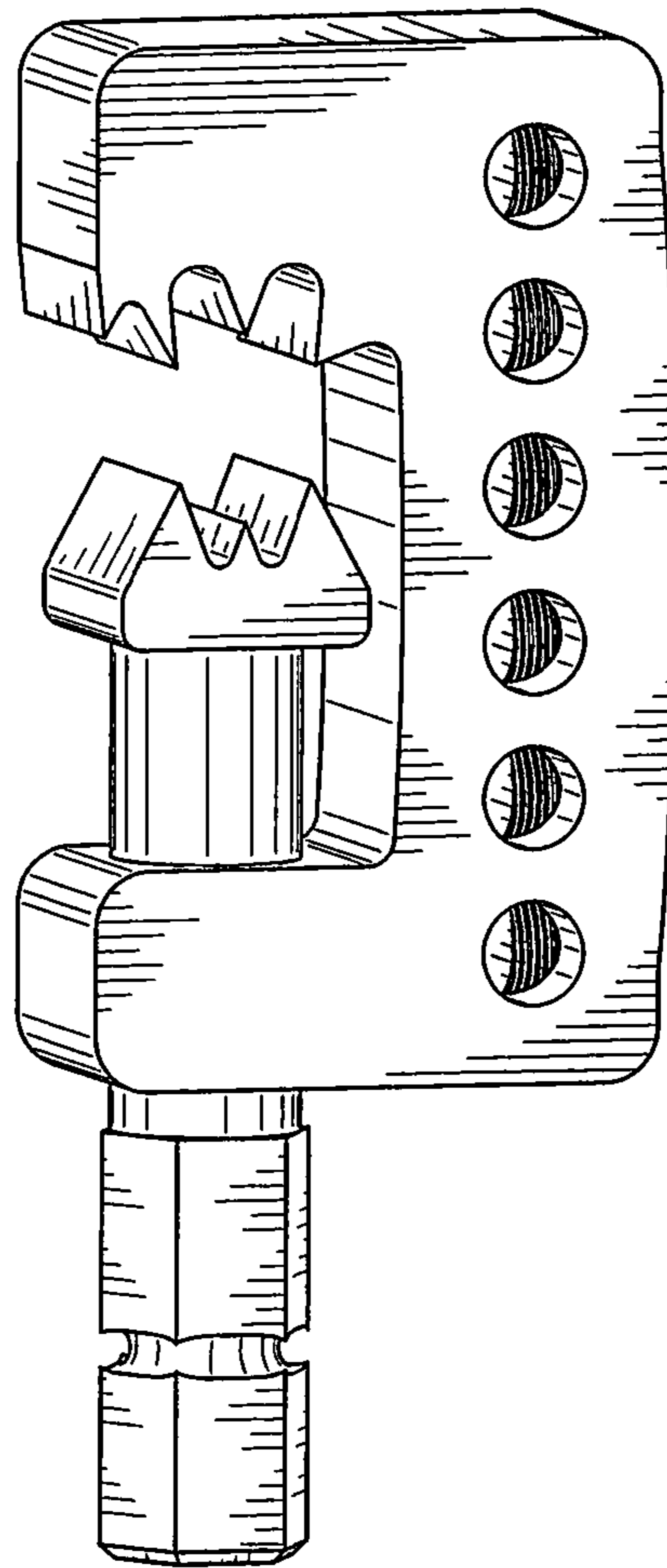

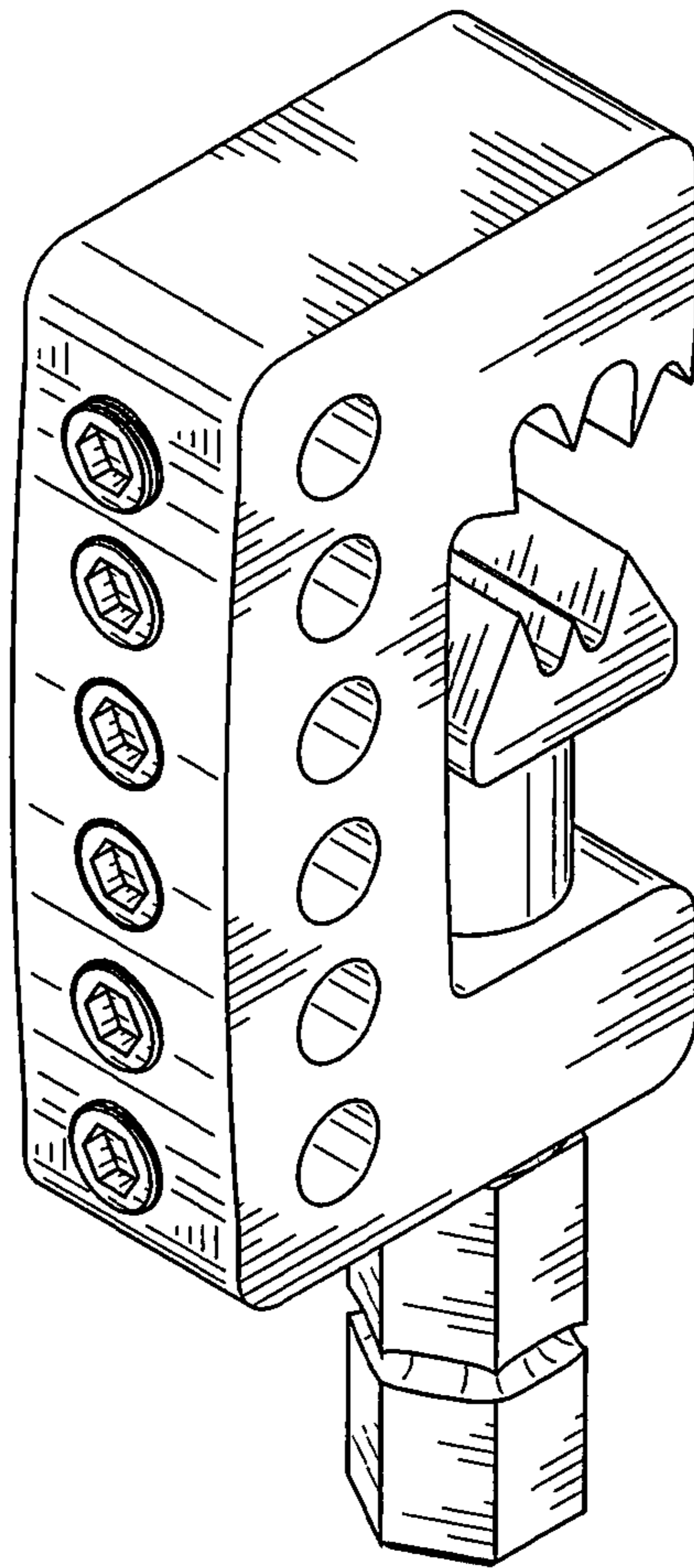

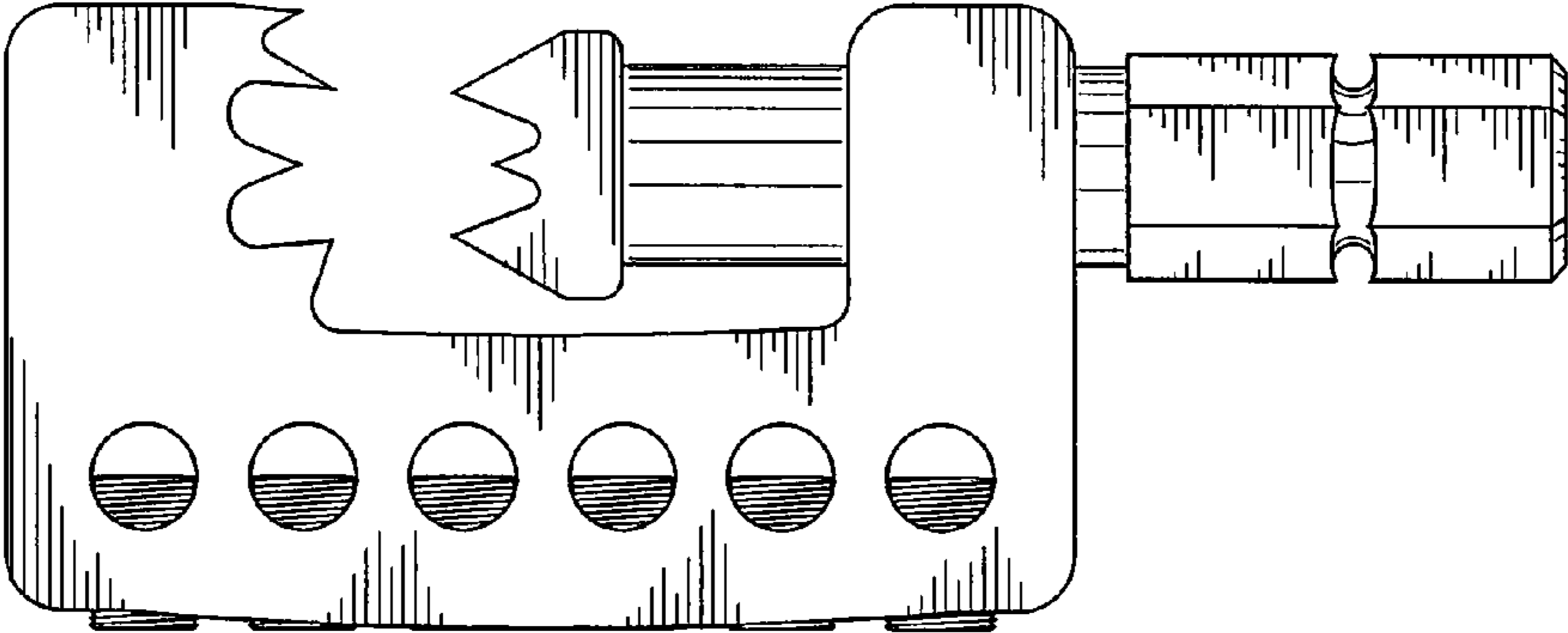

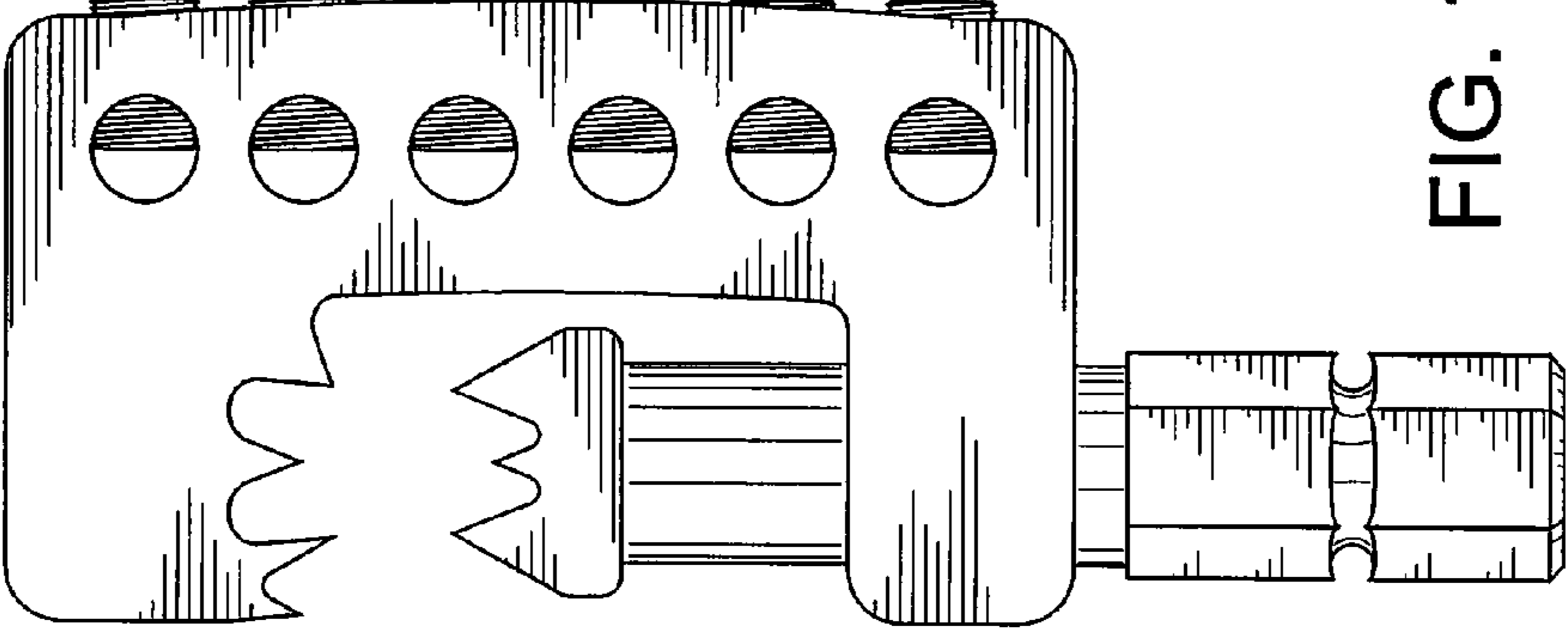

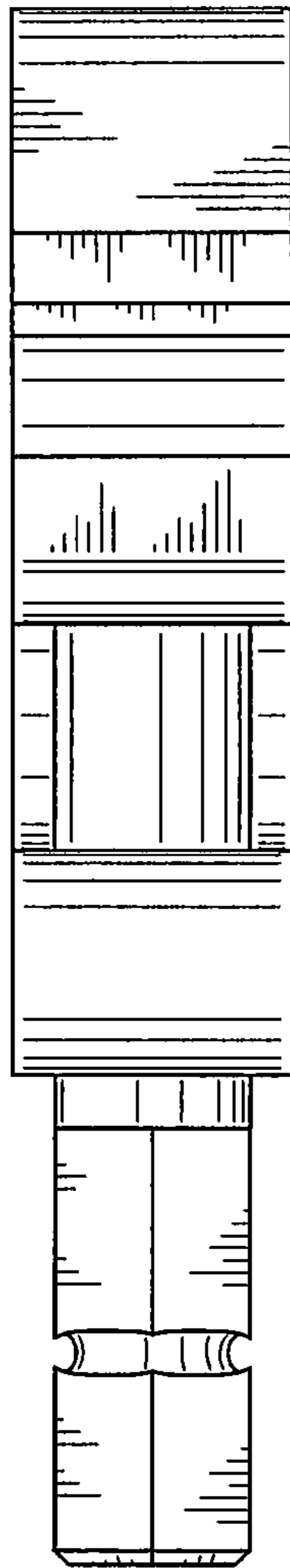

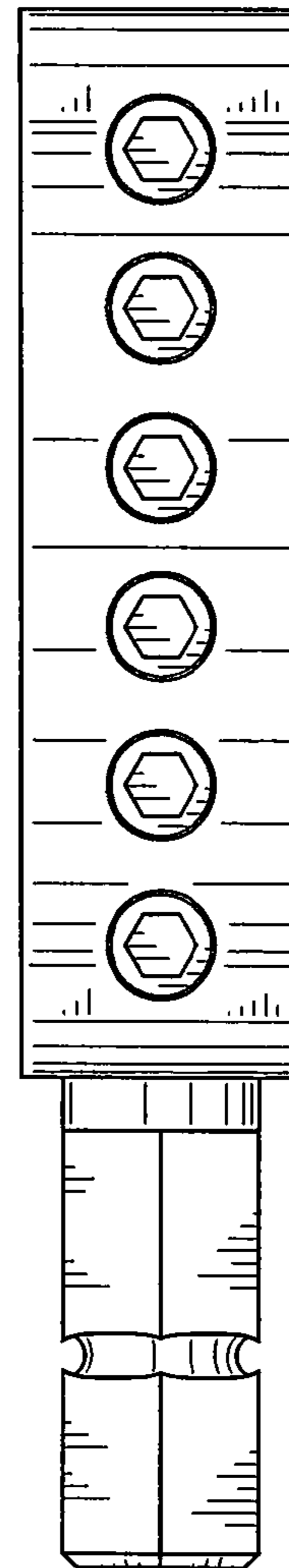

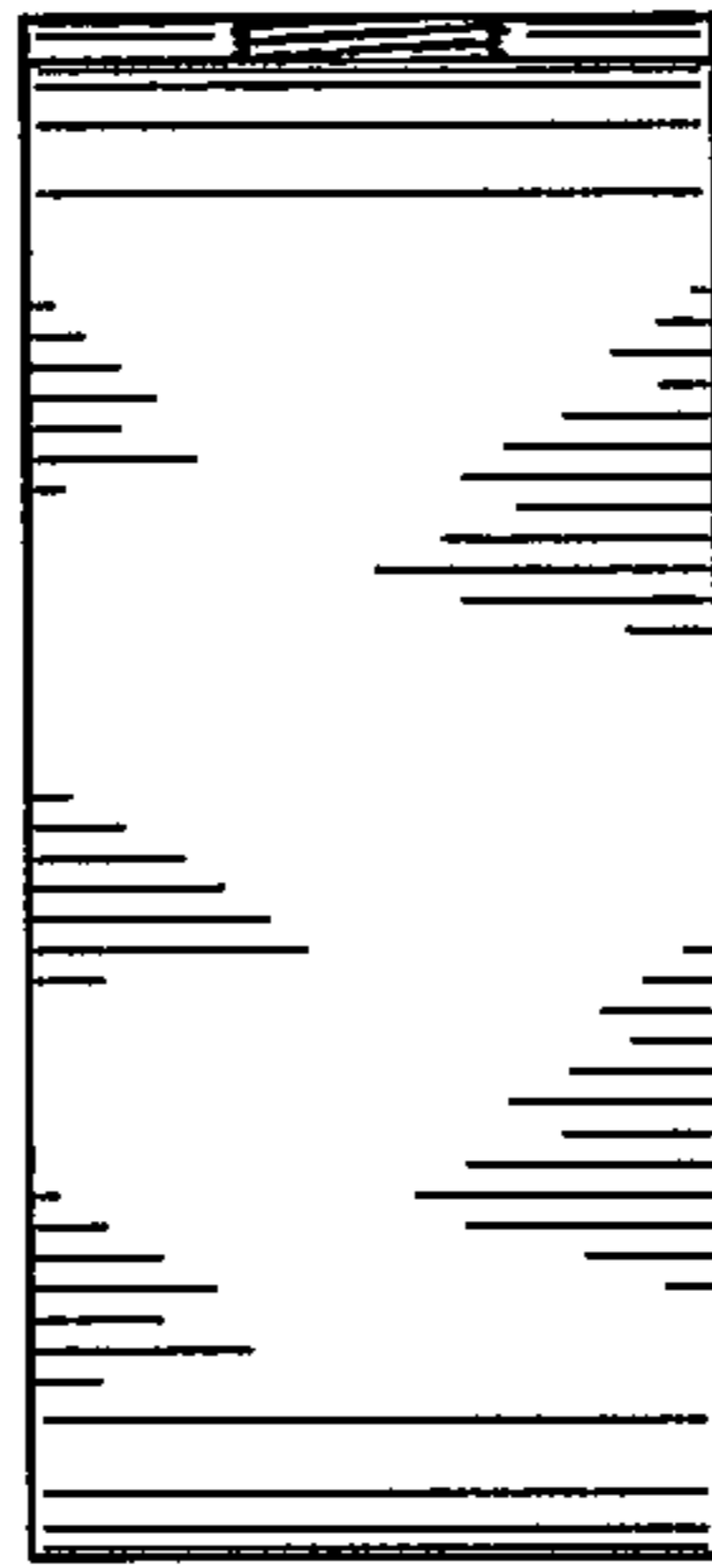

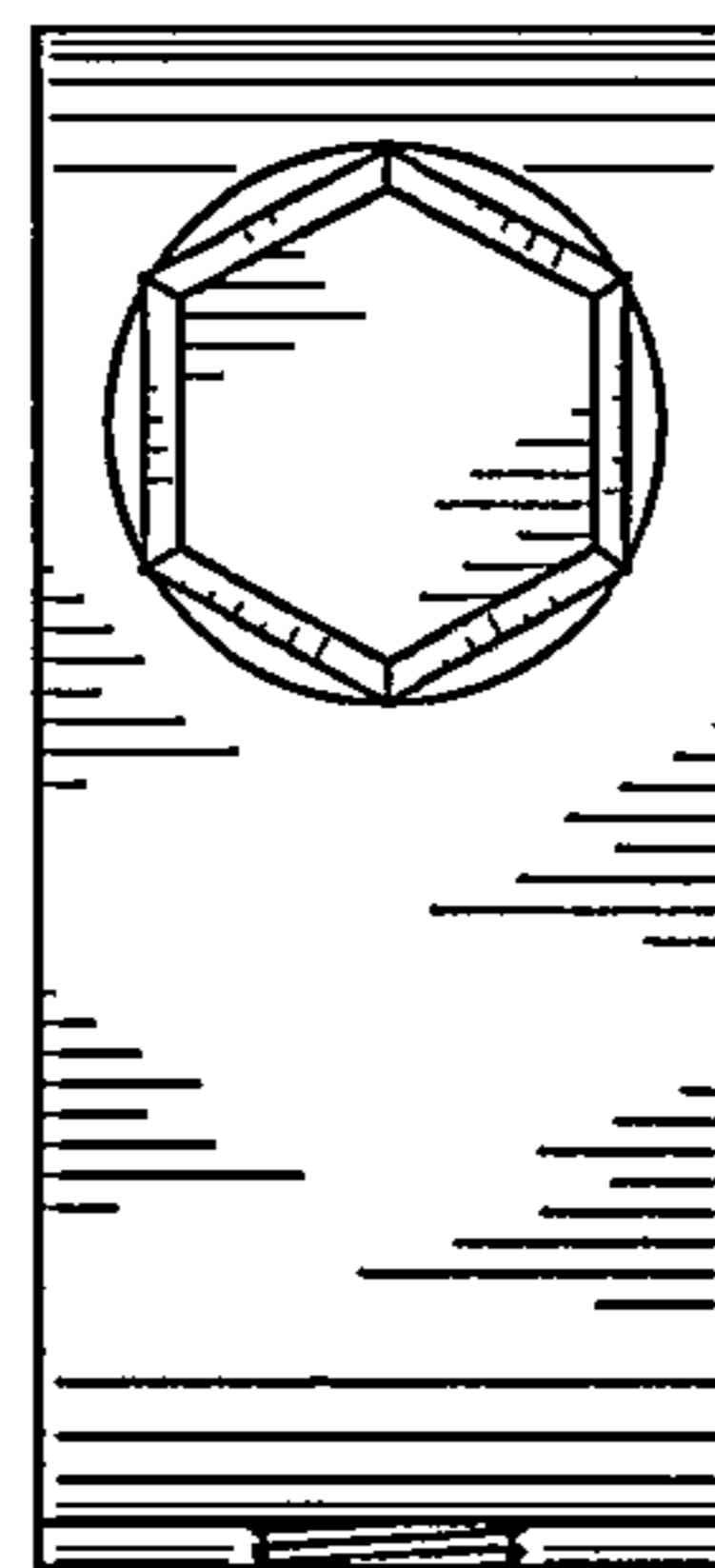
