FIG. 4 illustrates a first side view of the control unit illustrated in FIG. 1.

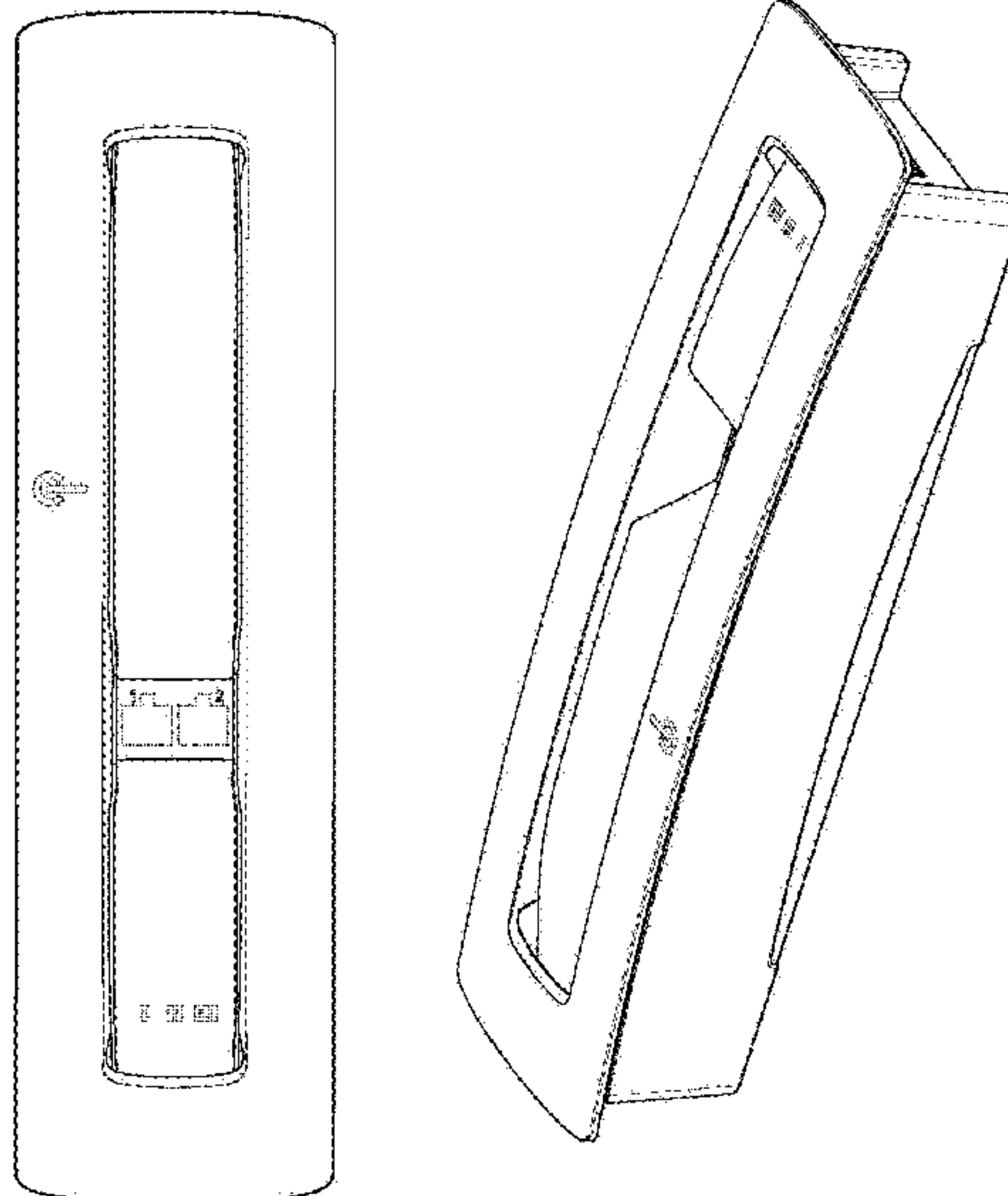
FIG. 5 illustrates a first end view of the control unit illustrated in FIG. 1.

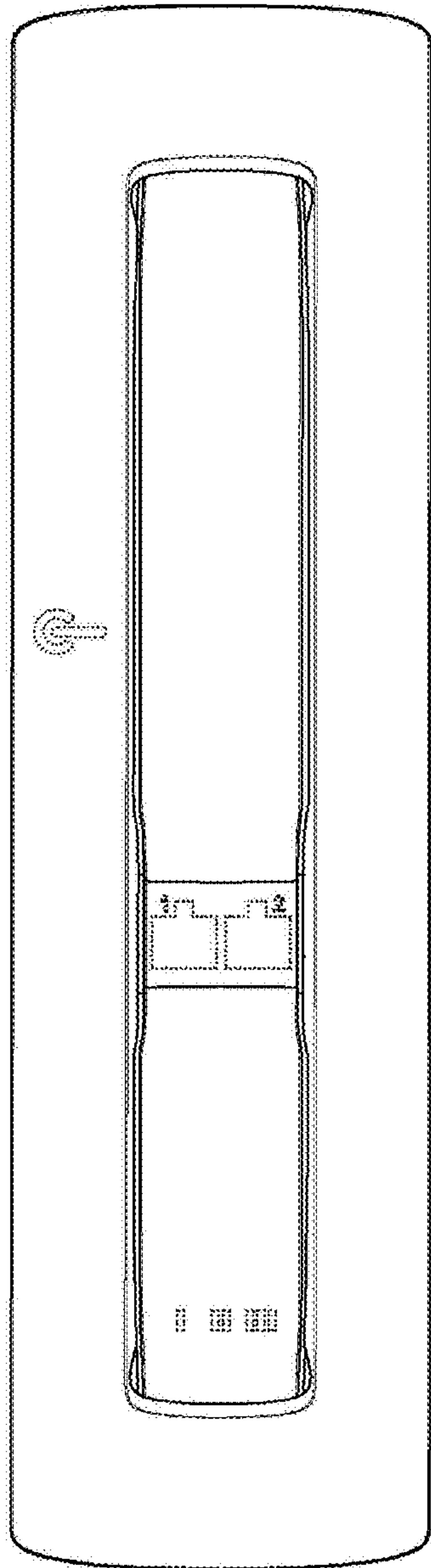

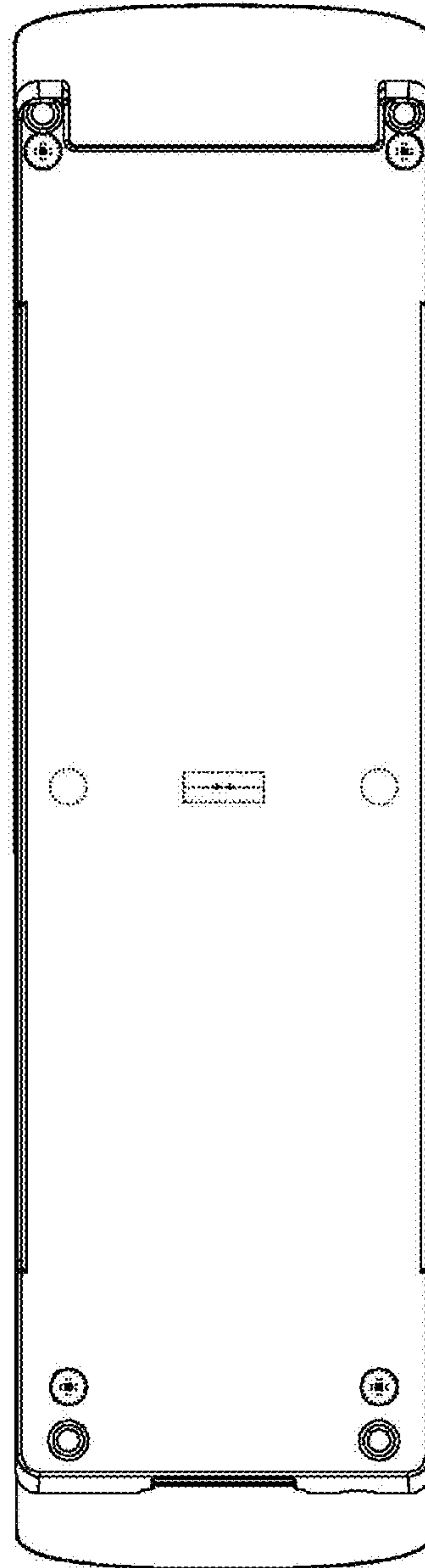

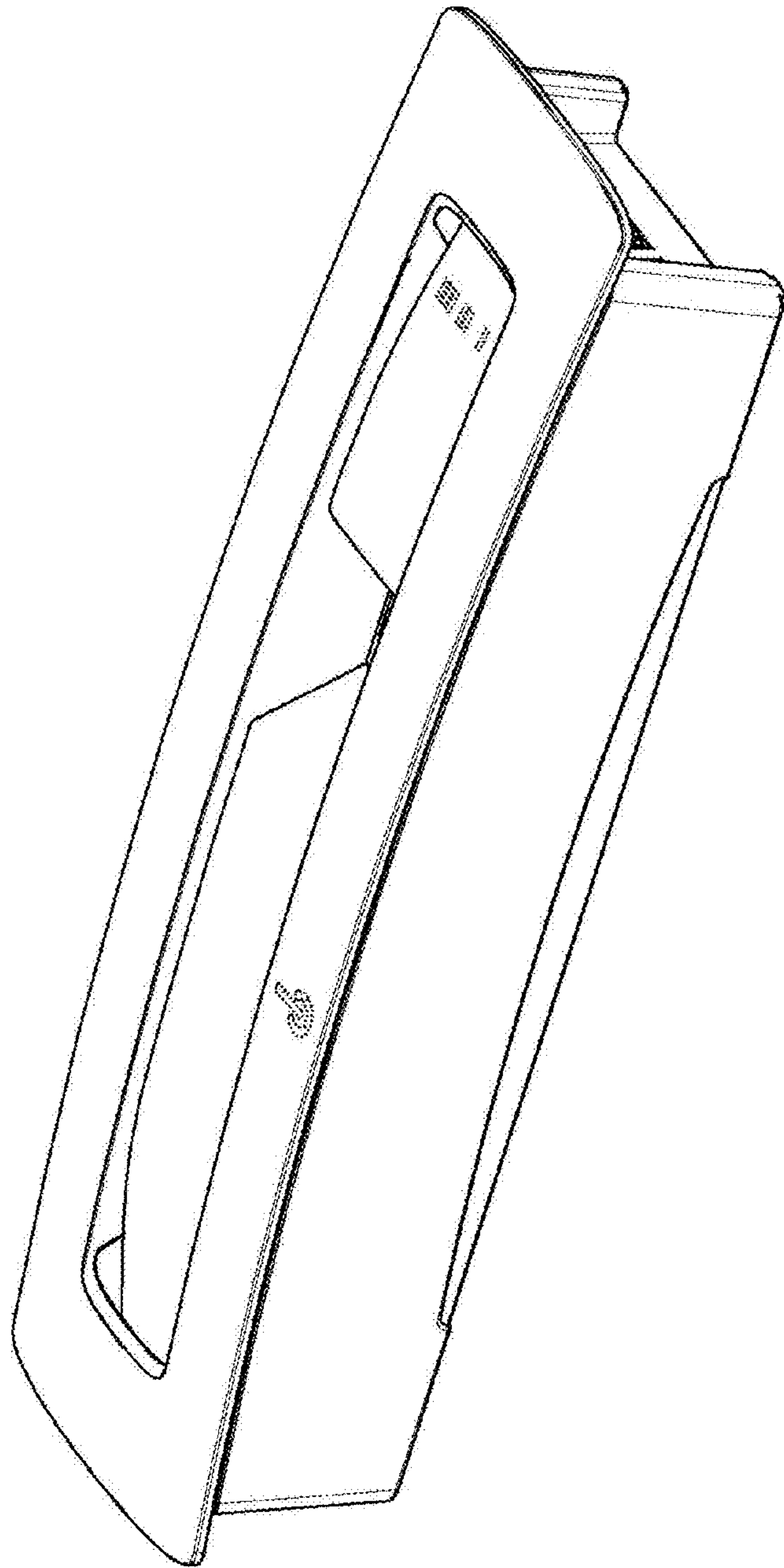

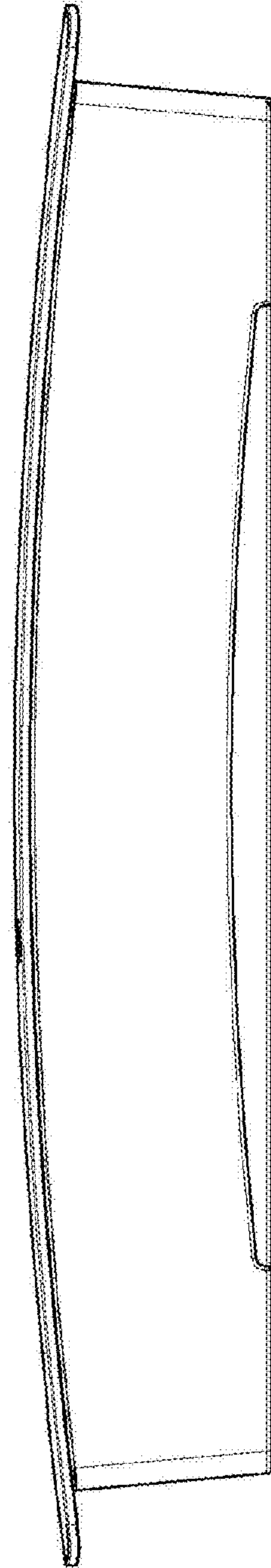

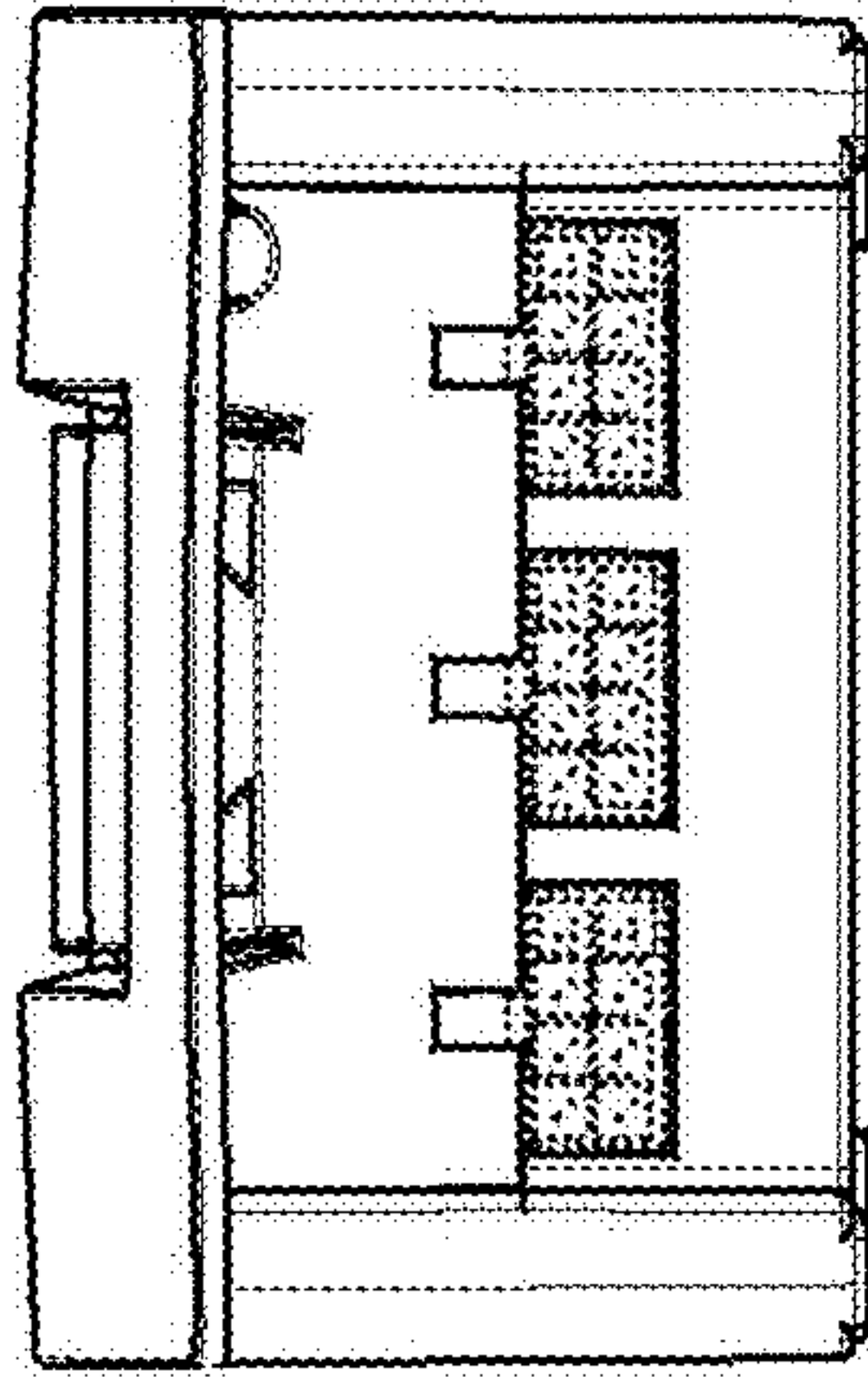

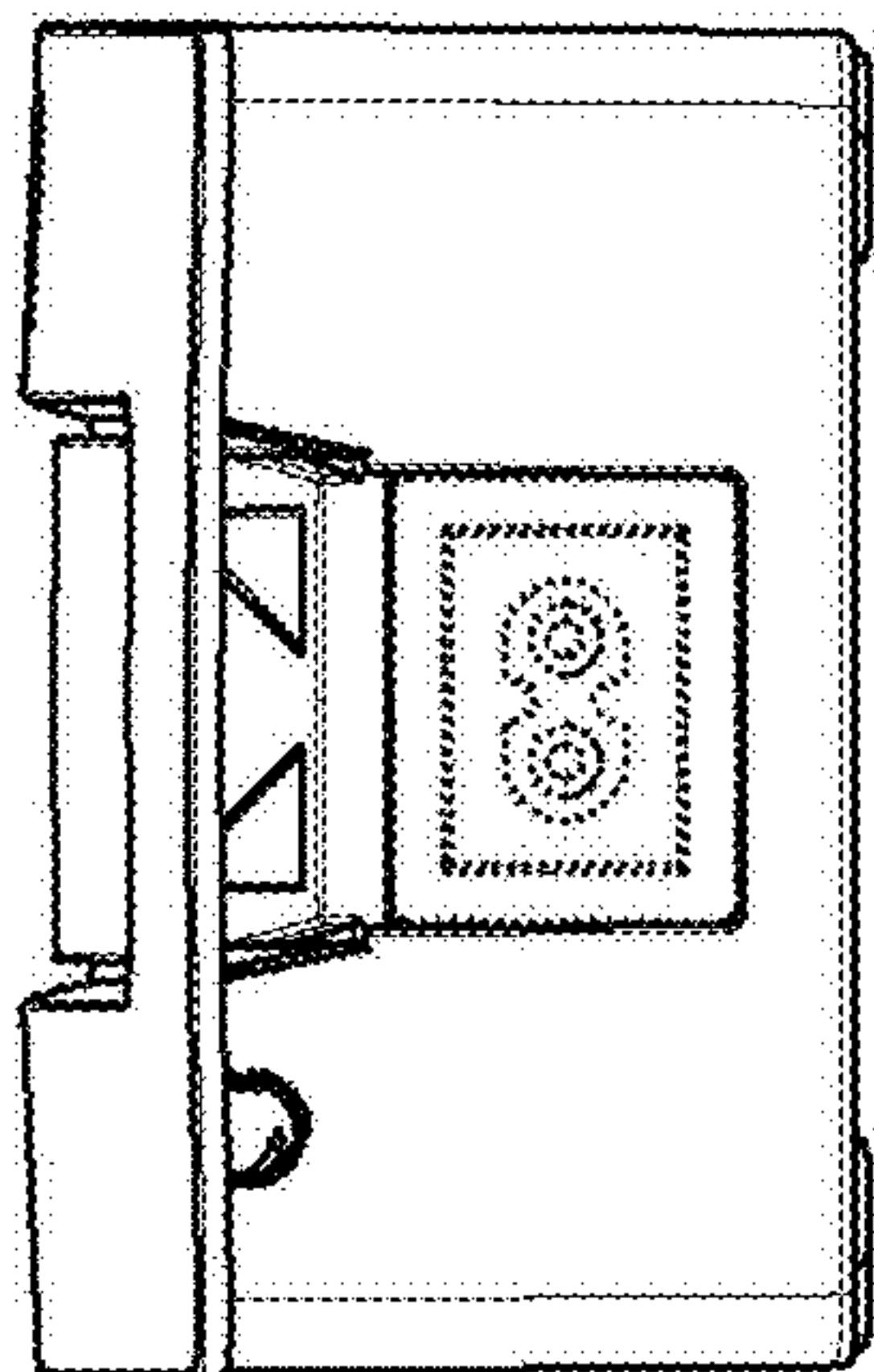

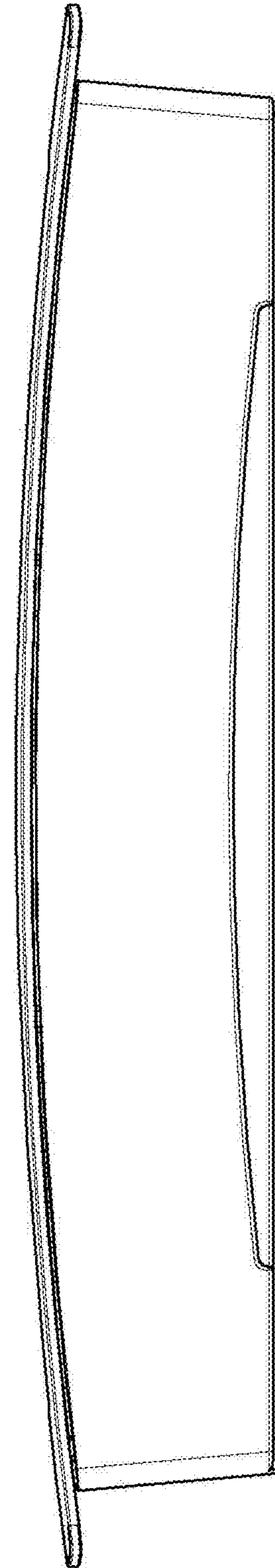
