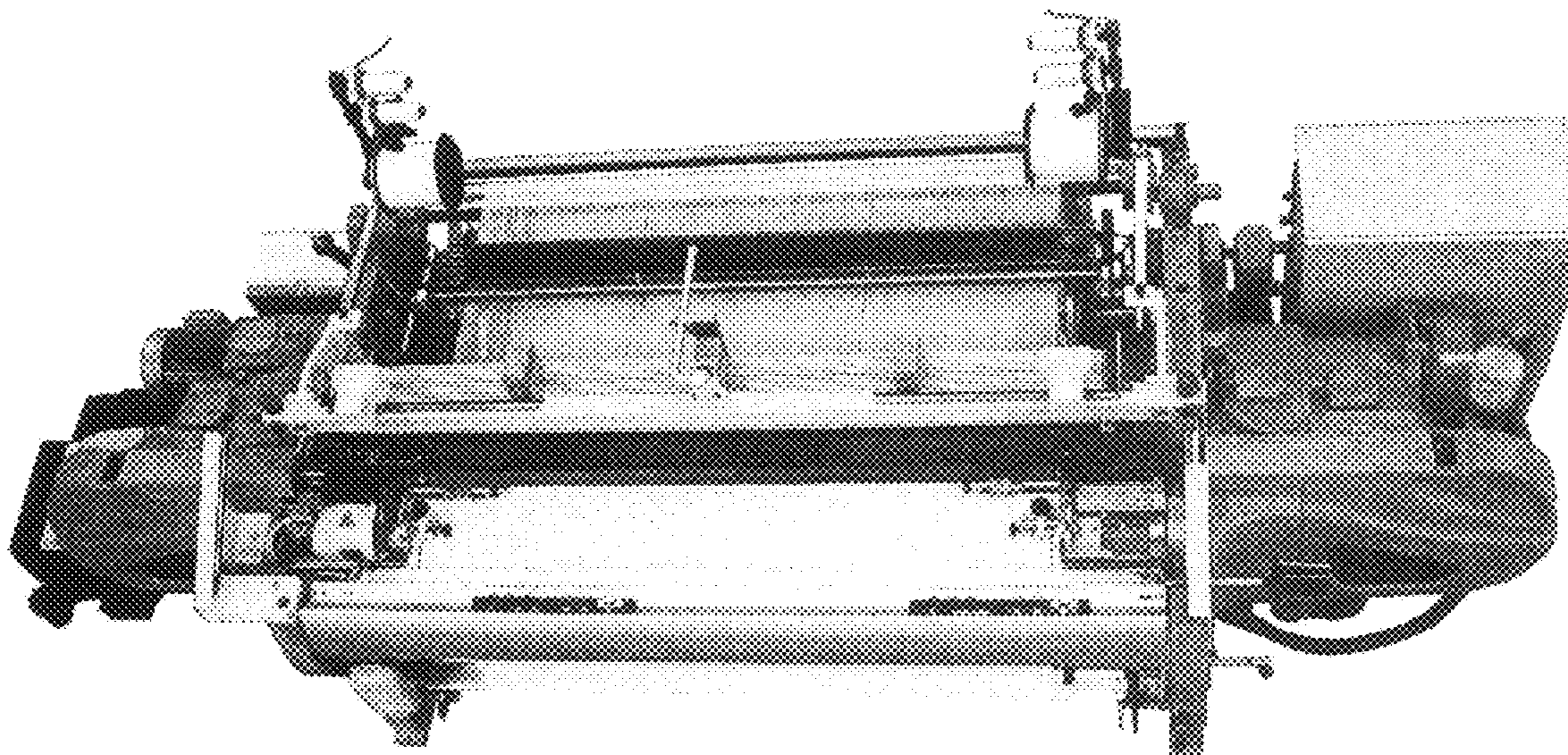
(57) **CLAIM**
The ornamental design for a weaving loom, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of a weaving loom constructed according our invention;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a right side and top perspective view thereof;
FIG. 4 is a left side and top perspective view thereof; and,
FIG. 5 is a rear and top perspective view thereof.
The bottom view is not shown and does not form a part of the claimed design.

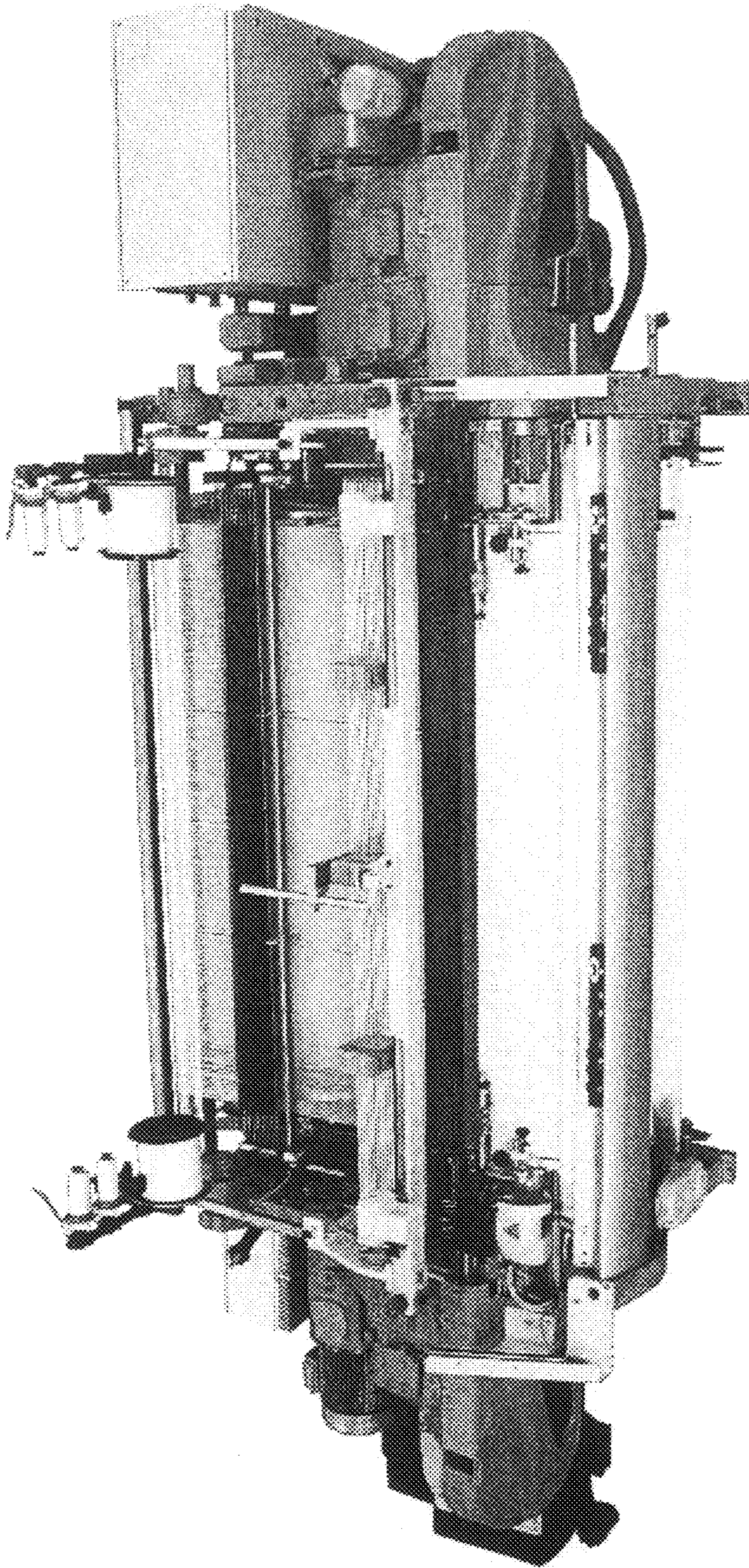

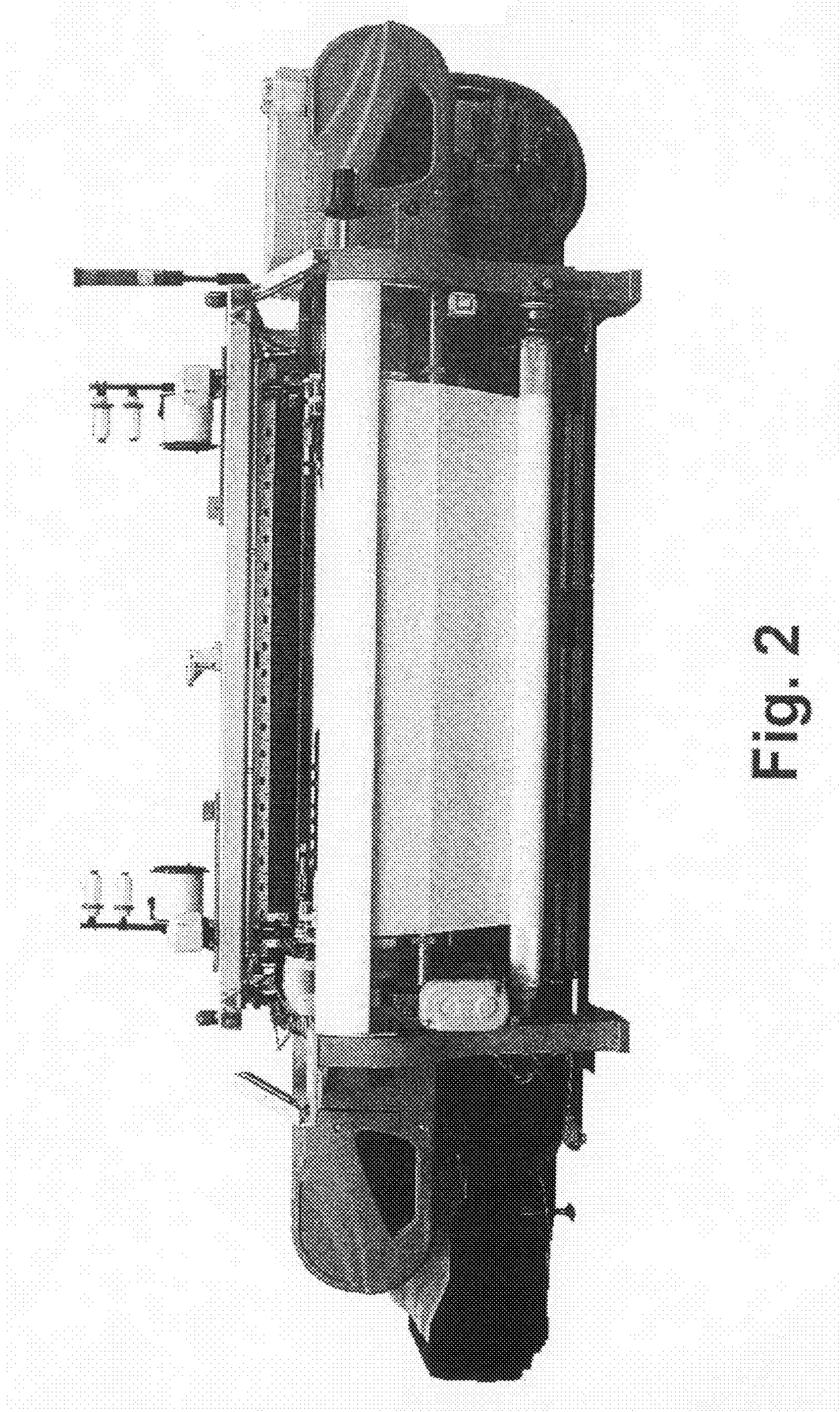

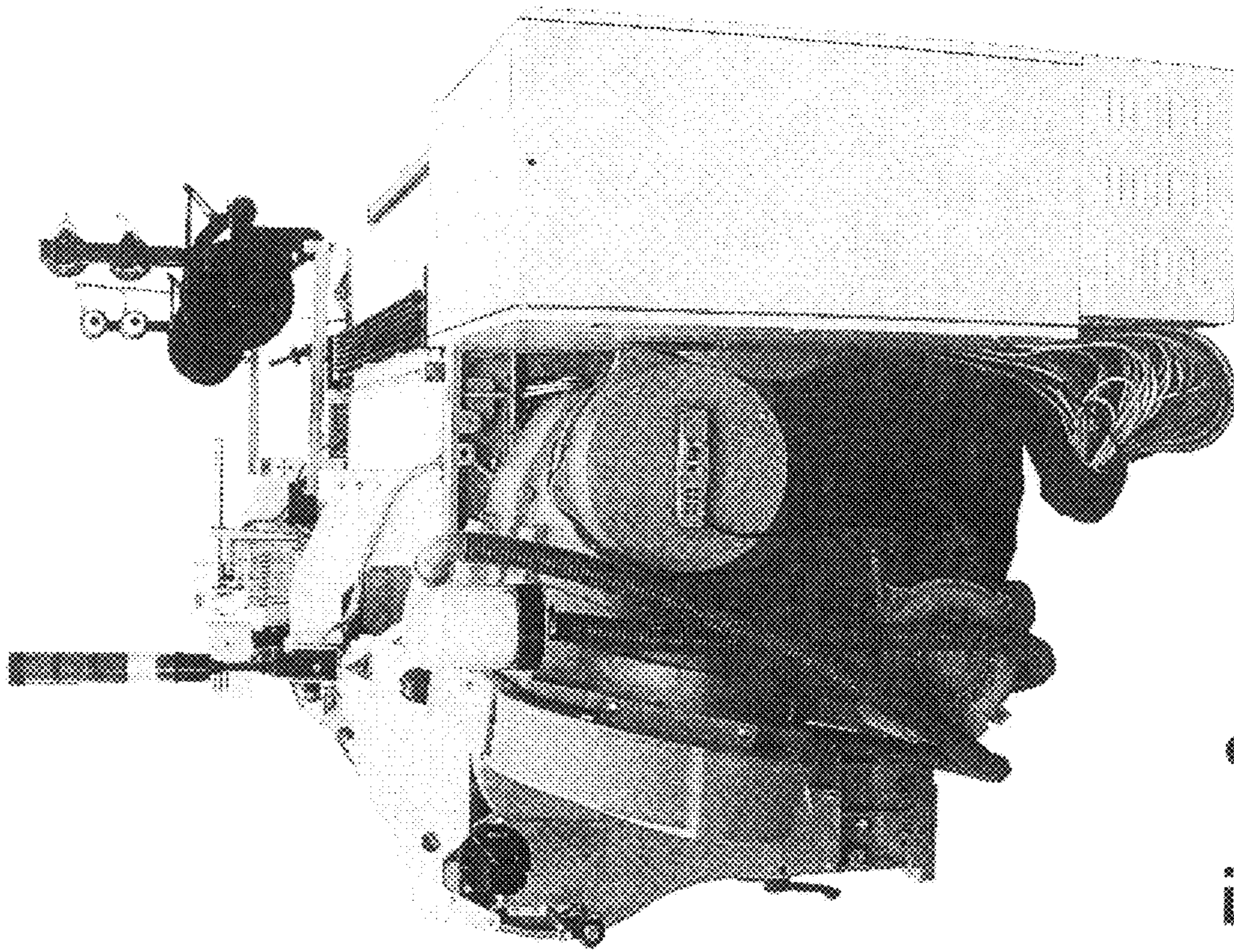

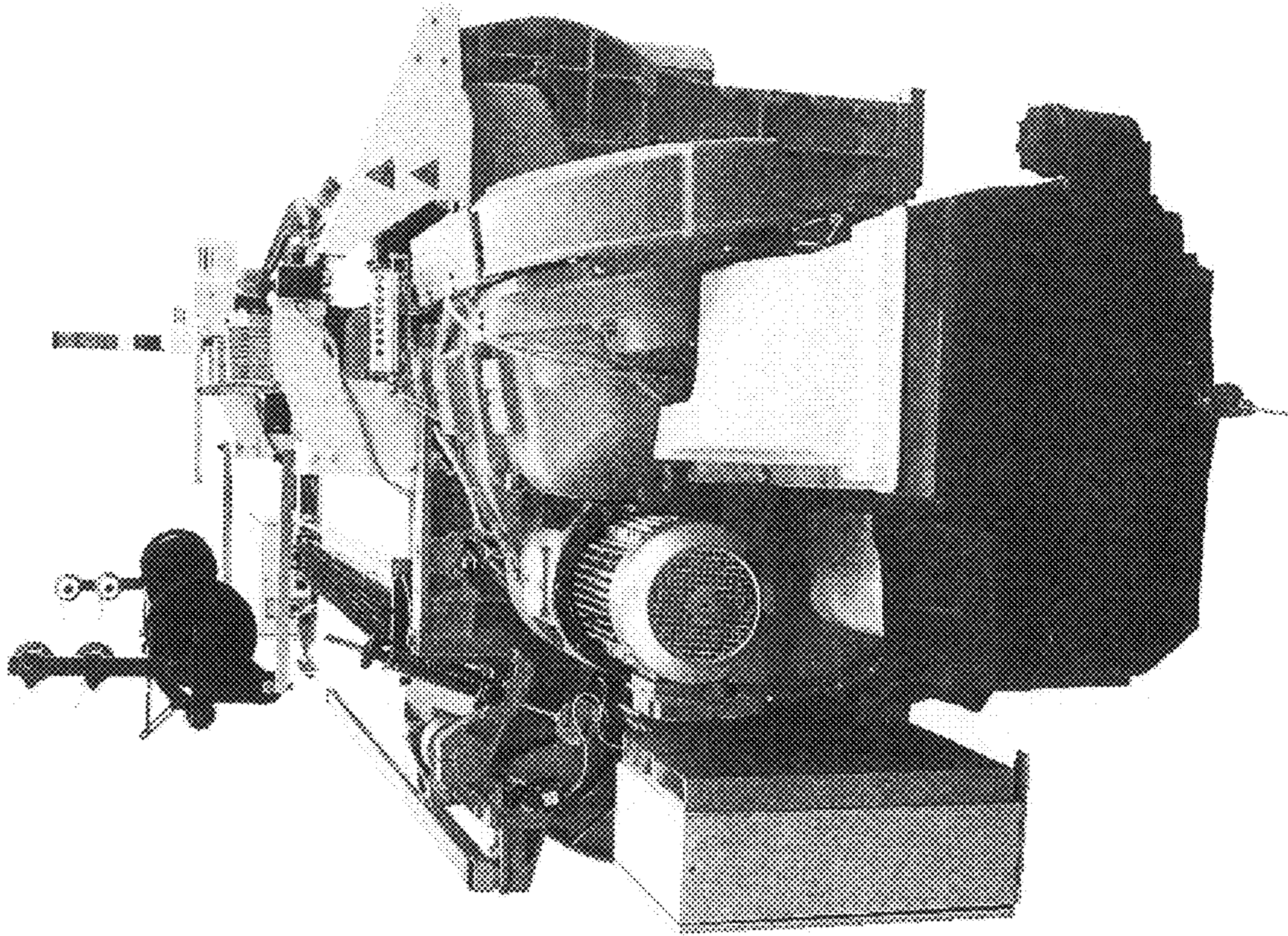

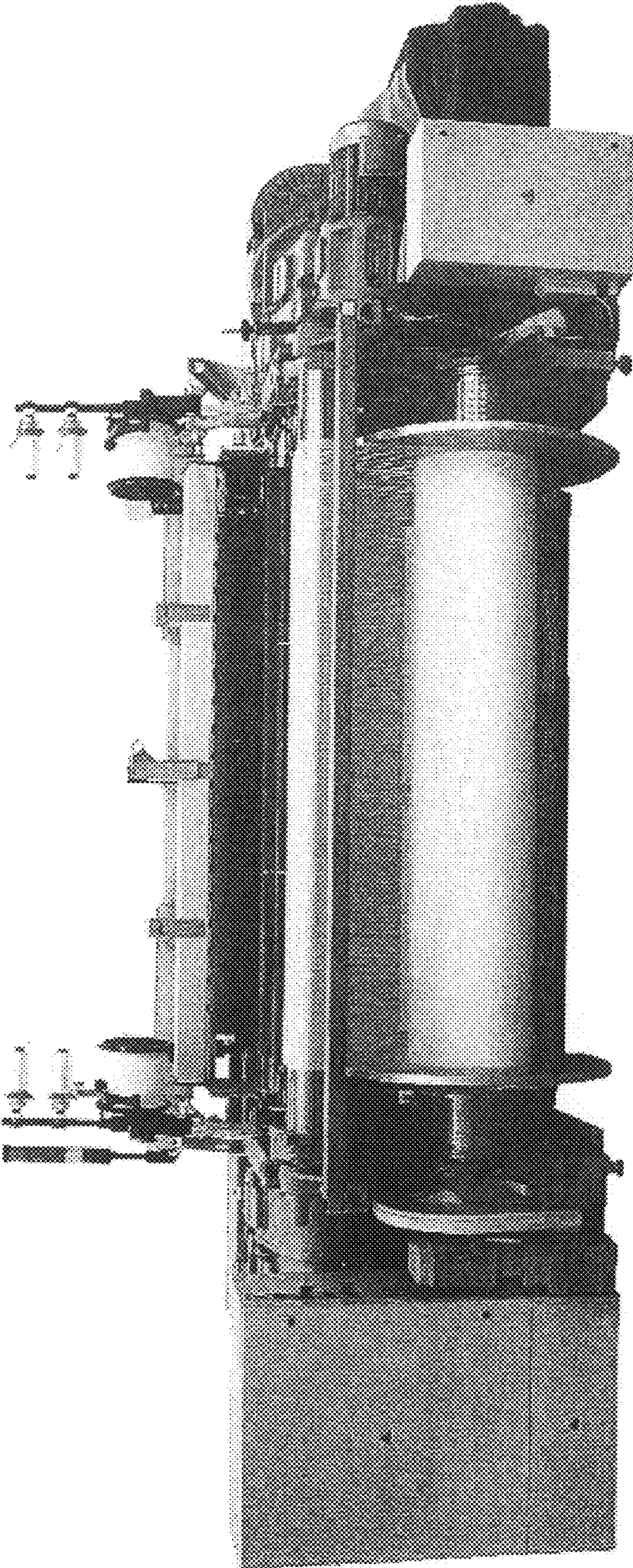
