DESCRIPTION

FIG. 1 is a front perspective view of the eyewear showing my new design;
FIG. 2 is a front view of the eyewear shown in FIG. 1;
FIG. 3 is a rear view of the eyewear shown in FIG. 1;
FIG. 4 is a left side view of the eyewear shown in FIG. 1;

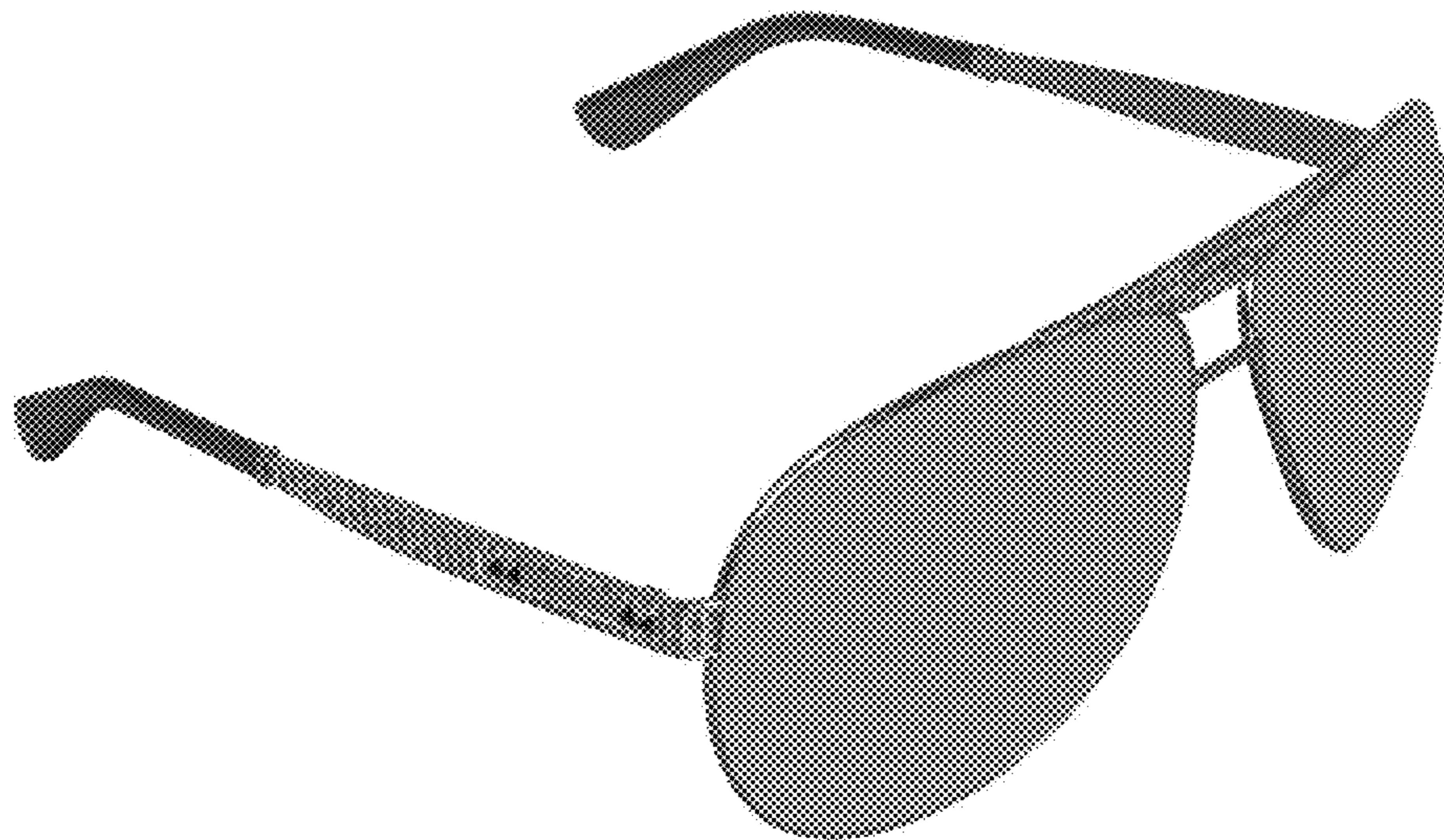

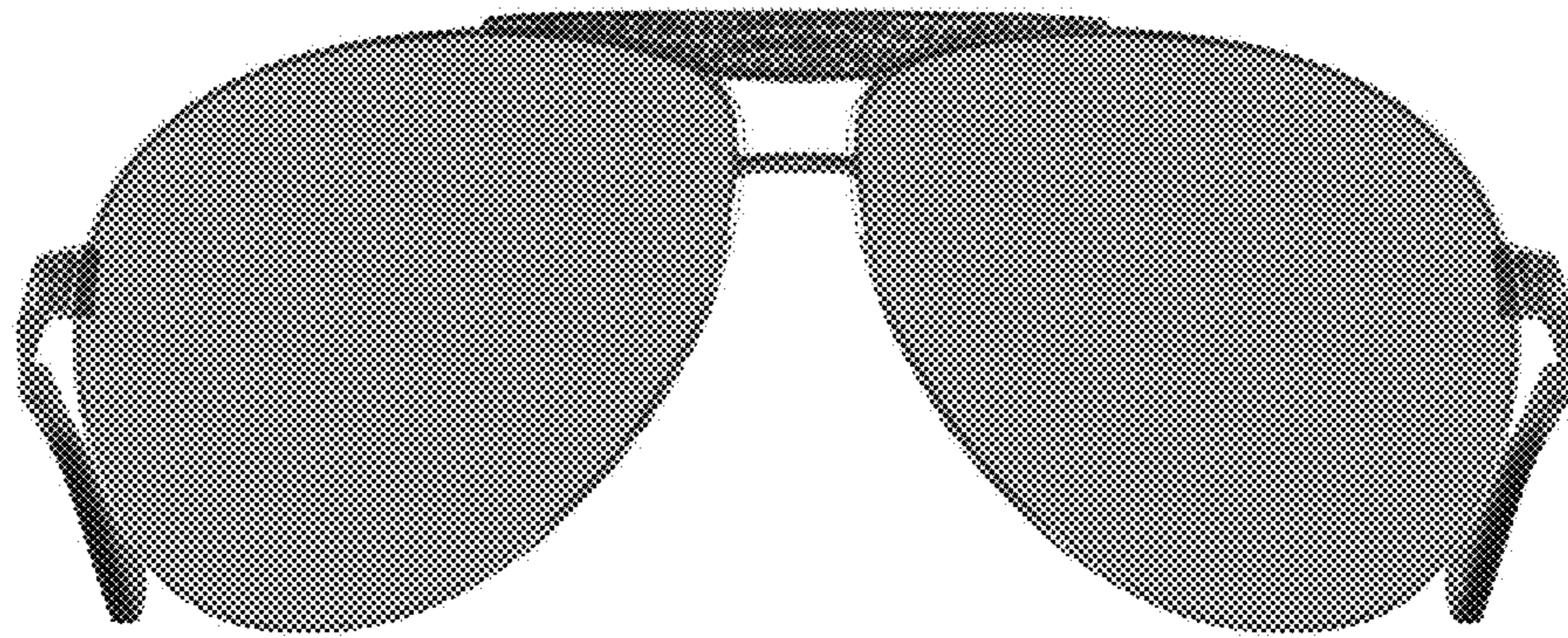

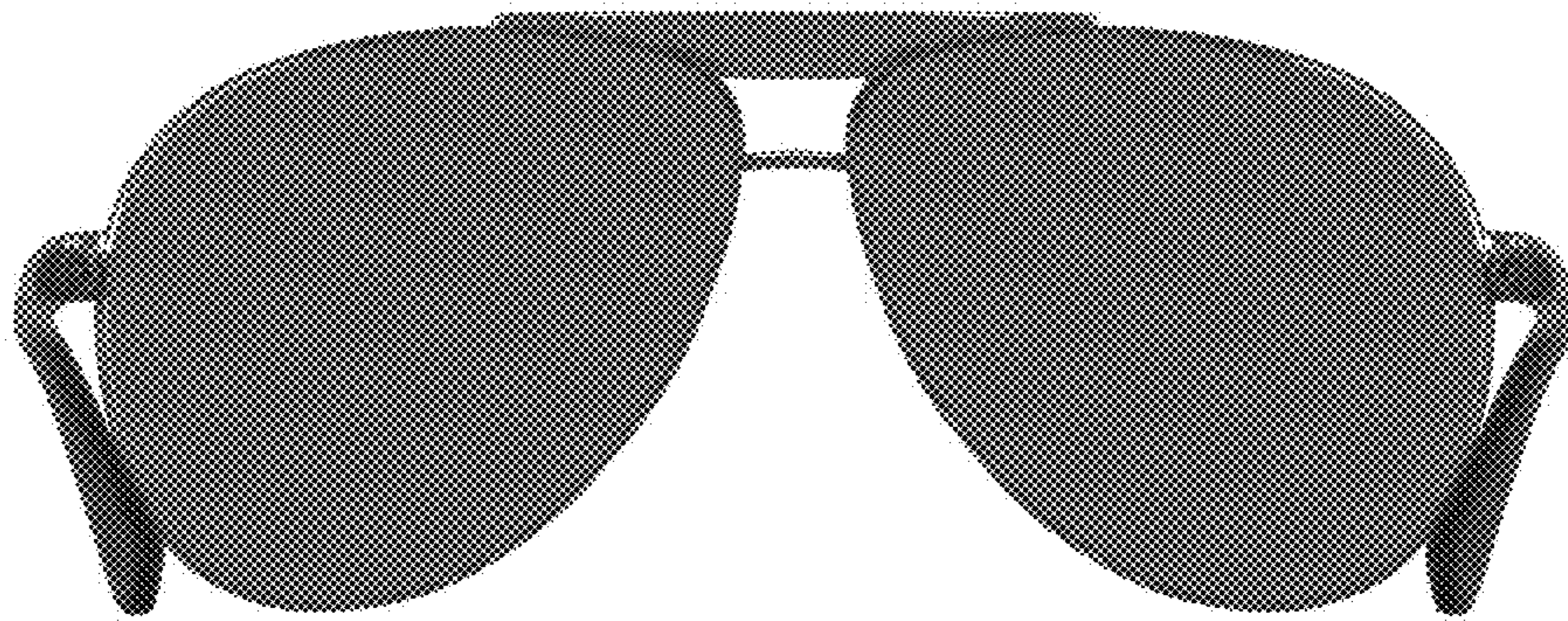

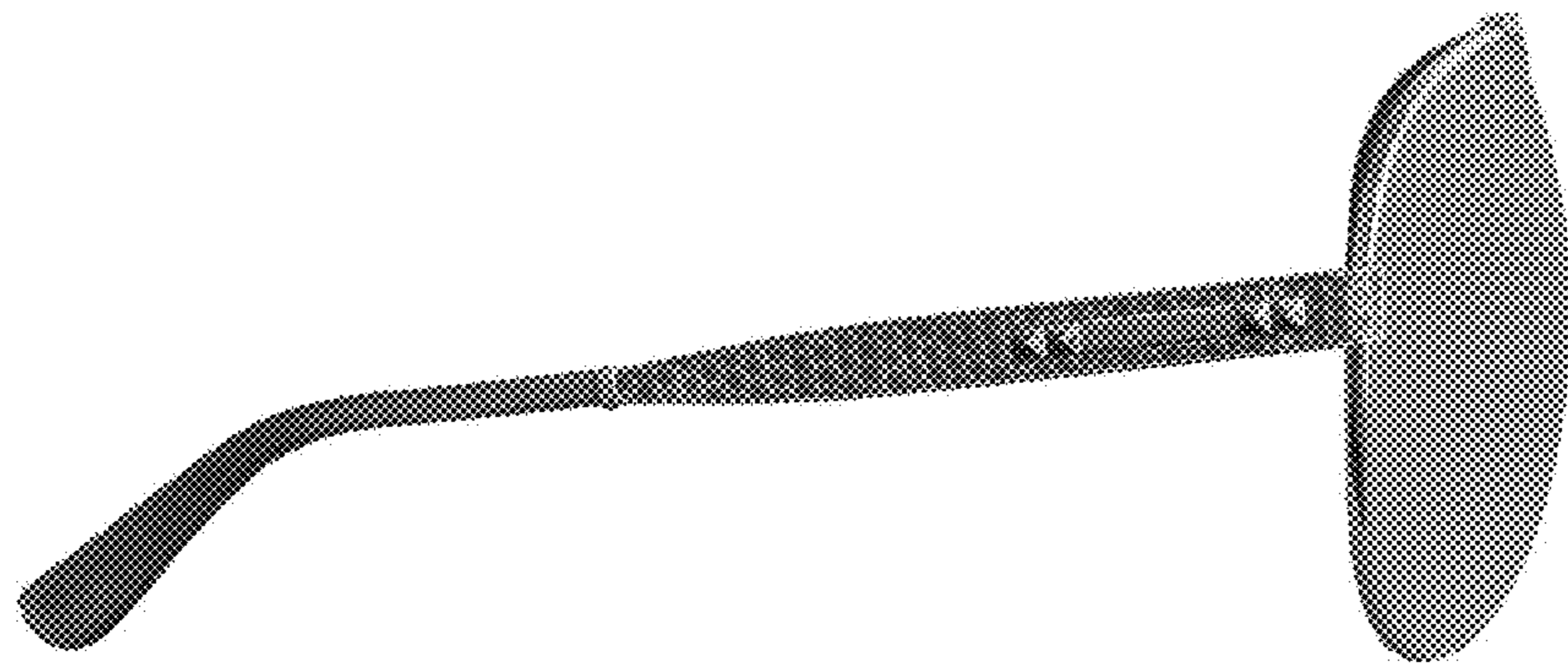

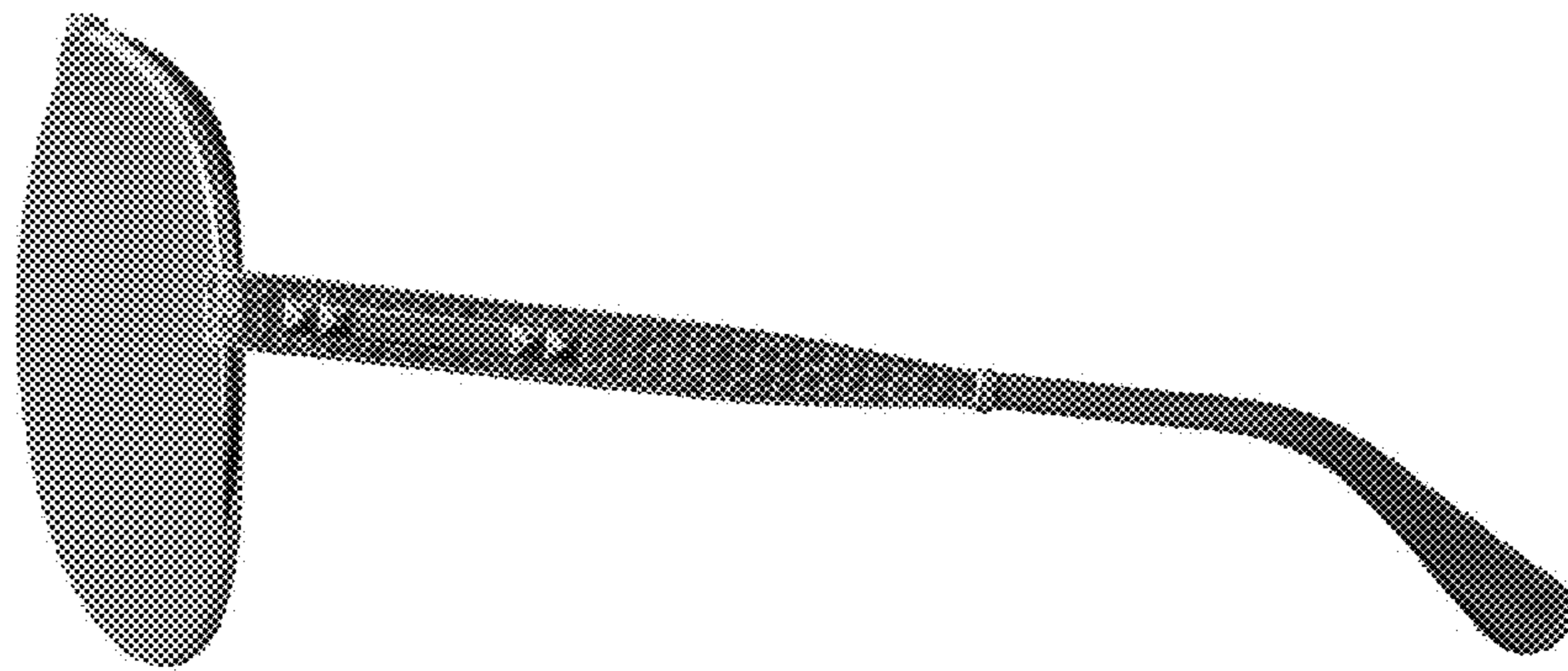
