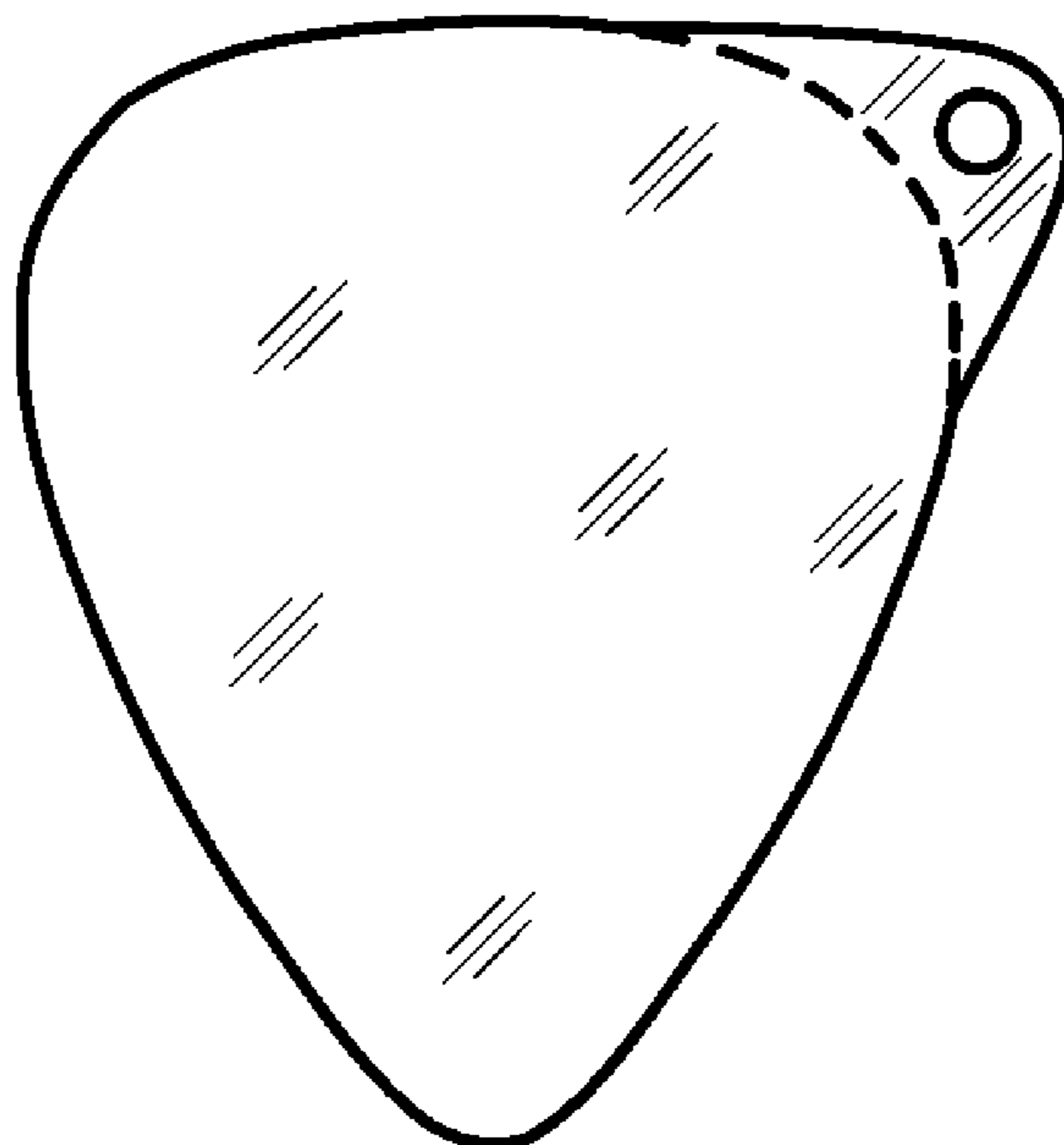
(57) **CLAIM**

The ornamental design for a detachable guitar pick, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a detachable guitar pick showing my new design;  
FIG. 2 is a rear elevation view thereof;  
FIG. 3 is a rear elevation view thereof, with the pick detached the key tag;  
FIG. 4 is a top view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a right side view thereof; and,  
FIG. 7 is a bottom view thereof.  
The broken lines shown in the drawings indicate perforations in the design claim.

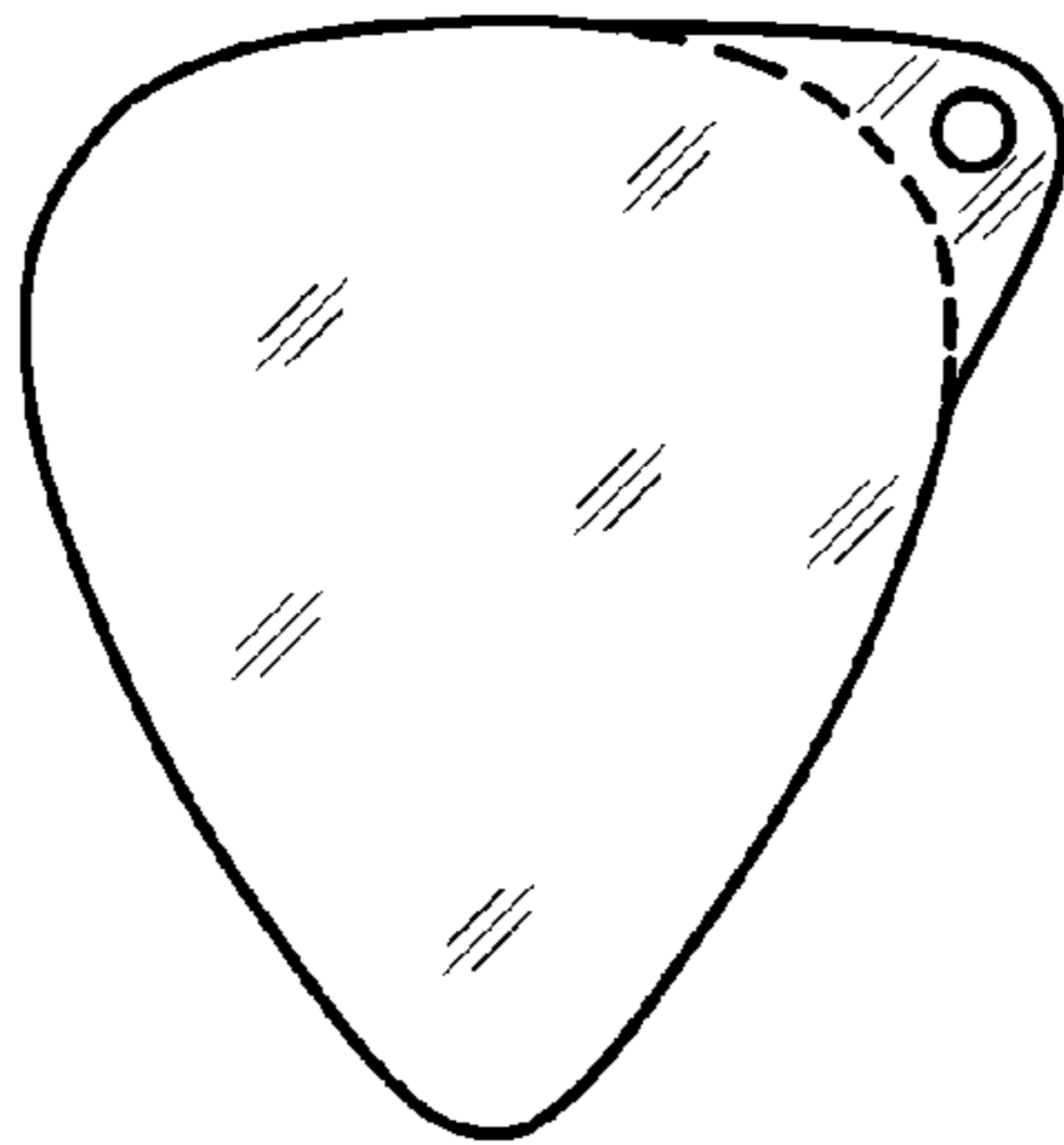

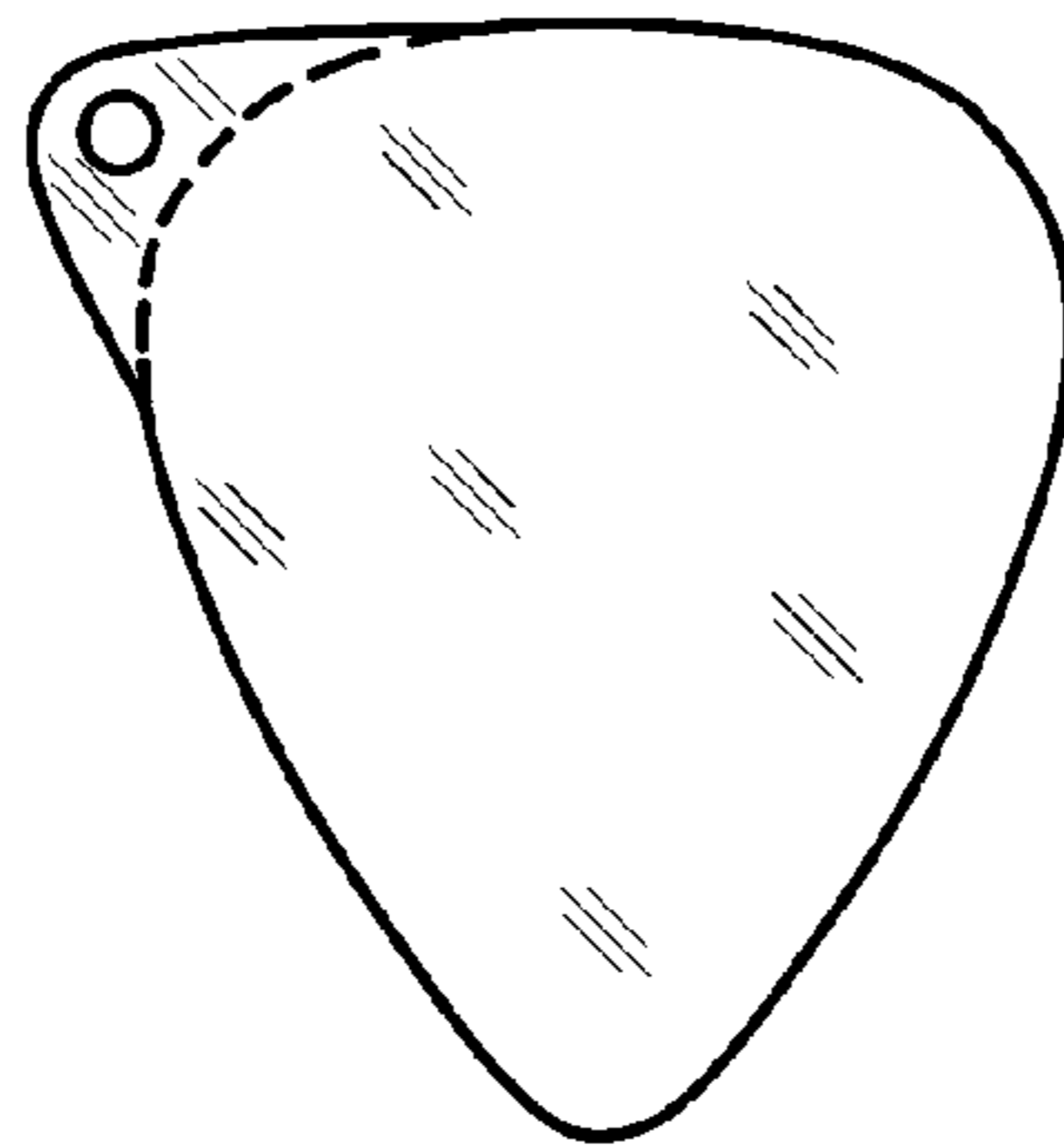

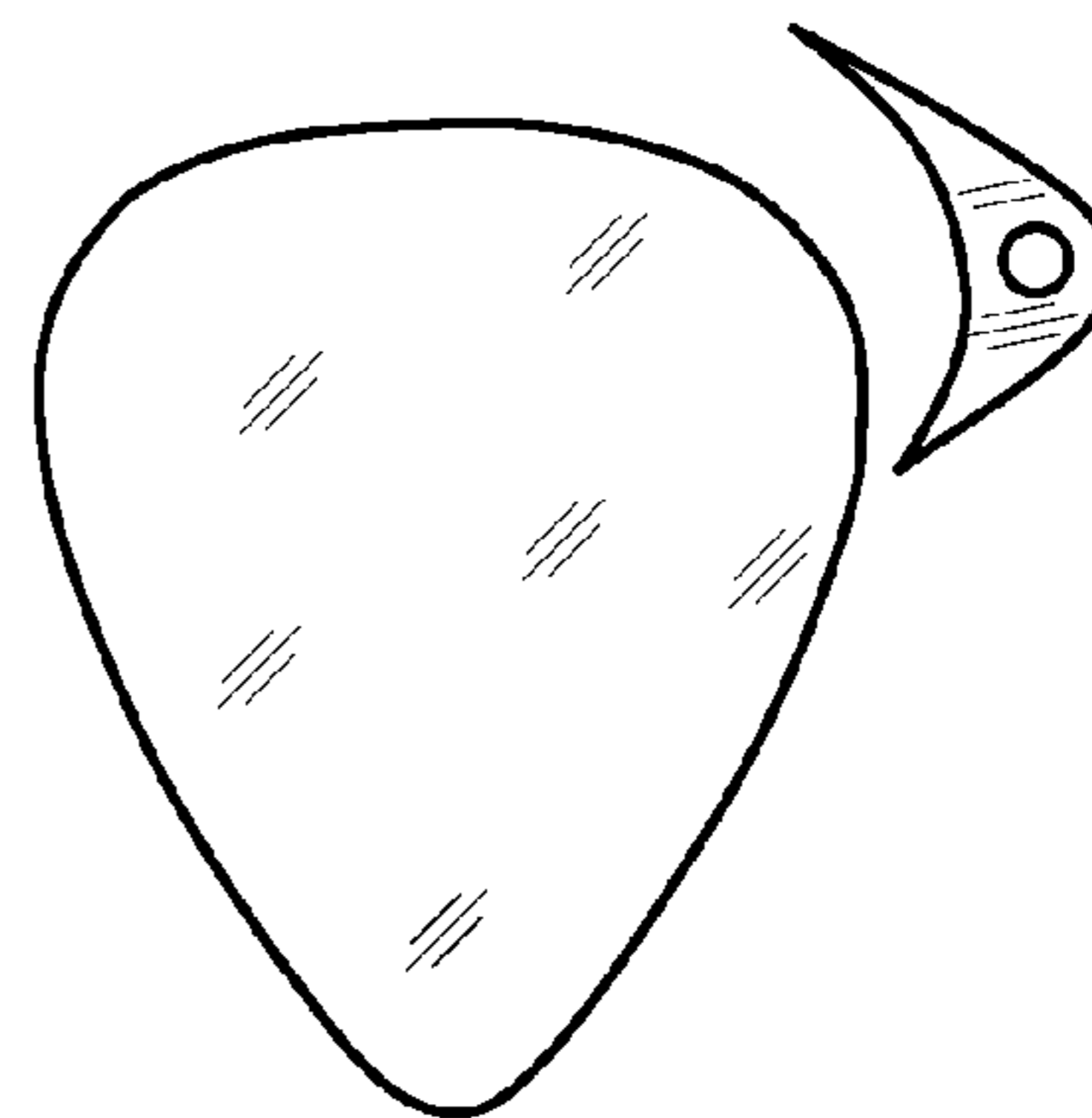

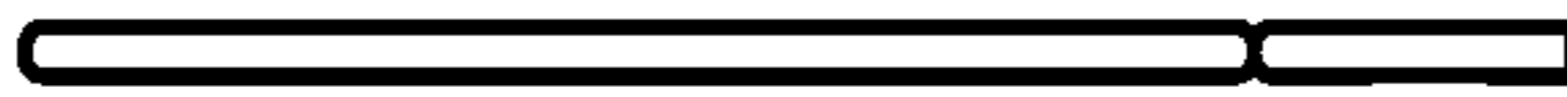
