(57) **CLAIM**

The ornamental design for a combination greeting card and wallet, as shown and described.

DESCRIPTION

FIG. 1 is a front and side perspective view of the combination greeting card and wallet with the front panel slightly opened showing my new design;

FIG. 2 is a front and top perspective thereof, with the front panel closed;

FIG. 3 is a rear perspective view thereof;

FIG. 4 is another perspective view of the combination greeting card and wallet with the panels in an open position.

FIG. 5 is a left side view of the combination greeting card and wallet shown in FIG. 4; and,

FIG. 6 is a right side view thereof.

All broken lines including the showing of written and pictorial matter in FIGS. 1-2 and 4 and the currency note shown in FIG. 4 is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

The nature and intended use of the article in which the design claimed herein is embodied is a combination greeting card and wallet/checkbook cover.

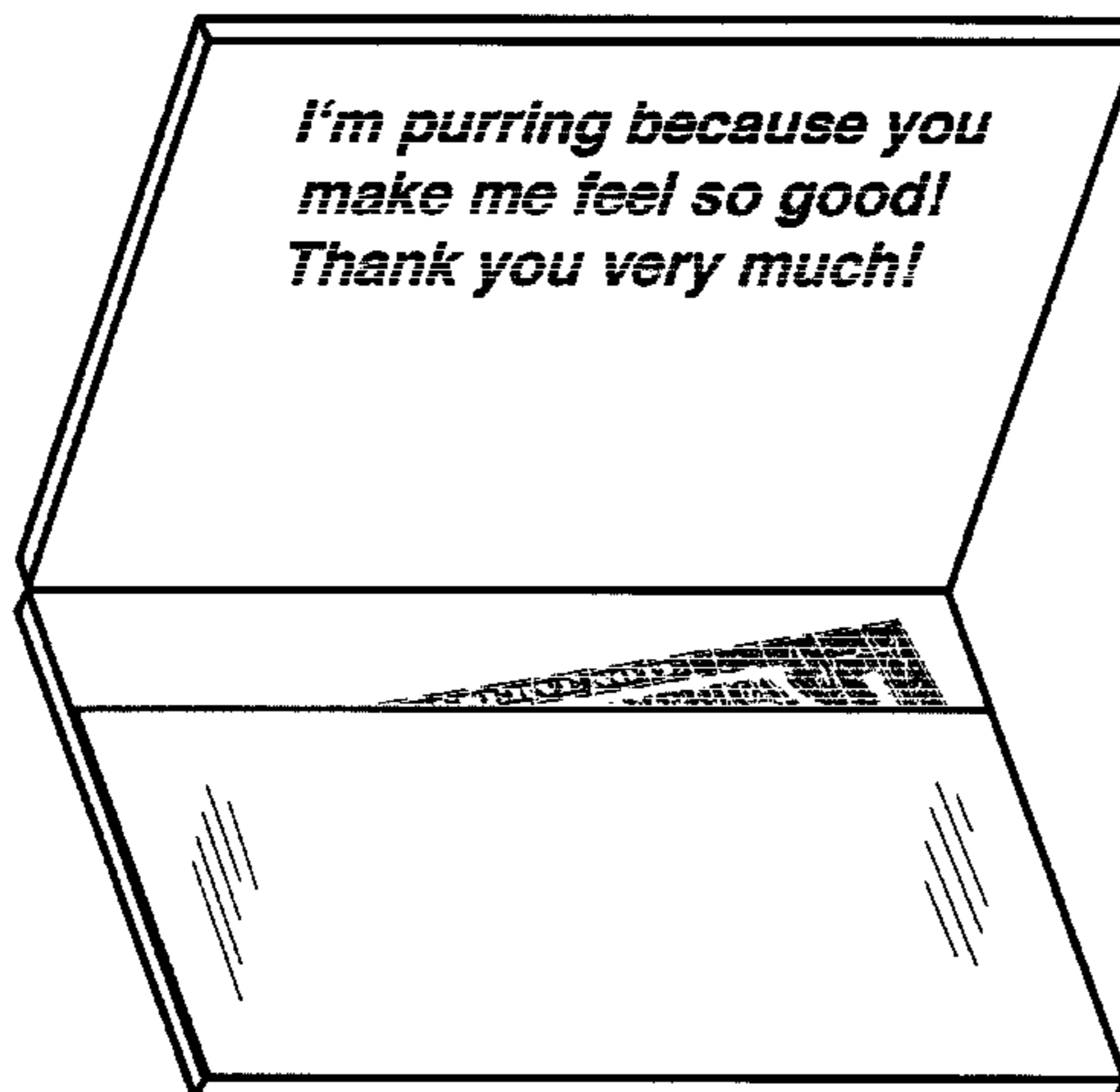

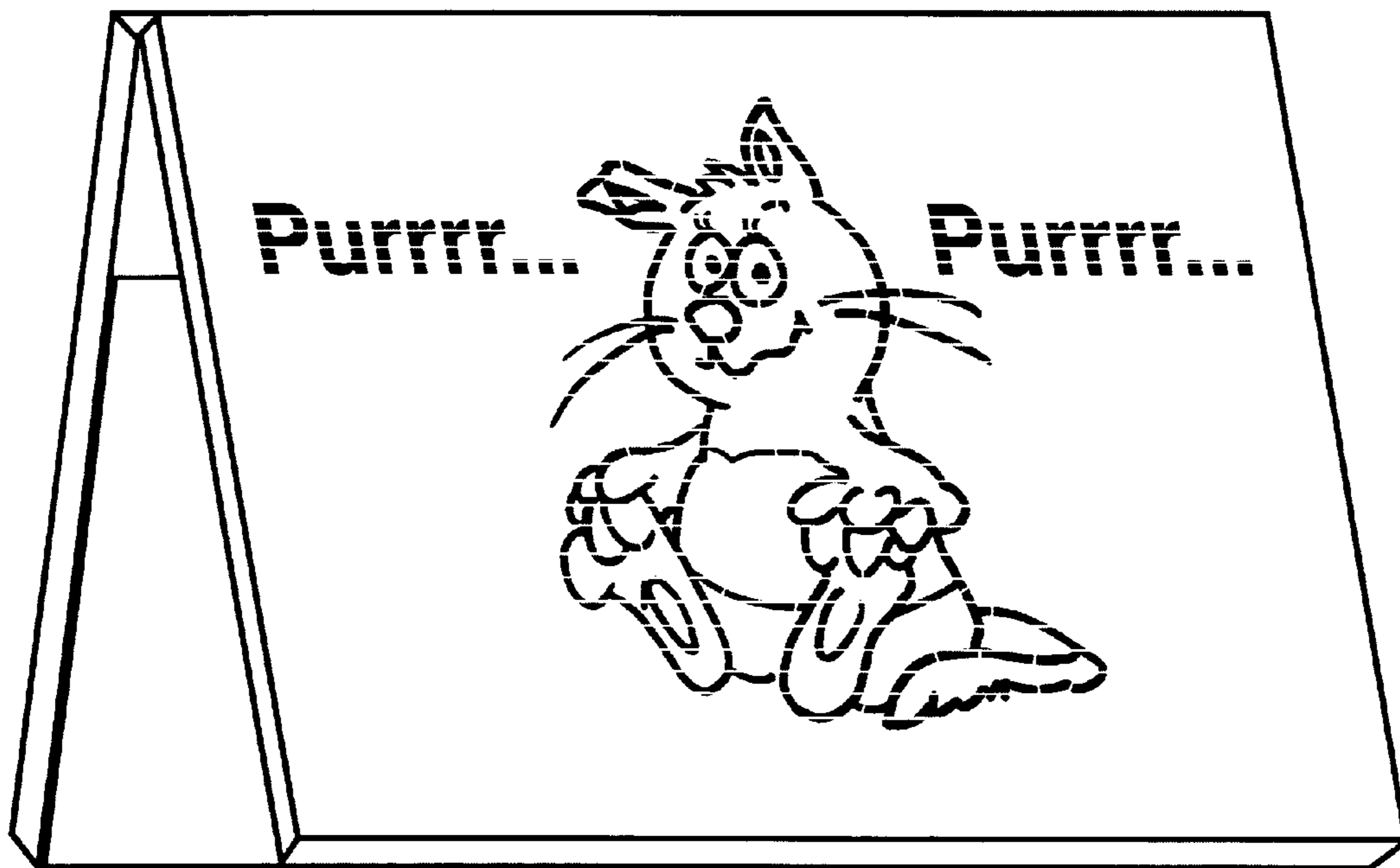

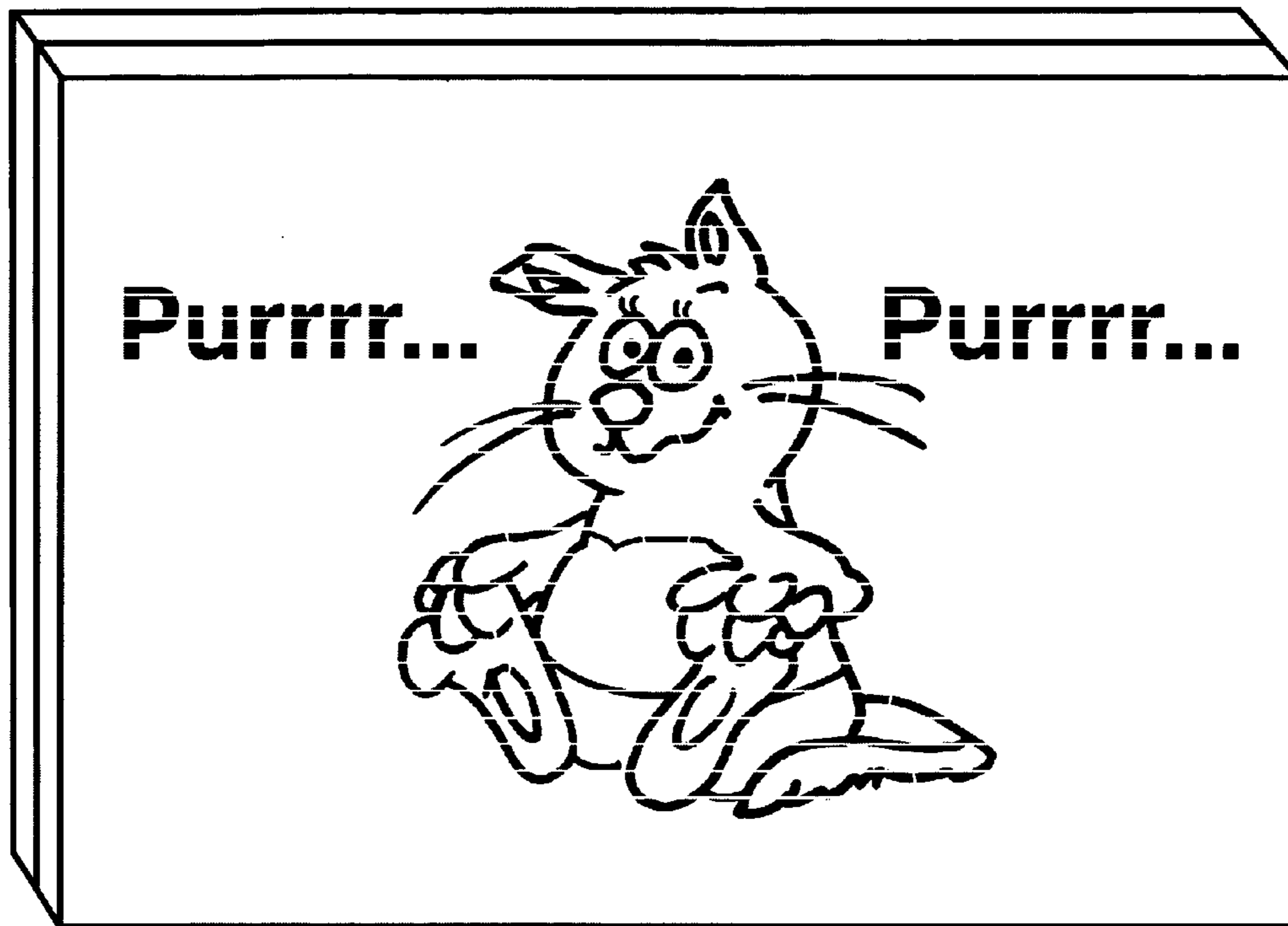

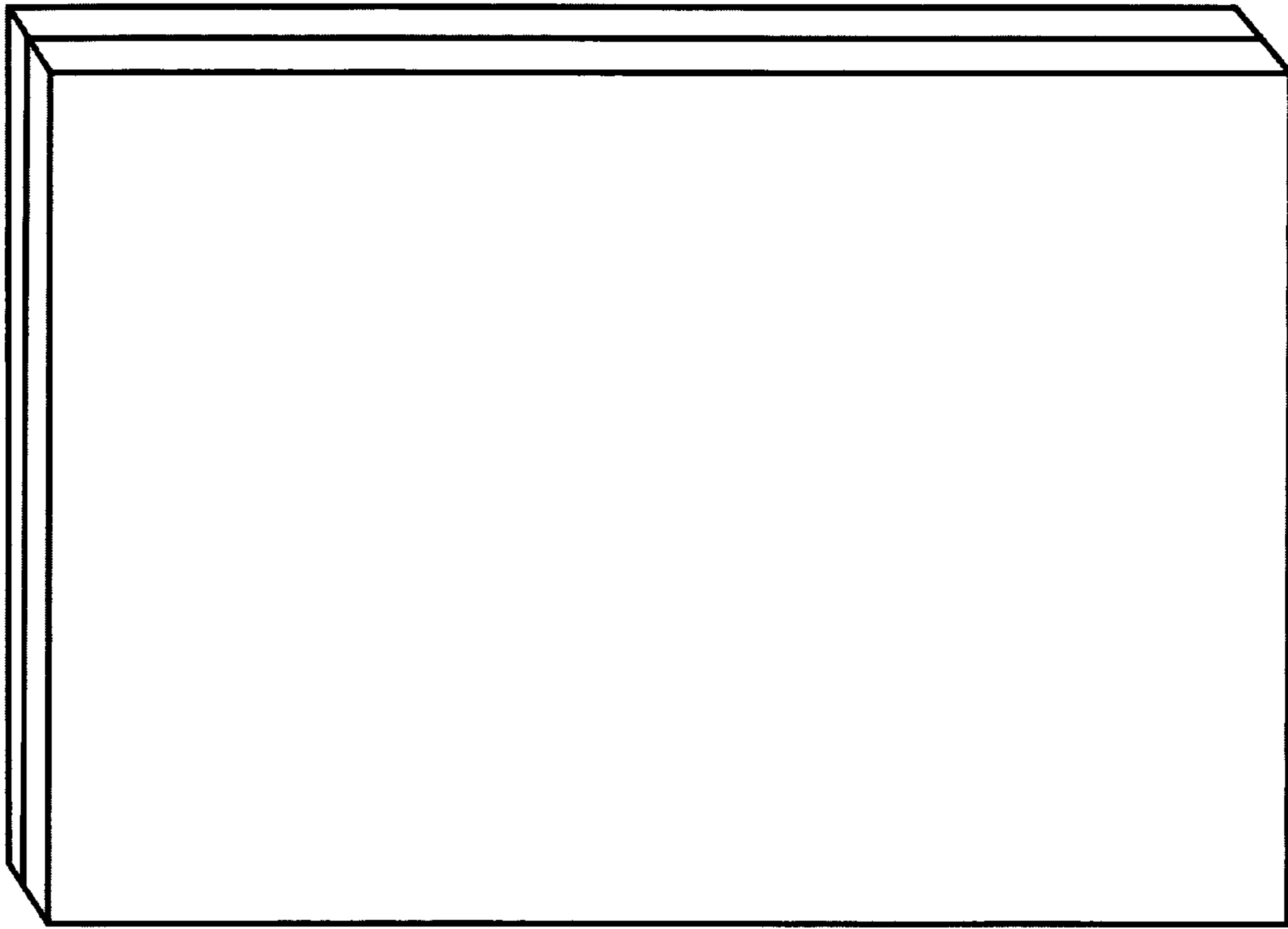

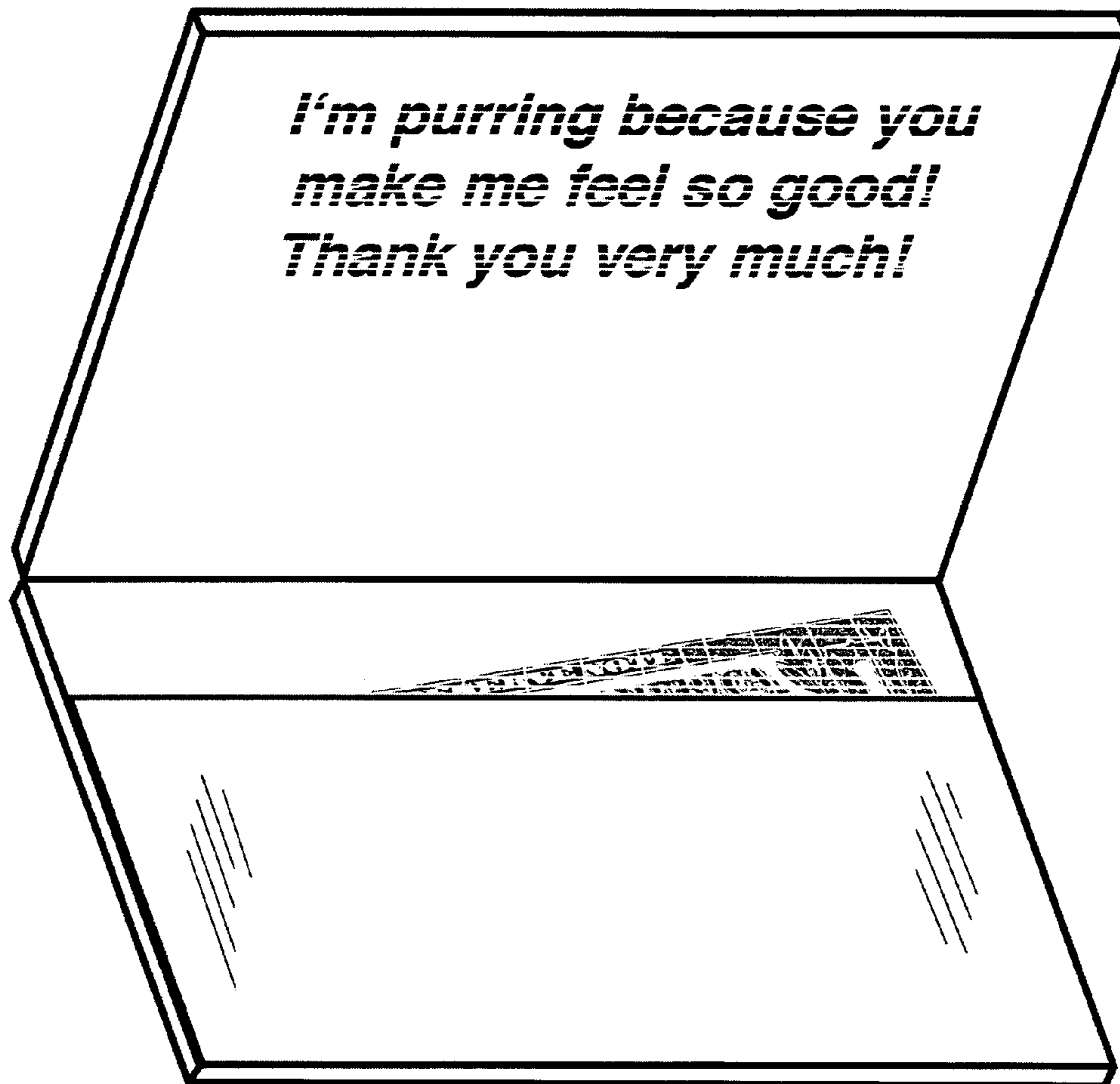

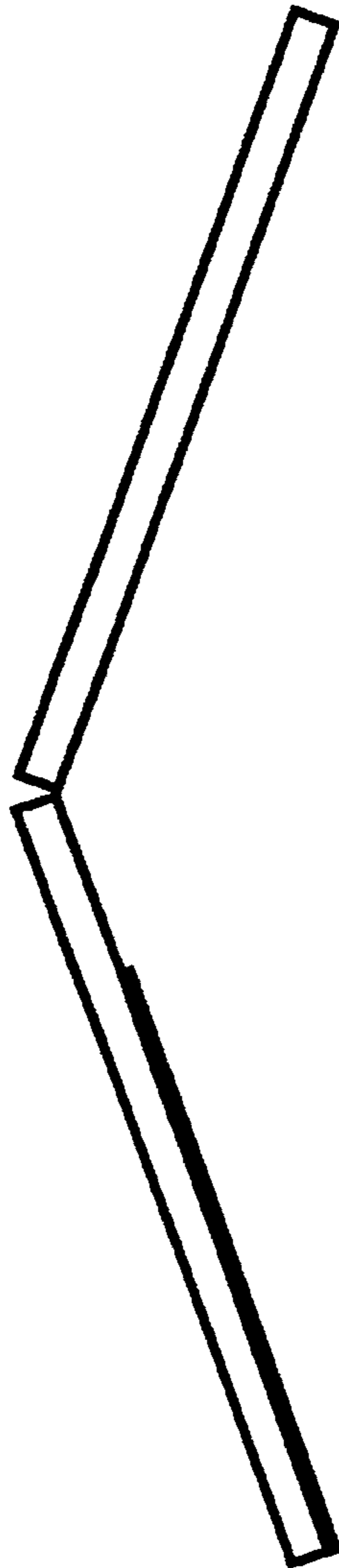
