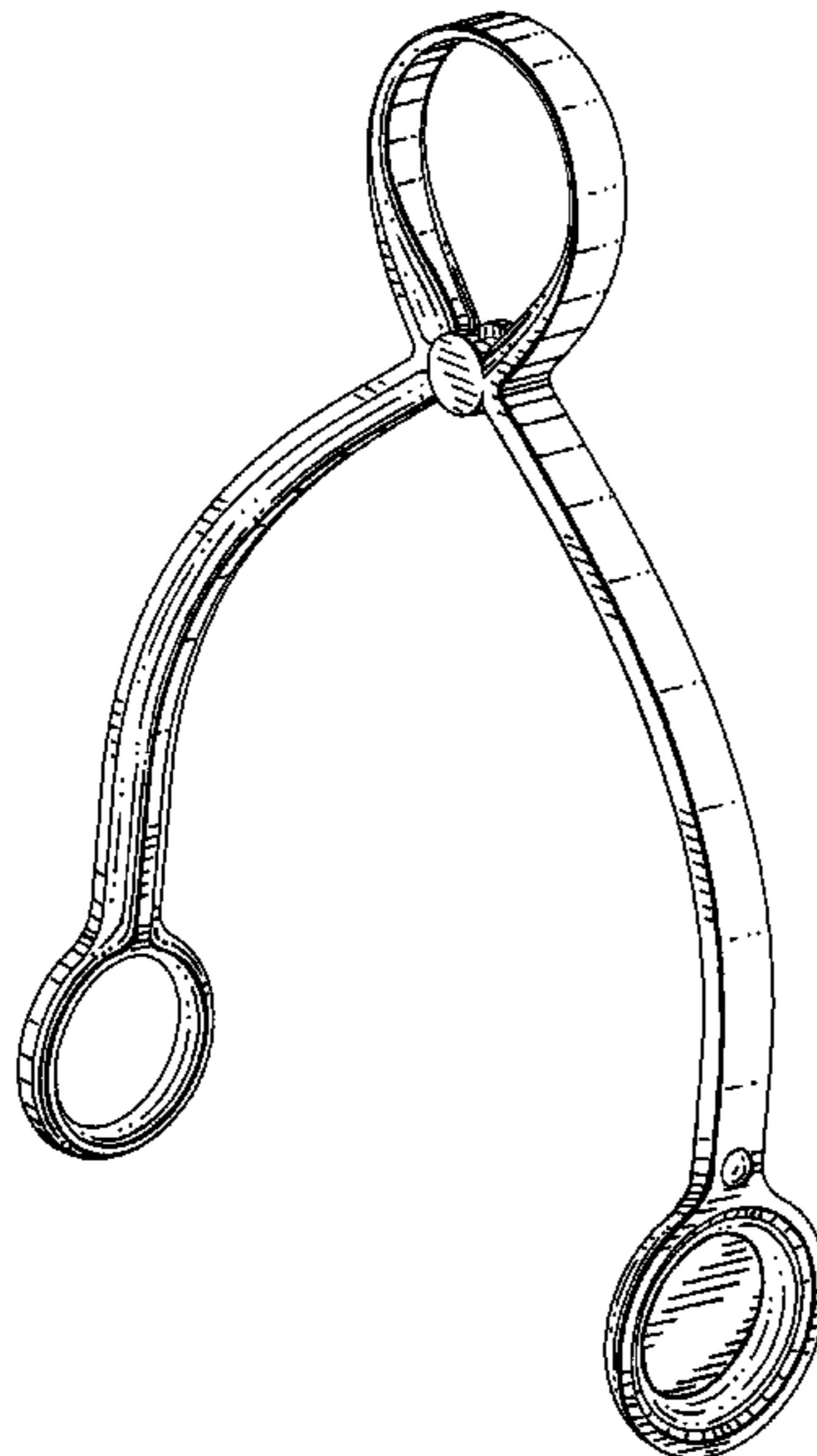
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a medical injector in accordance with an embodiment of the present invention.

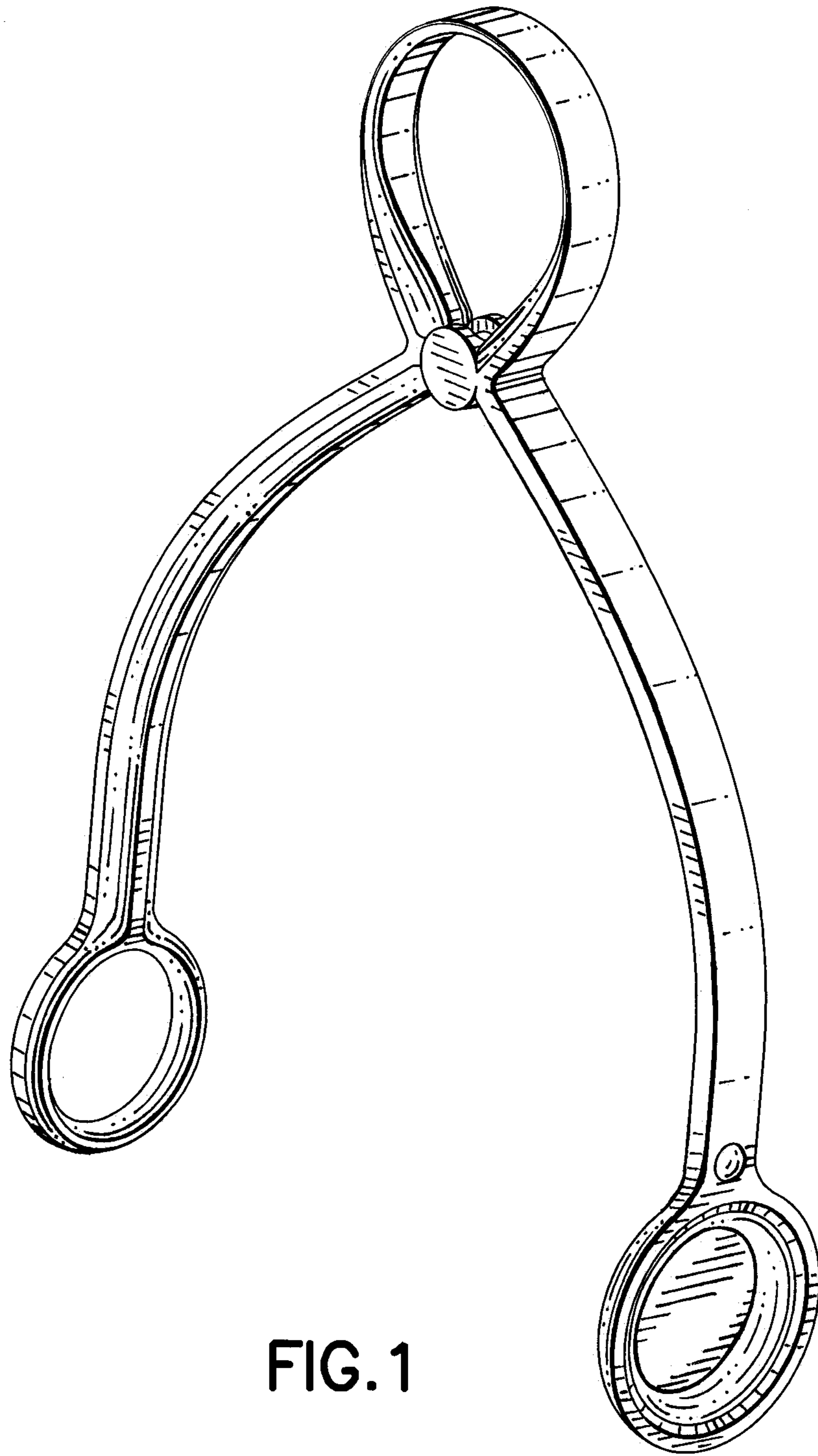

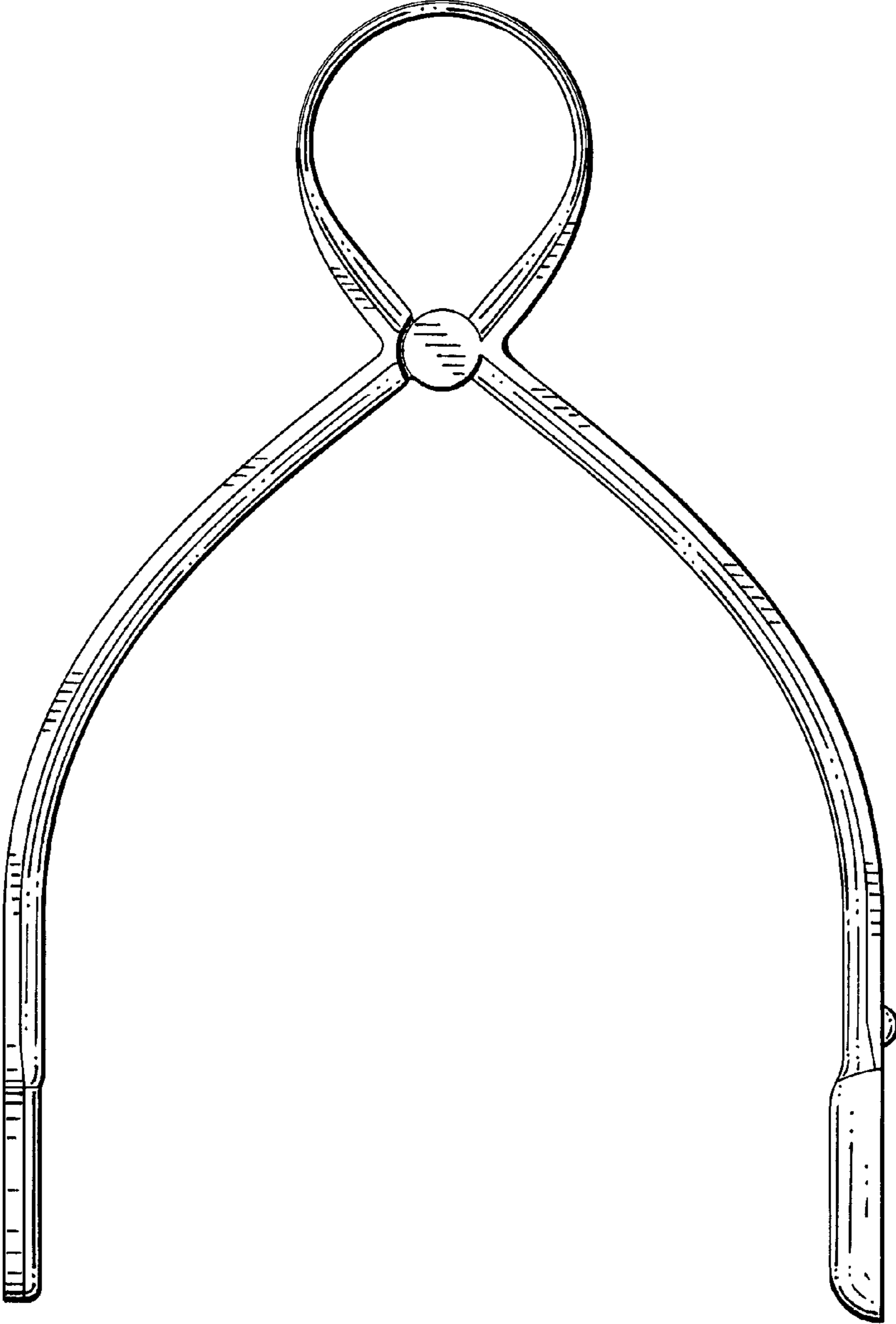

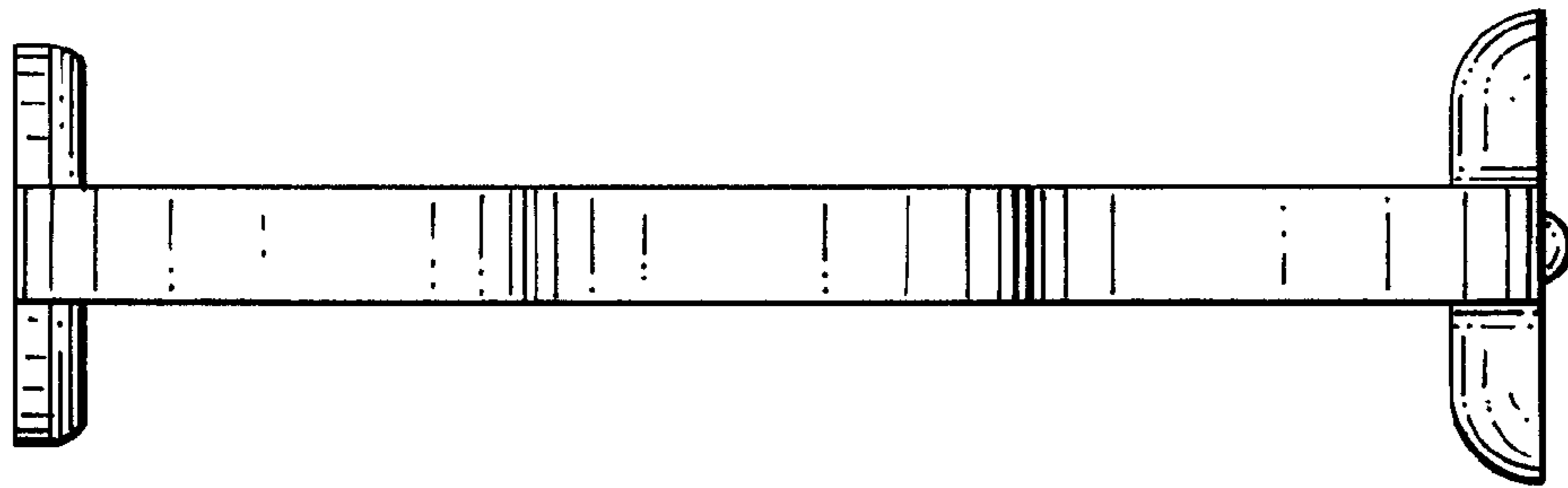

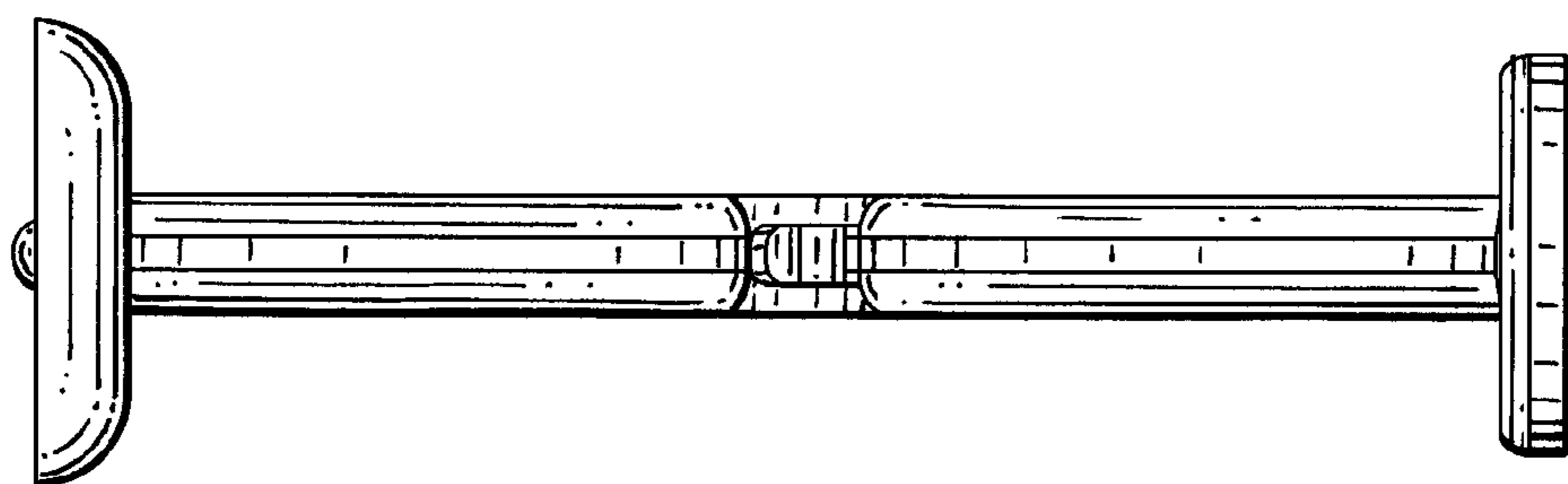

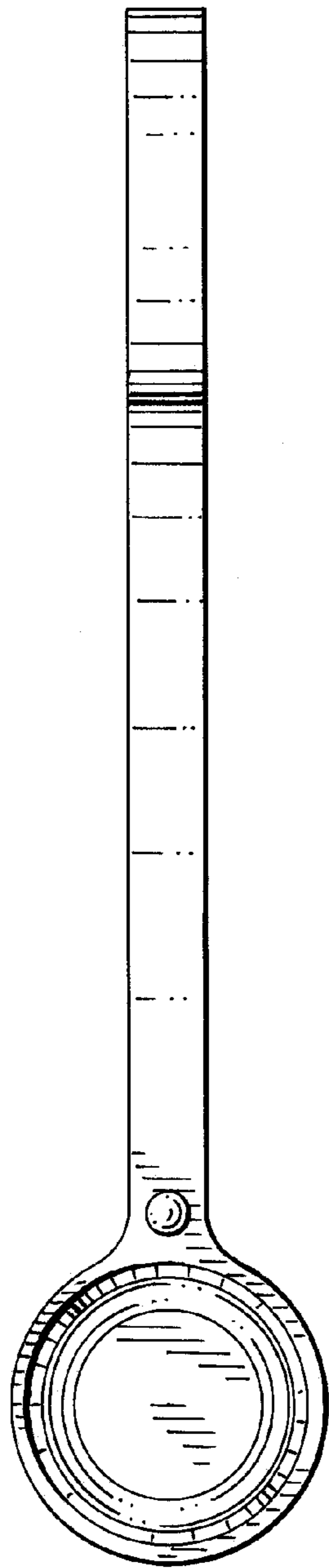

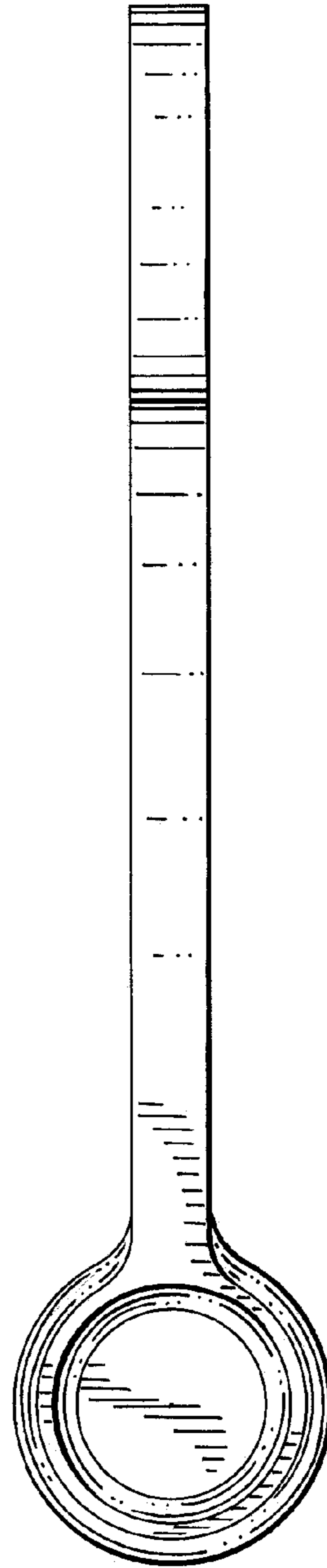

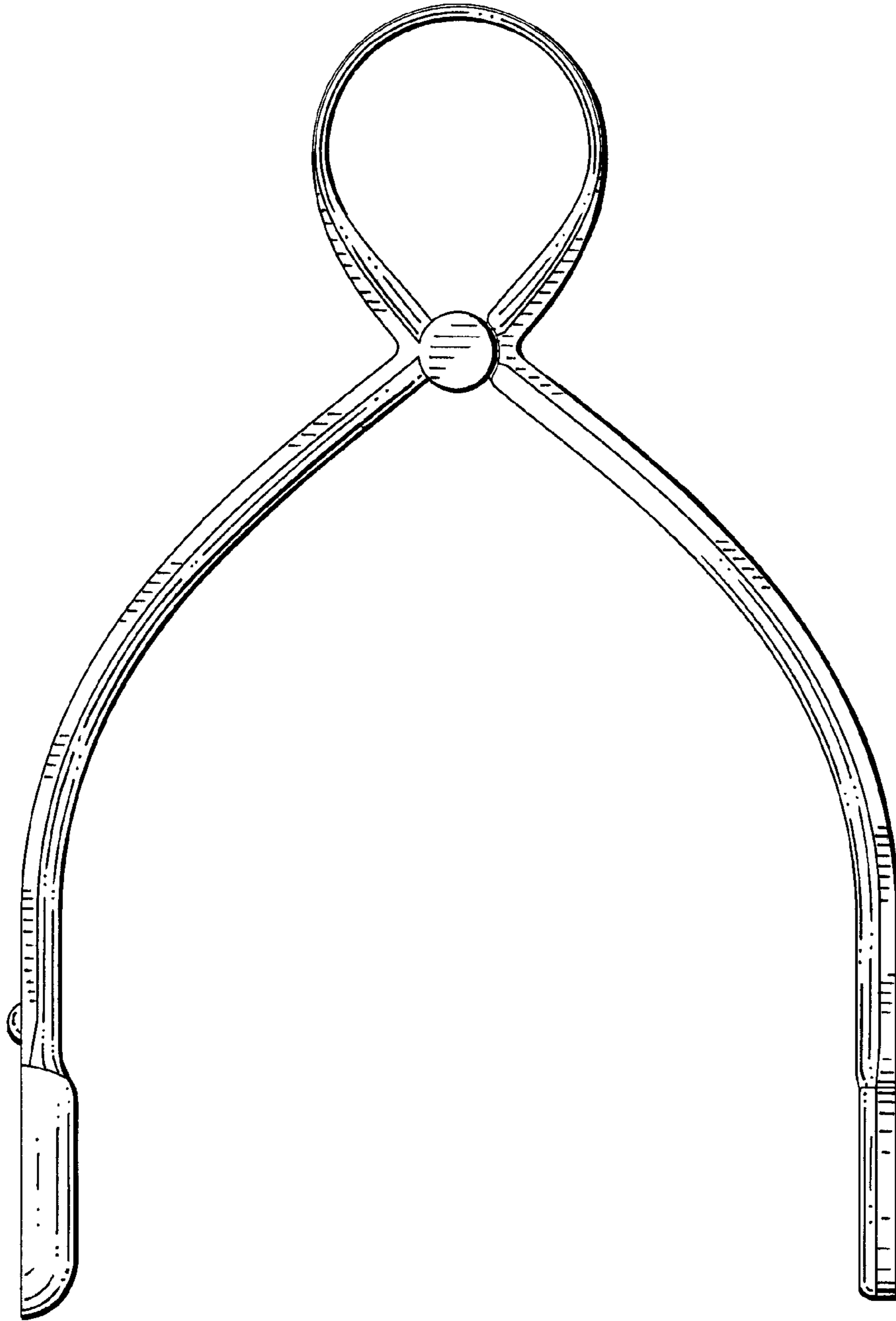
