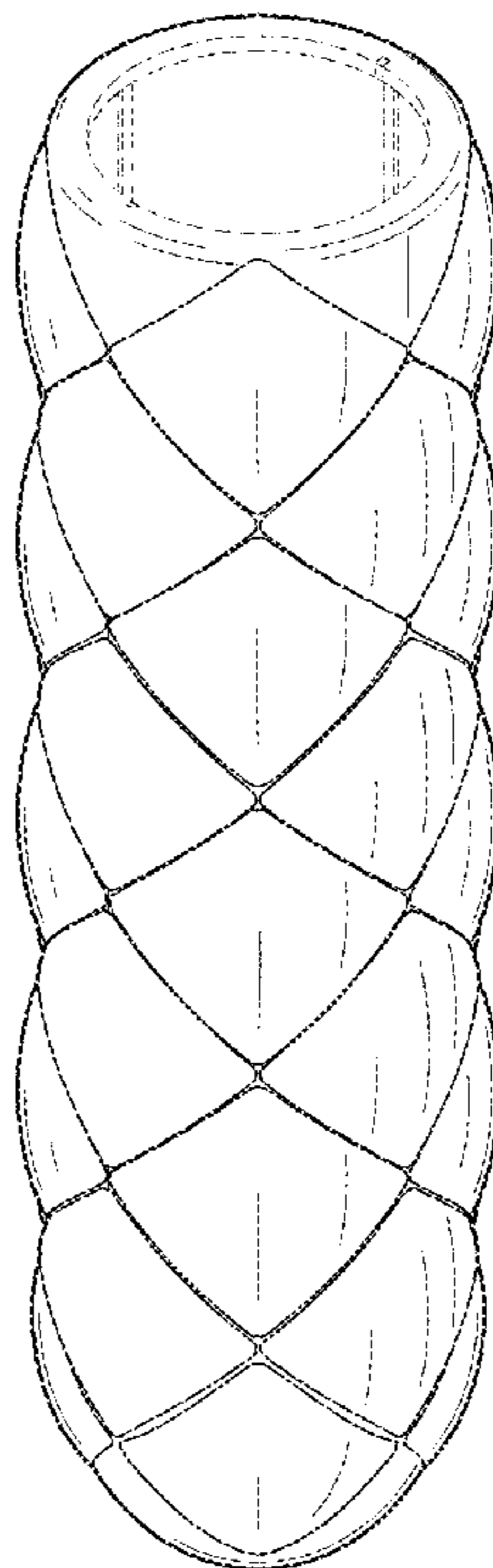
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a right side perspective view of a sleeve for a personal massager showing my new design.
FIG. 2 is a front plan view thereof.

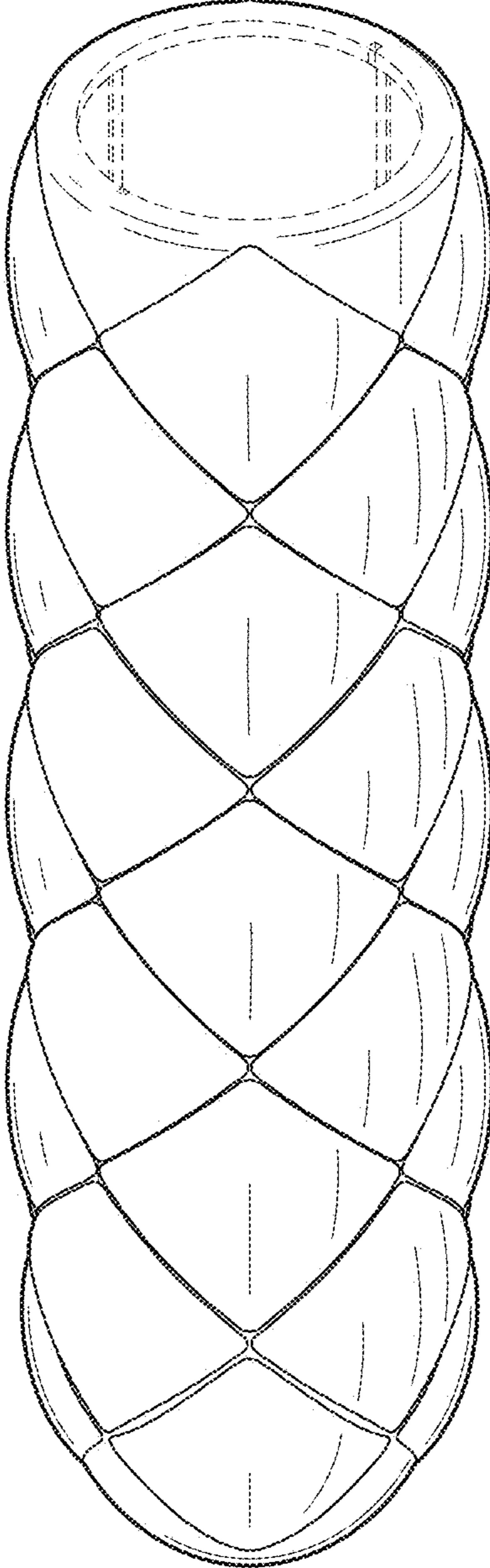

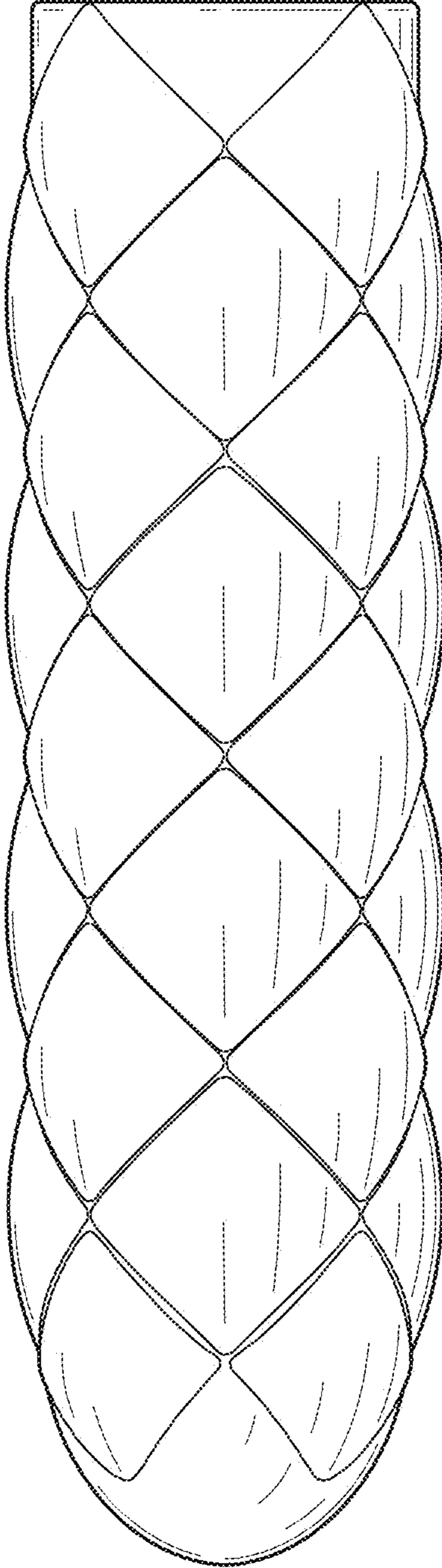

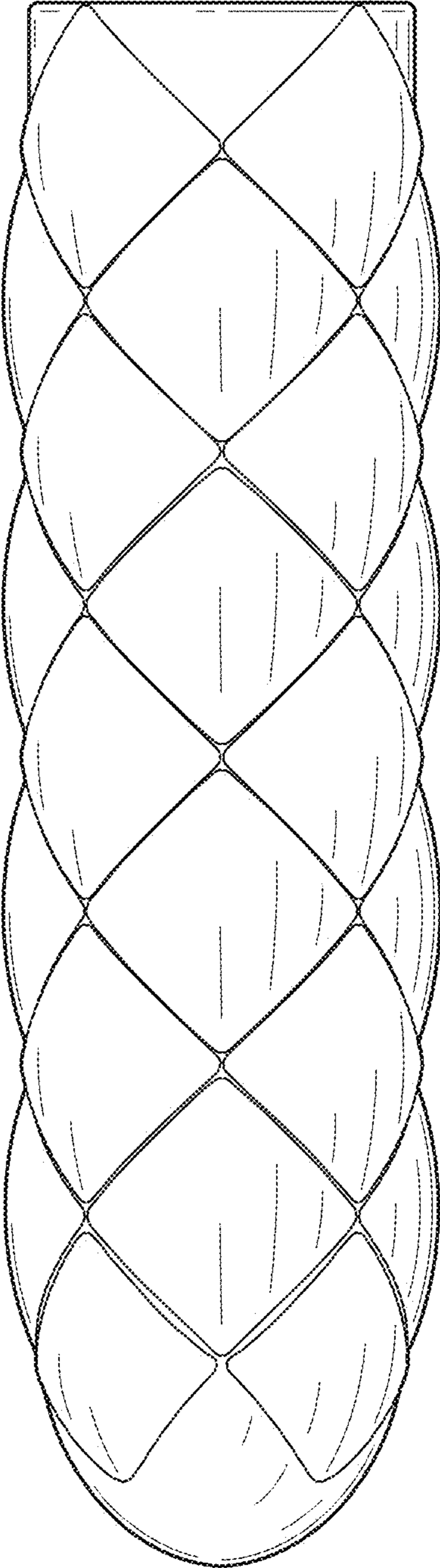

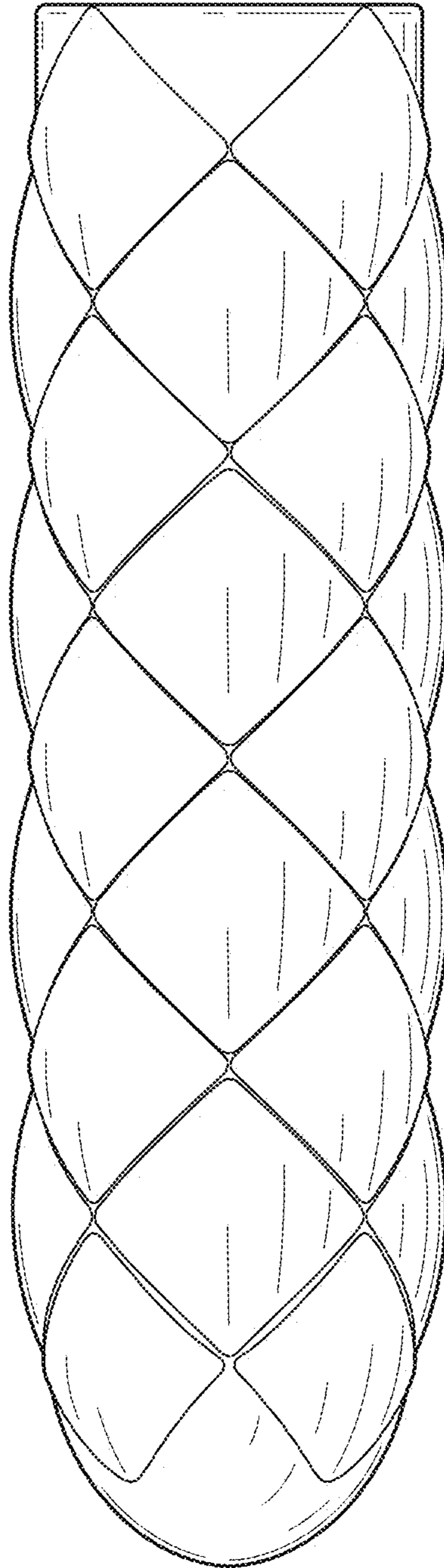

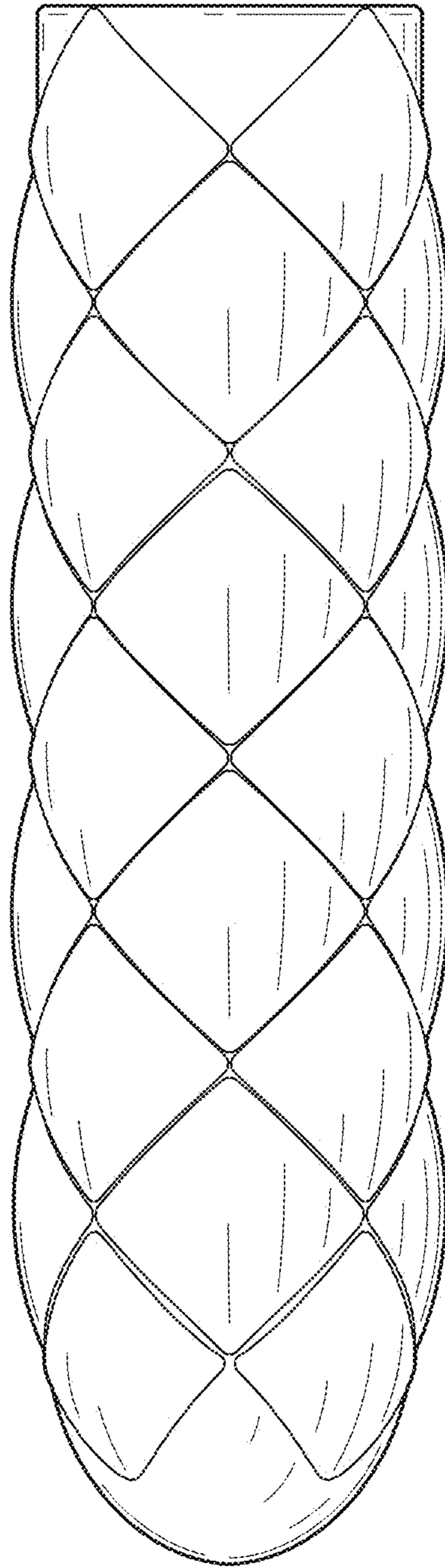

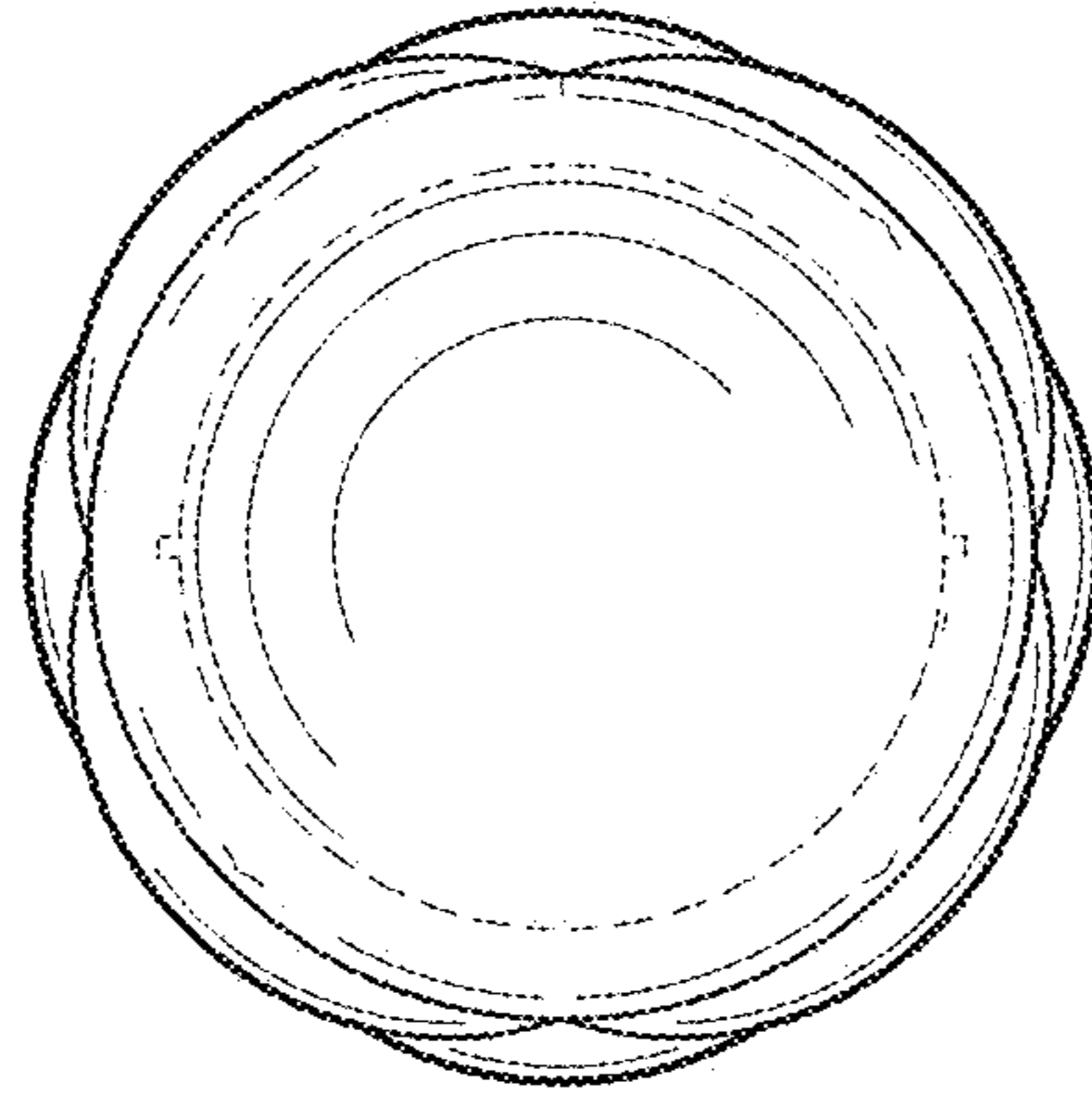

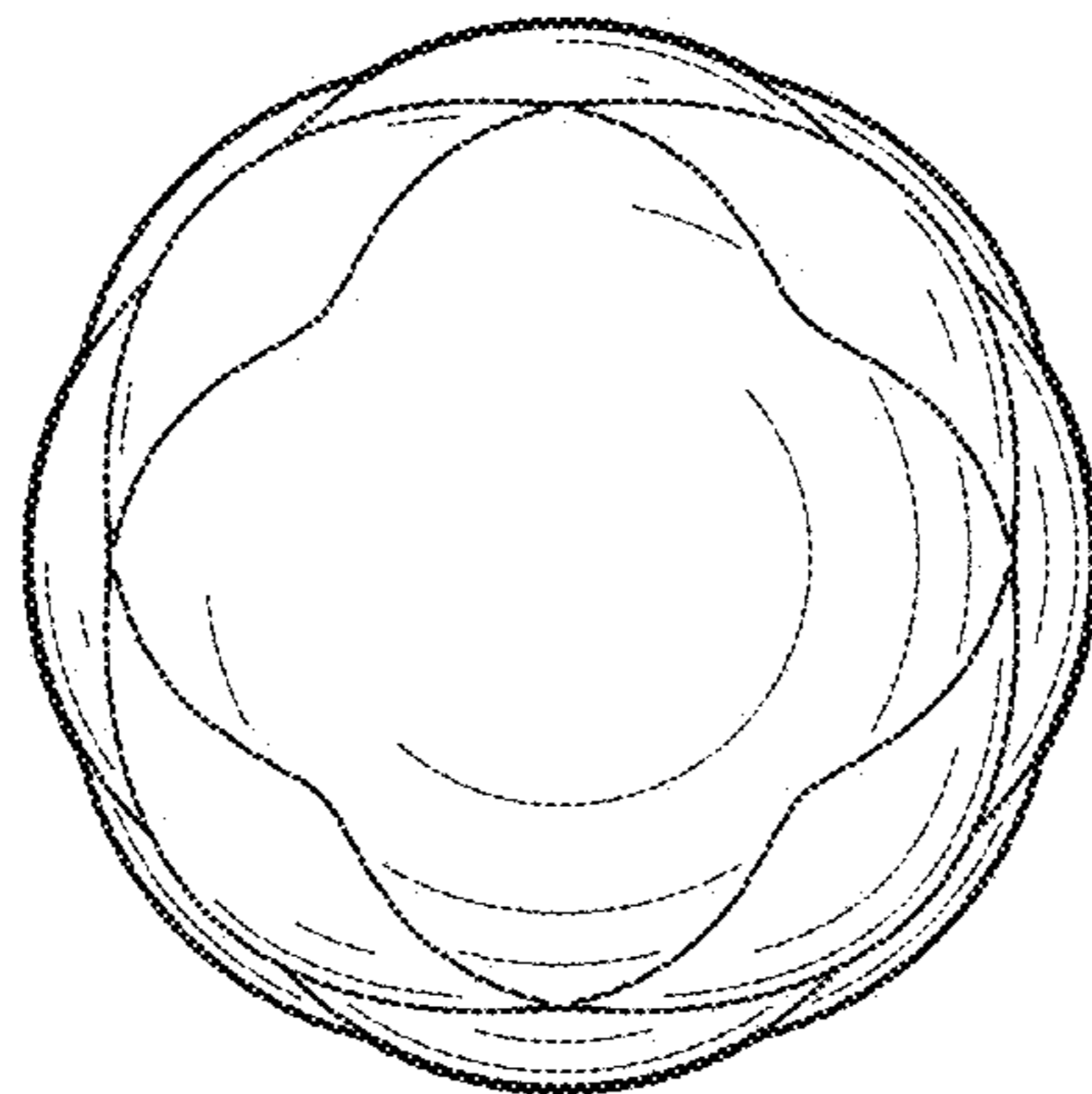
