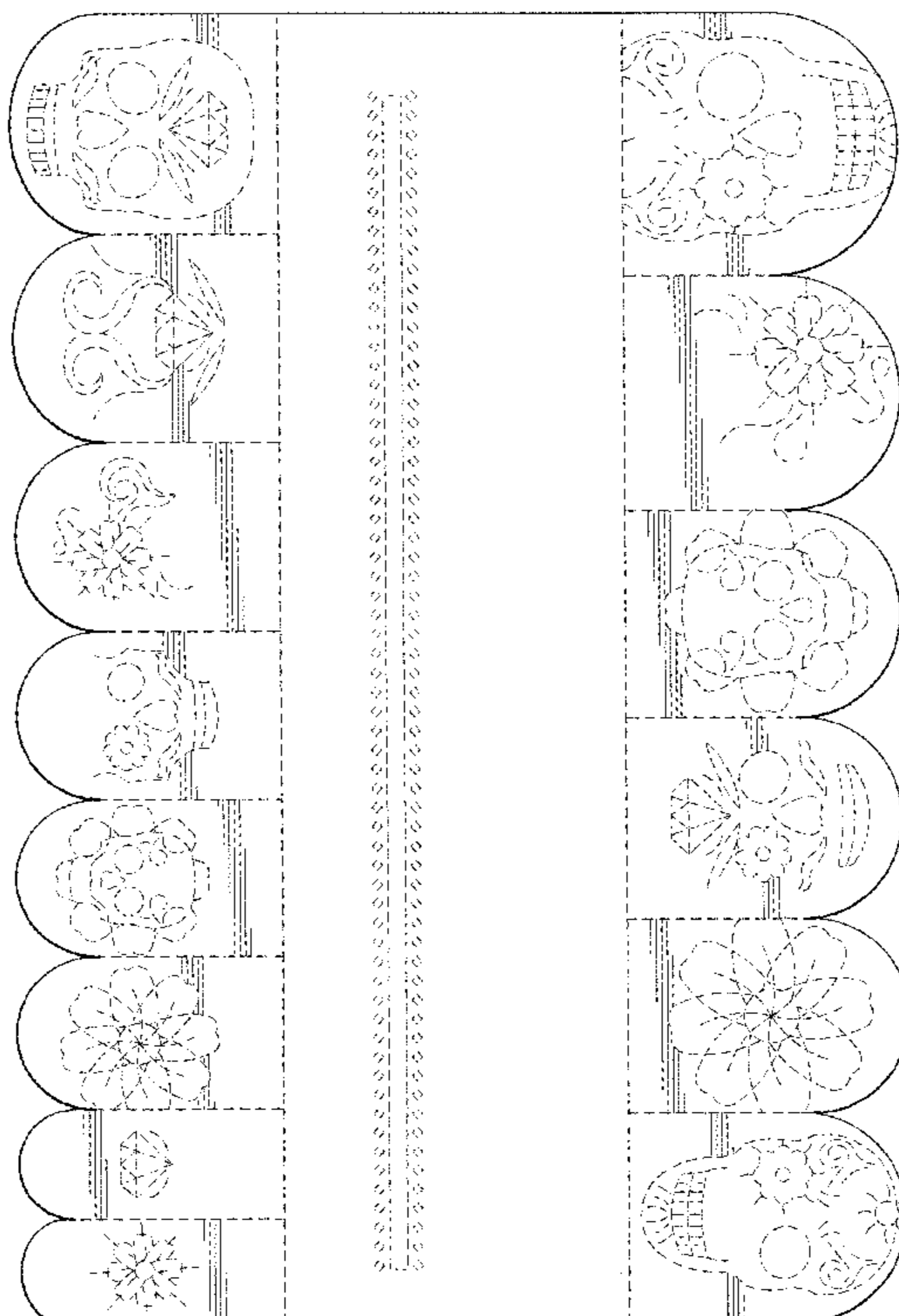
(57) **CLAIM**

The ornamental design for a device for applying nail decals, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a device for applying nail decals showing my new design, the dashed lines showing decals and perforations being for illustrative purposes only and forming no part of the claimed design; FIG. 2 is a bottom plan view thereof; FIG. 3 is a front side elevation view thereof; and, FIG. 4 is a right side elevation view thereof.

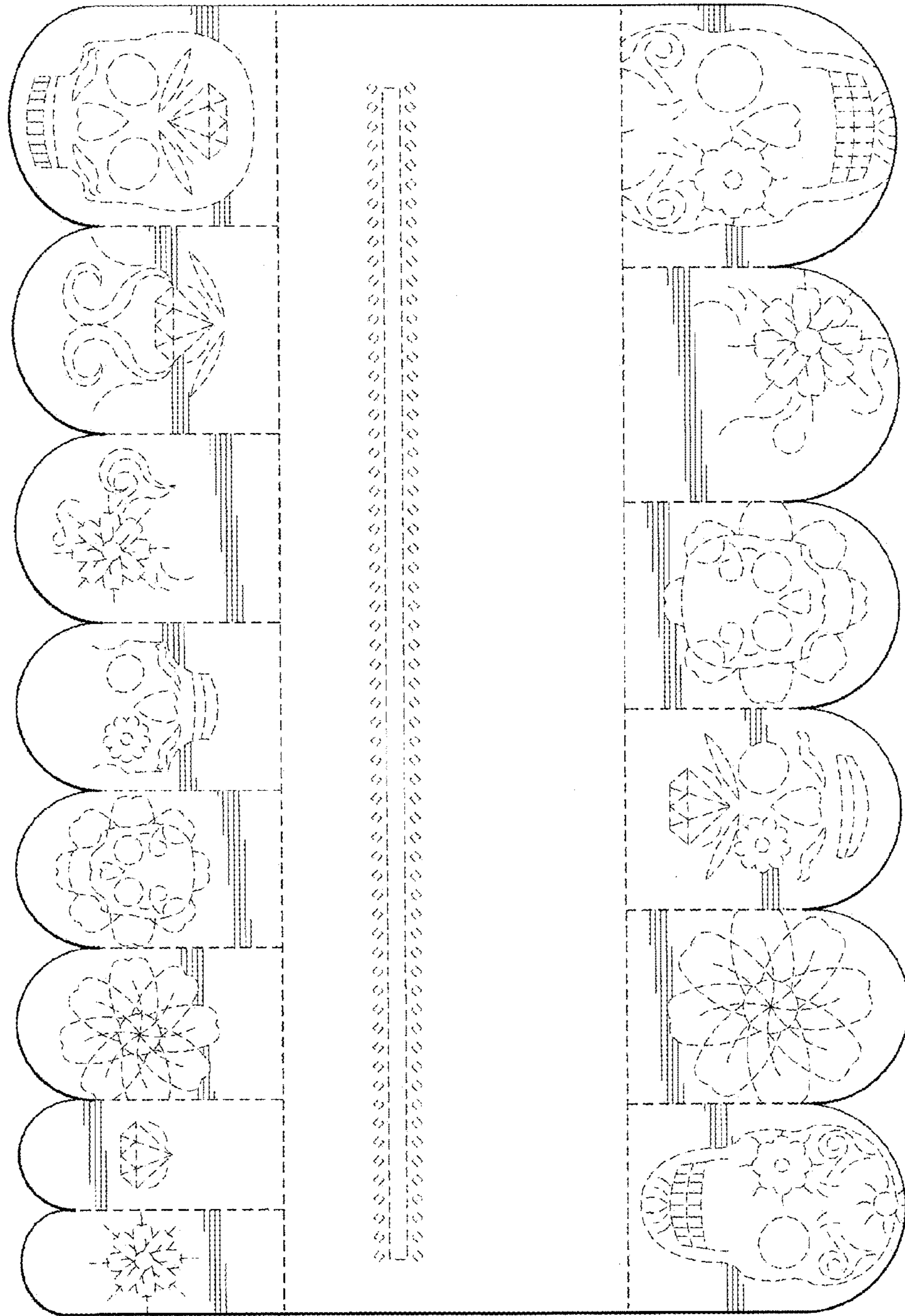

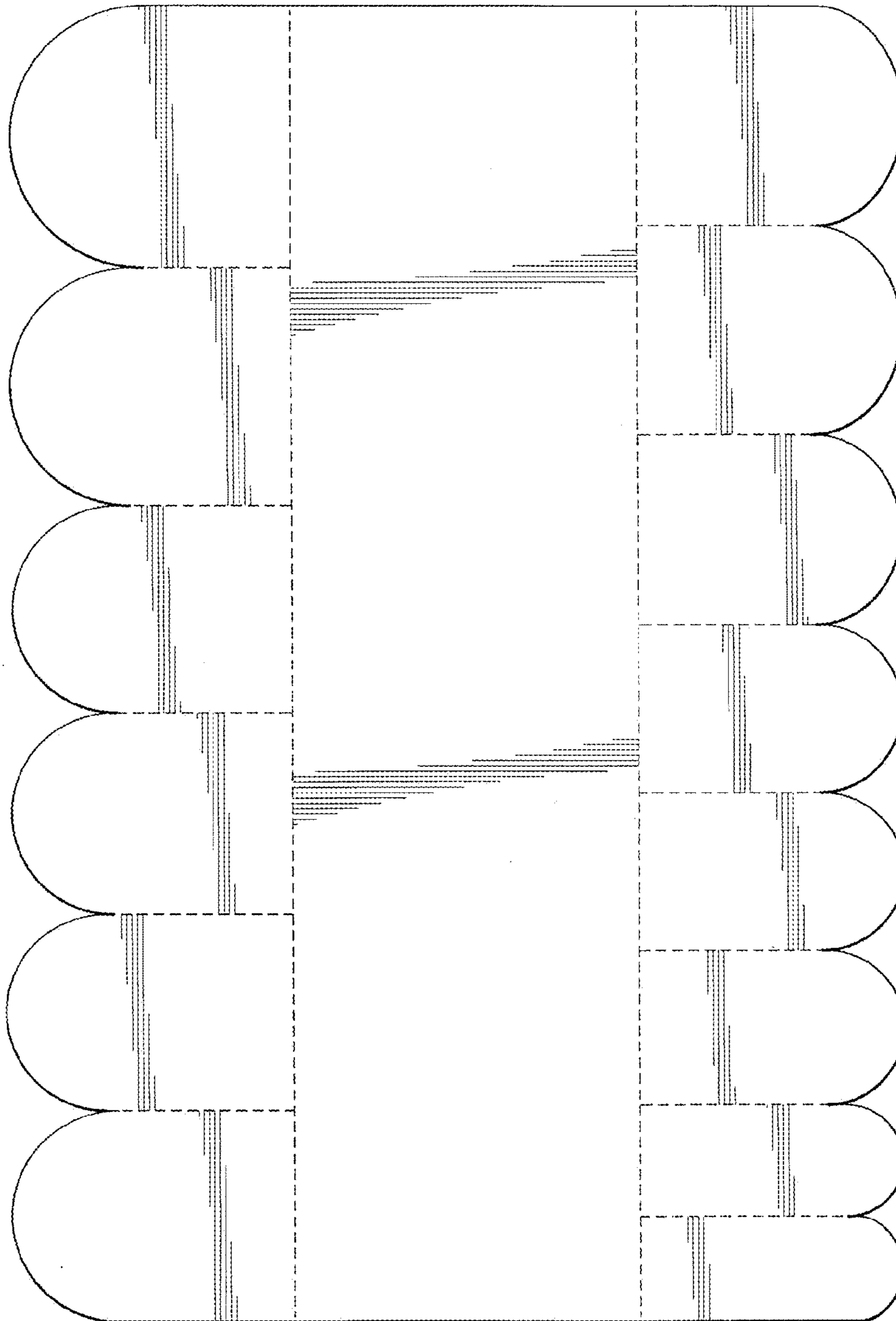

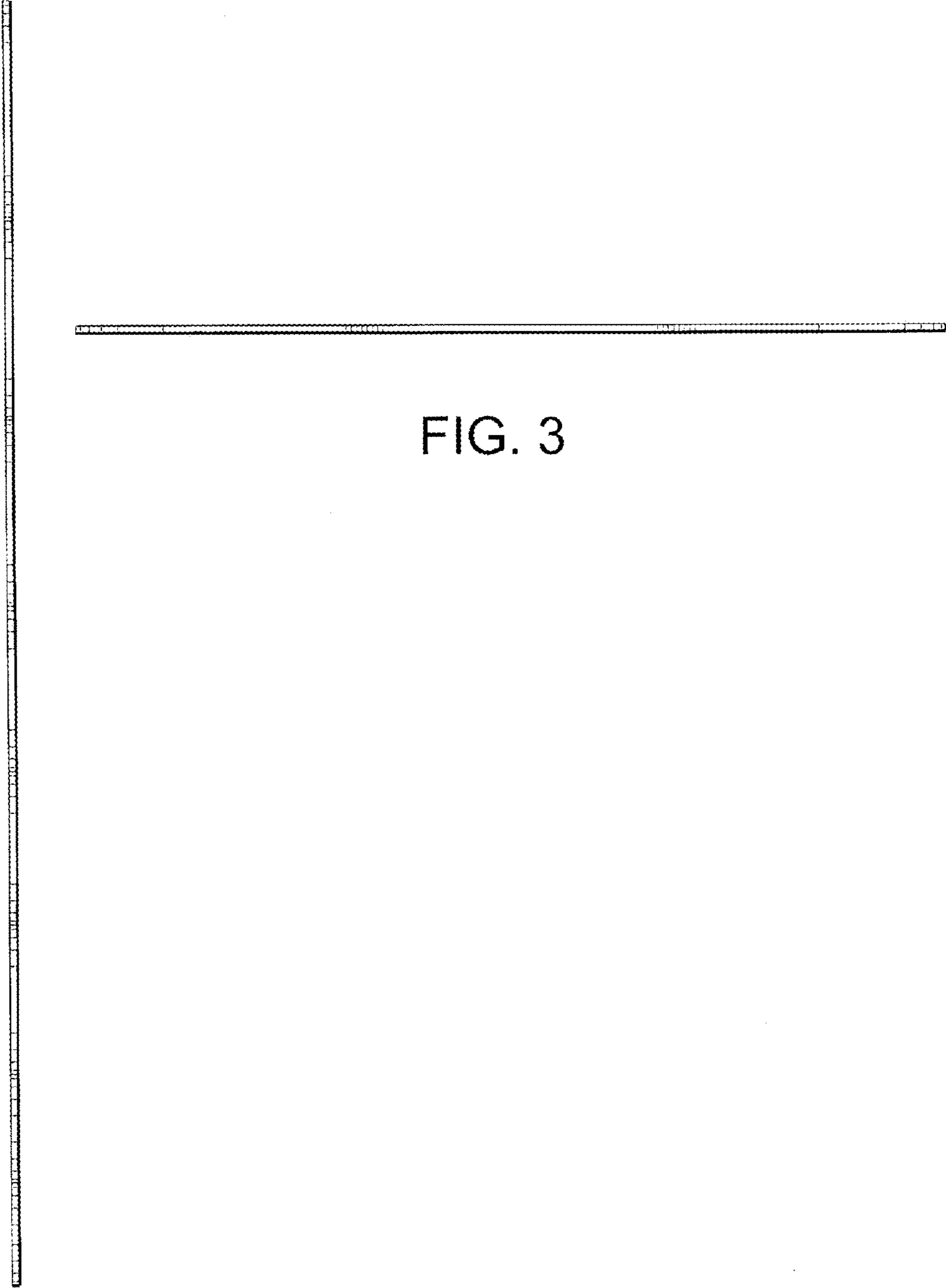
