DESCRIPTION

FIG. 1 is a front perspective view of the pet collar showing my new design, the pet collar being shown in a closed position; FIG. 2 is a front perspective view thereof, the pet collar being shown in a closed position;

FIG. 3 is a front elevational view thereof, shown in an opened condition;

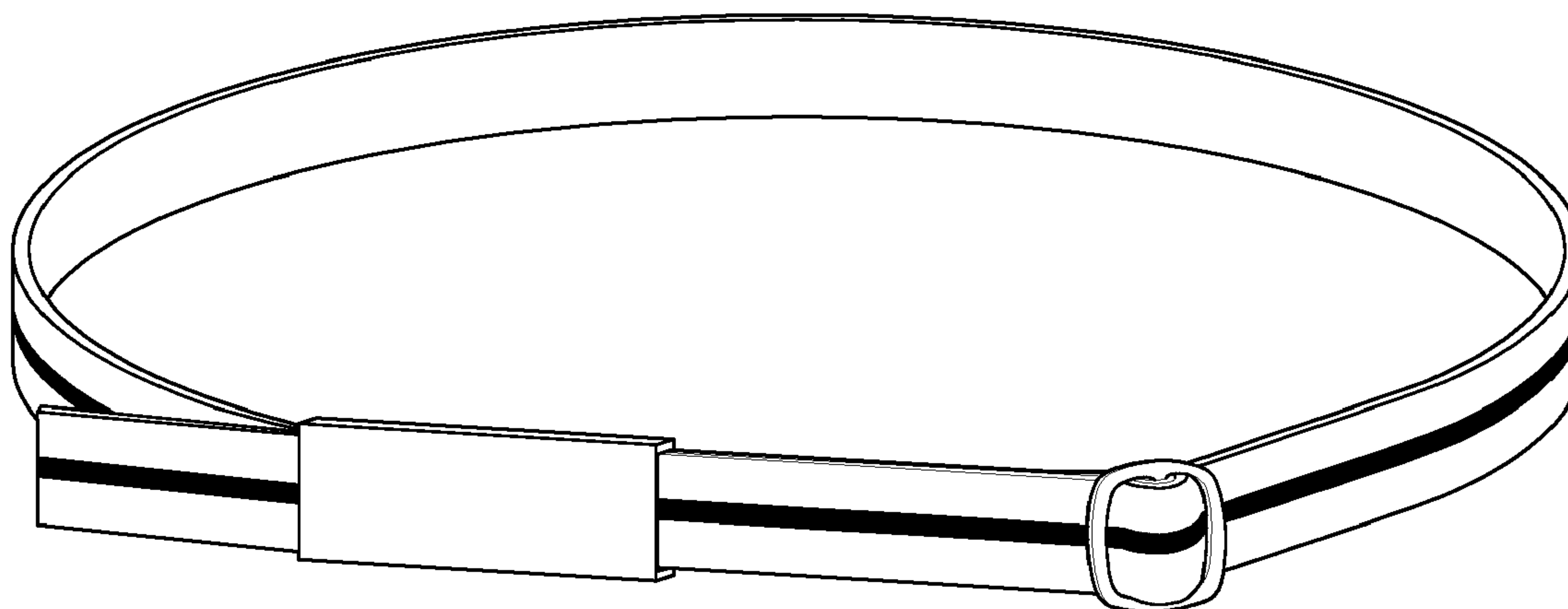
FIG. 4 is a rear elevational view of FIG. 3;

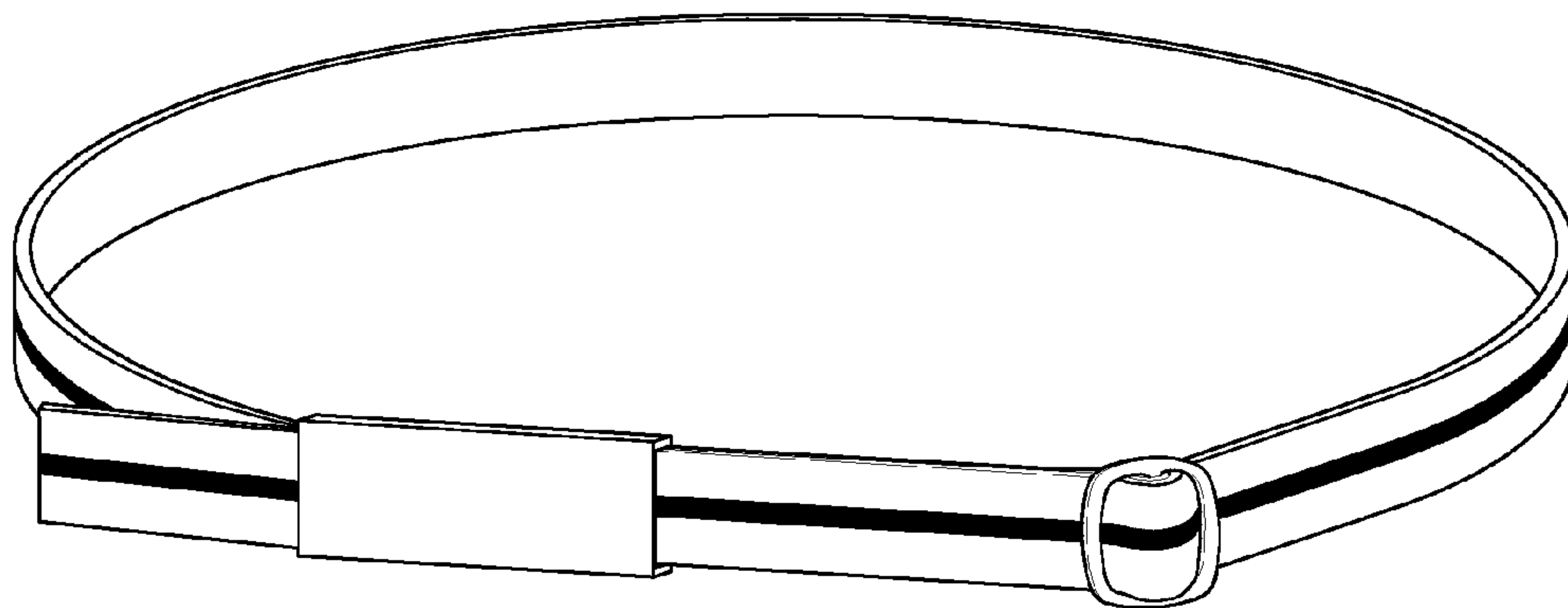

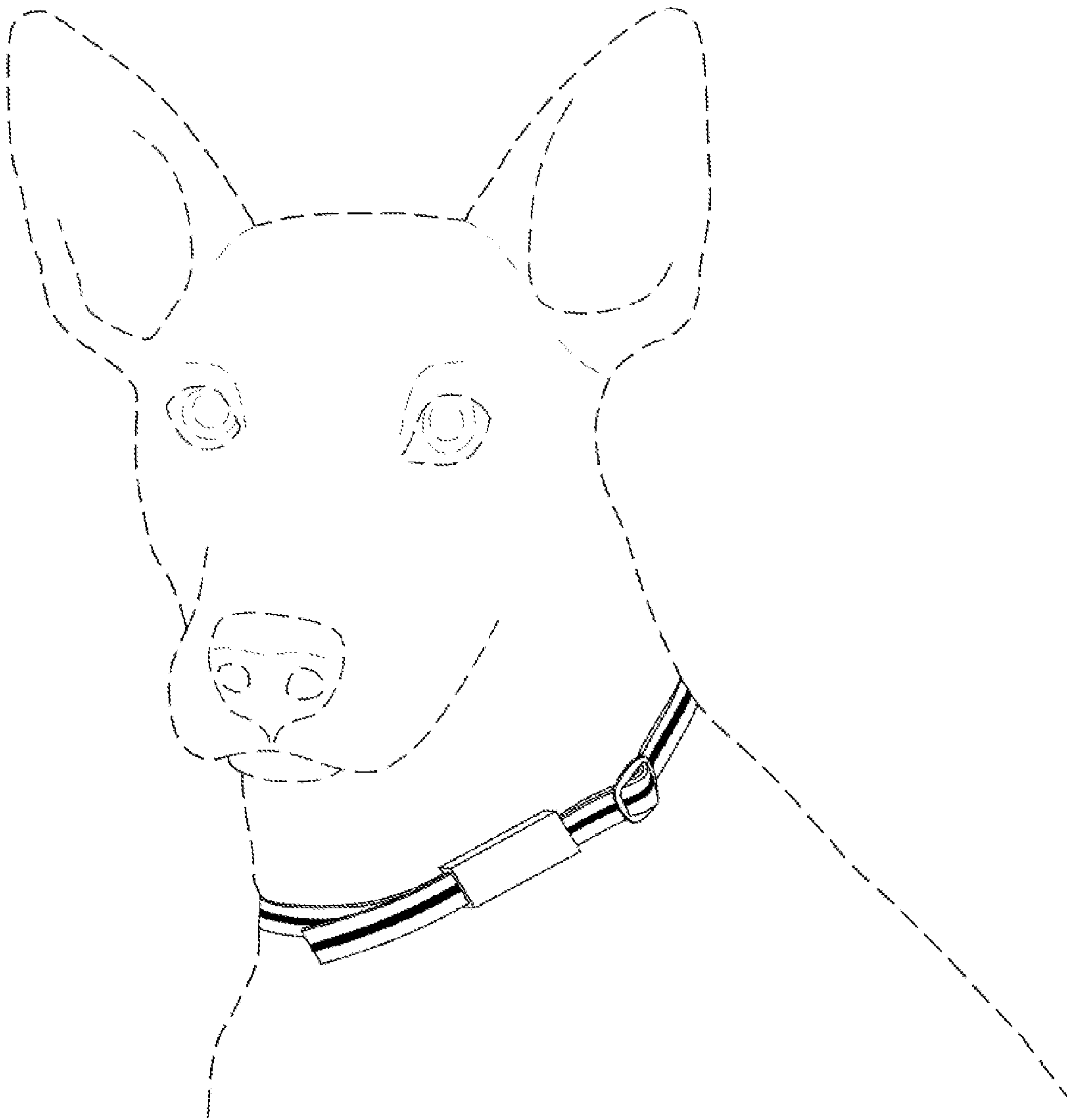

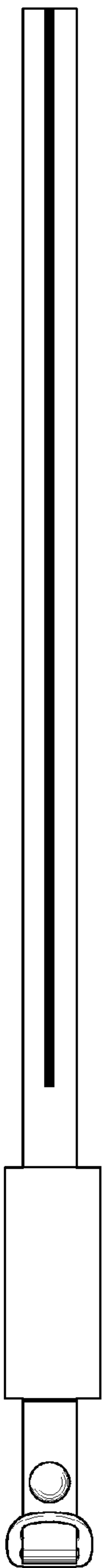

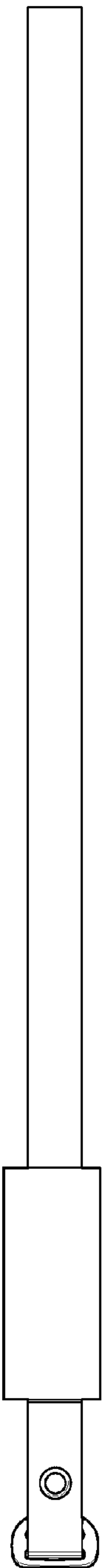

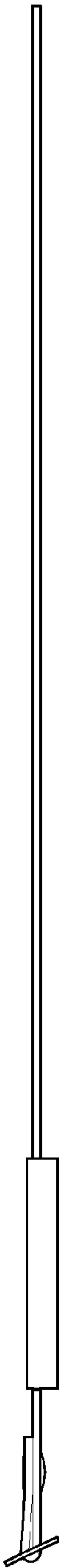

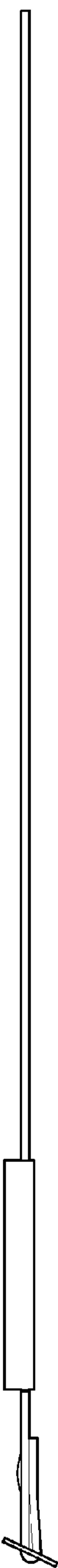
