The ornamental design for a multibasket, as shown and described.

DESCRIPTION

FIG. 1 is a front, side and top perspective view of a multibasket showing my new design with the middle handle in an extended position;
FIG. 2 is a is another perspective view thereof with the rear elongated handle in an extended position;
FIG. 3 is a front elevational view thereof; and
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a side elevational view thereof, the other side being the same in appearance;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

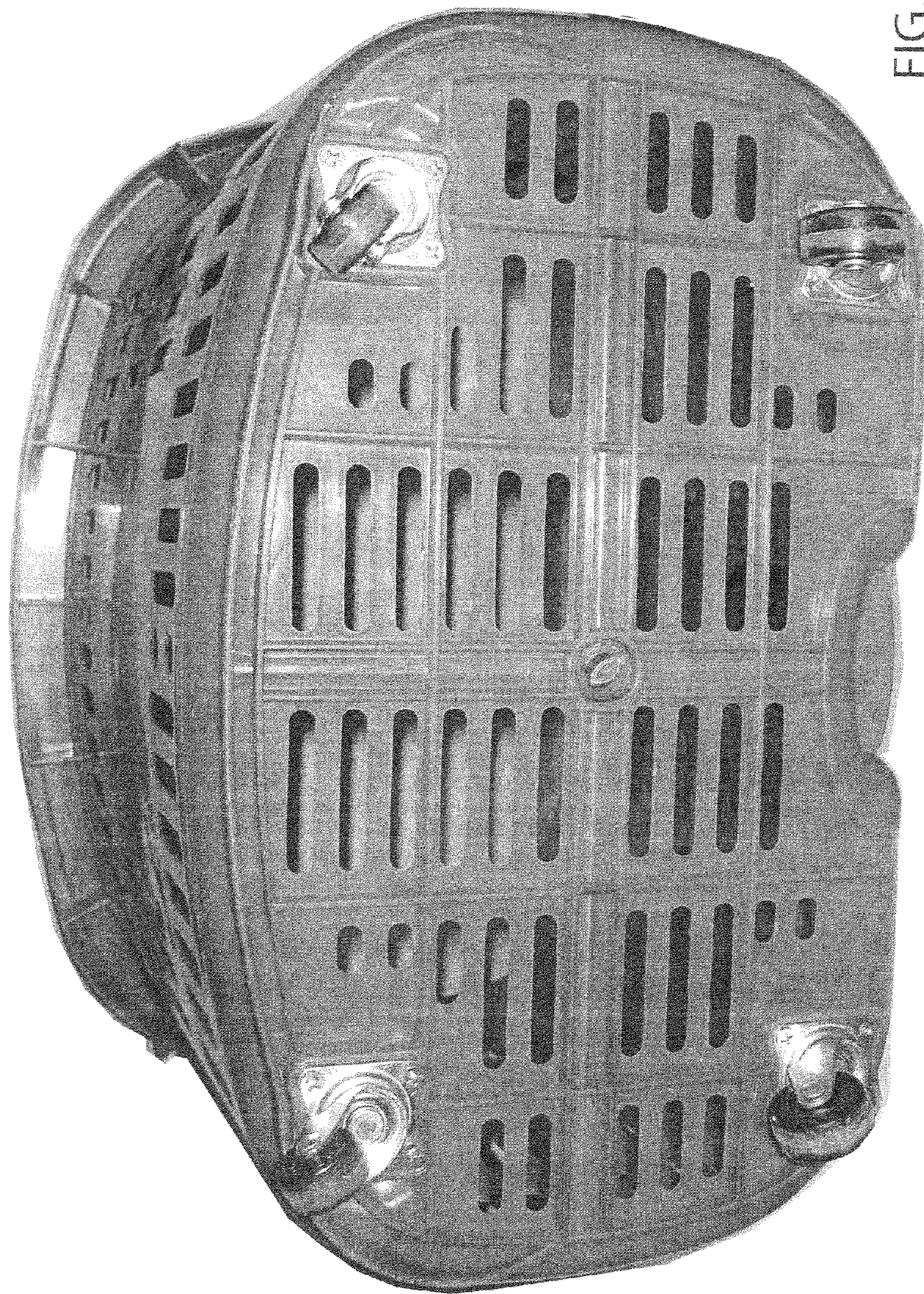
