FIG. 12 is a bottom plan view of the claimed design of FIG. 9;

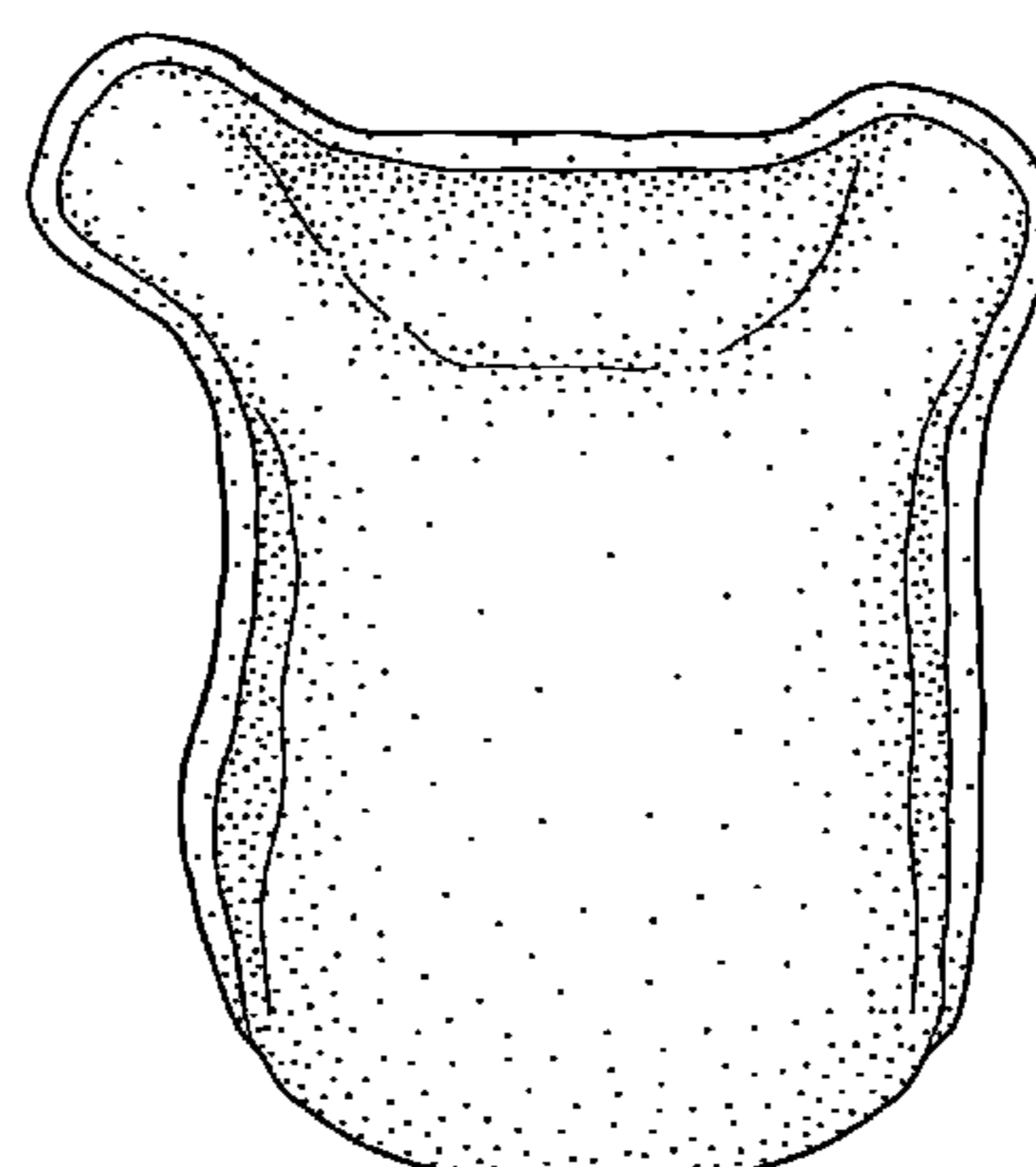
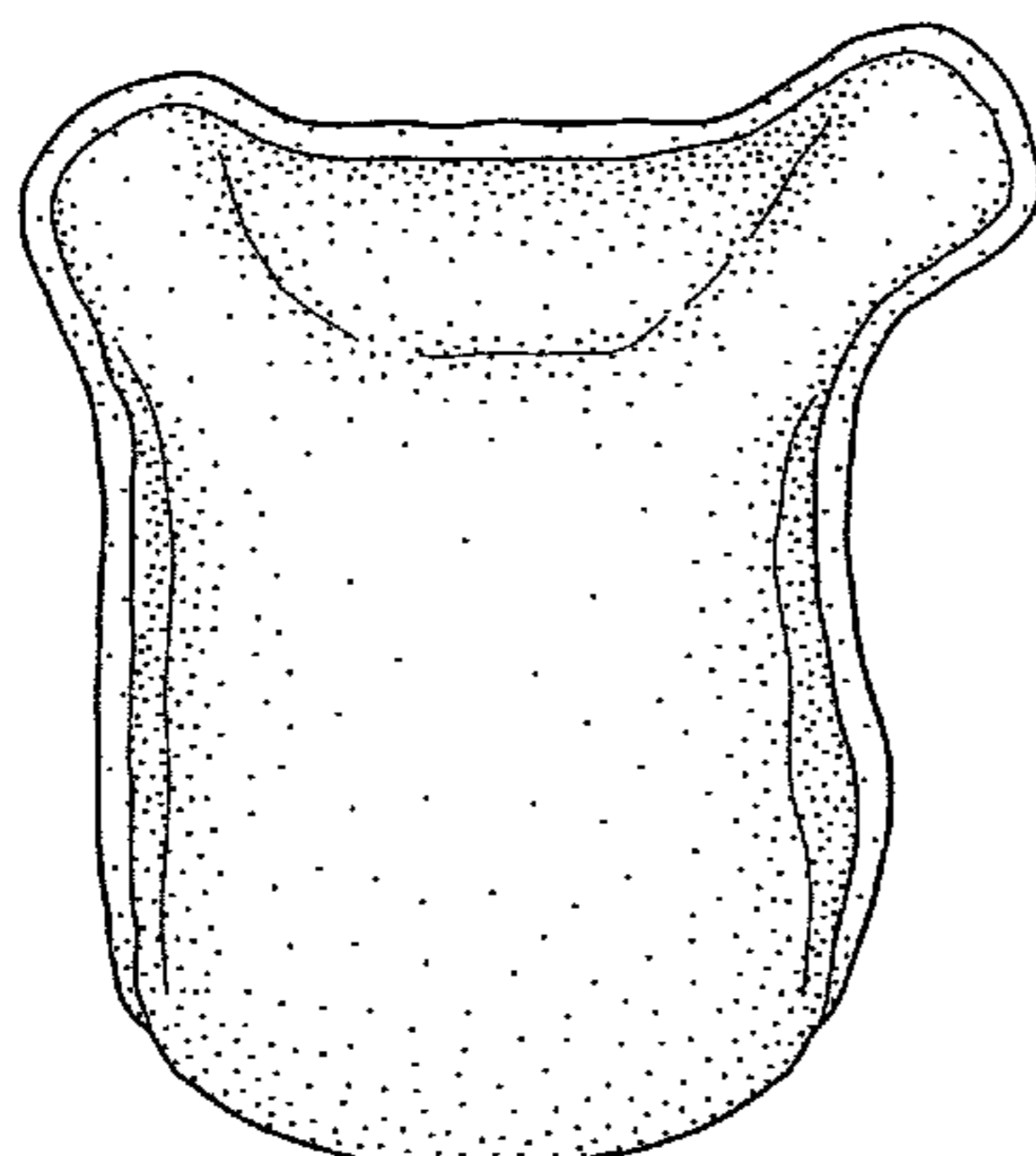
FIG. 13 is a right side elevational view of the claimed design of FIG. 9;

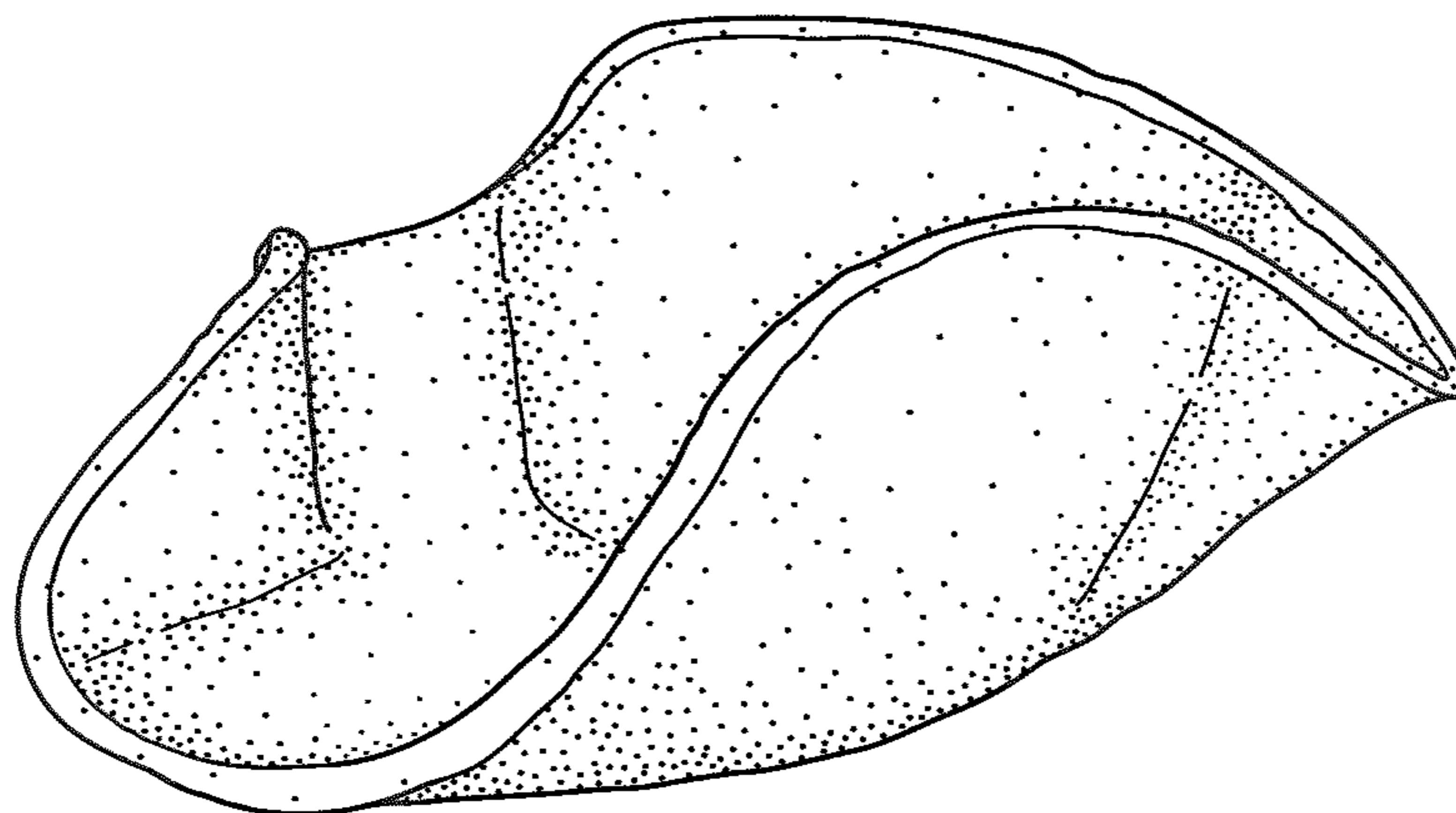

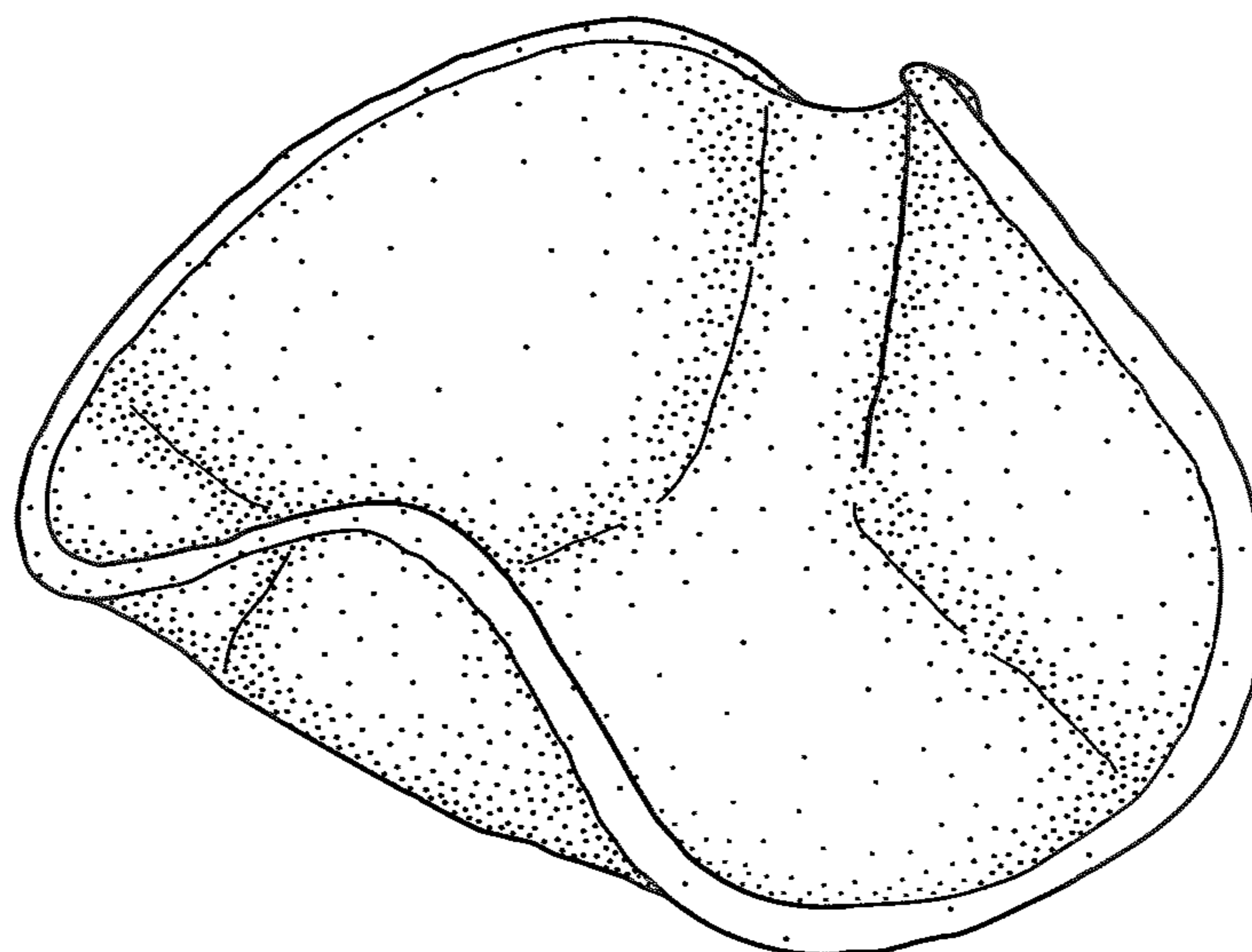

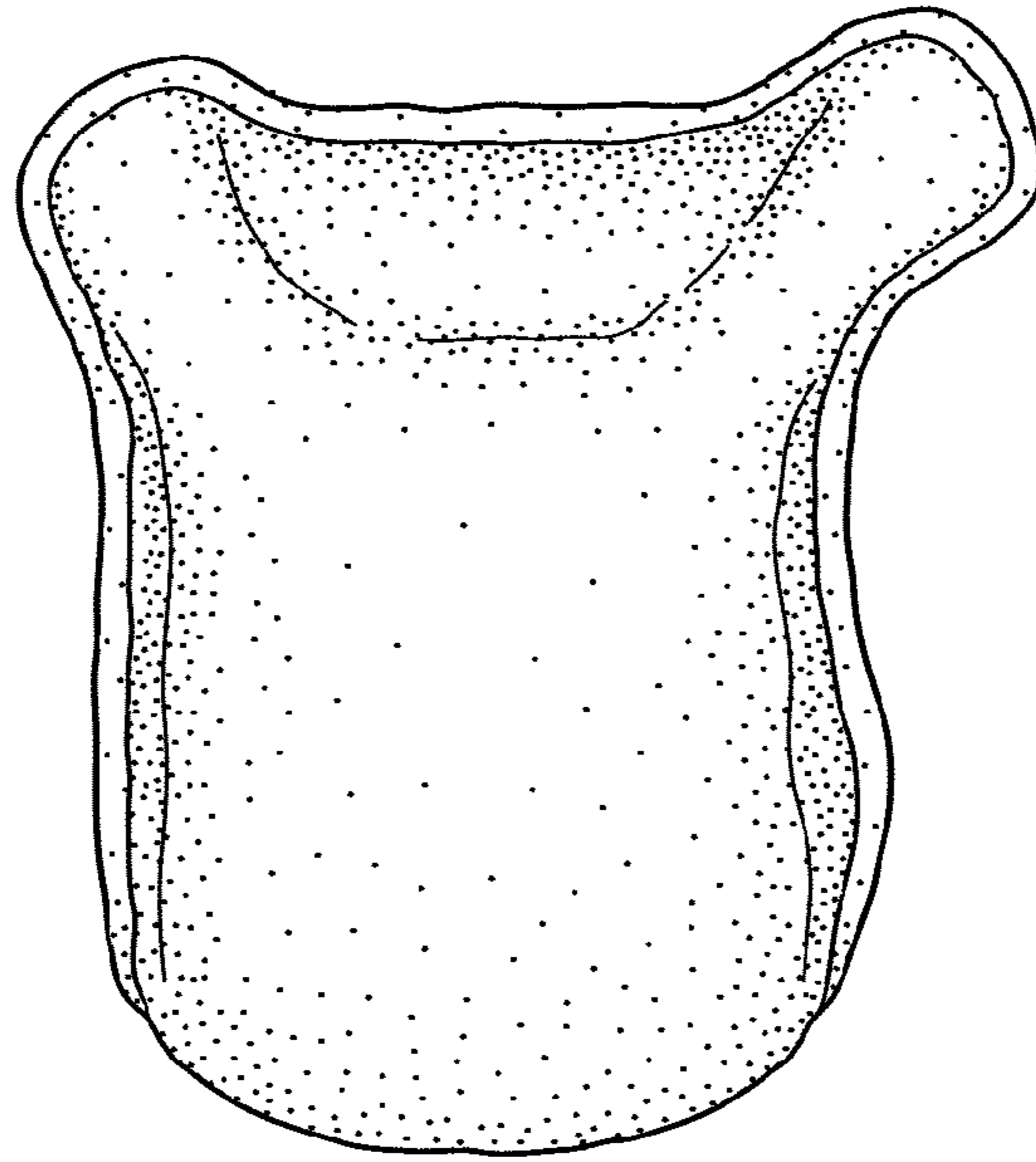

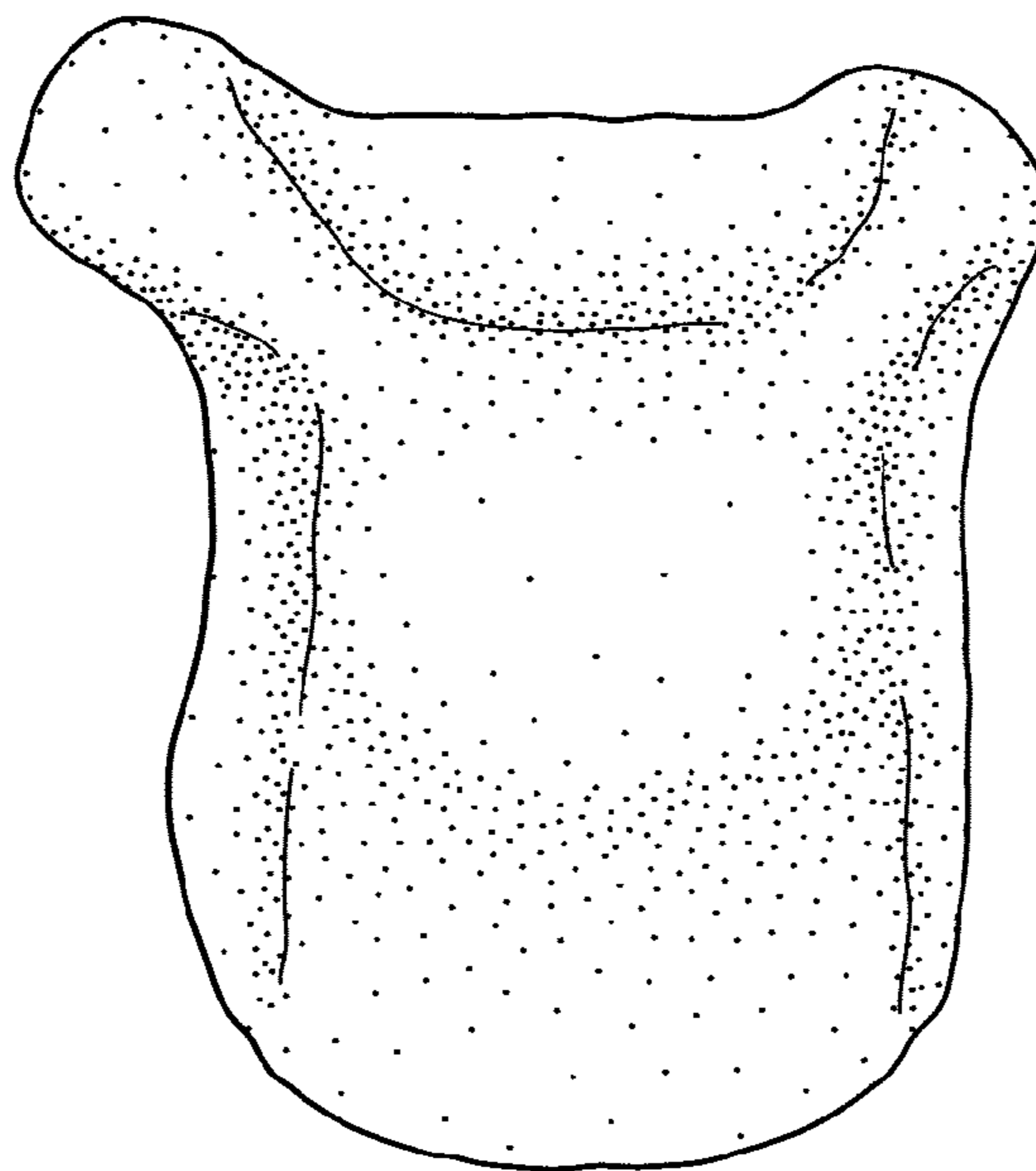

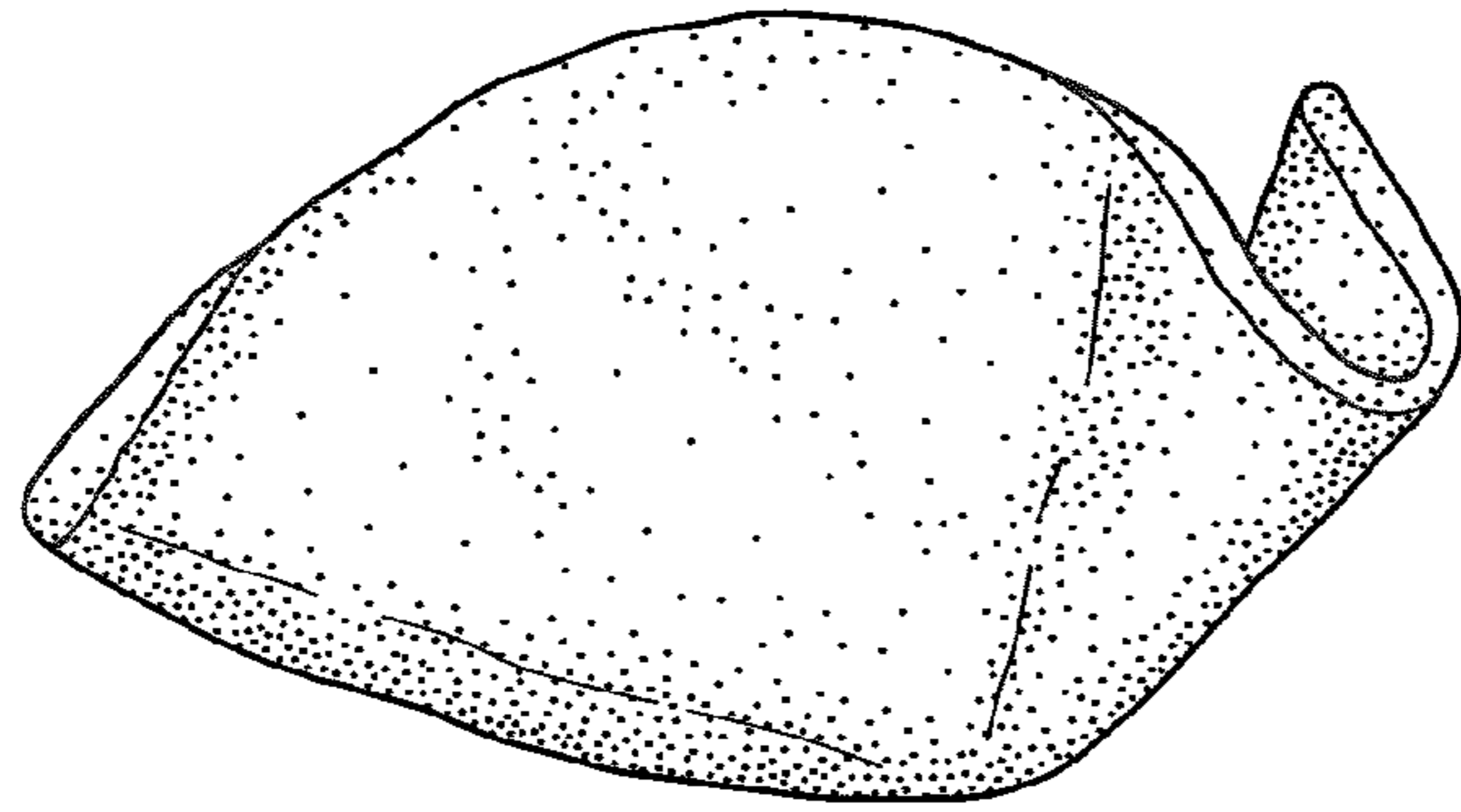

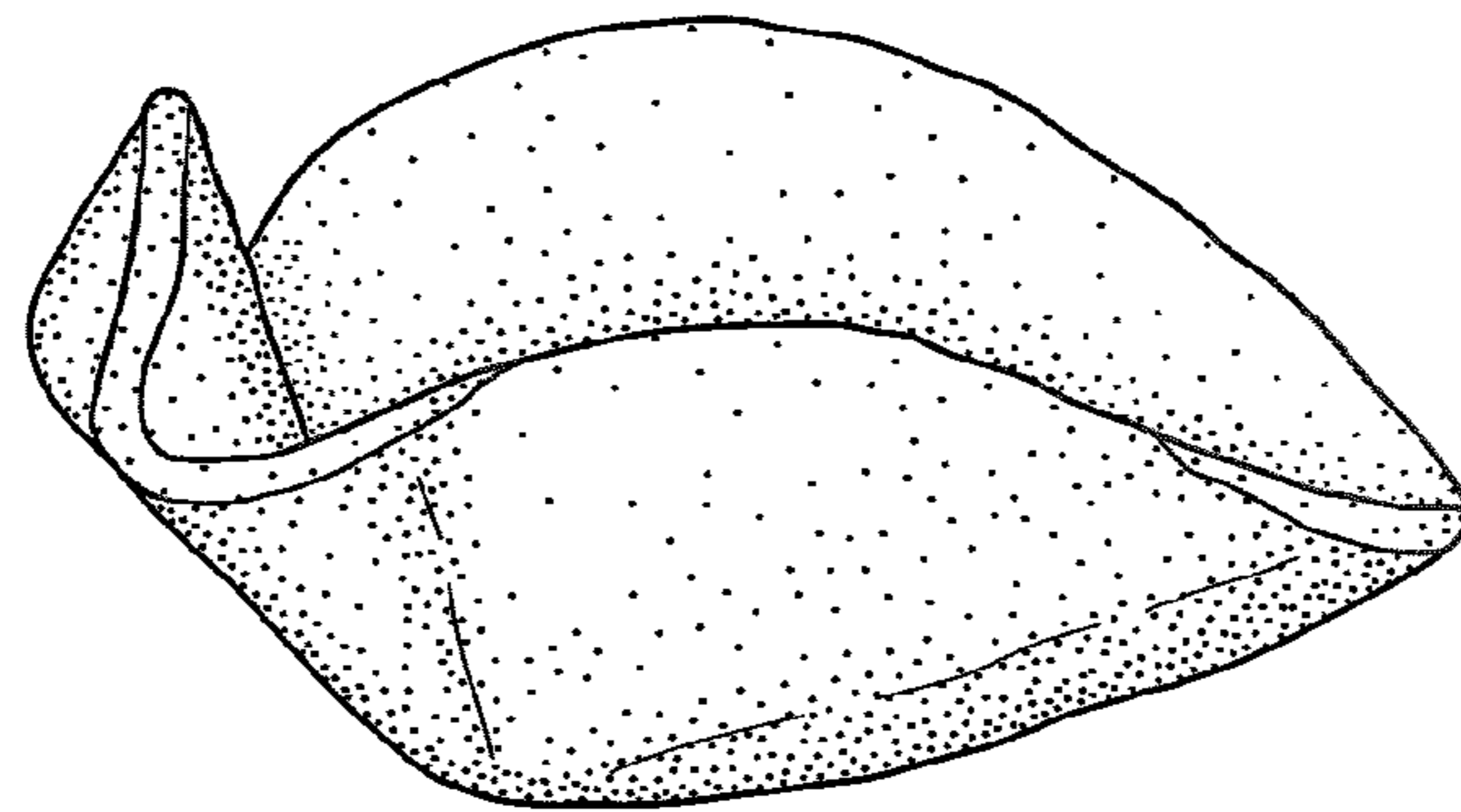

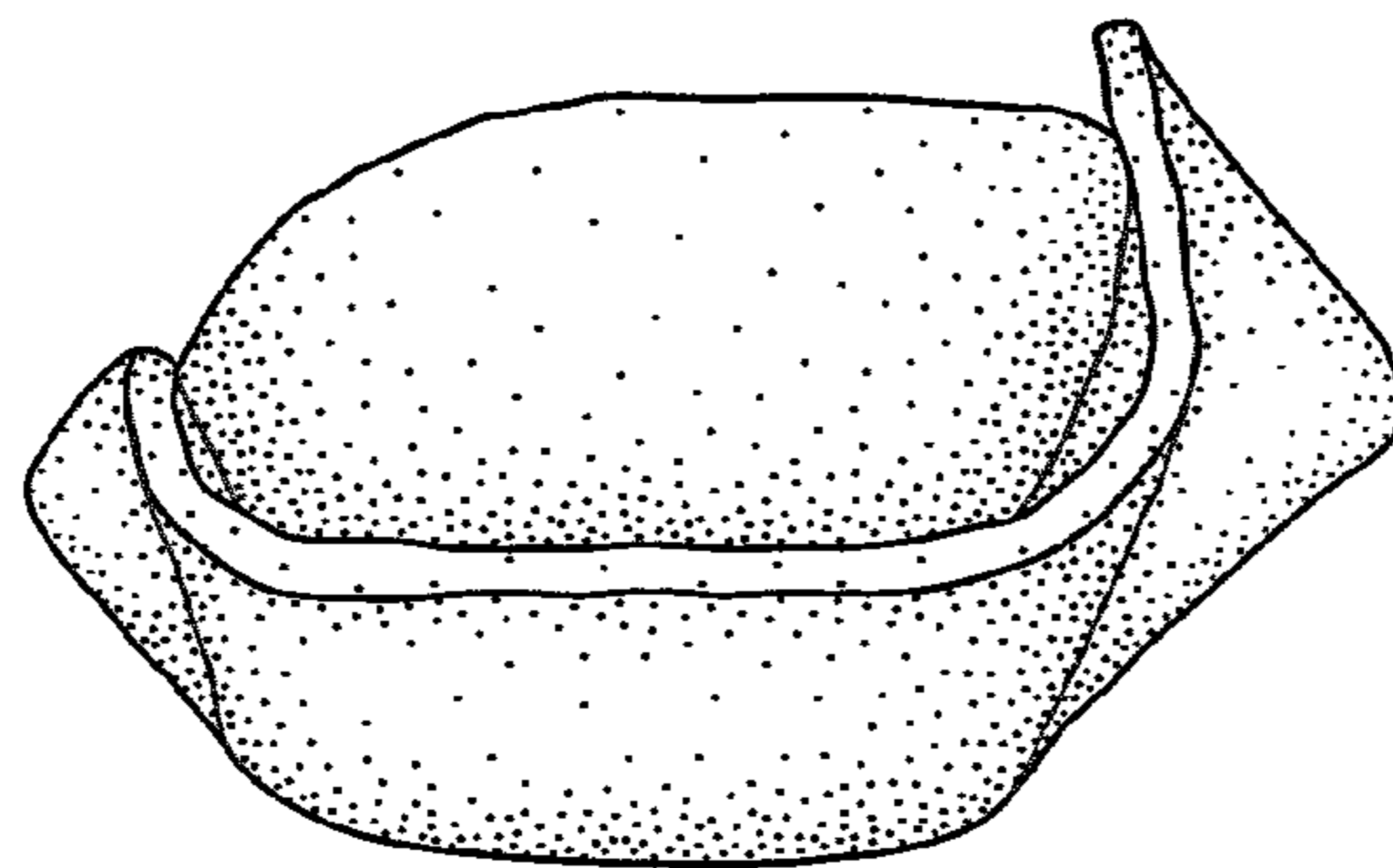

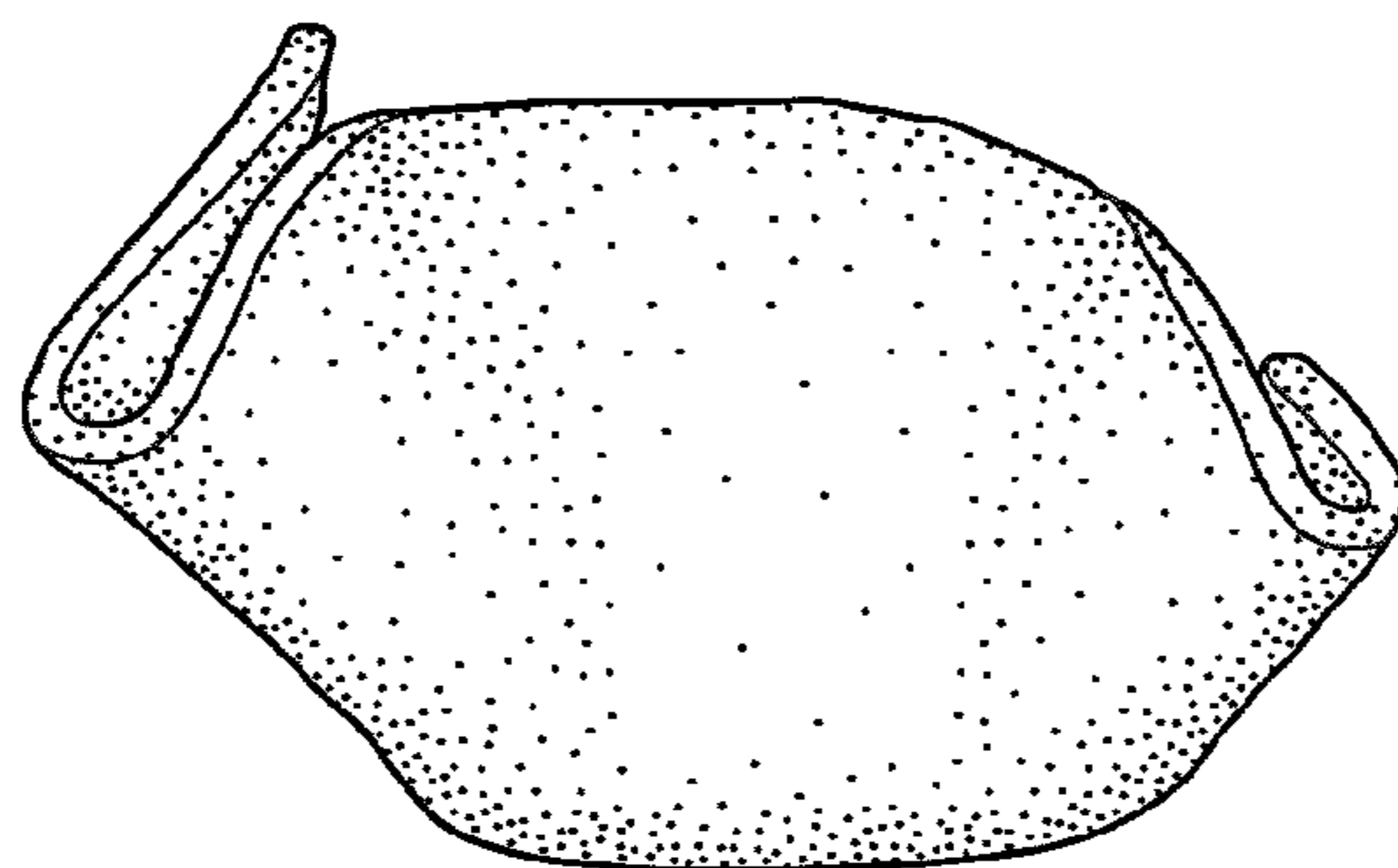

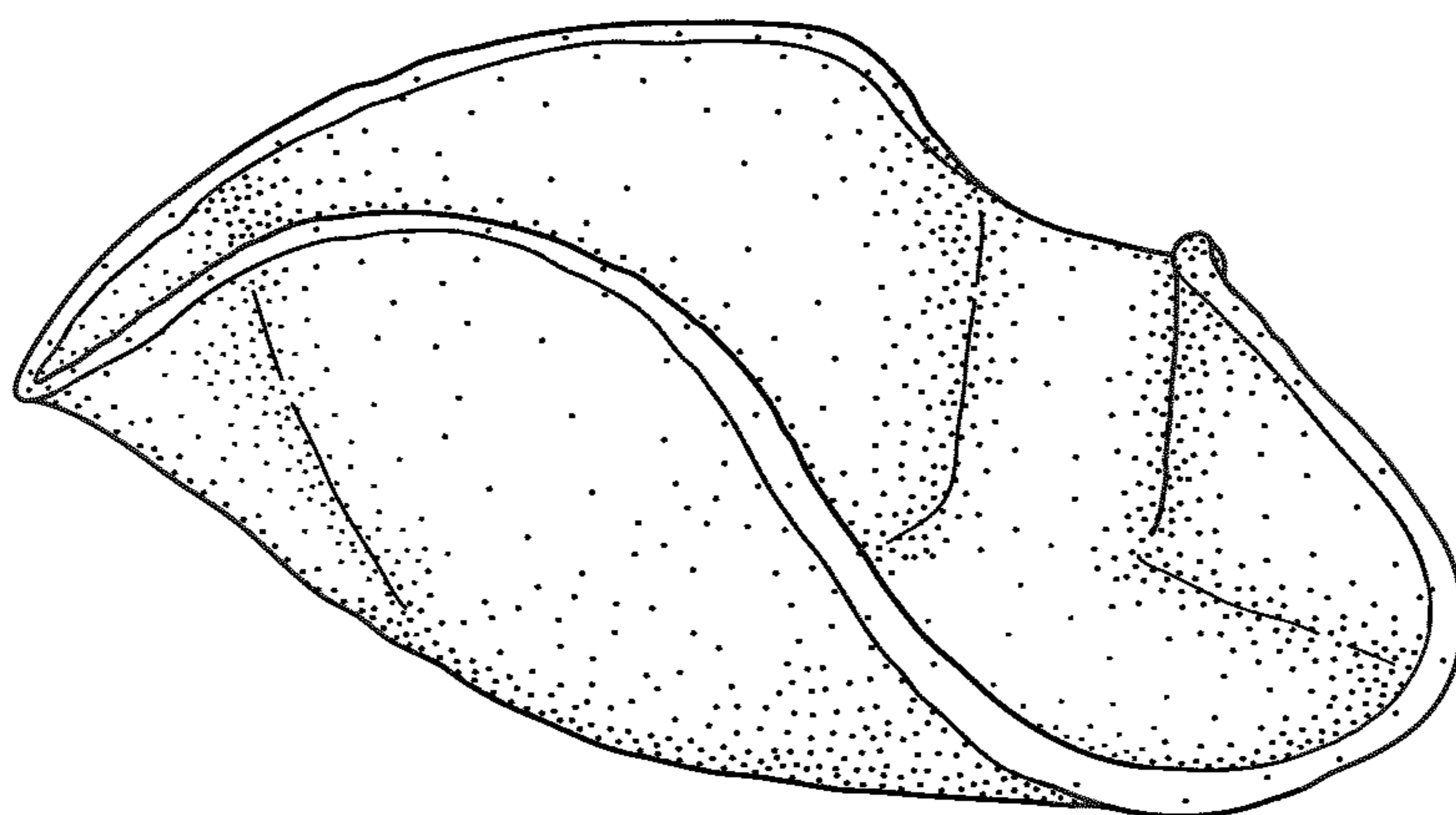

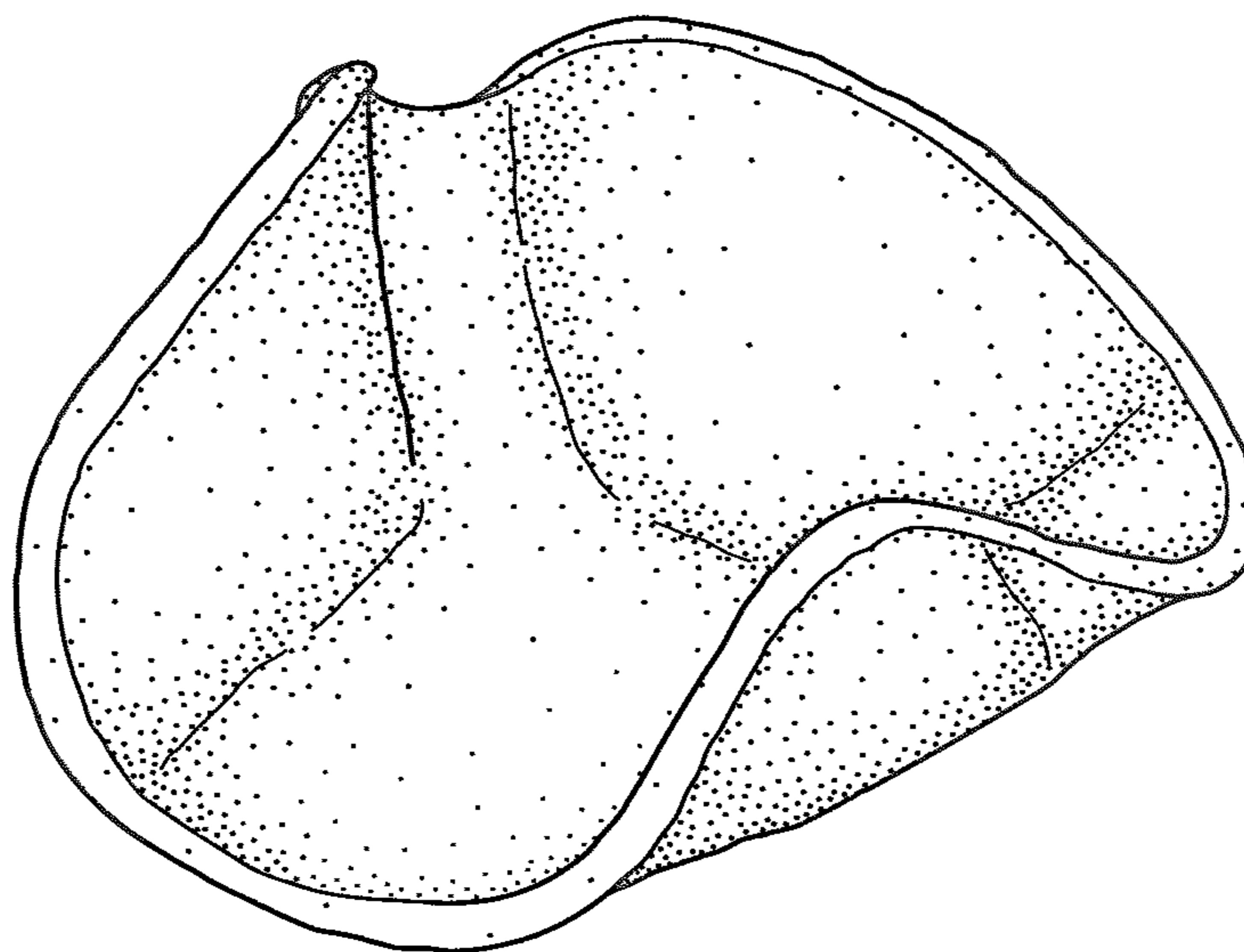

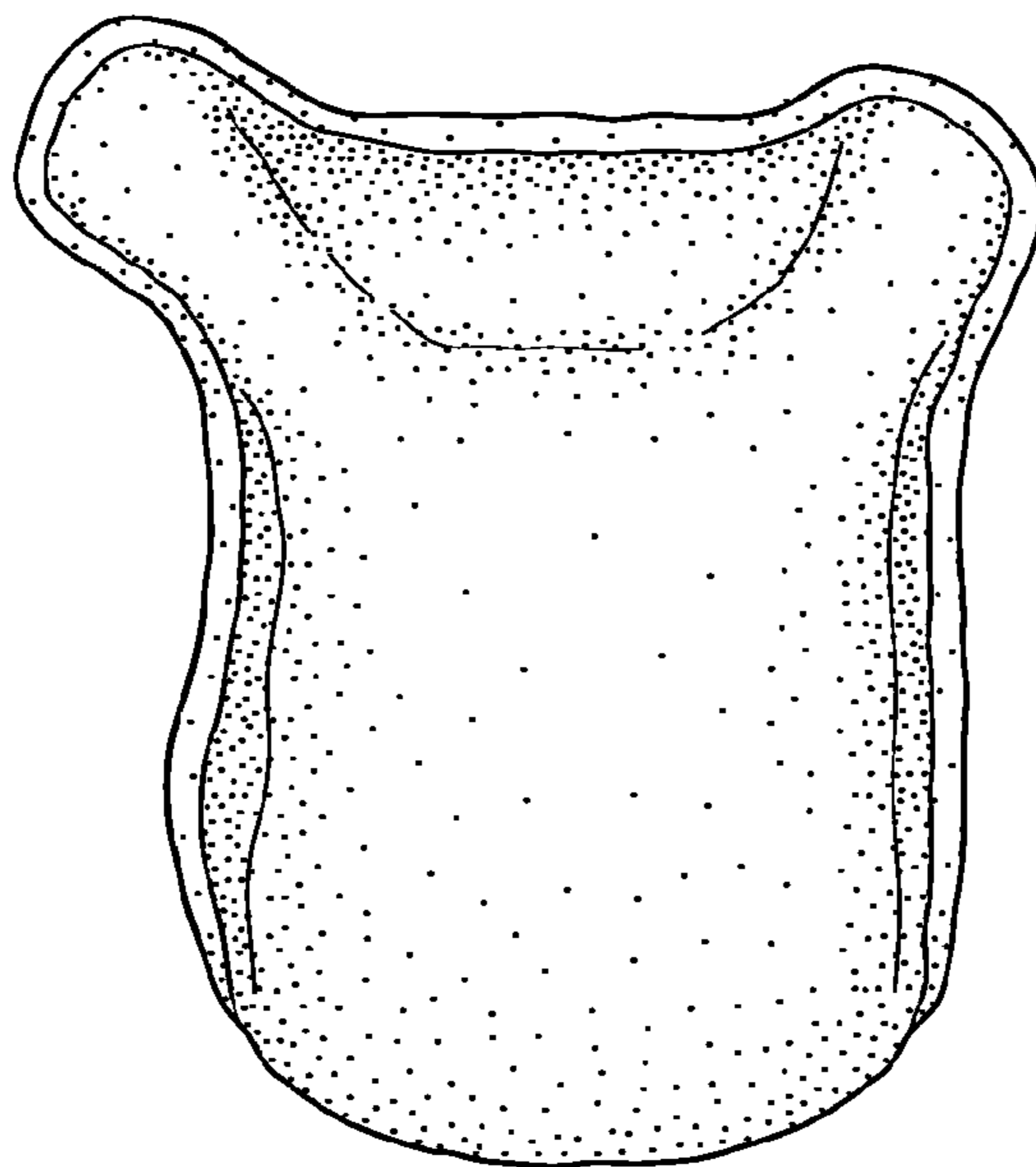

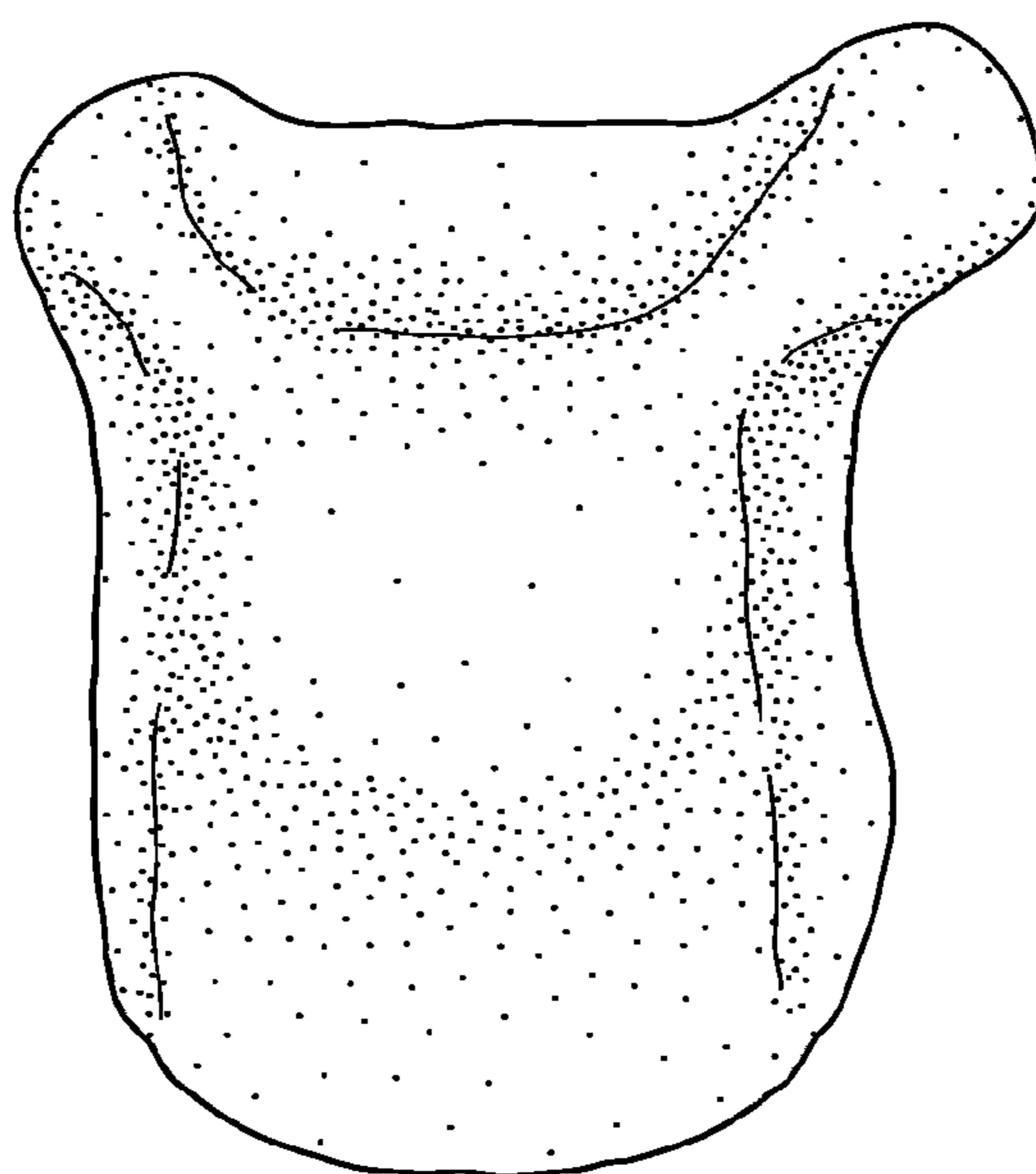

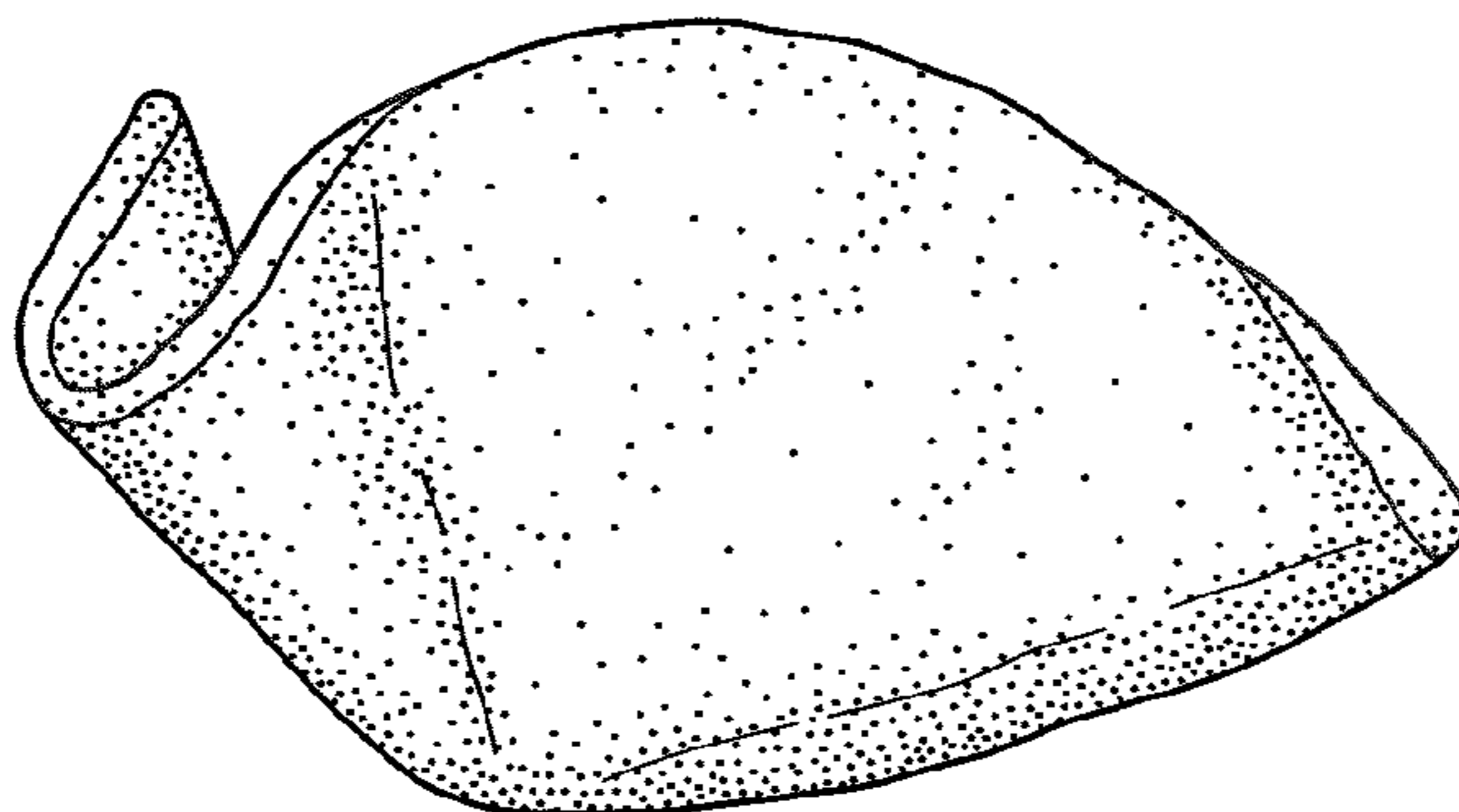

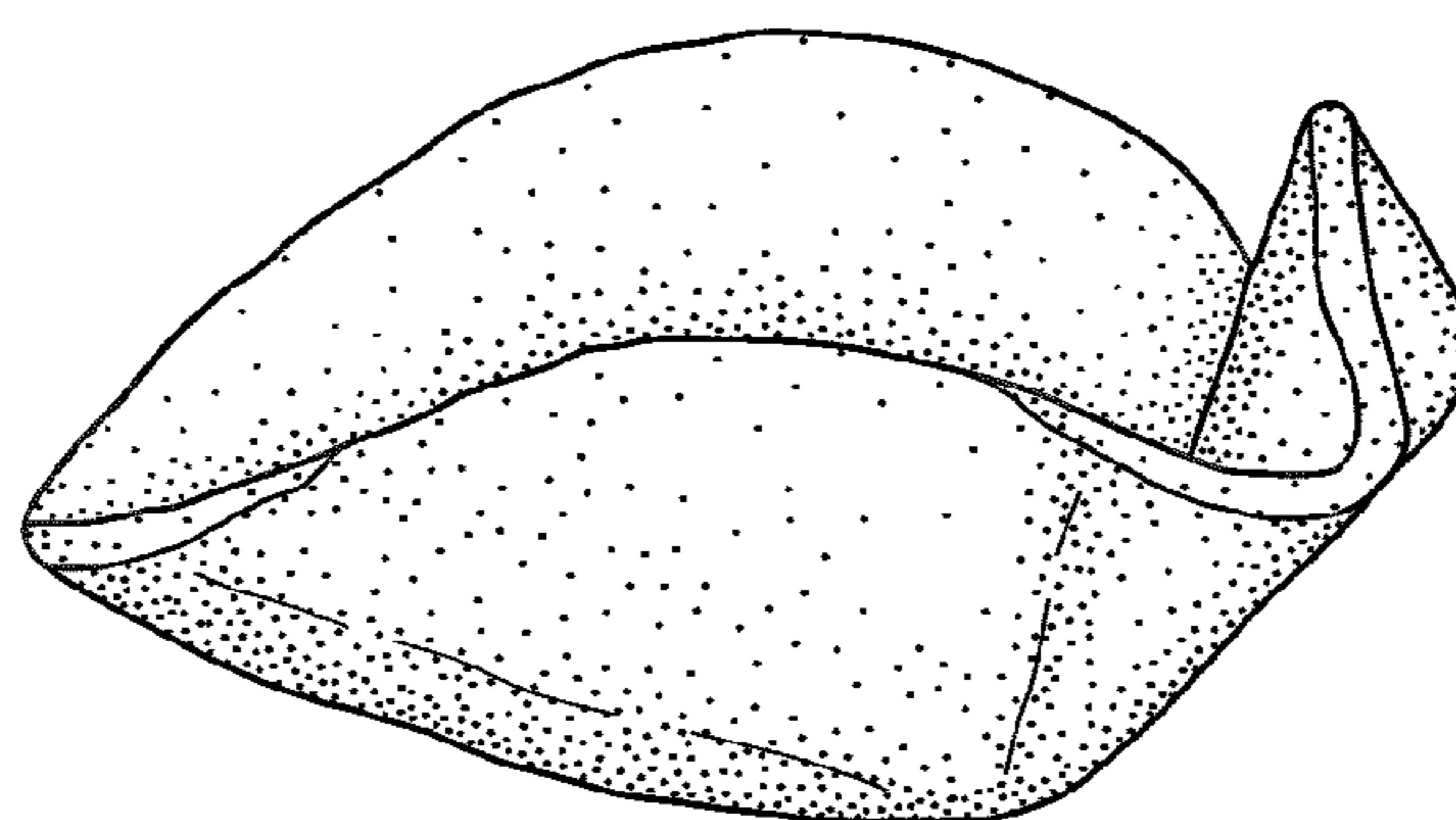

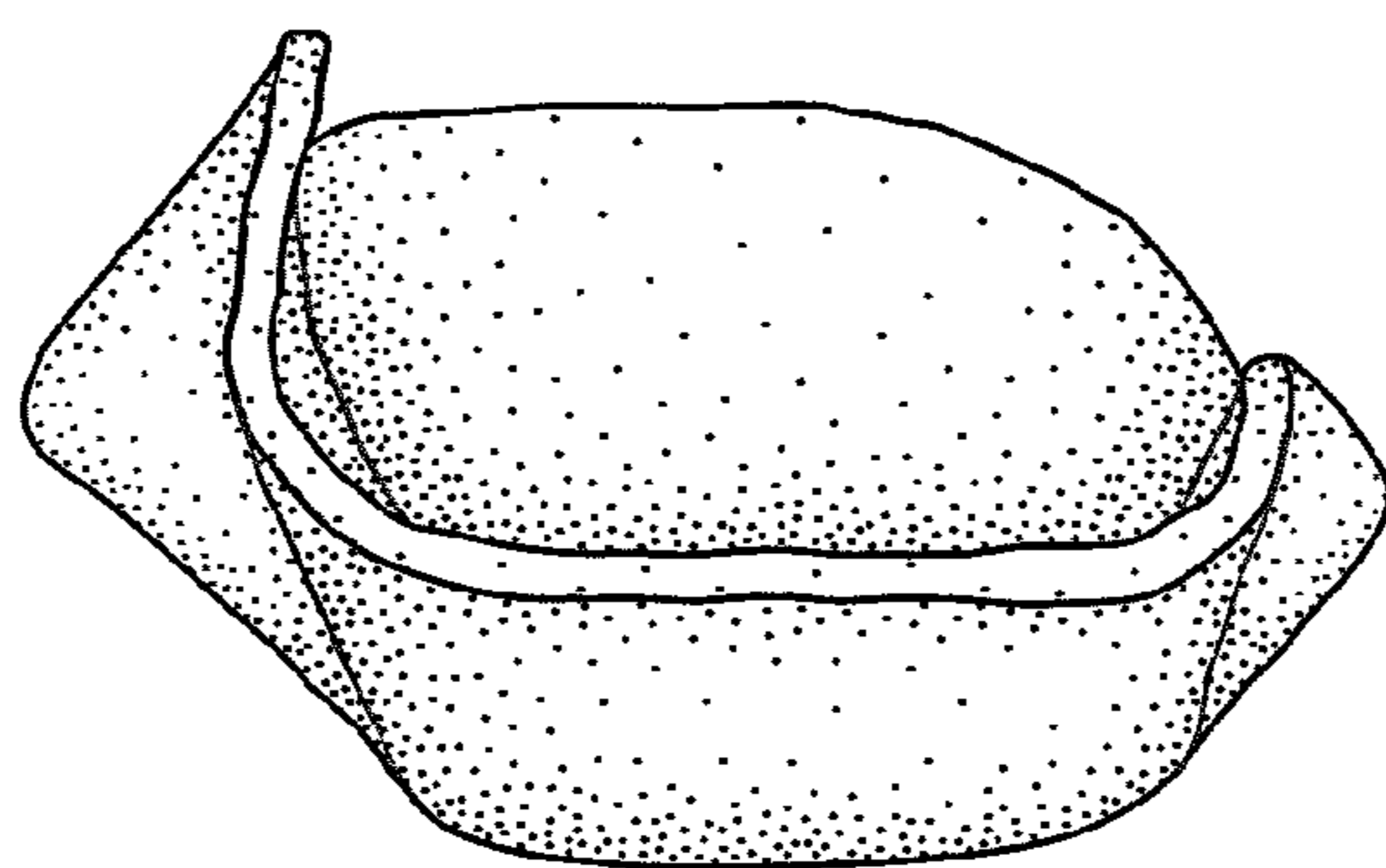

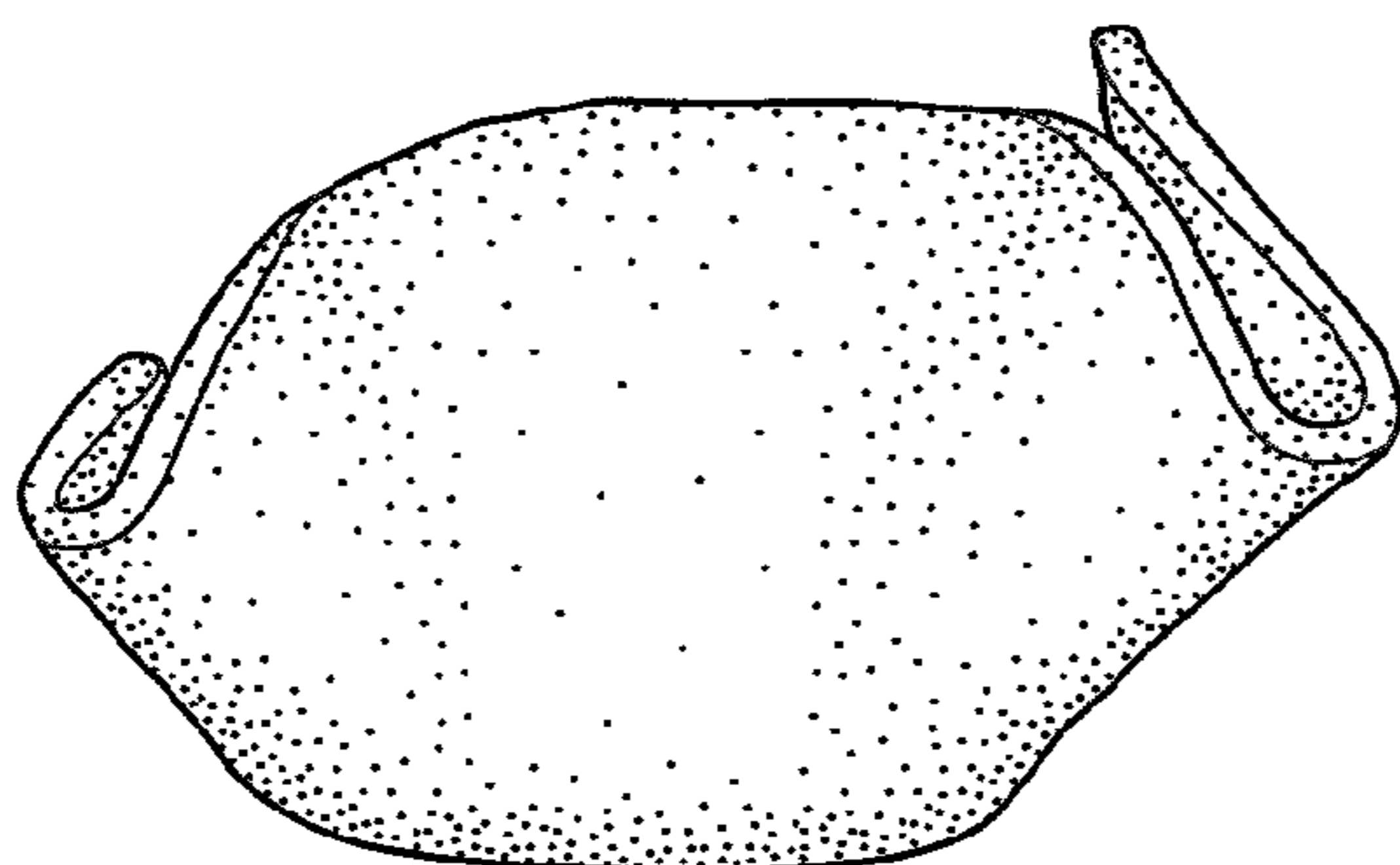
