(57) **CLAIM**

The ornamental design for a striped necktie, as shown and described herein.

**DESCRIPTION**

FIG. 1 is a perspective view of the striped necktie in an untied configuration.

FIG. 2 is a first side view of the striped necktie.

FIG. 3 is a front view of the striped necktie.

FIG. 4 is a second side view of the striped necktie.

FIG. 5 is a back view of the striped necktie.

FIG. 6 is a first end view of the striped necktie.

FIG. 7 is a second end view of the striped necktie; and,

FIG. 8 is an enlarged front view of the striped necktie of FIG. 1 in a tied configuration around a person's neck and worn in conjunction with a dress shirt.

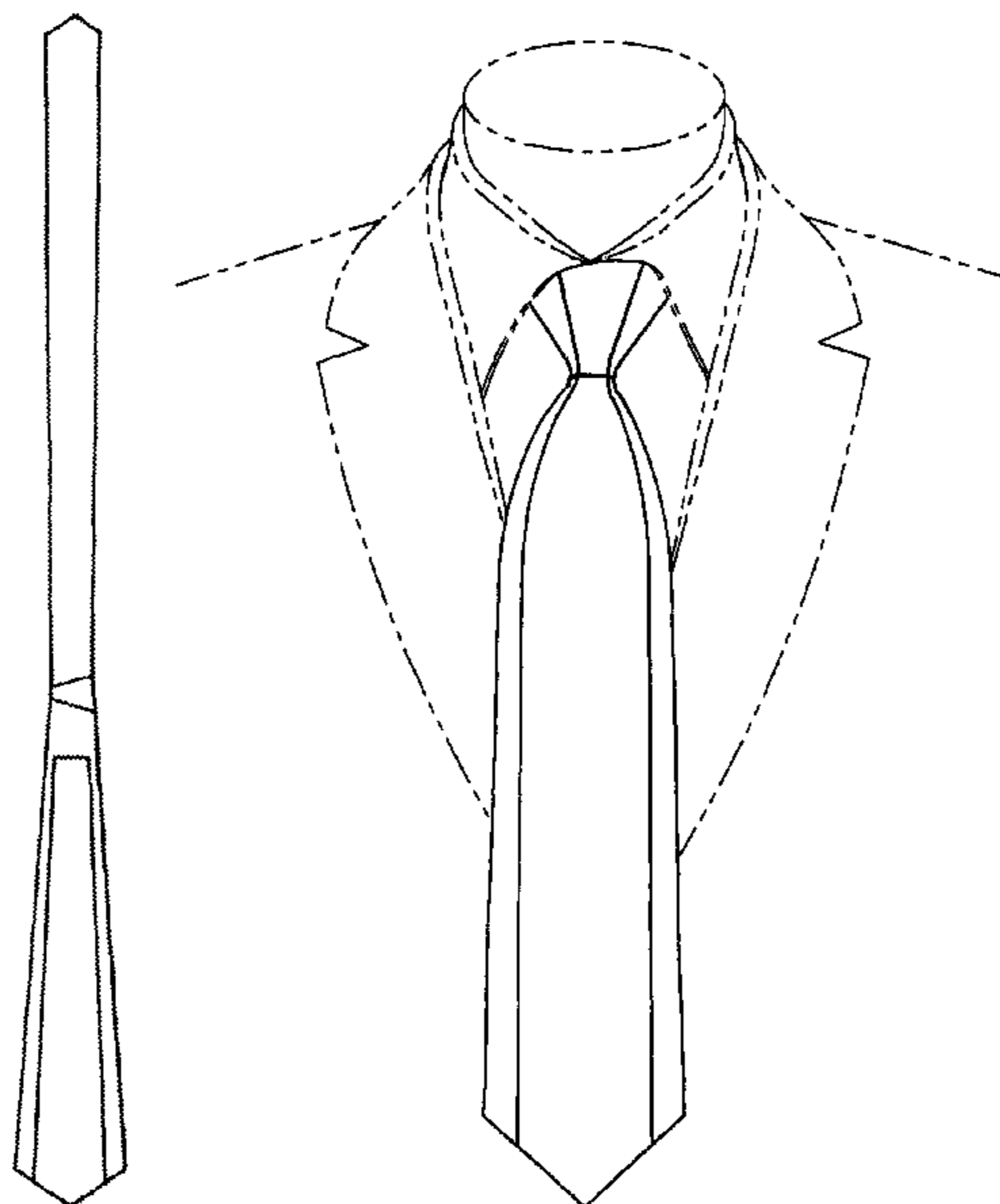

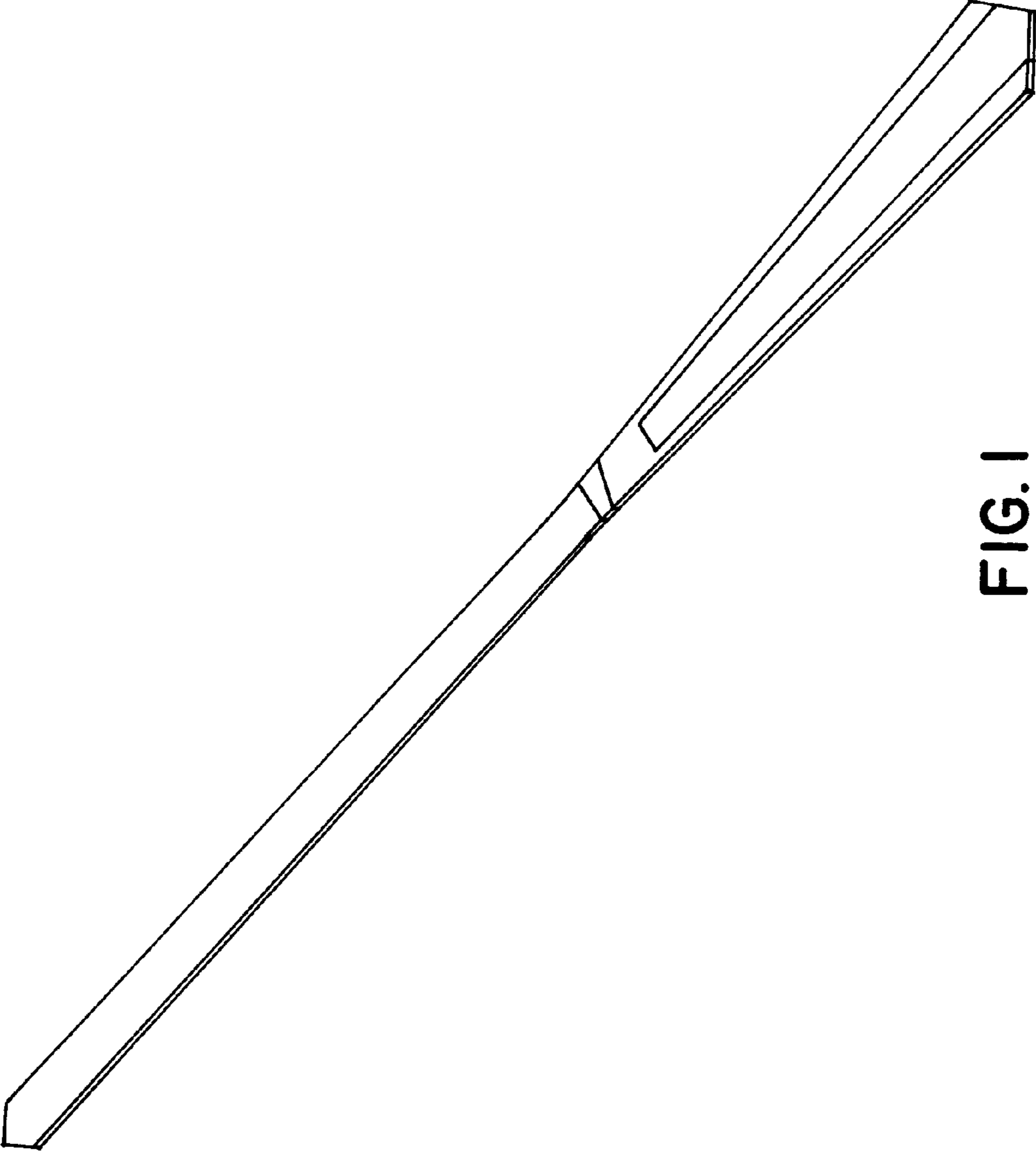

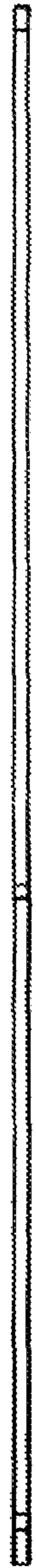

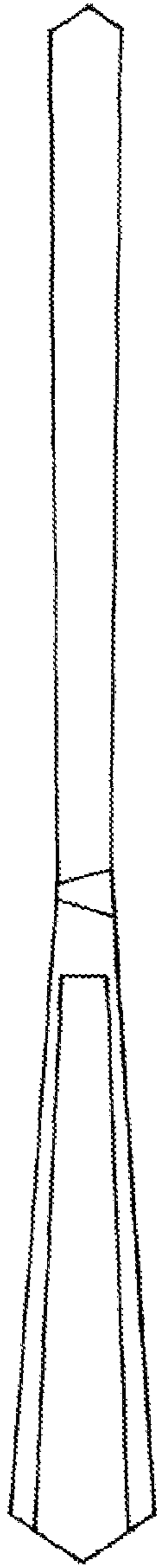

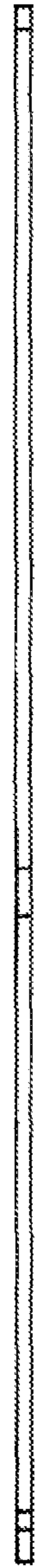

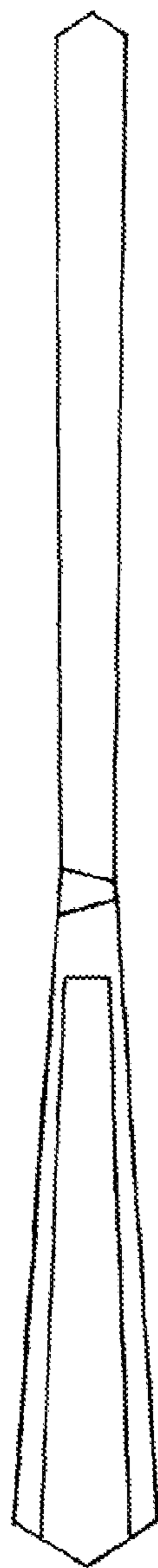

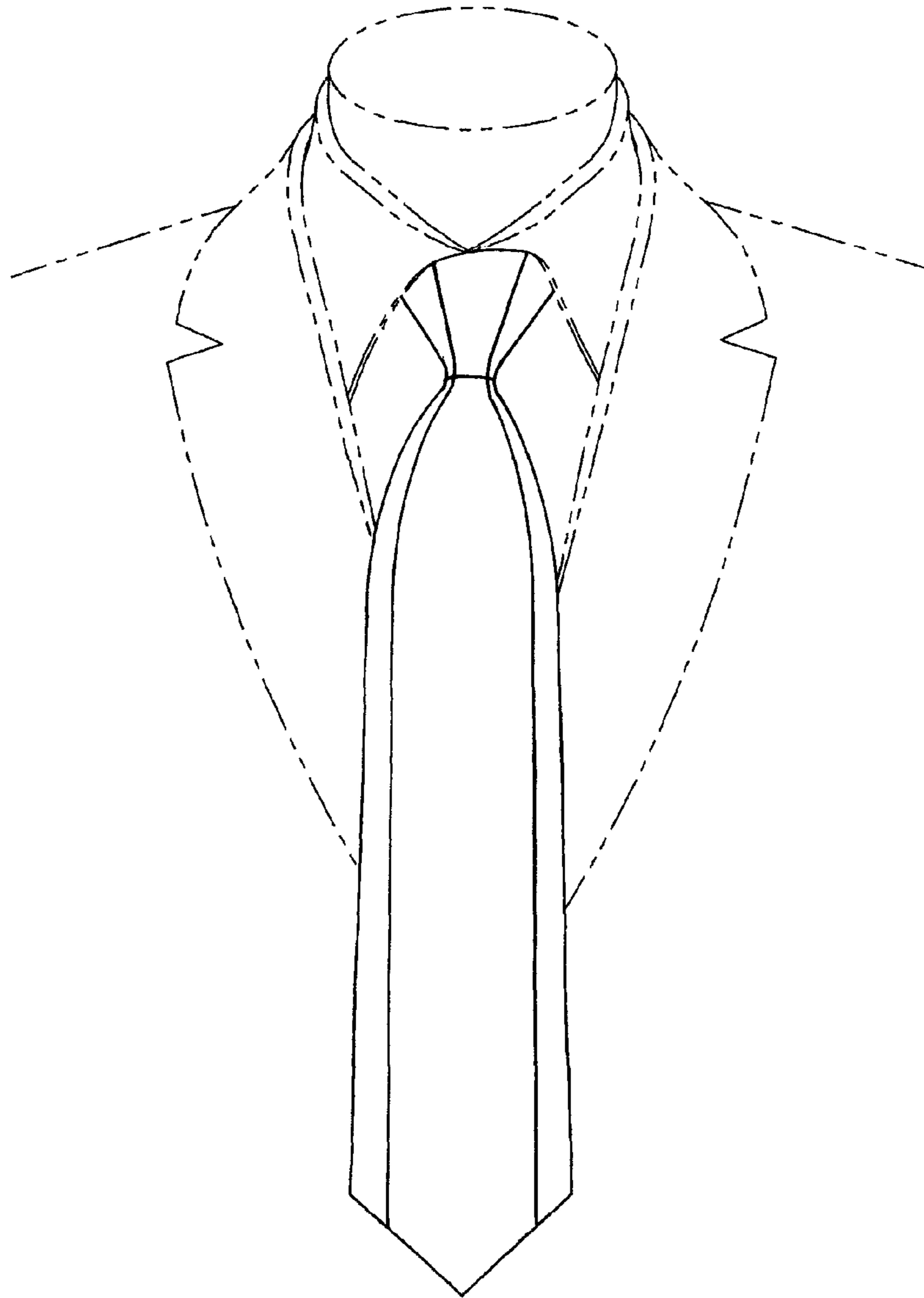
