**DESCRIPTION**

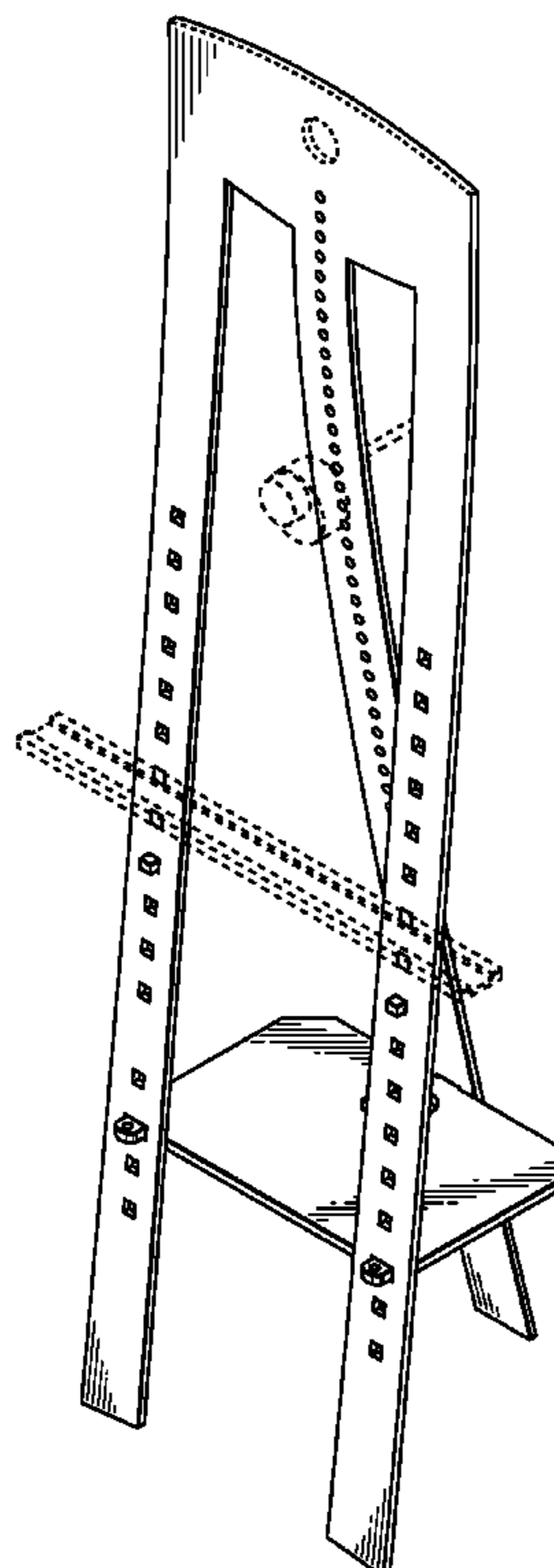
FIG. 1 is a perspective top view of the easel comprising a new, original and ornamental design. In all drawings, the elements shown by dashed lines are not claimed;

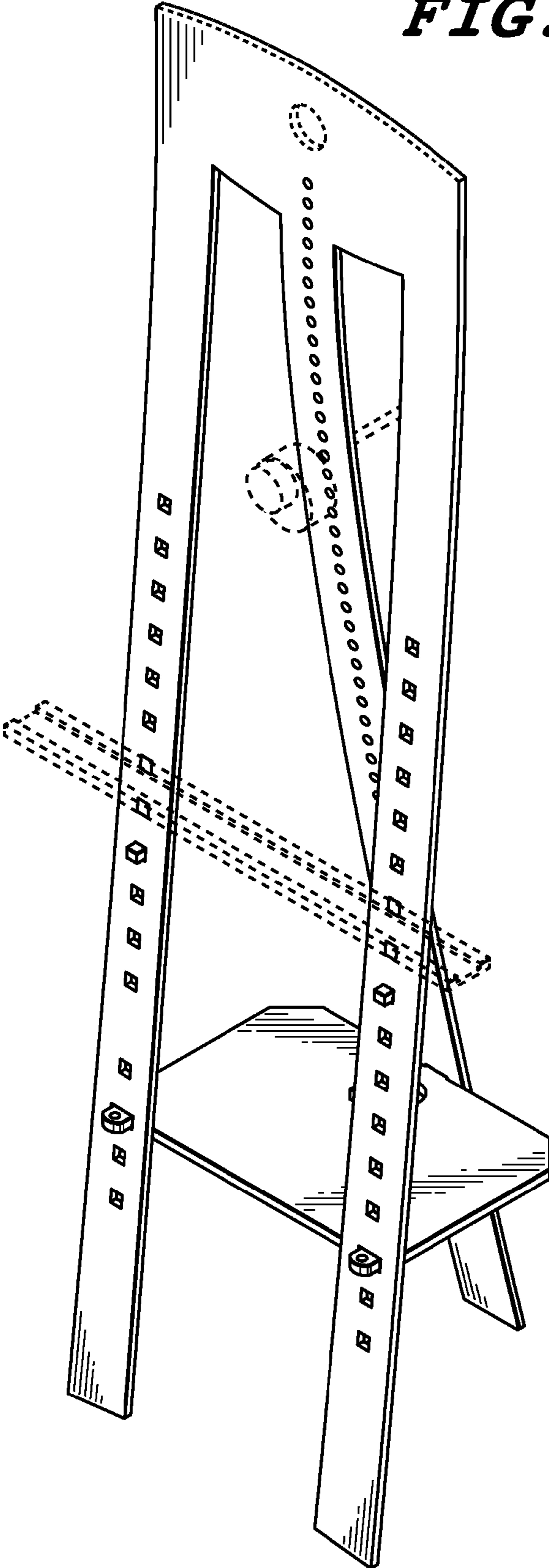

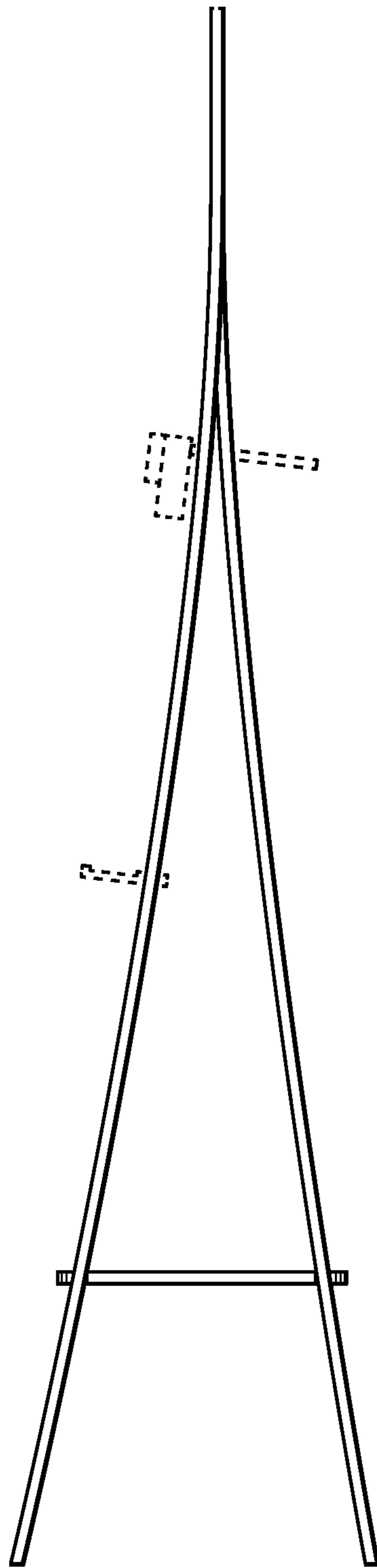

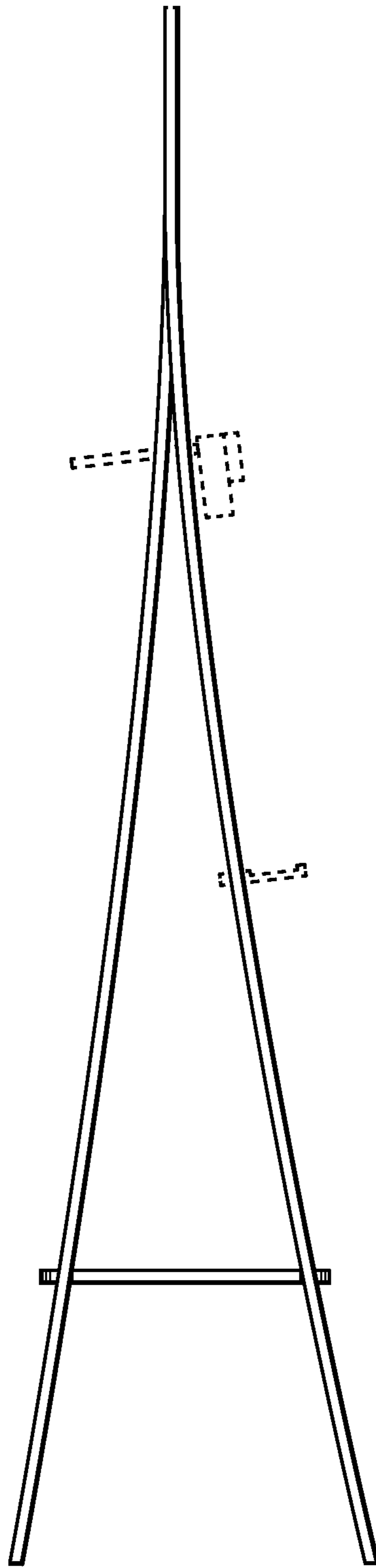

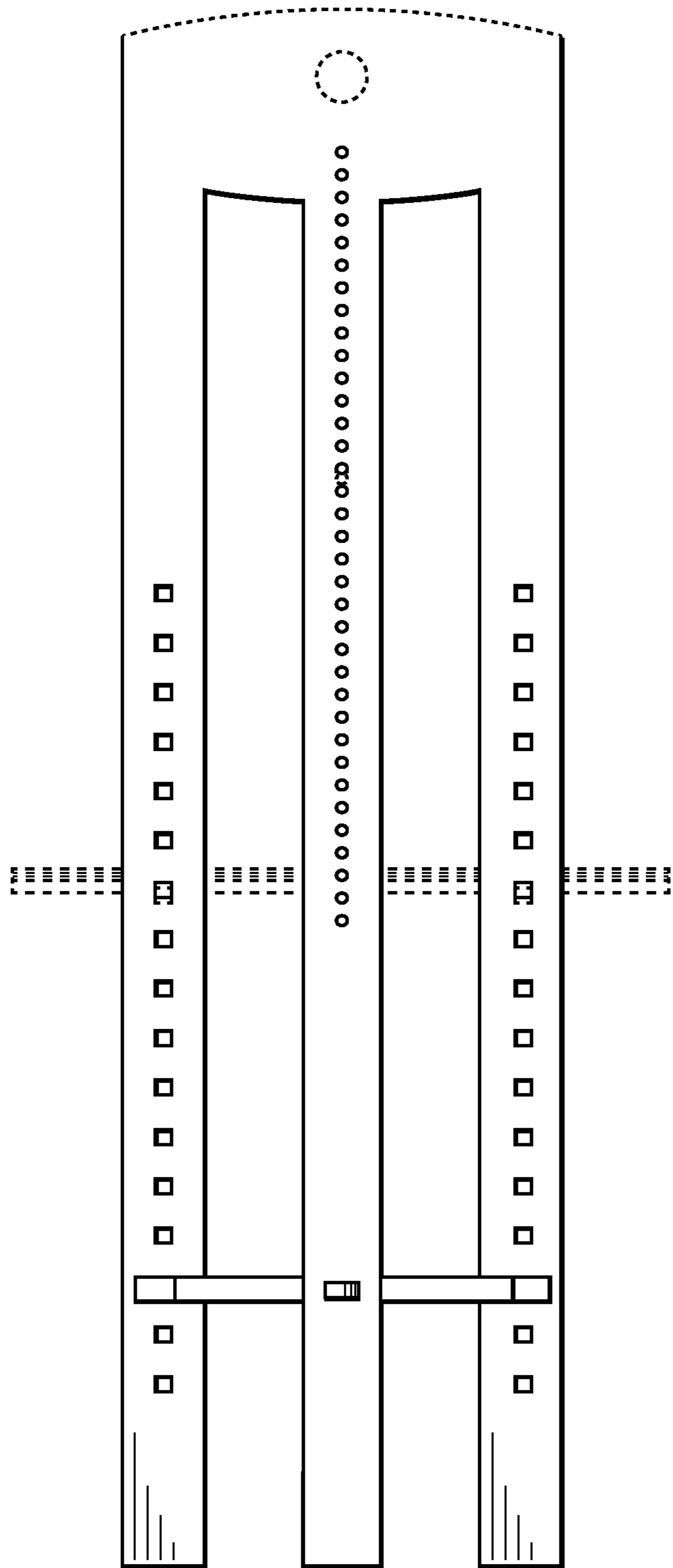




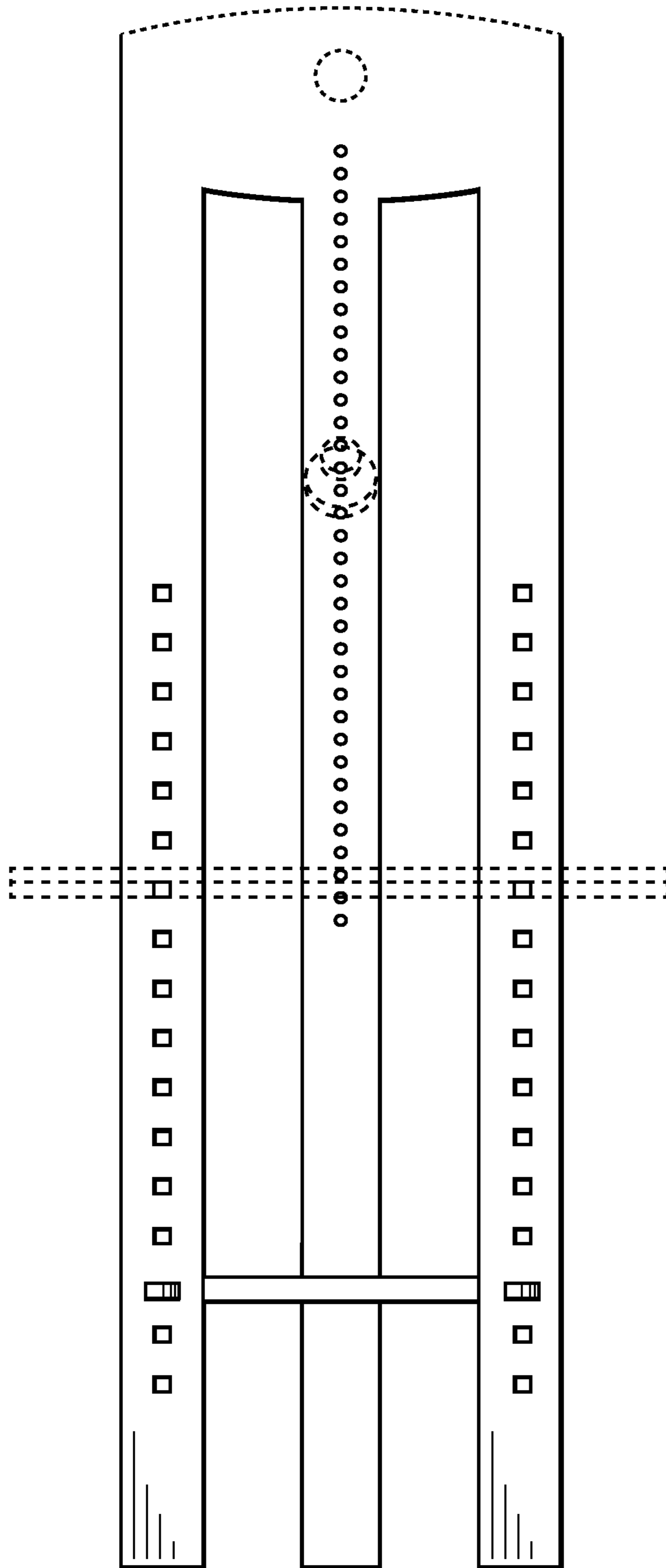

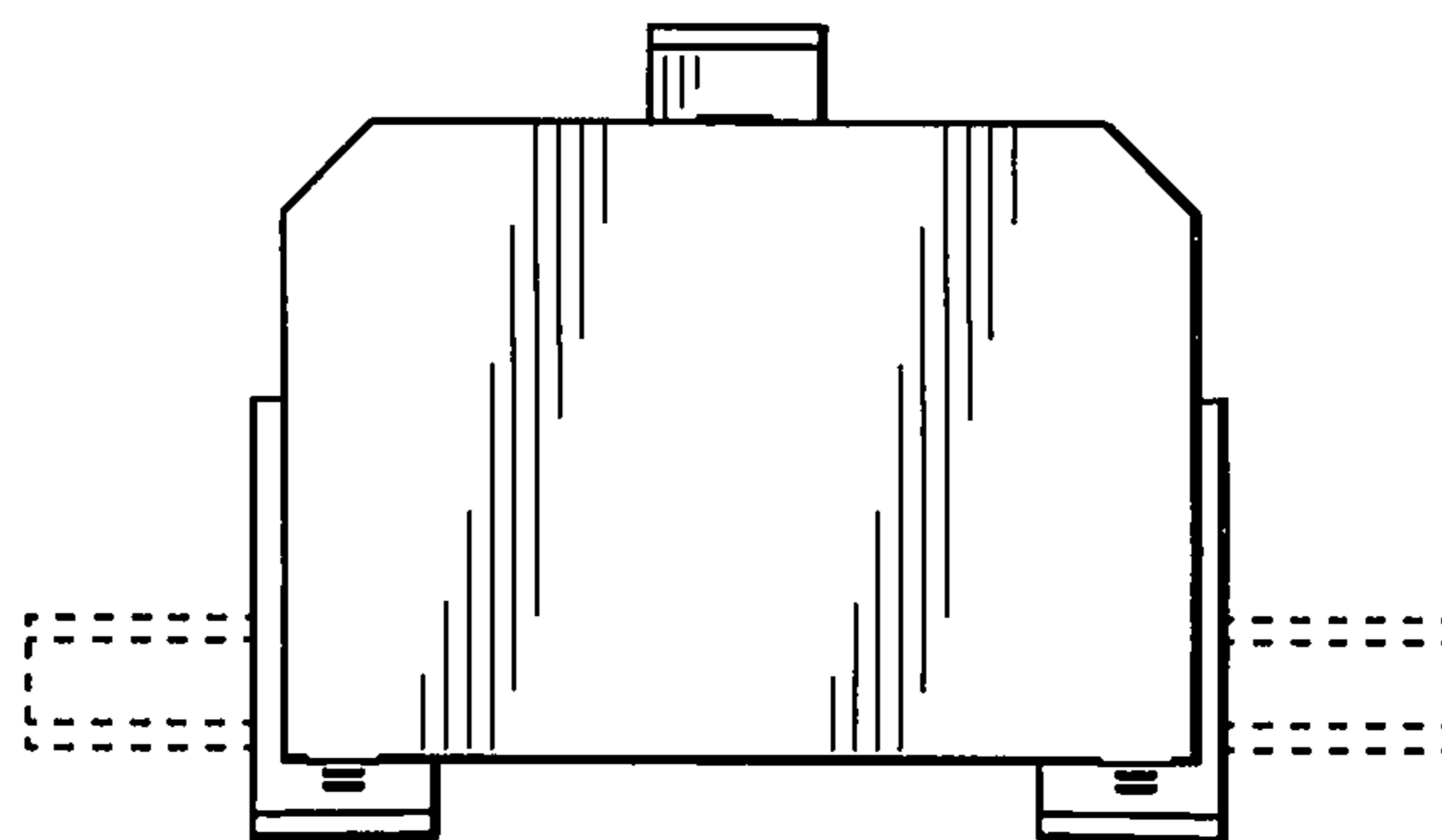
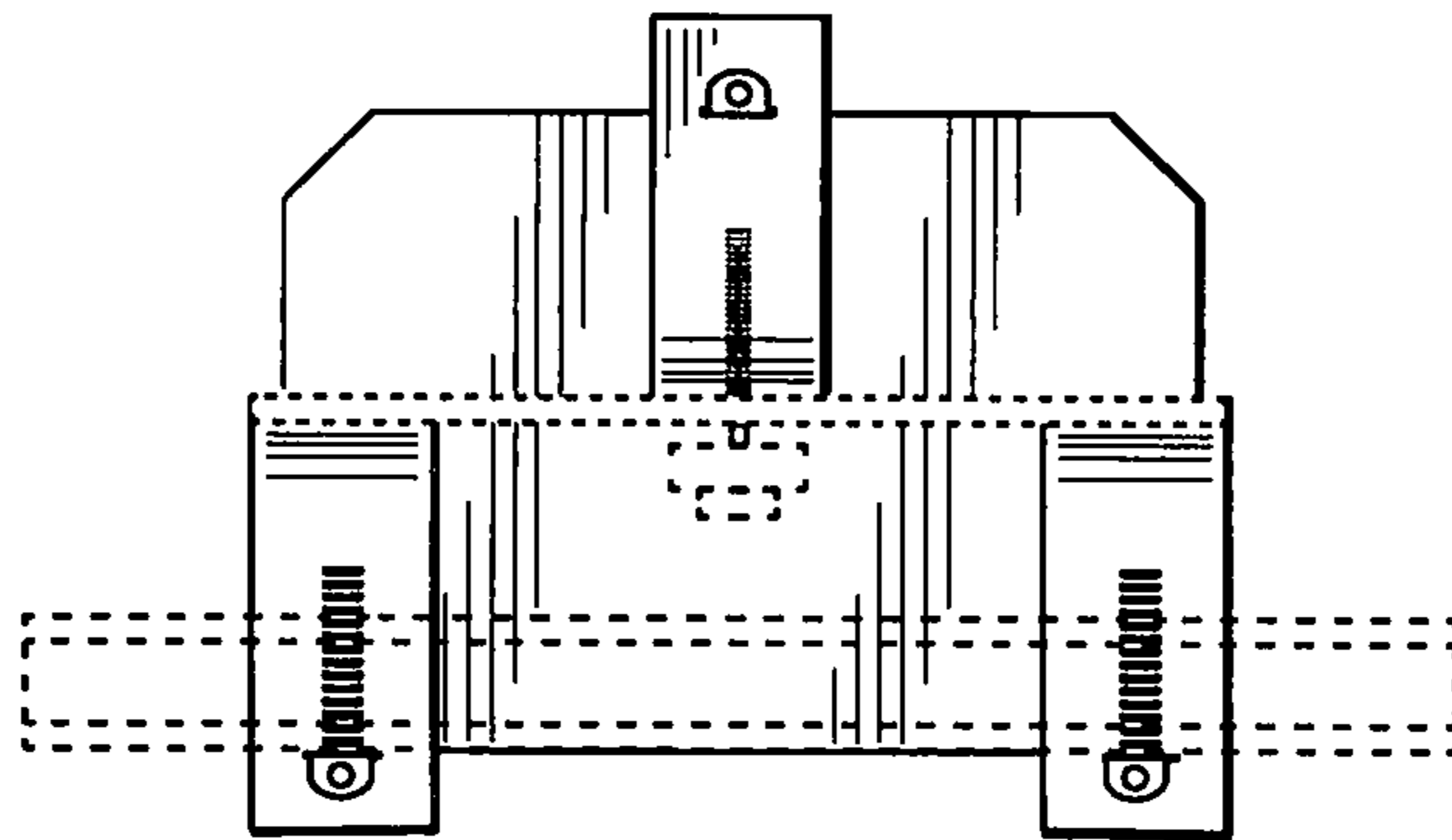
