The ornamental design of a grab bar, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, bottom, left side perspective view of a grab bar of the new design.

FIG. 2 is a front elevation view thereof.

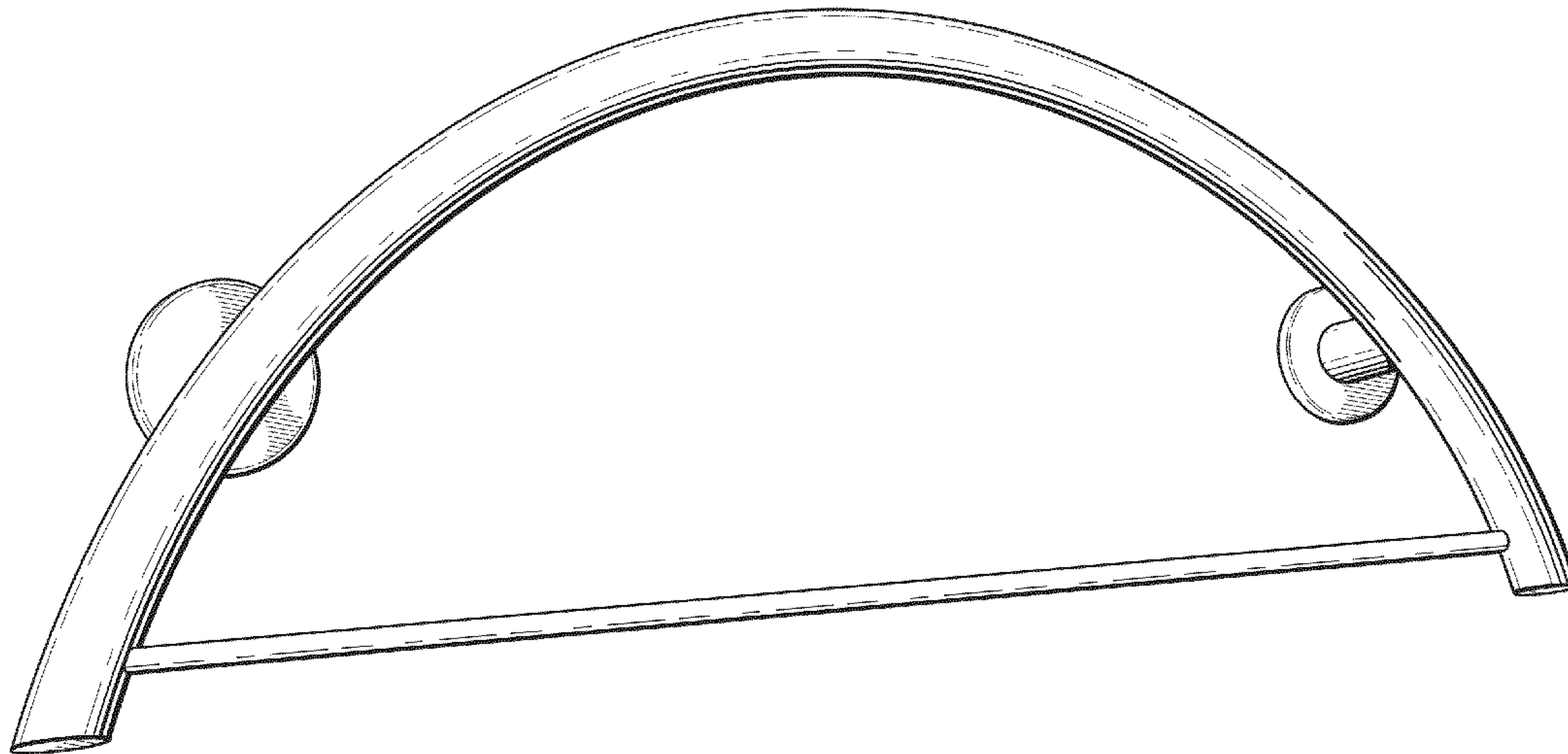
FIG. 3 is a rear elevation view thereof.

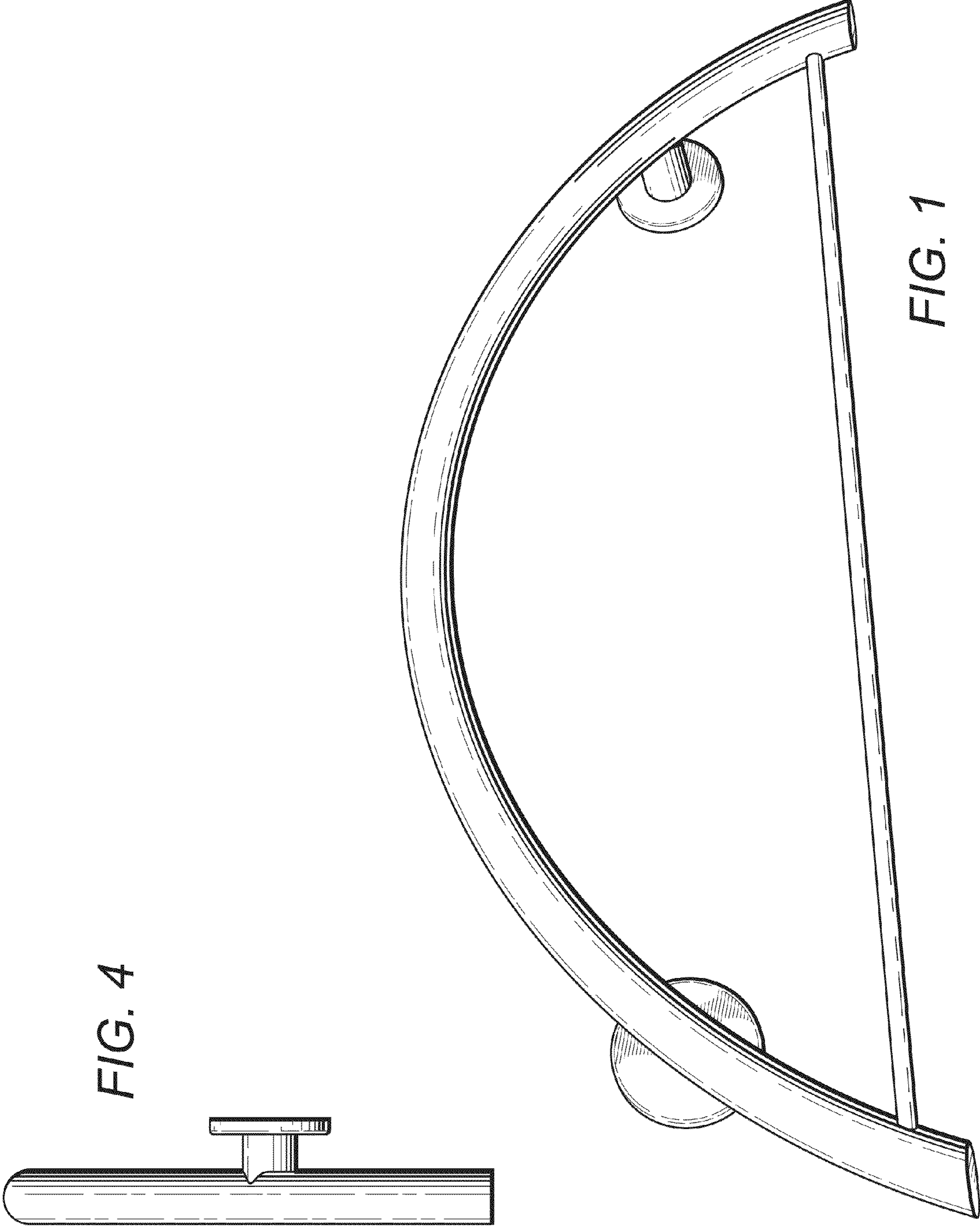

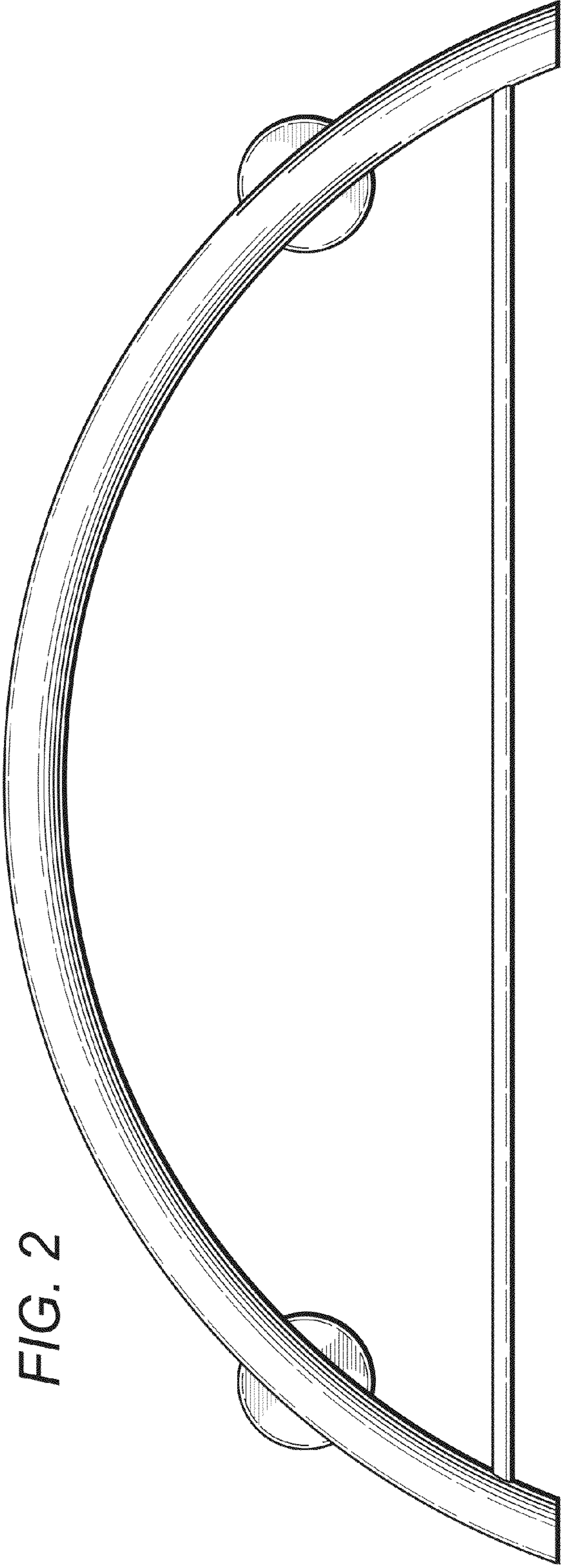

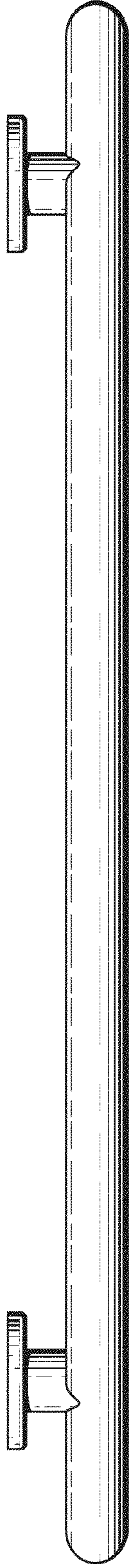

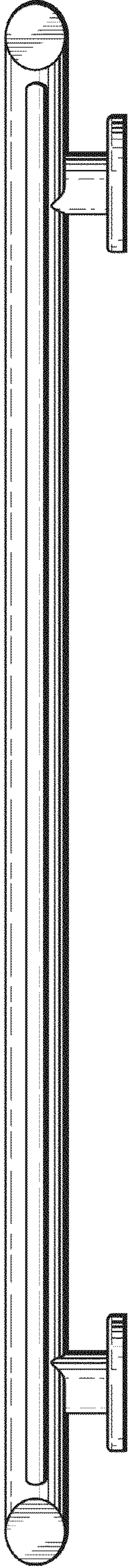
