DESCRIPTION

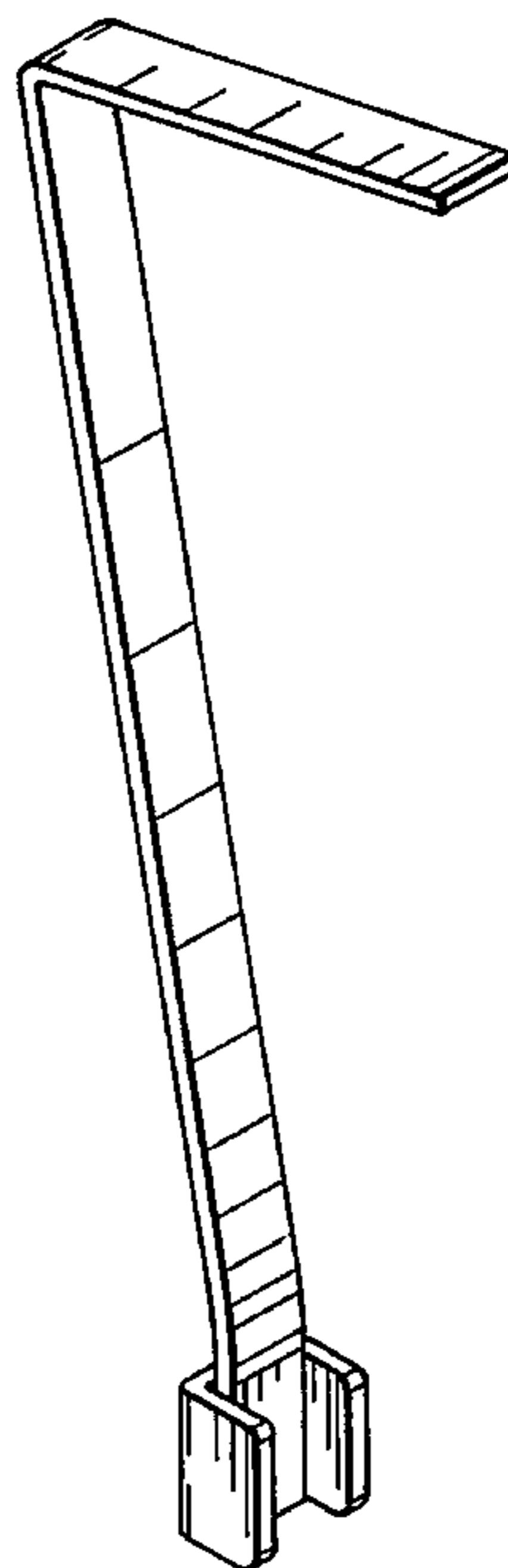
FIG. 1 is a front top and left side perspective view of a light support bracket showing my new design.

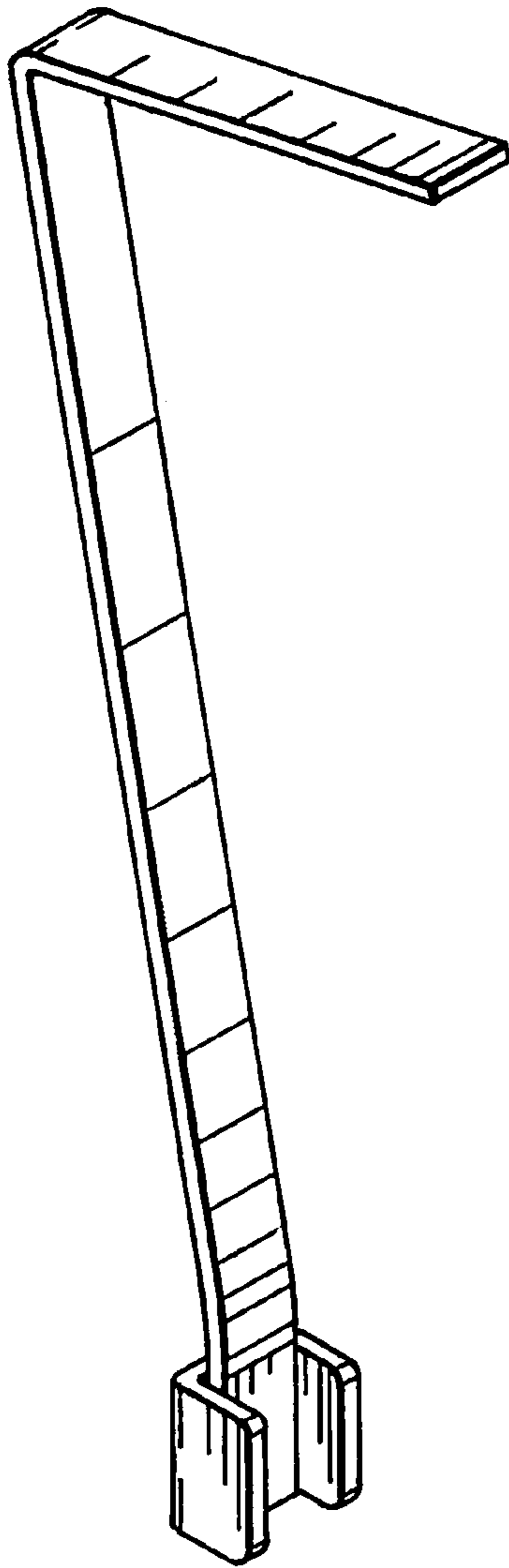

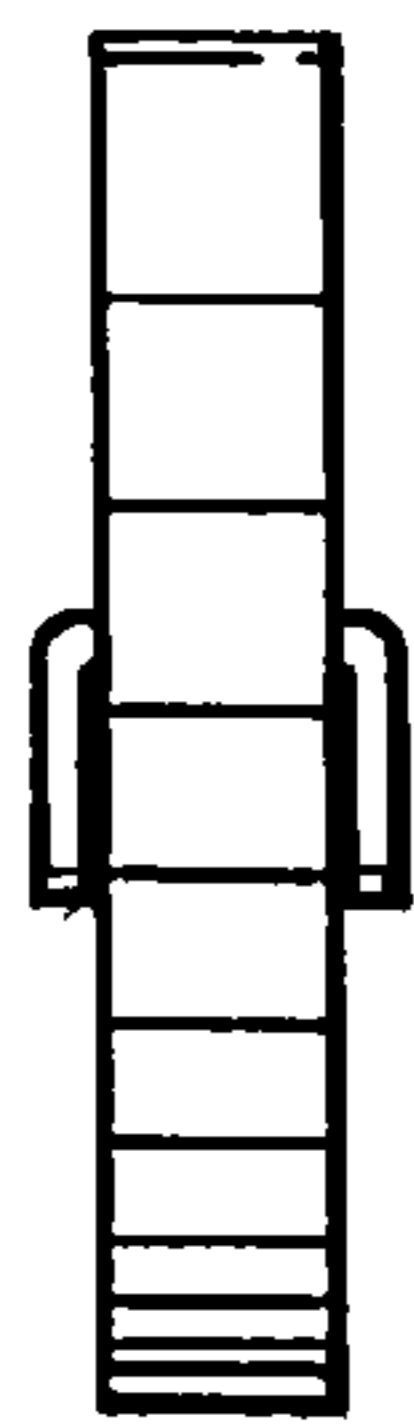

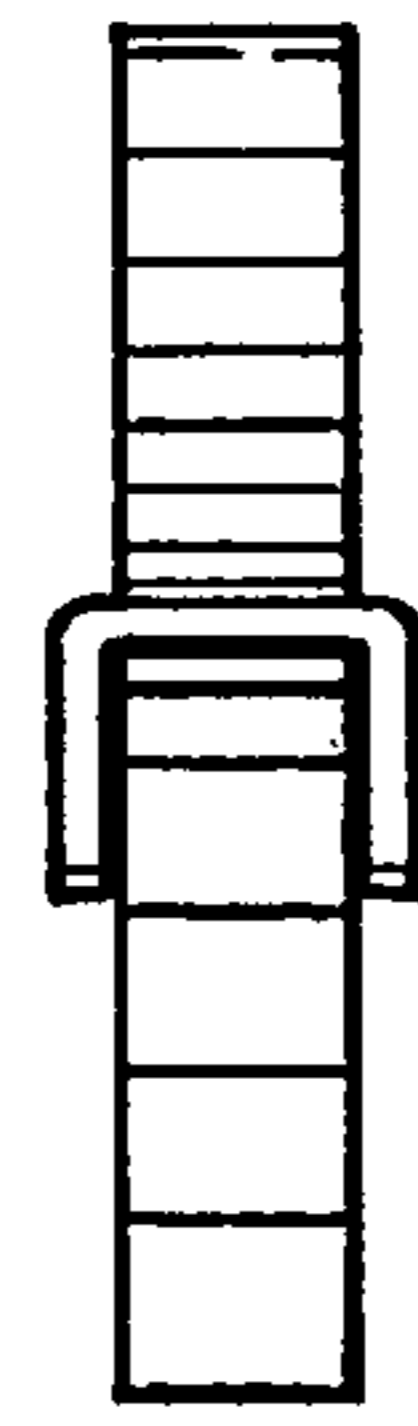

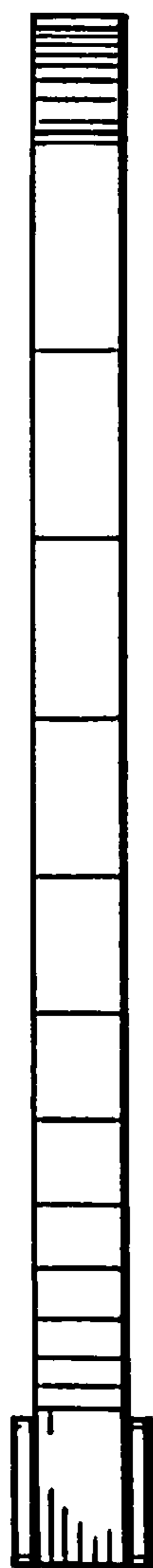

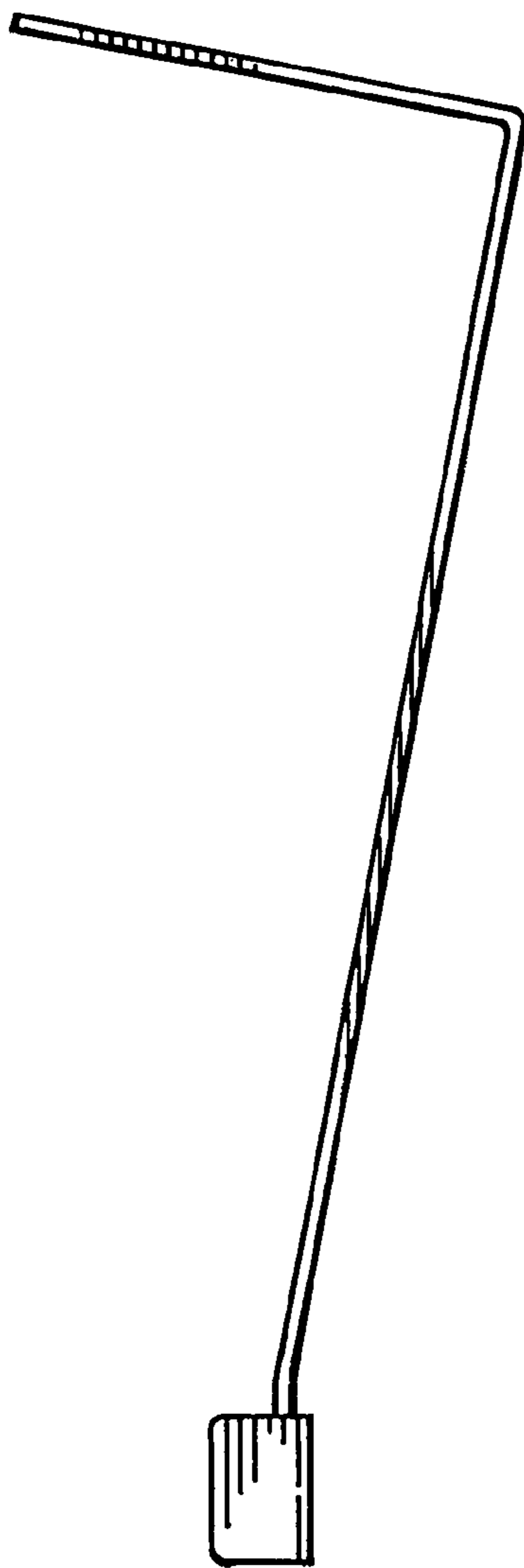

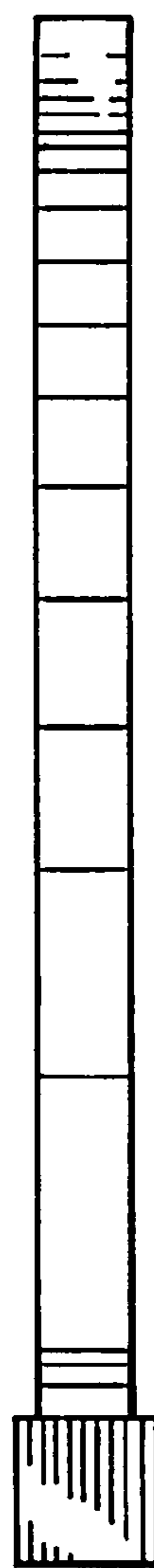
