DESCRIPTION

FIG. 3 is a side elevational view thereof, taken opposite from that of FIG. 2;

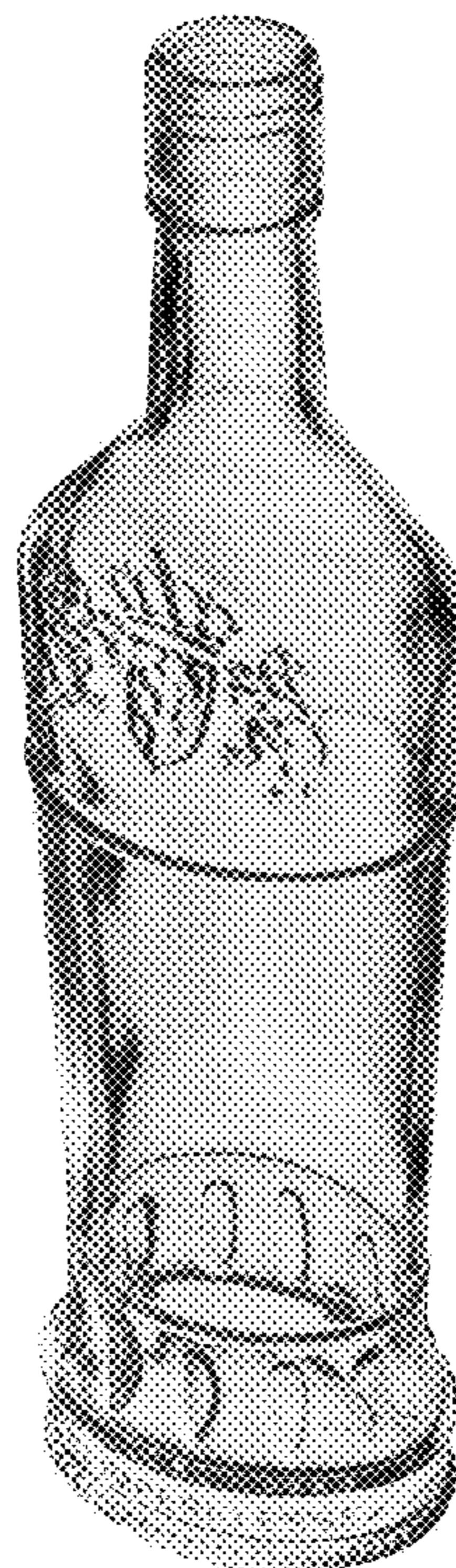
FIG. 4 is a front elevational view thereof;

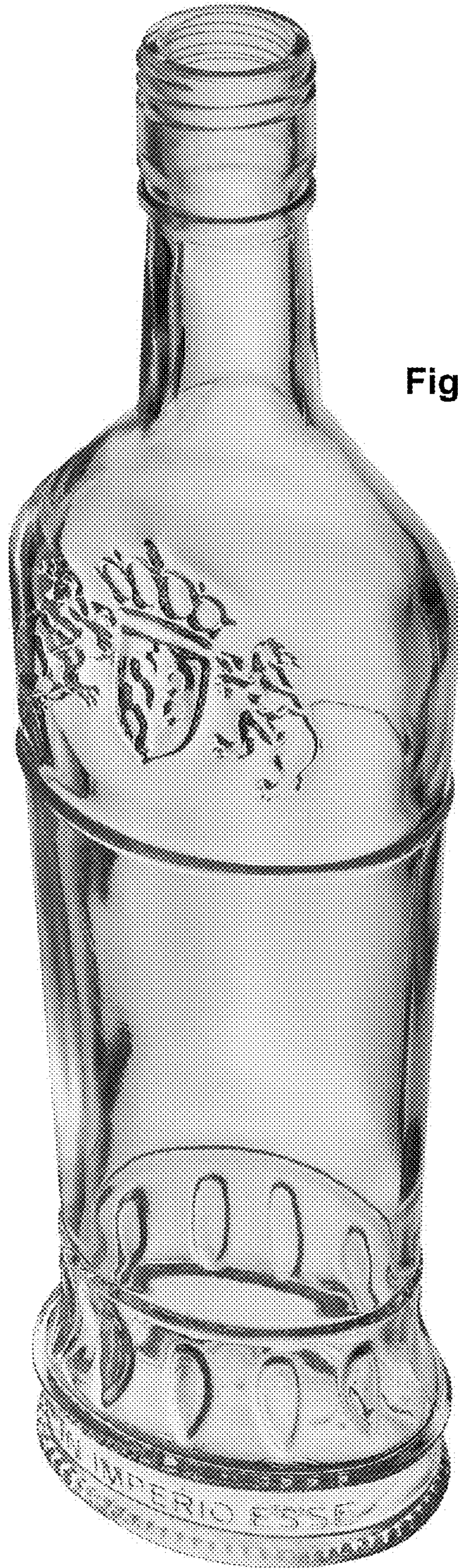

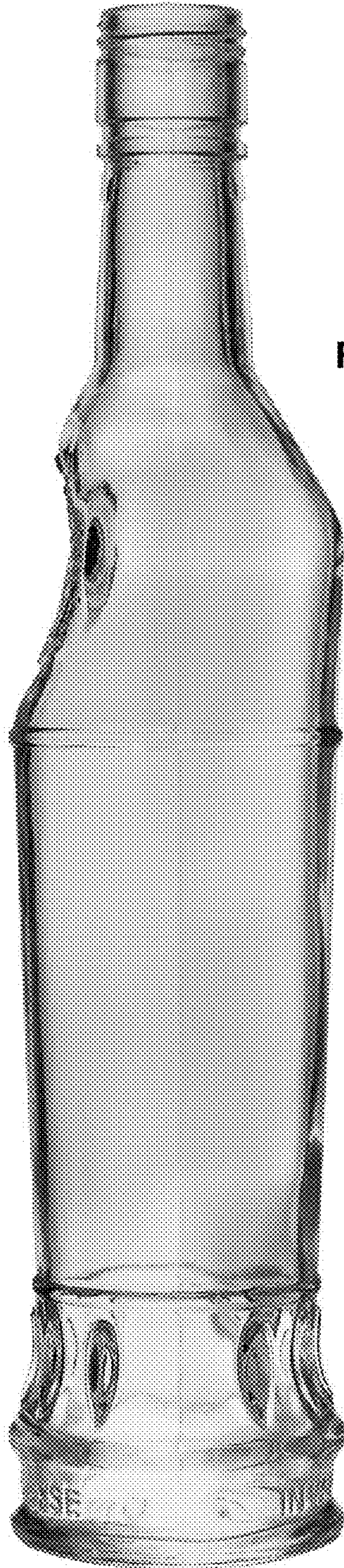

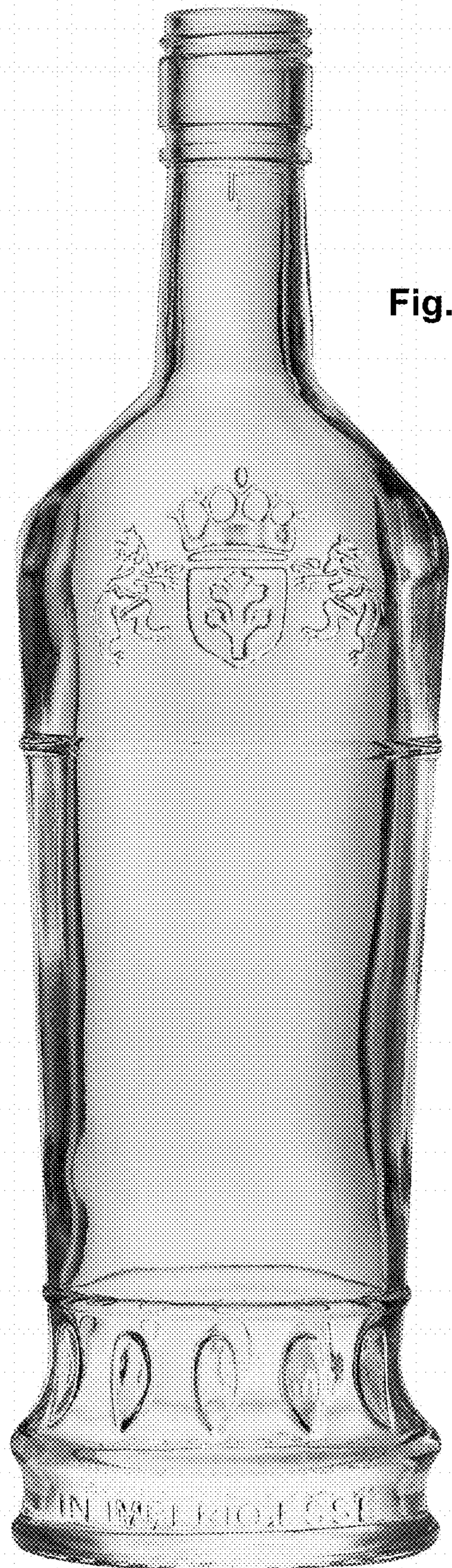

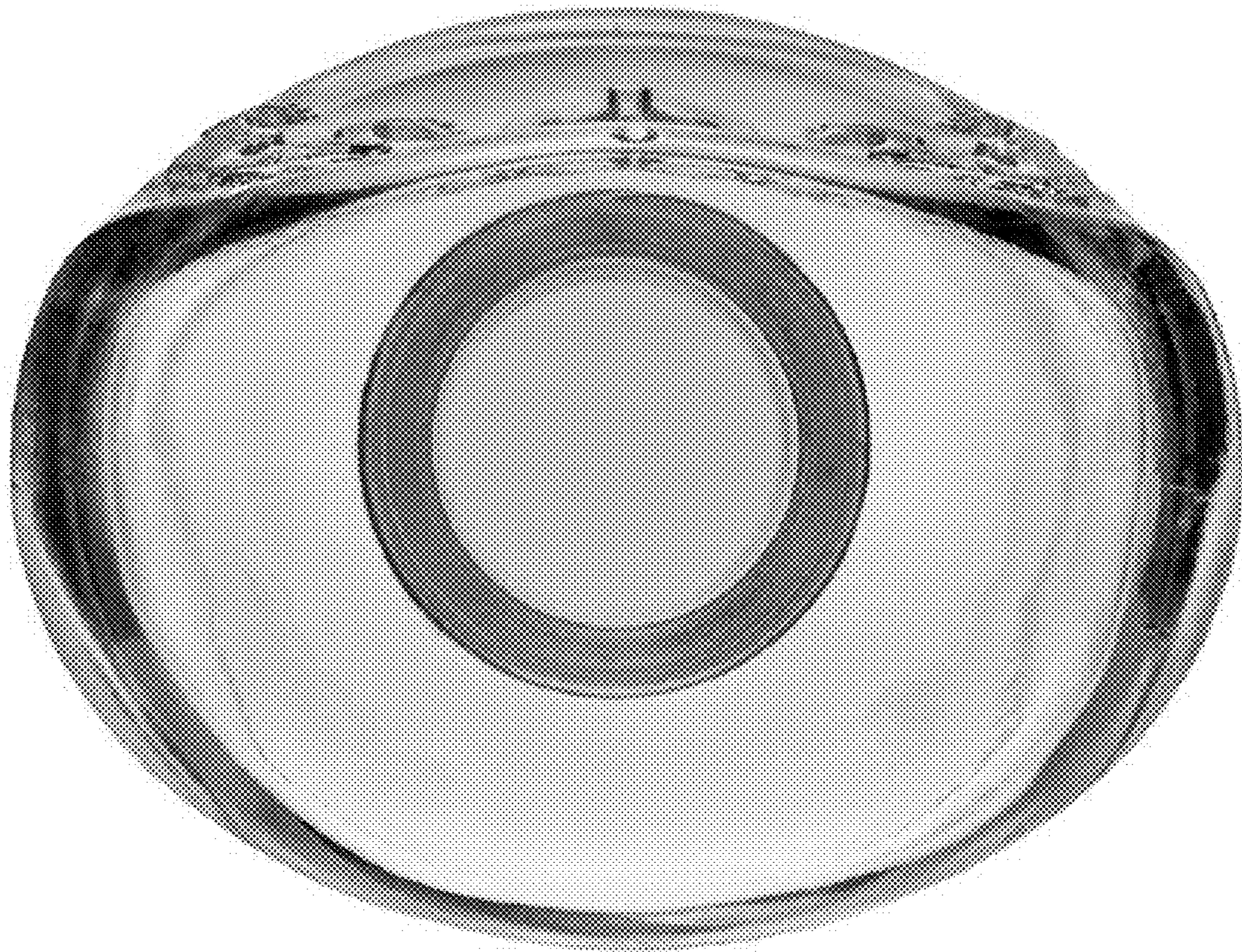
