DESCRIPTION

FIG. 1 is a front perspective view of the beverage container of the present invention;

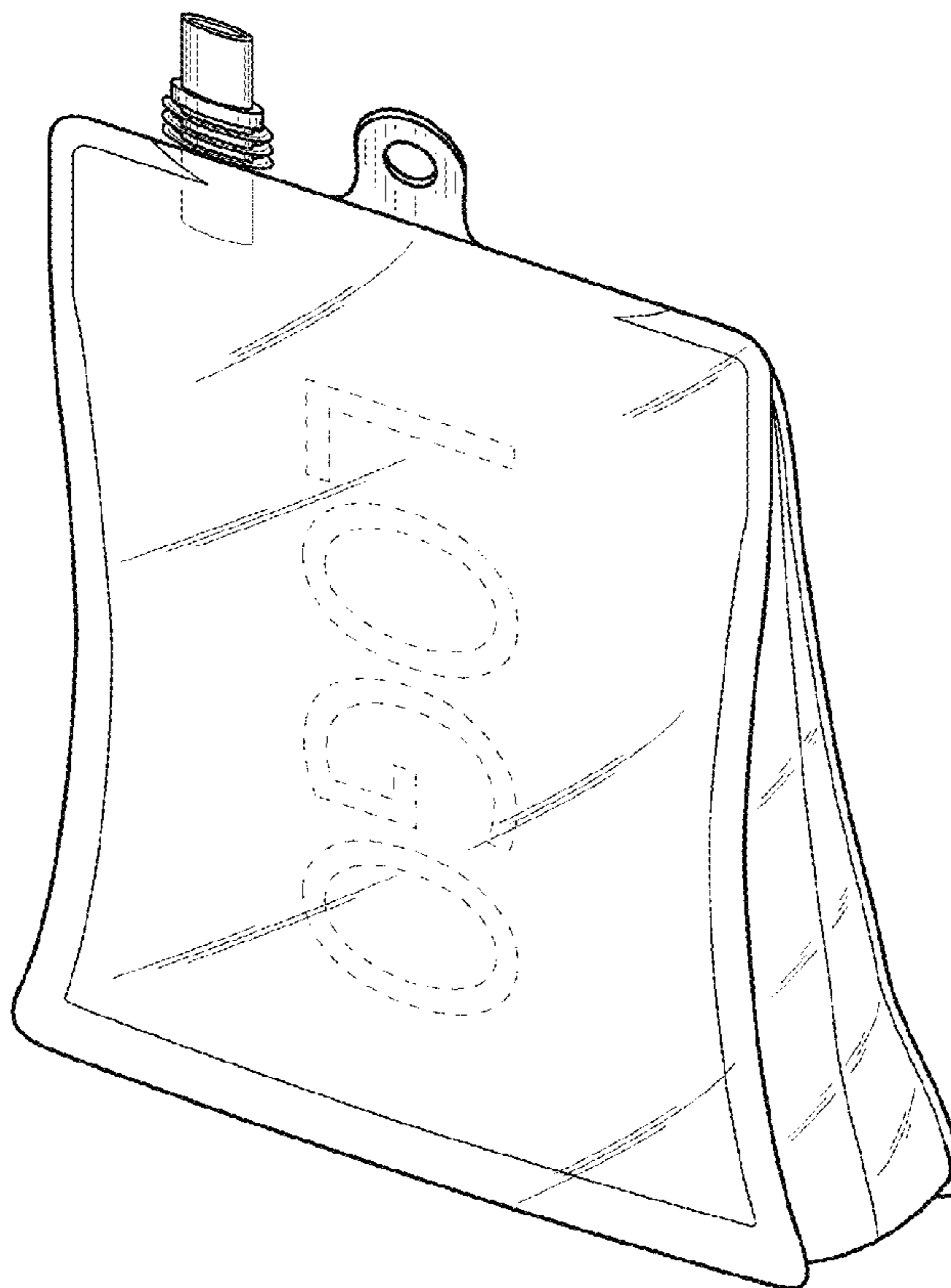
FIG. 2 is a front view of the beverage container of FIG. 1;

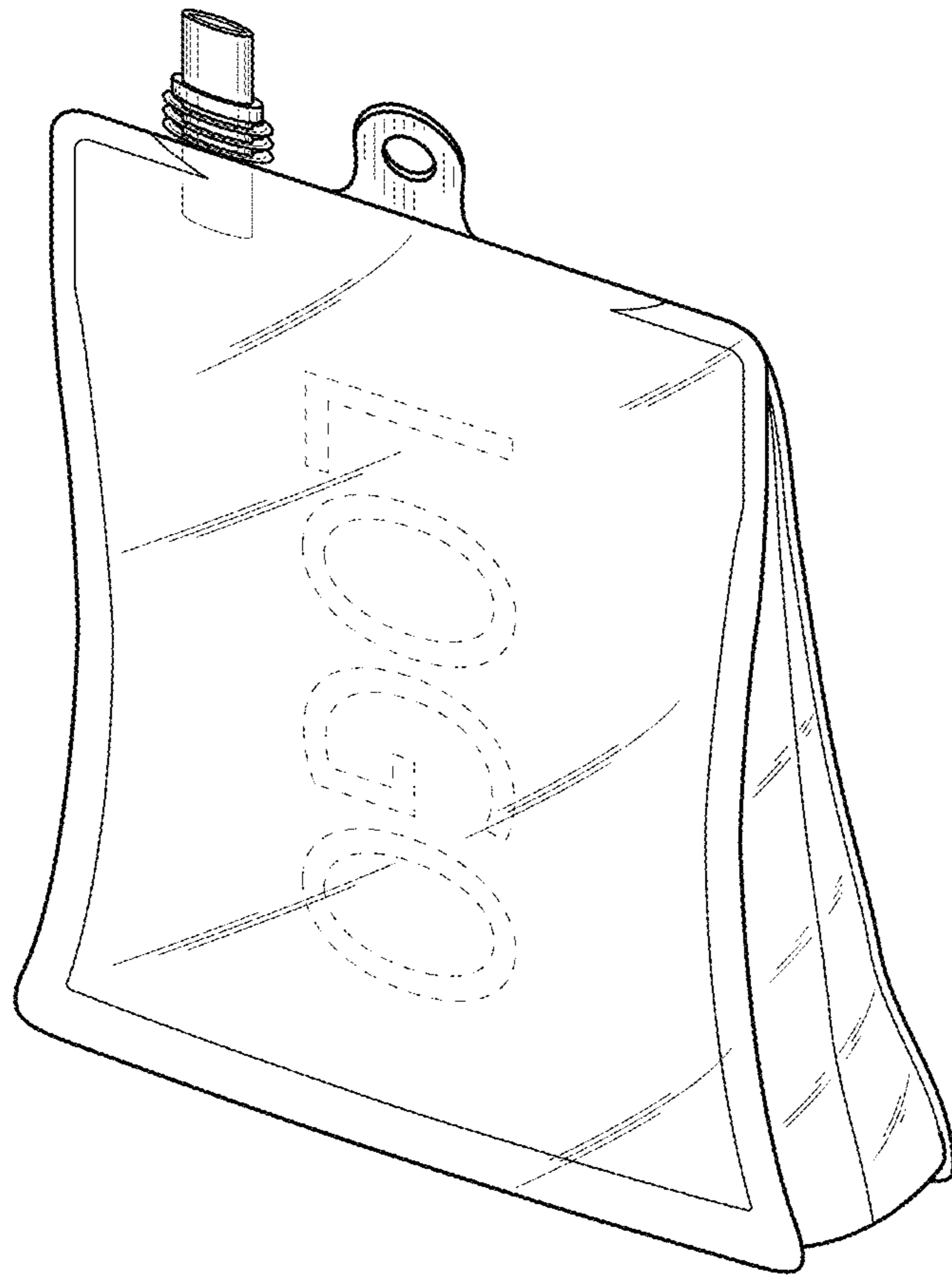

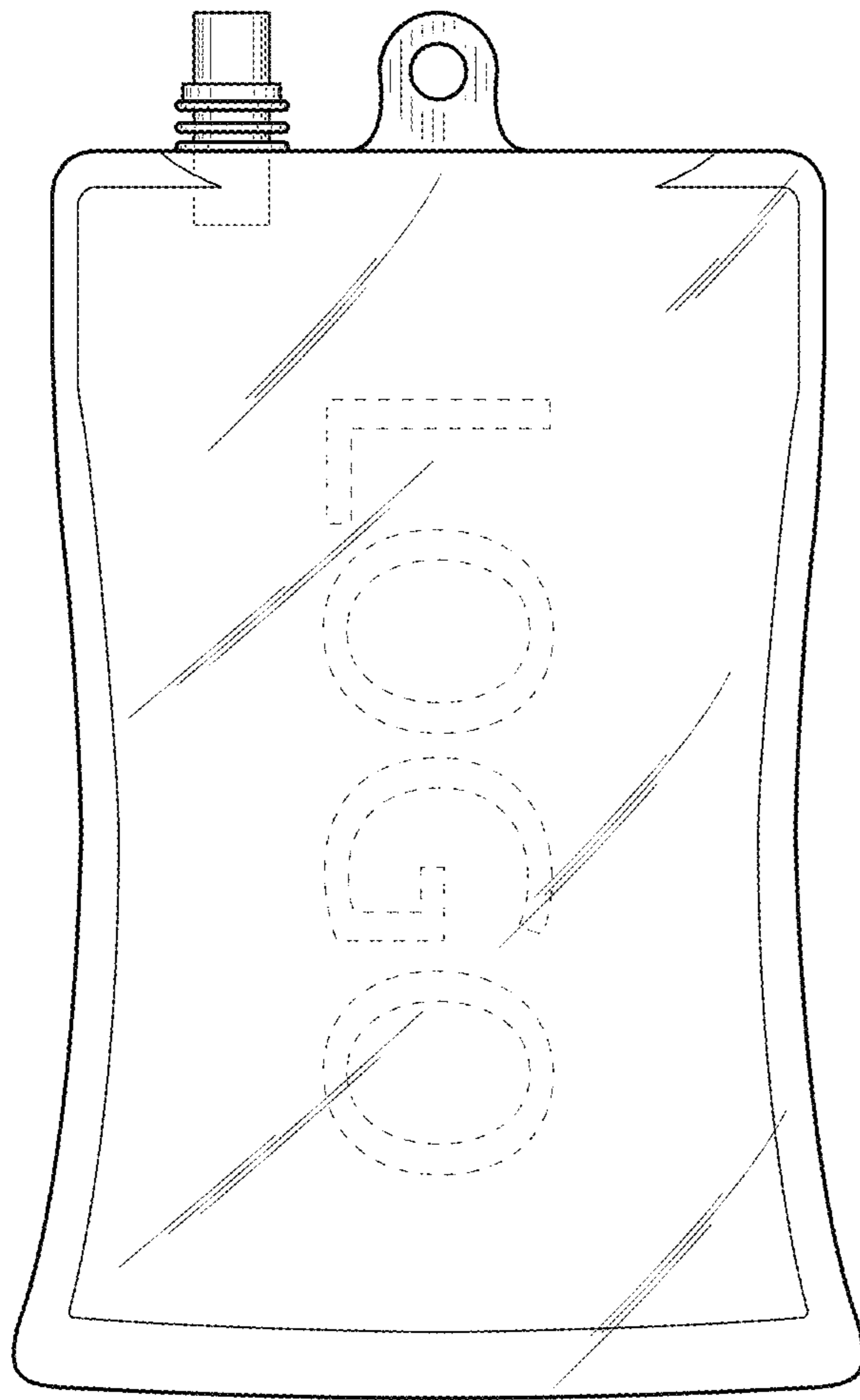

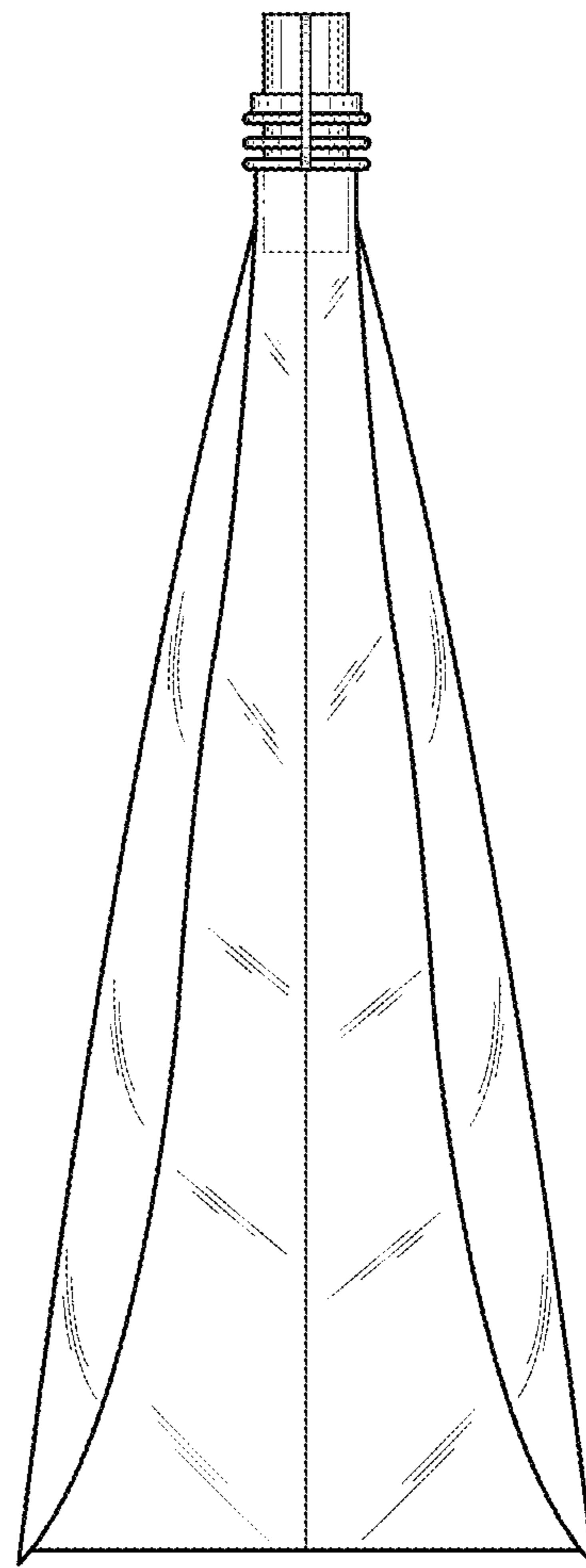

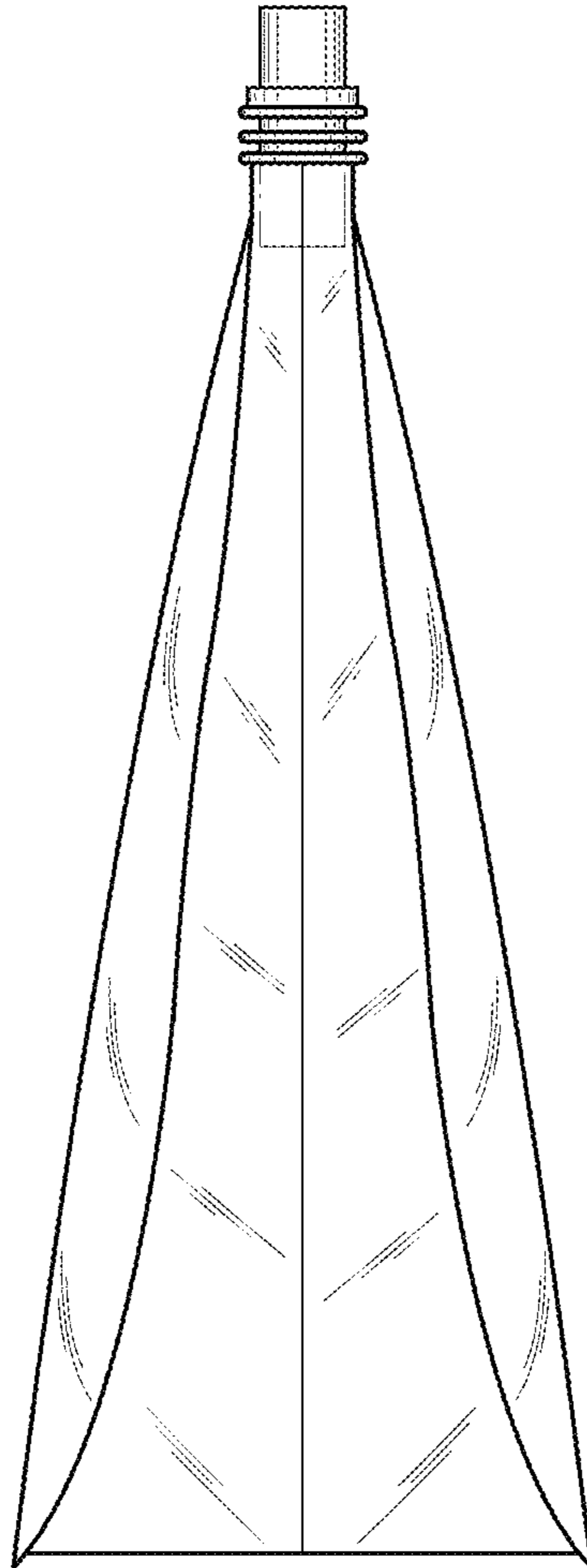
