**DESCRIPTION**

FIG. 1 is a front view of a ferrule for an optical fiber showing our new design,  
FIG. 2 is a rear view thereof,  
FIG. 3 is a right side view thereof,  
FIG. 4 is a left side view thereof,  
FIG. 5 is a top plane view thereof,  
FIG. 6 is a bottom view thereof,  
FIG. 7 is a sectional view taken in the direction of line 7-7 in FIG. 4;

FIG. 9 is another perspective view thereof.

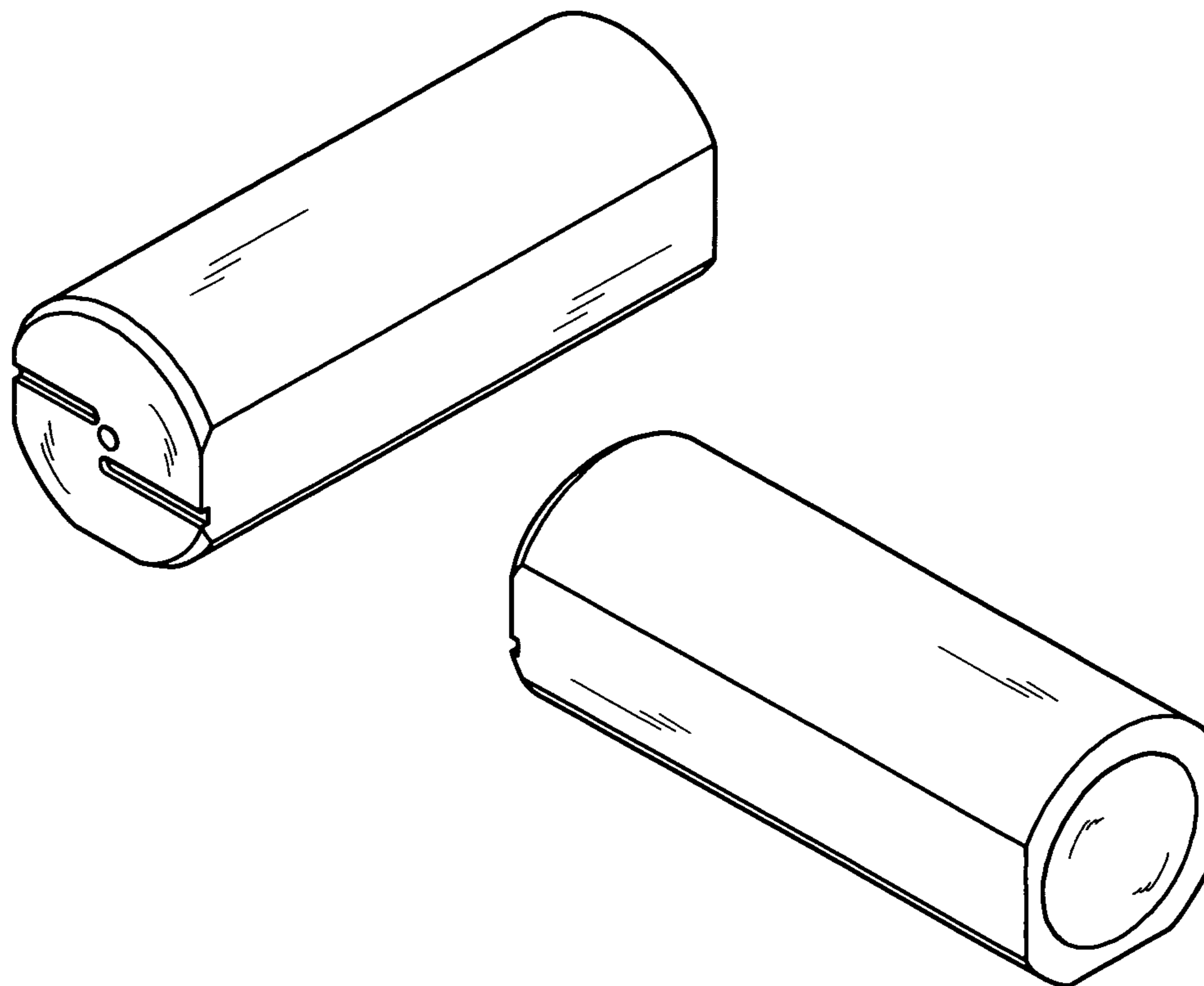

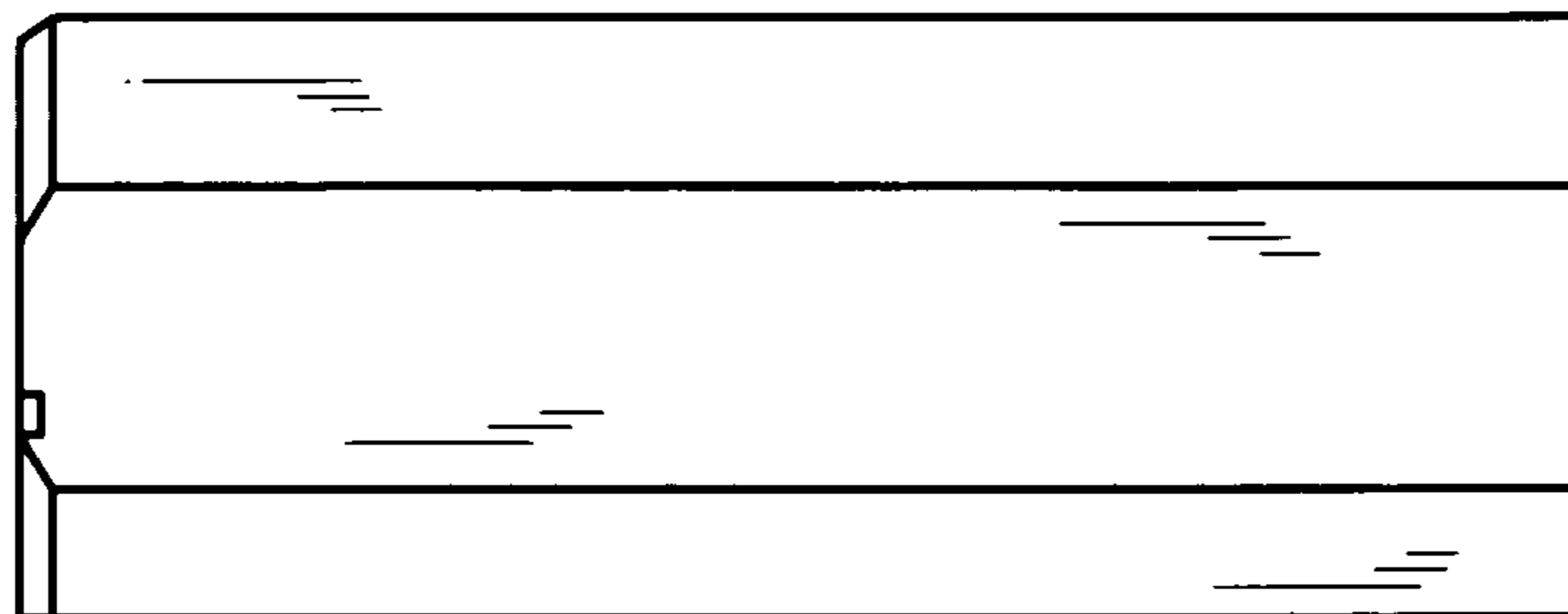

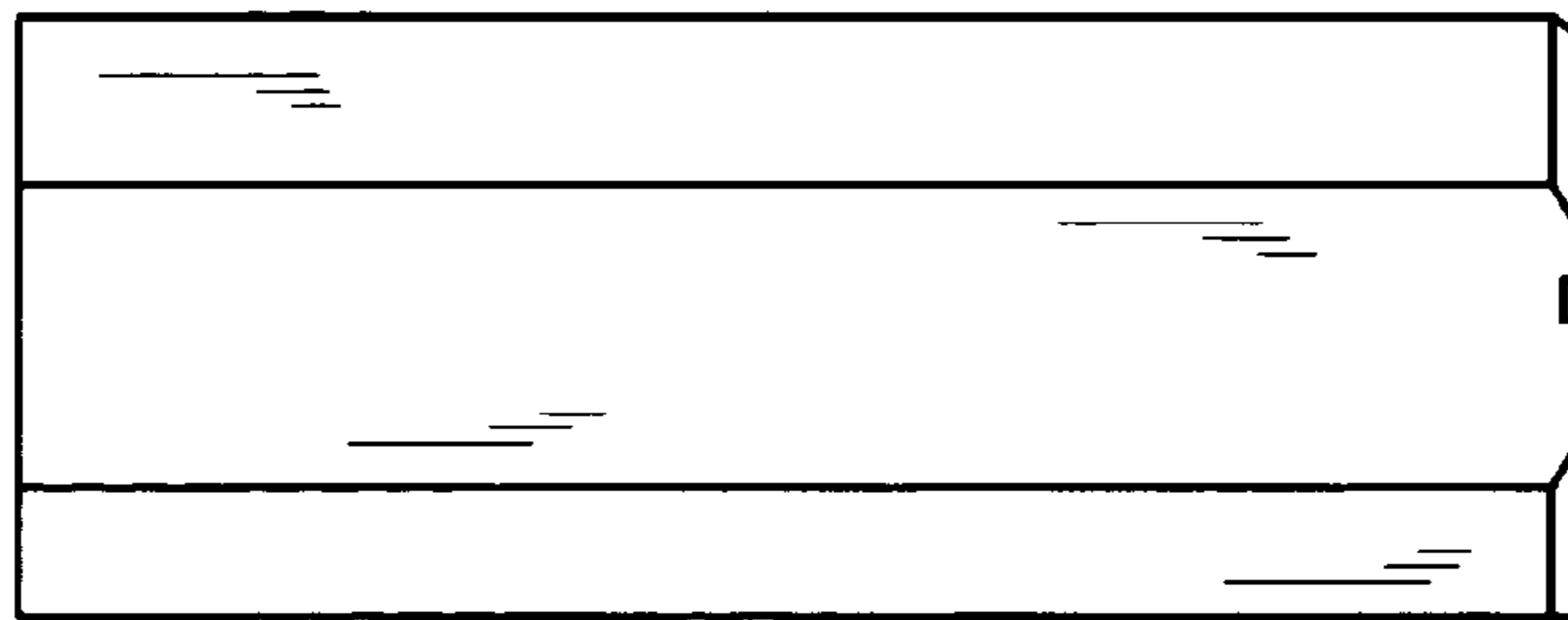

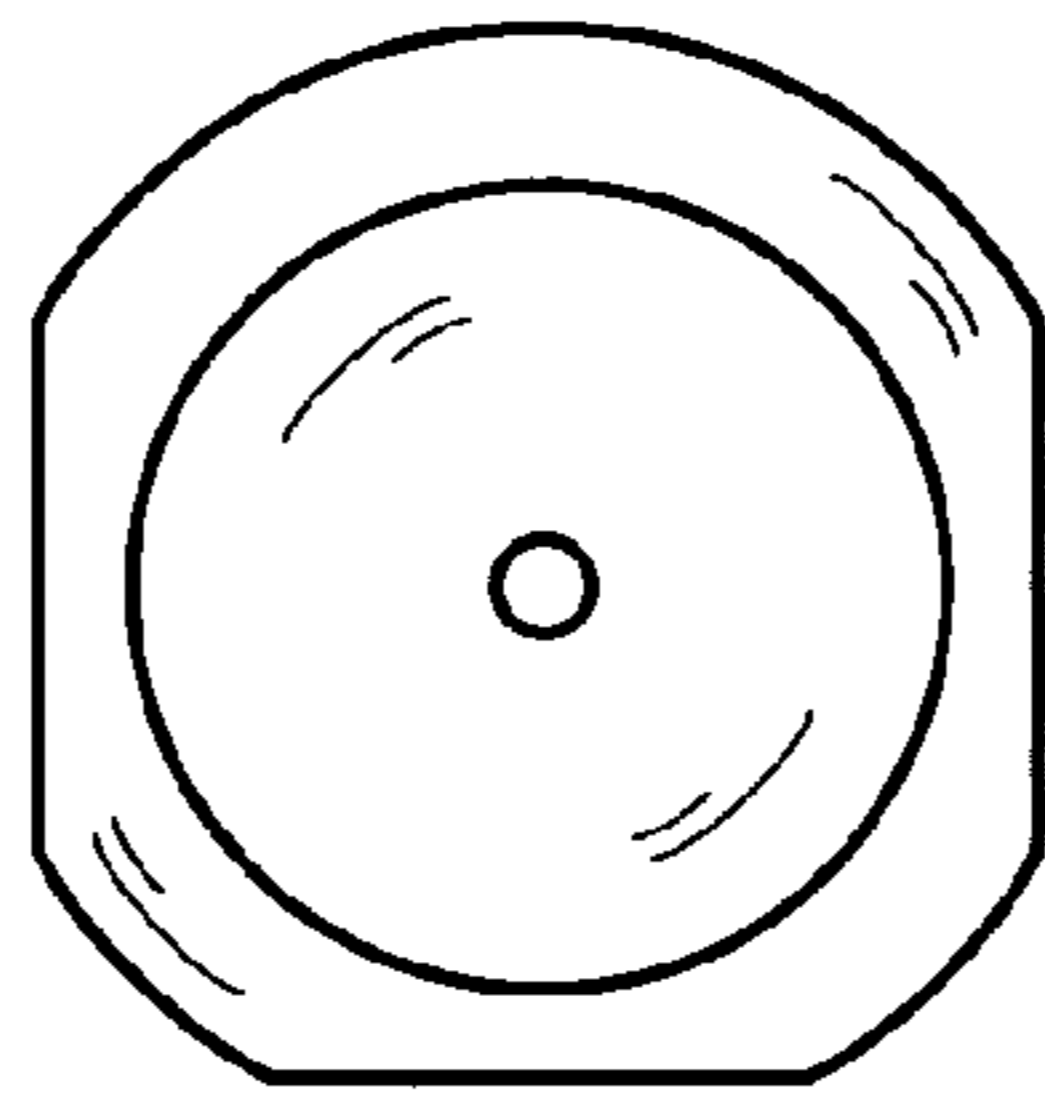

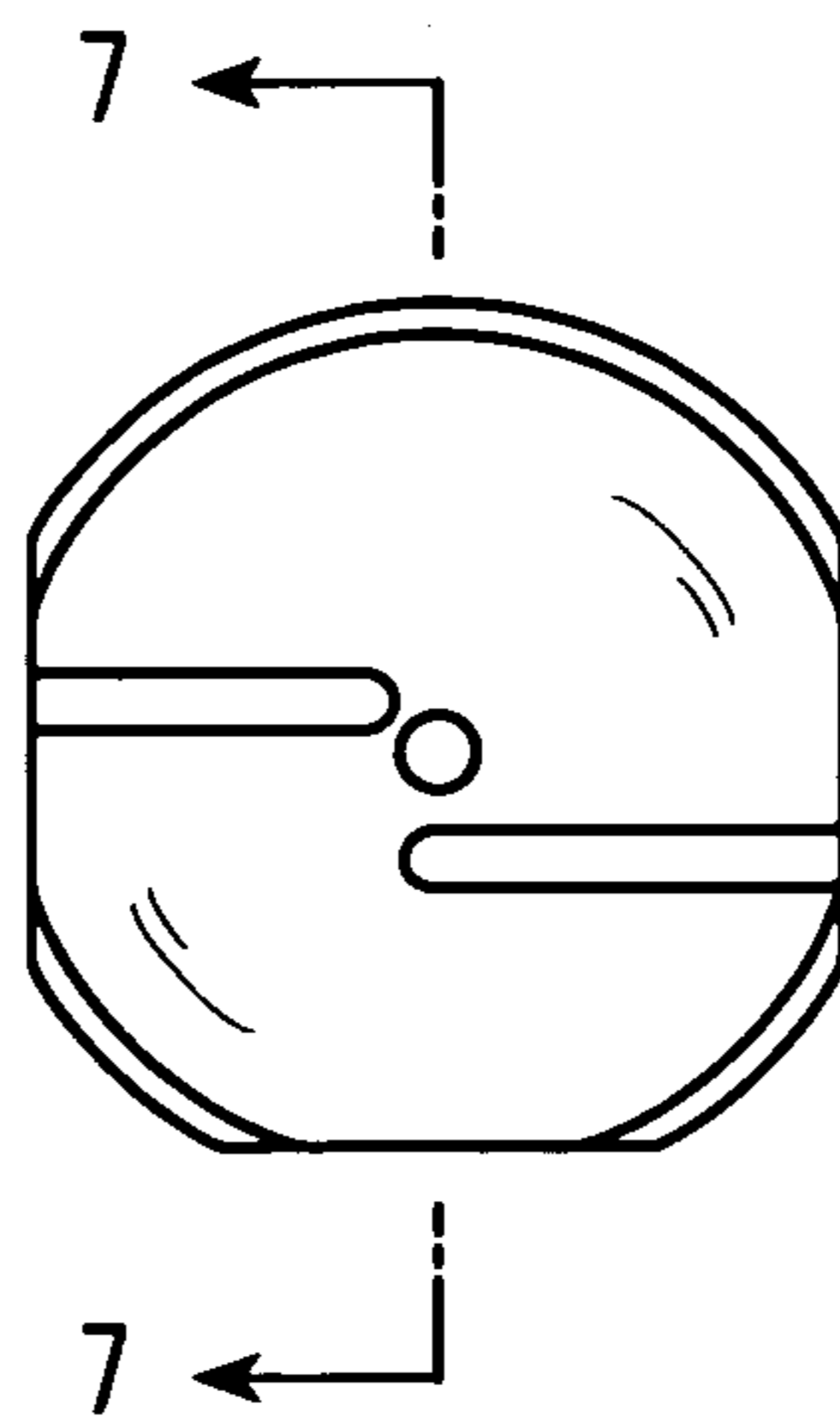

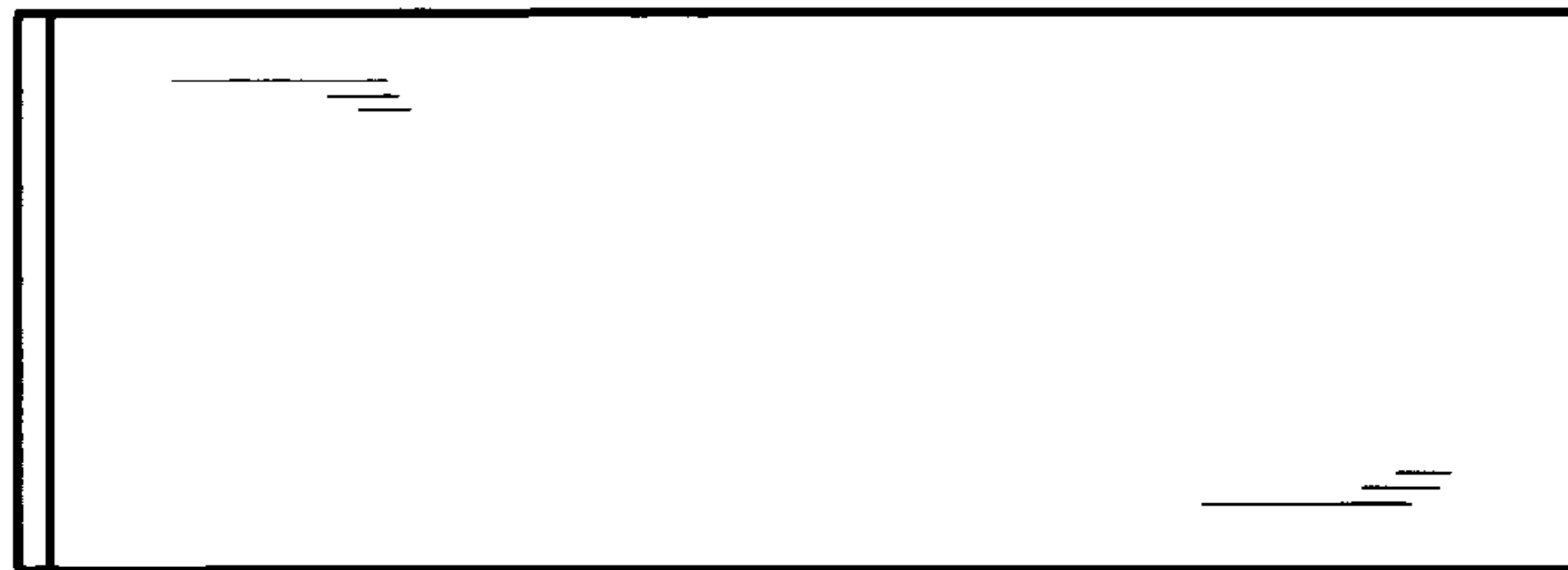

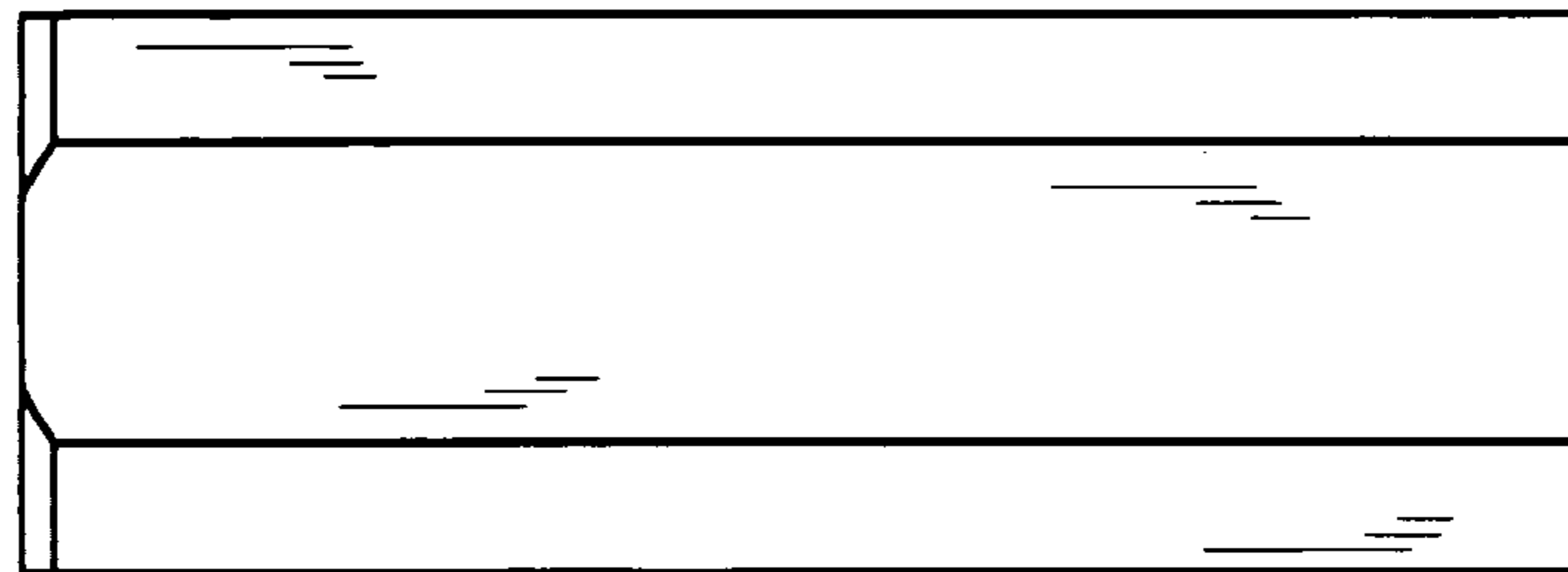

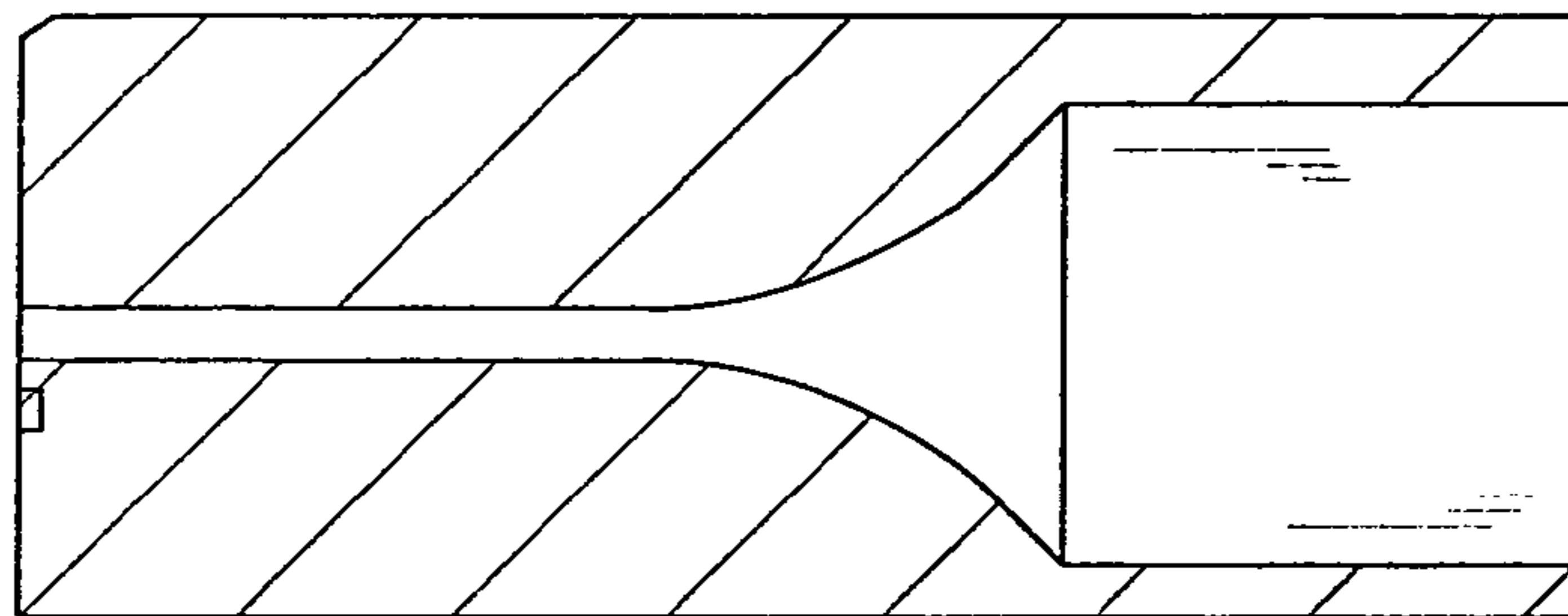

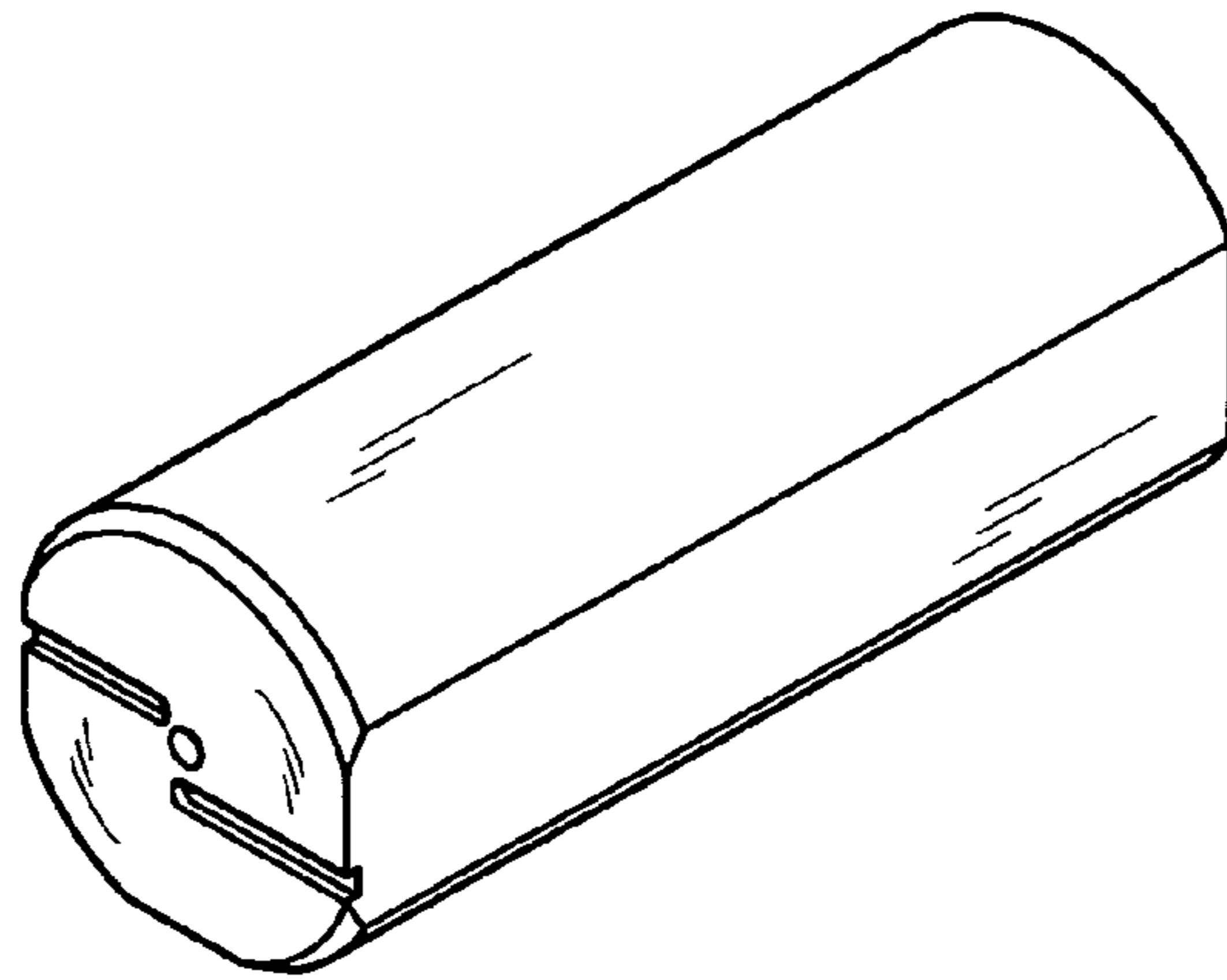
