(57) **CLAIM**

The ornamental design for a rechargeable docking speaker system, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, right side, perspective view of a rechargeable docking speaker system showing my new design in a first condition;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a side view thereof, at an enlarged scale, the opposite side view being a mirror image;

FIG. 8 is a cross-sectional view thereof along line 8-8 in FIG. 5;

FIG. 11 is a front, top, right side, perspective view thereof in a second condition;

FIG. 15 is a bottom view thereof;

FIG. 16 is a side view thereof at an enlarged scale, the opposite side view being a mirror image;

FIG. 17 is a cross-sectional view thereof at an enlarged scale along line 17-17 in FIG. 12;

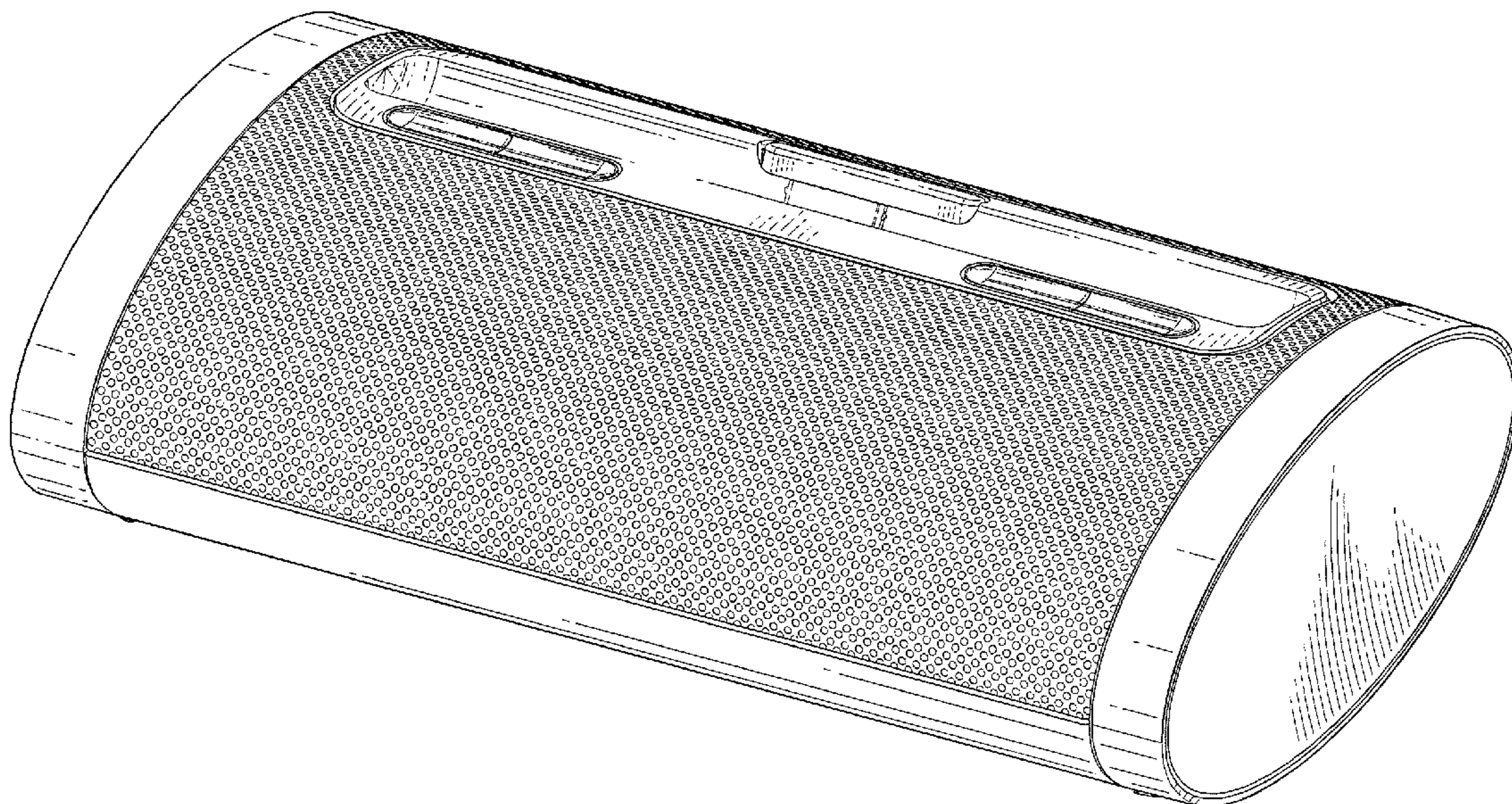
FIG. 18 is a cross-sectional view thereof at an enlarged scale along line 18-18 in FIG. 15;

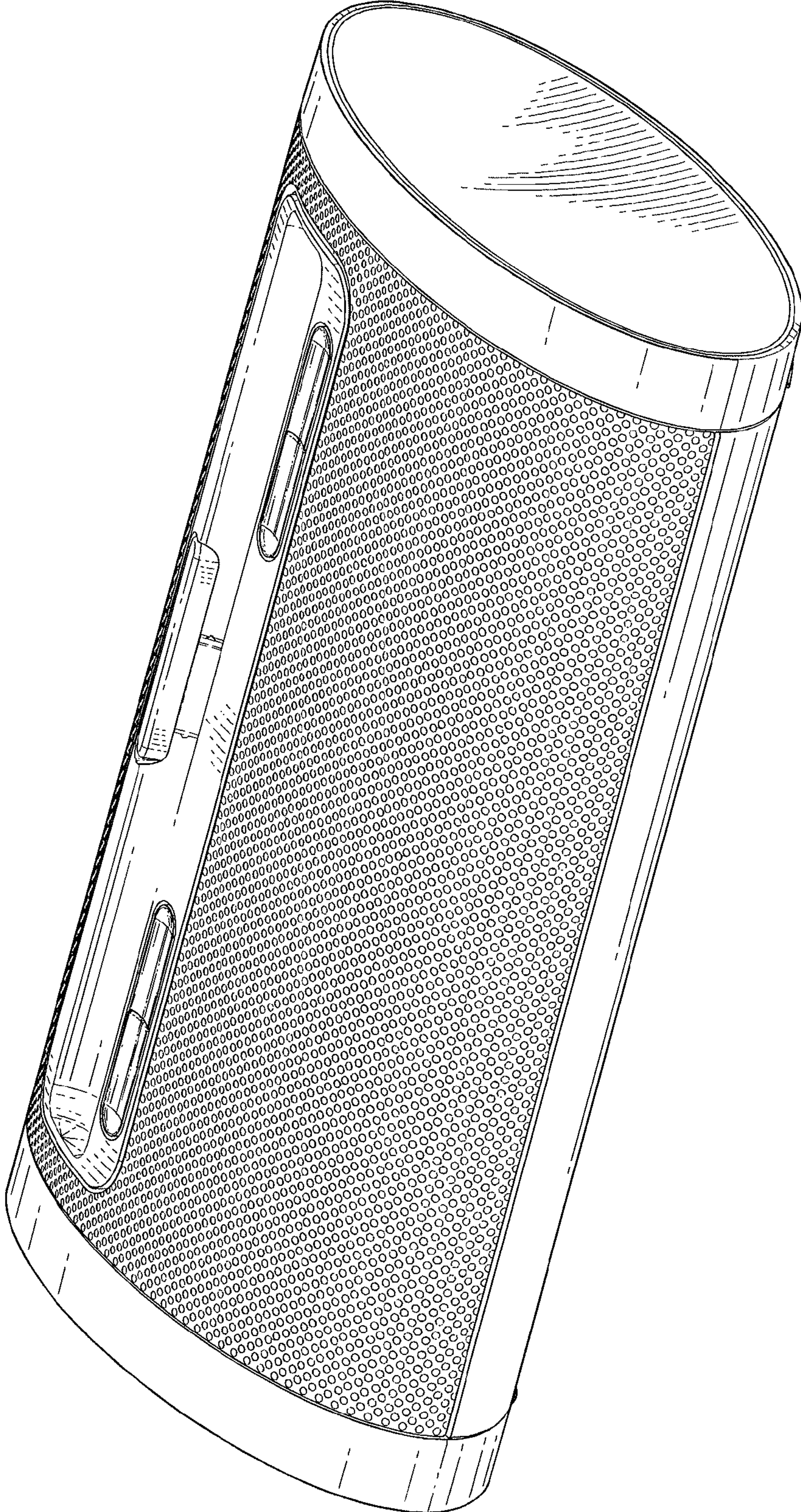

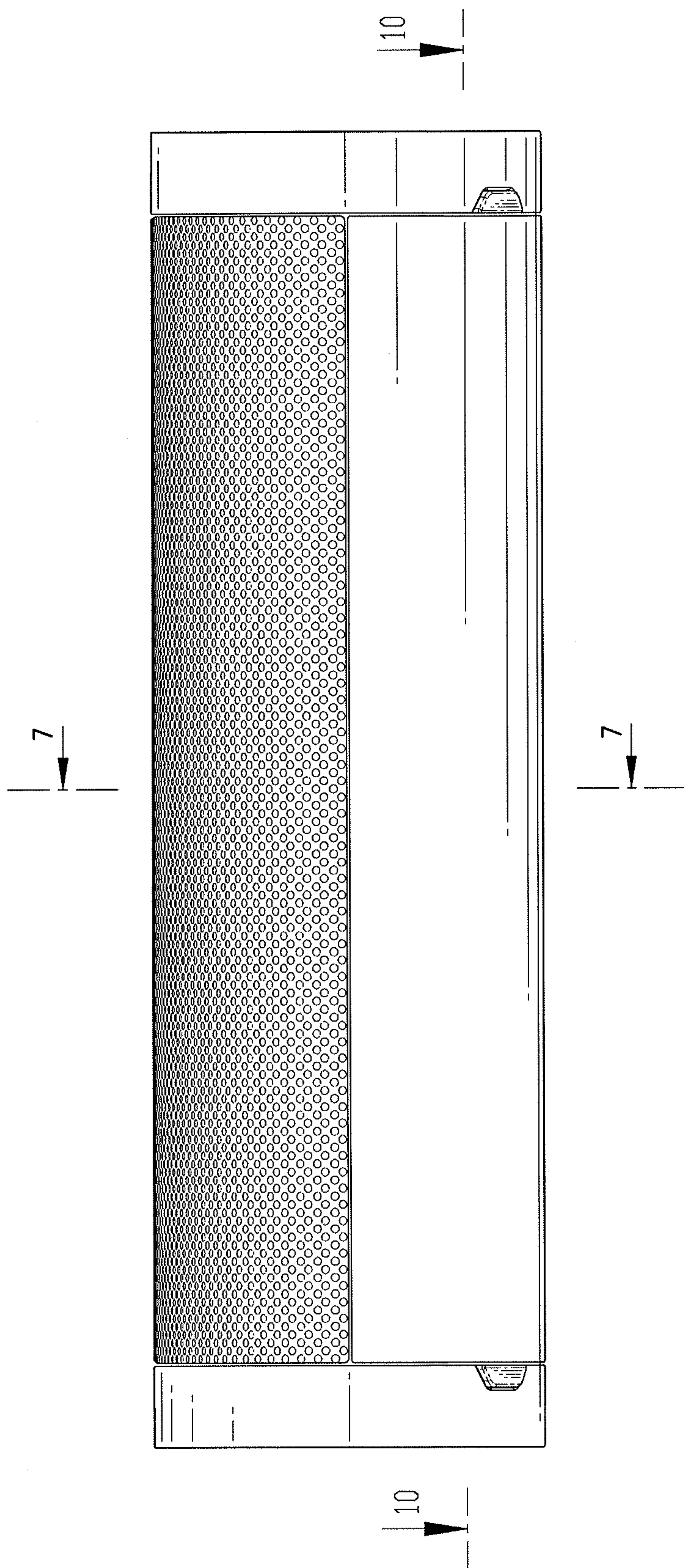

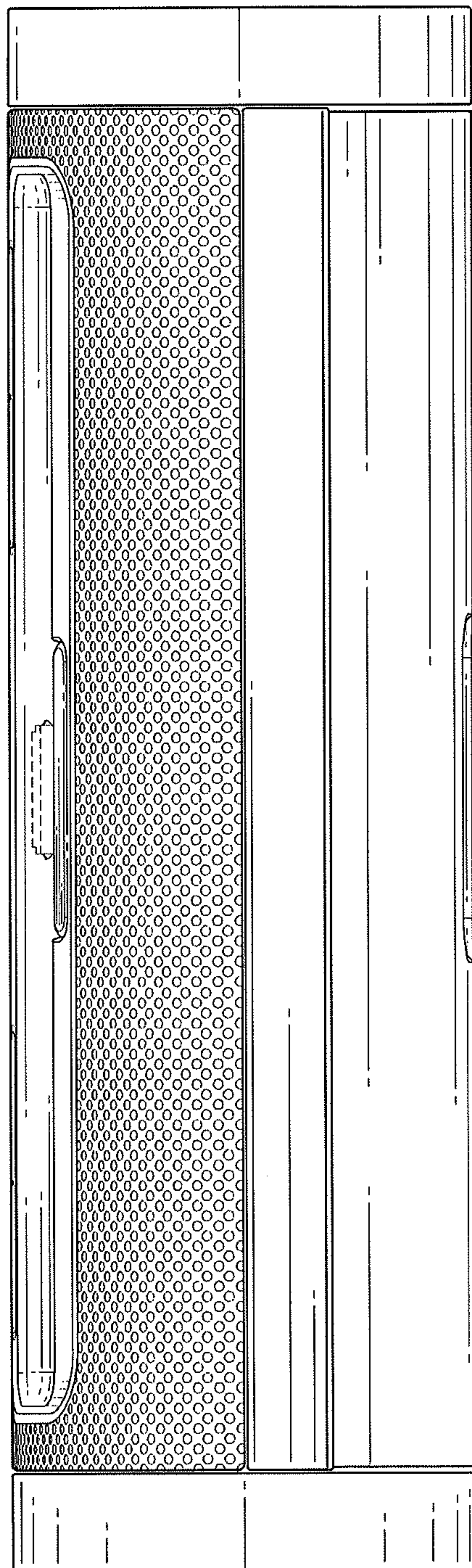

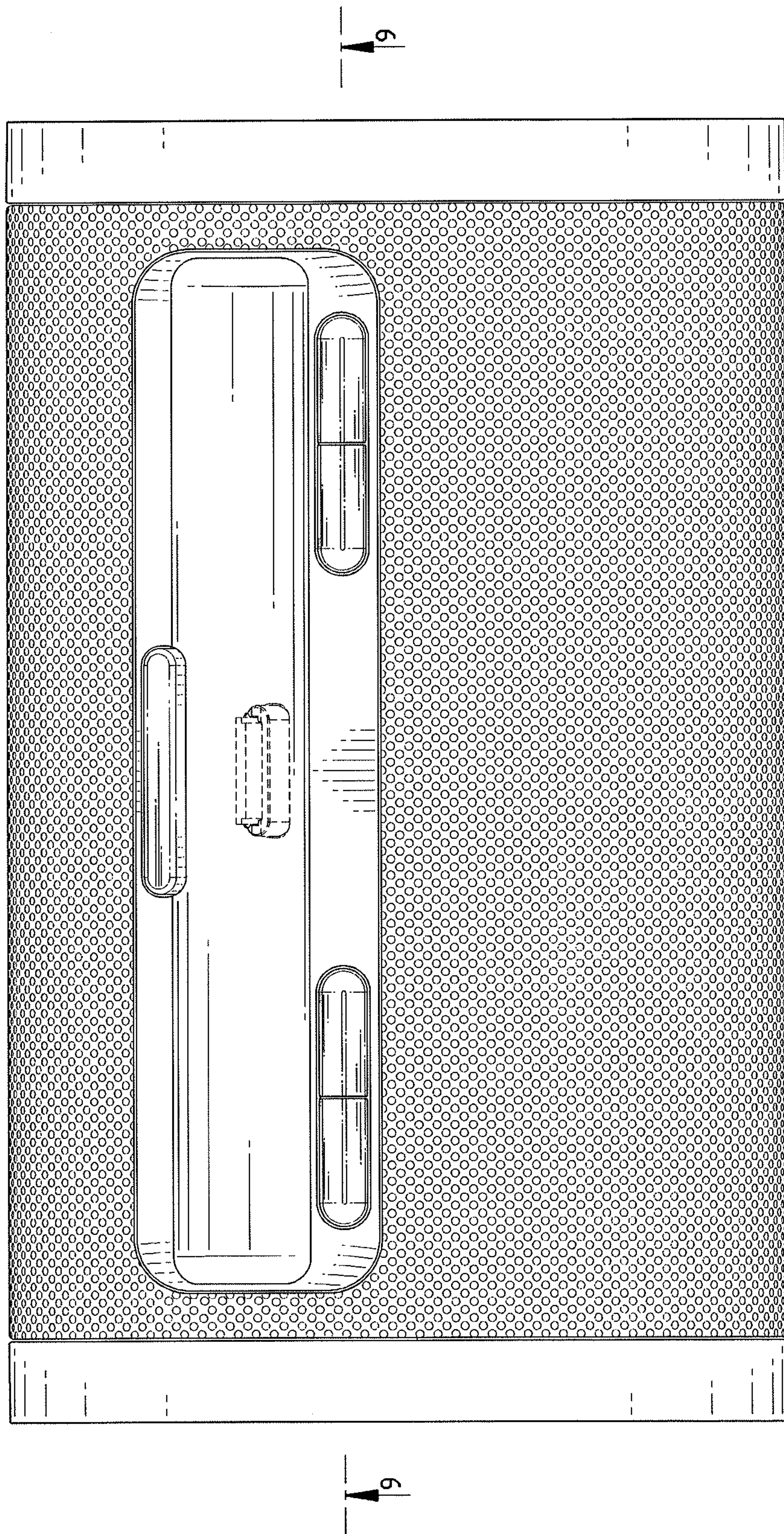

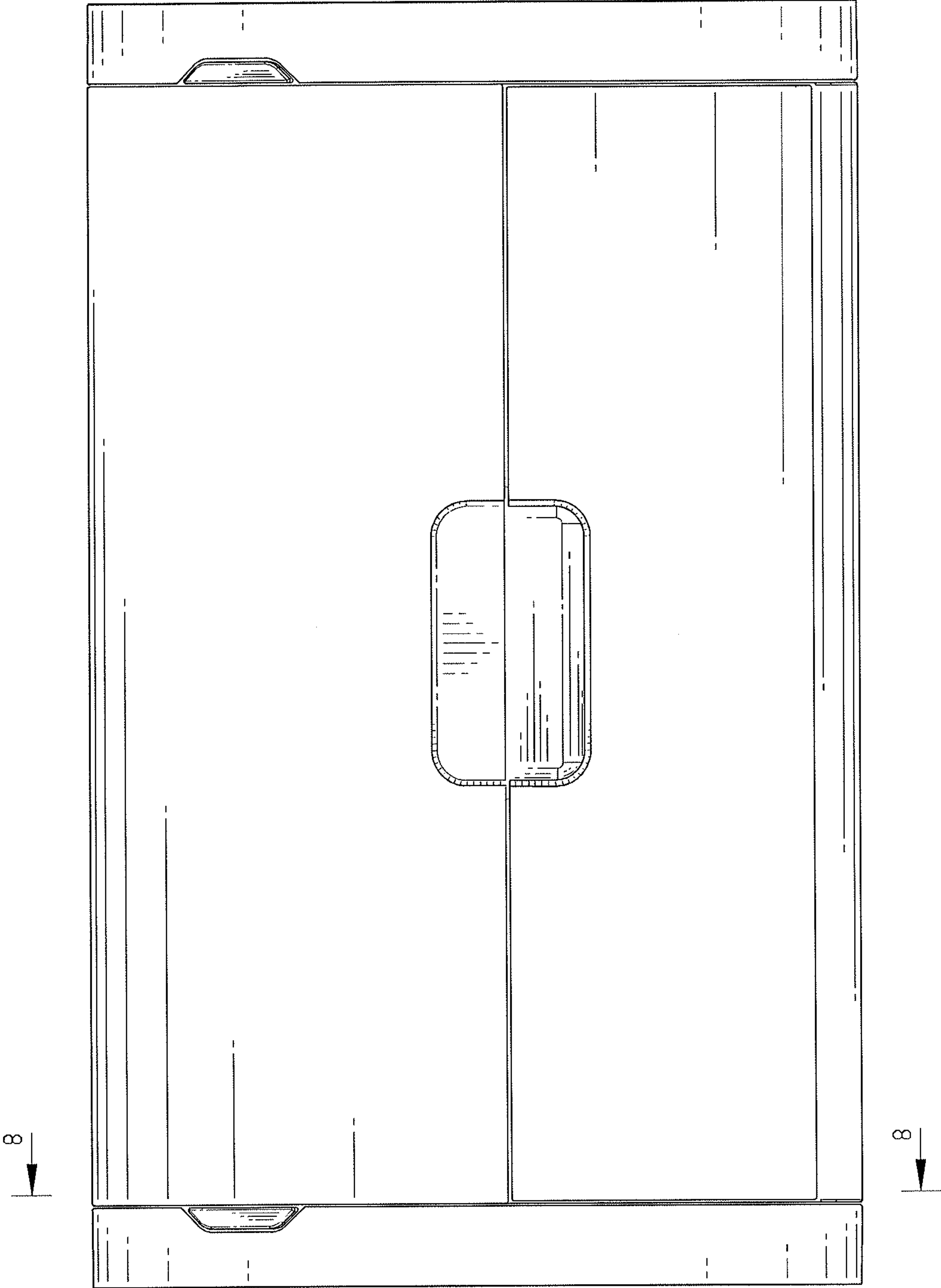

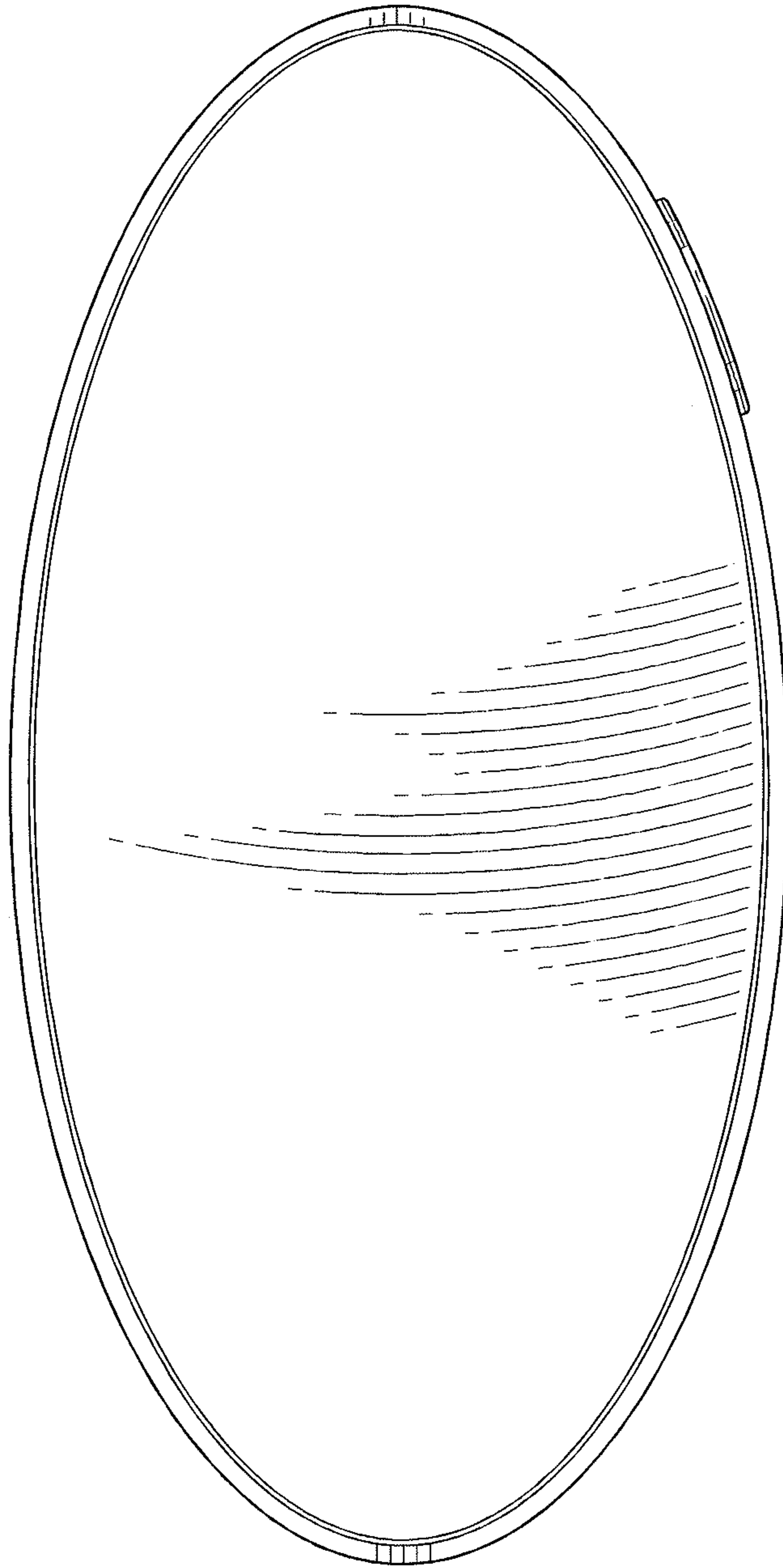

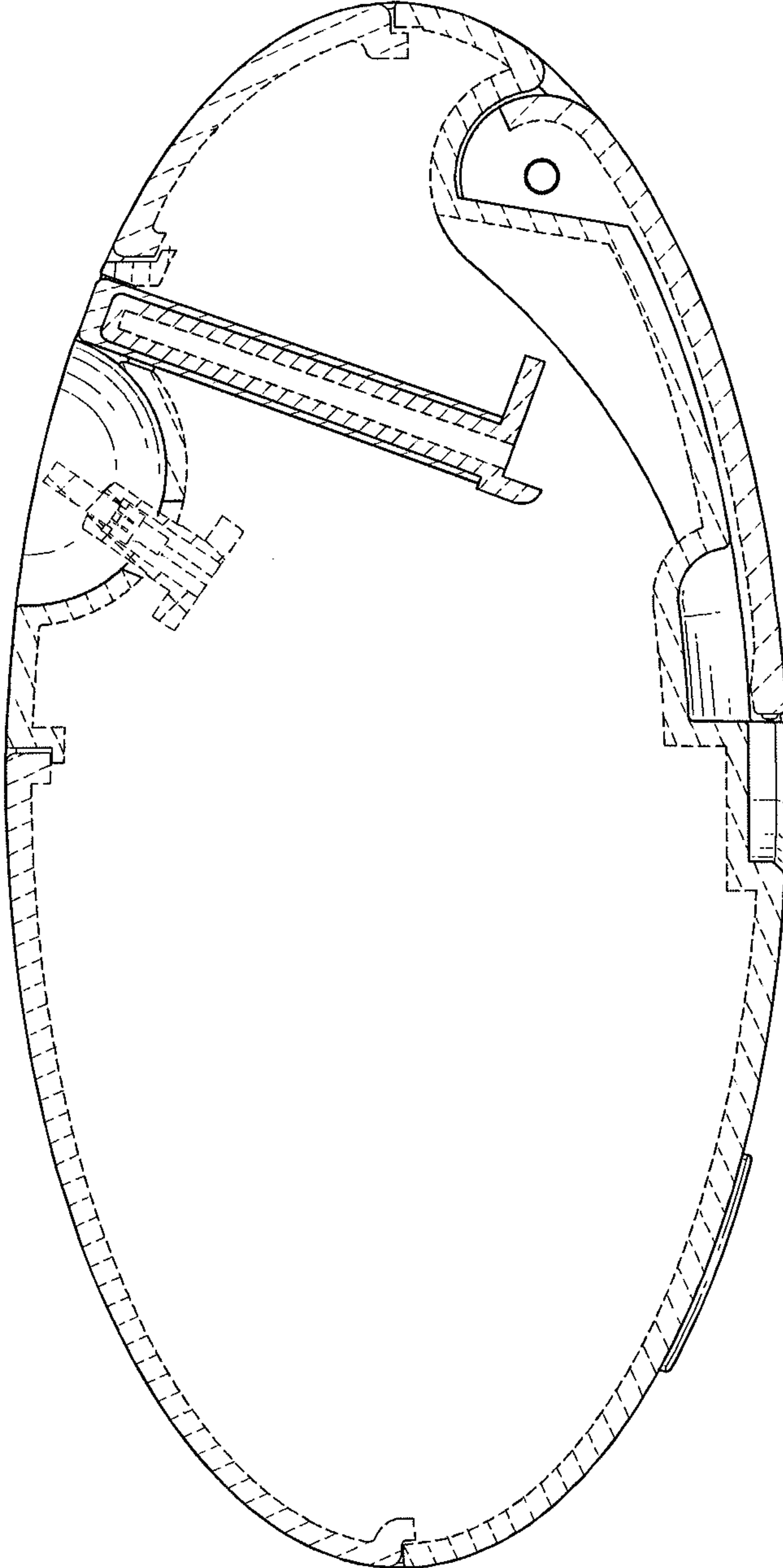

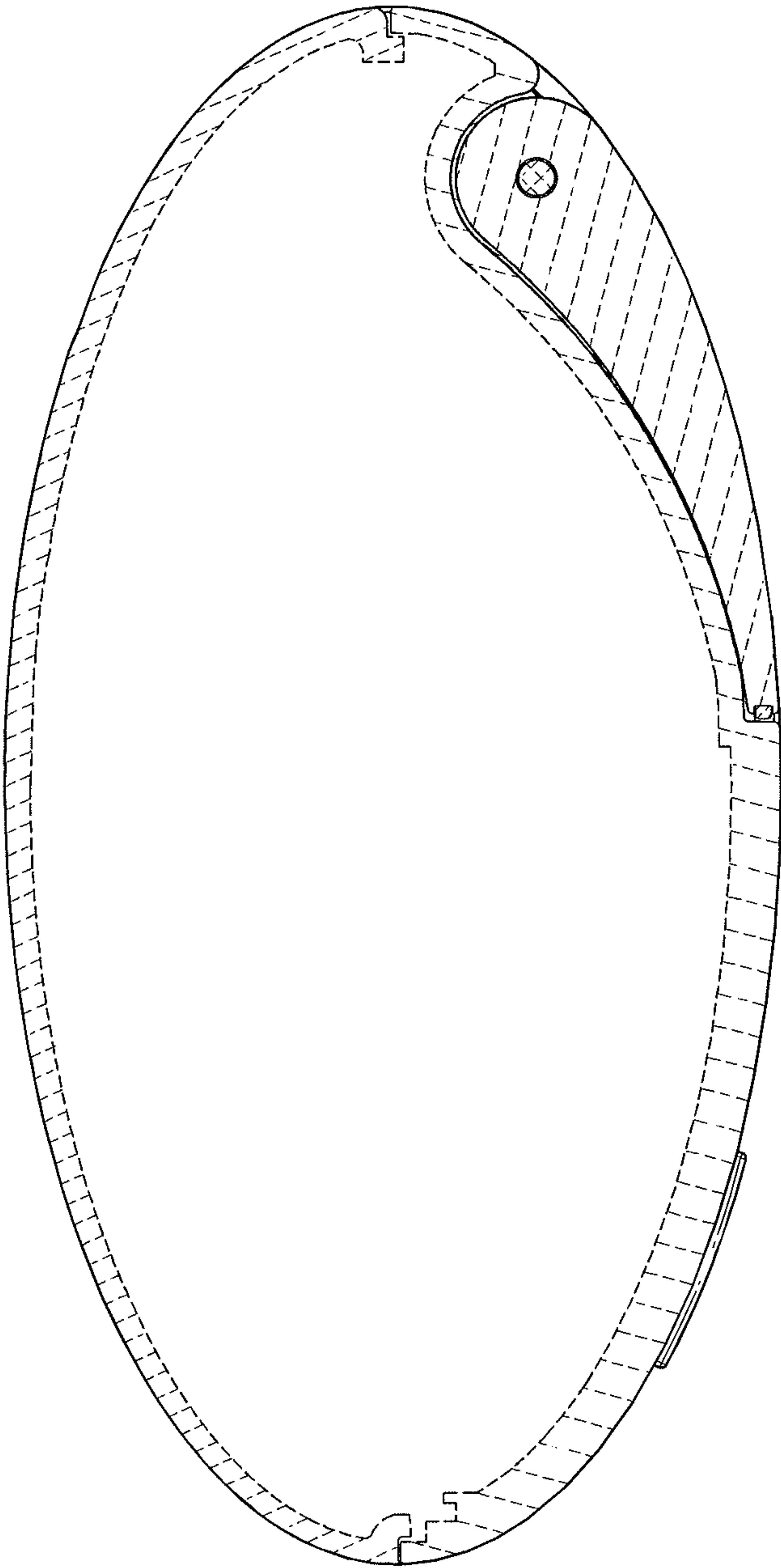

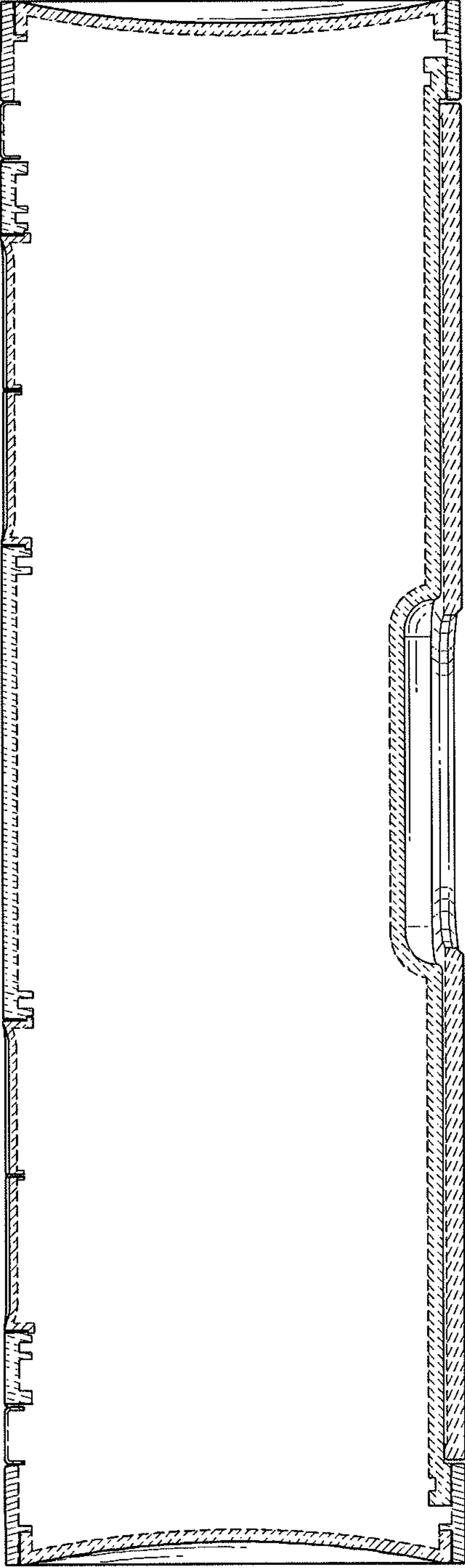

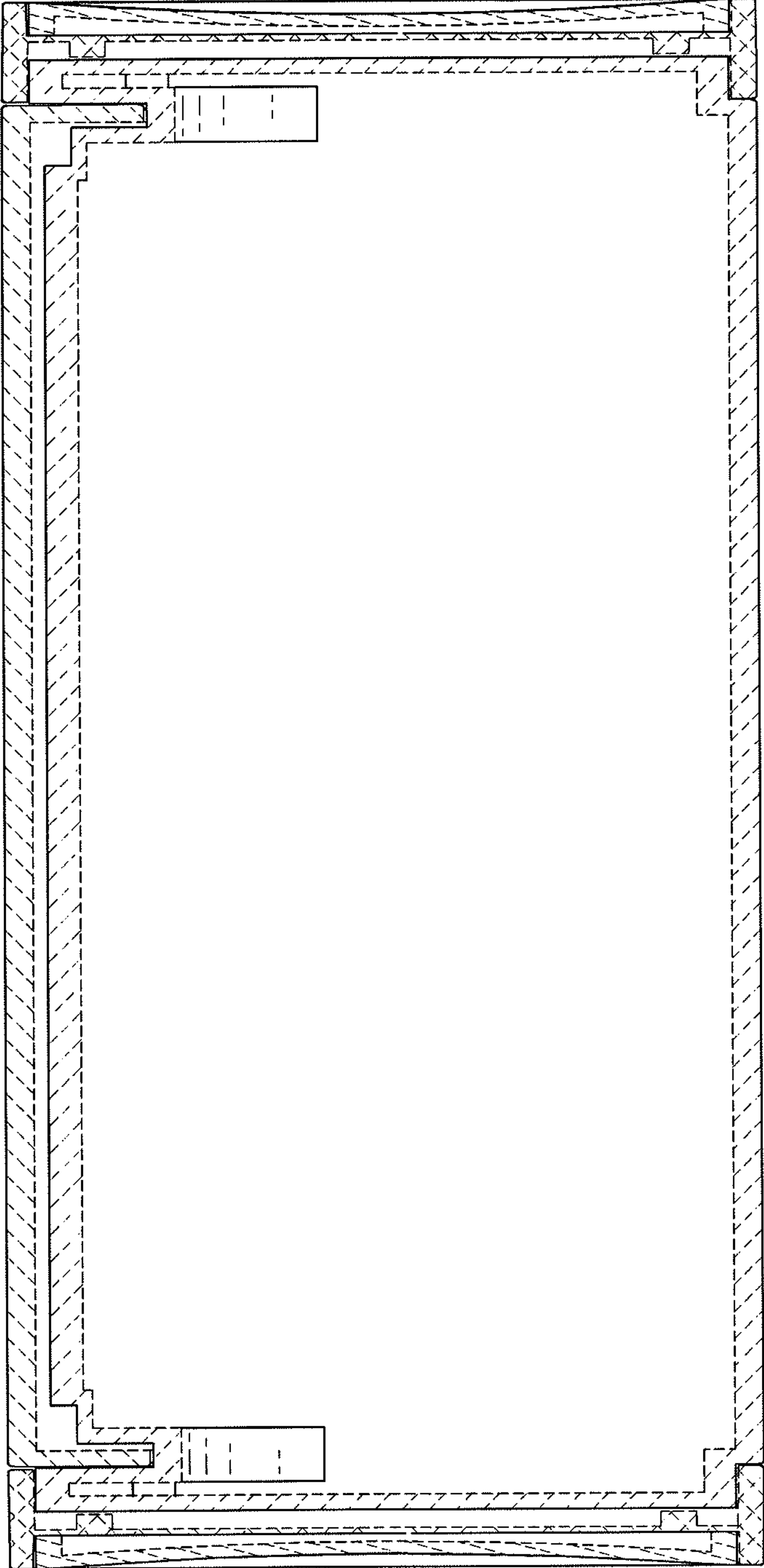

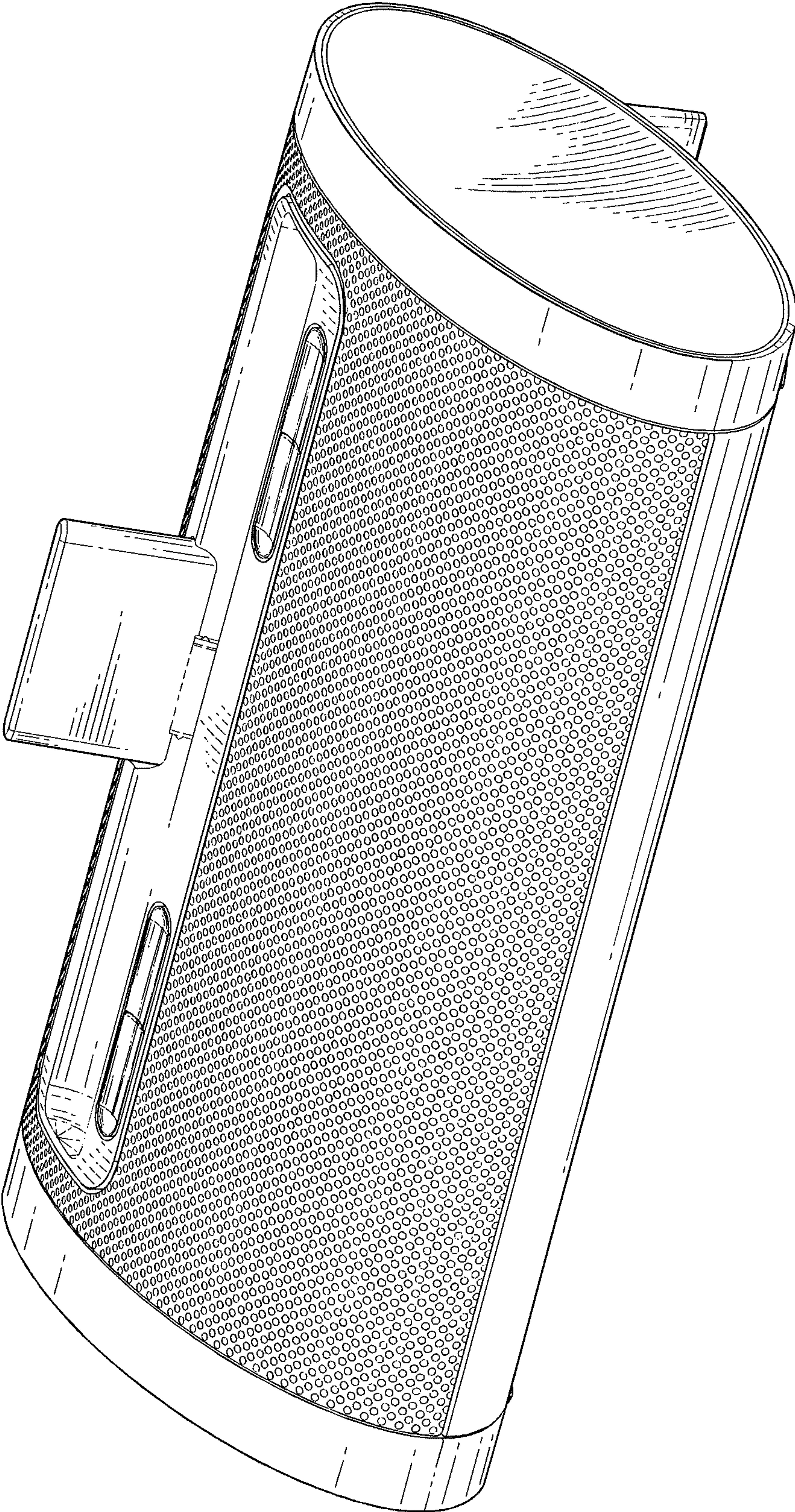

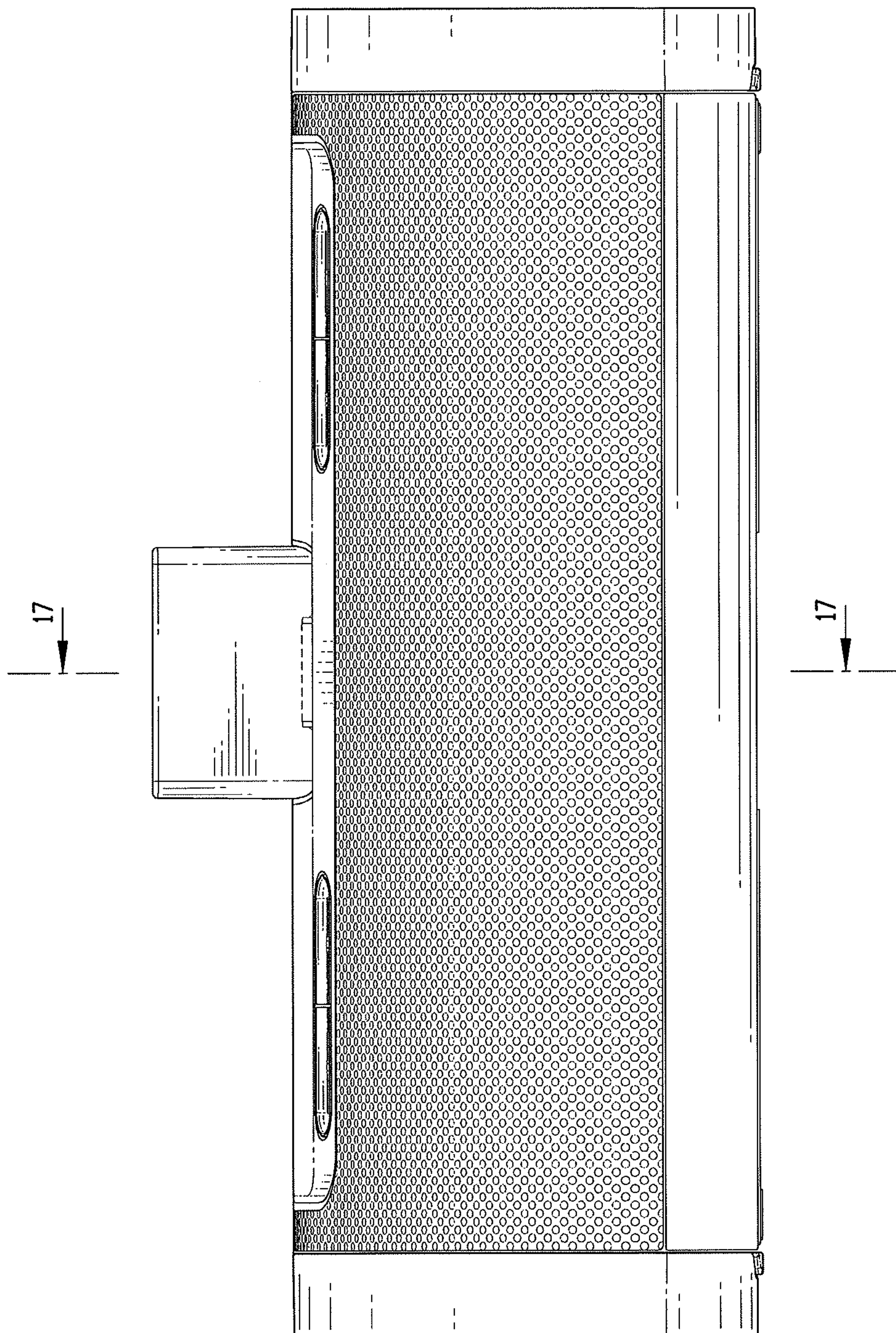

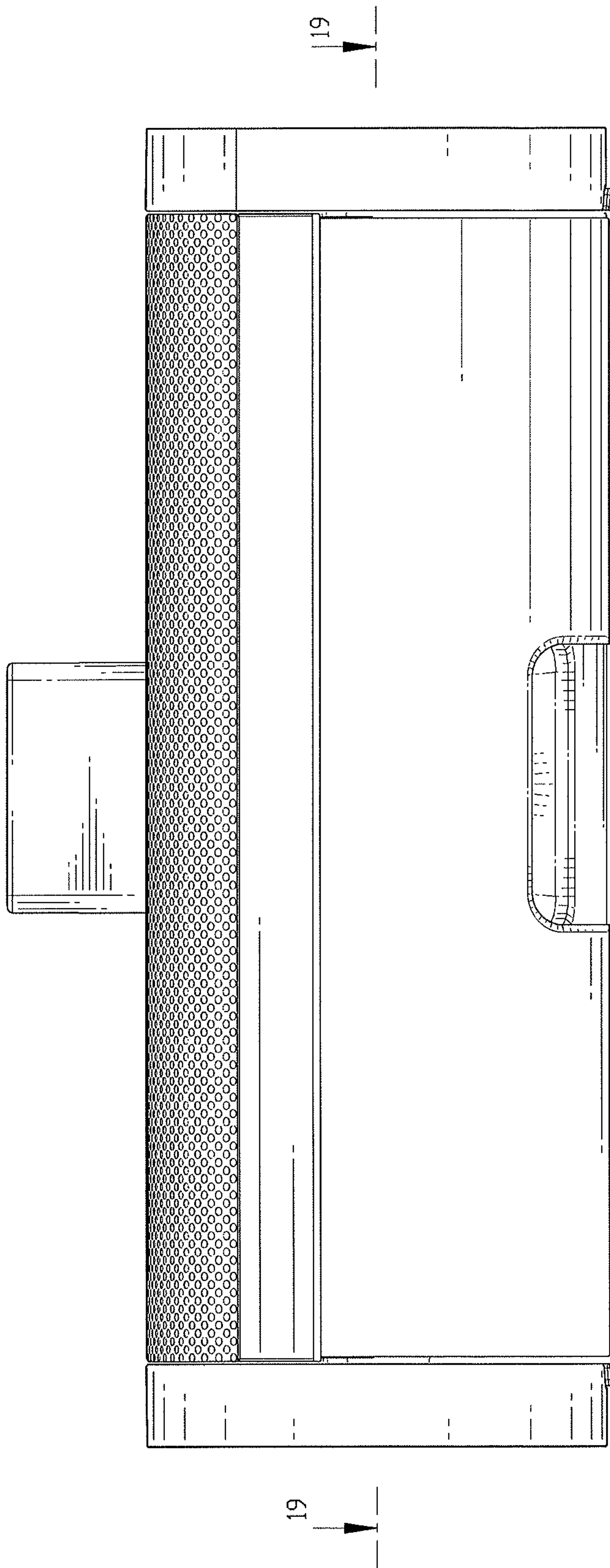

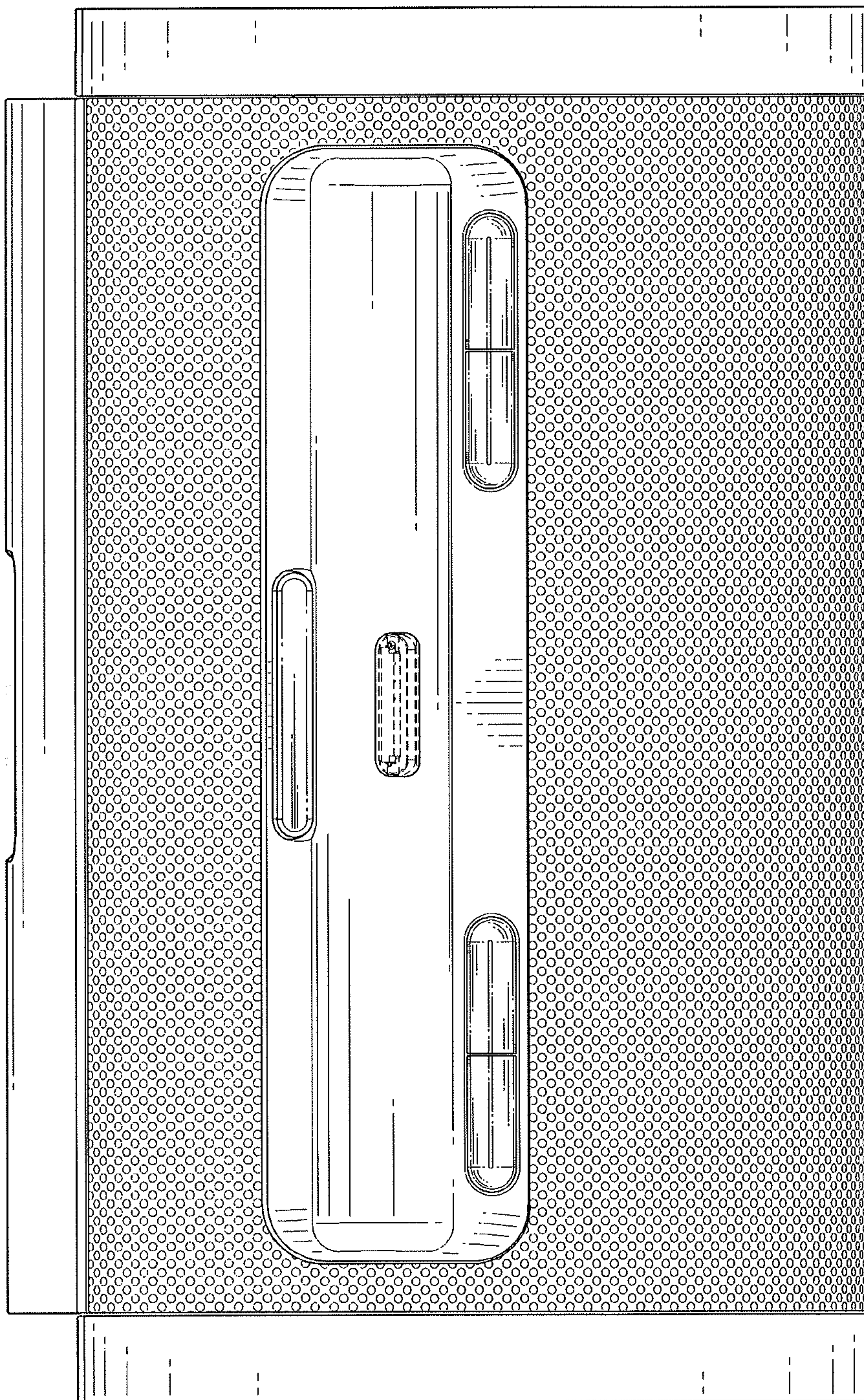

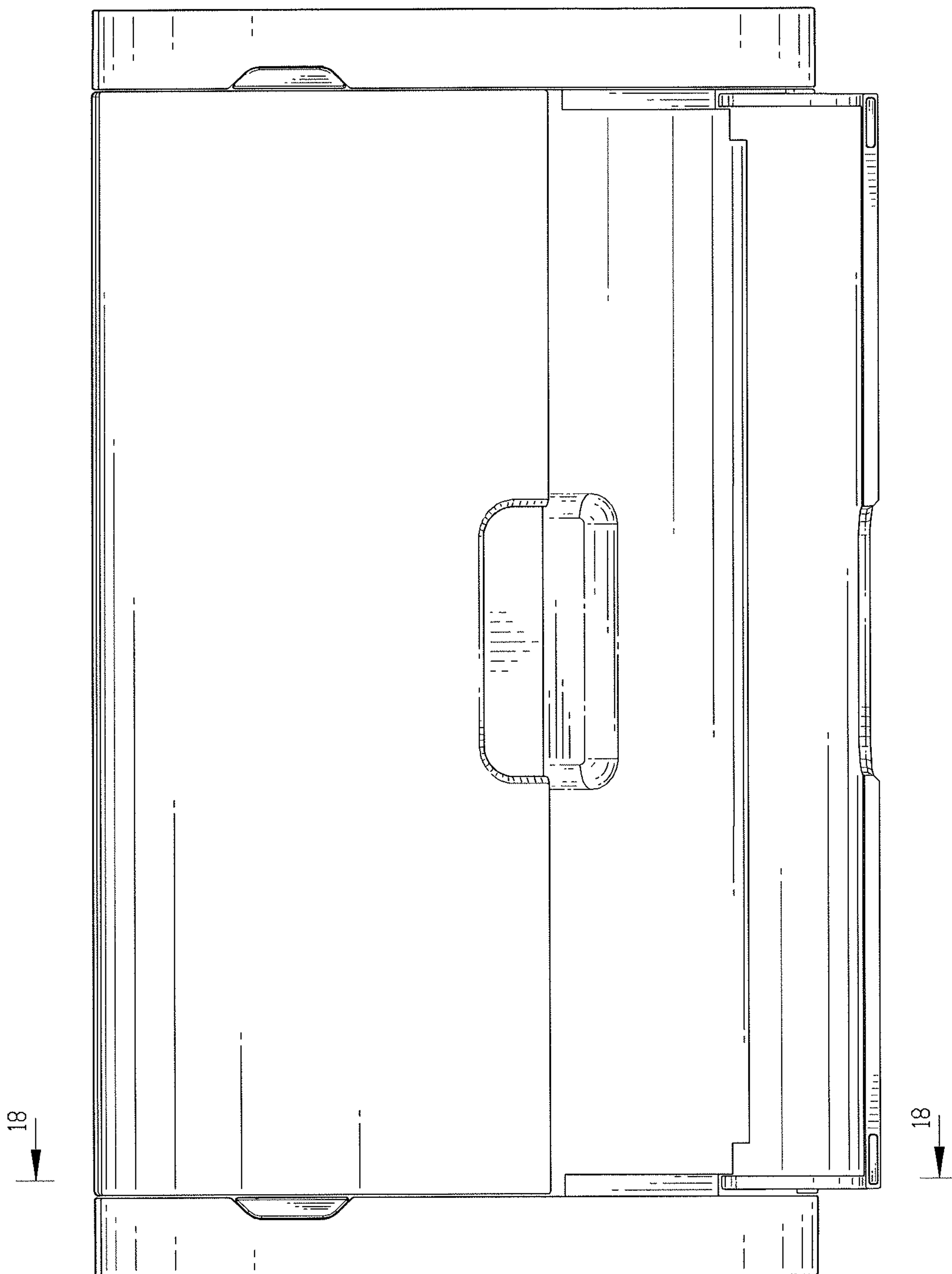

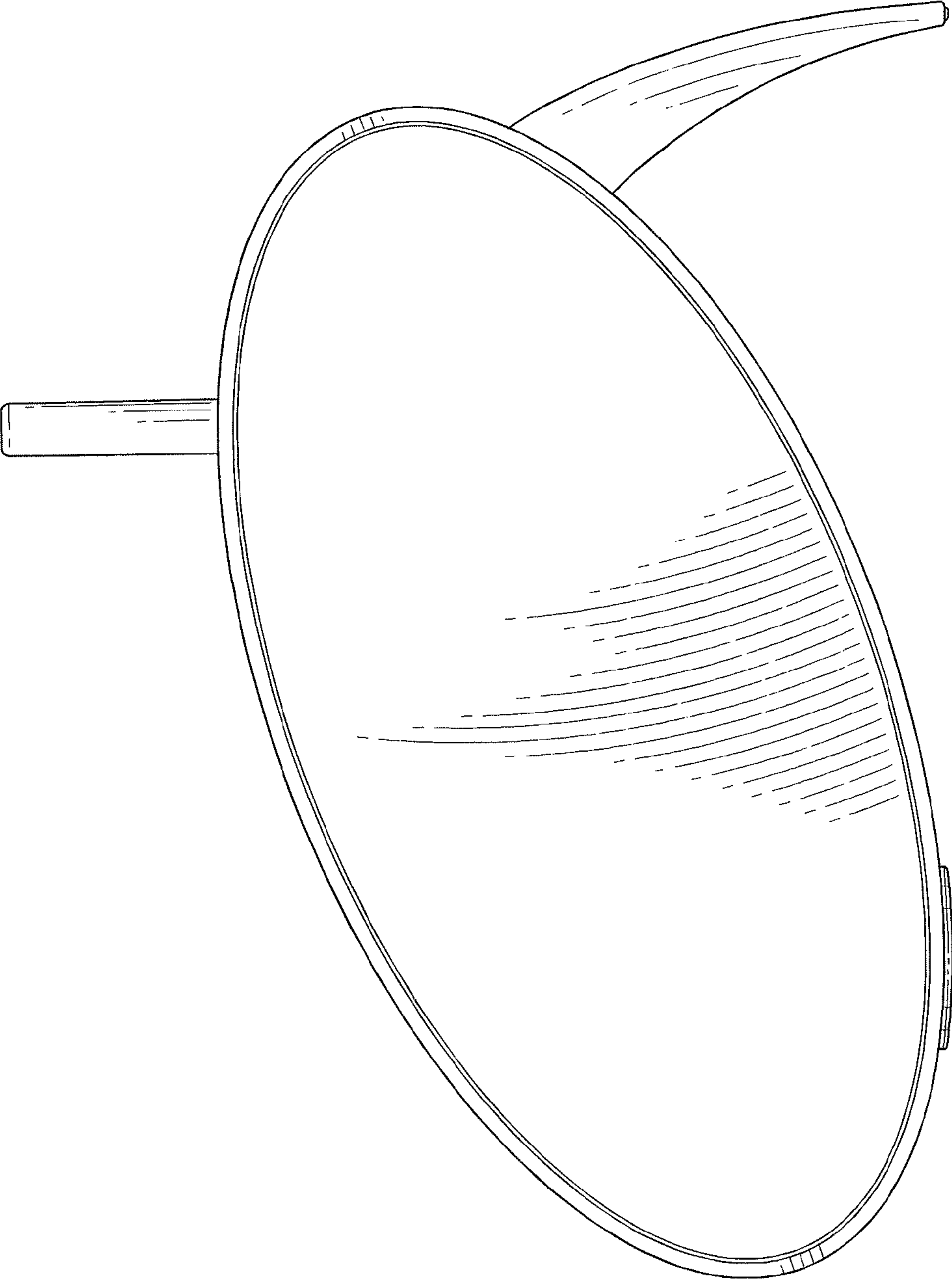

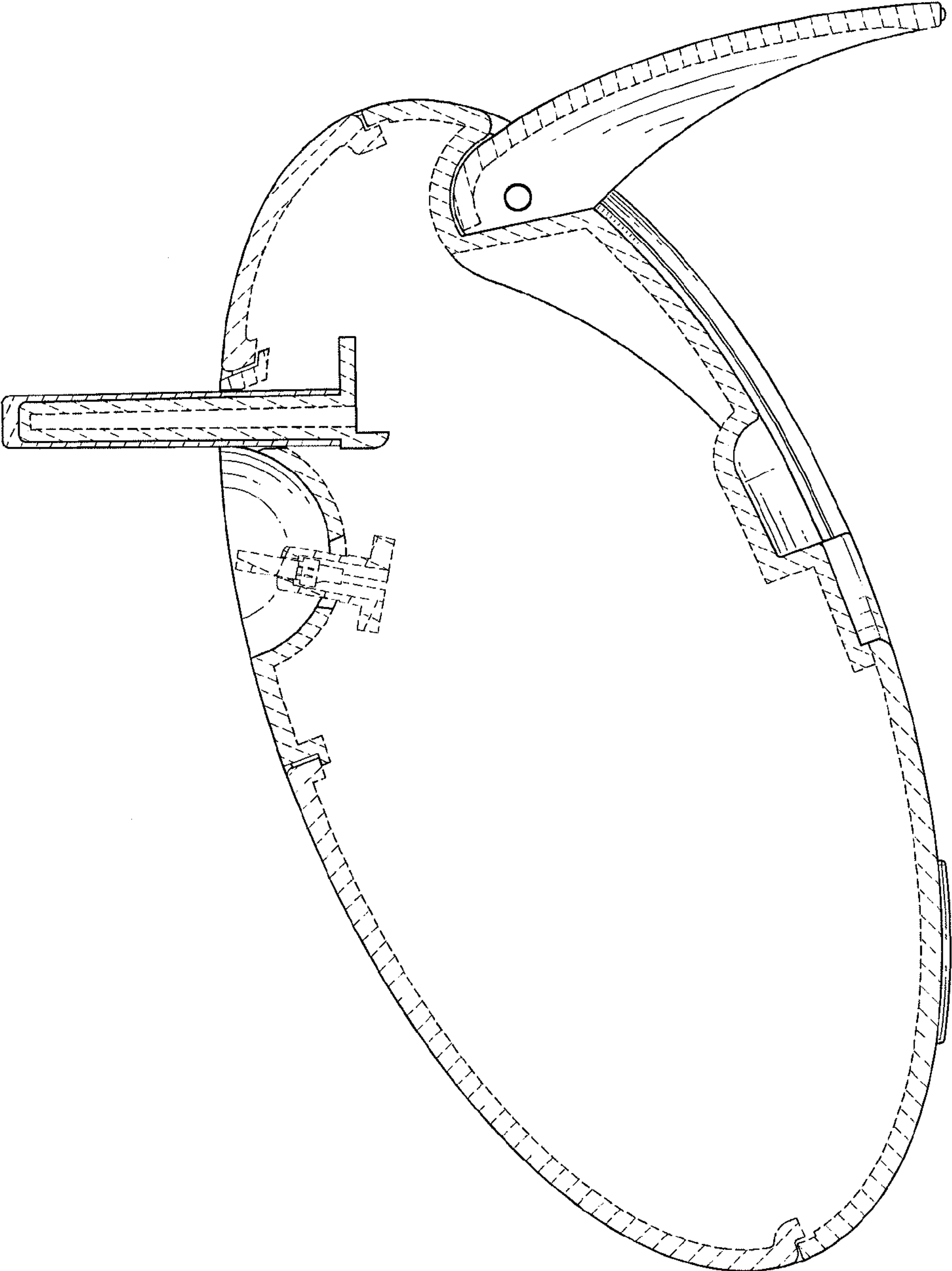

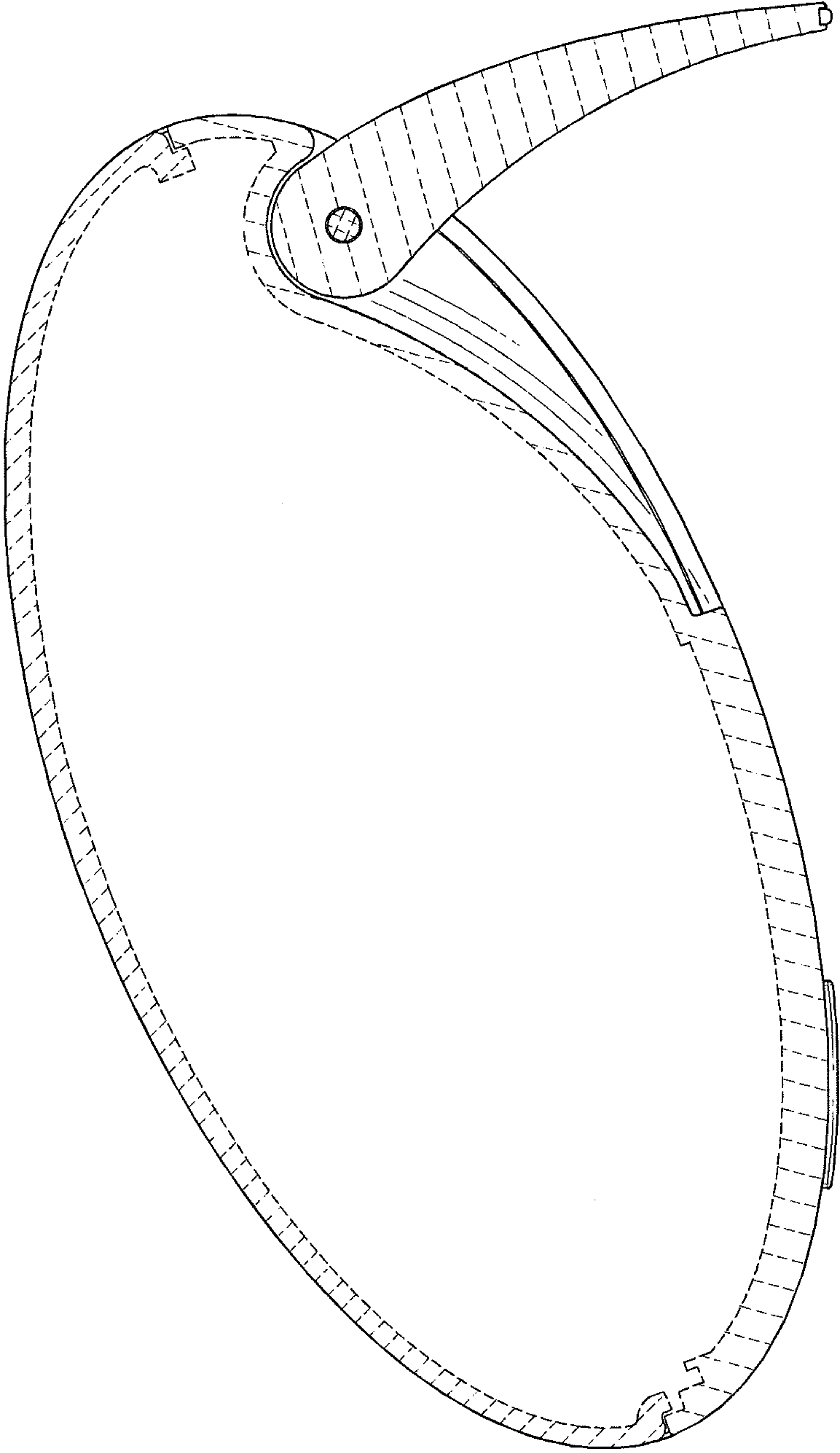

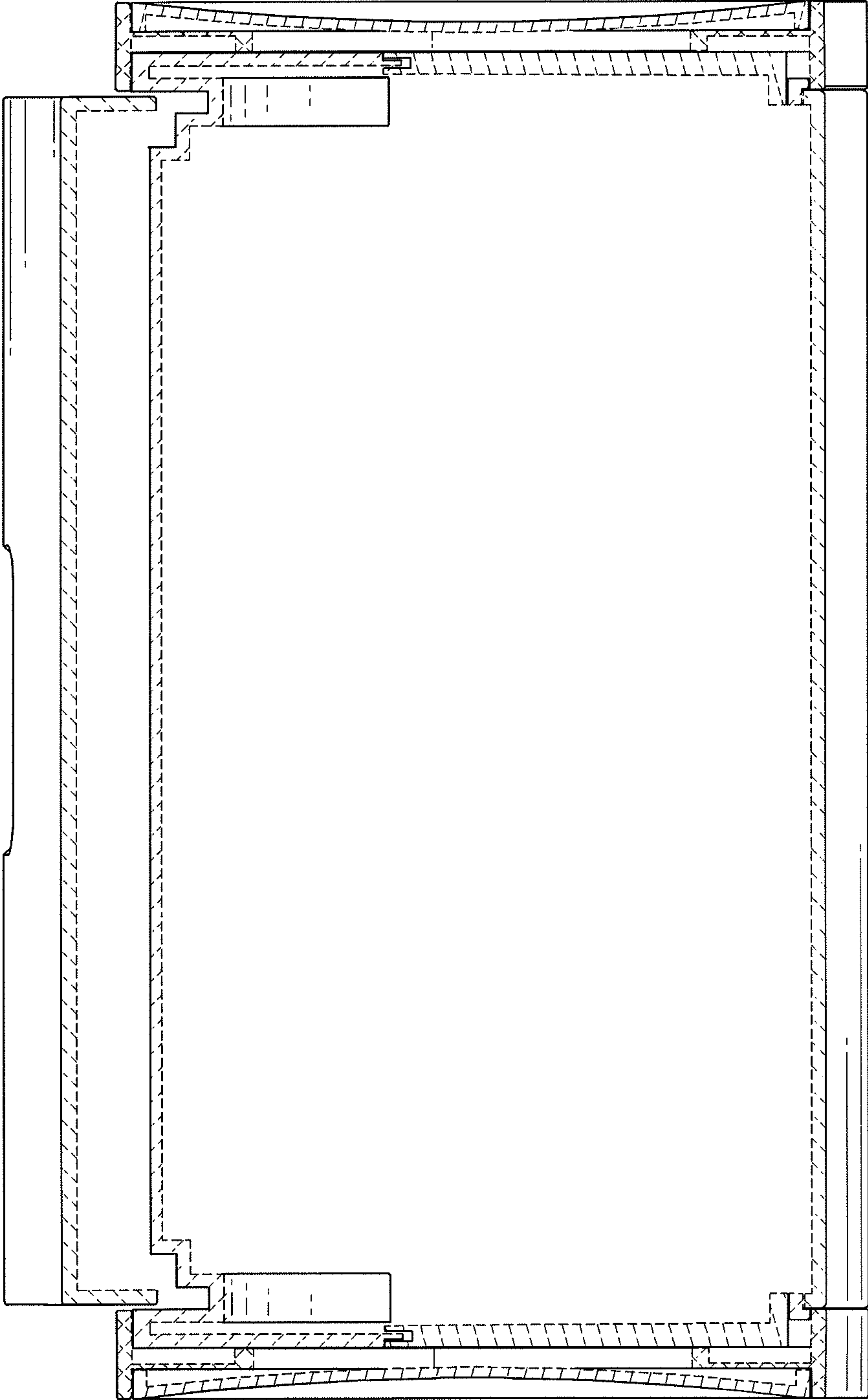

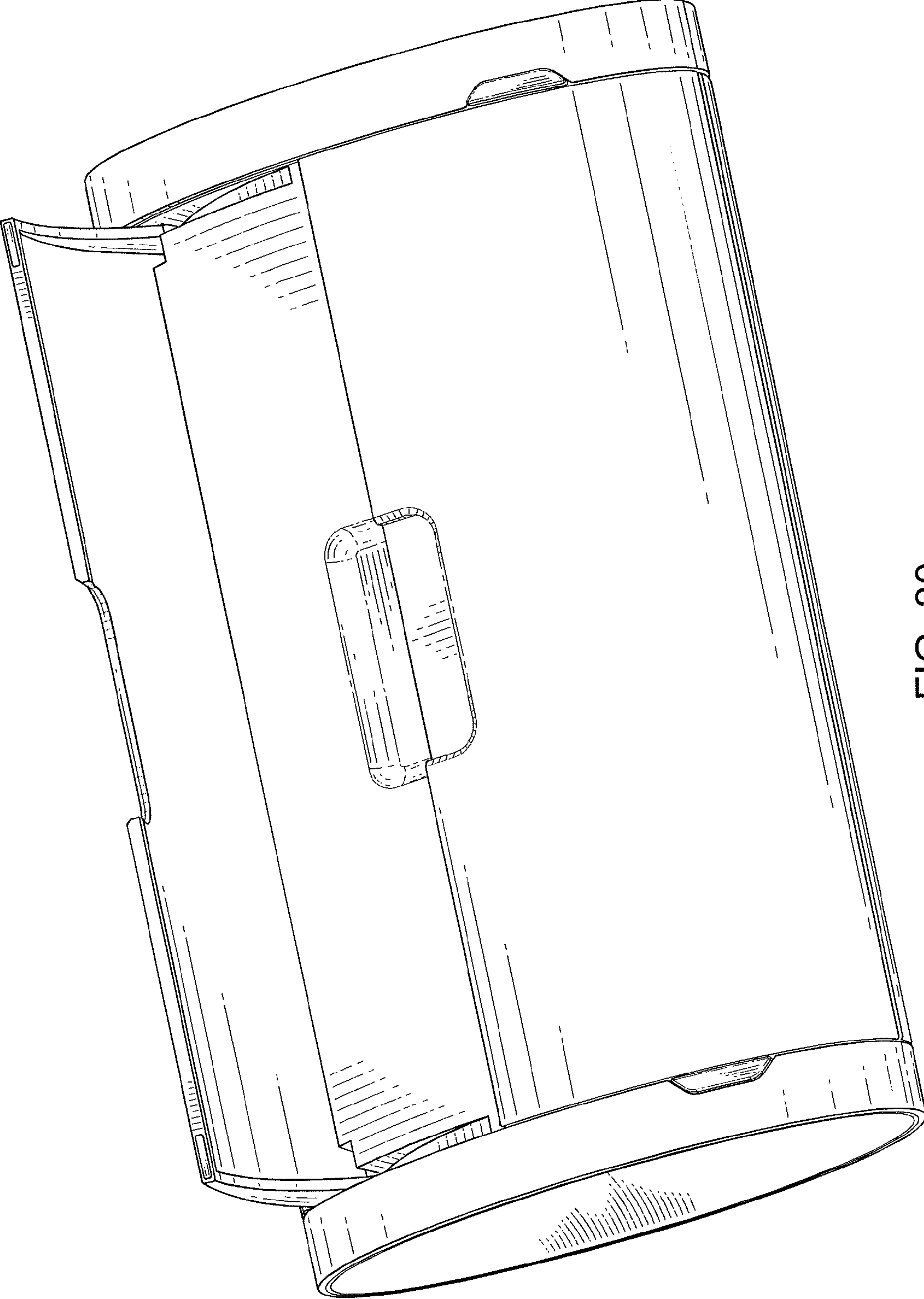
