FIG. 25 is a top view thereof;

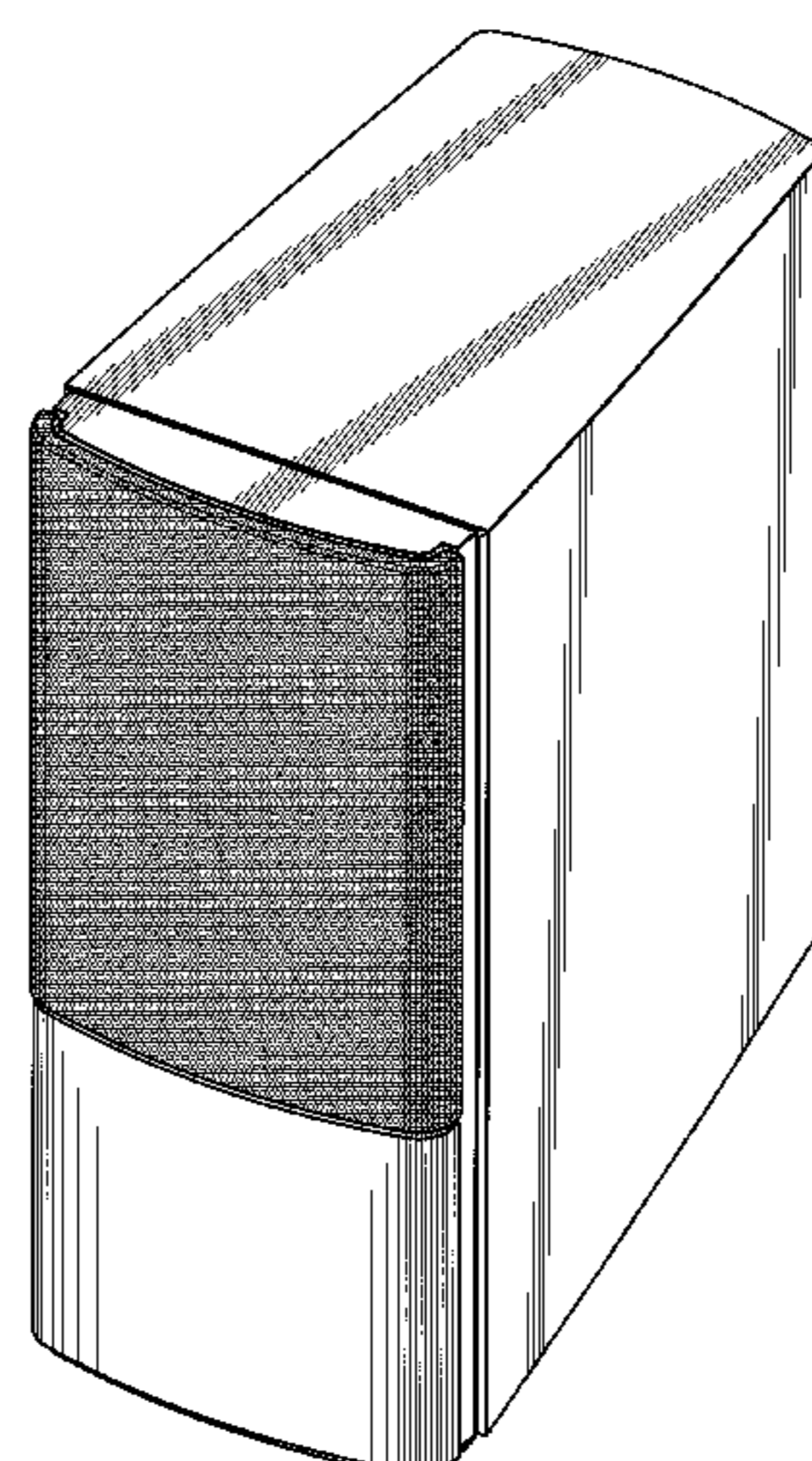
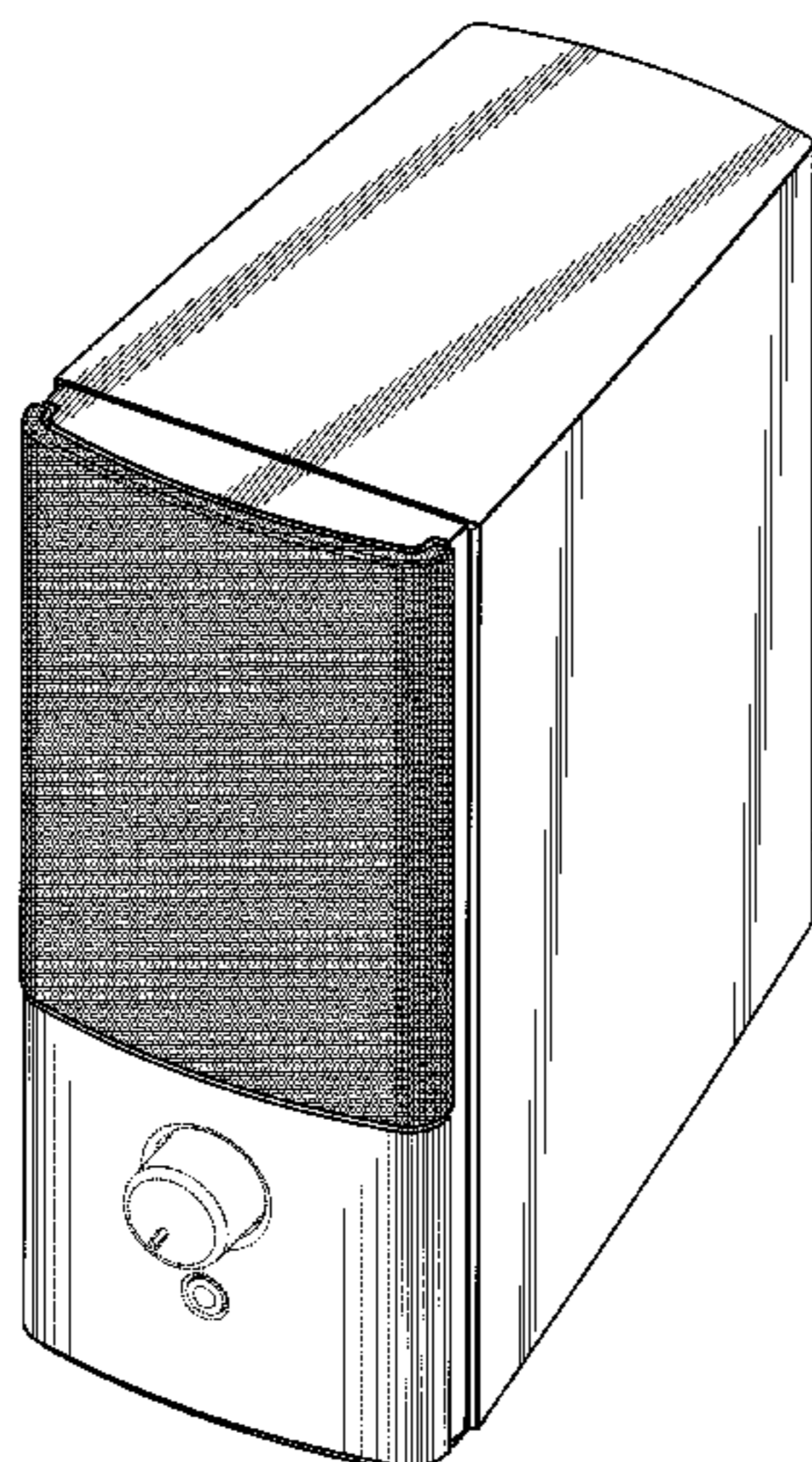

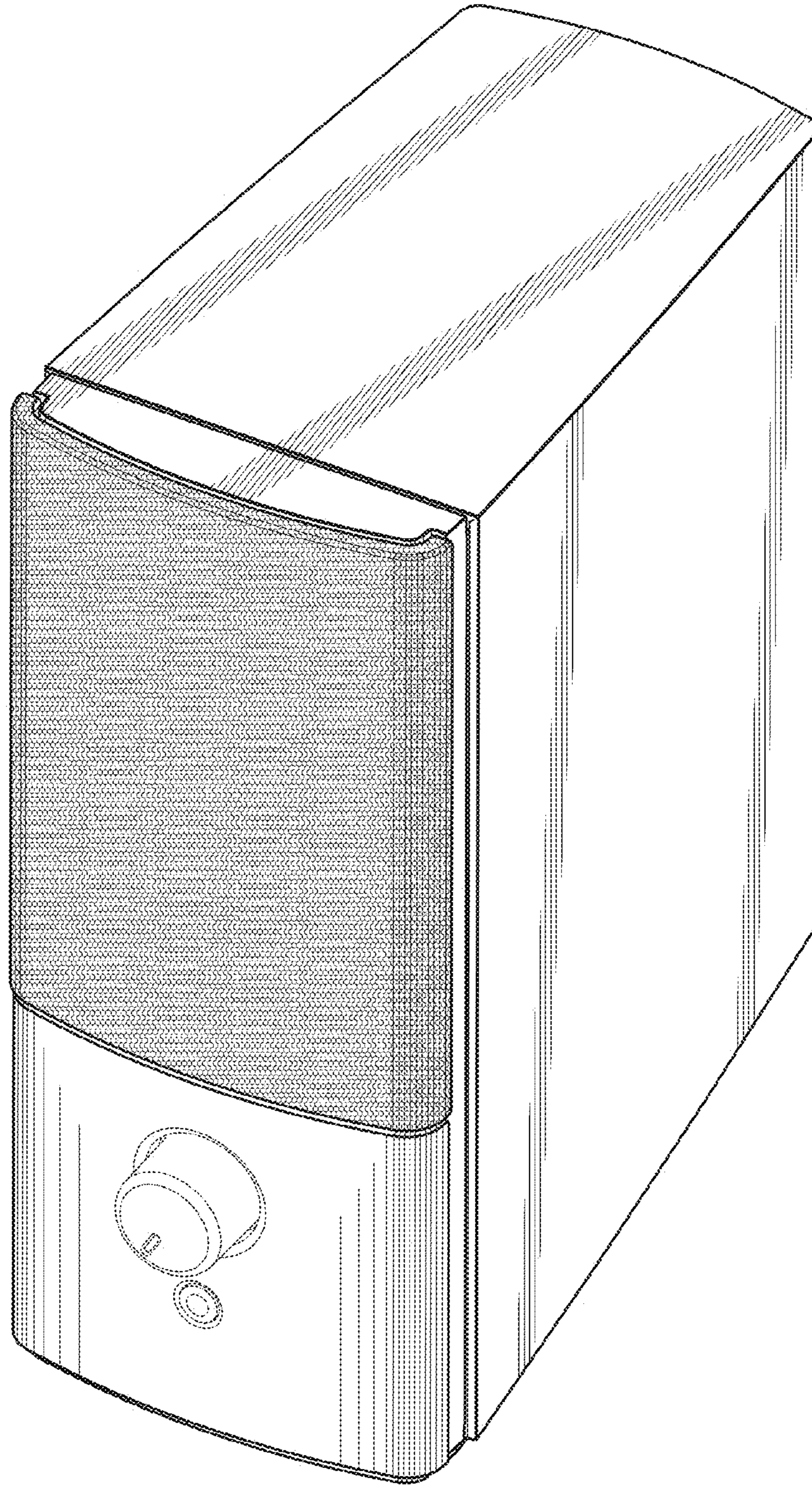

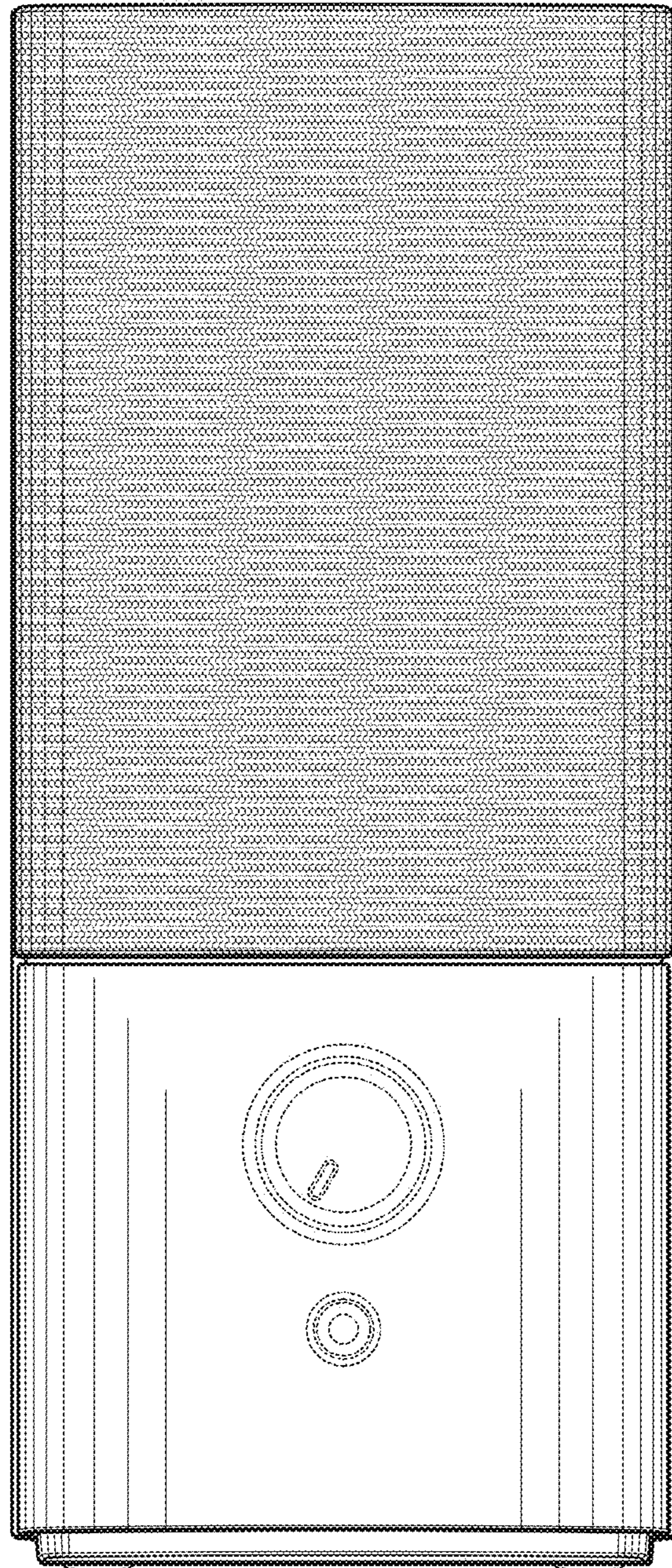

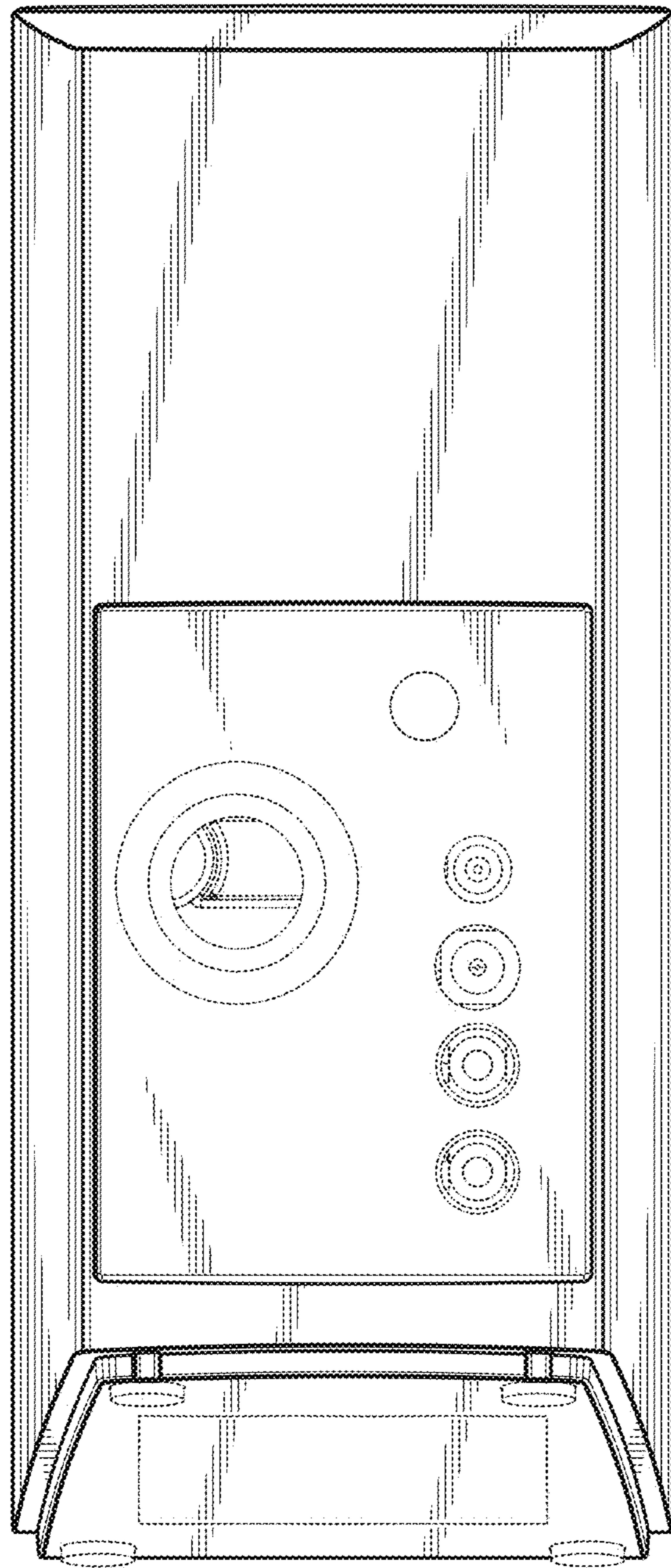

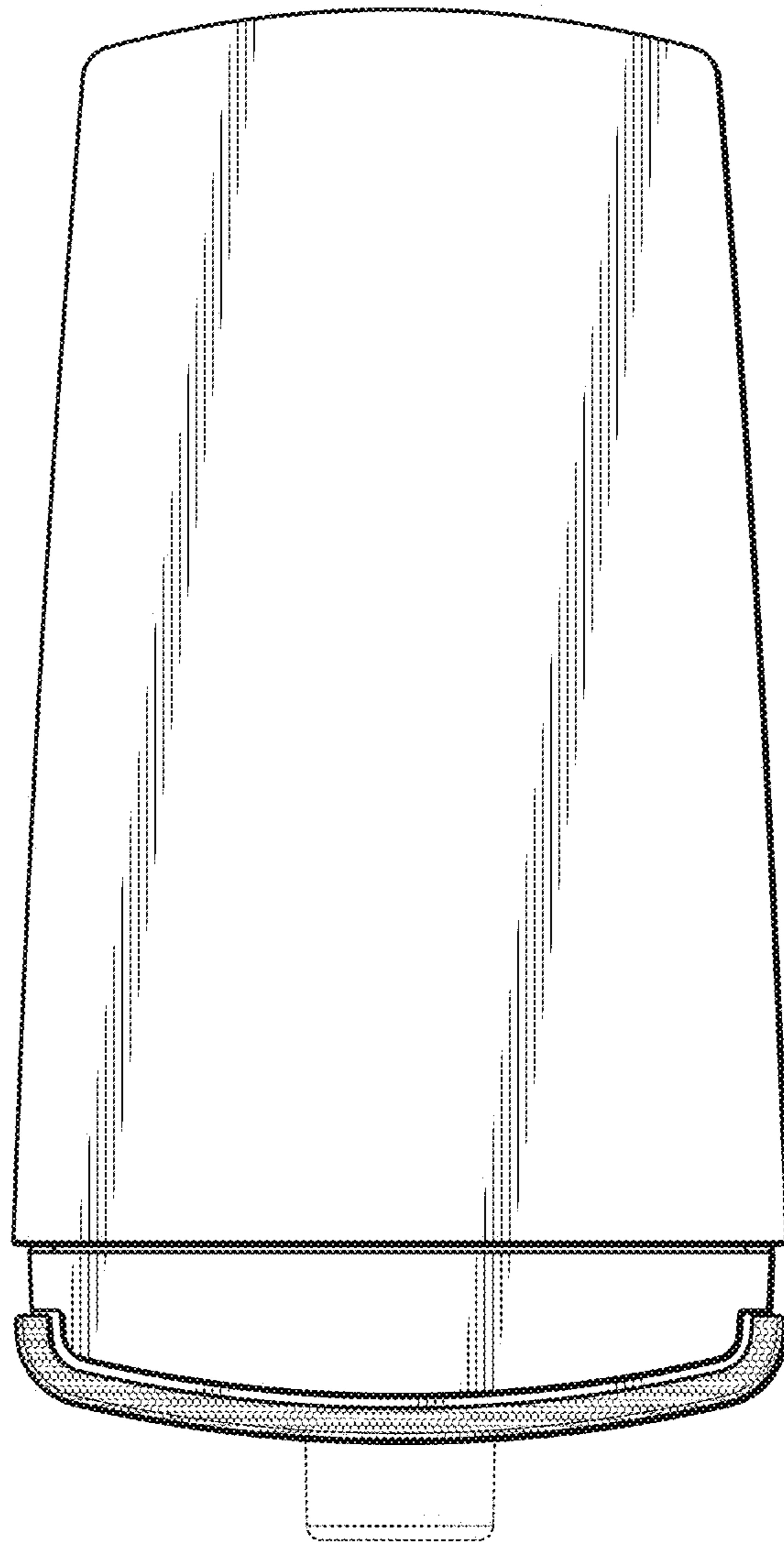

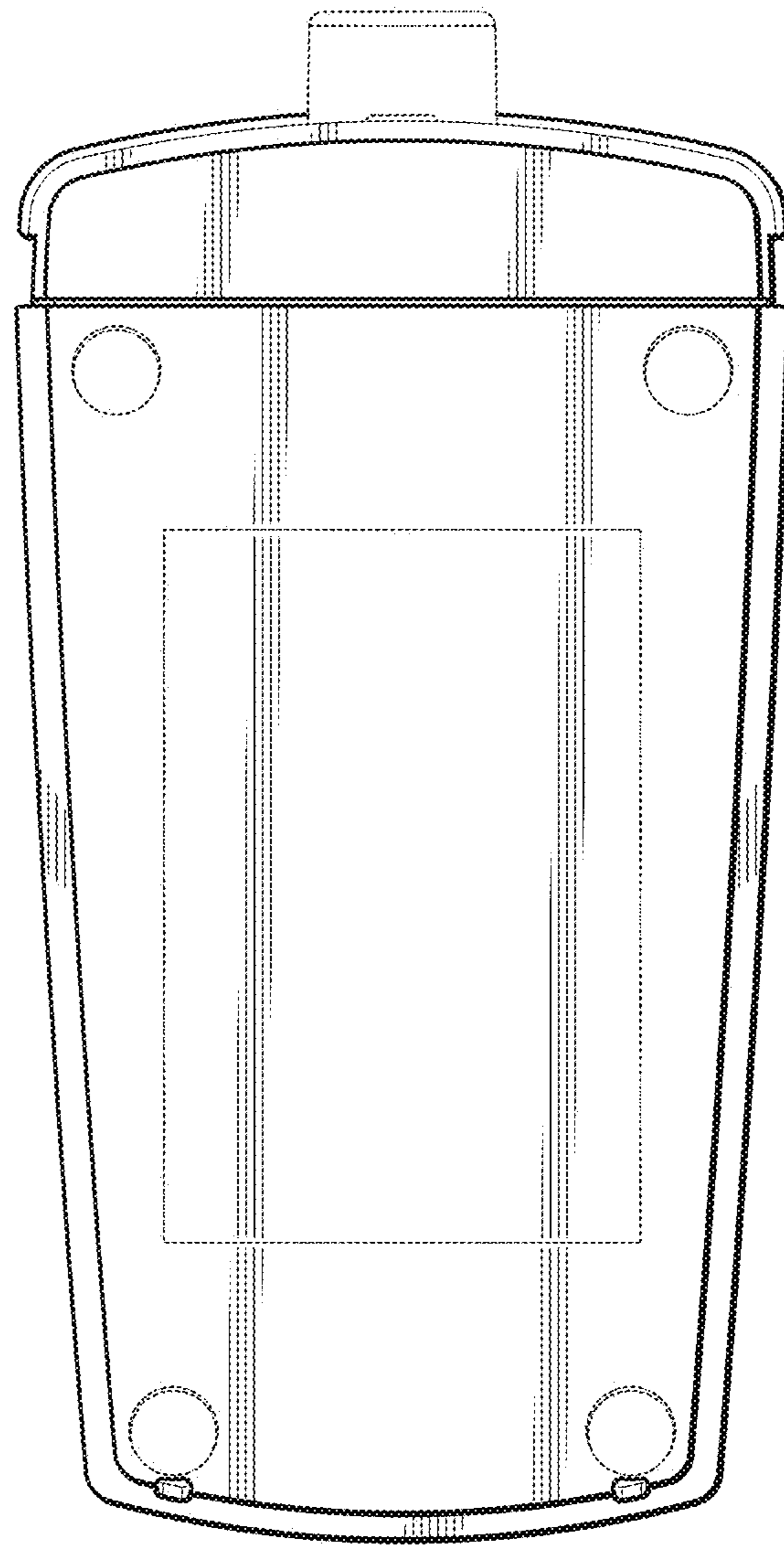

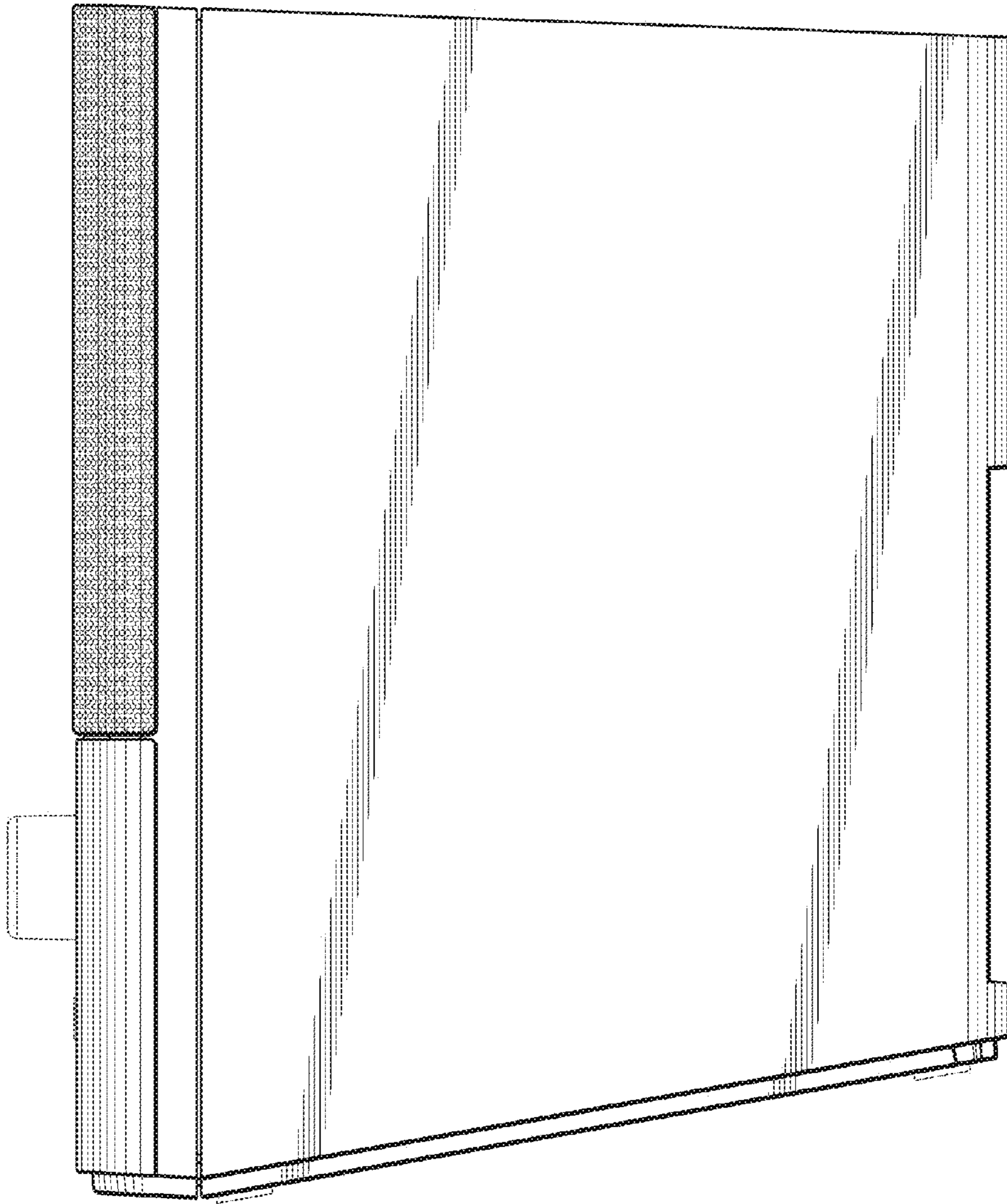

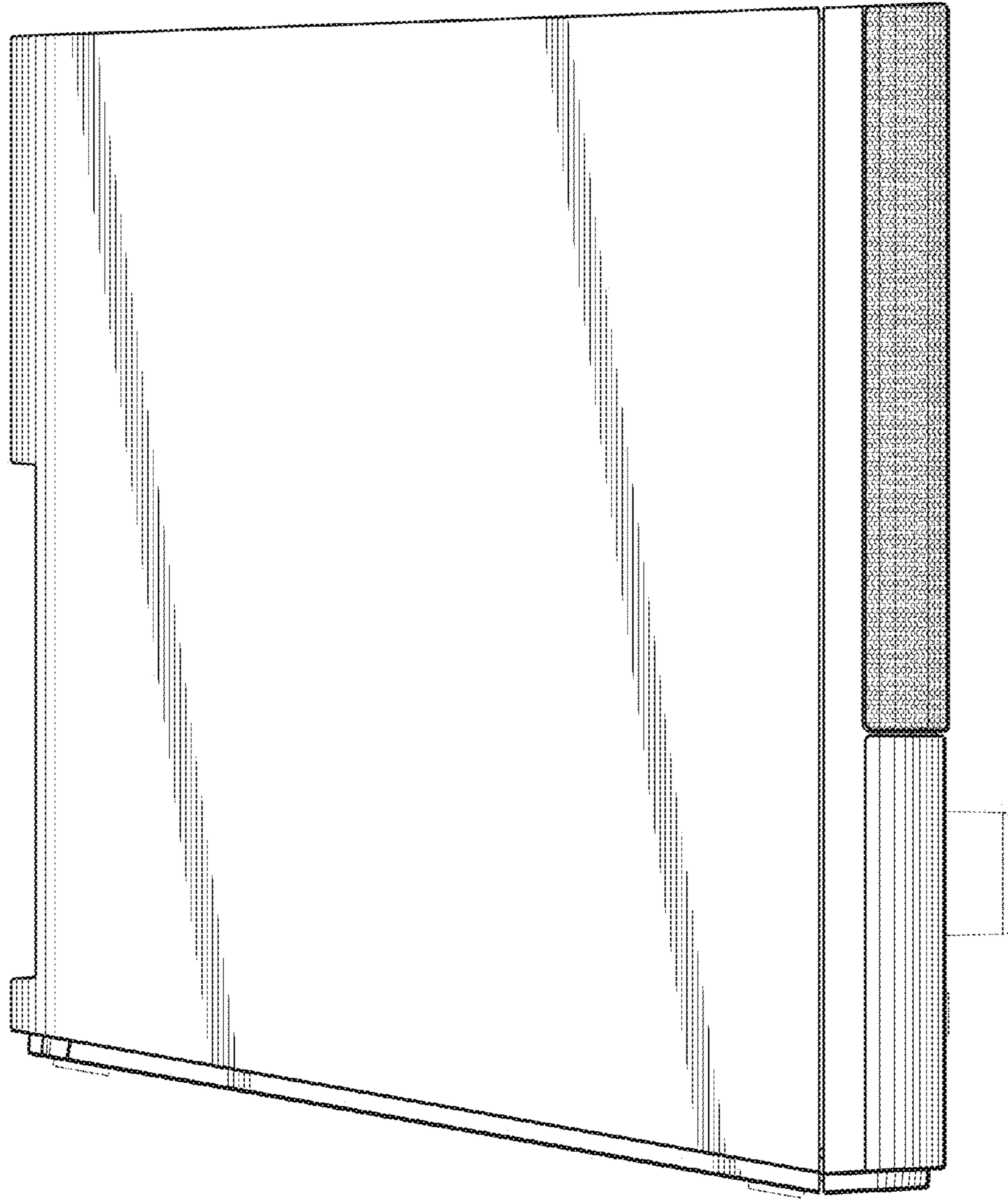

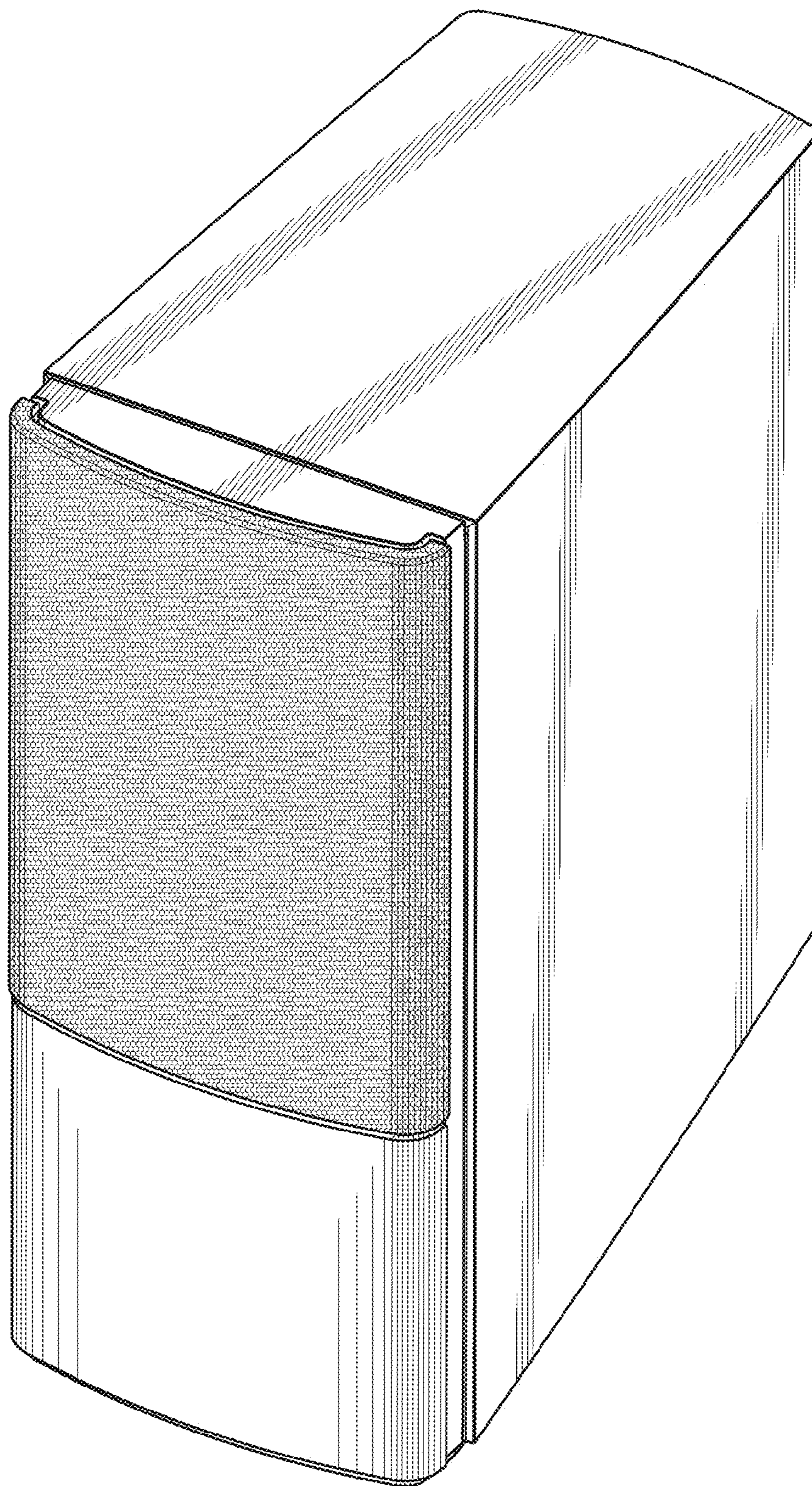

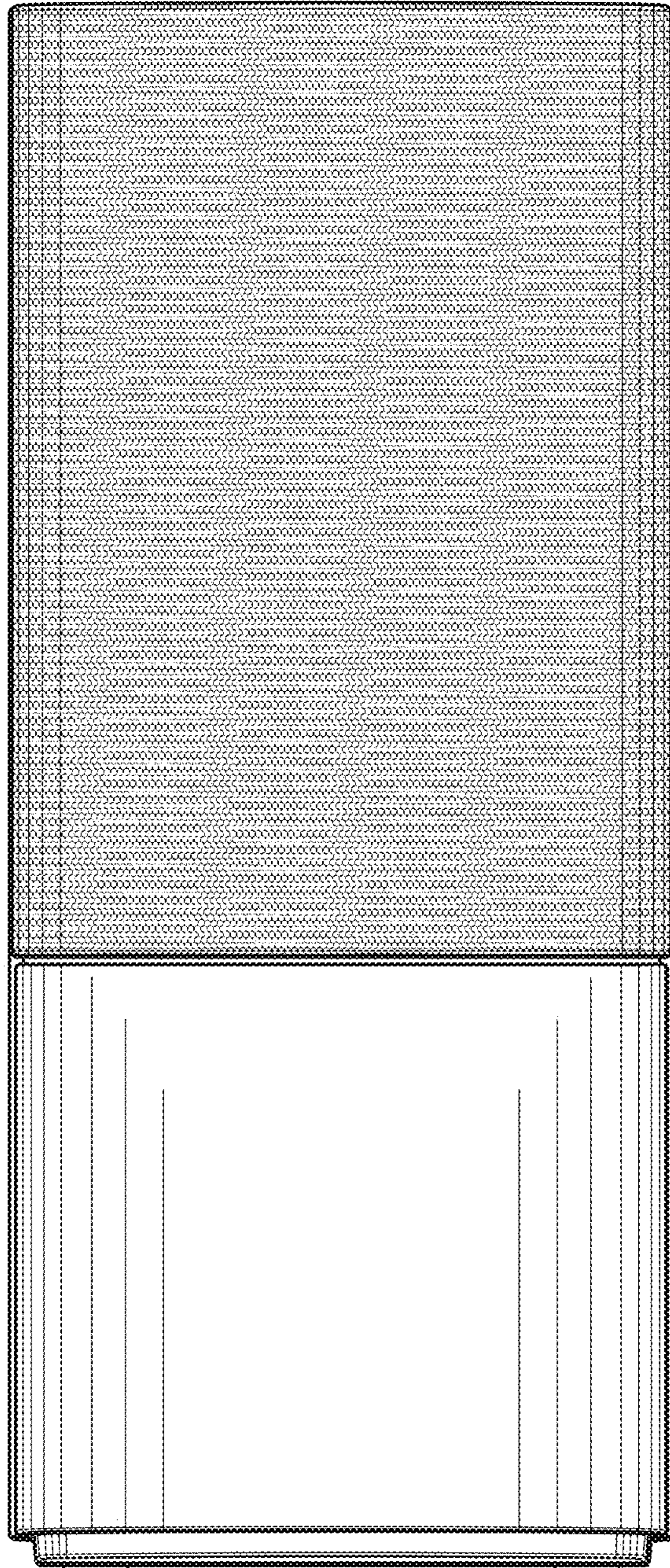

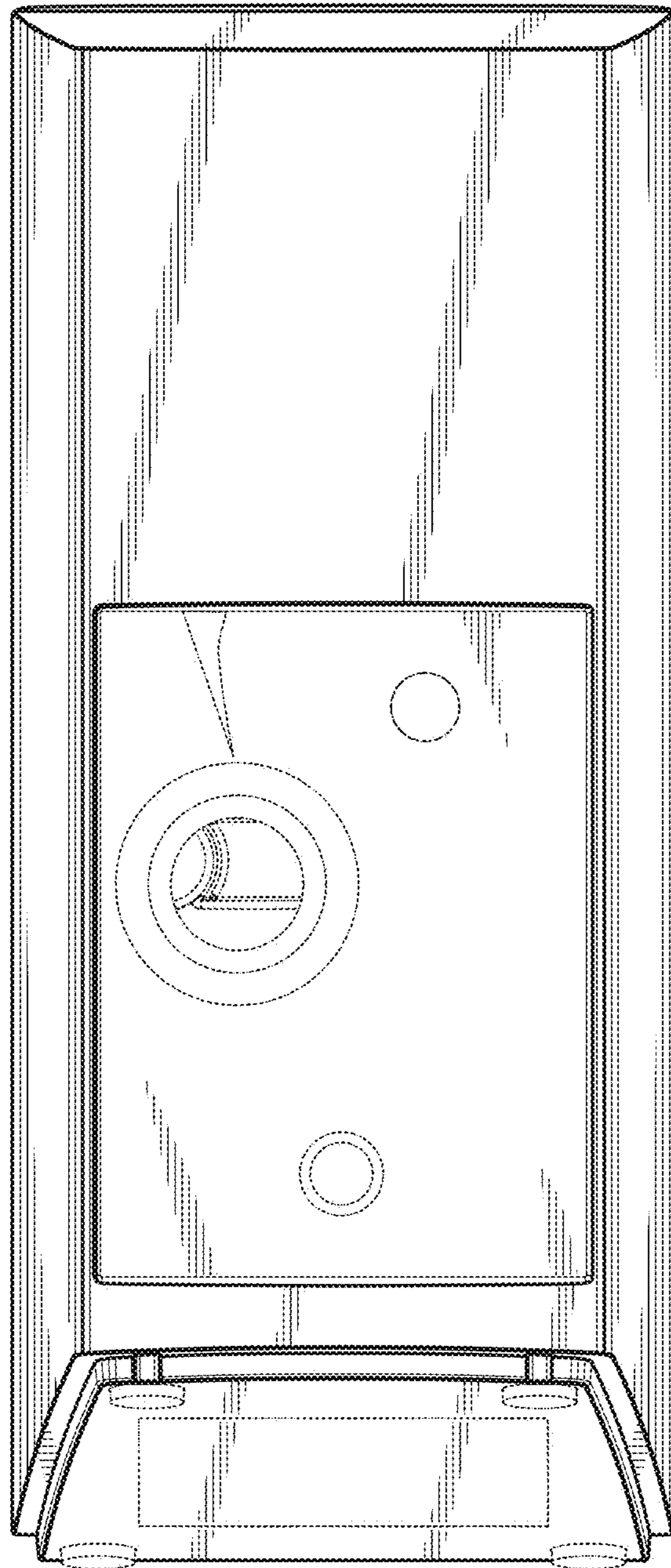

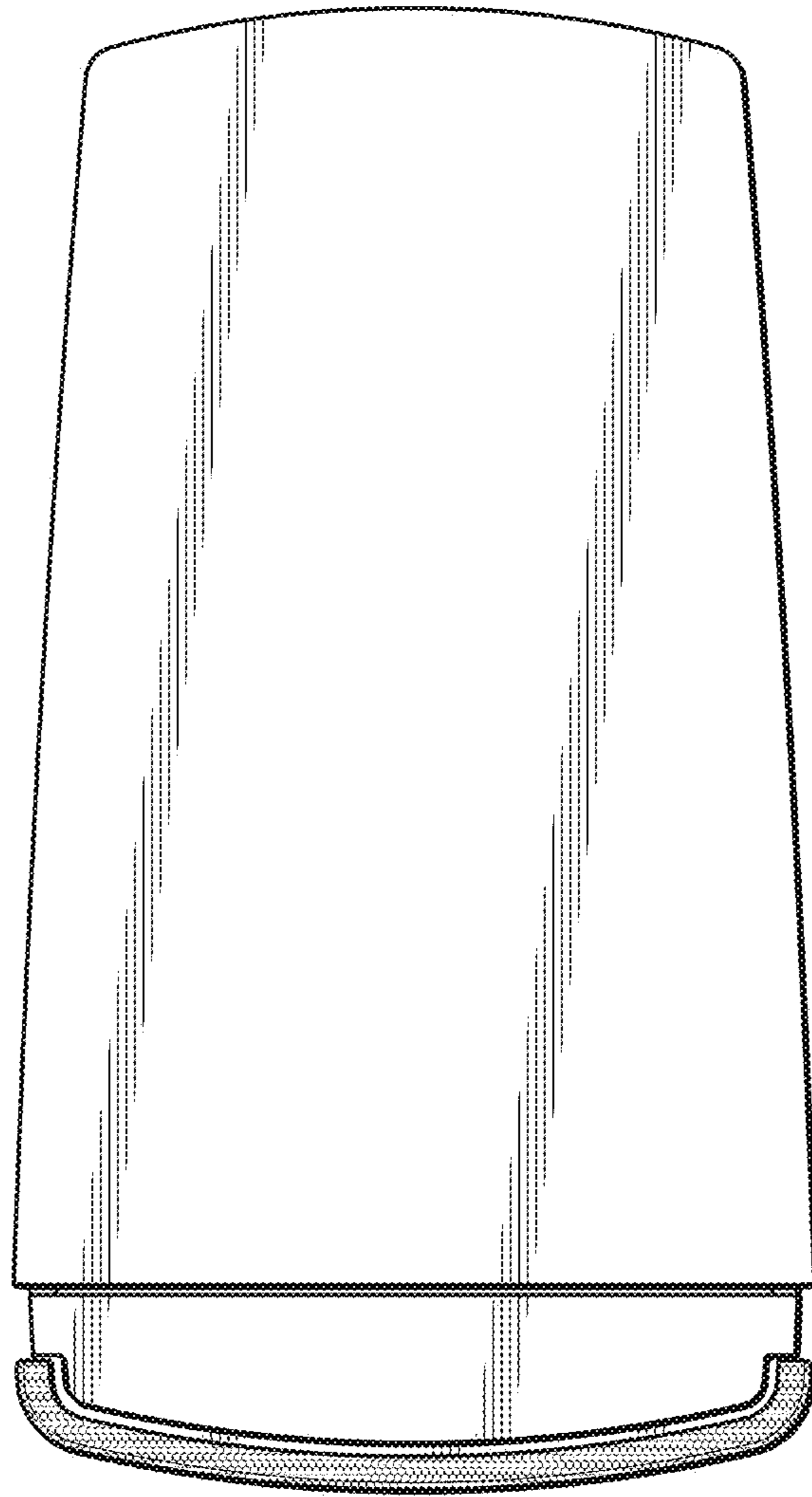

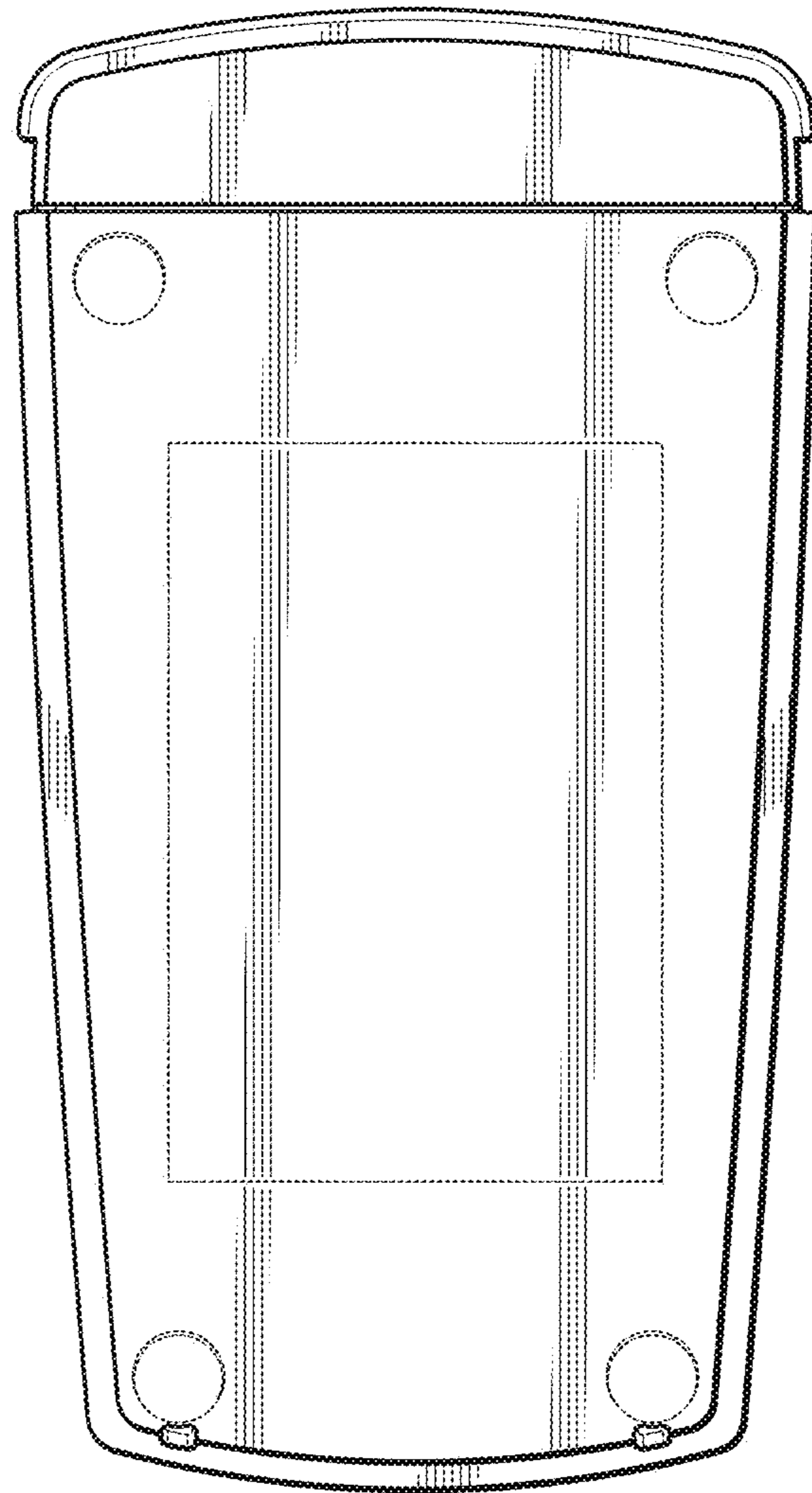

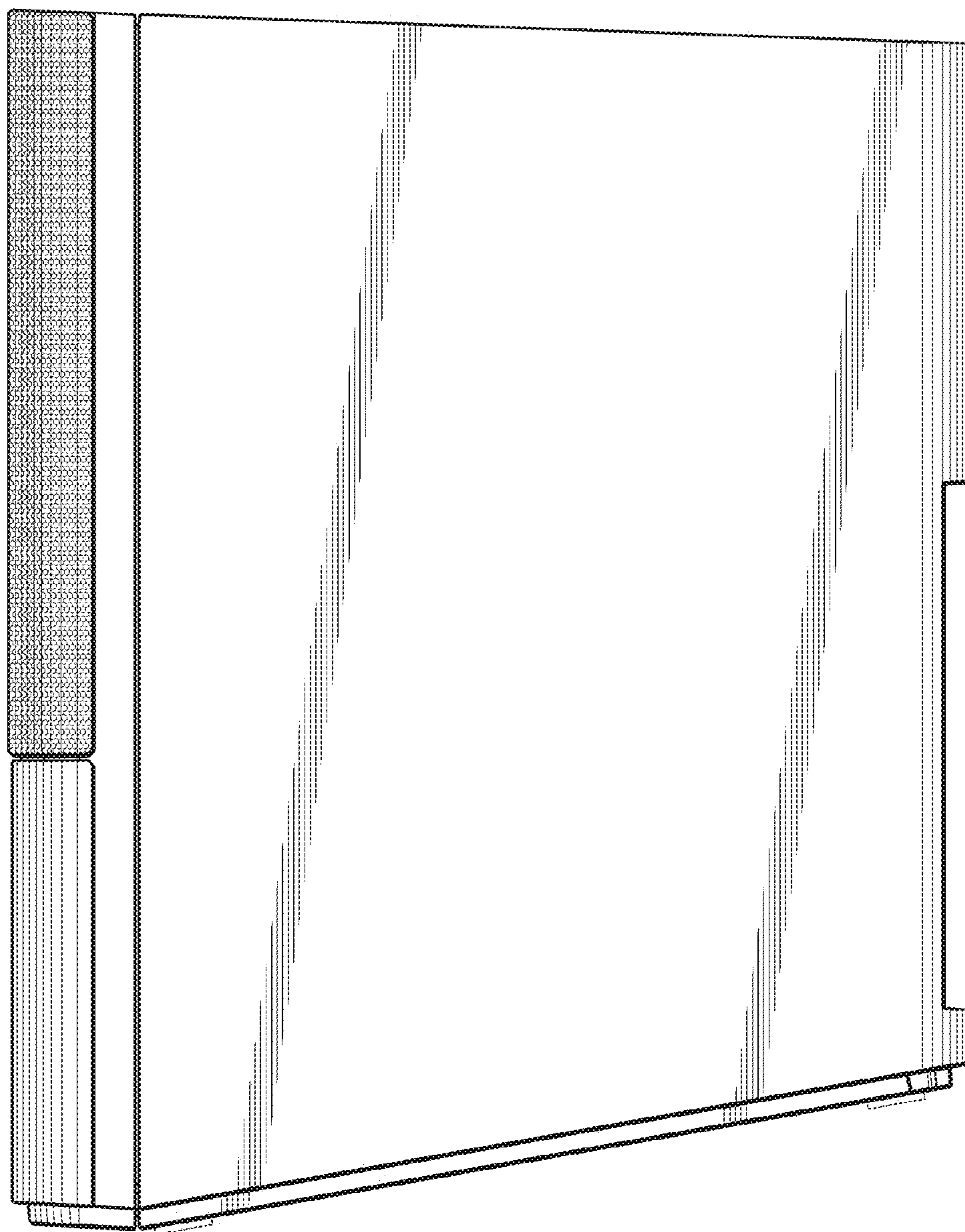

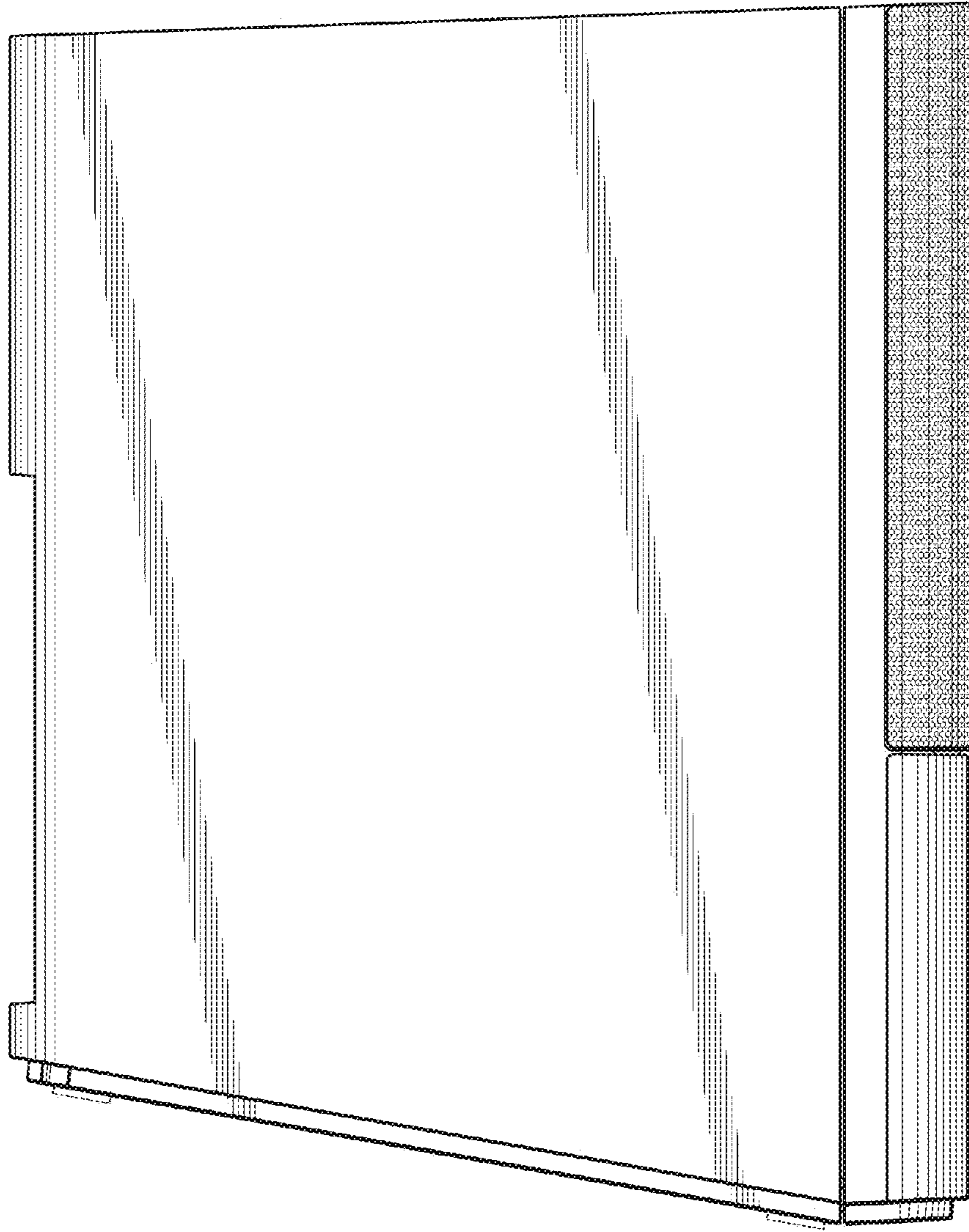

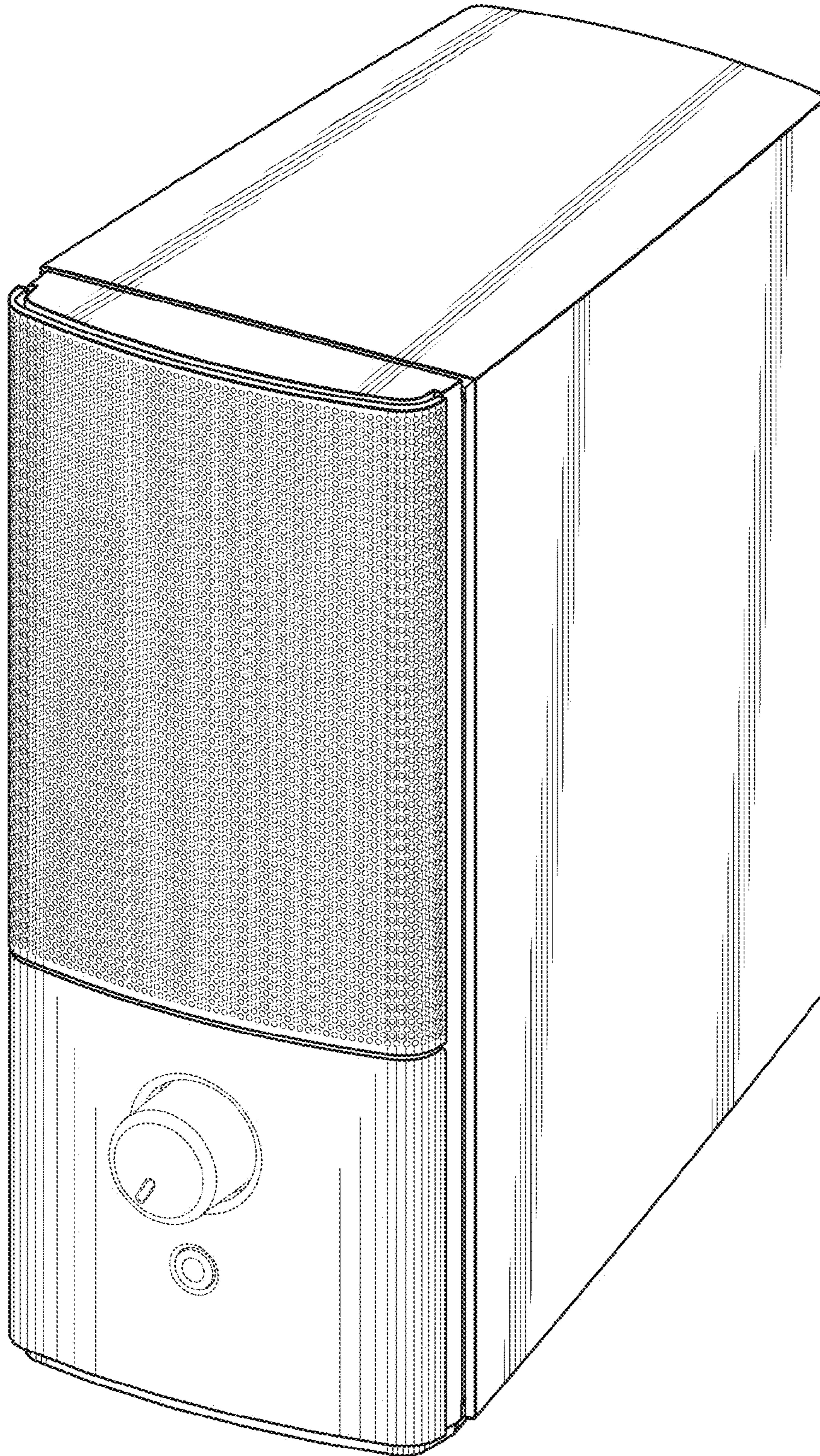

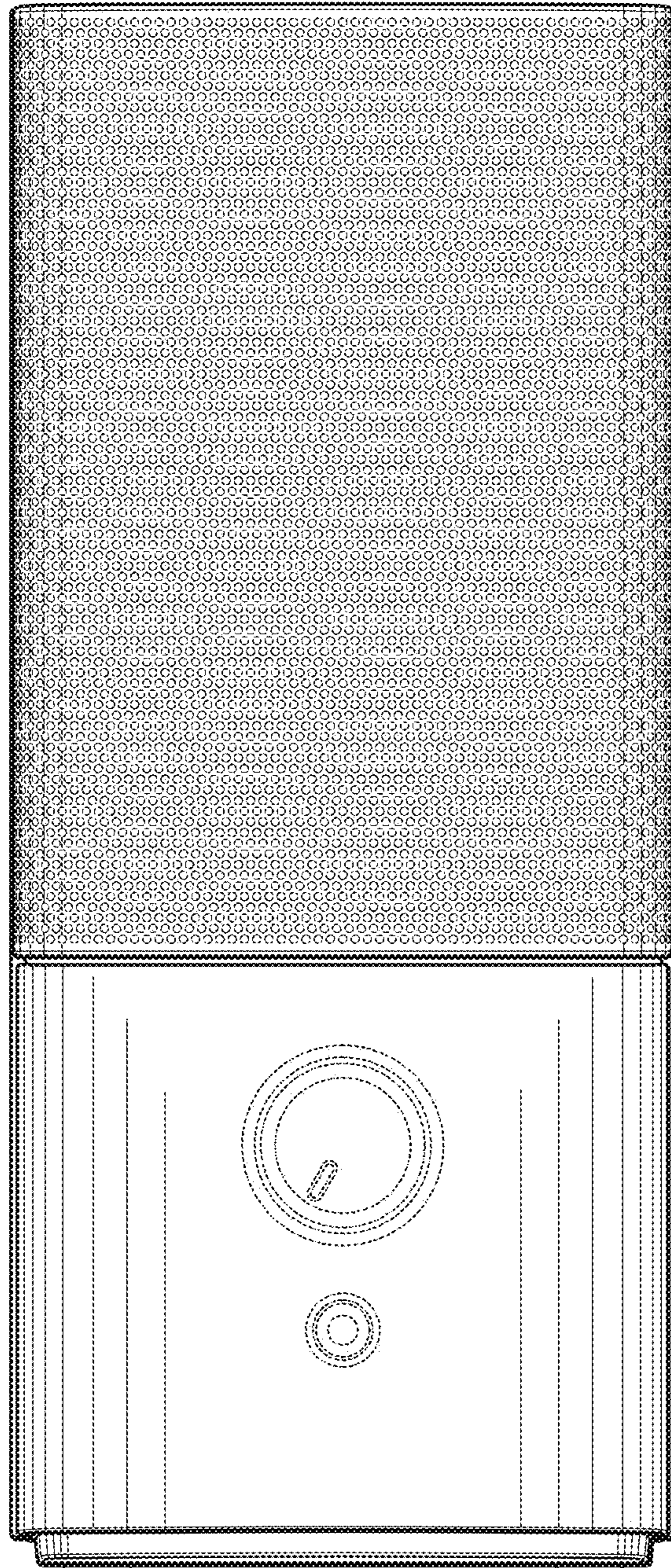

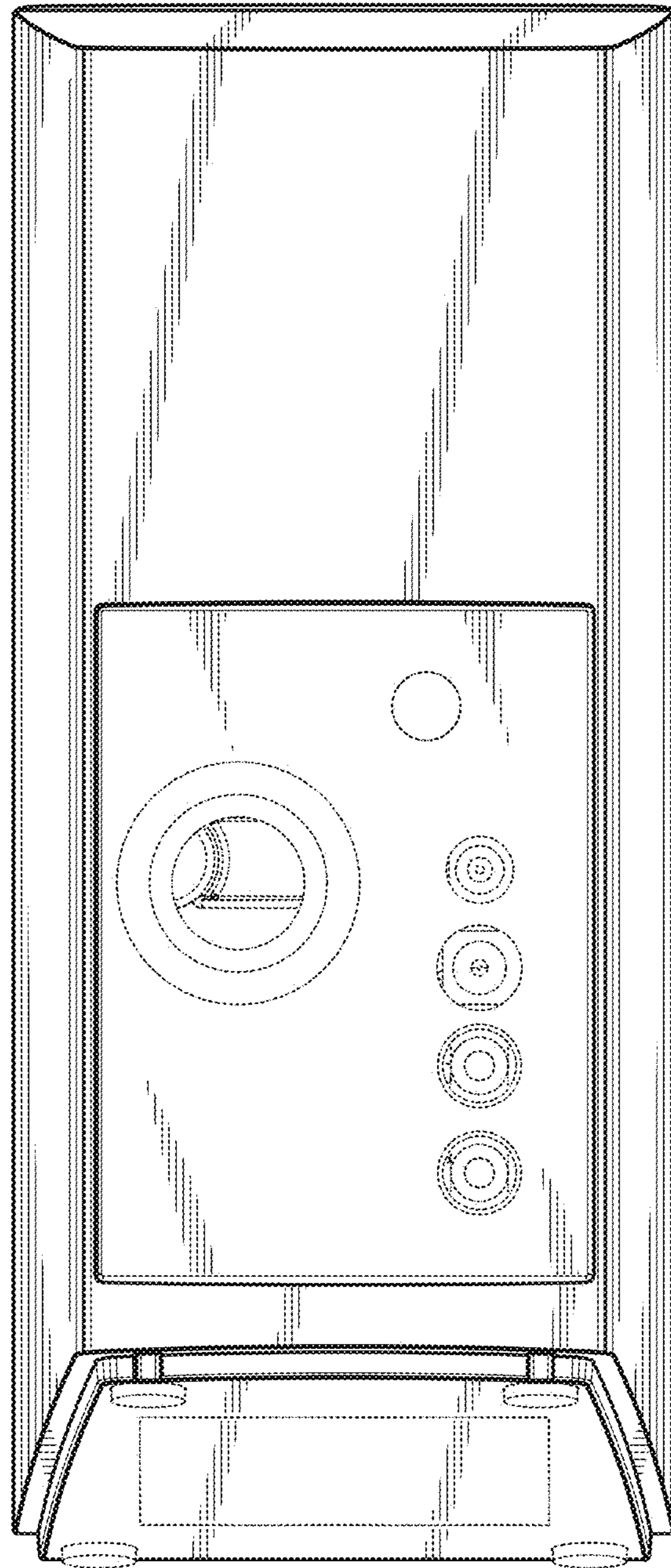

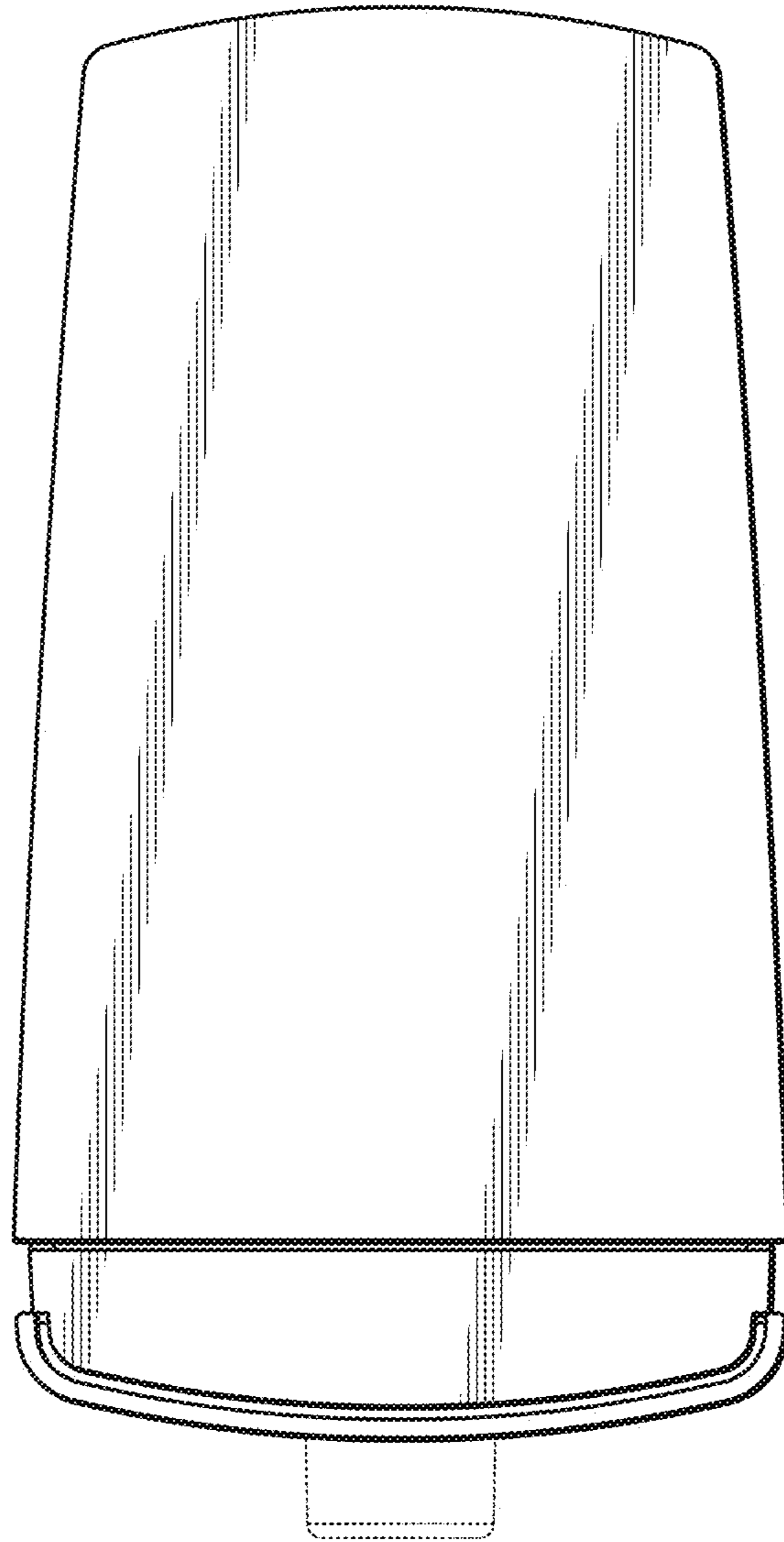

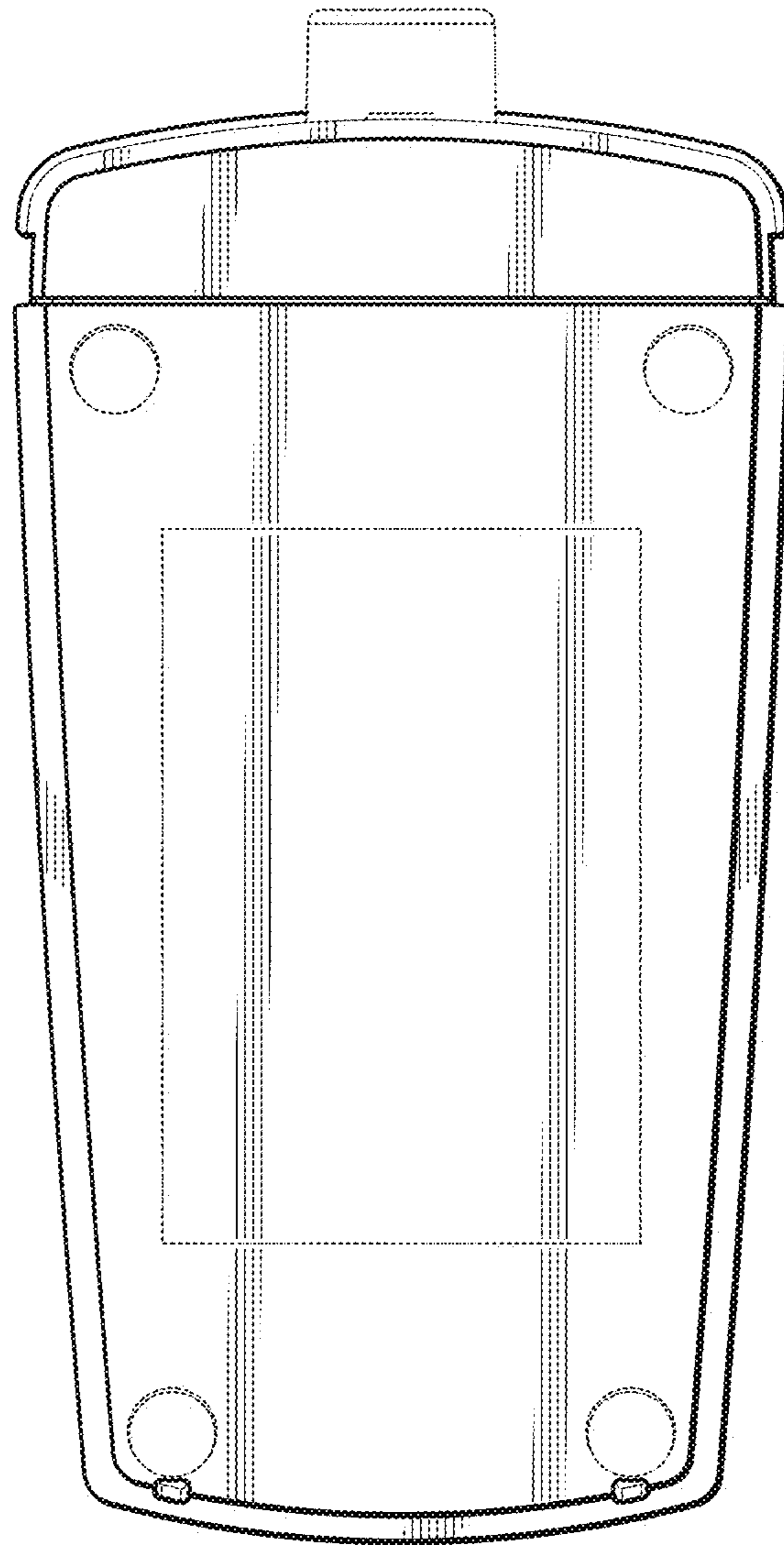

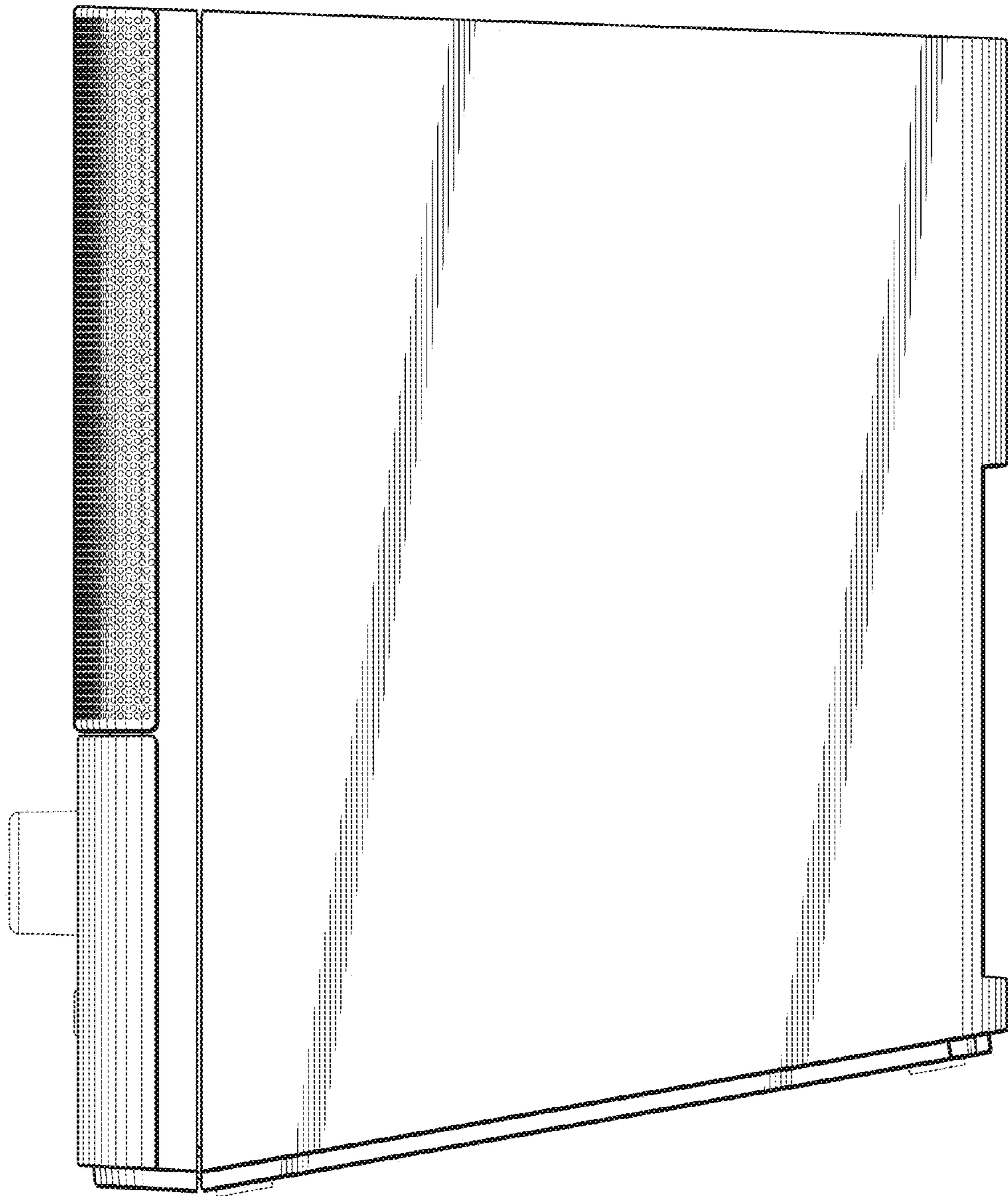

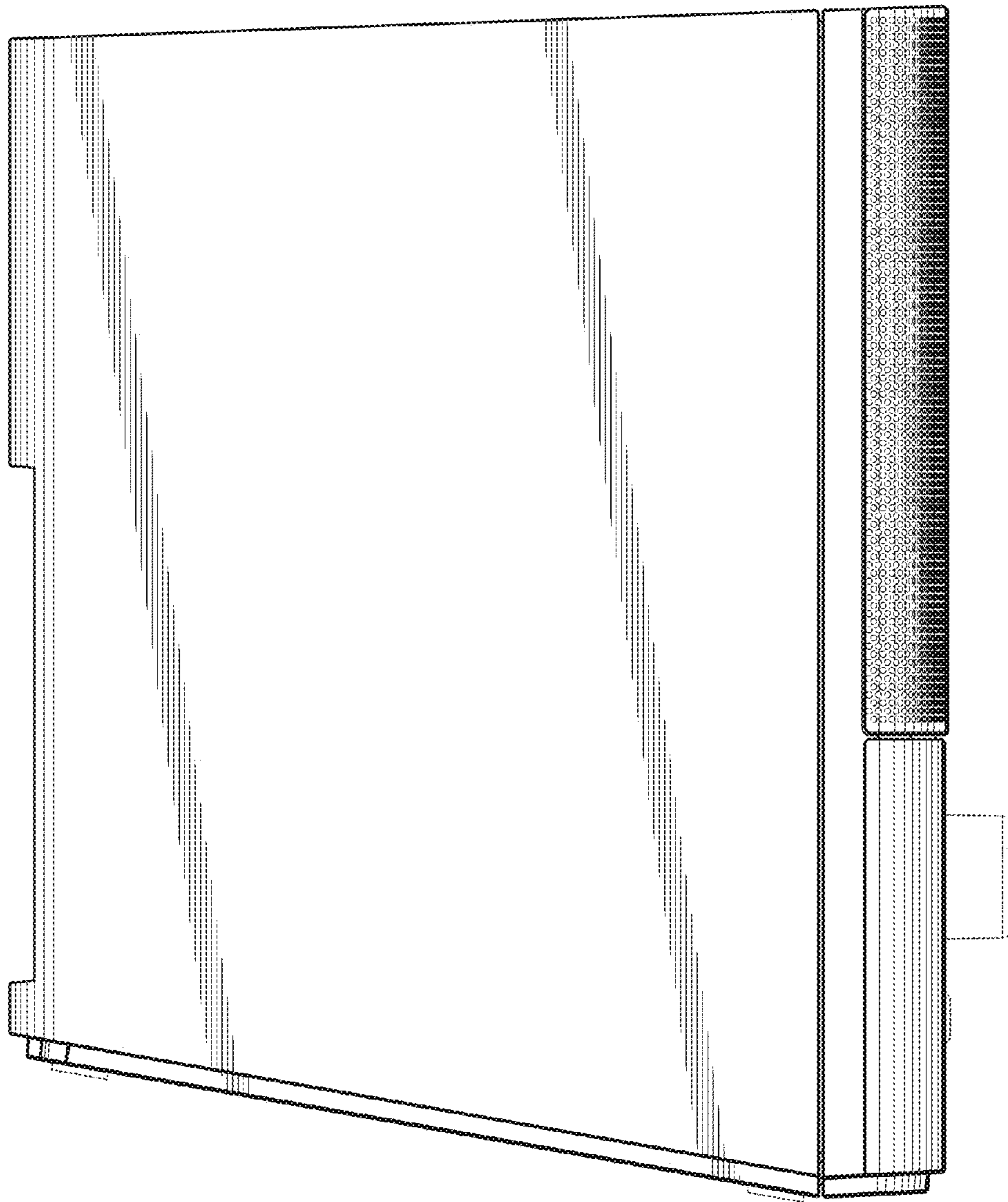

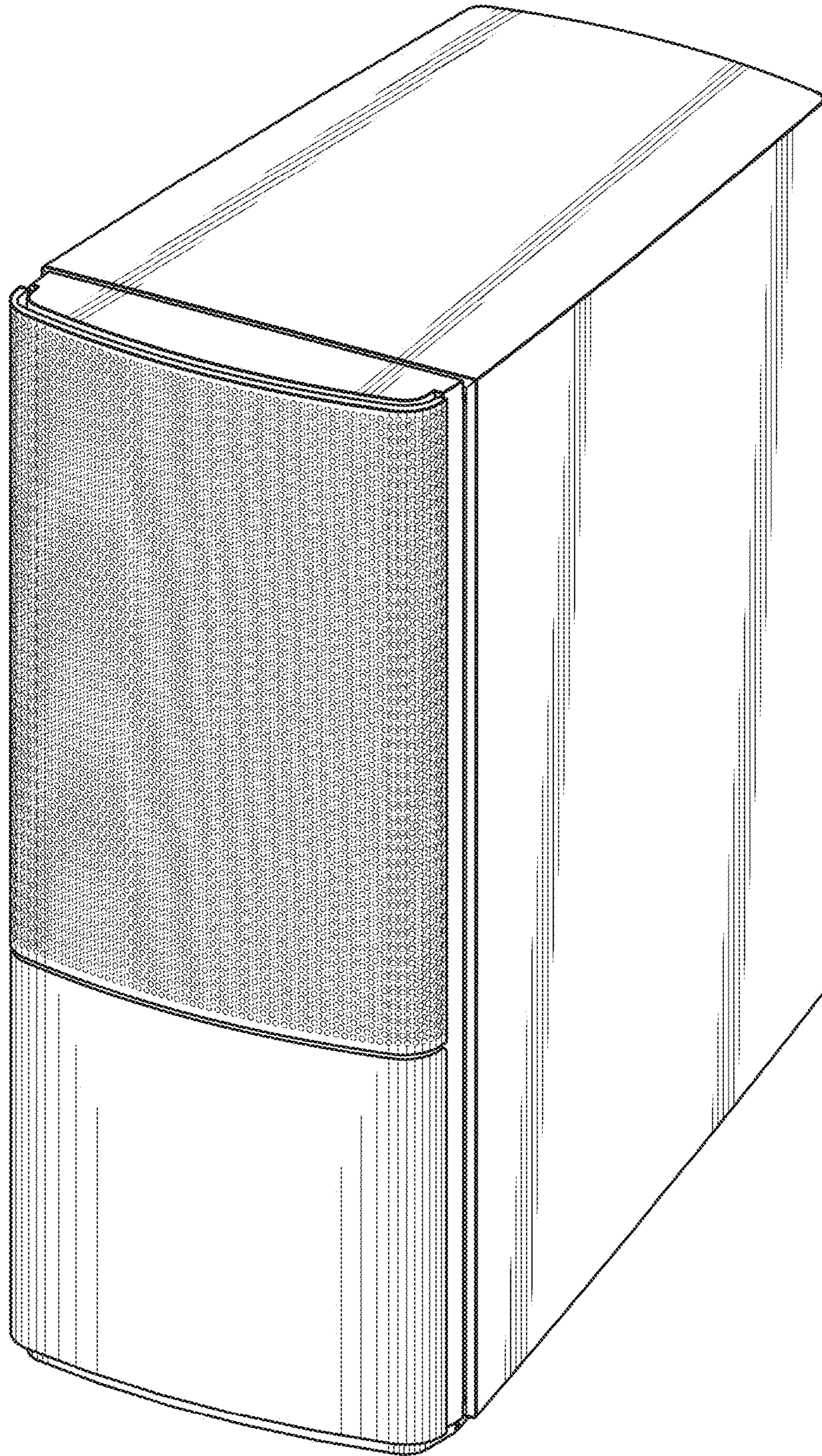

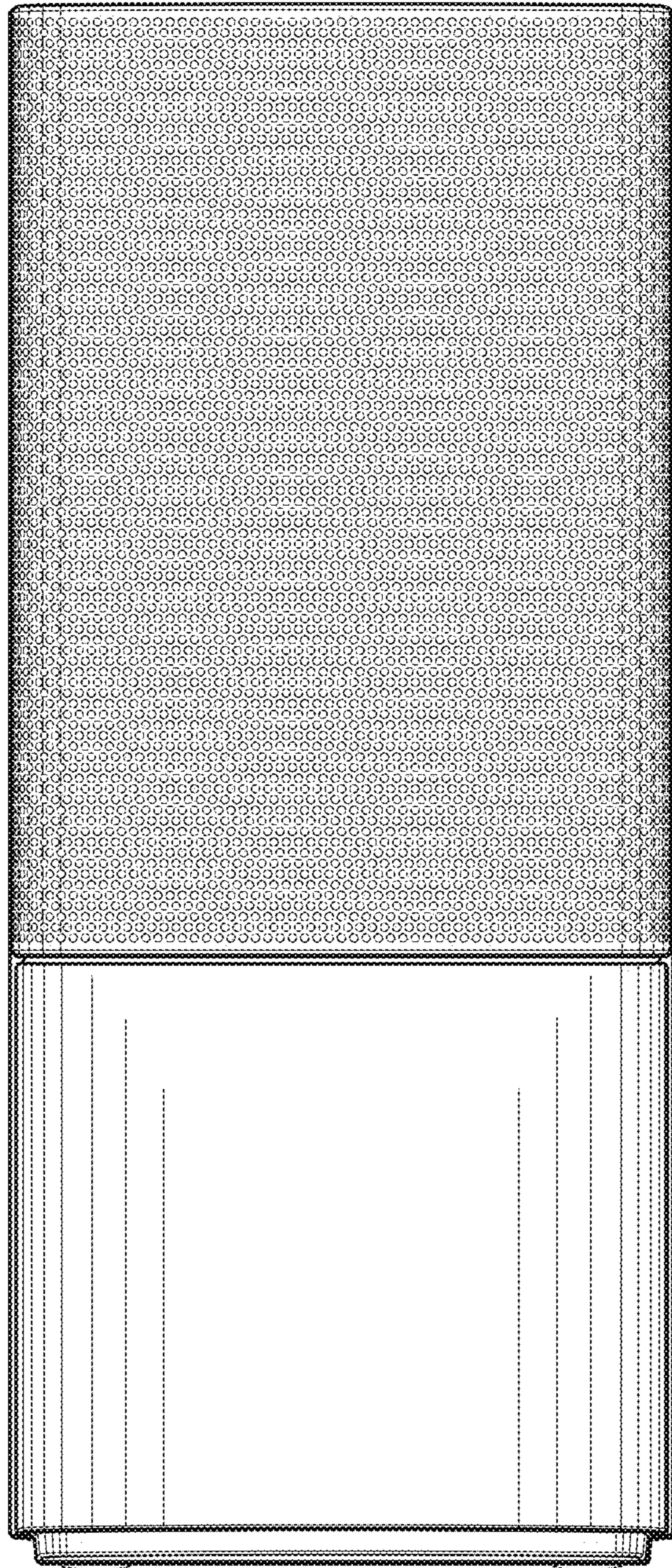

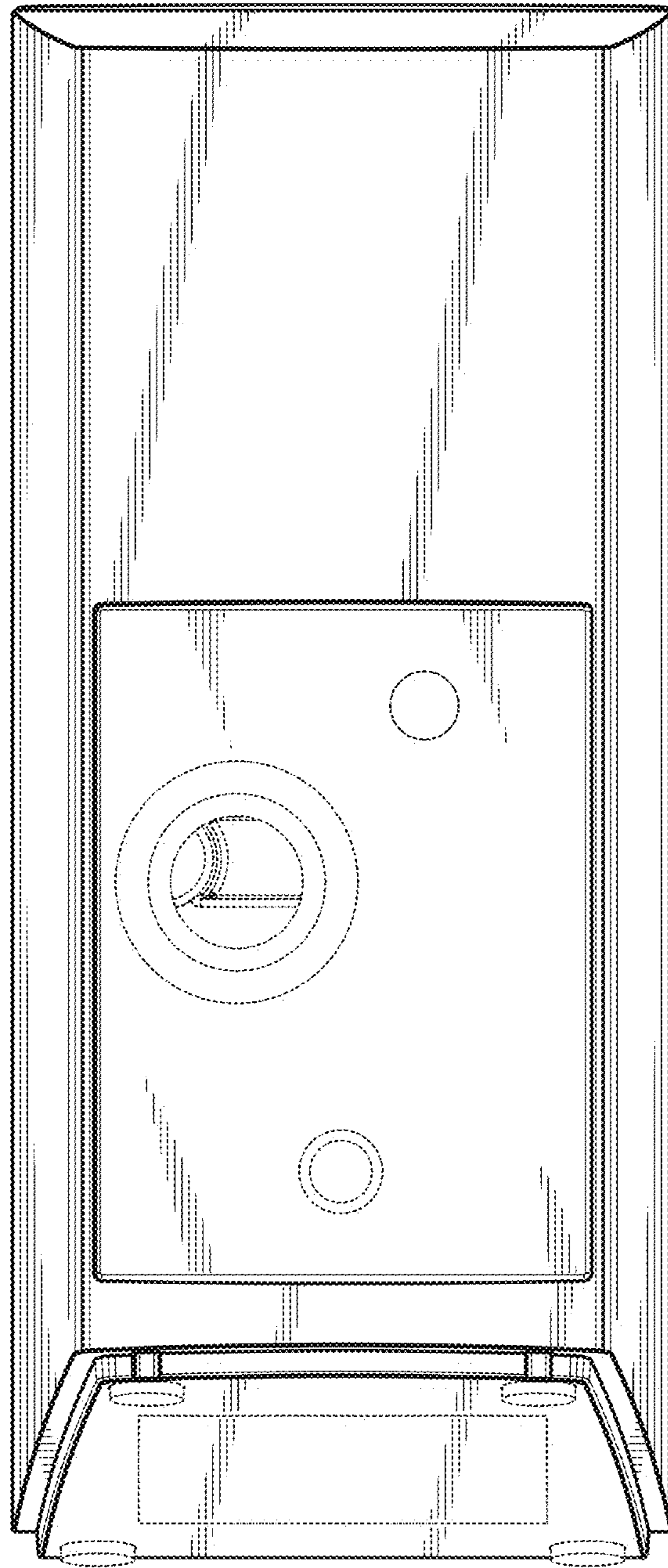

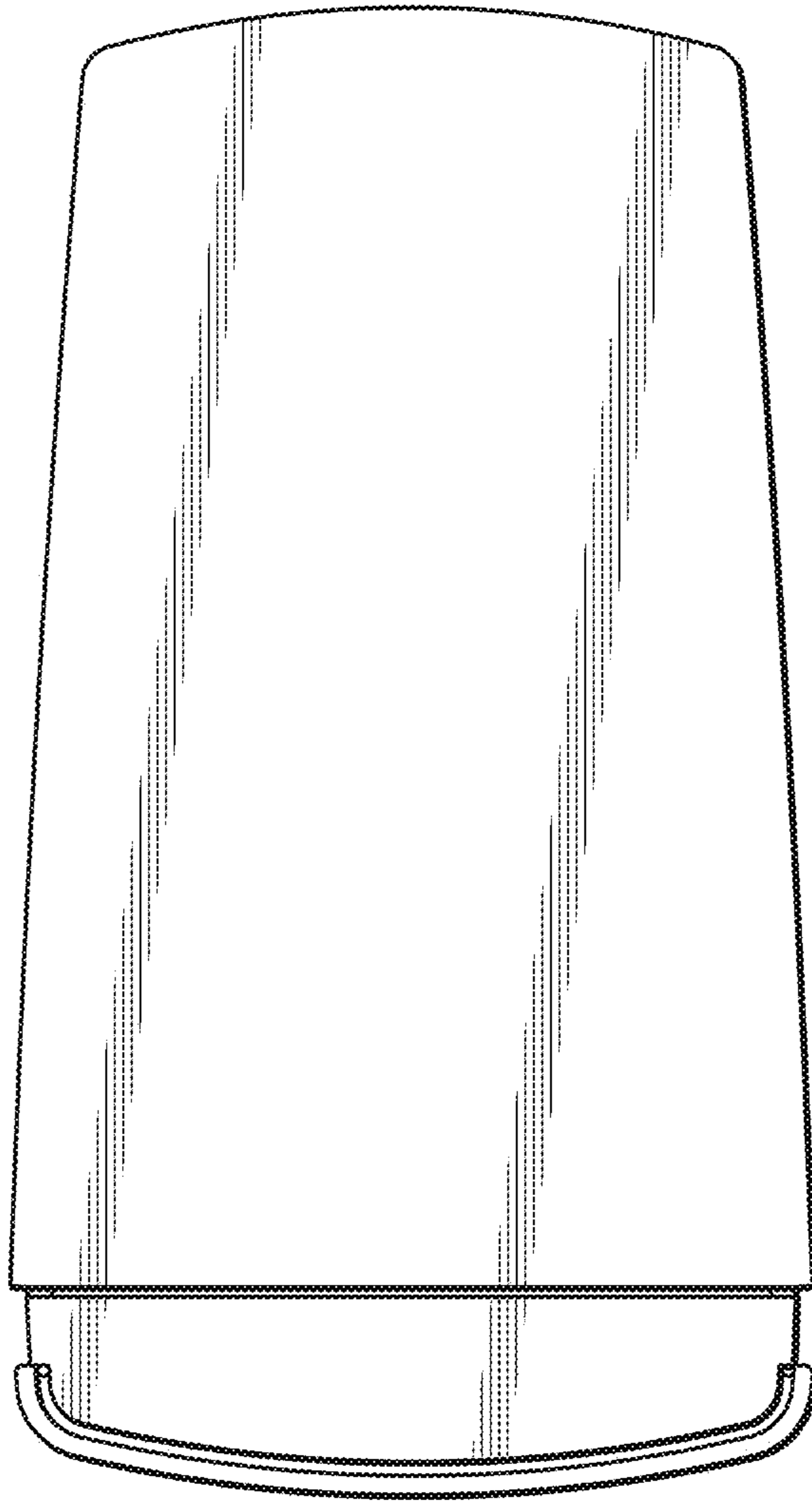

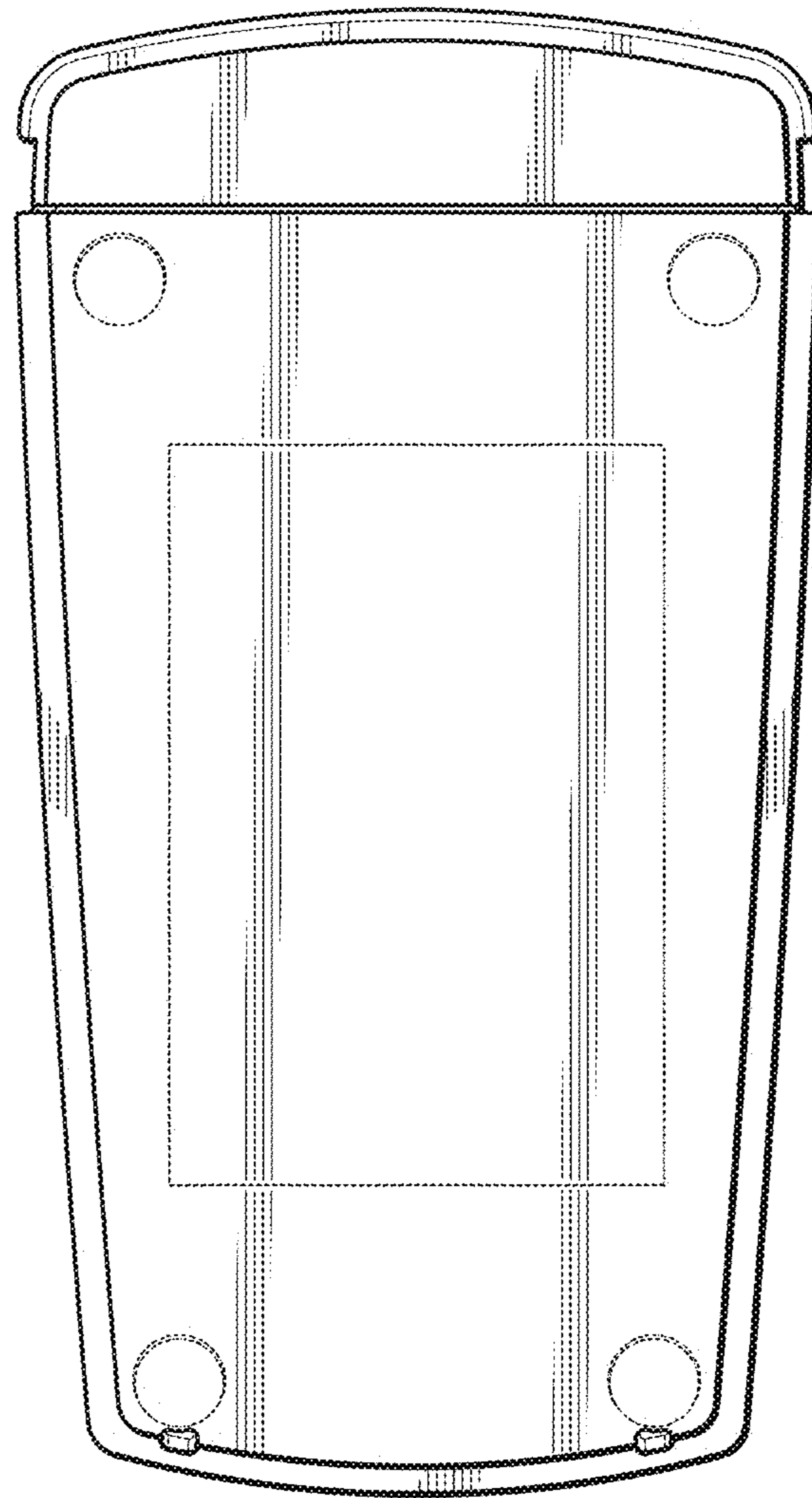

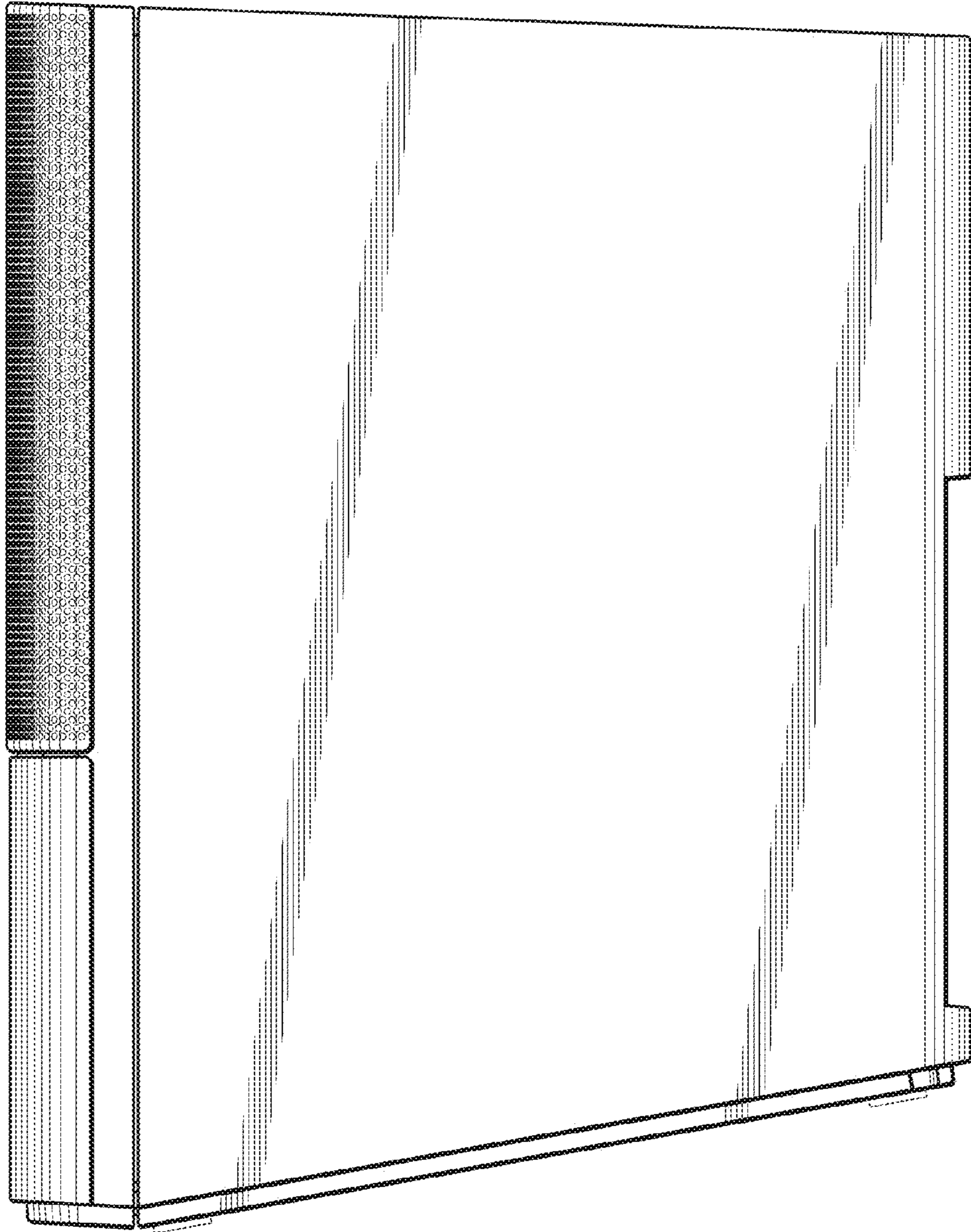

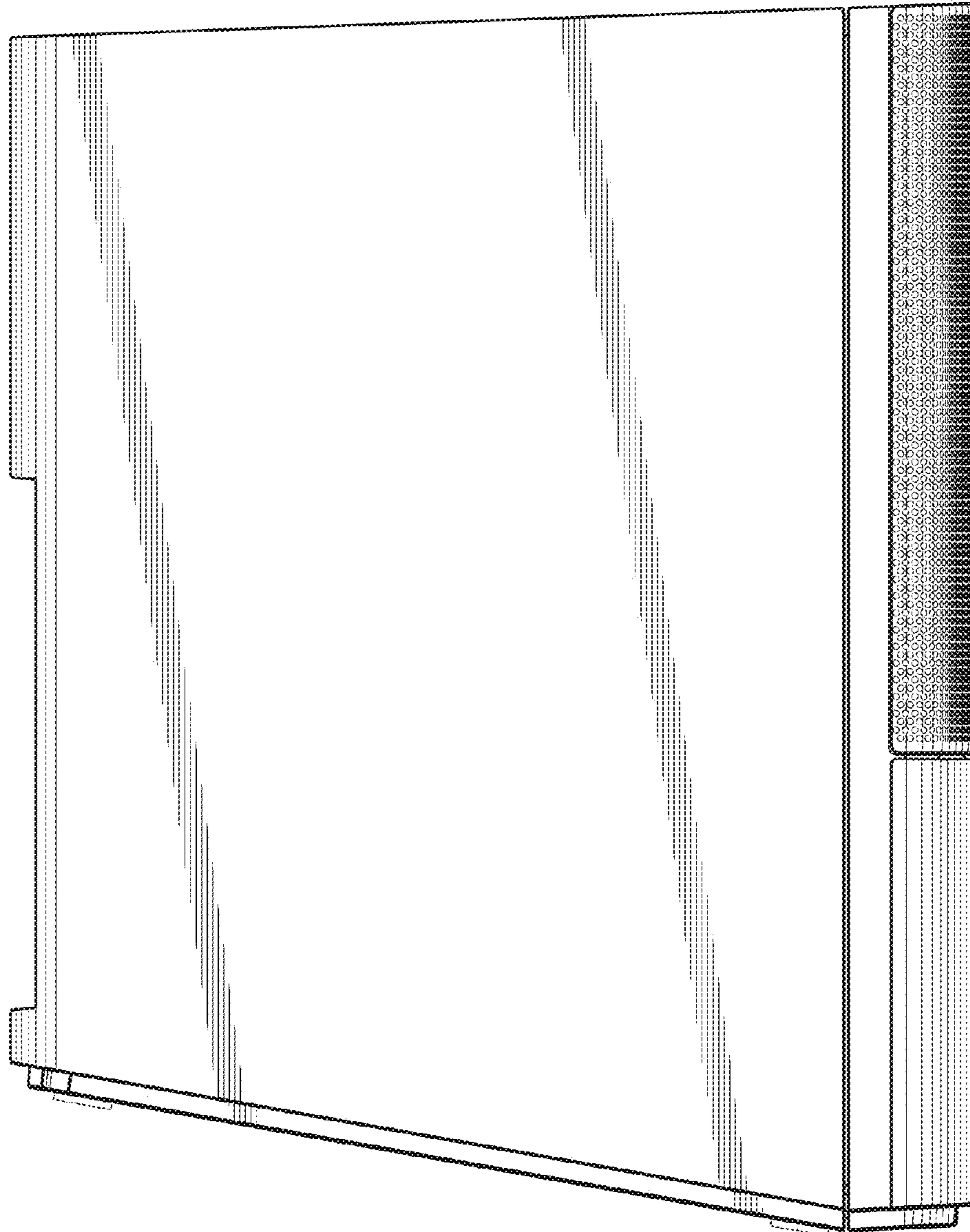
