(57) **CLAIM**

We claim the ornamental design for a display screen with a graphical user interface, as shown and described.

**DESCRIPTION**

The FIGURE is a view of a display screen with a graphical user interface according to our new design, wherein the outermost broken lines surrounding the graphical user interface represent a display screen which forms no part of the claimed design, and wherein other broken lines in the drawing illustrate environment and form no part of the claimed design.
