(57) **CLAIM**

The ornamental design for a display screen portion with icon,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen portion with icon  
showing my new design; and,  
FIG. 2 is a front view of the display screen portion of icon of  
FIG. 1, in which a mobile terminal in broken lines is provided  
to illustrate an example environment.

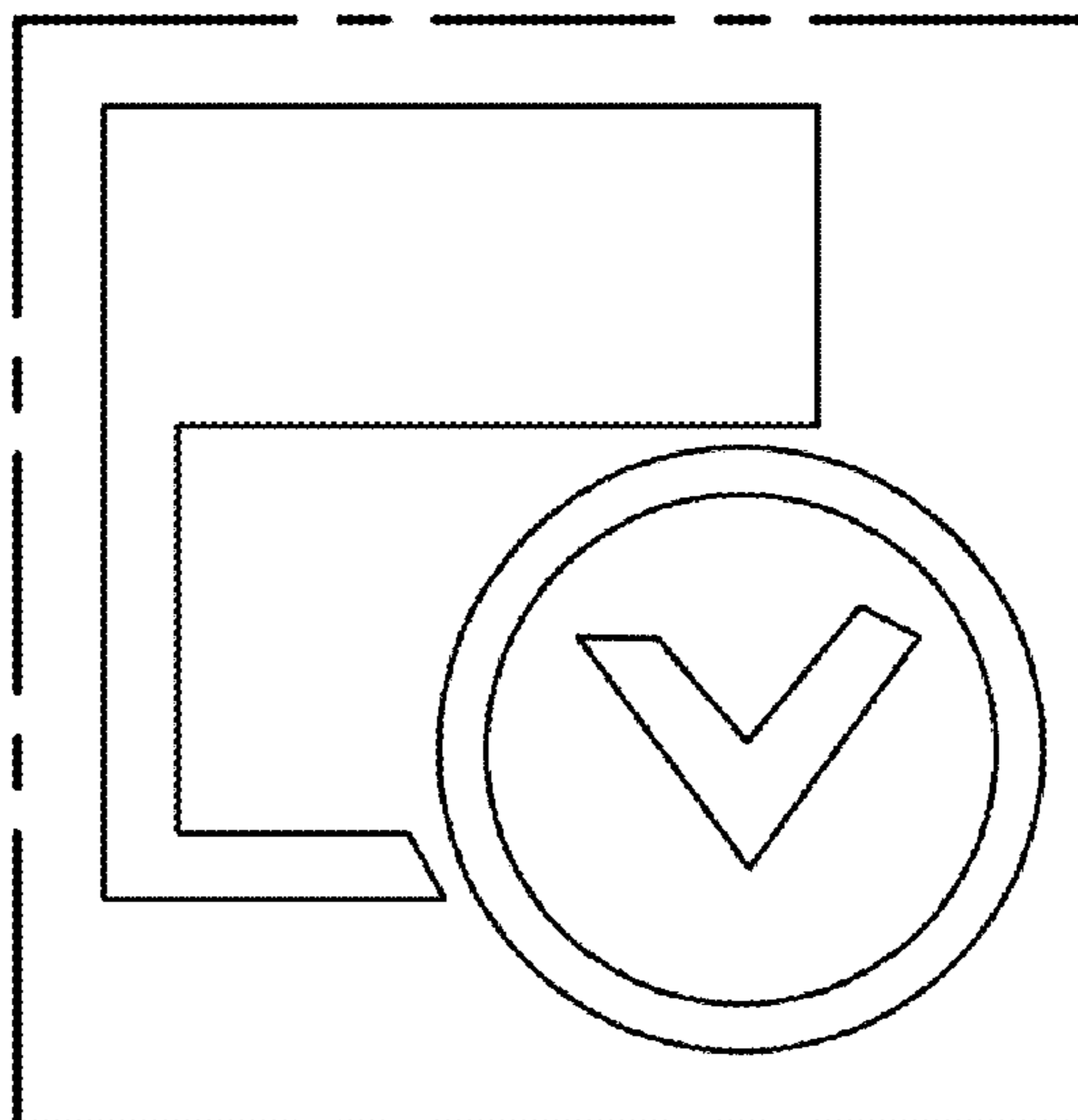

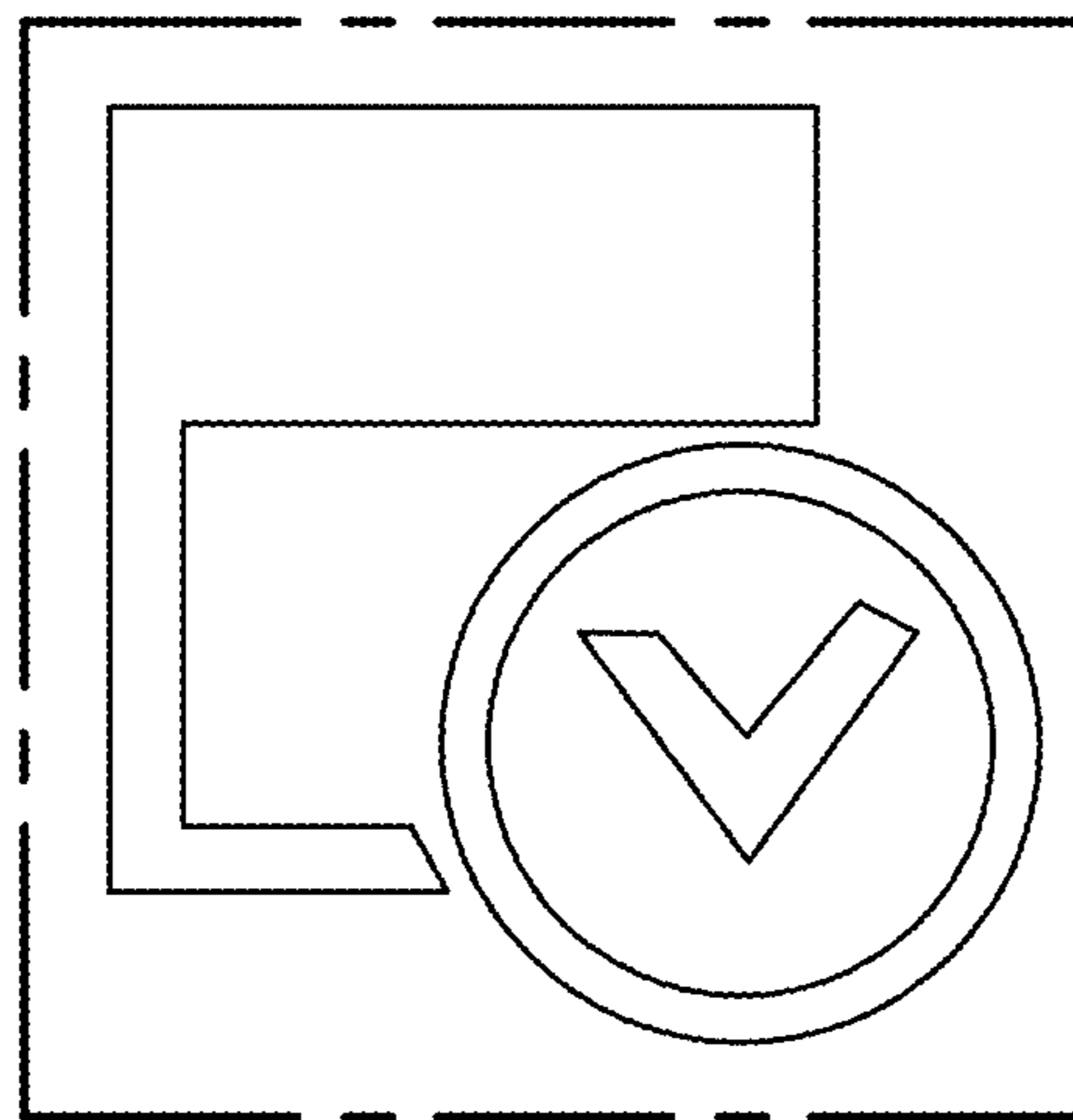
