I claim the ornamental design for a studded ball, as shown and described.

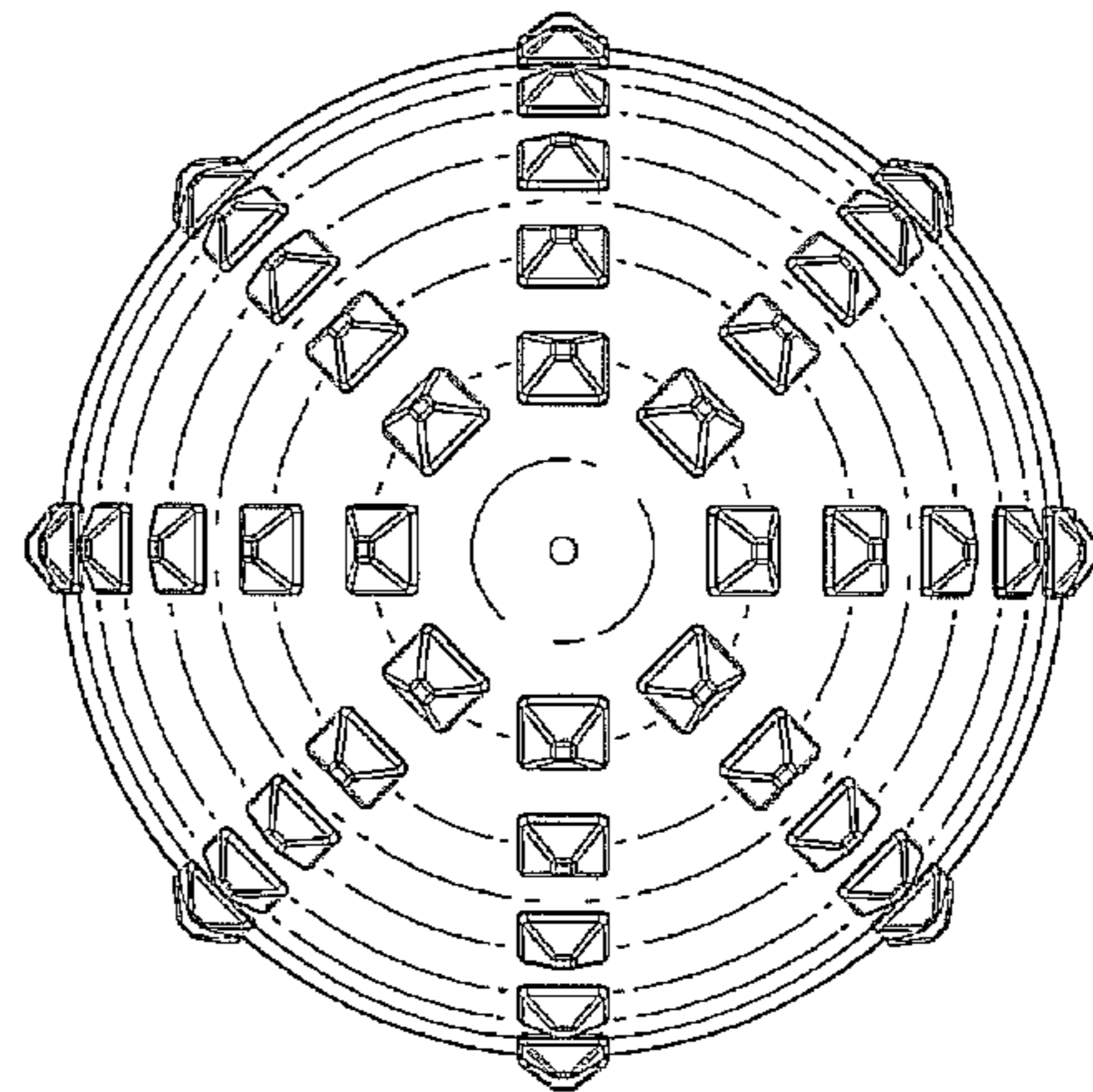
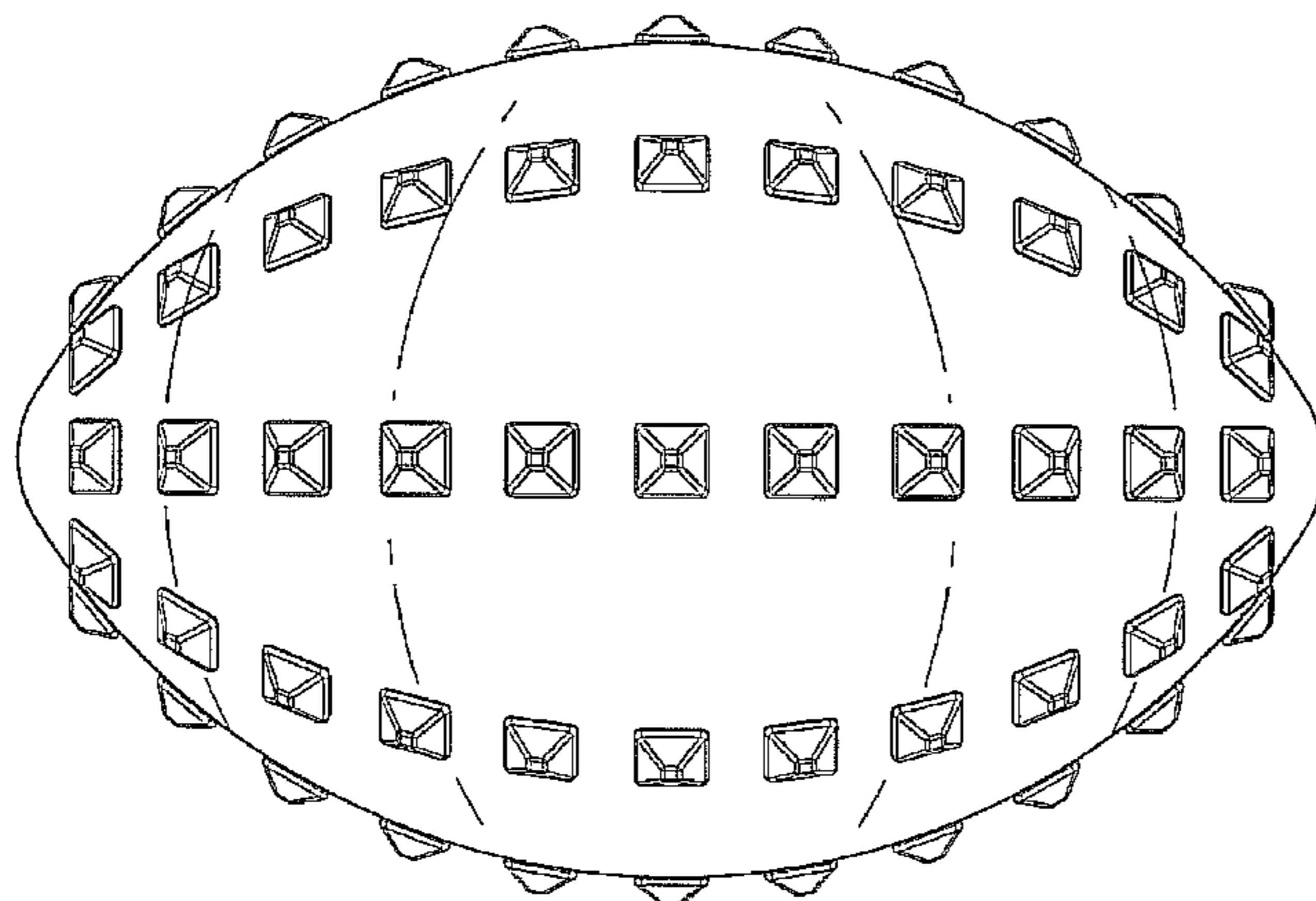
DESCRIPTION

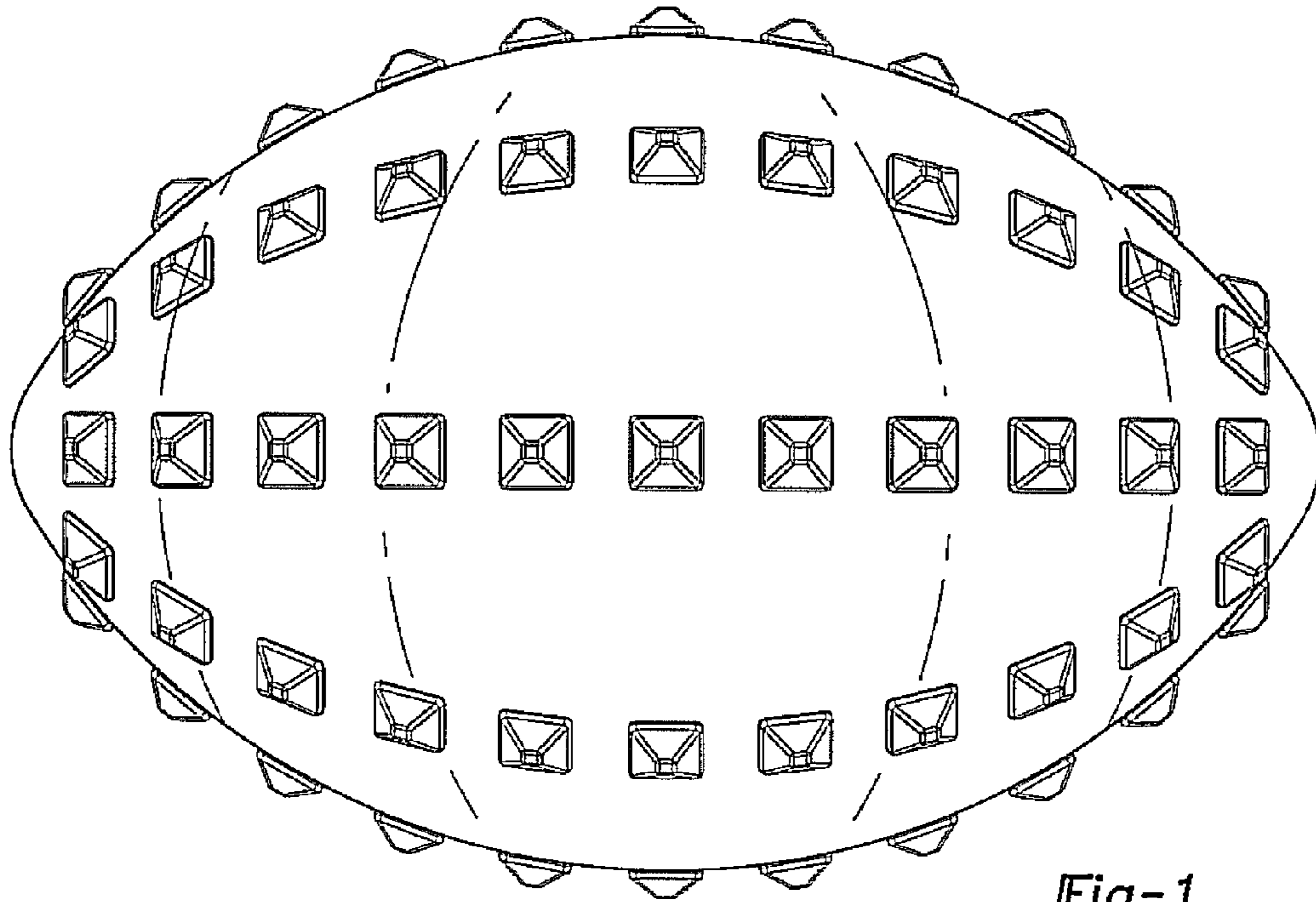

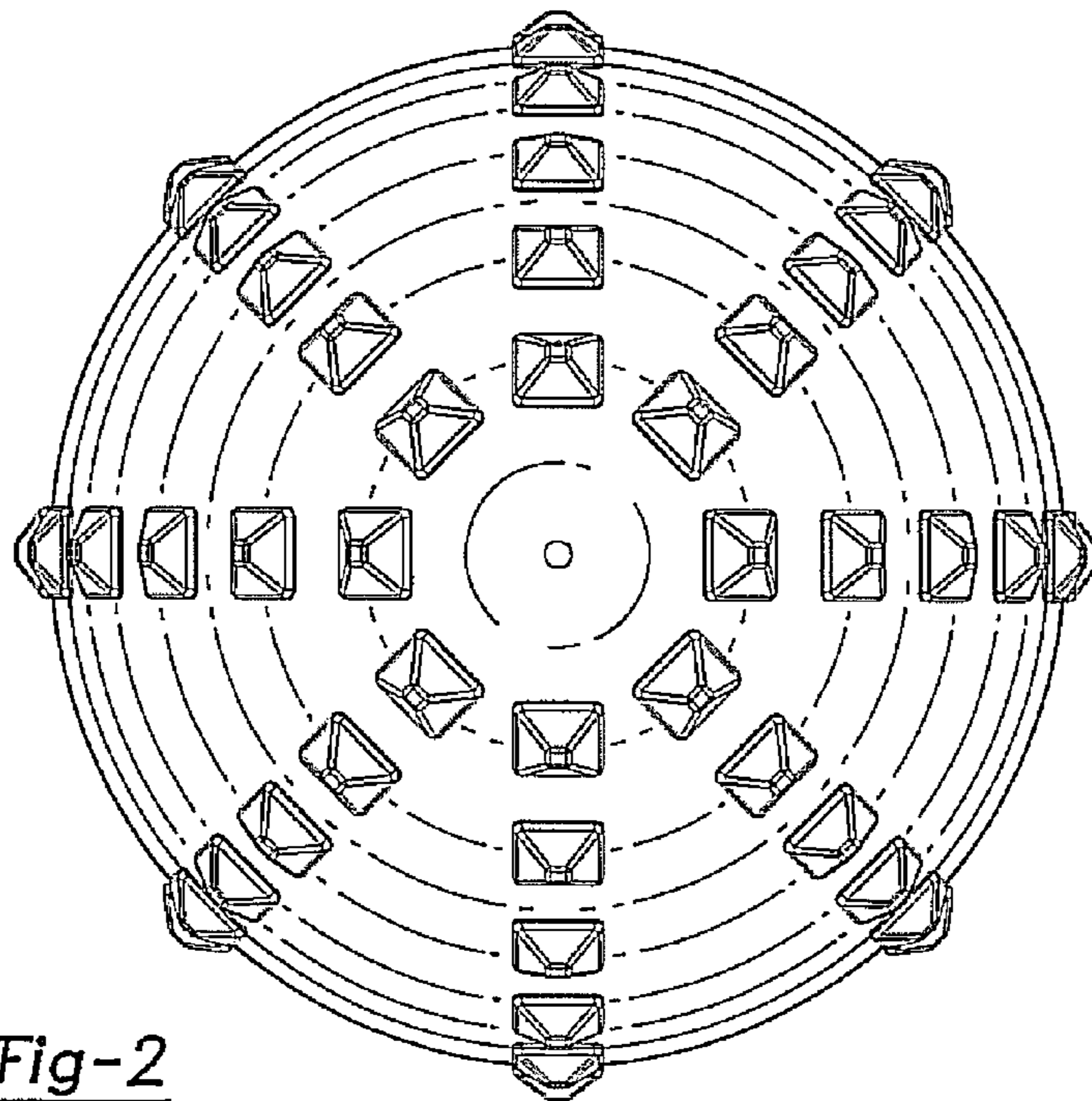

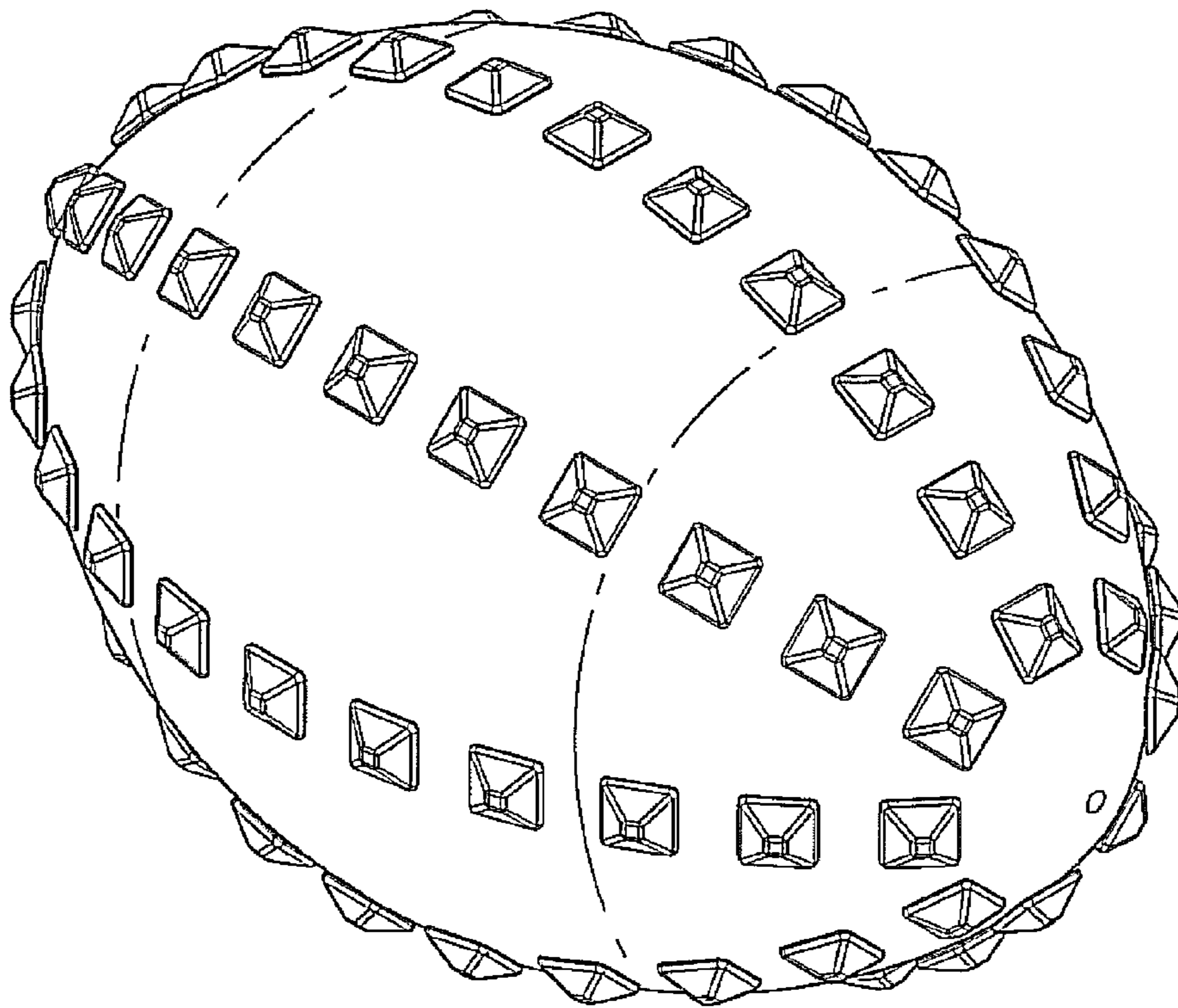
