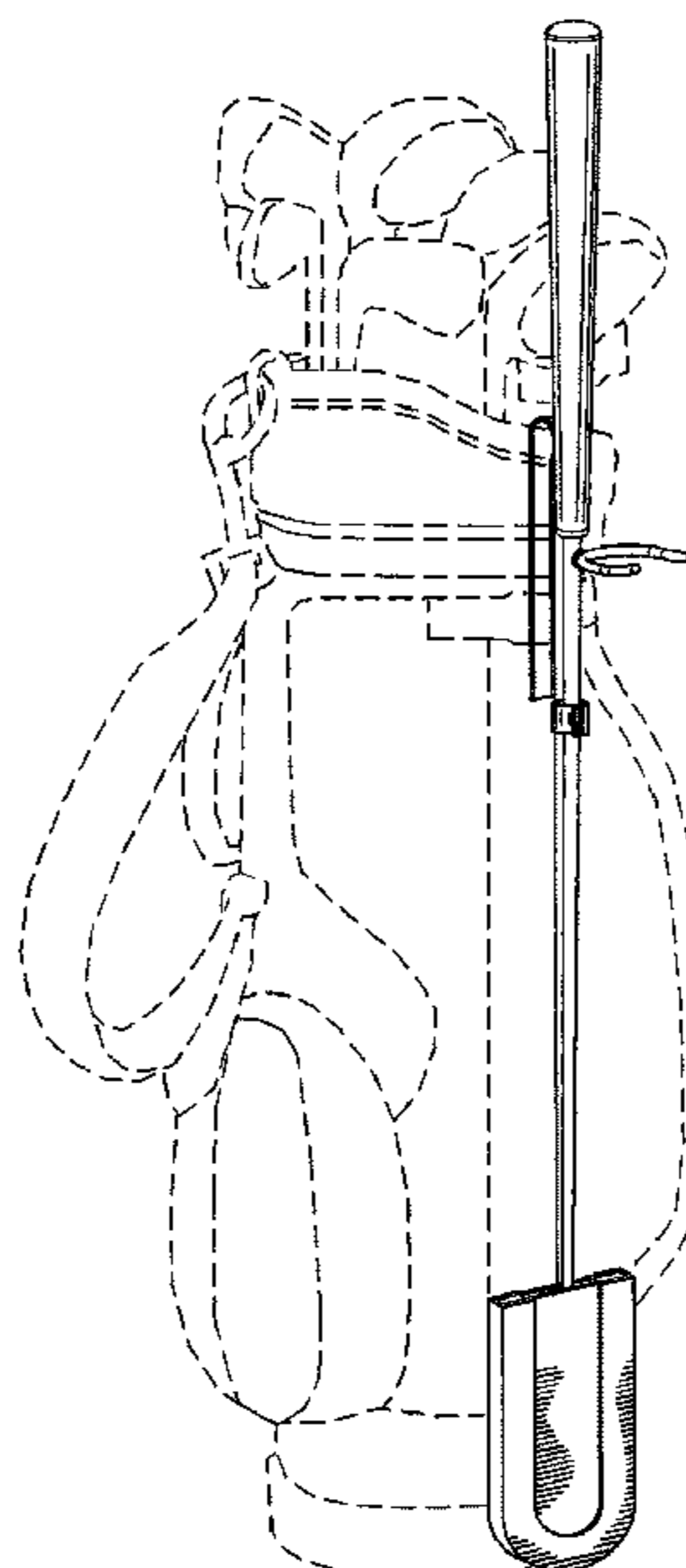

 FIG. 2 is a left front perspective view of the golf club holder only of the combined golf club holder and sheath of FIG. 1;
 FIG. 3 is a front perspective view of the golf club holder of FIG. 2;
 FIG. 4 is a left side elevational view of the golf club holder of FIG. 2, the right side elevational view being a mirroring image thereof;
 FIG. 5 is a front elevational view of the golf club holder of FIG. 2;
 FIG. 6 is right front perspective view of the sheath only of the combined golf club holder and sheath of FIG. 1;
 FIG. 7 is a right rear perspective view of the sheath of FIG. 6;
 FIG. 8 is a top plan view of the sheath of FIG. 6;
 FIG. 9 is a left side elevational view of the sheath of FIG. 6, the right side elevational view being a mirroring image thereof; and,
 FIG. 10 is a front elevational view of the sheath of FIG. 6.
 The broken line disclosure in the figures, which includes a golf bag and golf clubs for an intended use of the combined golf club holder and sheath, is for illustration purposes only and forms no part of the claimed design.

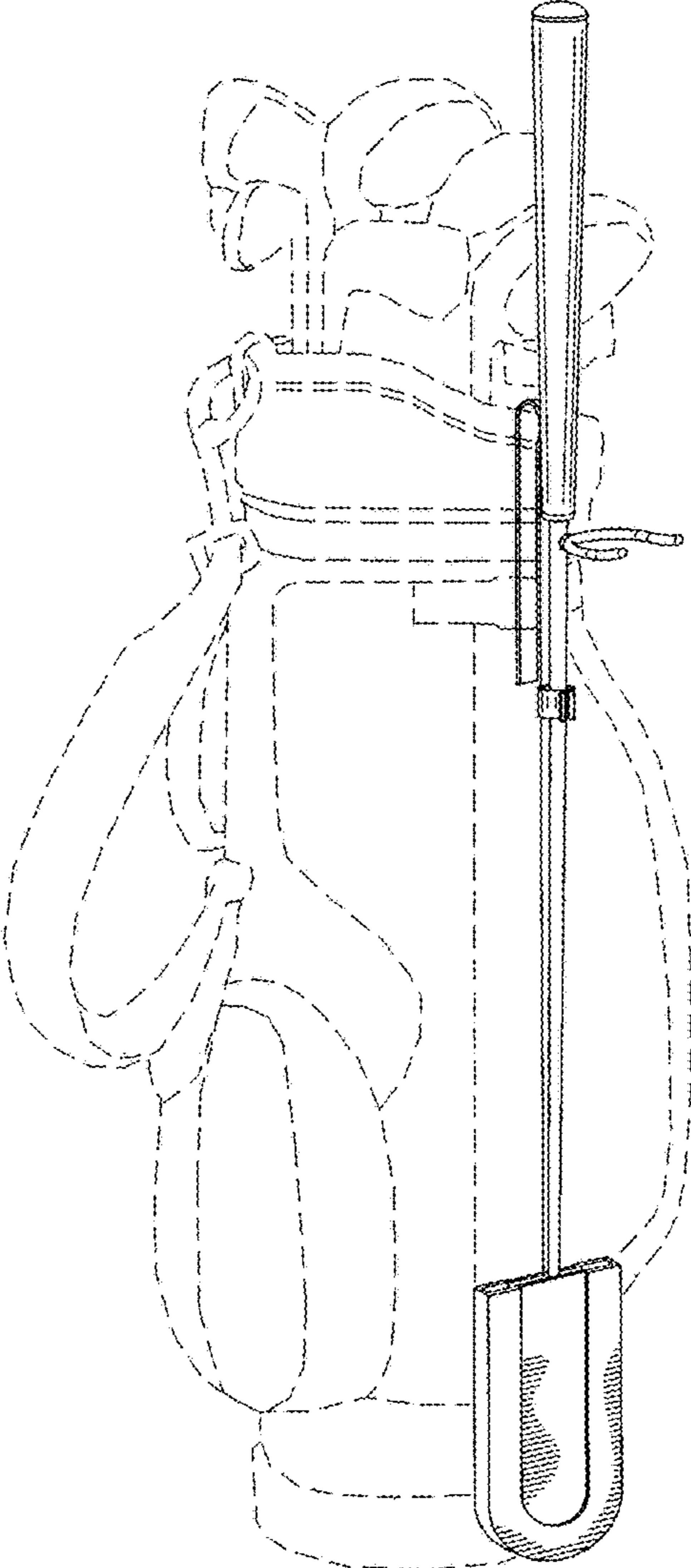

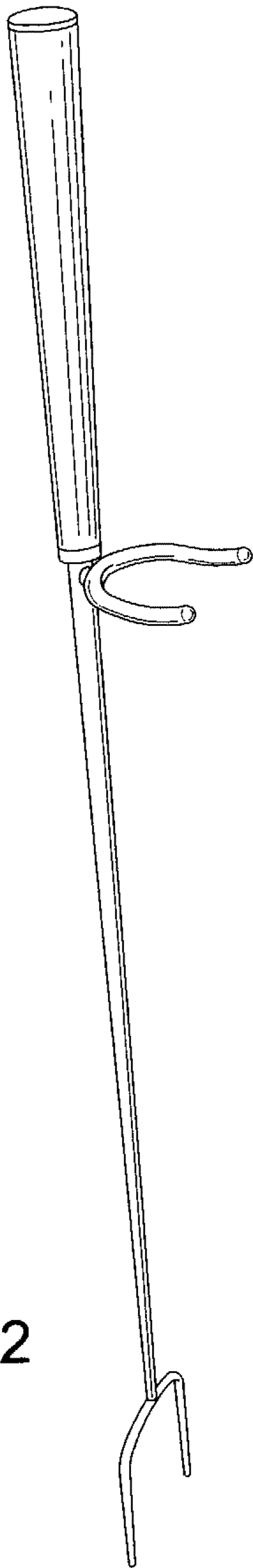

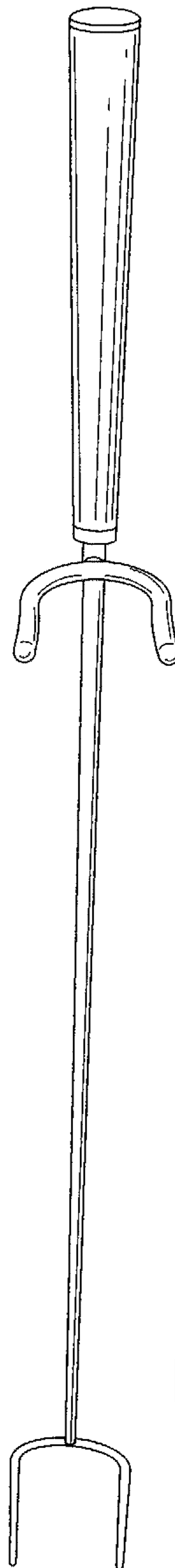

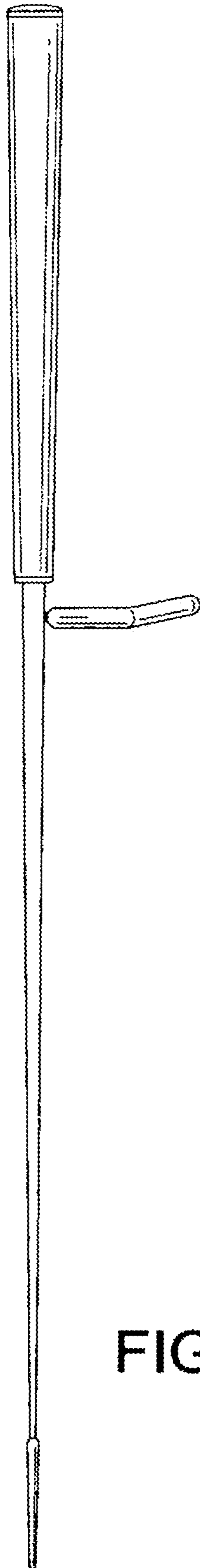

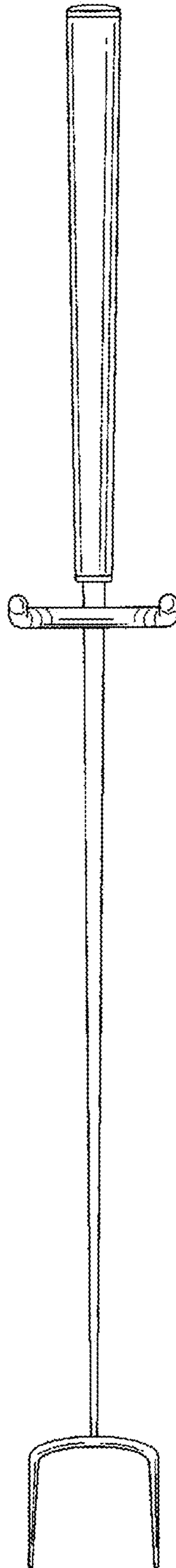

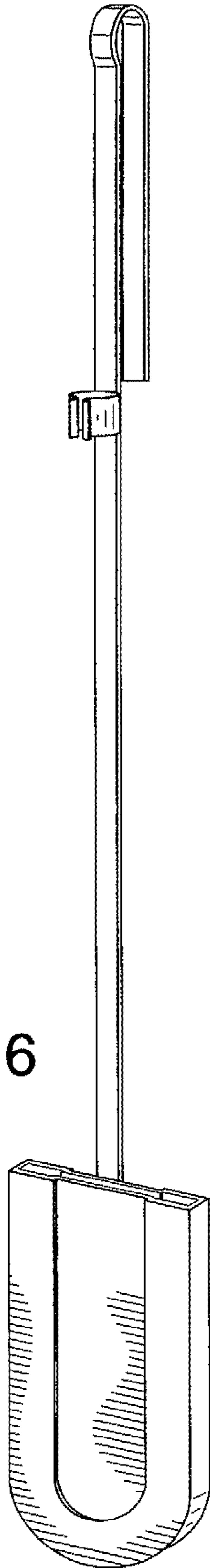

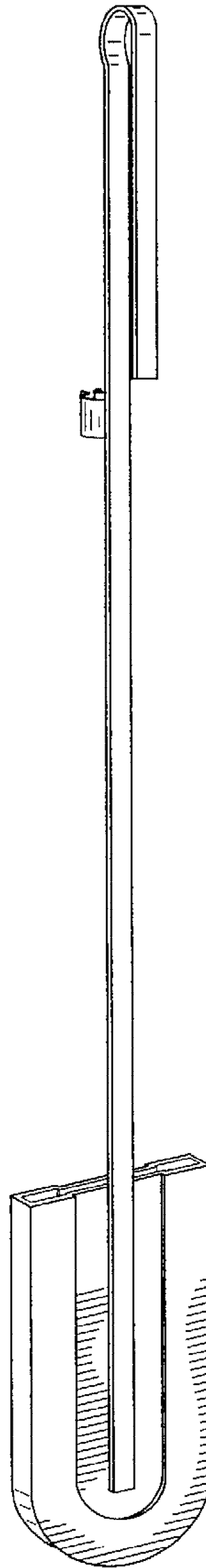

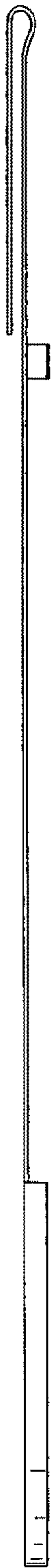

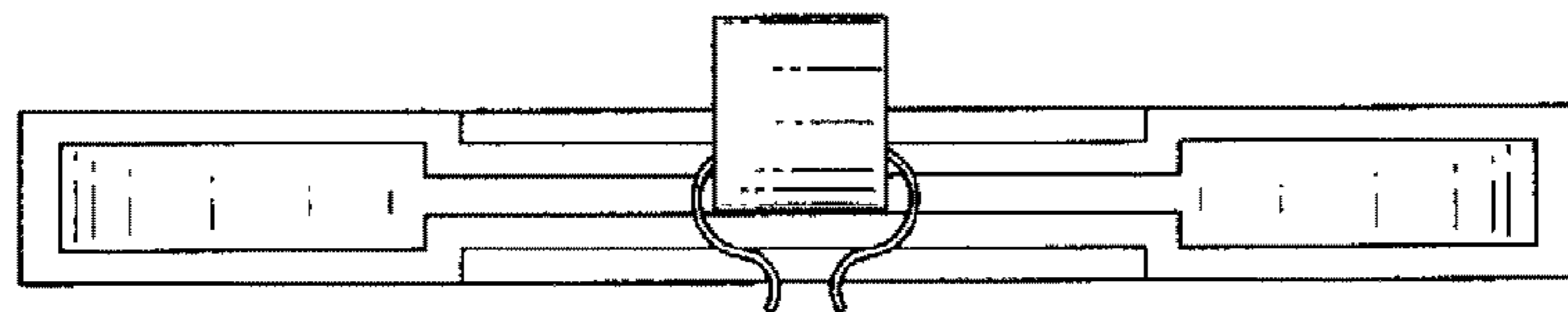
