(57) **CLAIM**

The ornamental design for face cozy for a continuous positive air pressure ventilation therapy mask, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a face cozy for a continuous positive air pressure ventilation therapy mask showing my new design;

FIG. 2 is a left side view thereof, the right side view being a mirror image;

FIG. 3 is a front view thereof;

FIG. 4 is a top view thereof; and,

FIG. 5 is a back view thereof.

The broken line showing of a person and a face mask is included for the purpose of illustrating environment and forms no part of the claimed design.

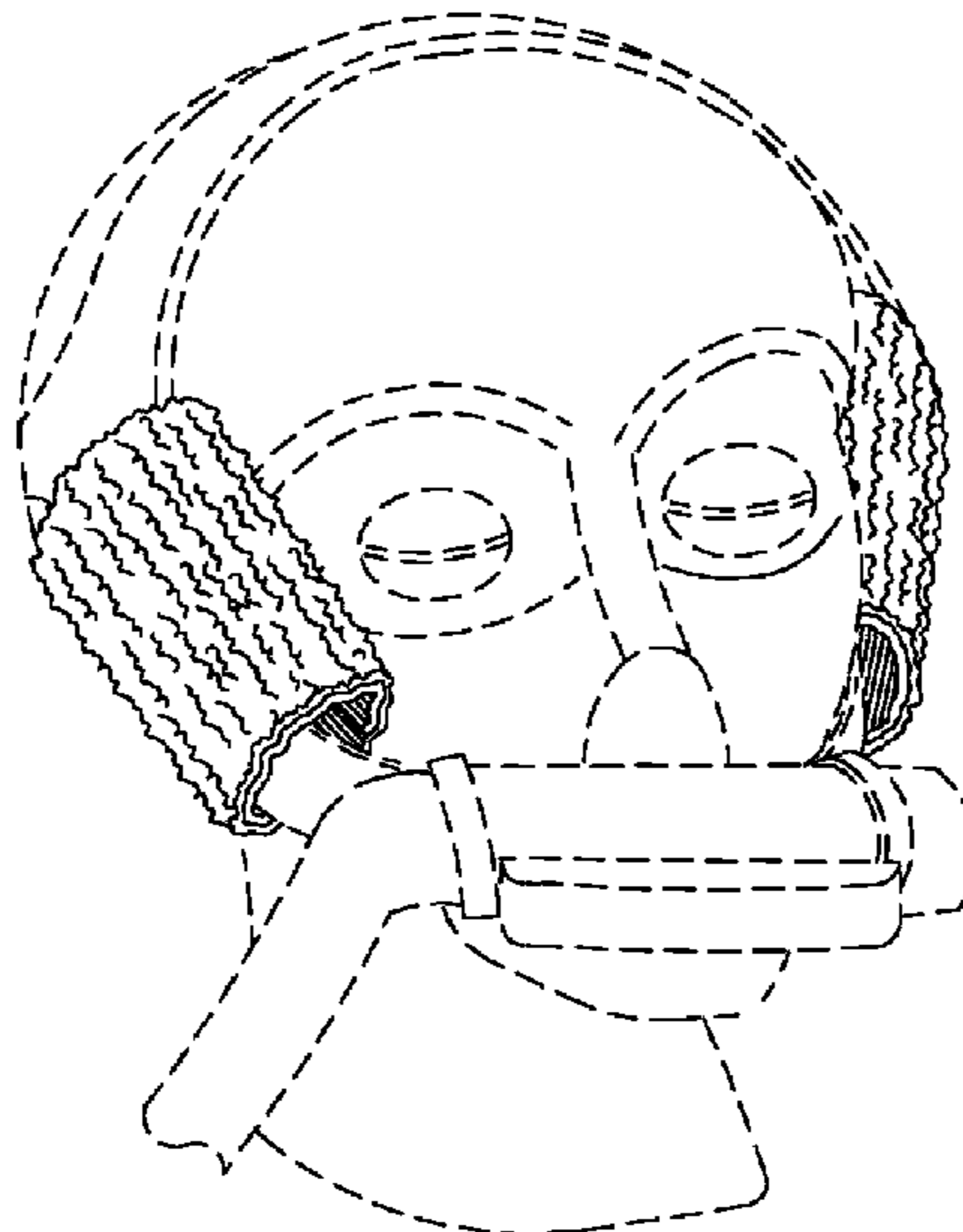

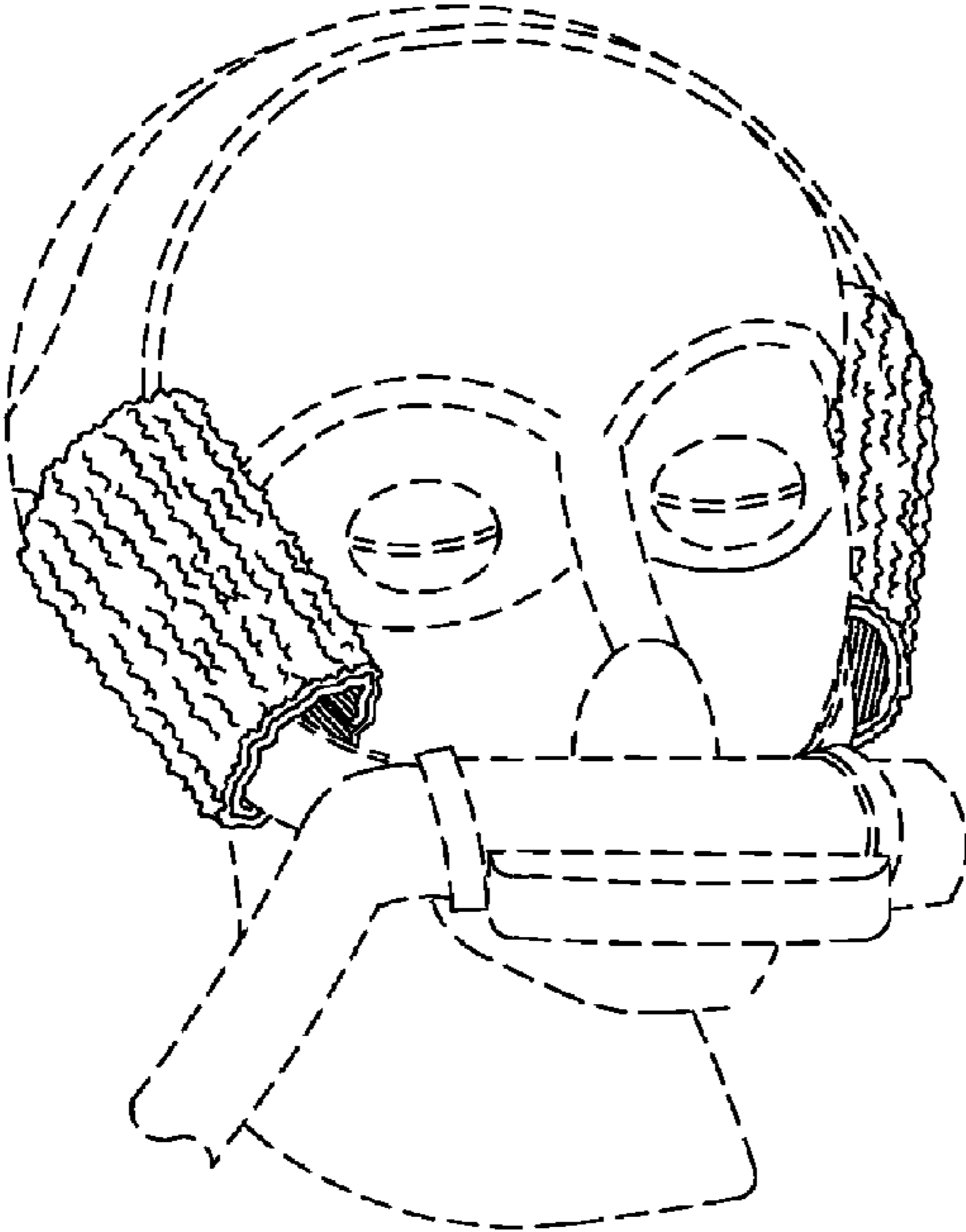

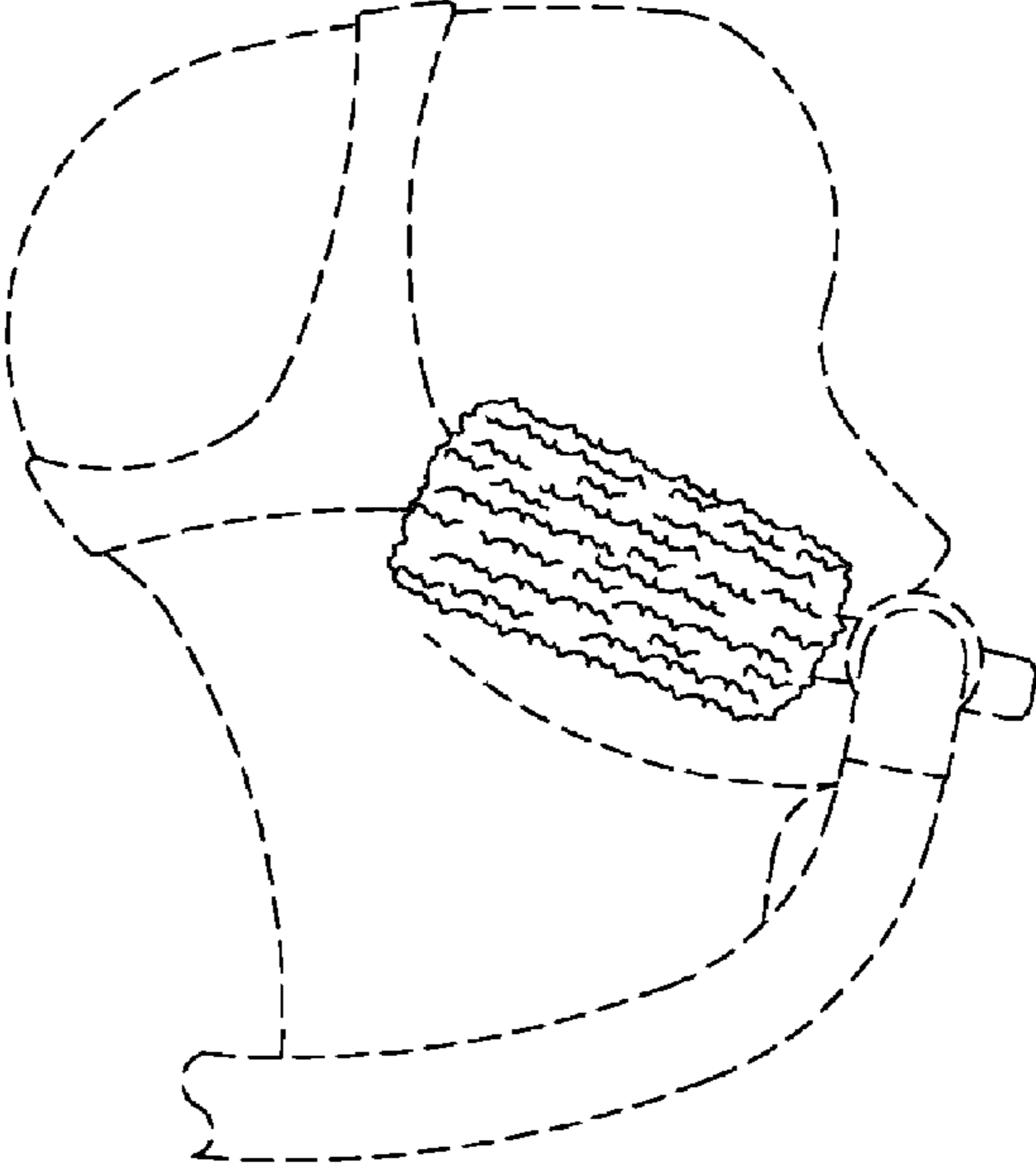

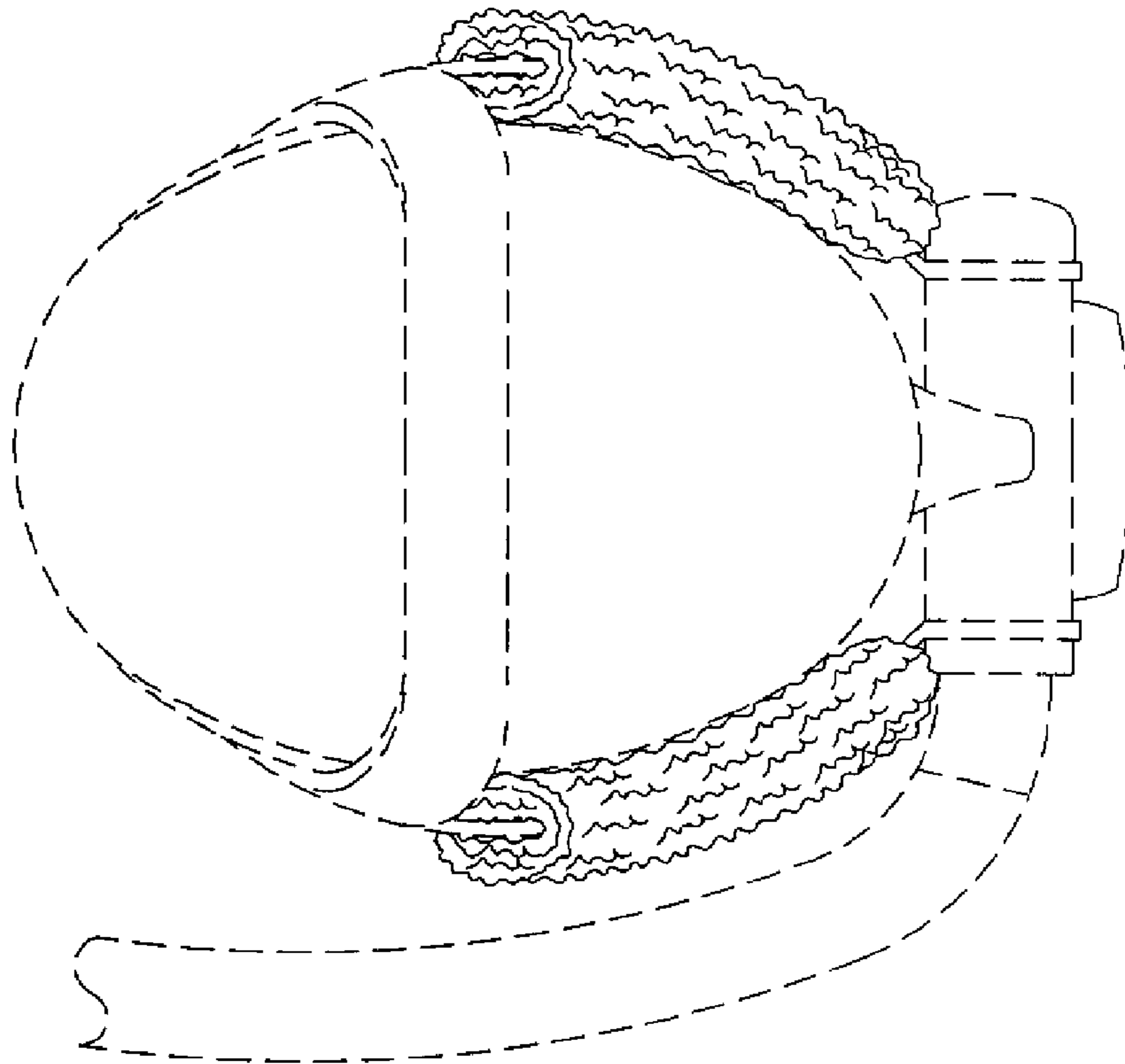

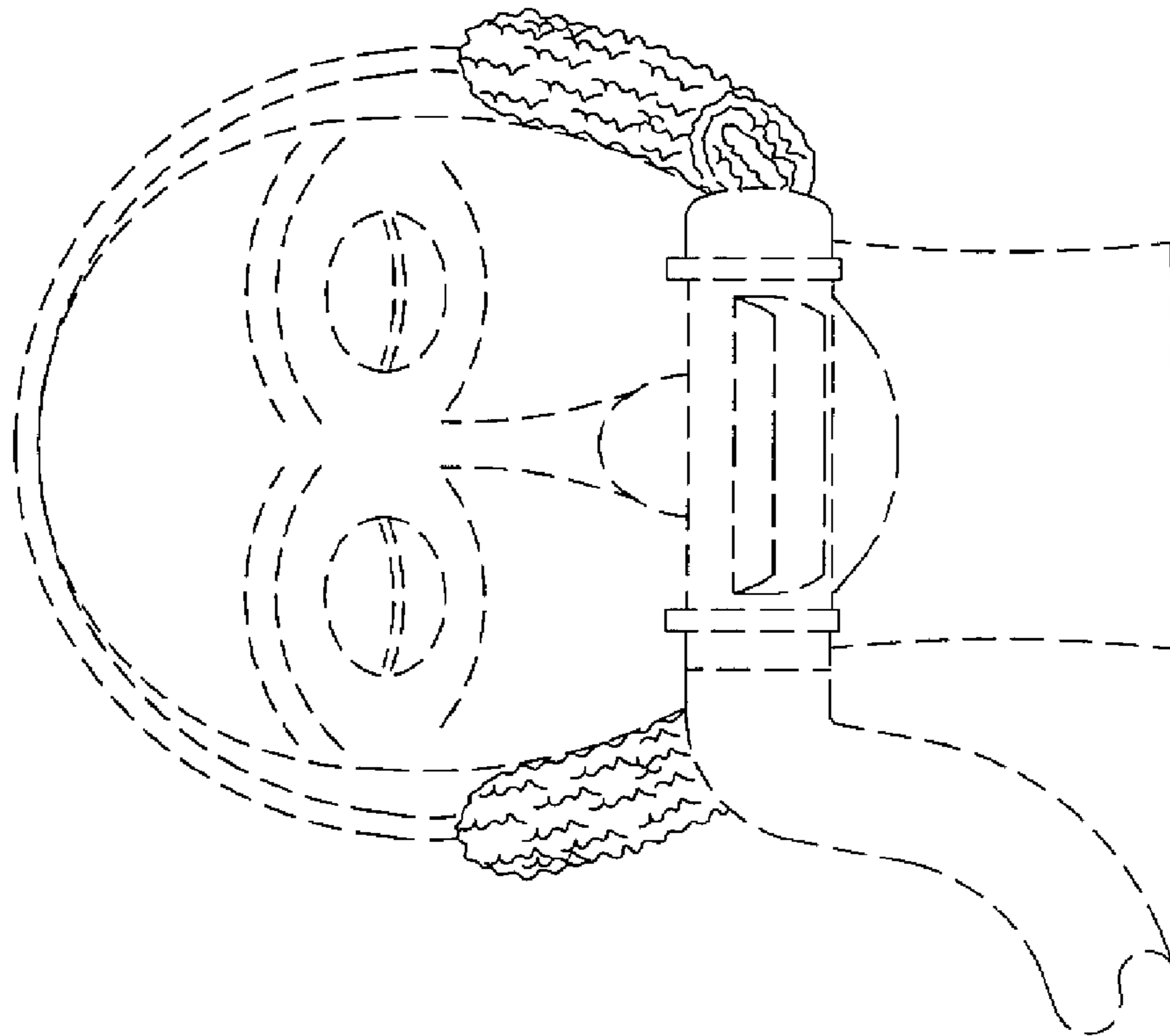
