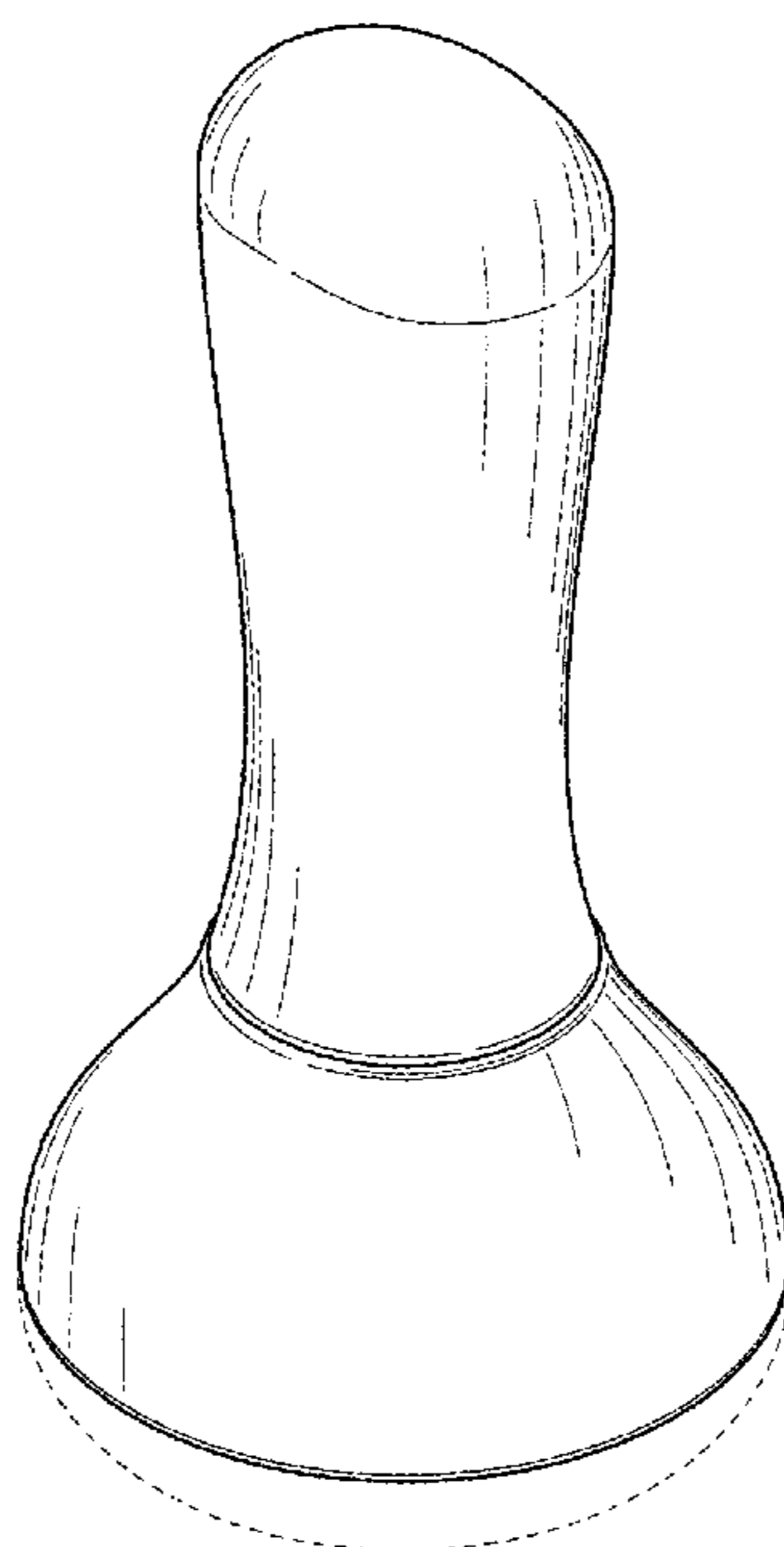
(57) **CLAIM**

The ornamental design for a skin treatment applicator, as shown and described.

DESCRIPTION

FIG. 1 shows a top, front, right side perspective view of the skin treatment applicator;
 FIG. 2 shows a front elevational view of the skin treatment applicator;
 FIG. 3 shows a back elevational view of the skin treatment applicator;
 FIG. 4 shows a right side elevational view of the skin treatment applicator;

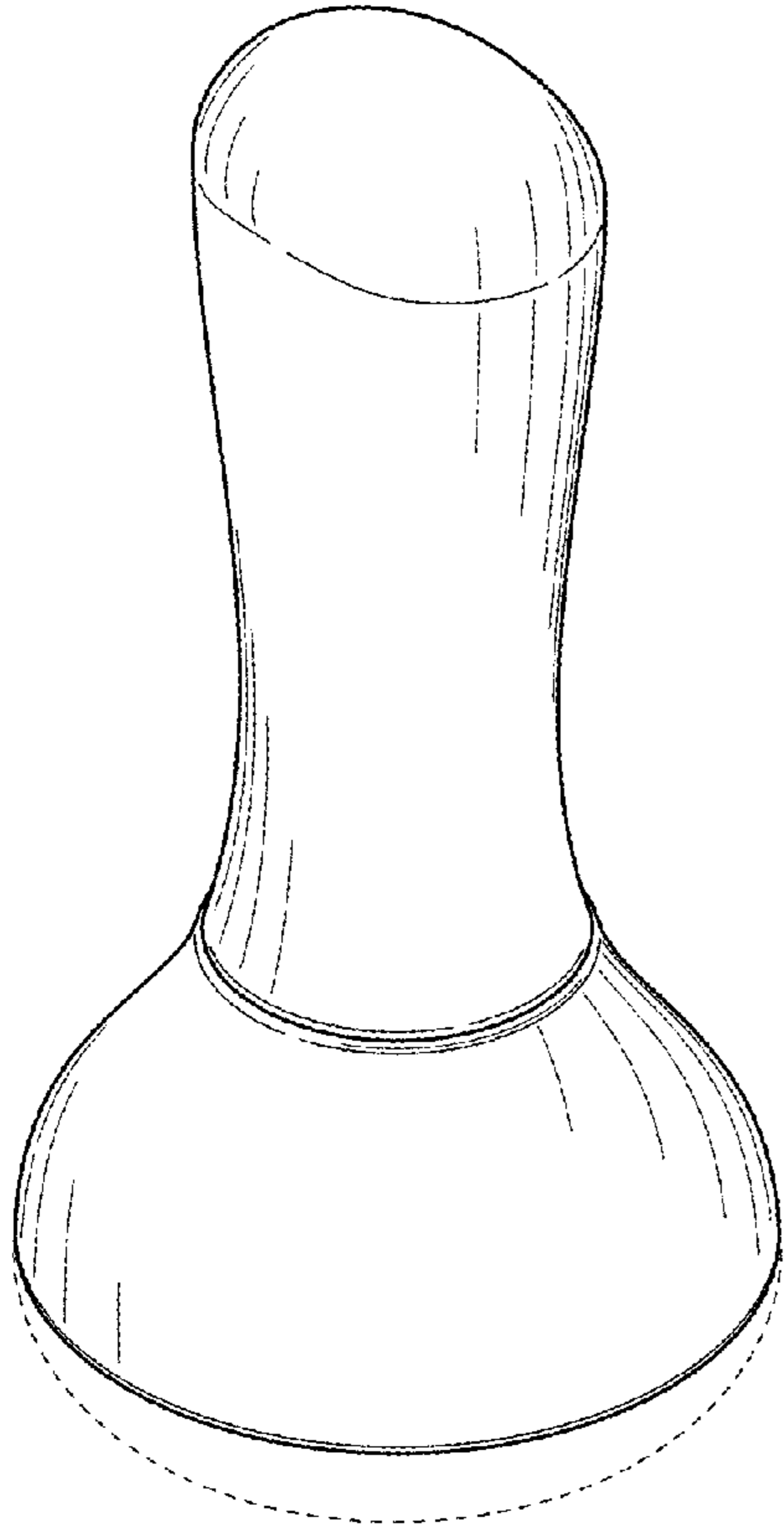

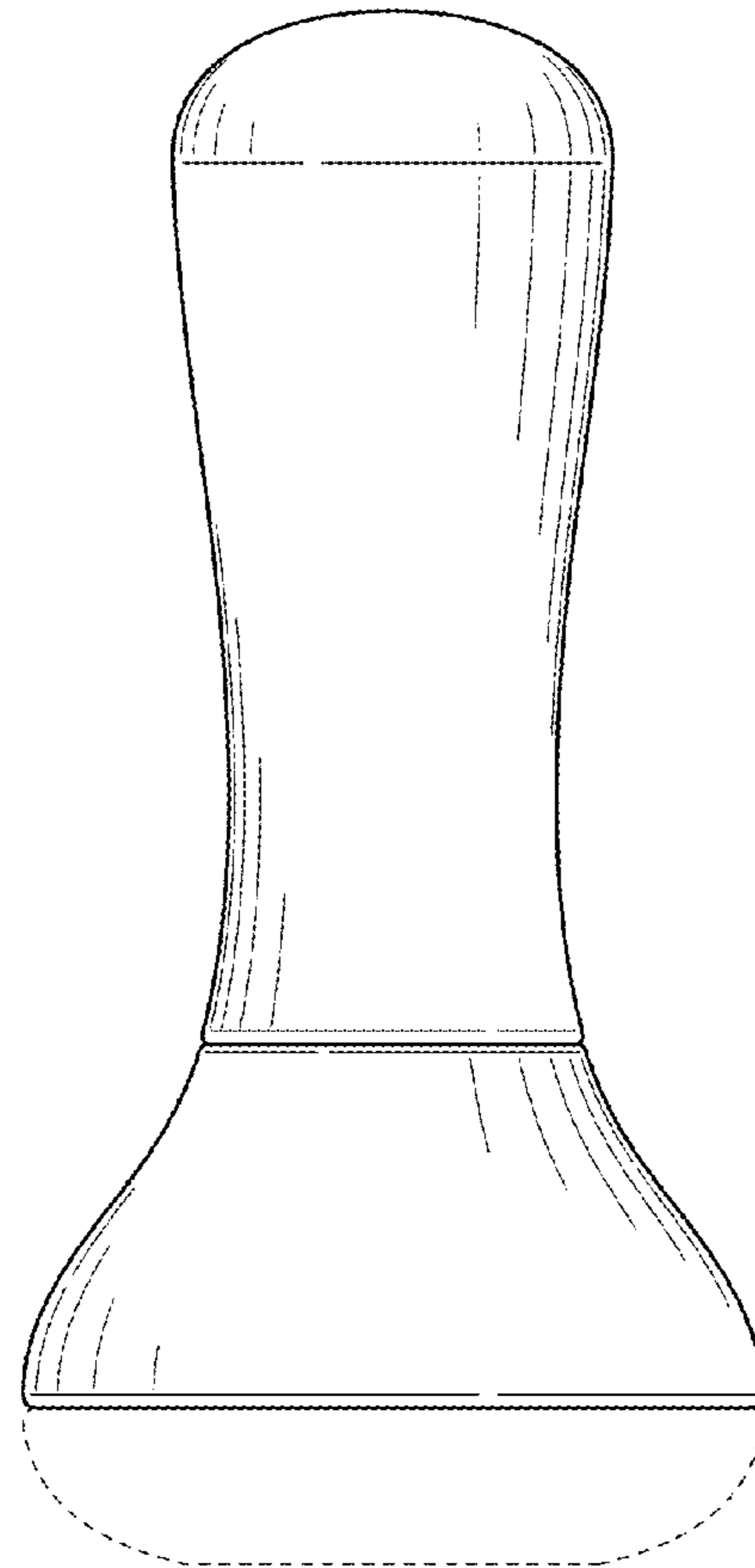

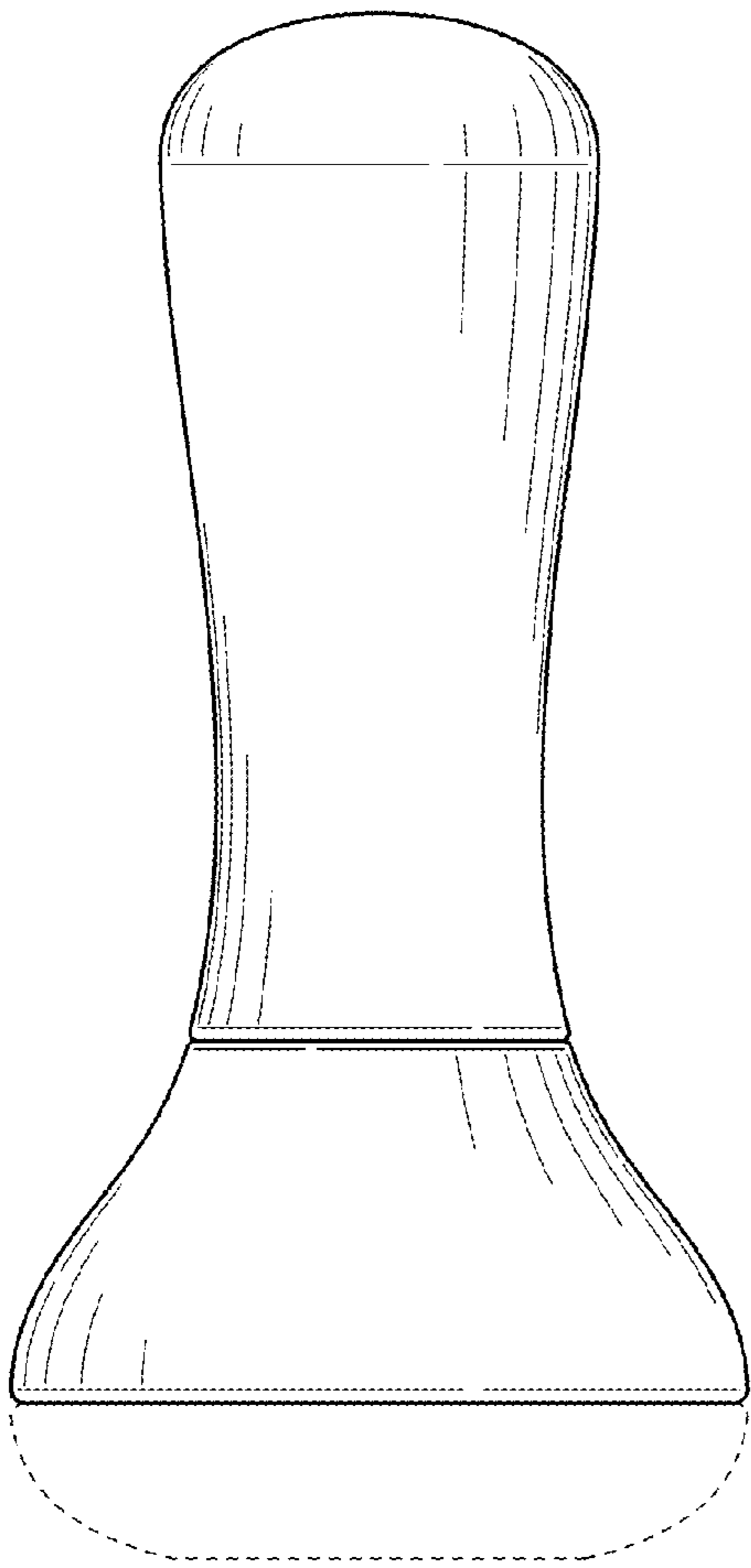

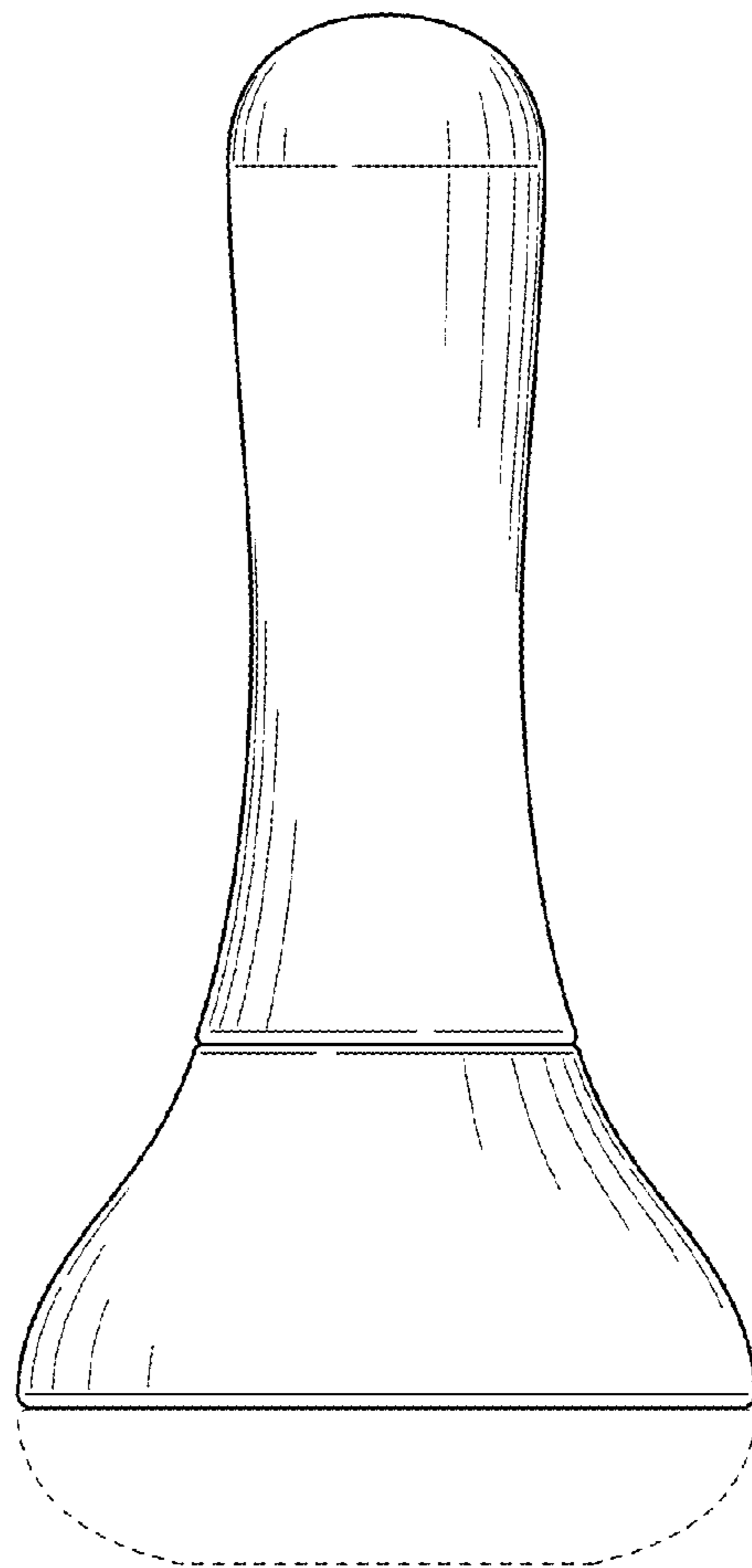

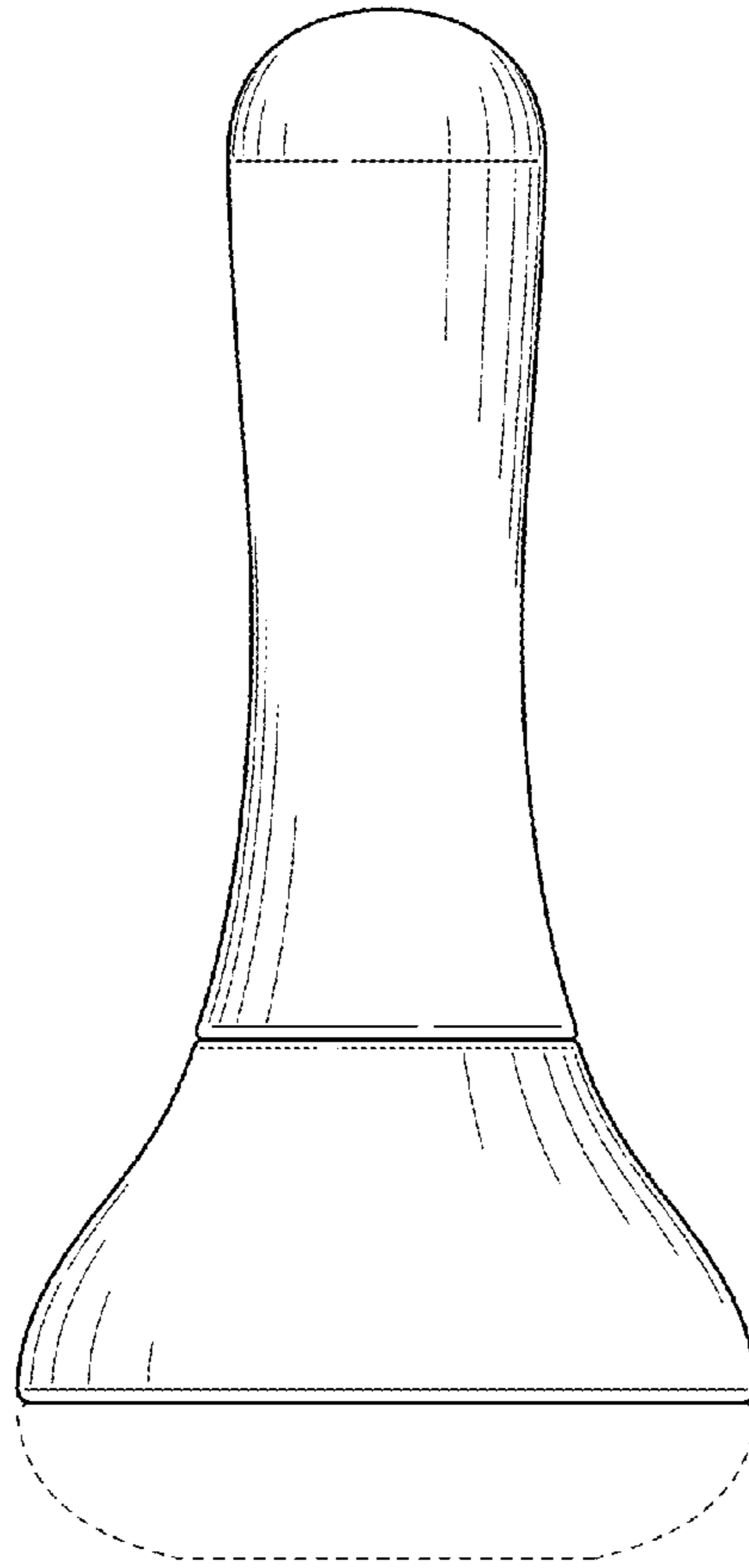

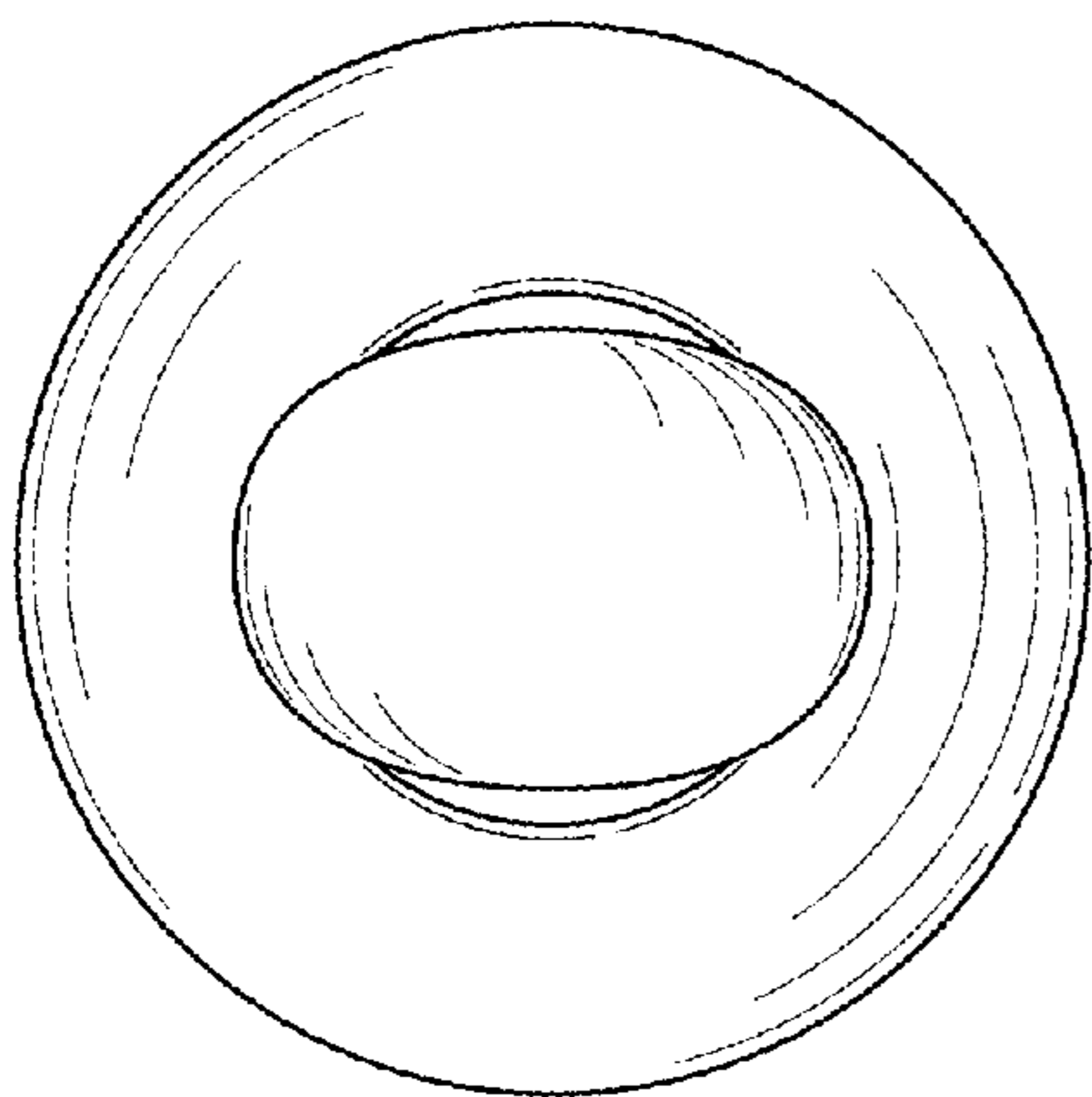

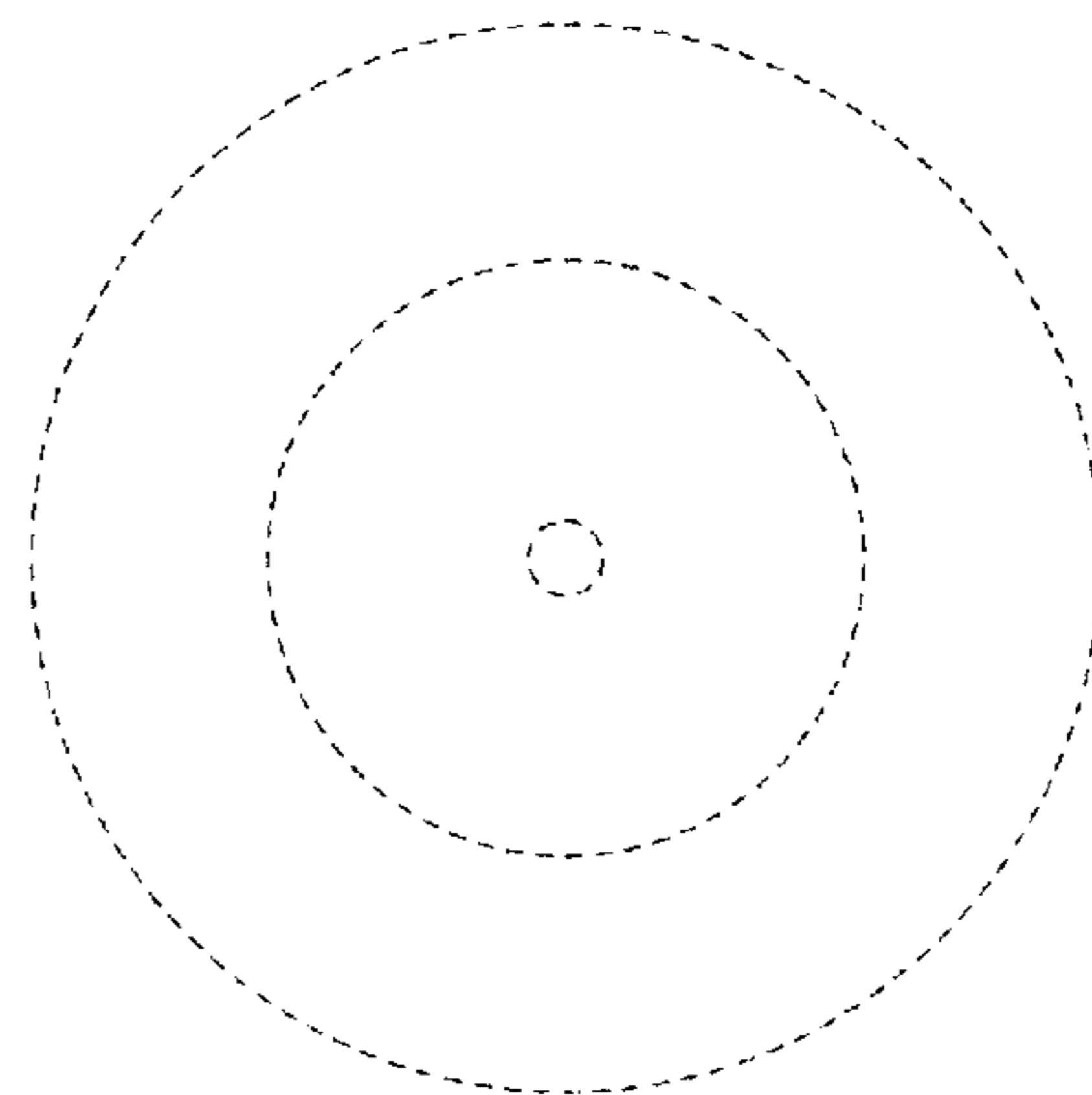
