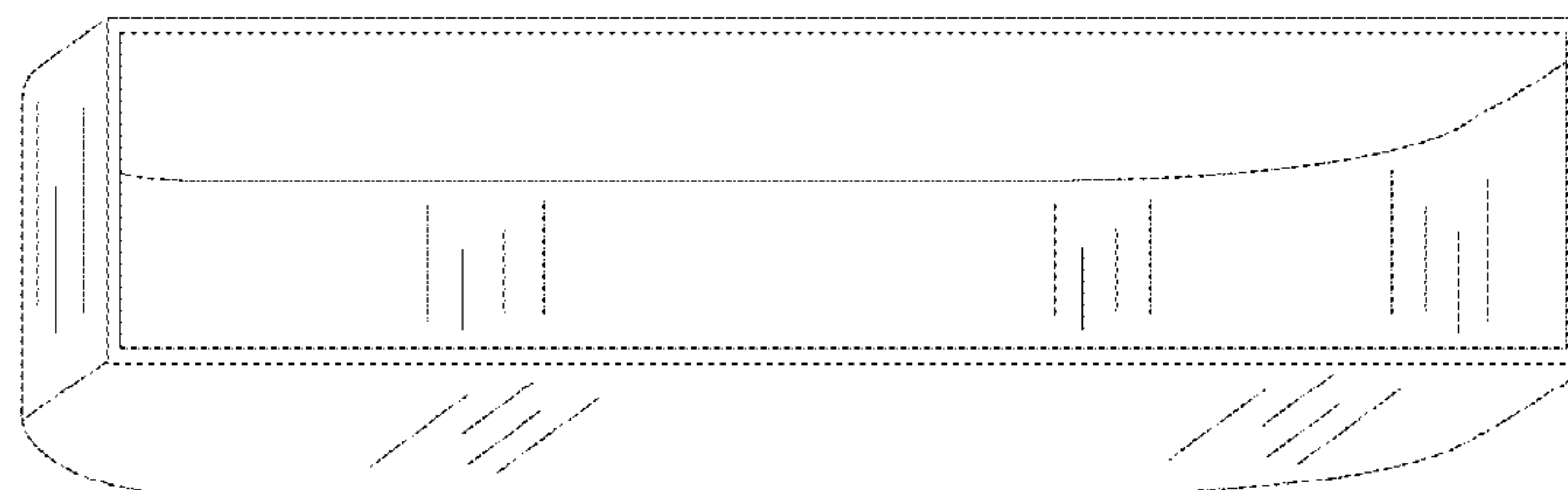
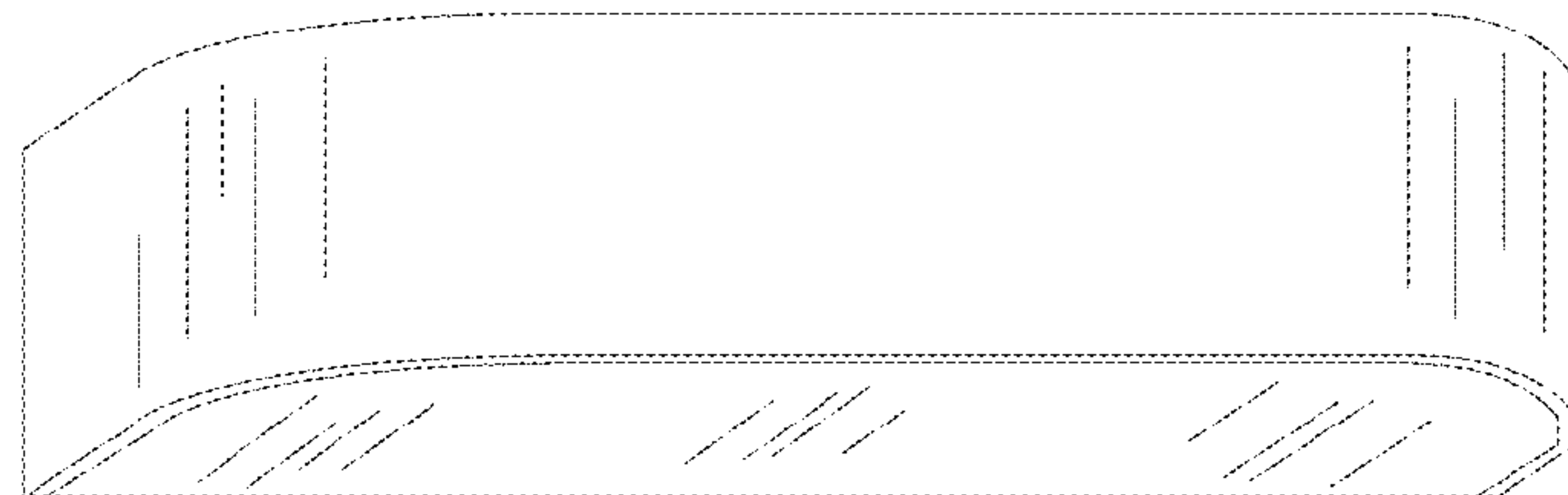
FIG. 1 is a lower perspective view from the front of the rounded shade for vanity shadow box.

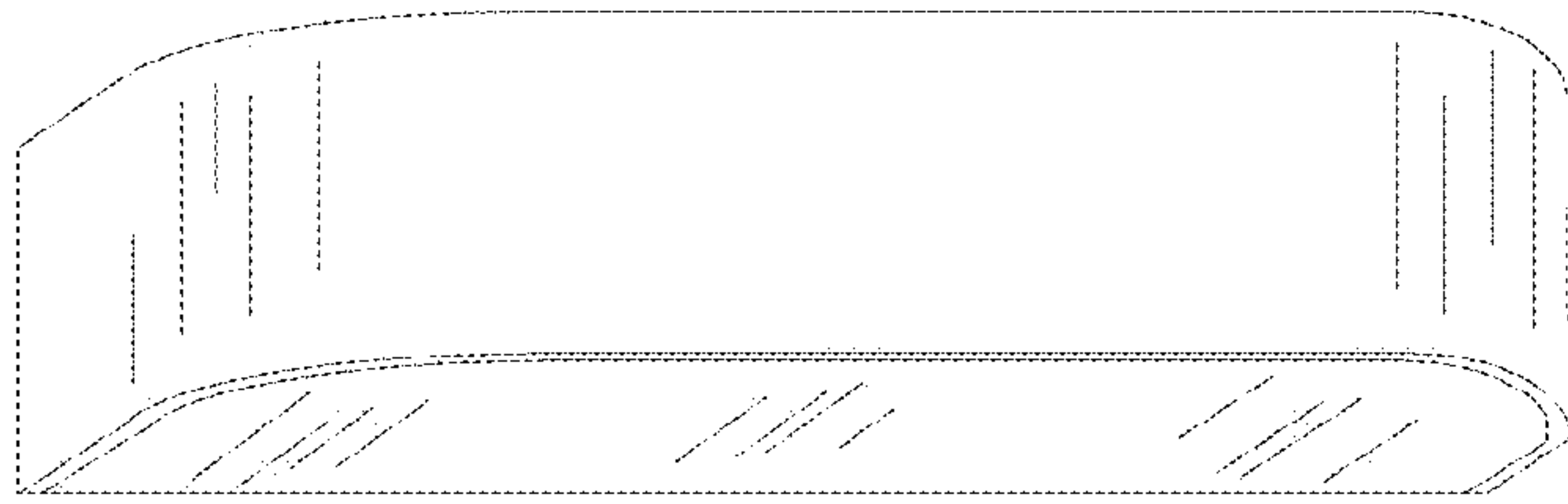

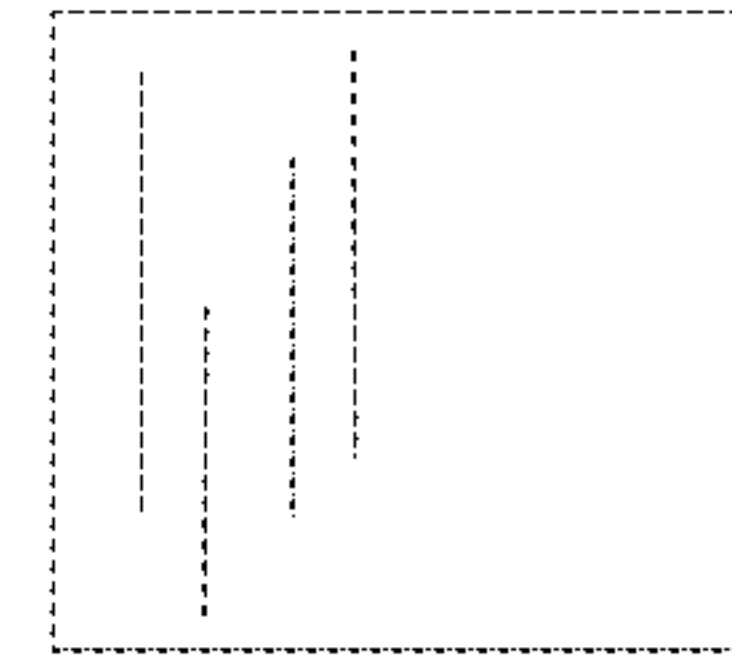

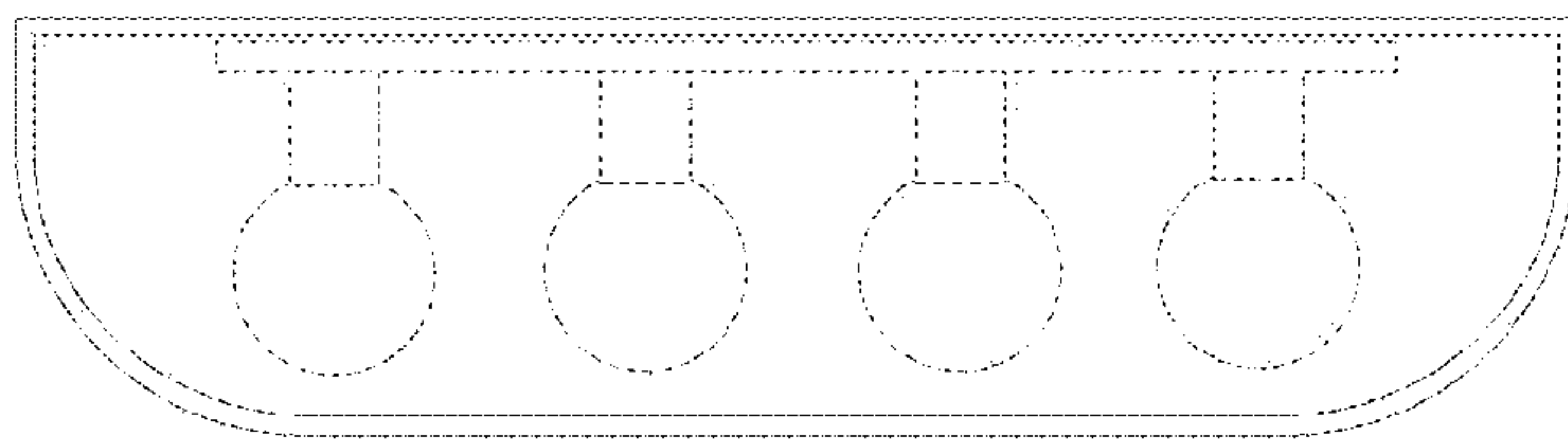

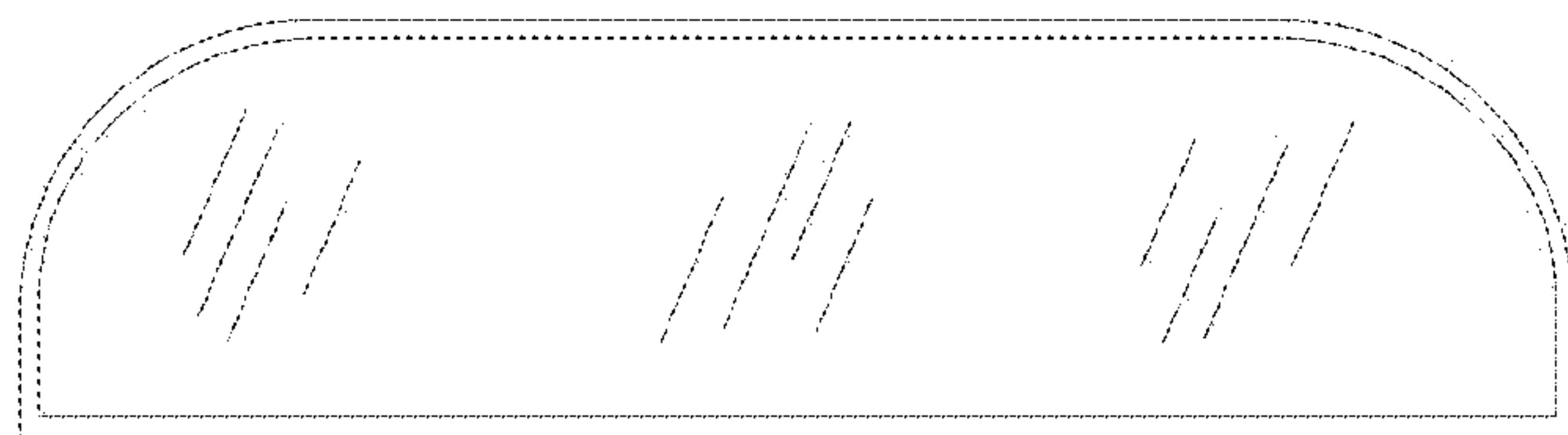

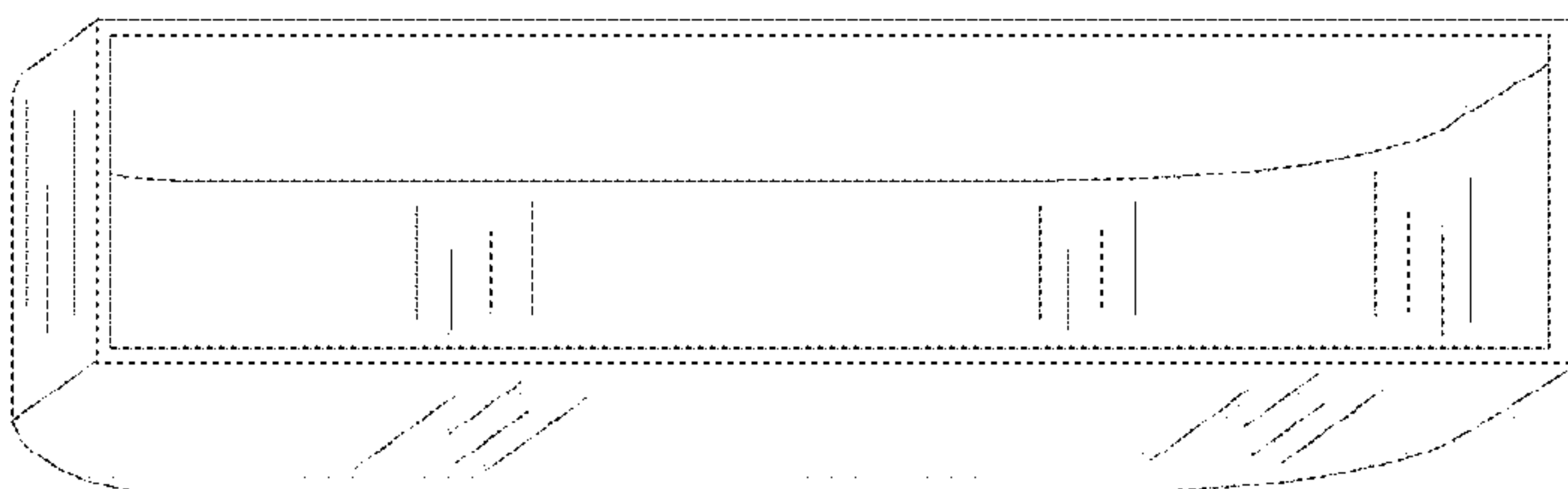
