(57) **CLAIM**

We claim the ornamental design for a novelty headband, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a novelty headband, showing the new design.

FIG. 2 is a right side elevational view thereof, the left side elevational view being the mirror image of the right side elevational view;

FIG. 3 is a front elevational view thereof;

FIG. 4 is another perspective view of the novelty headband of FIG. 1; and,

FIG. 5 is another perspective view of the novelty headband of FIG. 1.

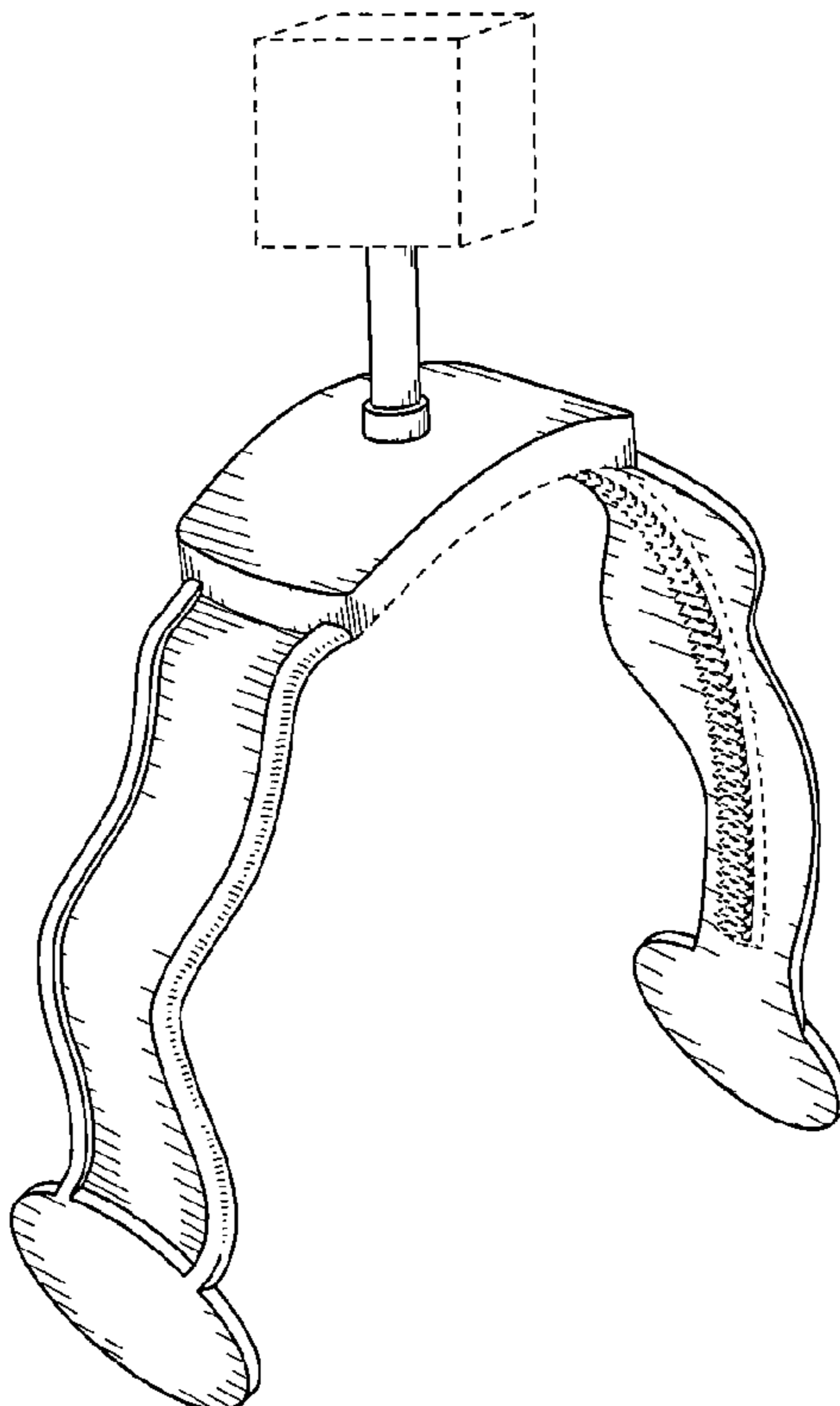

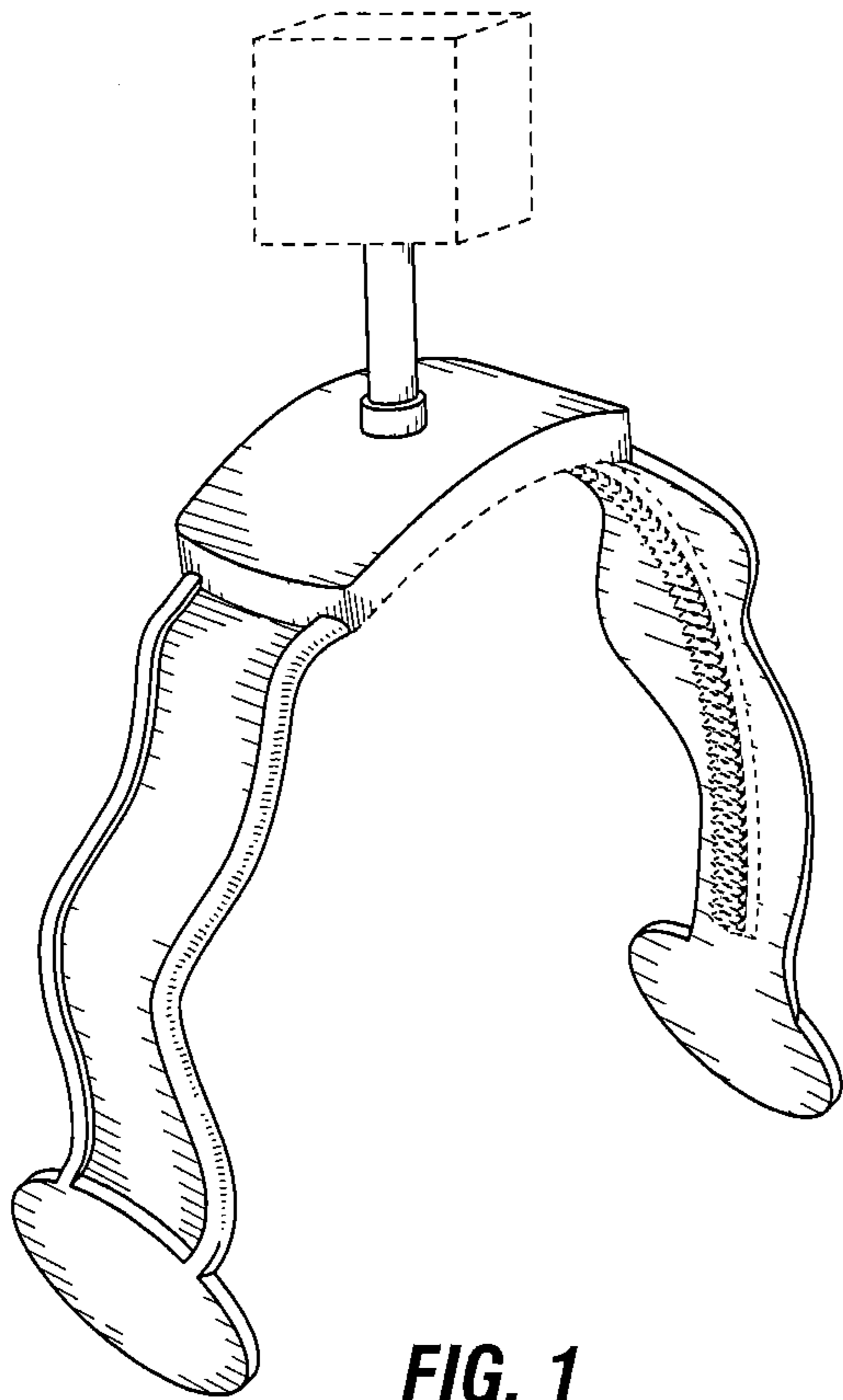

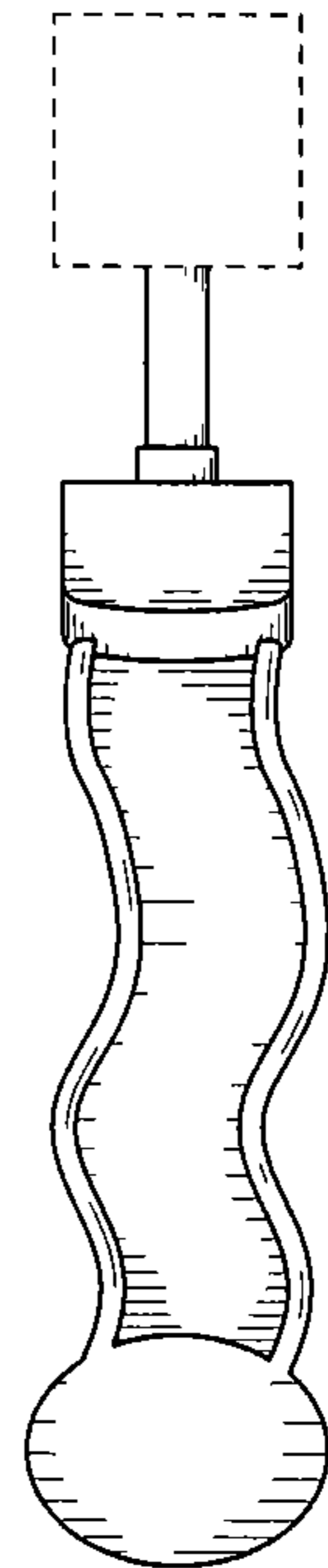

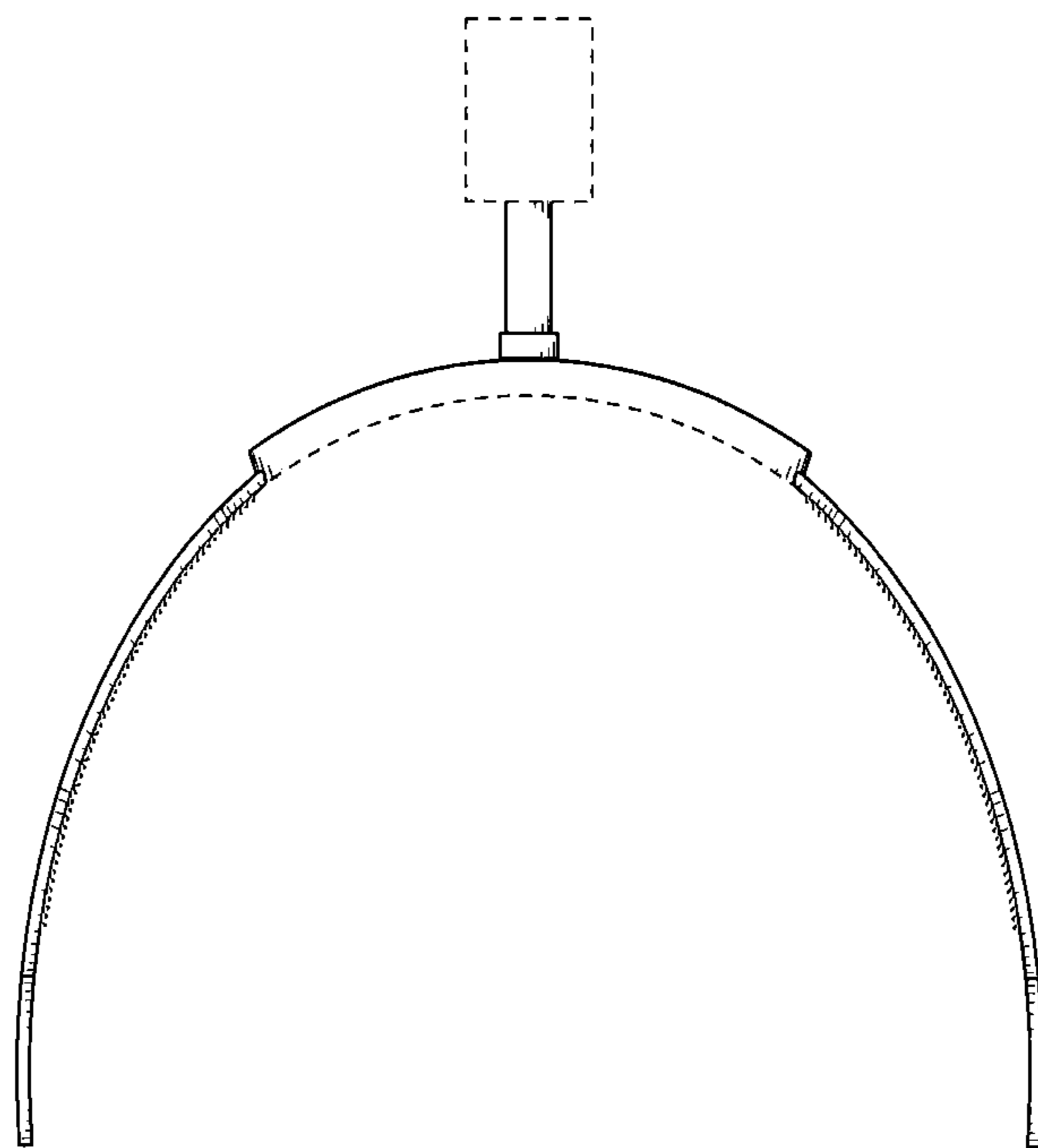




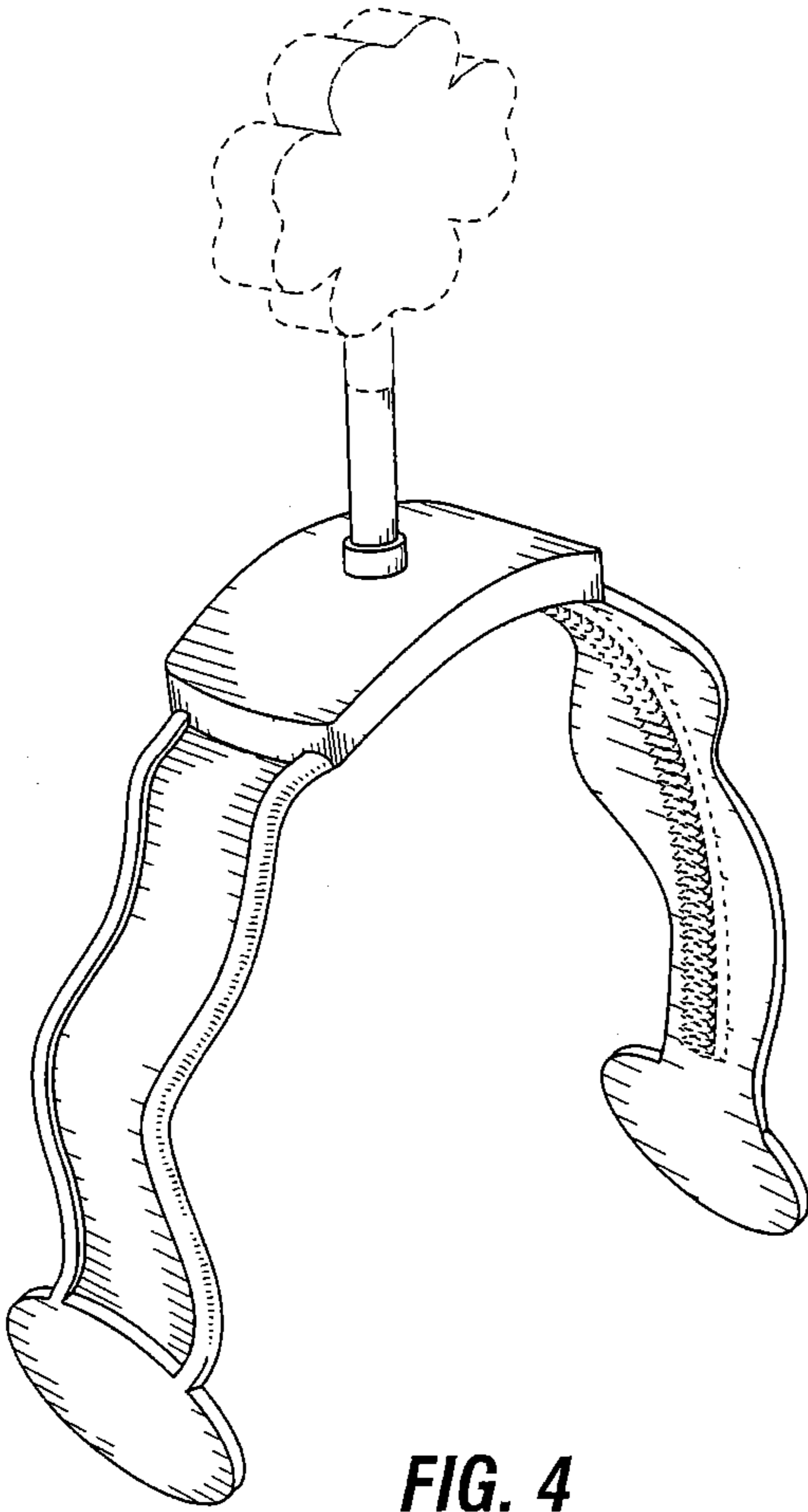

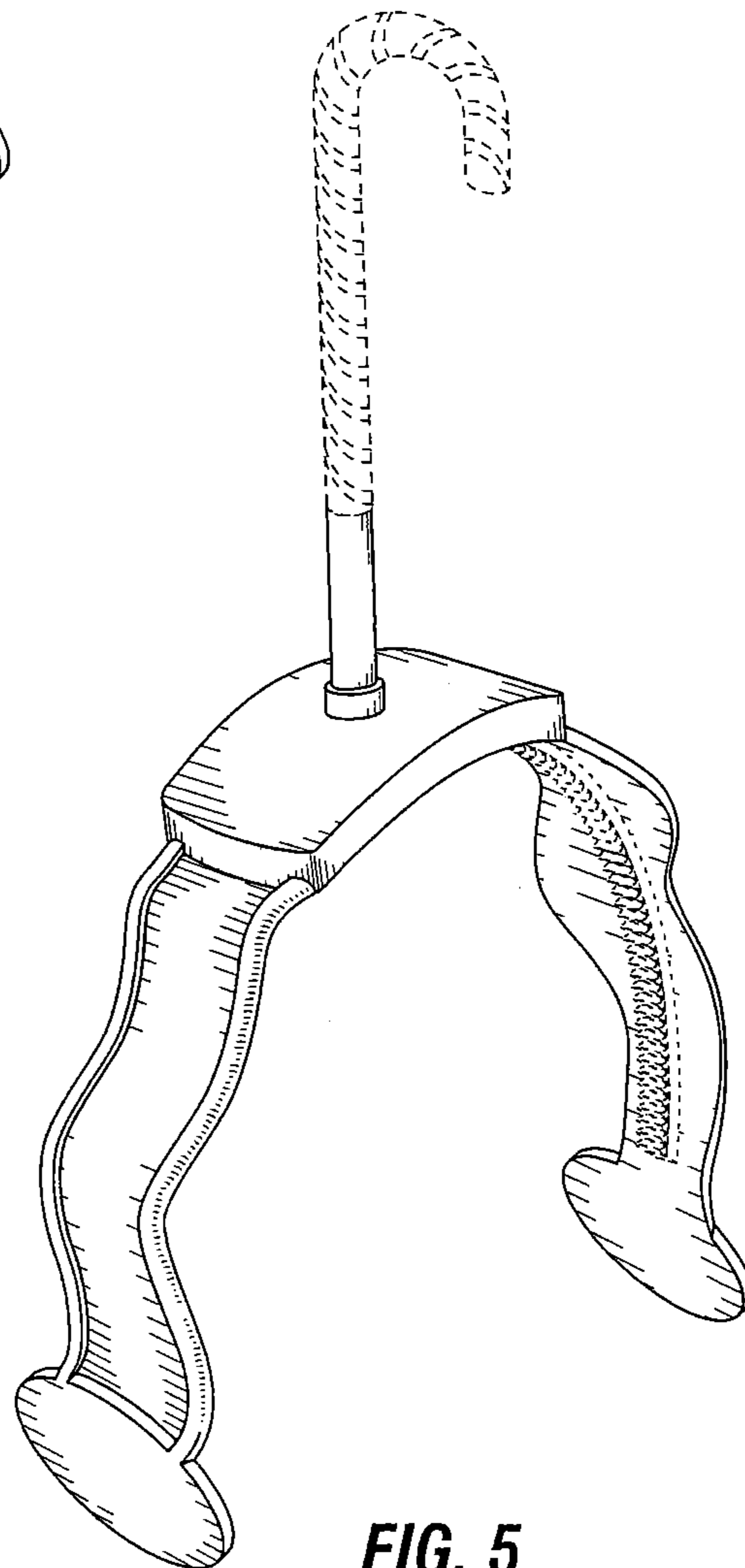
