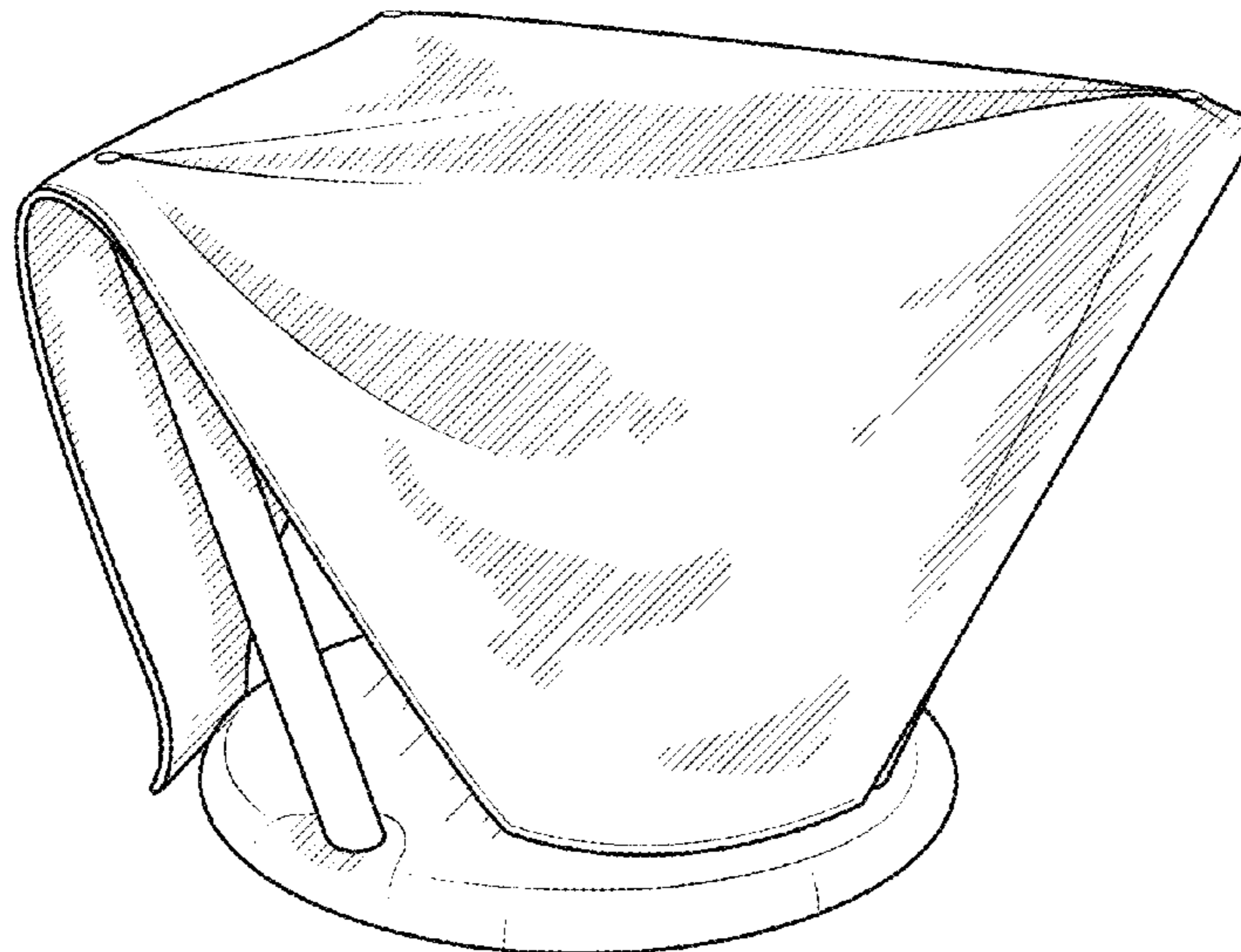
(57) **CLAIM**

The ornamental design for a pet hammock, as shown.

DESCRIPTION

FIG. 1 is a perspective view of the pet hammock of the present invention as seen from a first rotational view; FIG. 2 is a perspective view of the pet hammock of FIG. 1 as seen from a second rotational view; FIG. 3 is a perspective view of the pet hammock of FIG. 1 as seen from a third rotational view showing the fabric hanging over the edge of the base which is a different position from the fabric on the right side of FIG. 1; and, FIG. 4 is a top plan view in elevation of the pet hammock of FIG. 1.

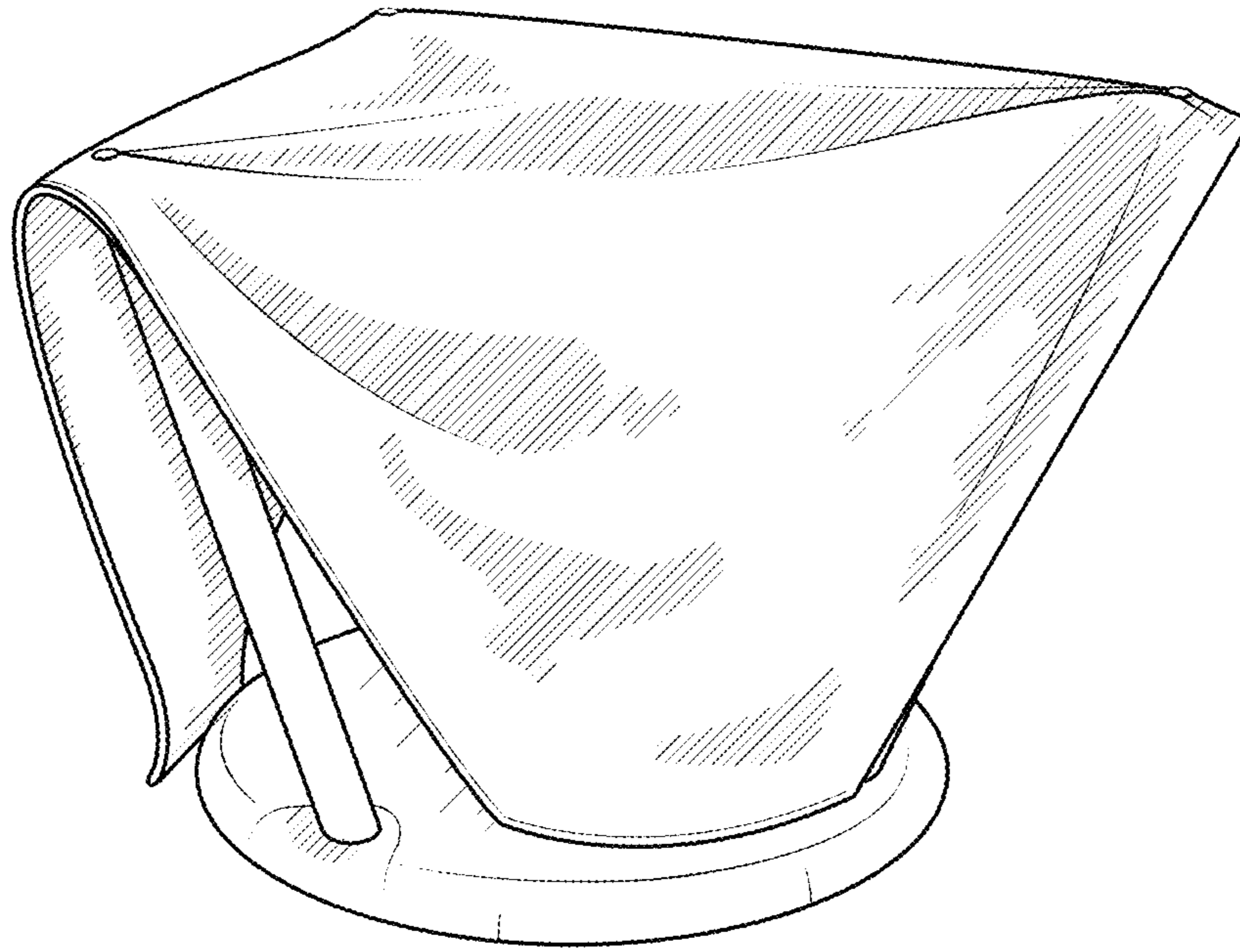

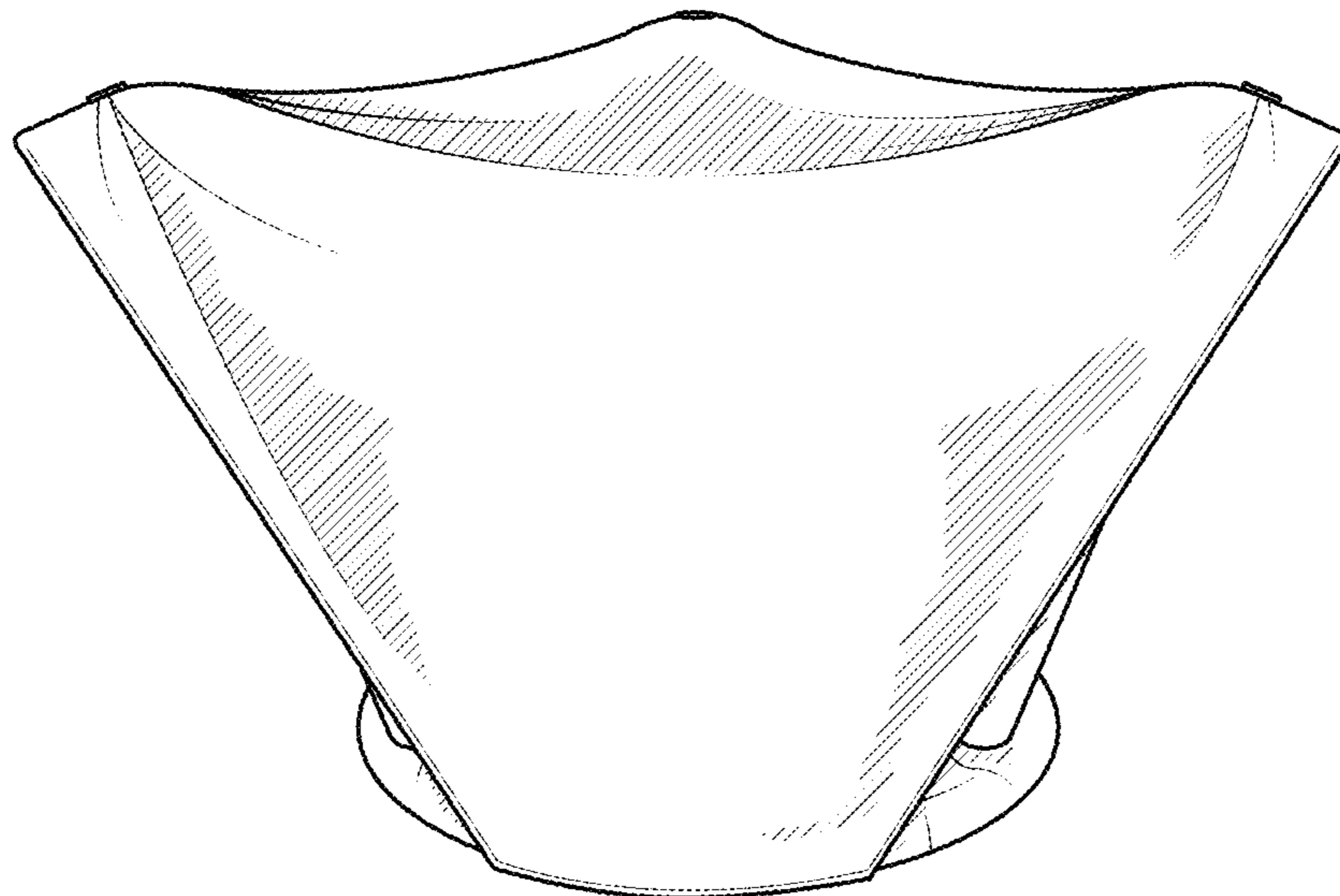

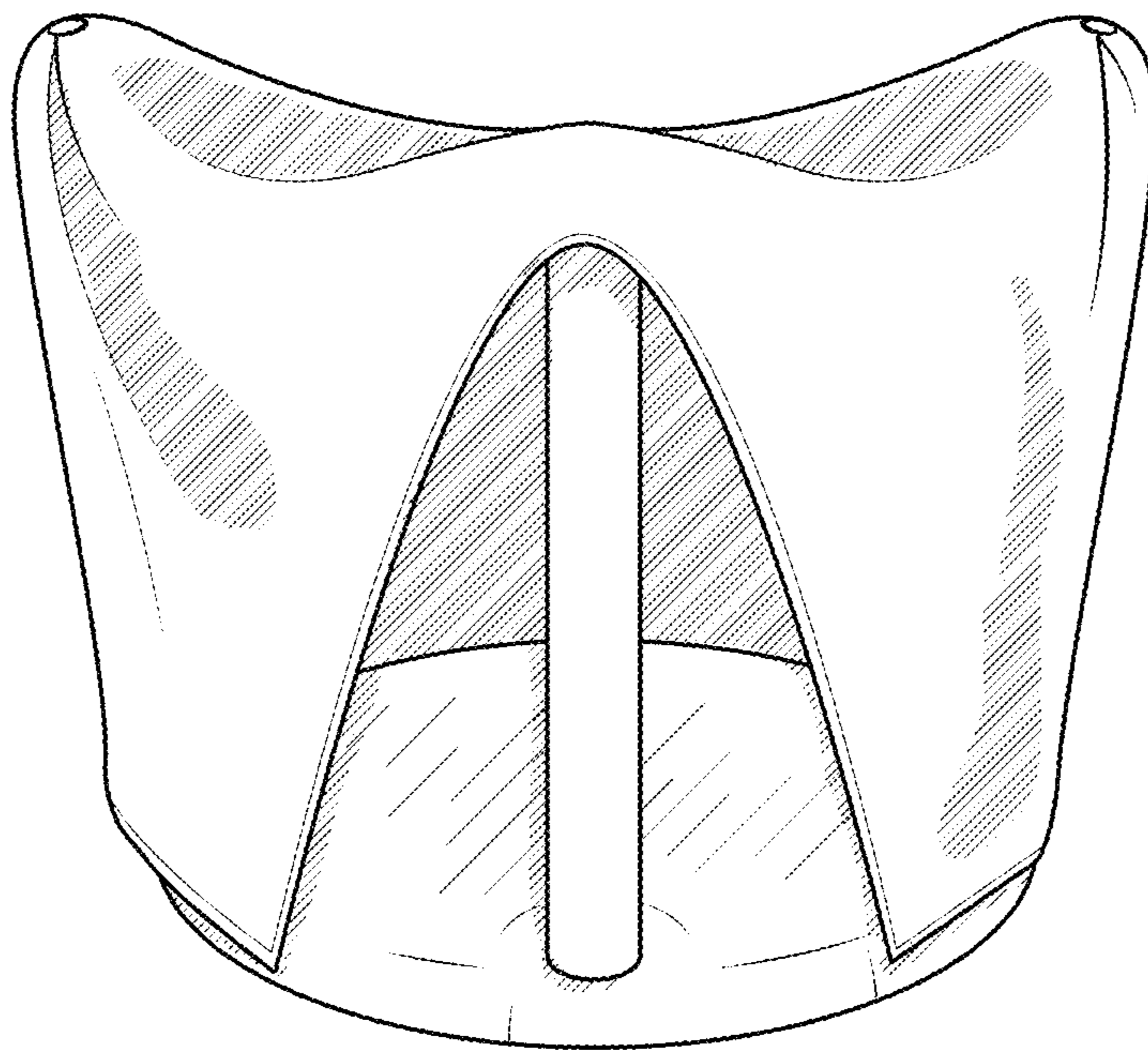

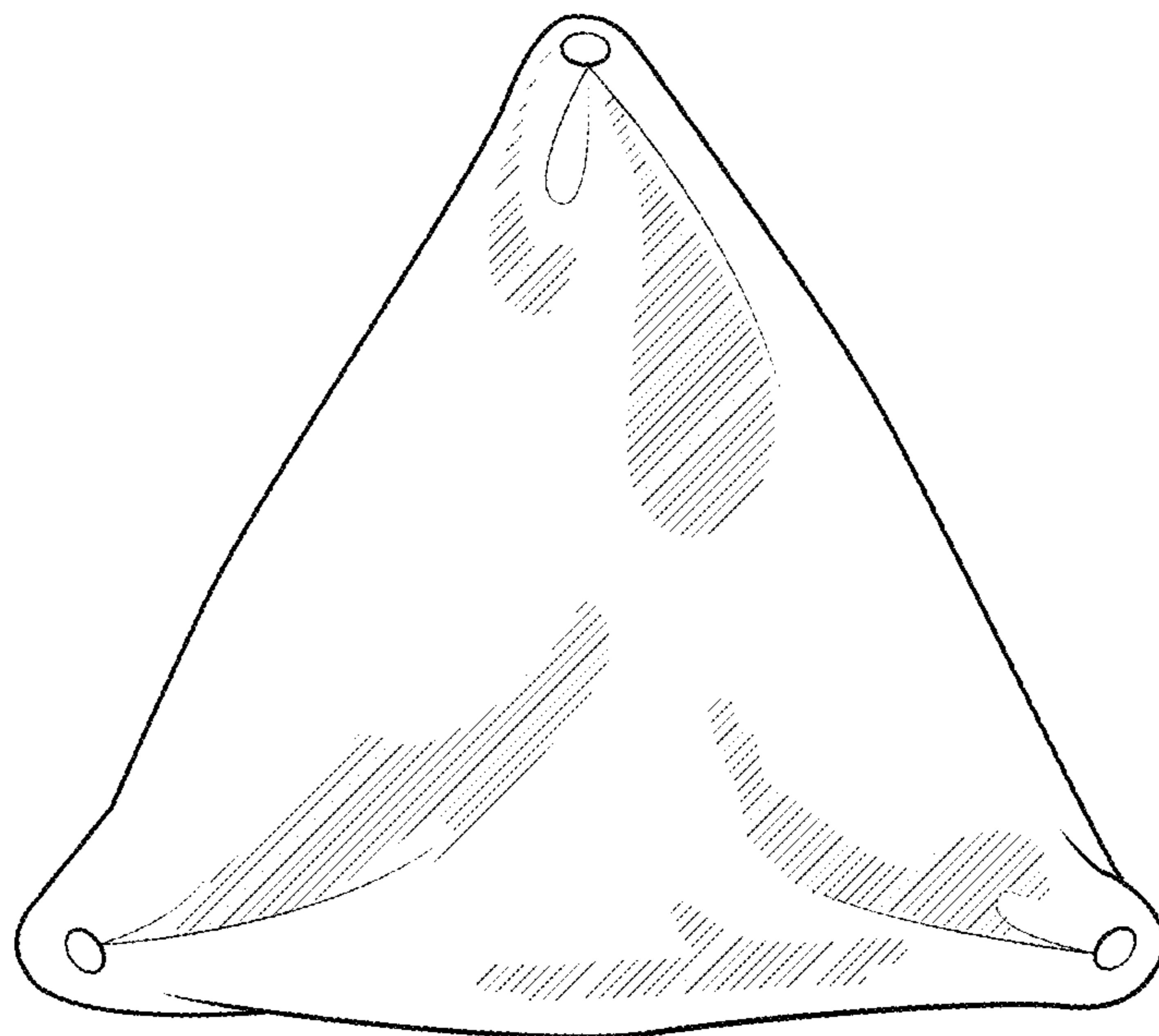
