The ornamental design for a collar for animal, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a collar for animal showing my new design;

FIG. 2 is an enlarged partial perspective view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a side elevational view, the opposite side being a mirror image thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a first end elevational view thereof; and,

FIG. 7 is a second end elevational view thereof.

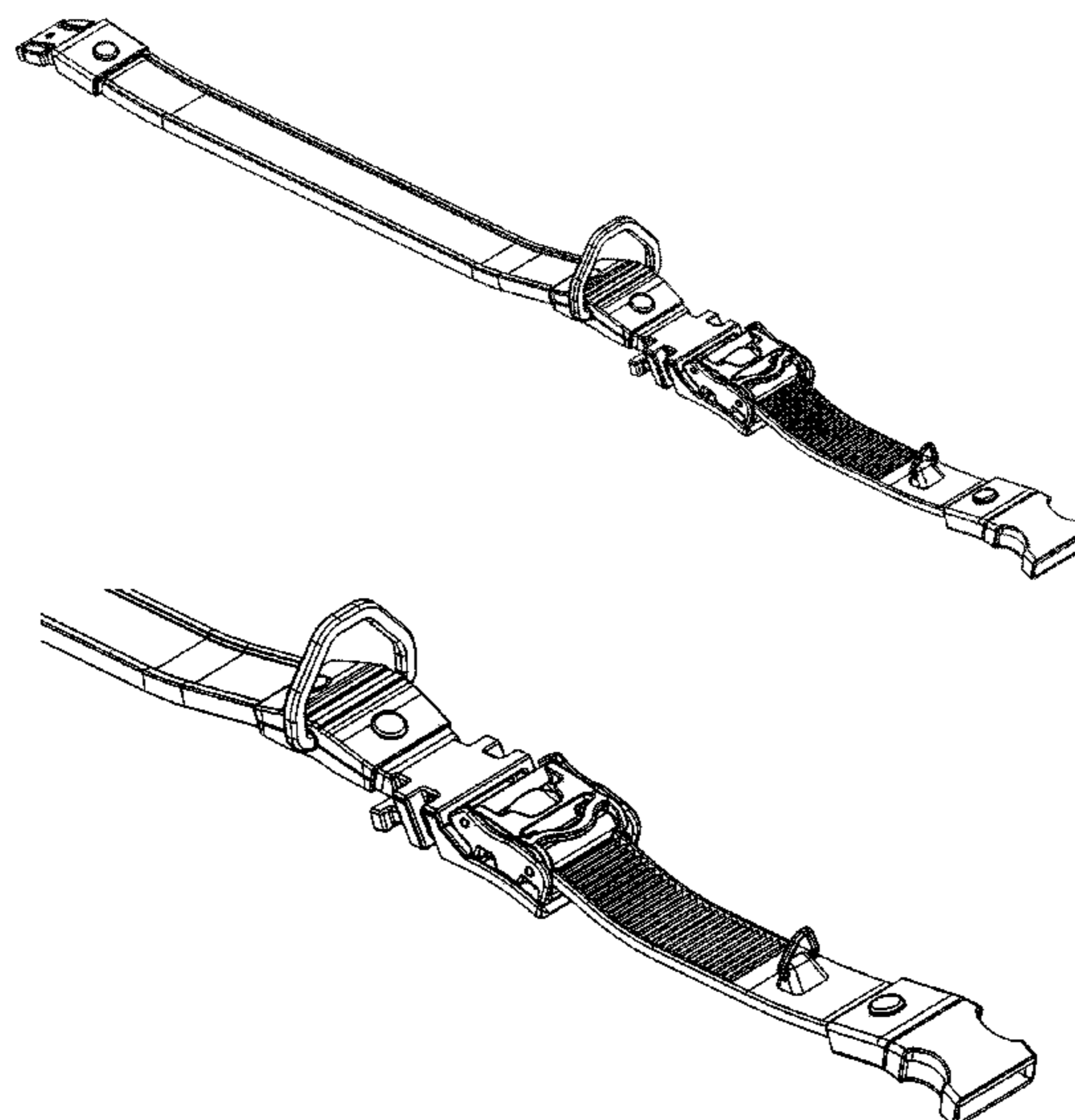

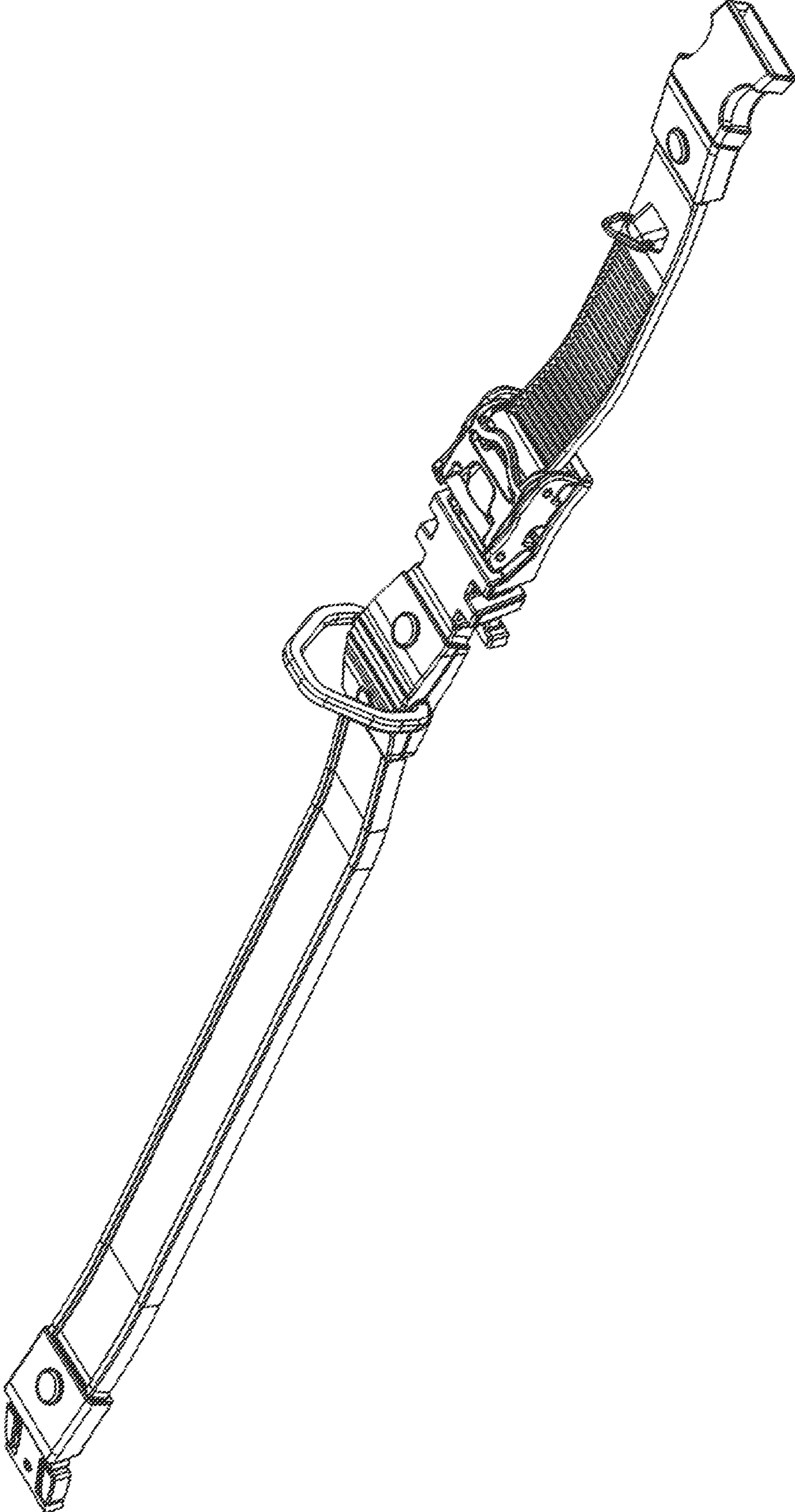

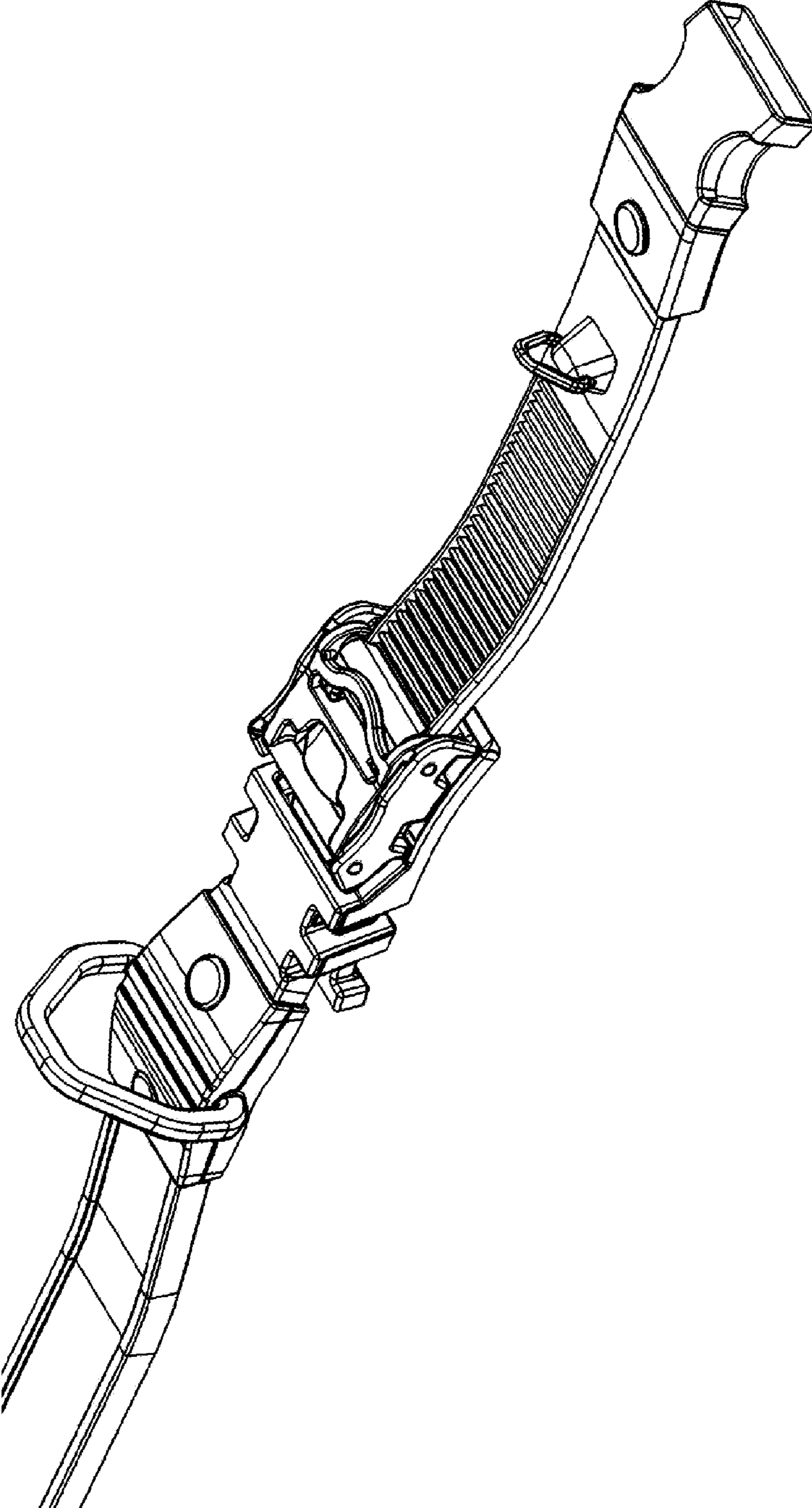

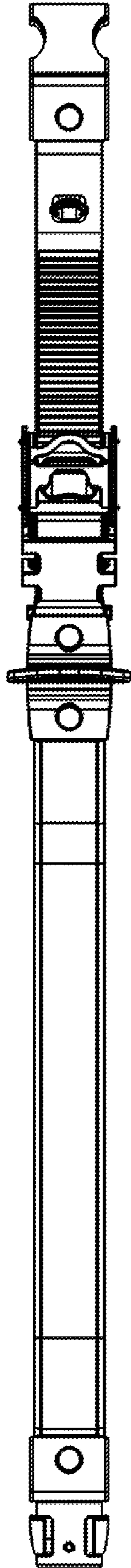

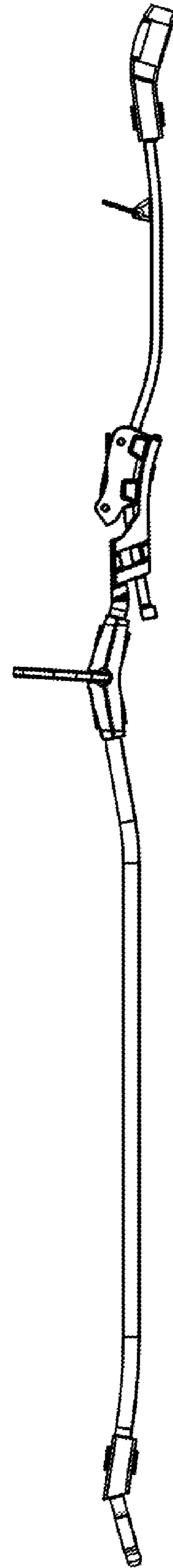

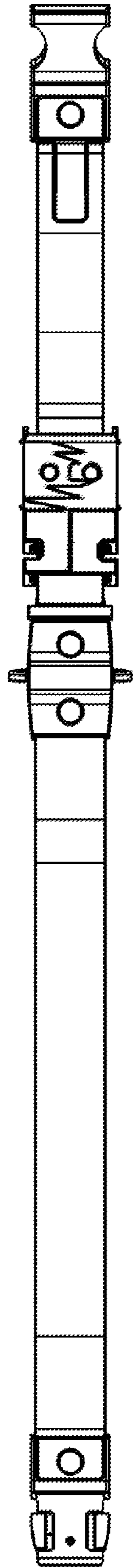

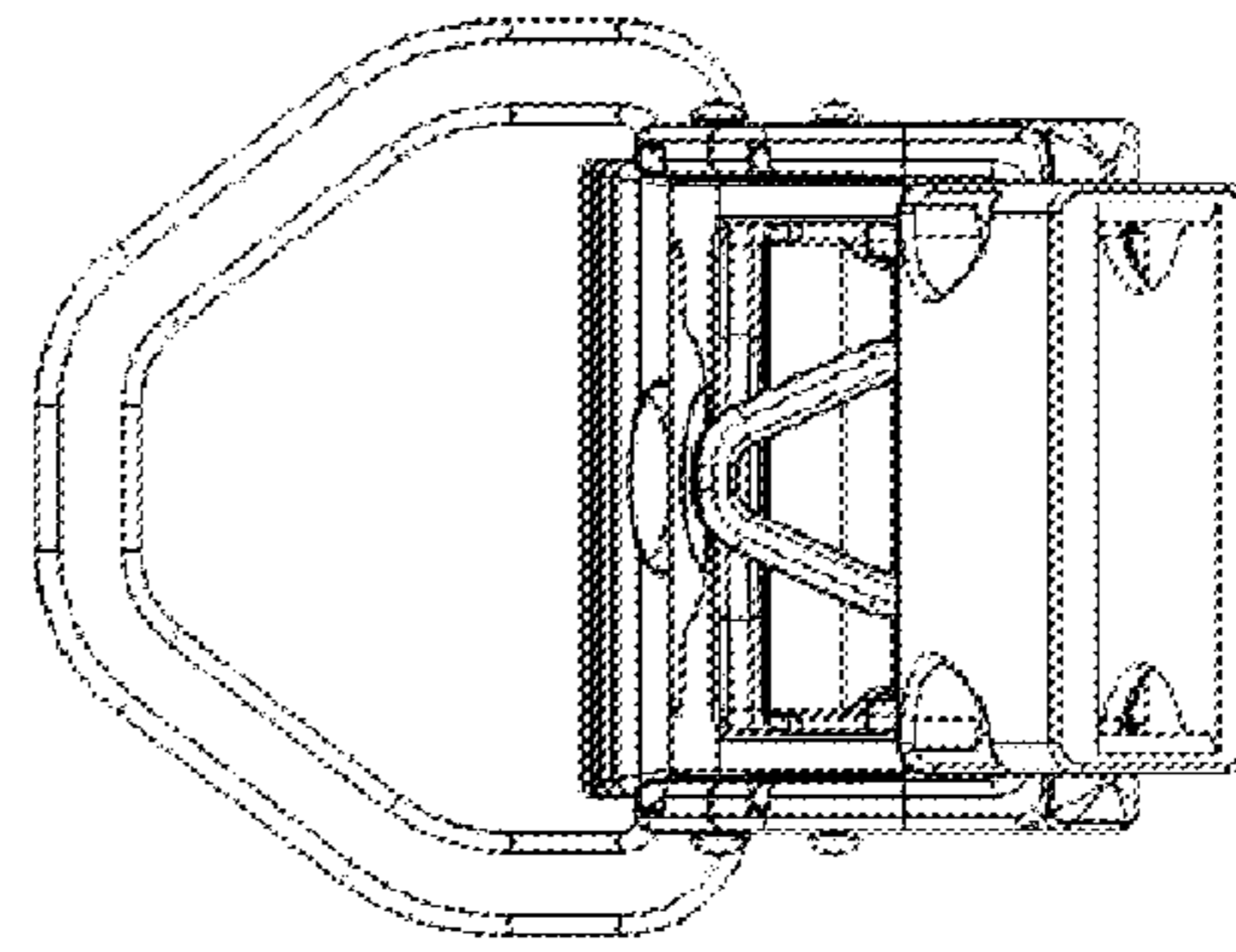
