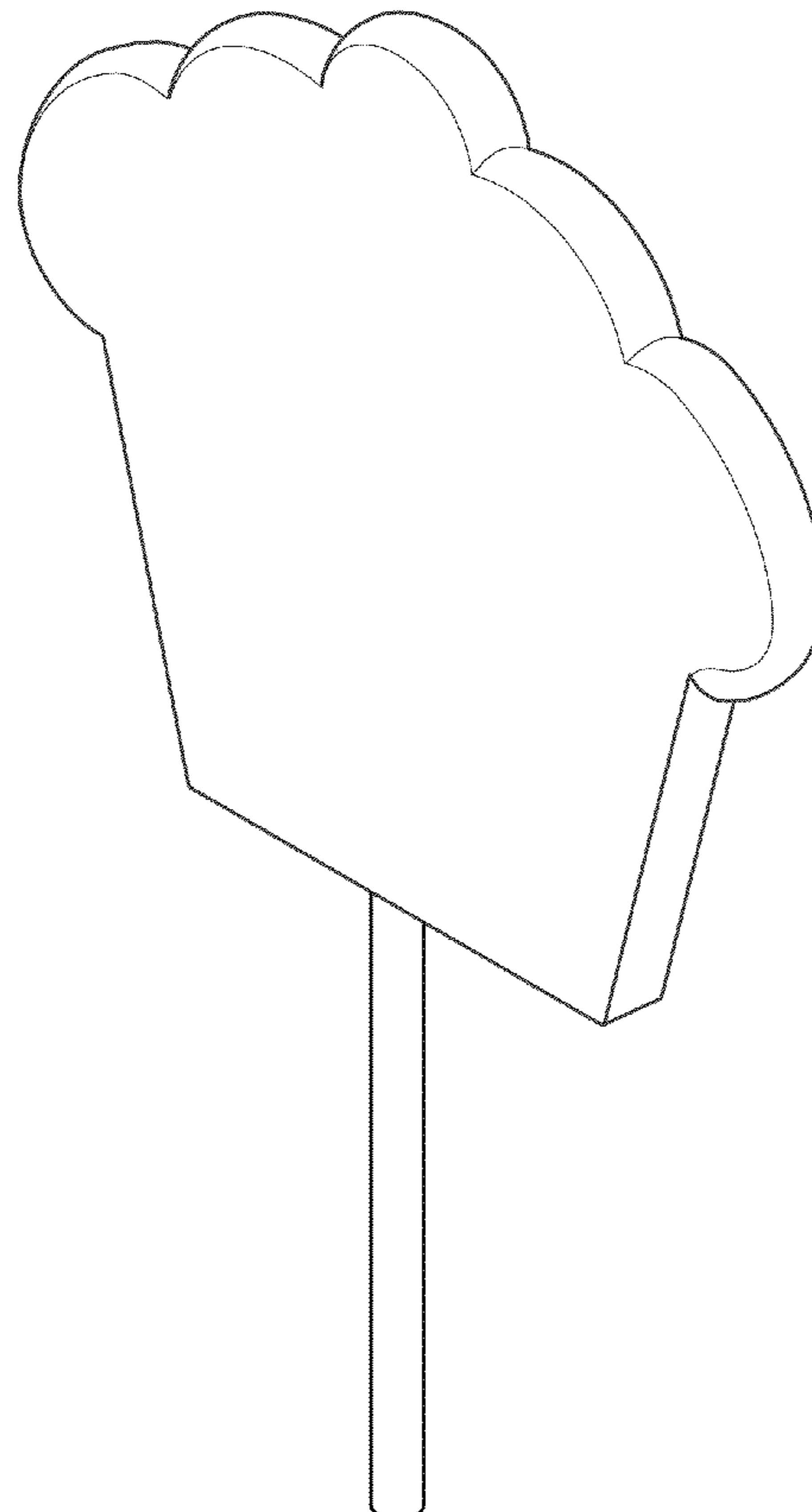
(57) **CLAIM**

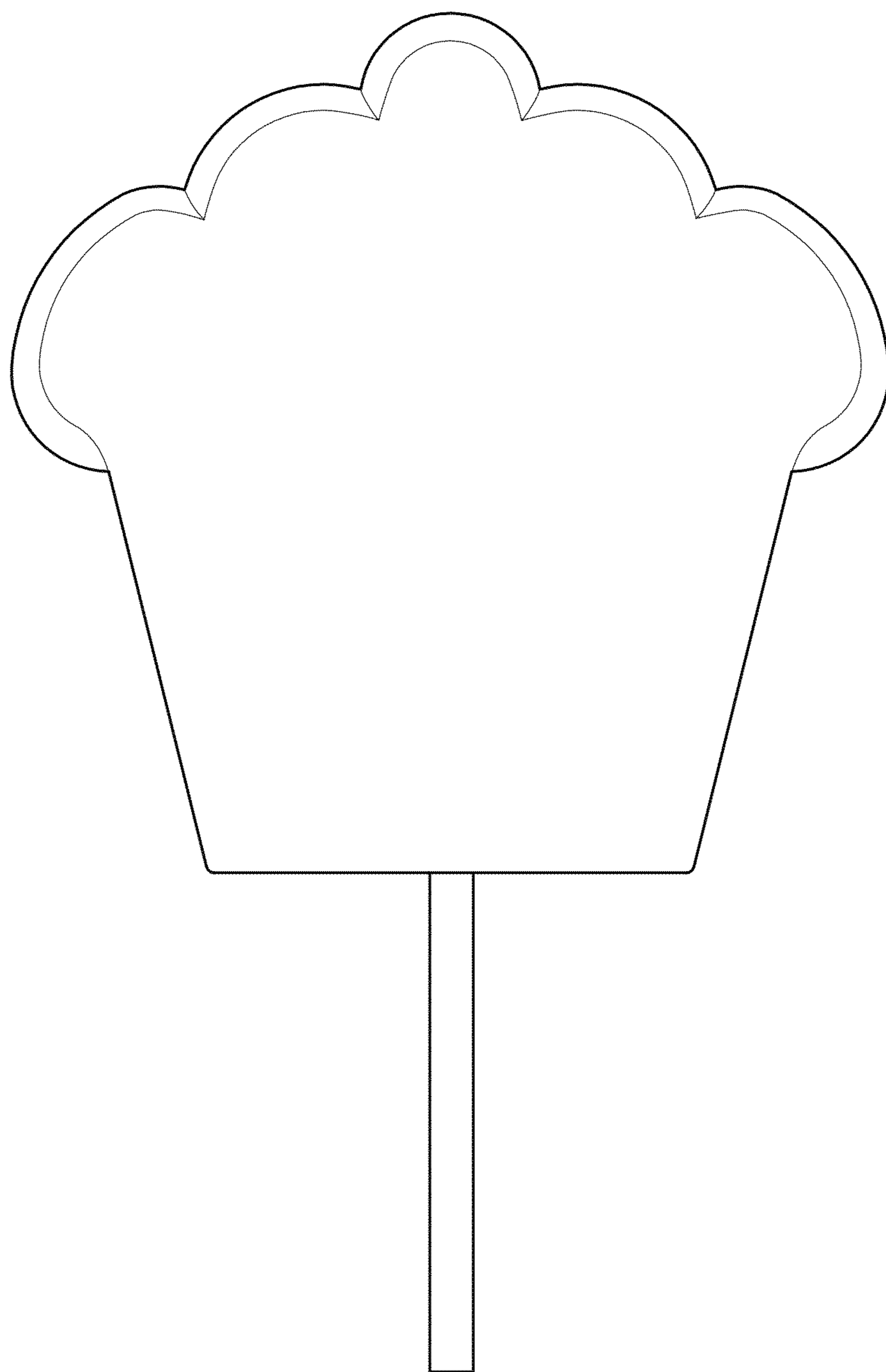
The ornamental design for a cupcake shaped fruit dessert, as shown and described.

**DESCRIPTION**

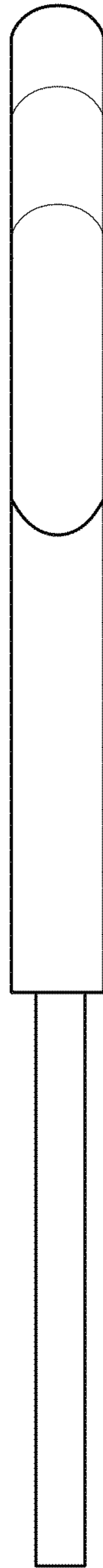
FIG. 1 is a front view of the new design for a cupcake shaped fruit dessert, the back view being symmetrical.

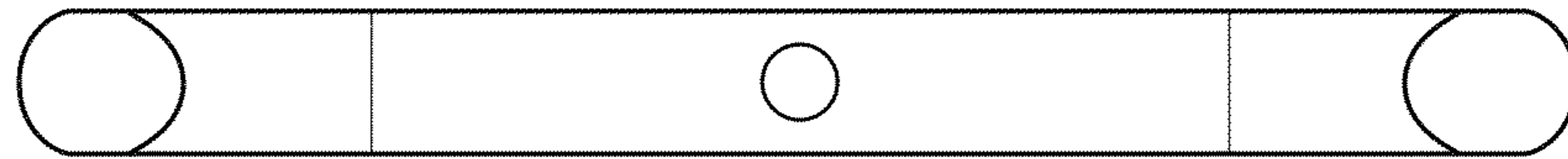

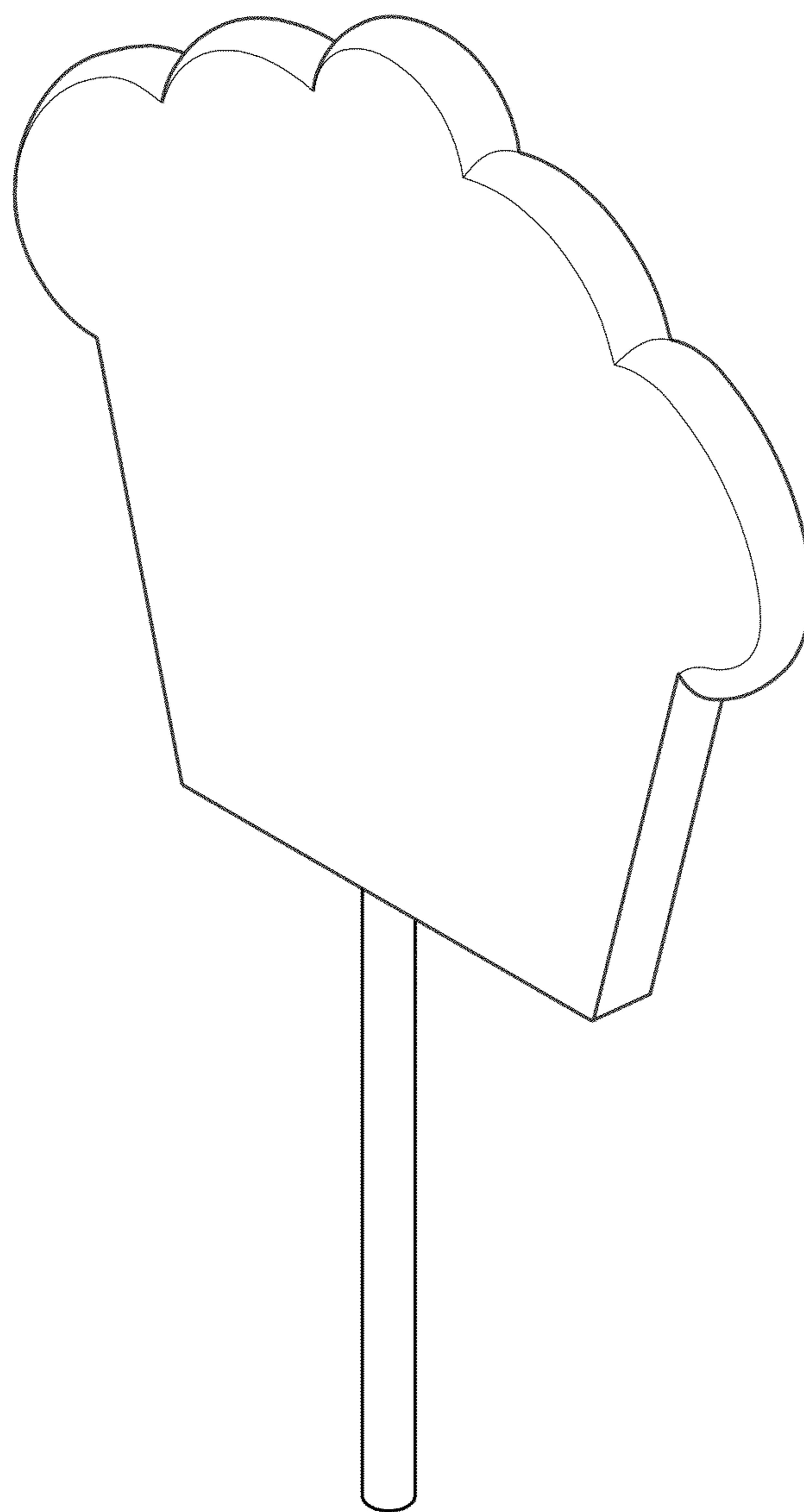

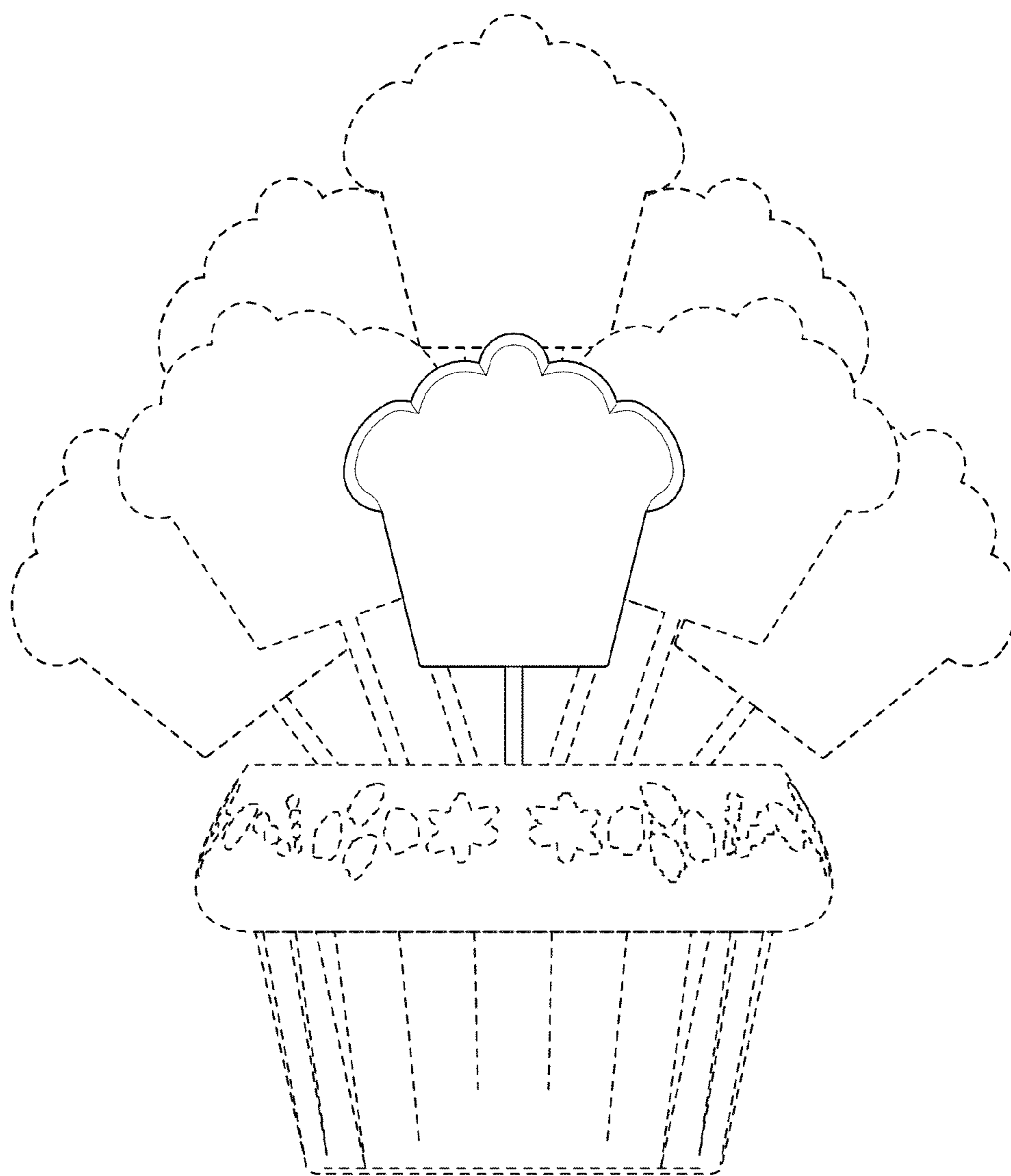
