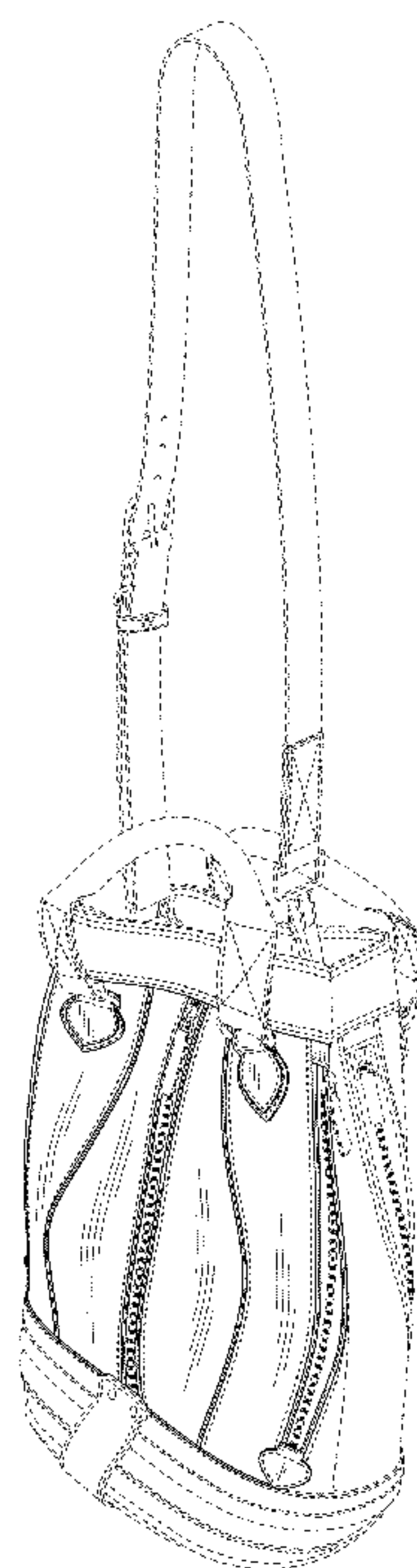

The ornamental design for a bag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bag showing my new design;
 FIG. 2 is a front view of the bag shown in FIG. 1;
 FIG. 3 is a rear view of the bag shown in FIG. 1;
 FIG. 4 is a right side view of the bag shown in FIG. 1;
 FIG. 5 is a left side view of the bag shown in FIG. 1;
 FIG. 6 is a top view of the bag shown in FIG. 1;
 FIG. 7 is a bottom view of the bag shown in FIG. 1;
 FIG. 8 is a front perspective view of the bag shown in FIG. 1, shown with strap removed;
 FIG. 9 is a front view of the bag shown in FIG. 8;
 FIG. 10 is a rear view of the bag shown in FIG. 8;
 FIG. 11 is a right side view of the bag shown in FIG. 8;
 FIG. 12 is a left side view of the bag shown in FIG. 8;
 FIG. 13 is a top view of the bag shown in FIG. 8; and,
 FIG. 14 is a bottom view of the bag shown in FIG. 8.
 The broken lines showing the strap, buckles, handles, metal rings, zippers, zipper pulls, zipper tracks, portions of the body of the bag and rivets are for the purposes of illustrating environment and form no part of the claimed design.
 The dotted lines other than those representing the strap, buckles, handles, metal rings, zippers, zipper pulls, zipper tracks, portions of the bottom of the bag, portions of the back of the bag, portions of the sides of the bag, portions of the top of the bag, and rivets are understood to represent stitching and are part of the claimed design.

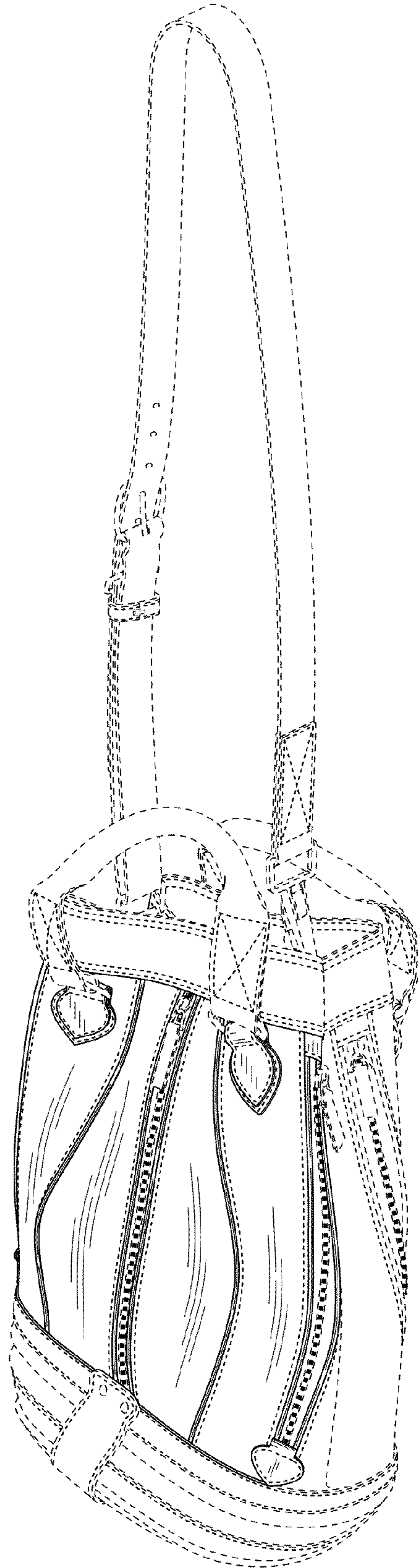

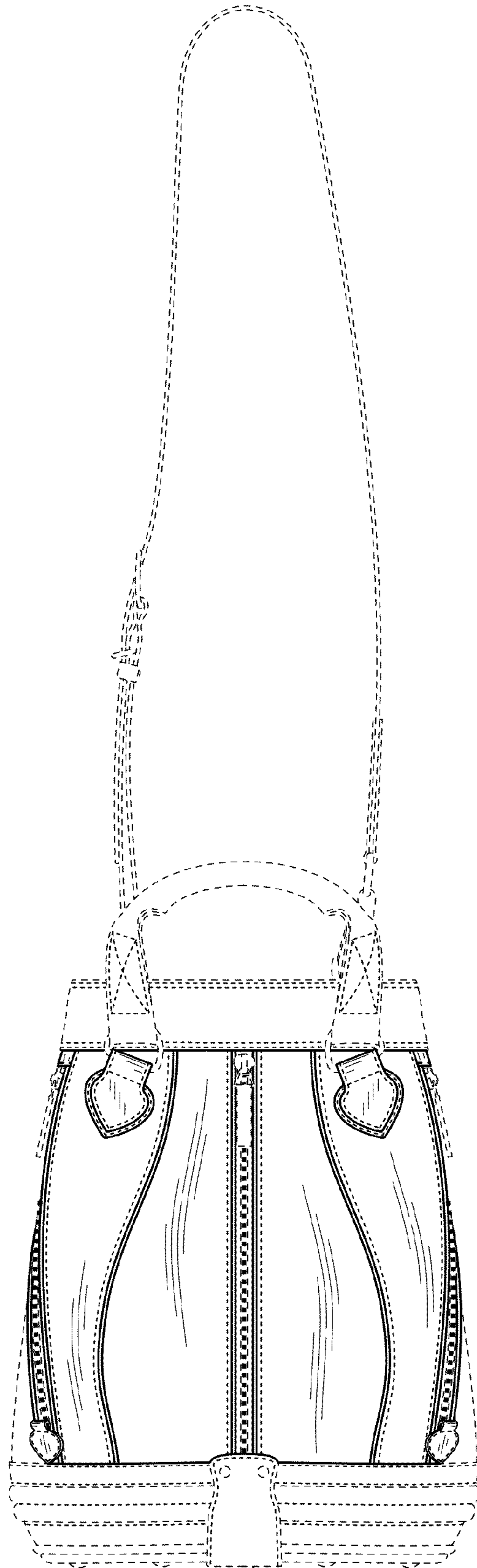

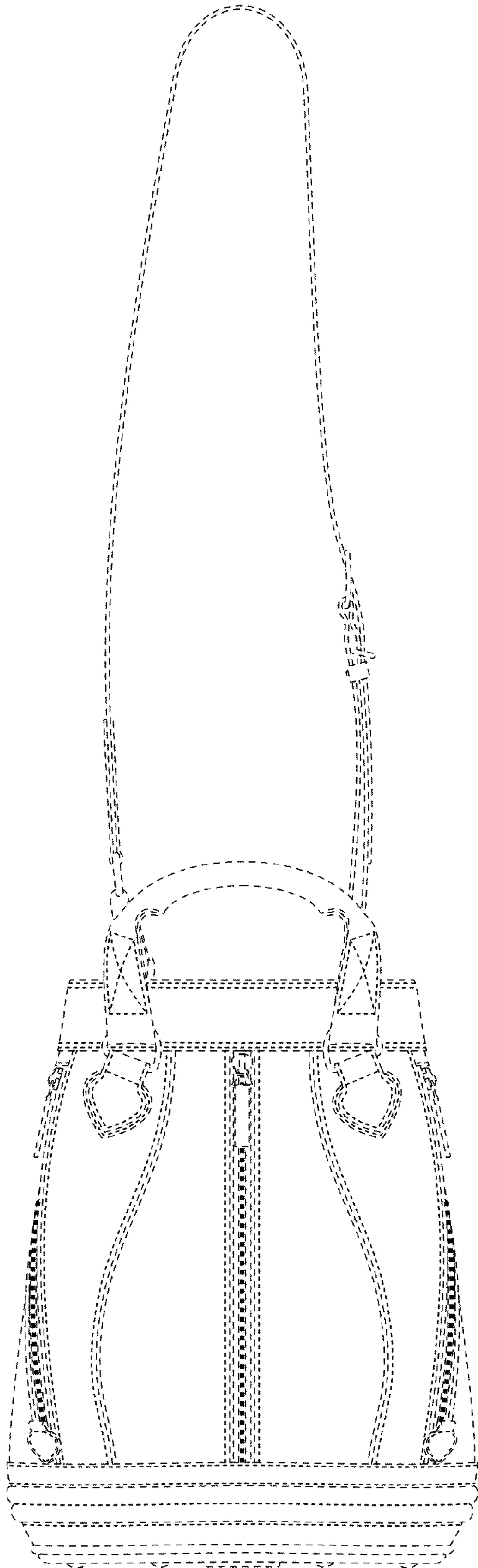

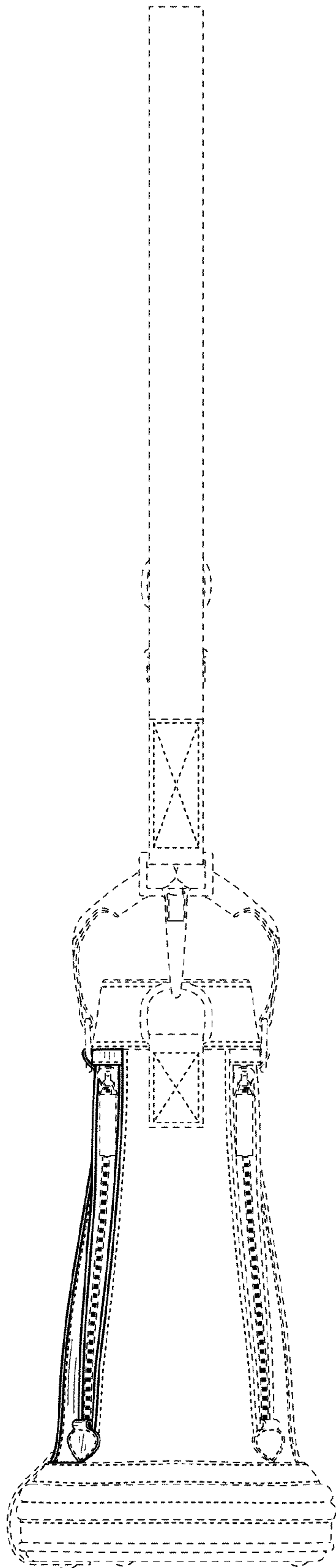

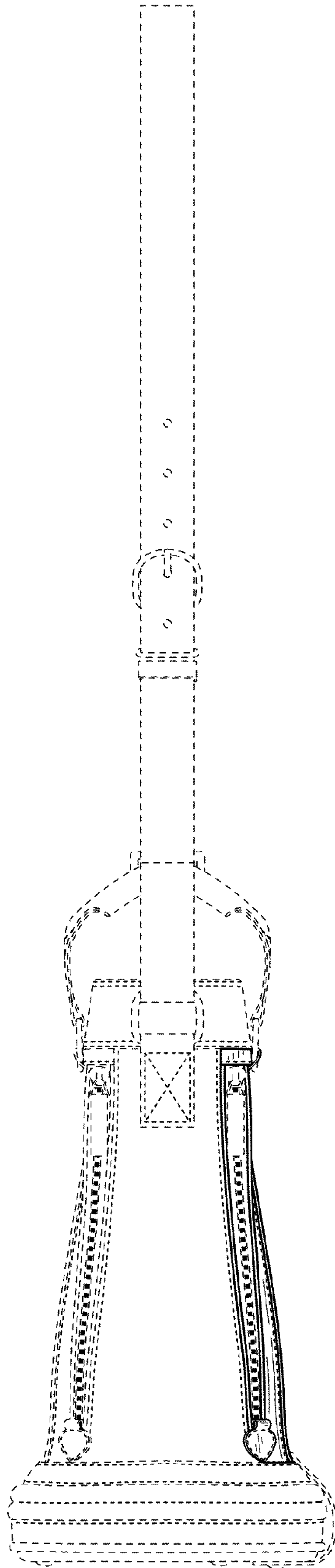

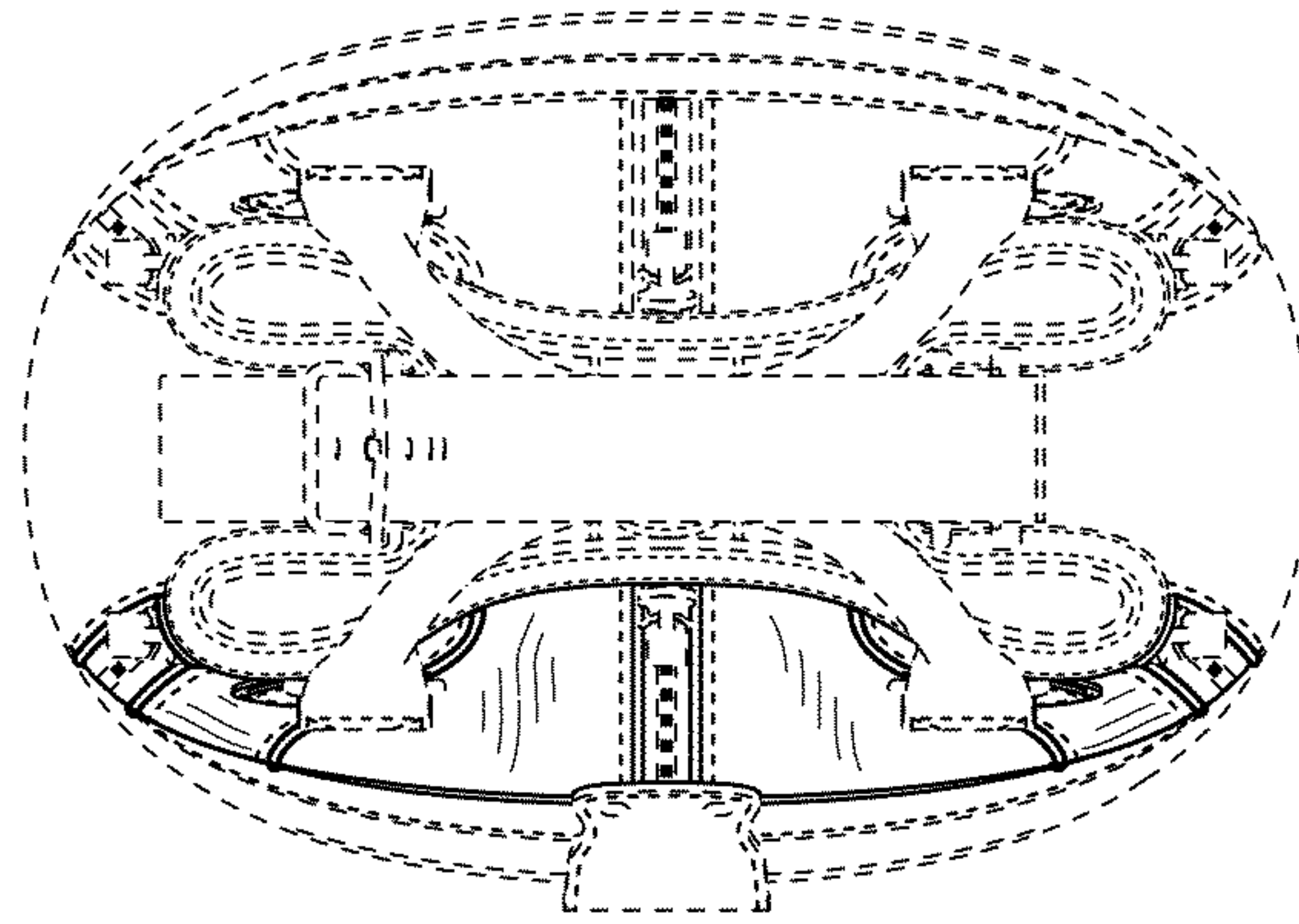

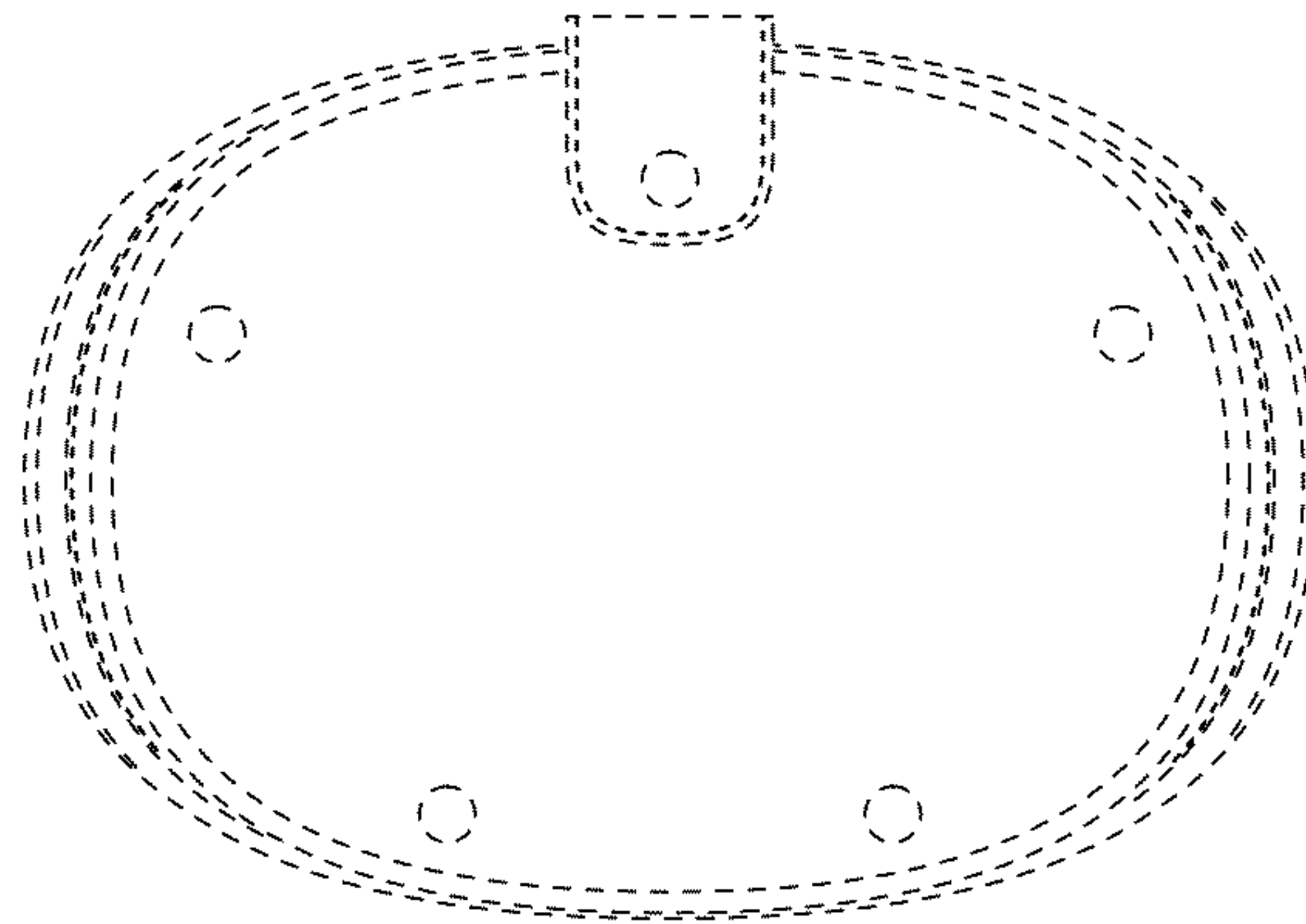

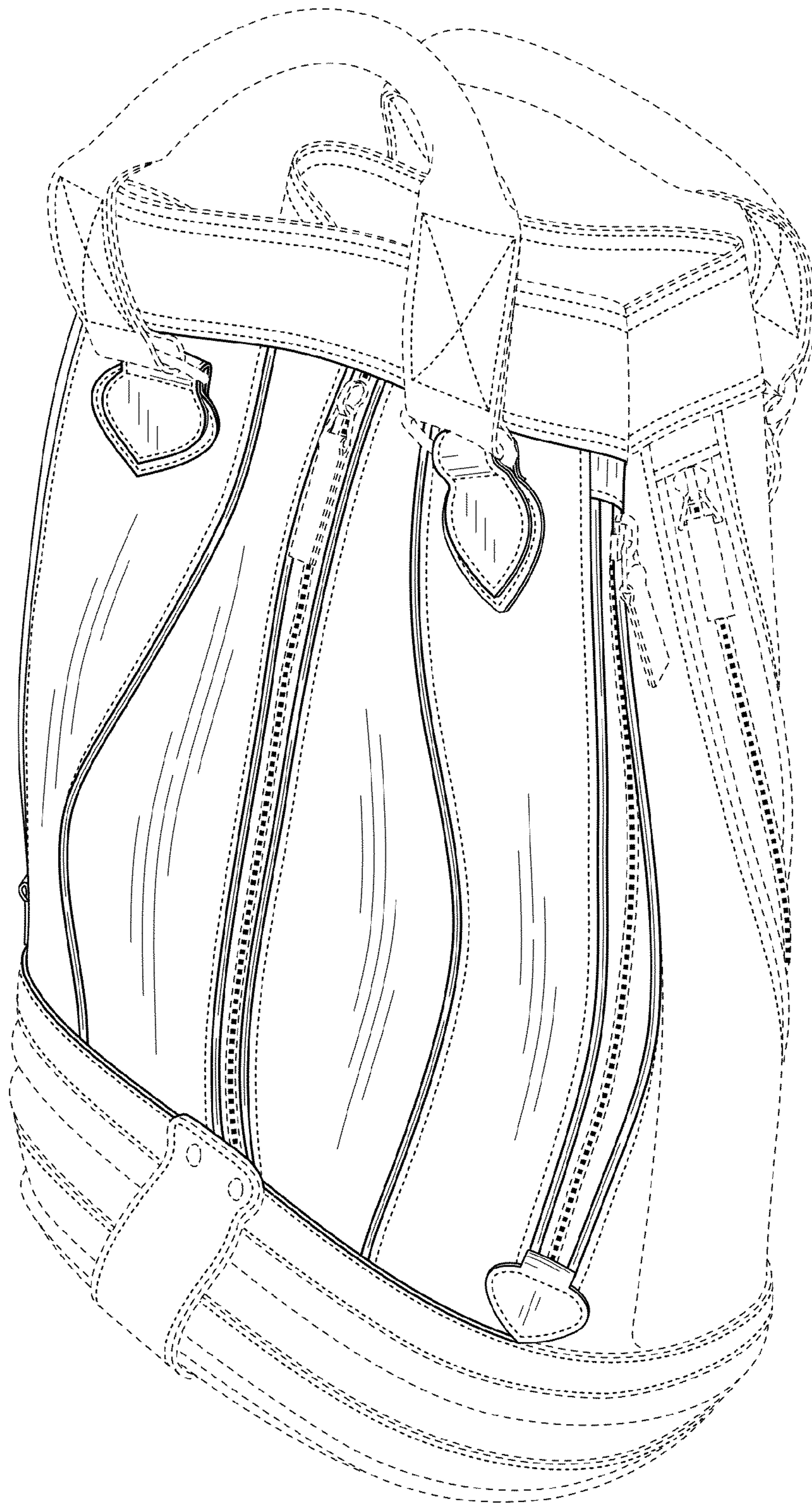

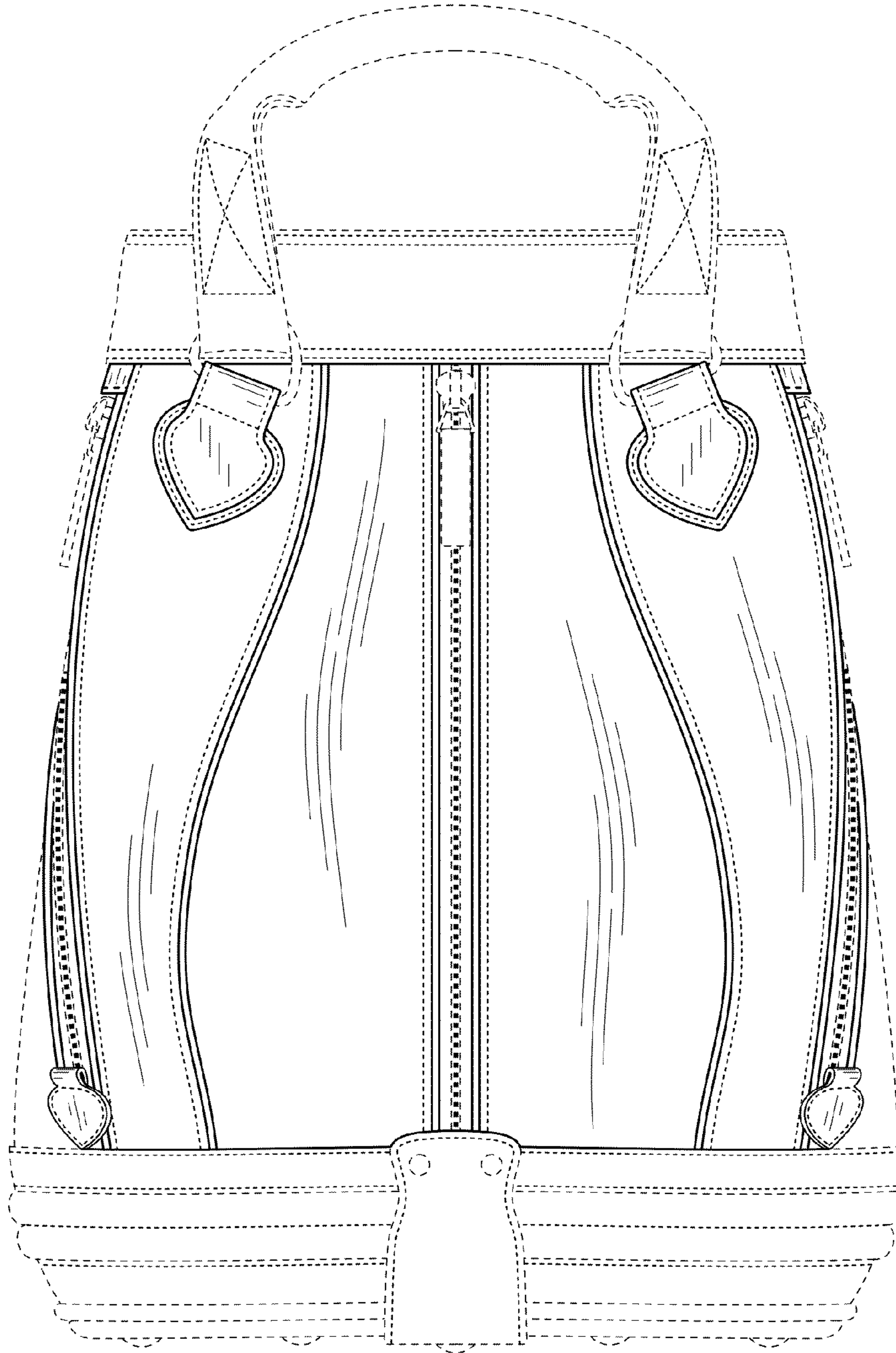

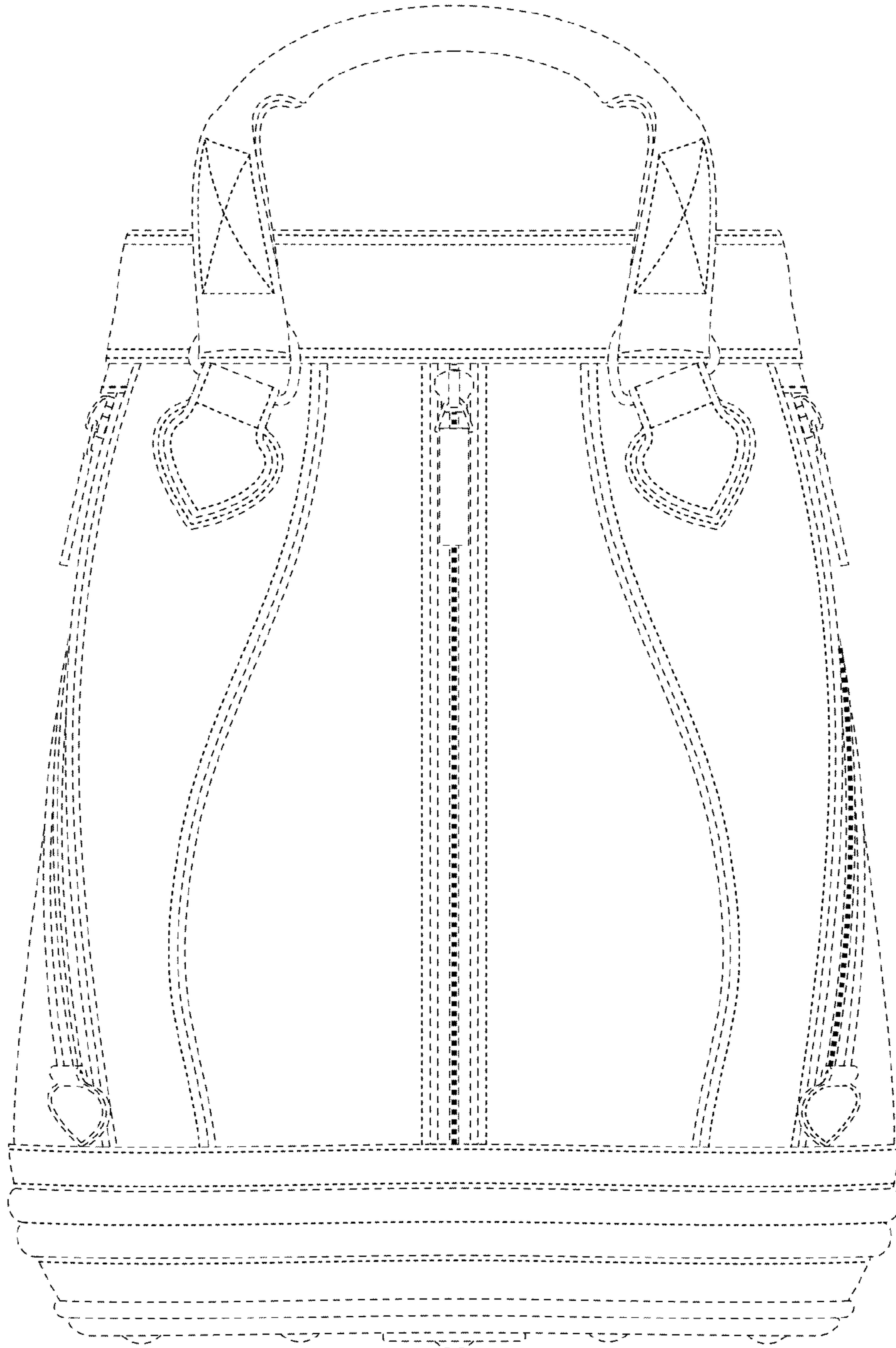

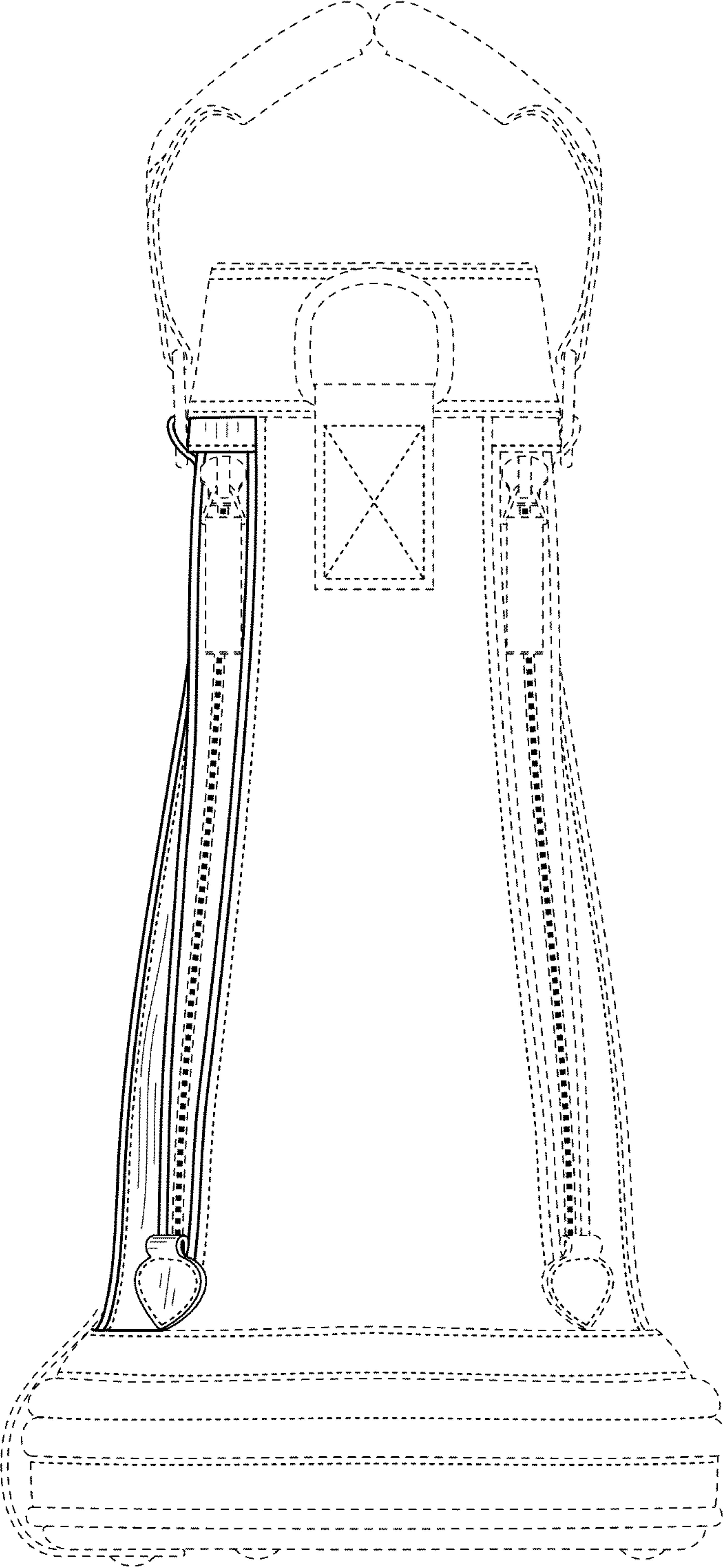

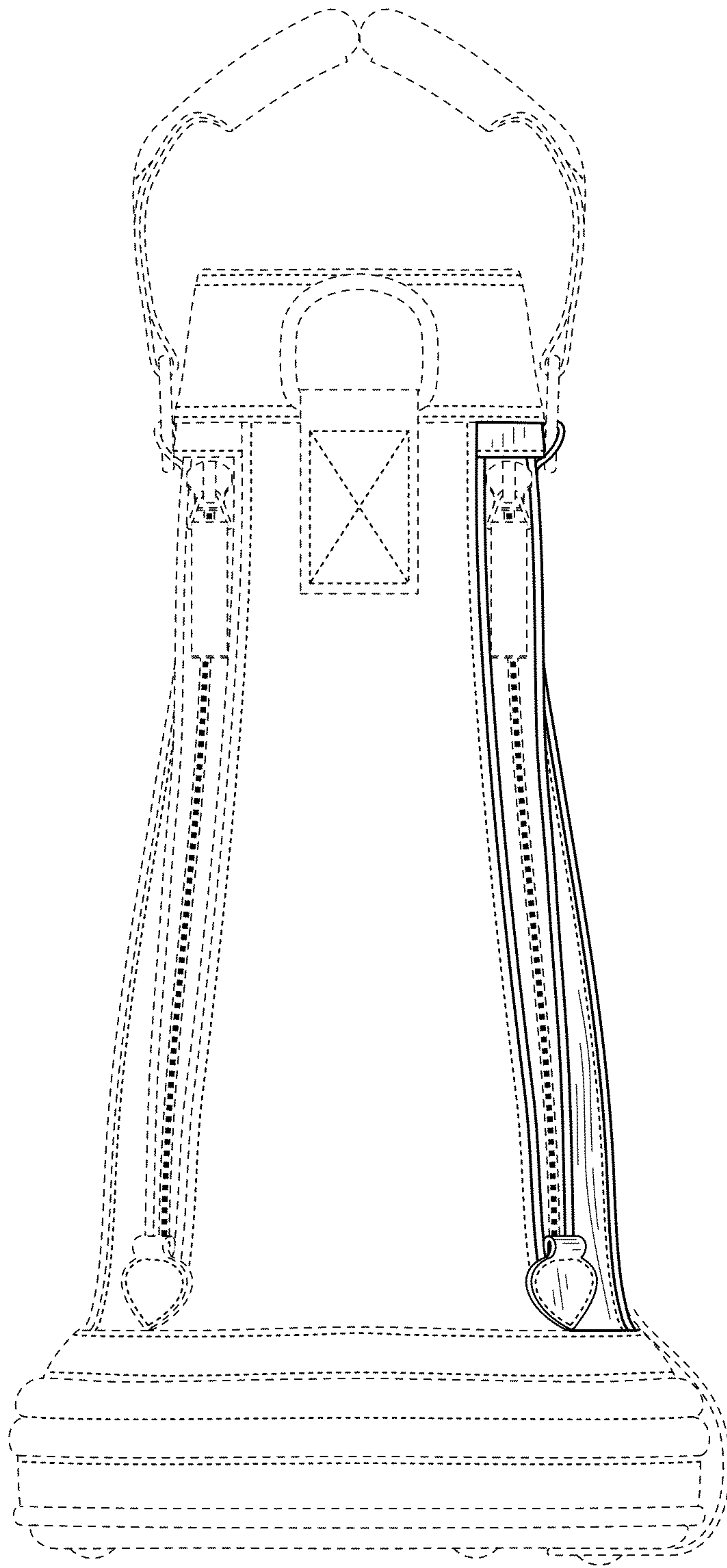

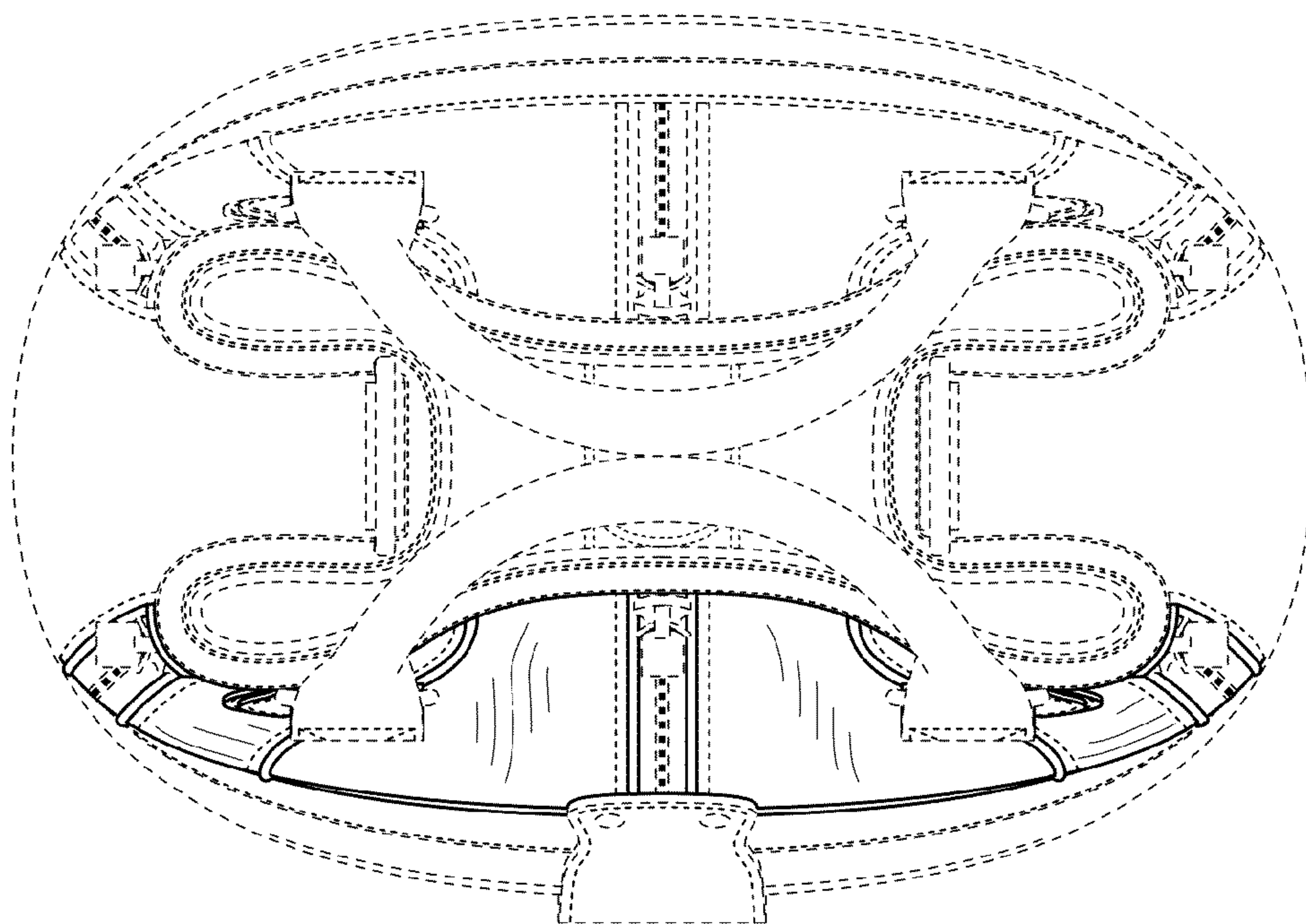

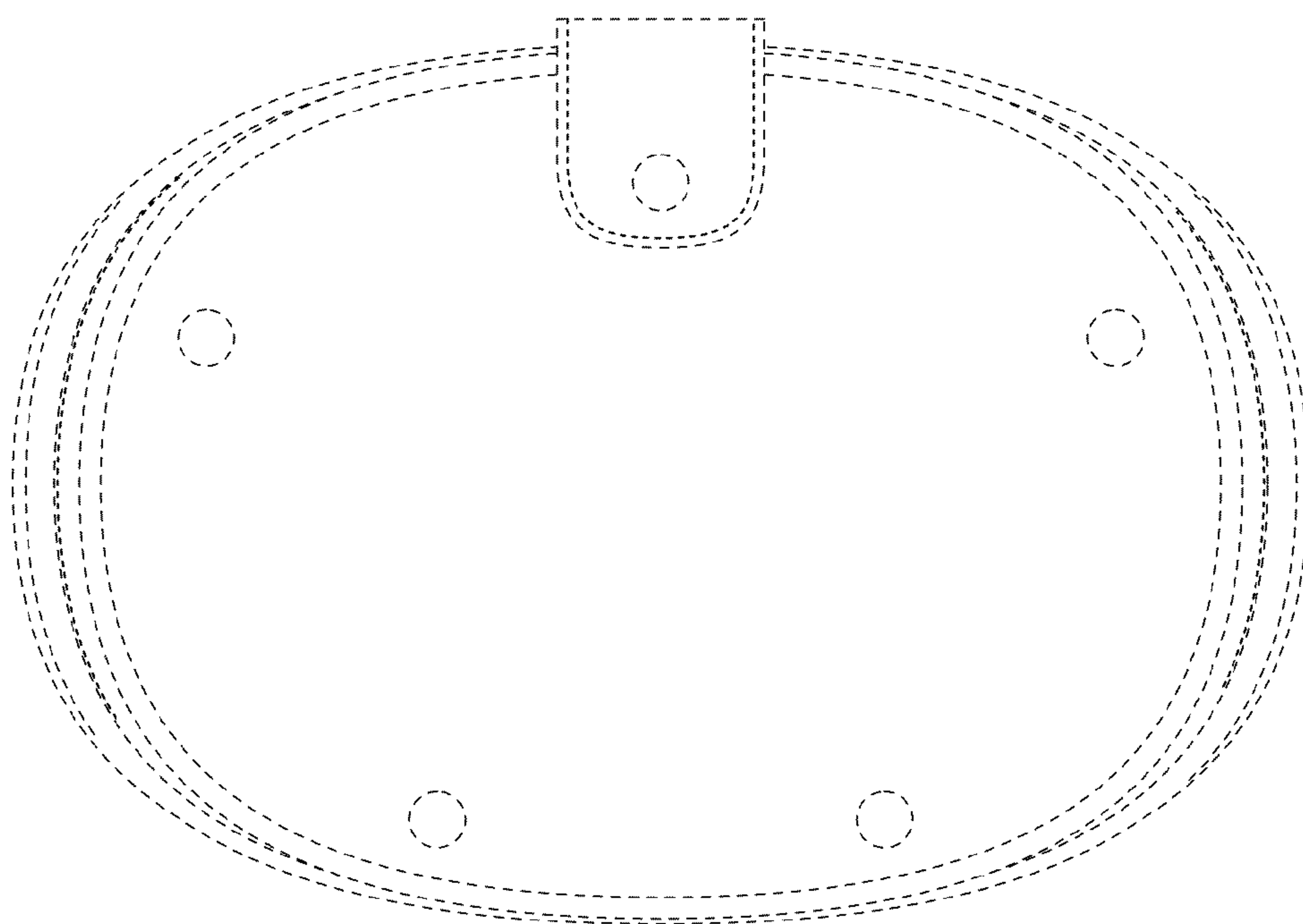
