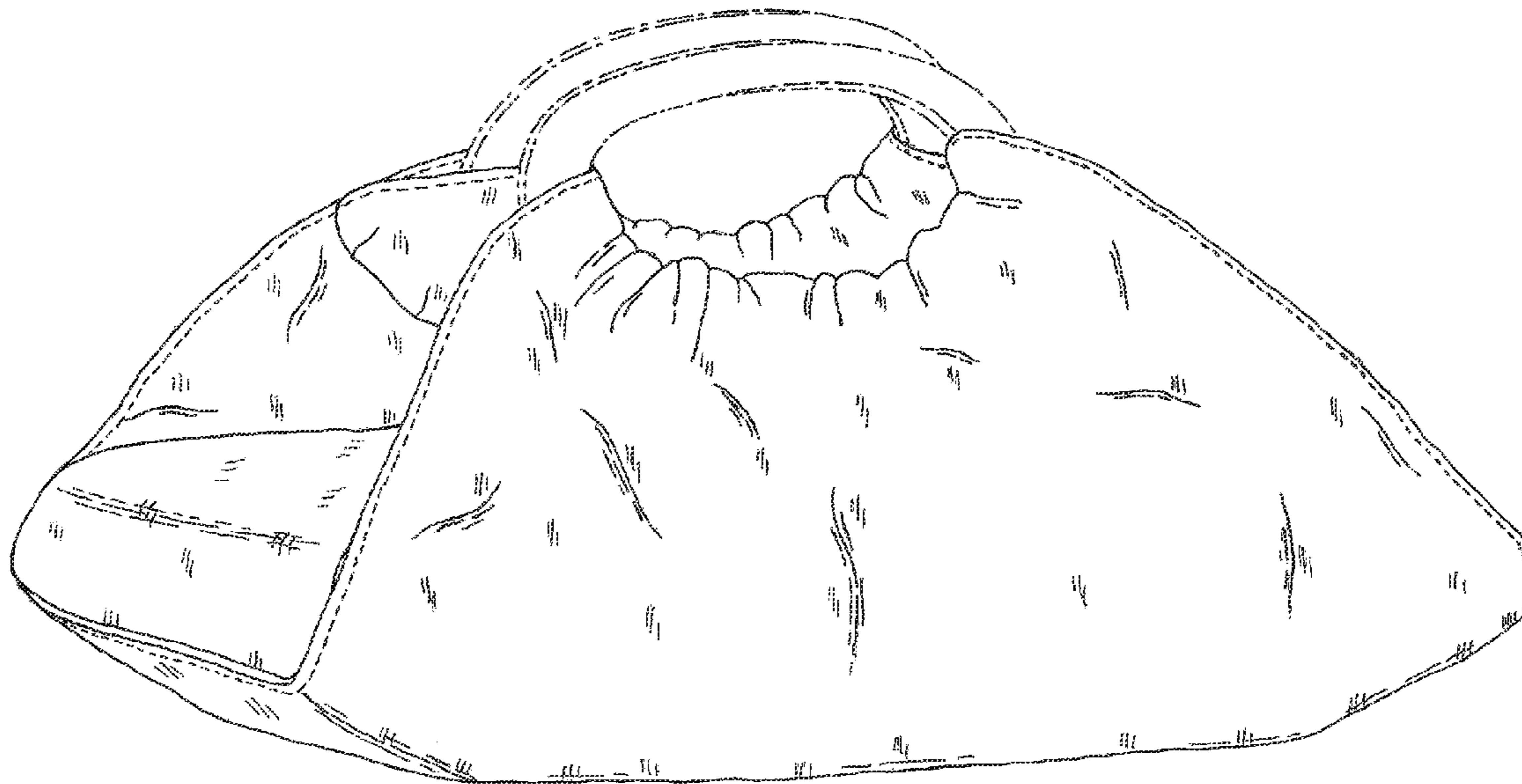
(57) **CLAIM**

The ornamental design for a food container carrier, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a food container carrier according to my new design;  
FIG. 2 is a right side/left side view thereof, it being understood that the right and left side views are identical;  
FIG. 3 is a first end view thereof;  
FIG. 4 is a second, opposite end view thereof; and,  
FIG. 5 is a top view thereof.  
Features shown in dash-dot (i.e., phantom) lines form no part of the claimed design.  
The small dashed lines are indicative of stitching.

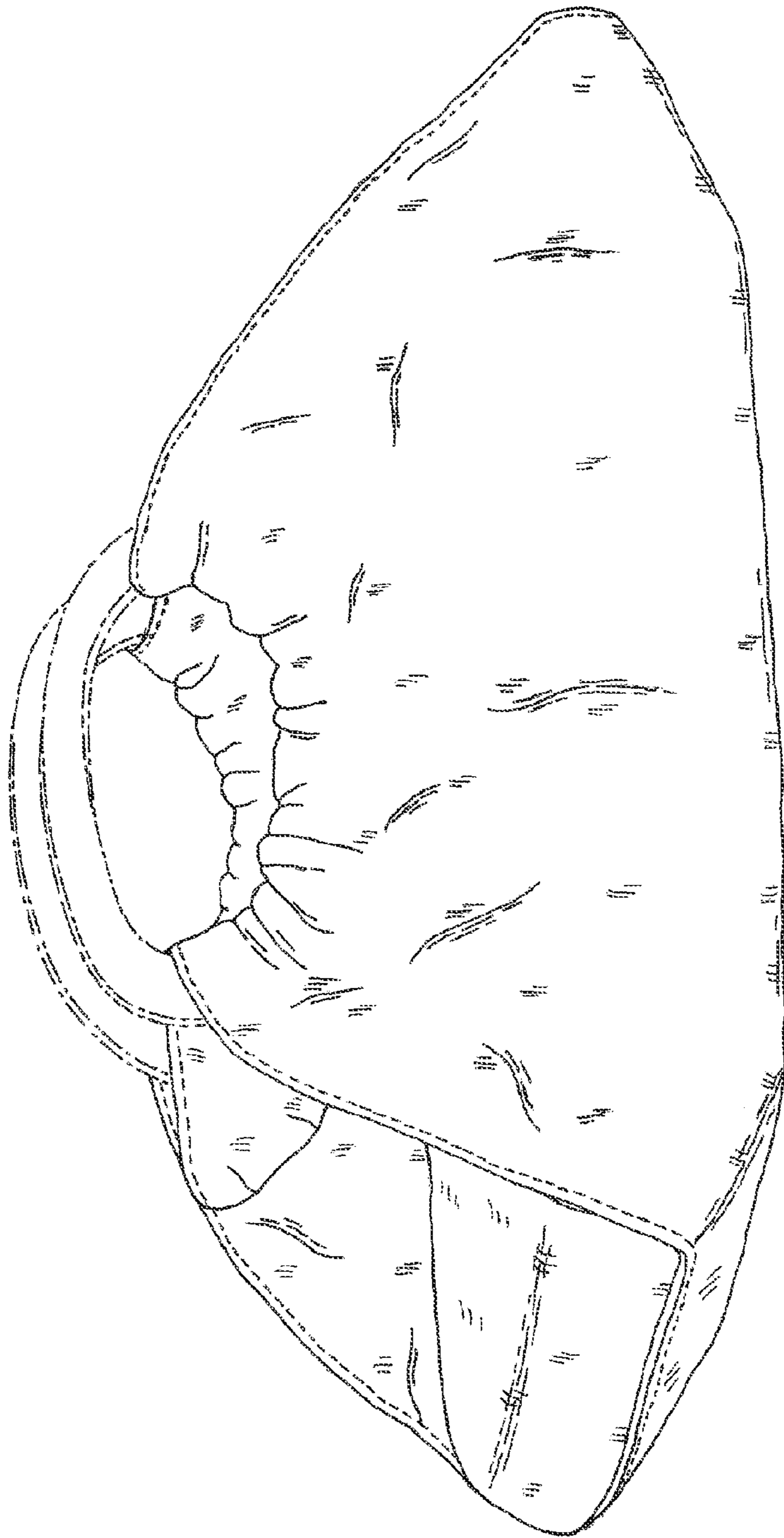

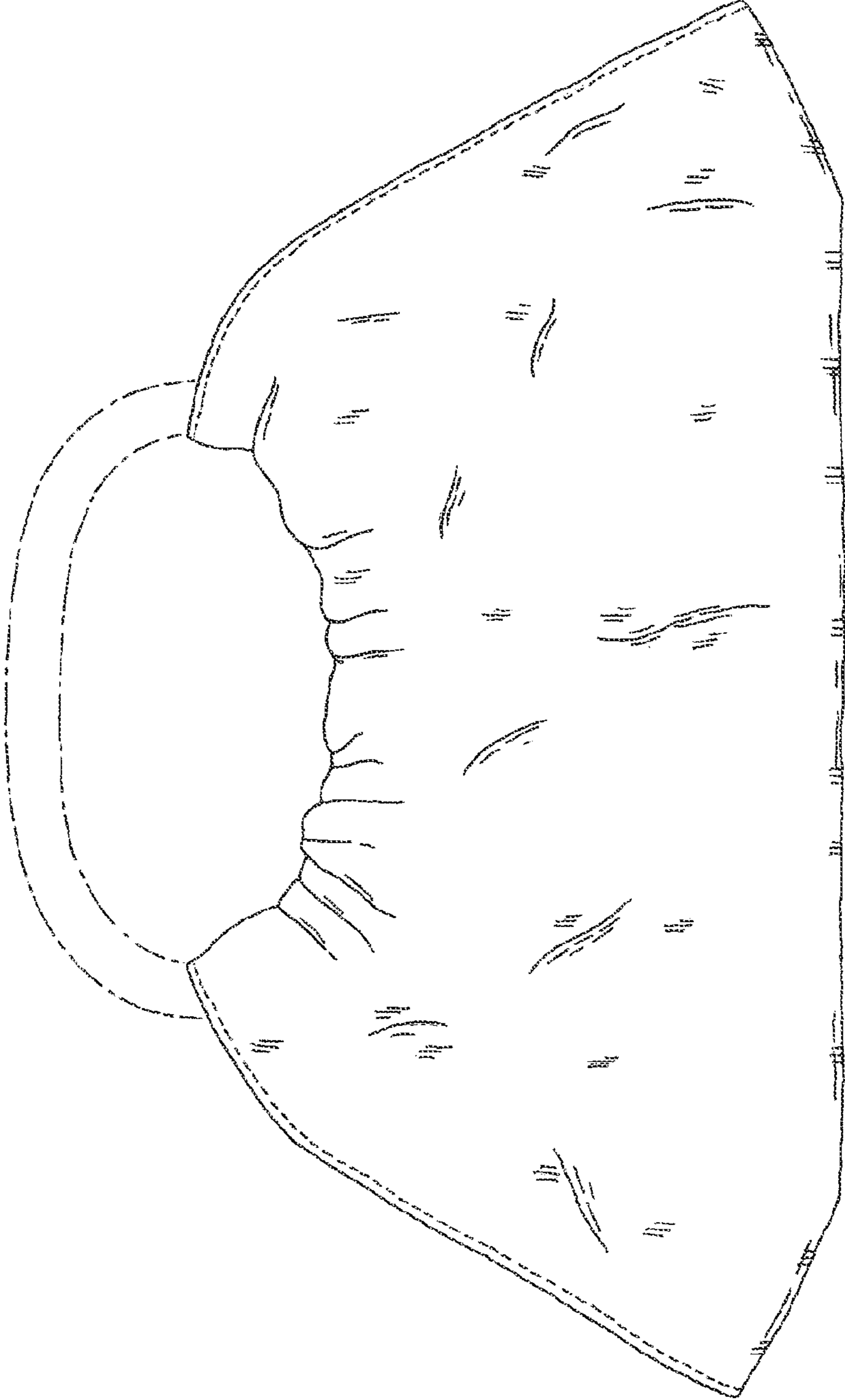

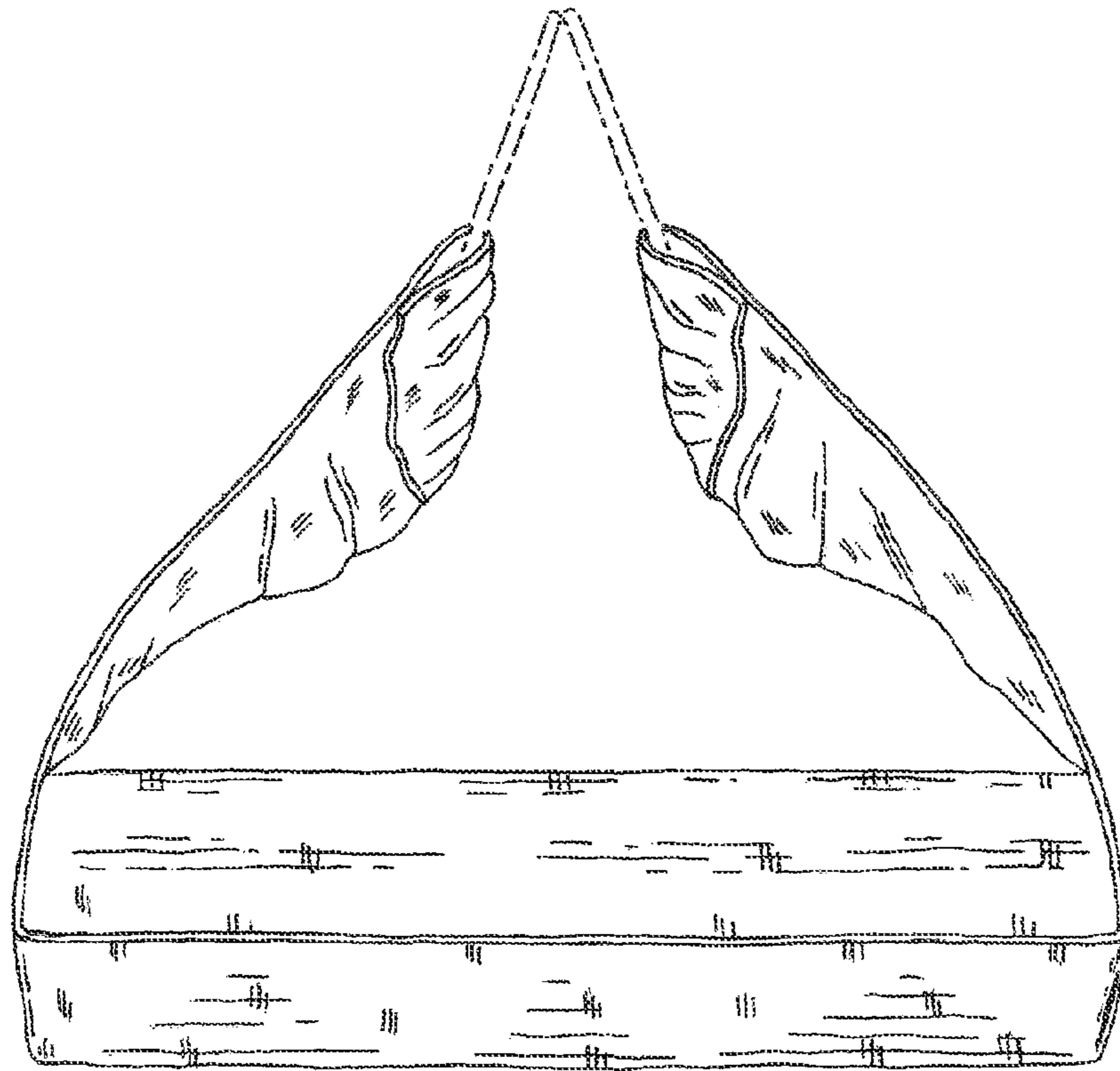

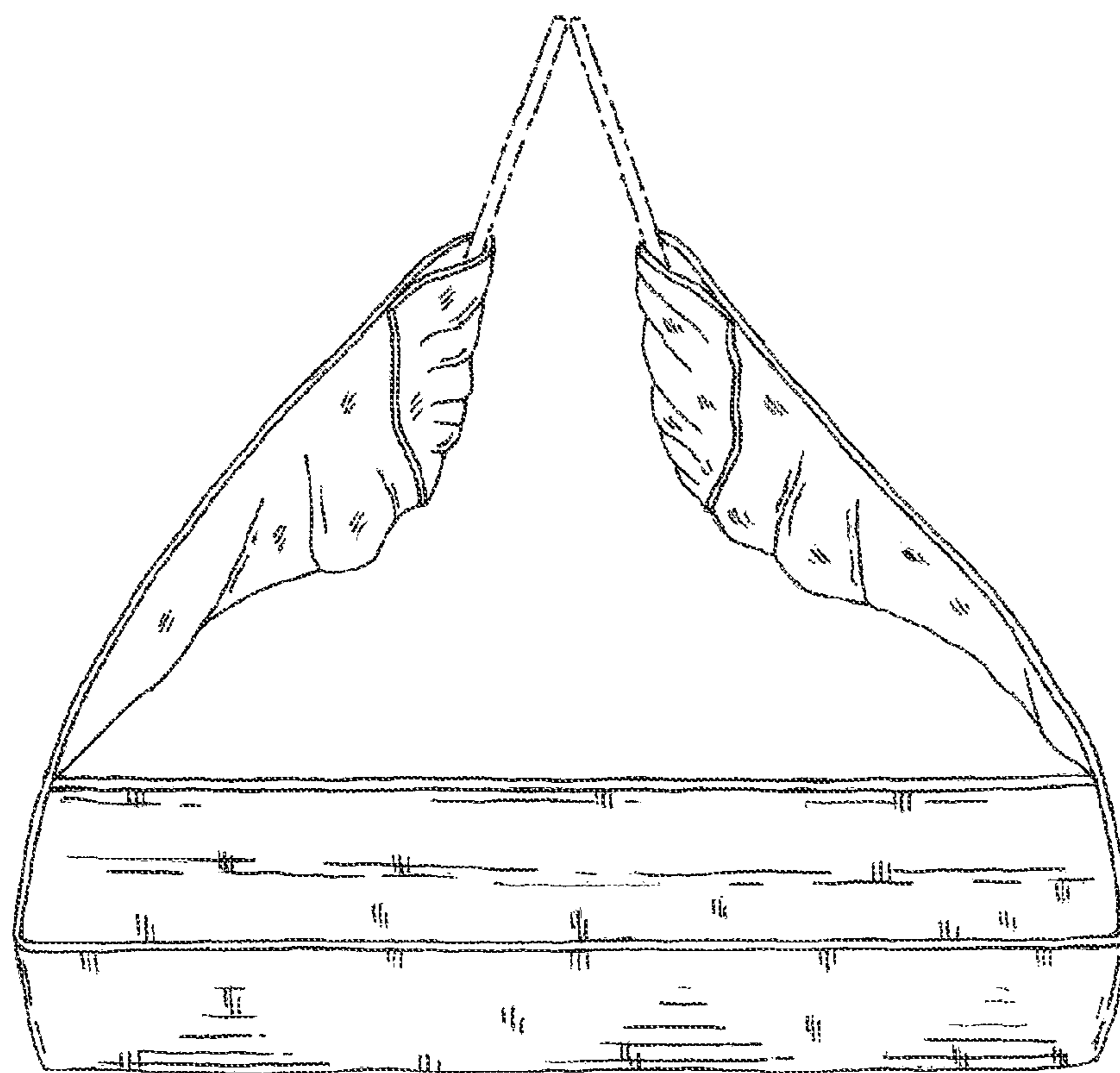

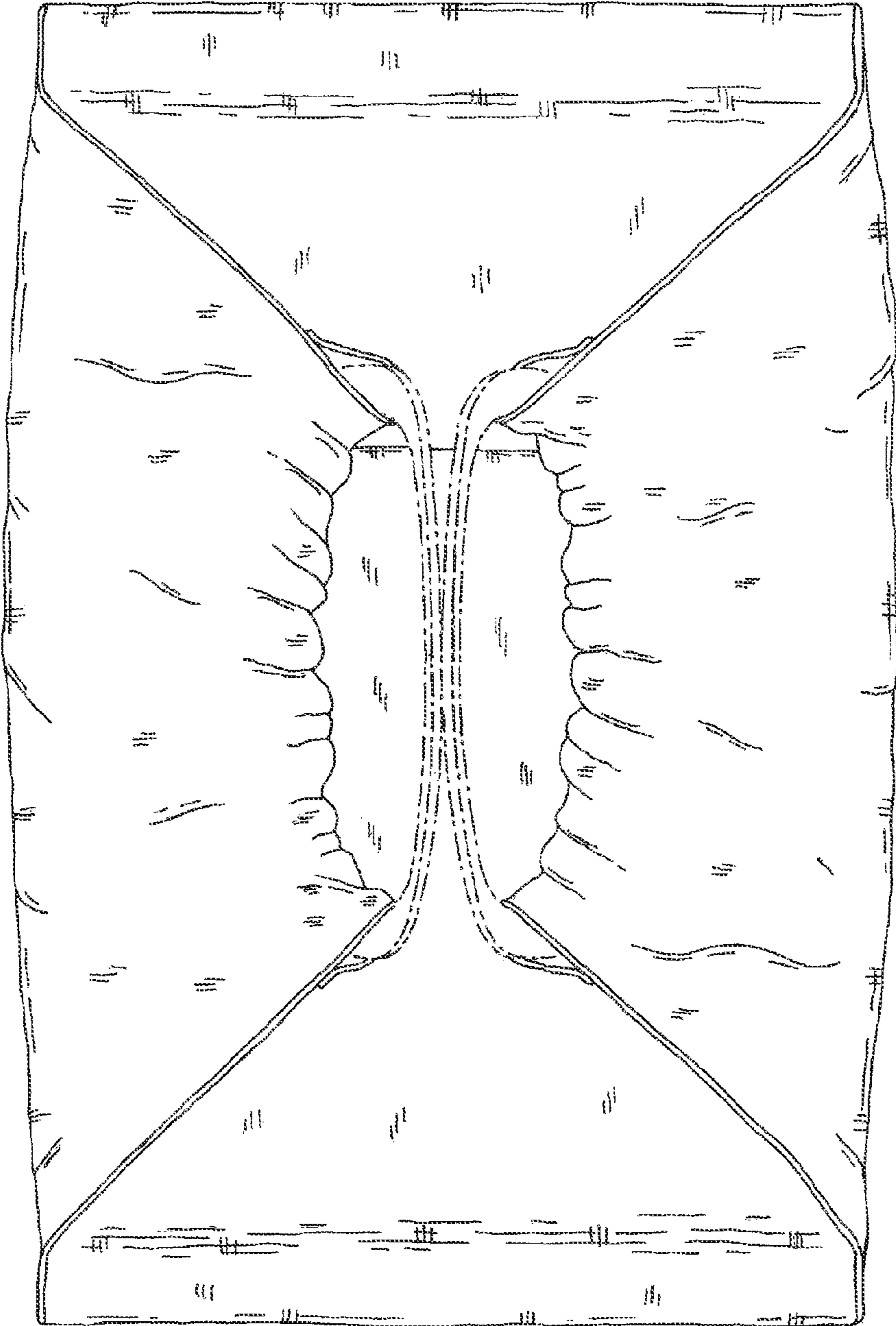
