The ornamental design of an rectangular exhaust stack for transportation vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a three dimensional view of a rectangular exhaust stack for transportation vehicle, such as a truck showing my new design;

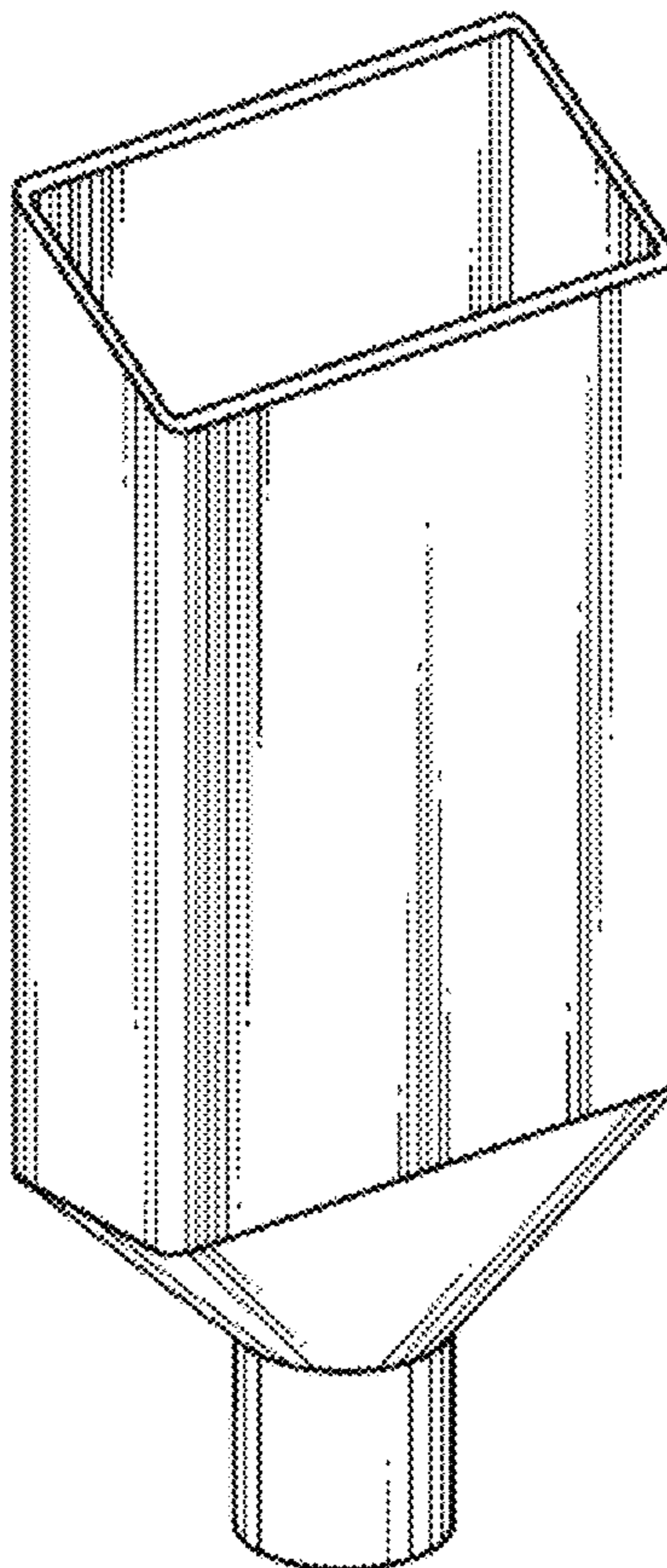

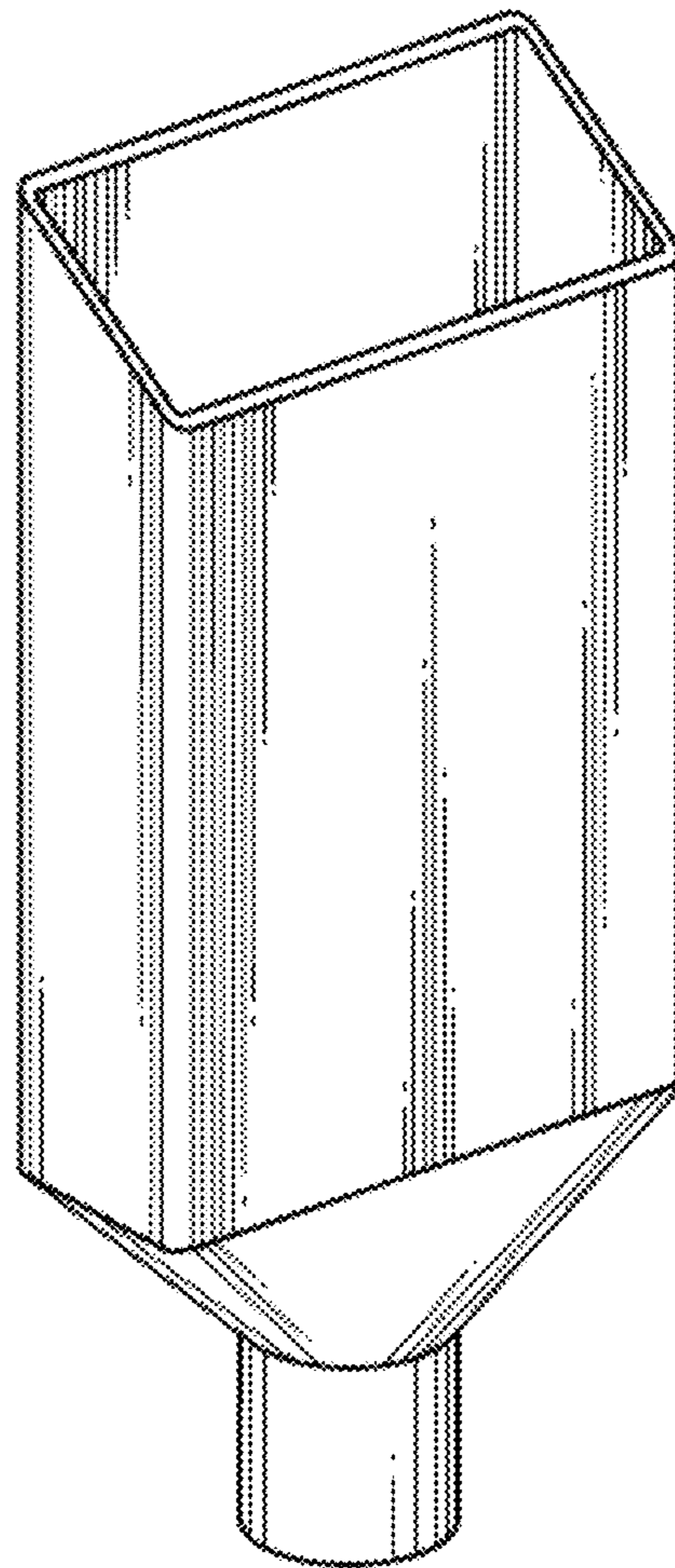

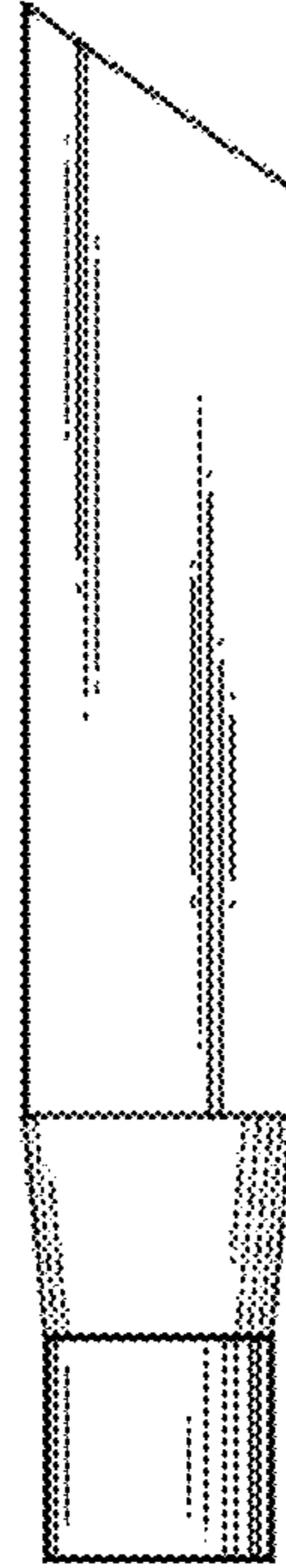

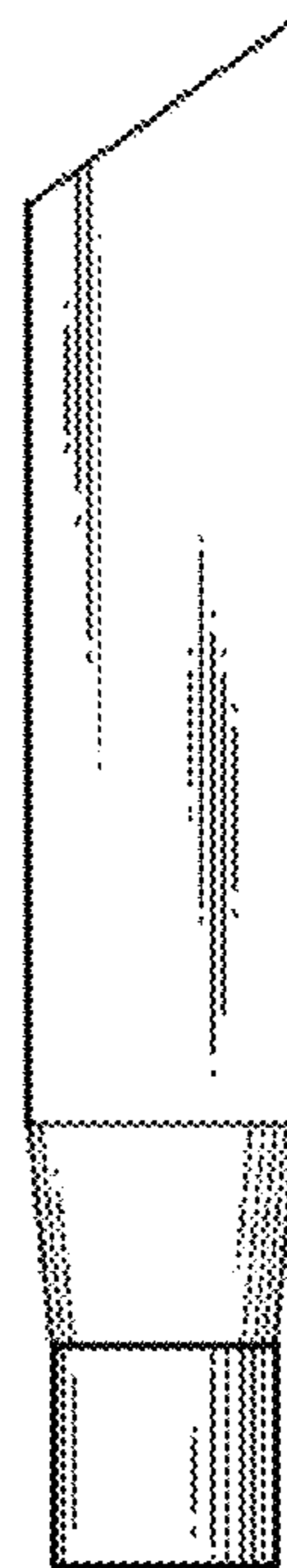

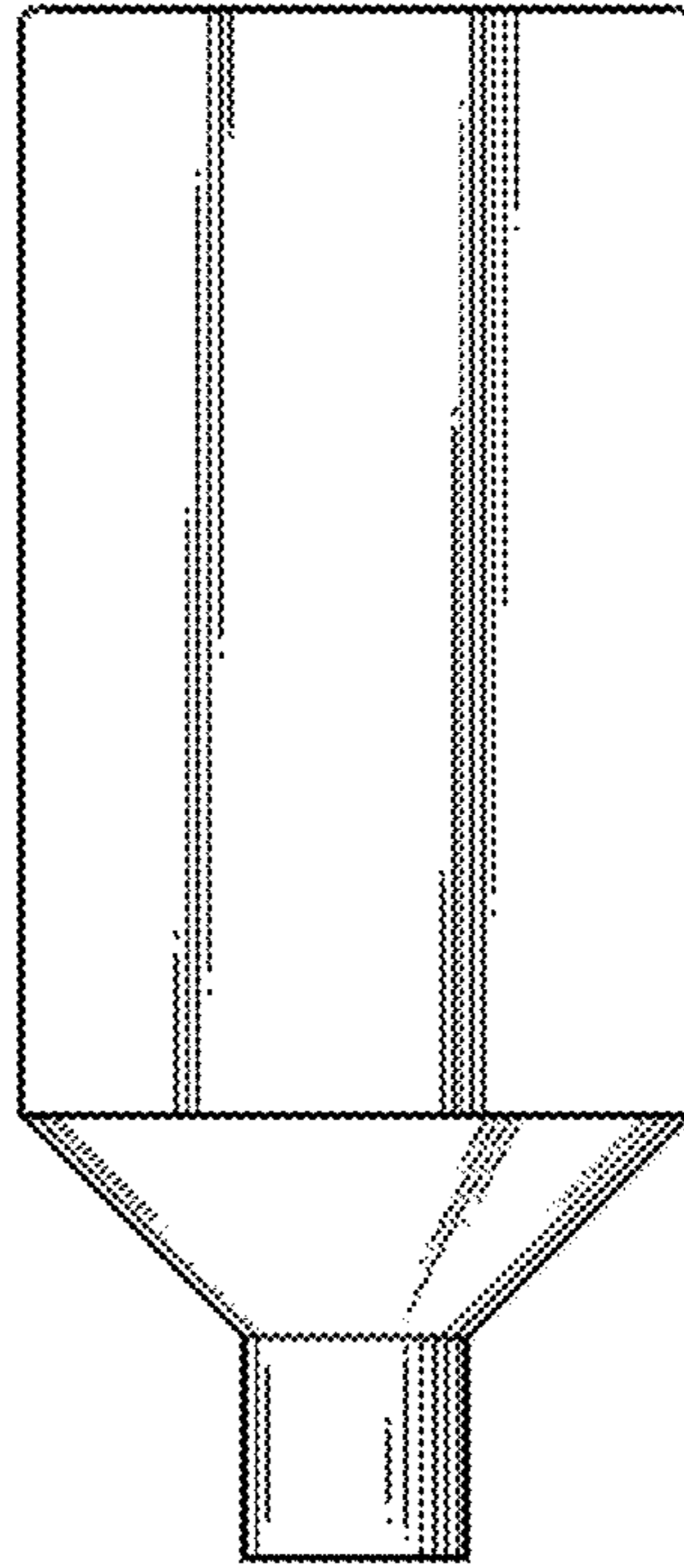

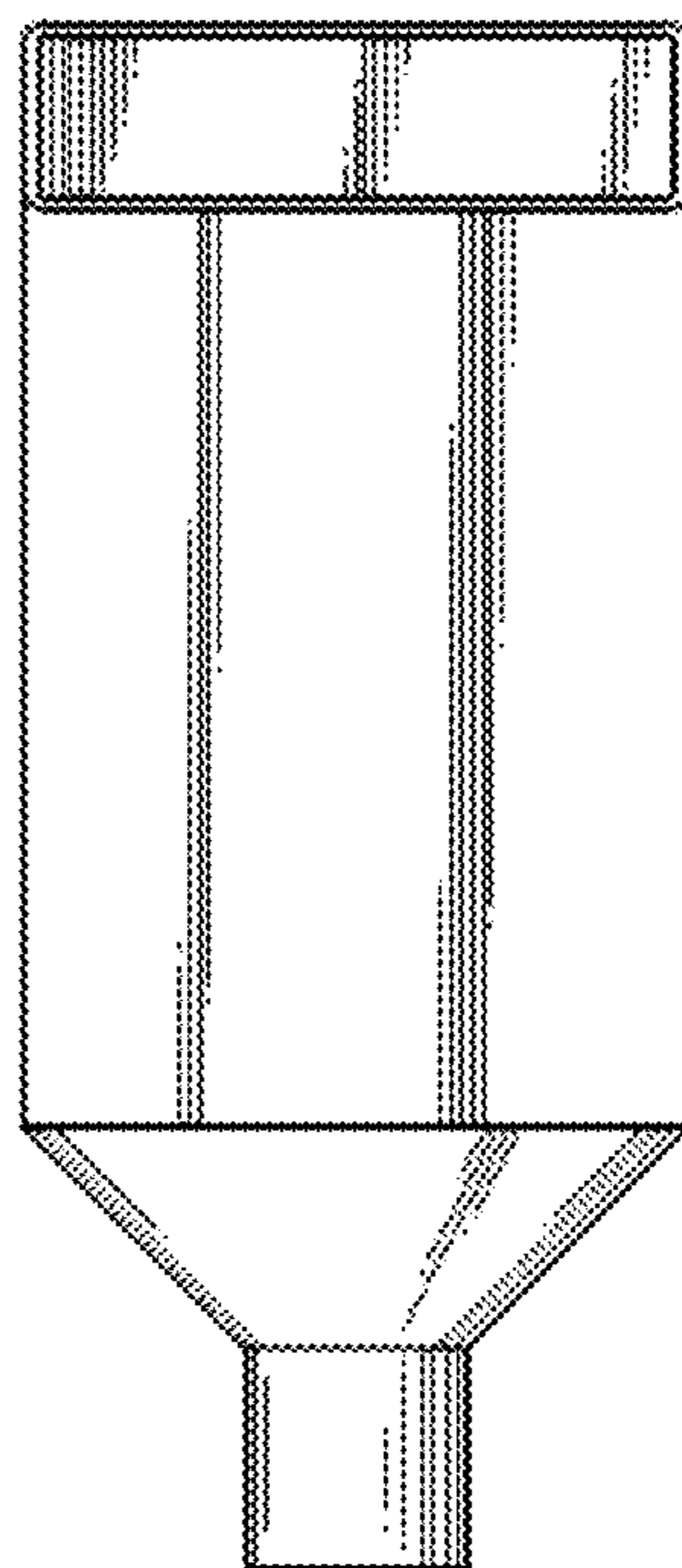

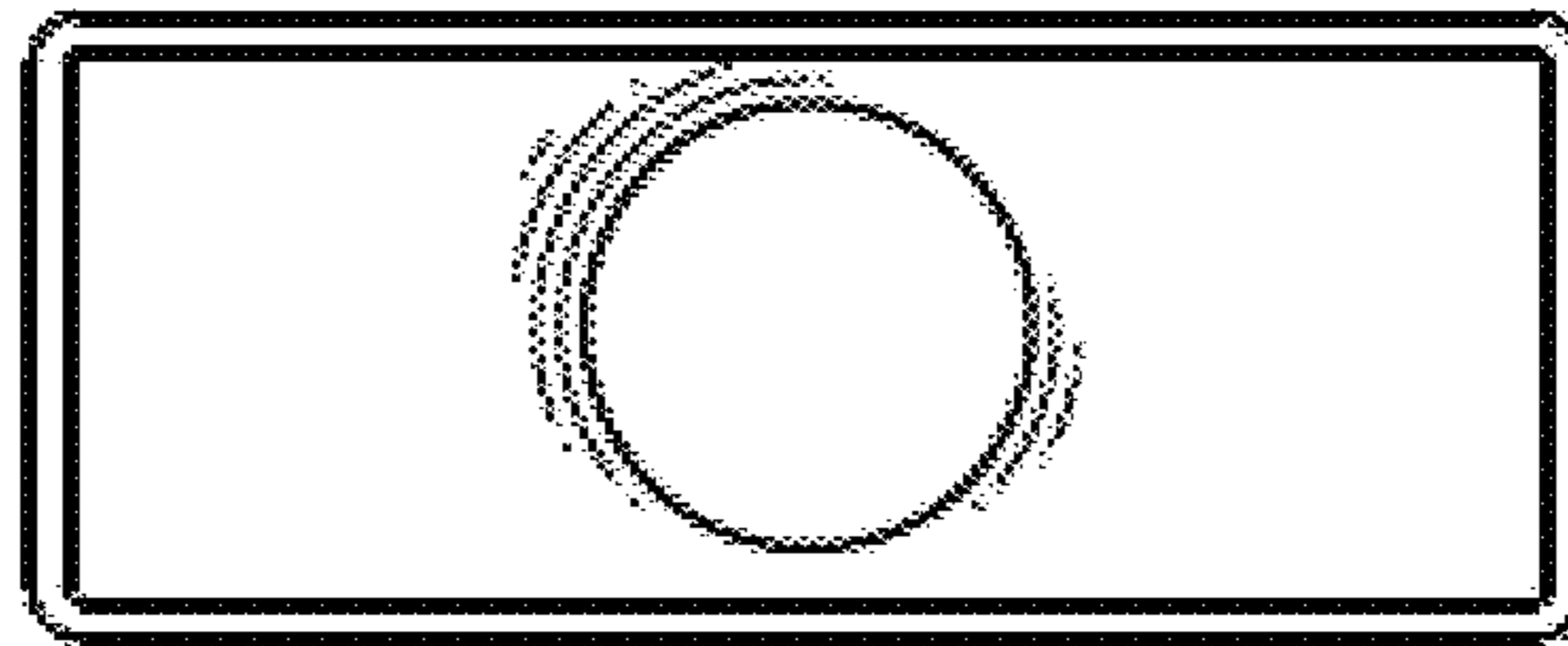
