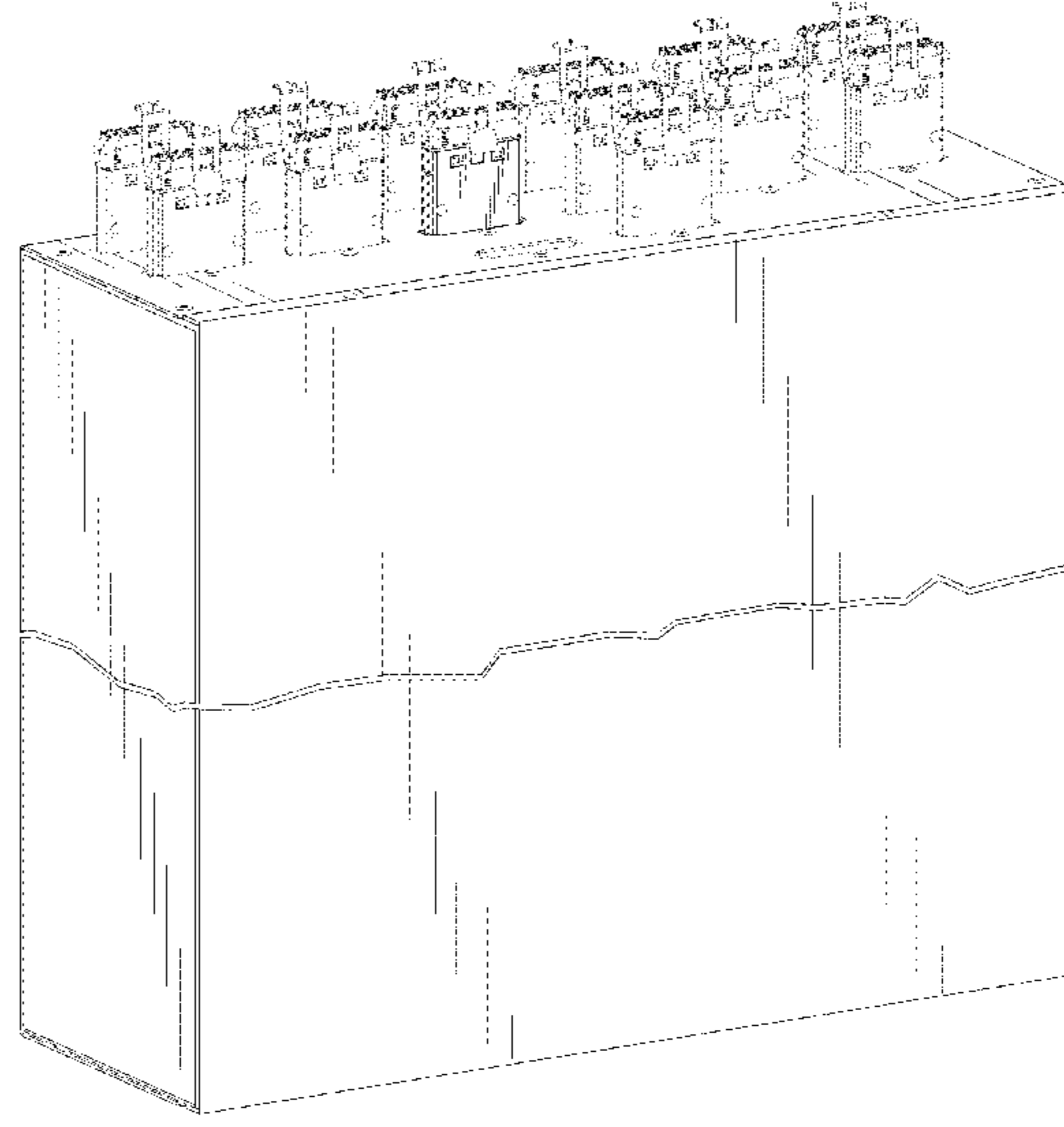
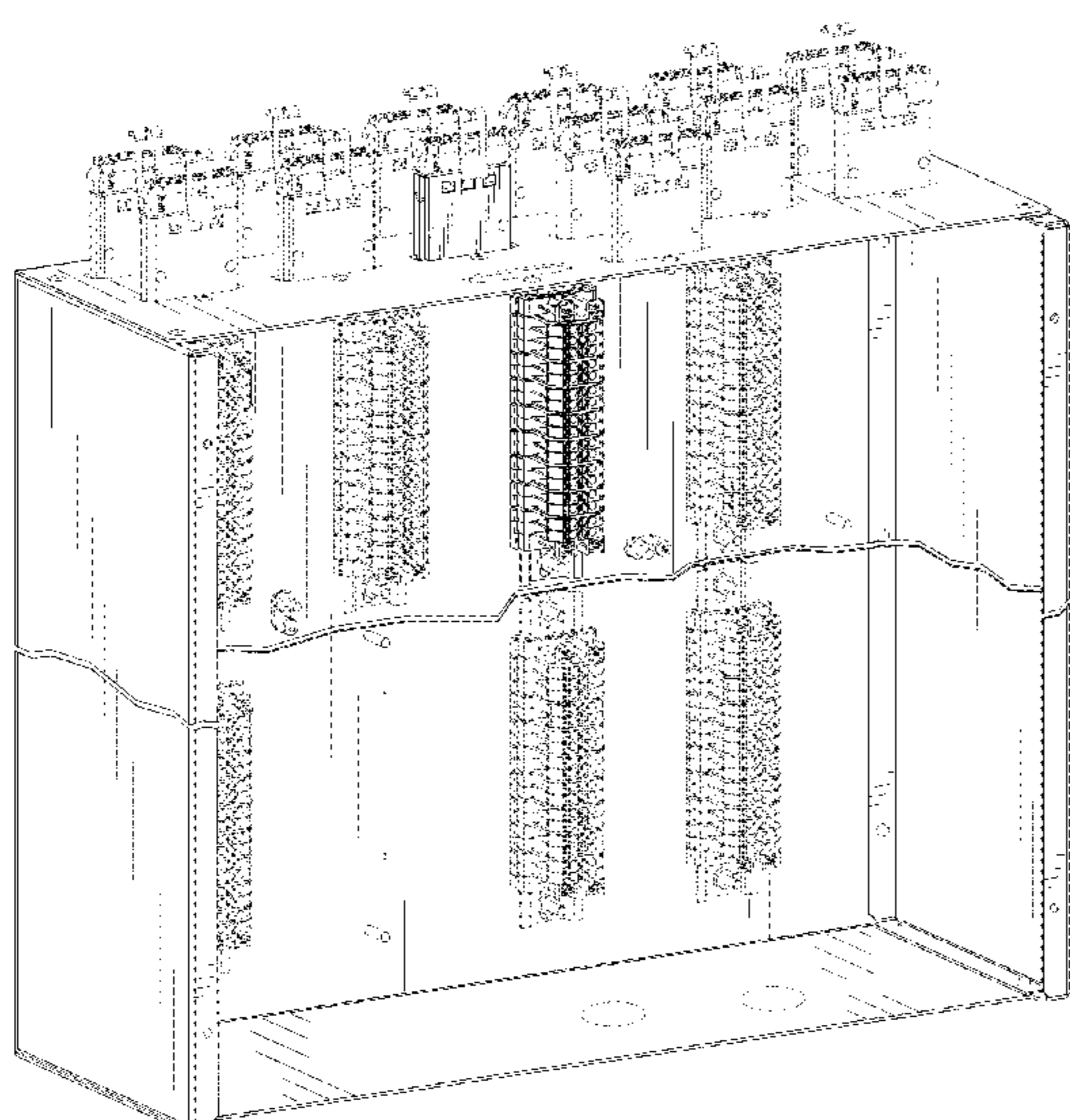
FIG. 1 is an exploded top, left, and front perspective view of

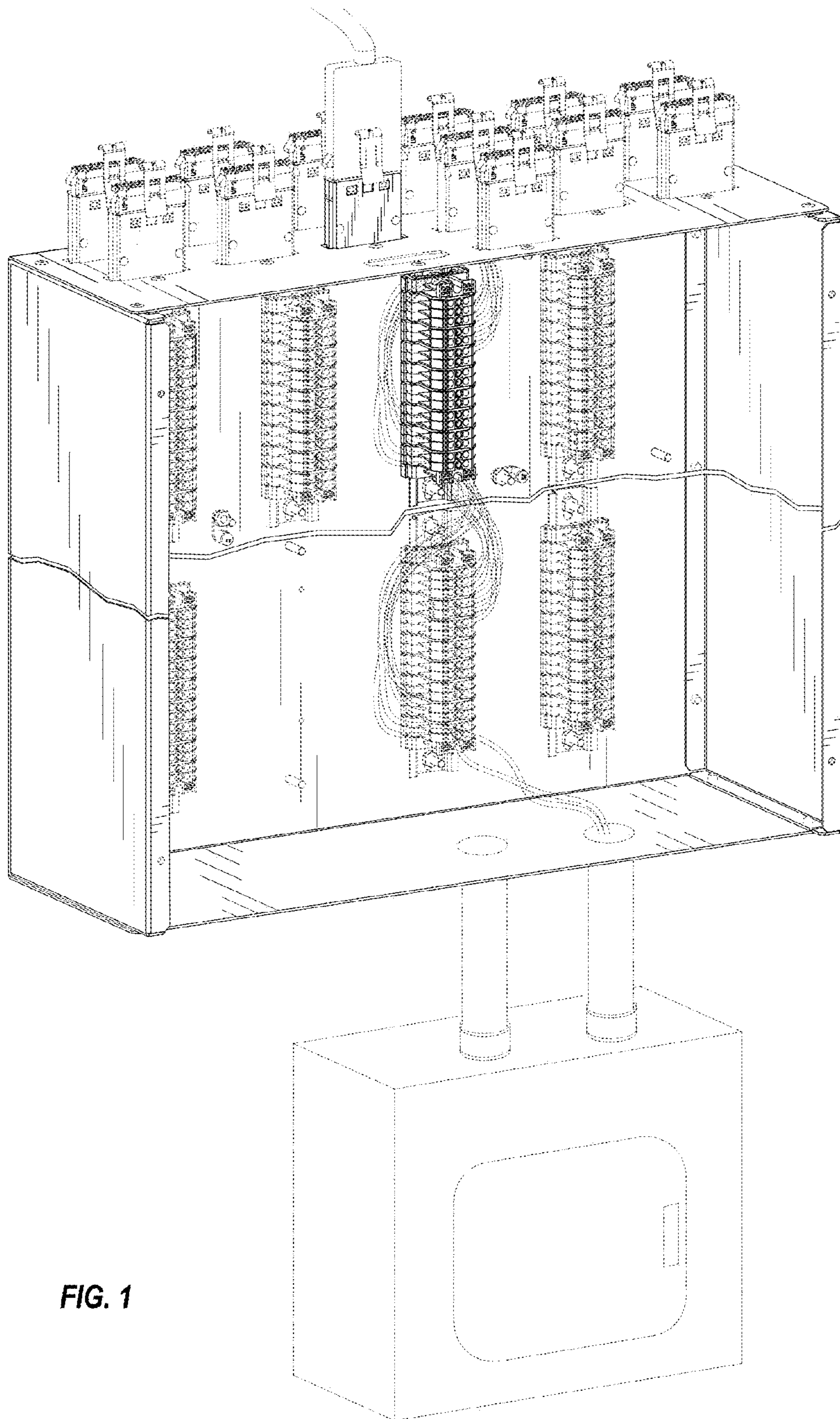

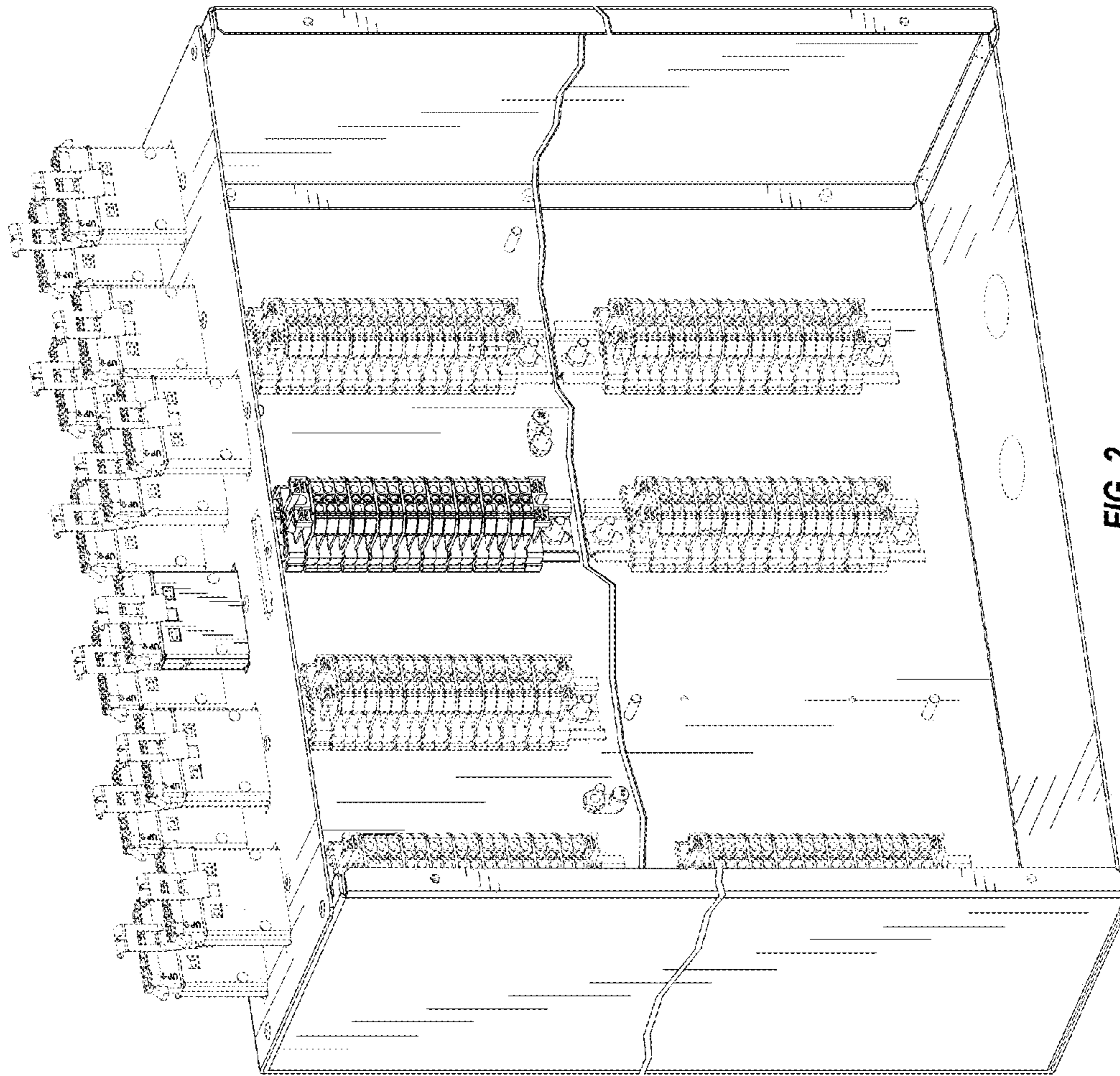

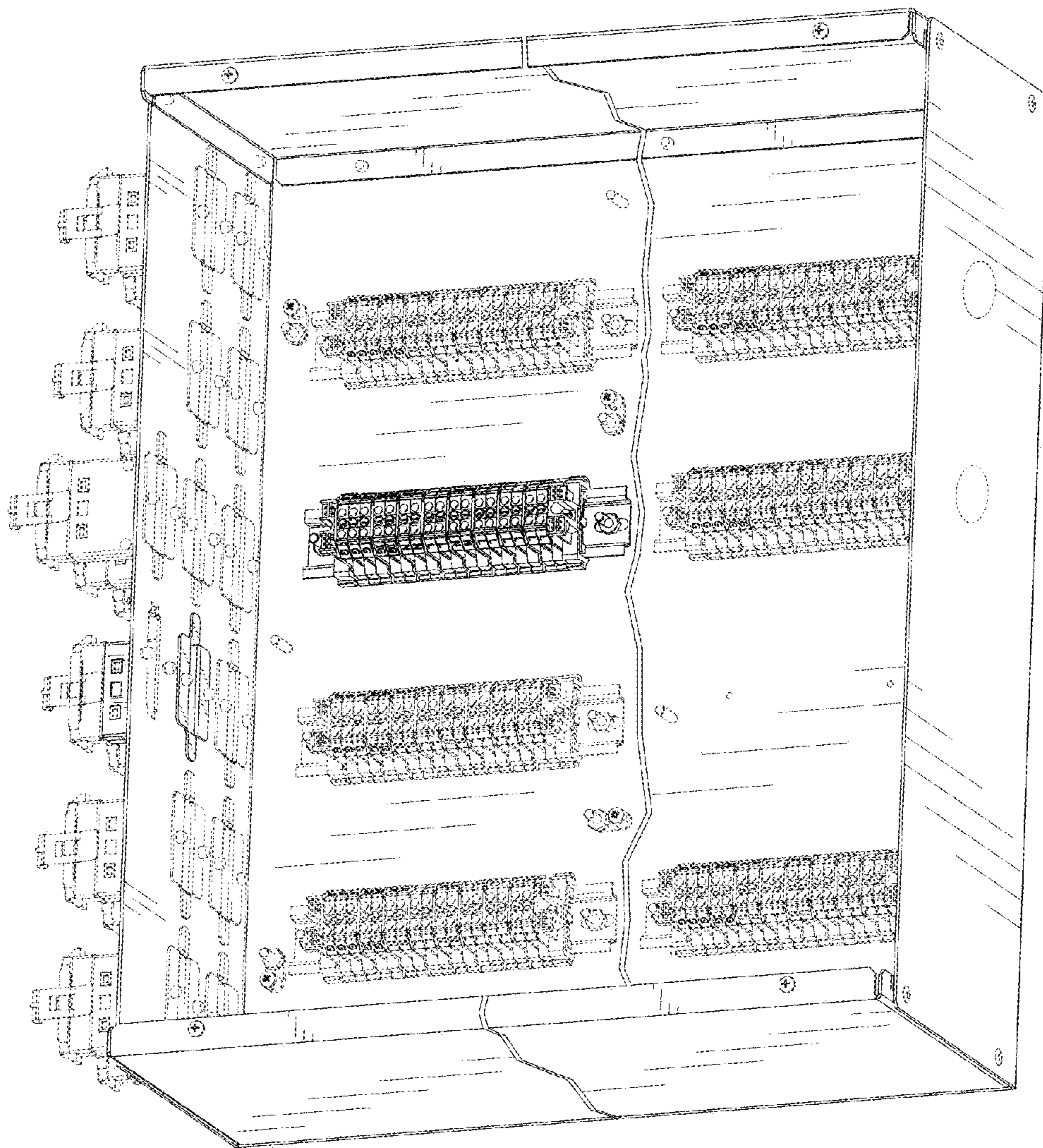

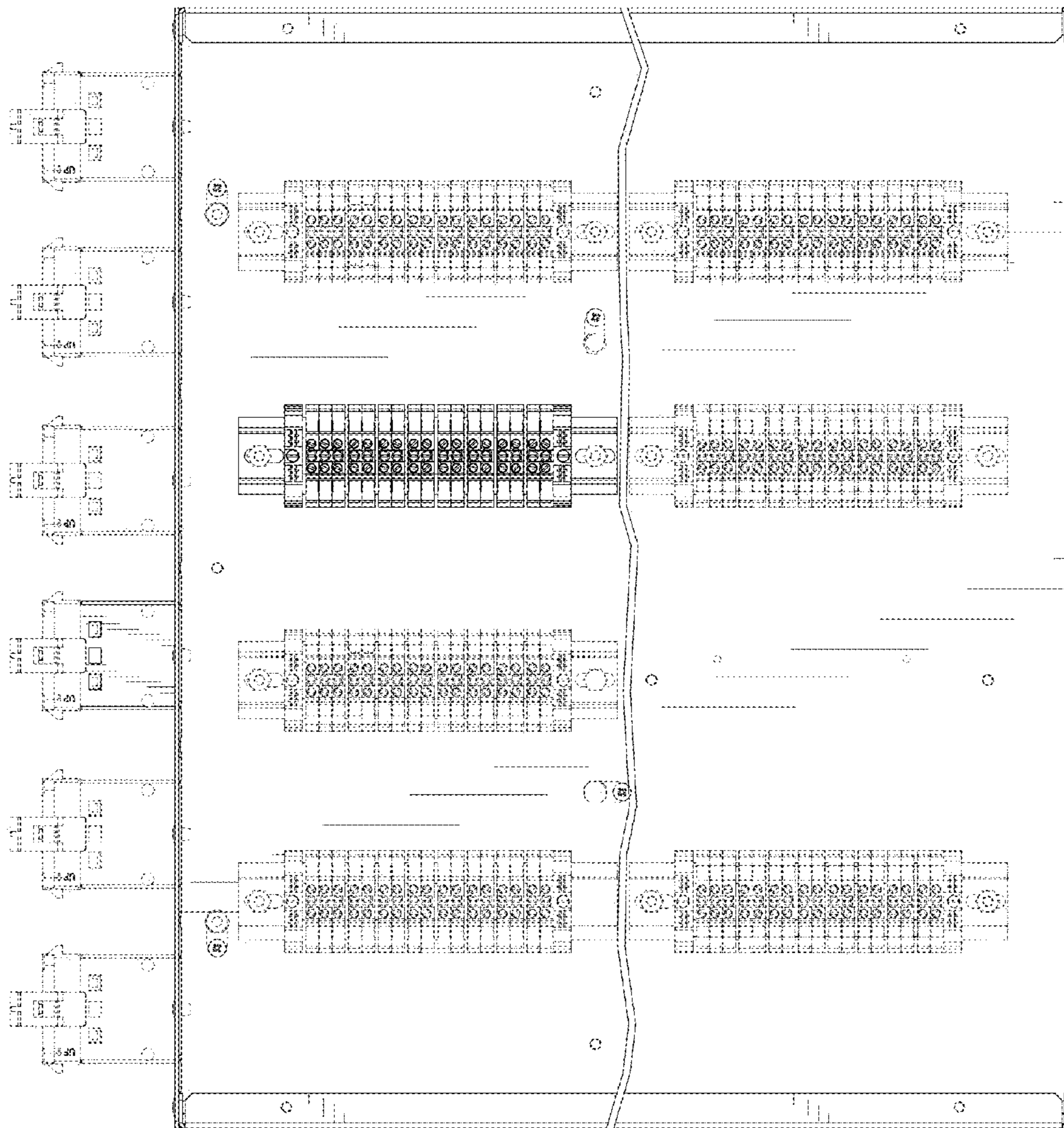

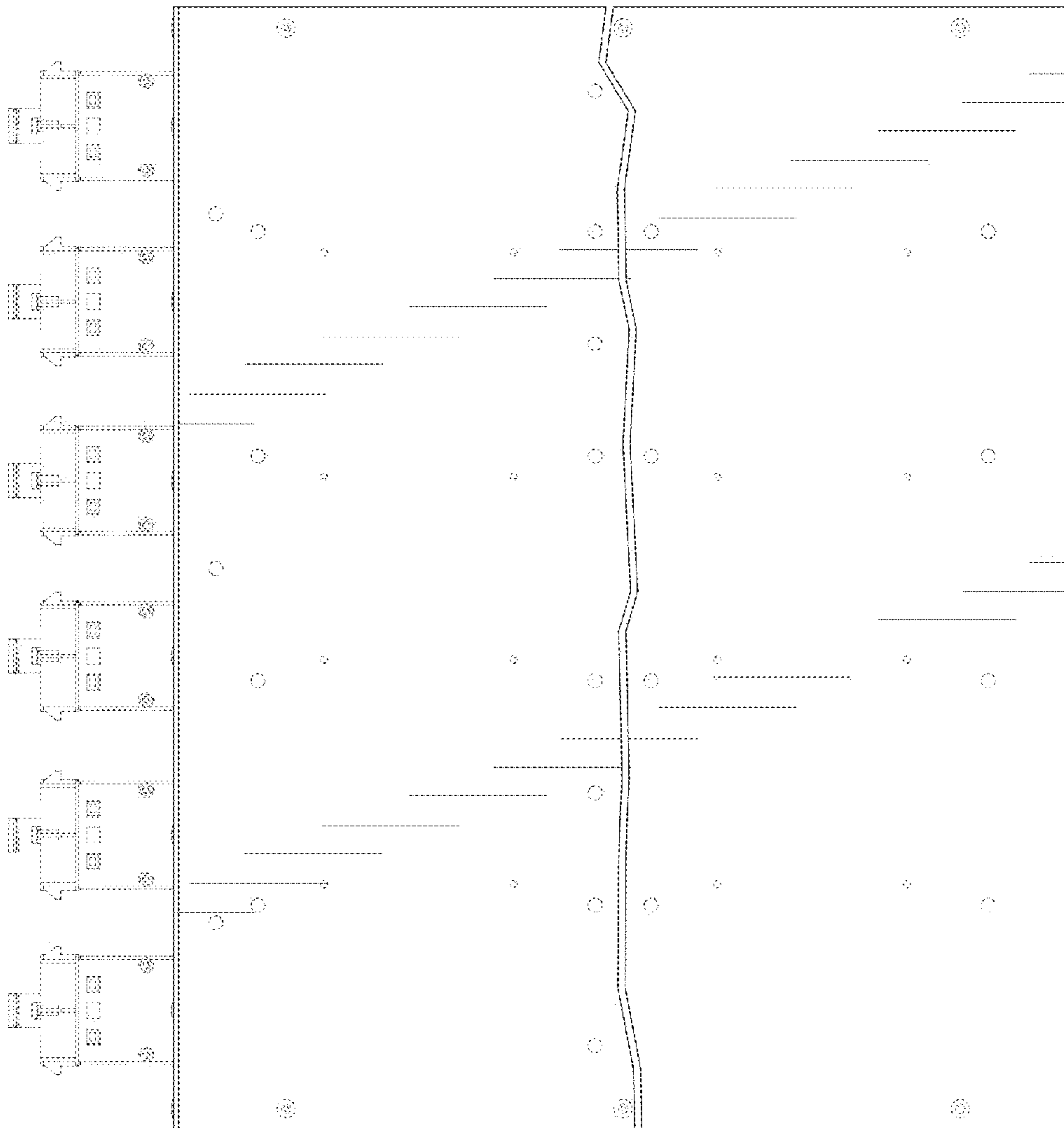

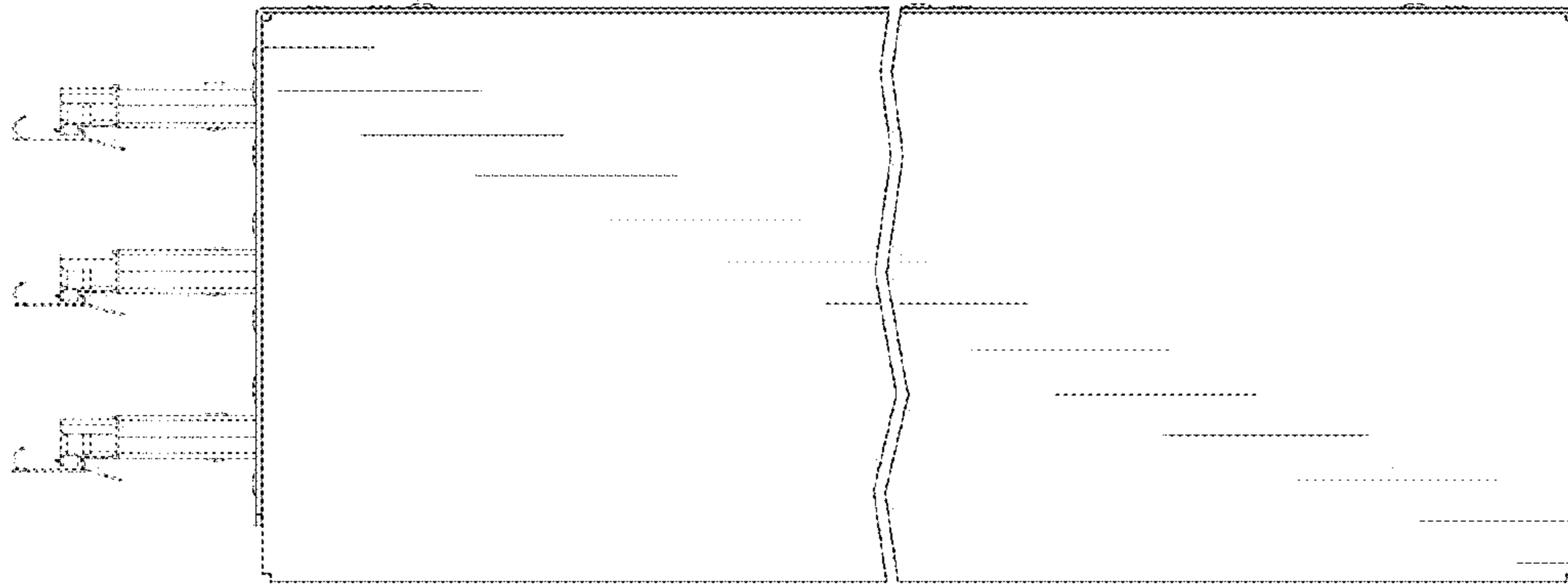

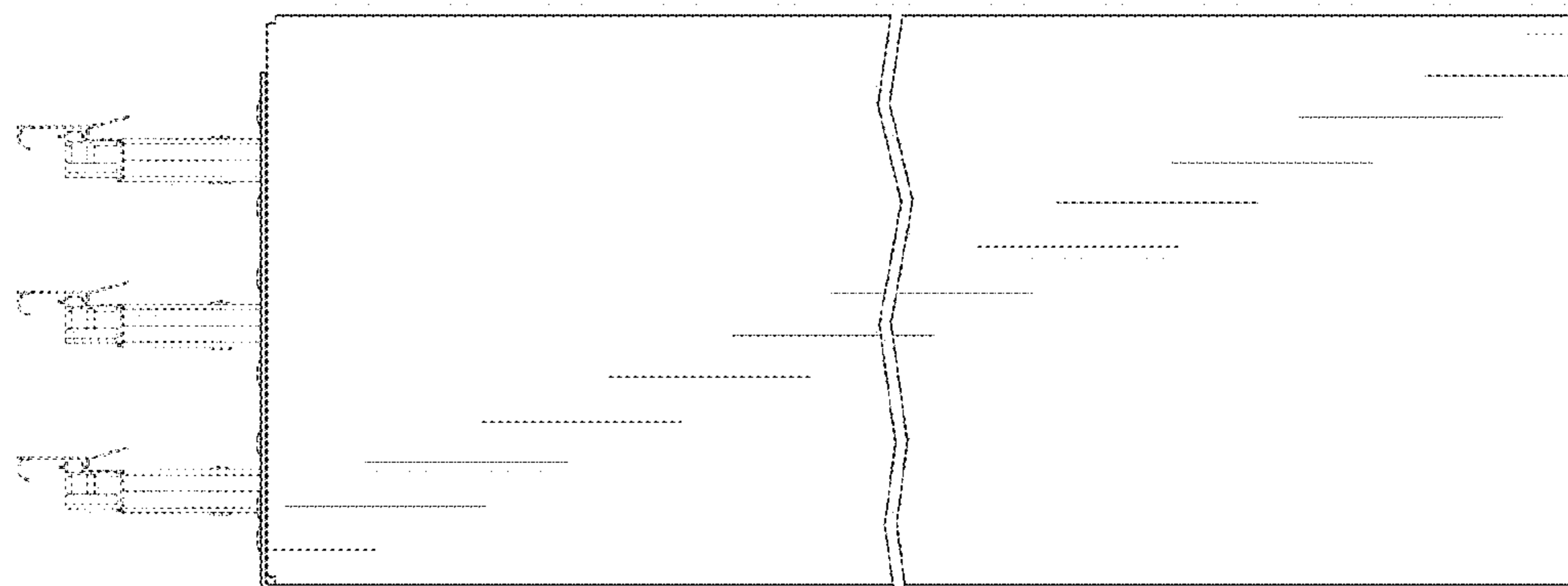

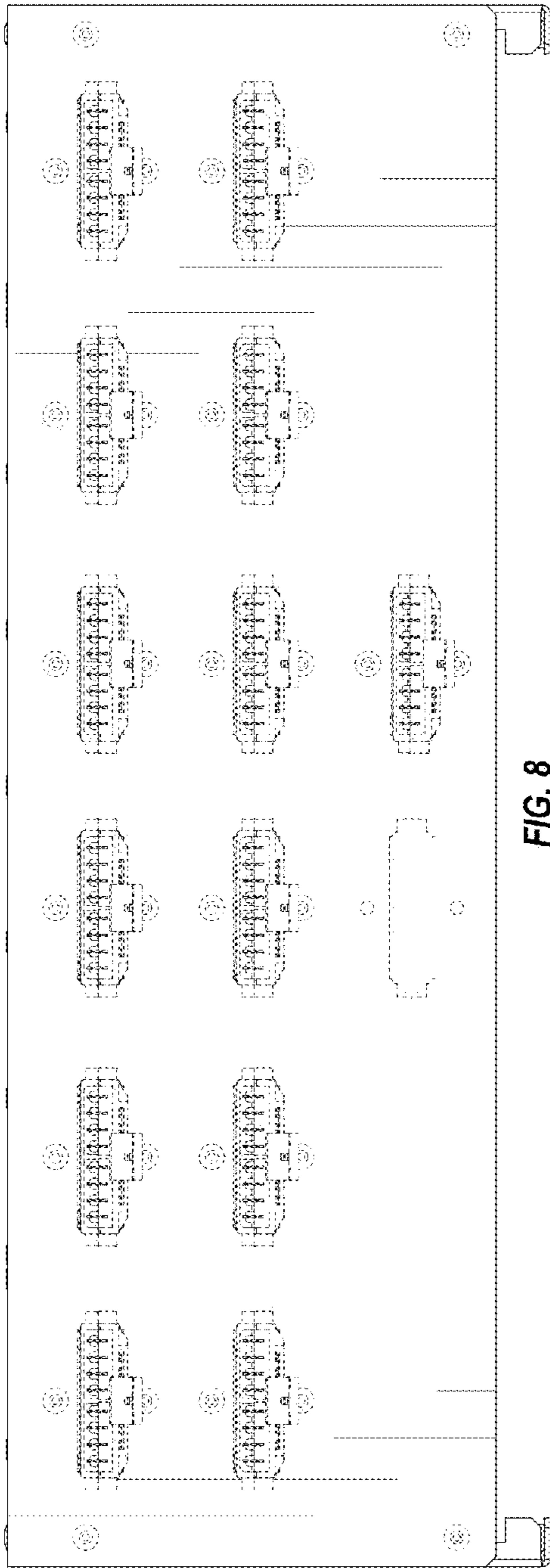

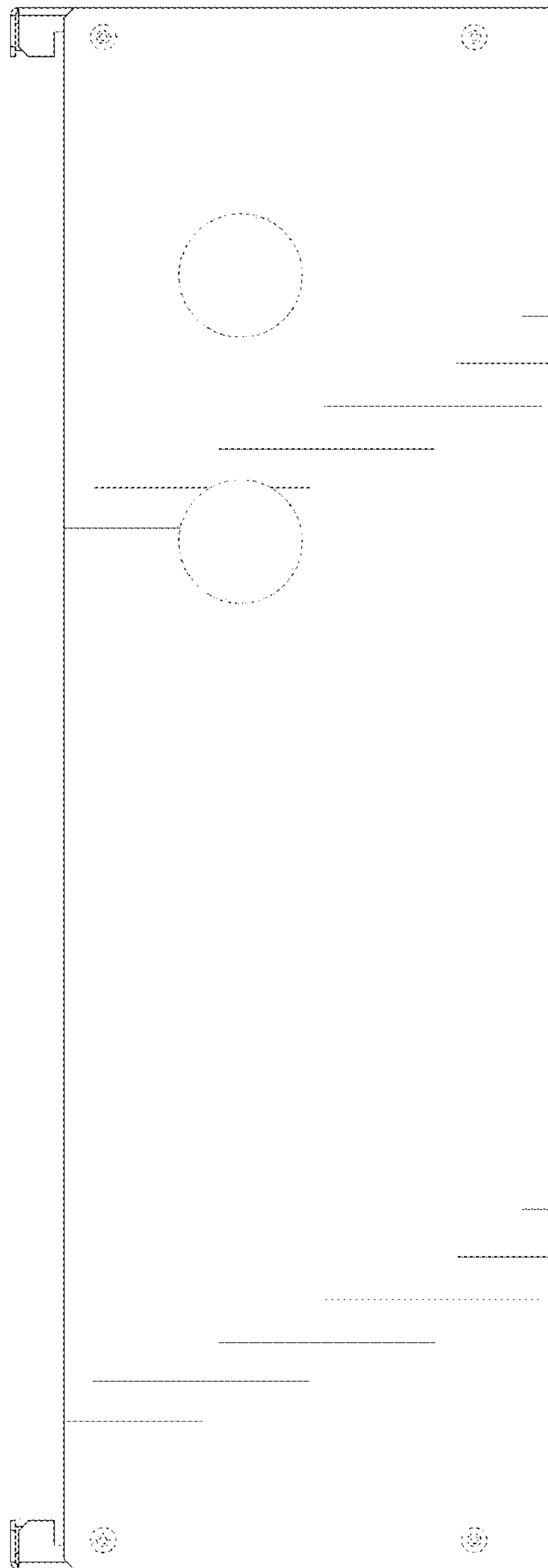

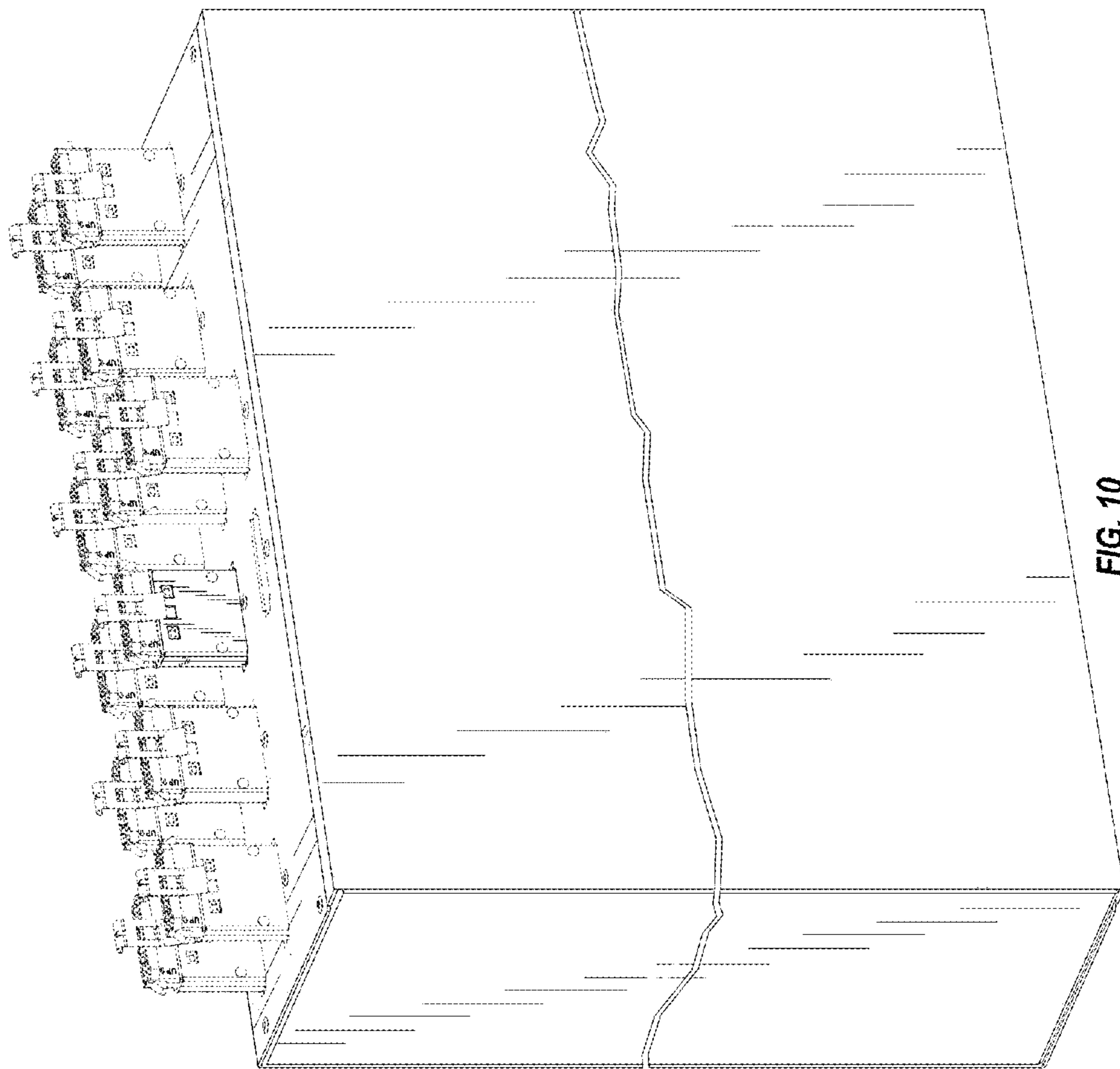

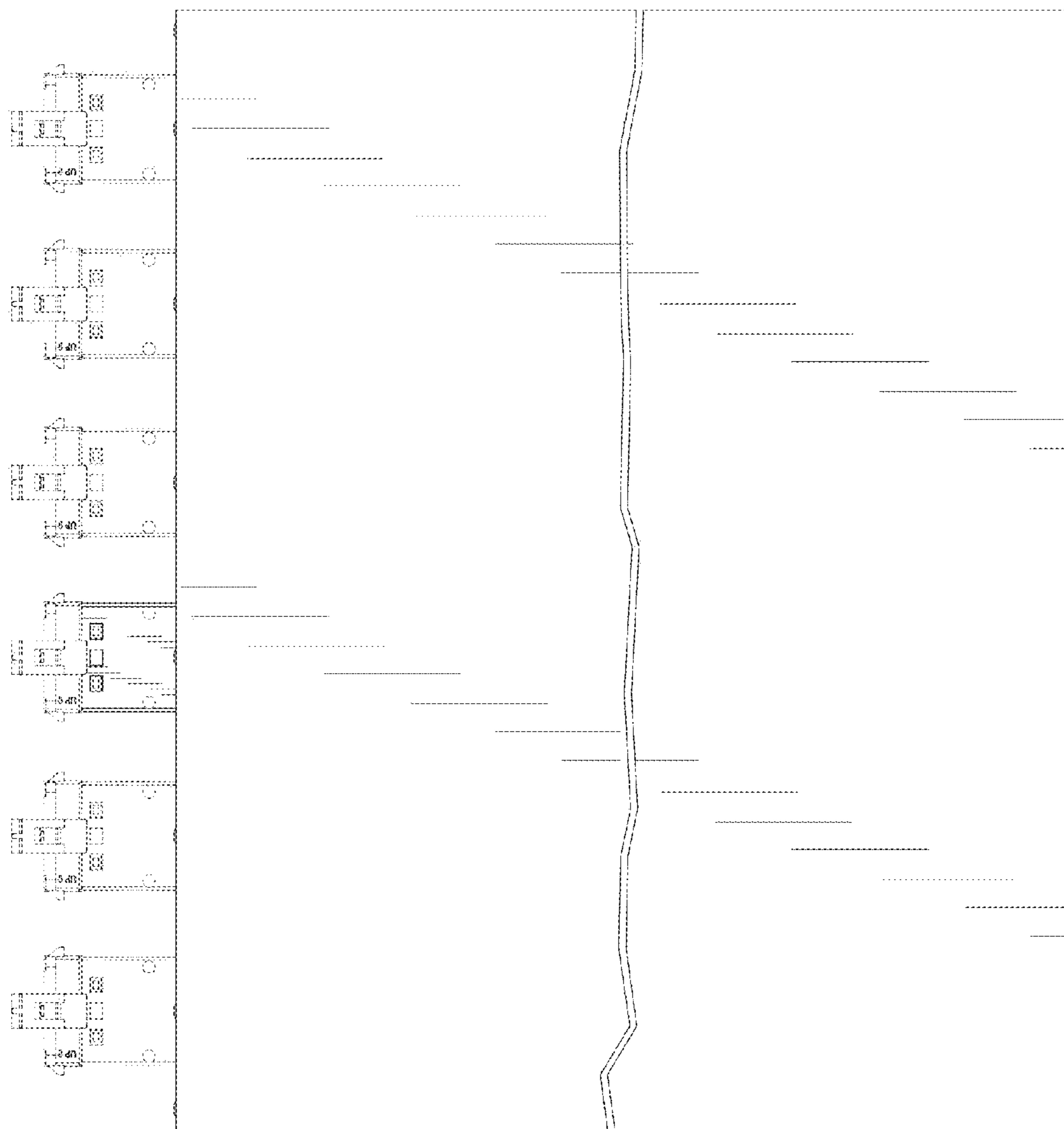

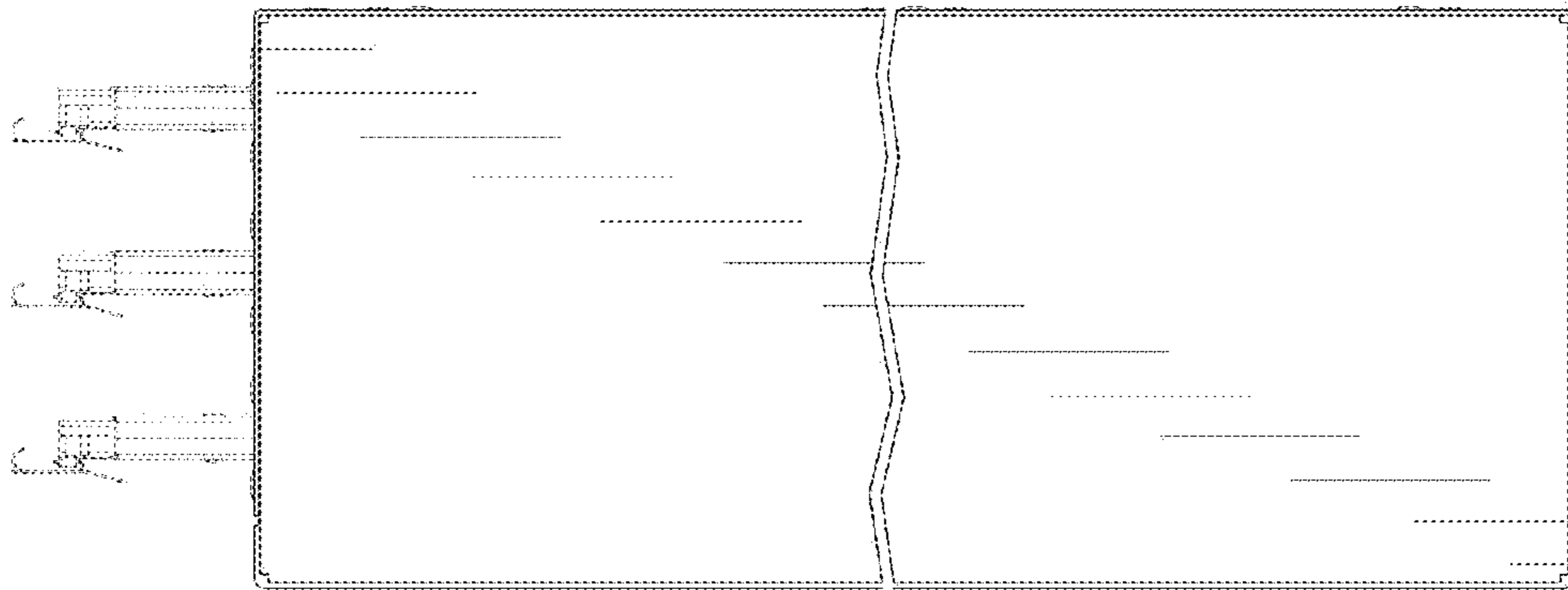

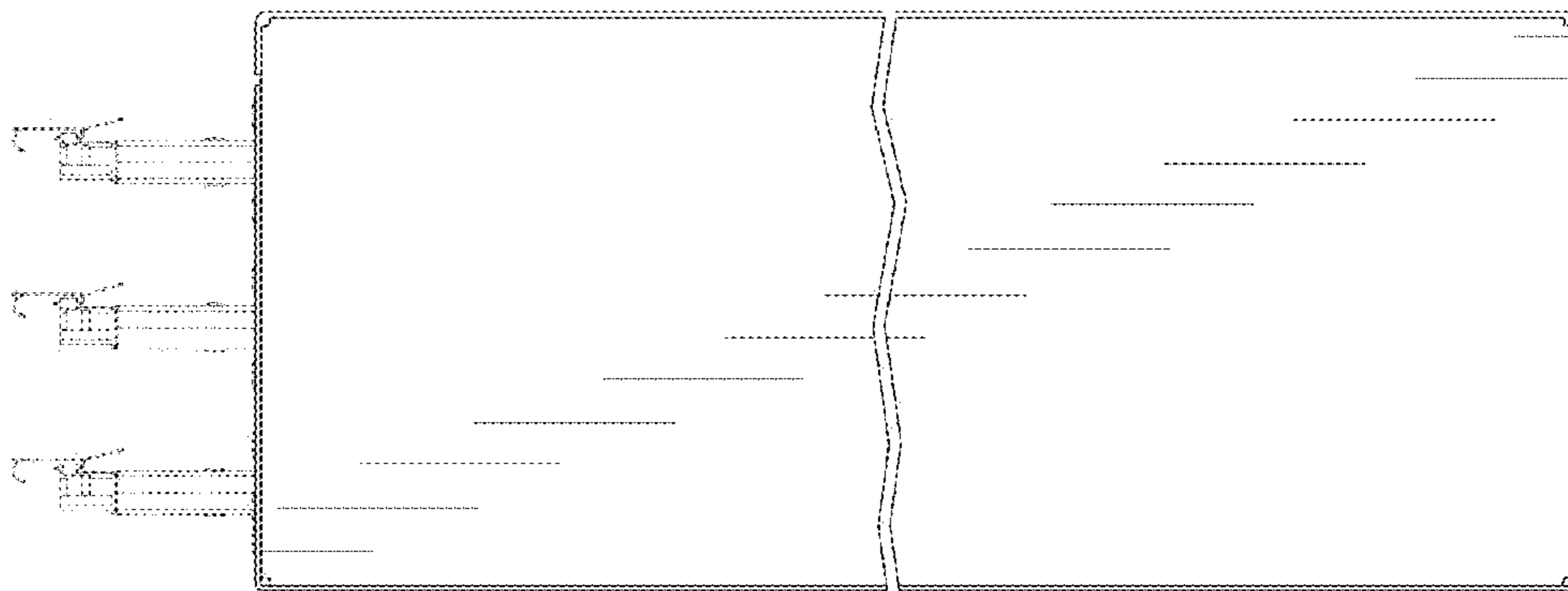

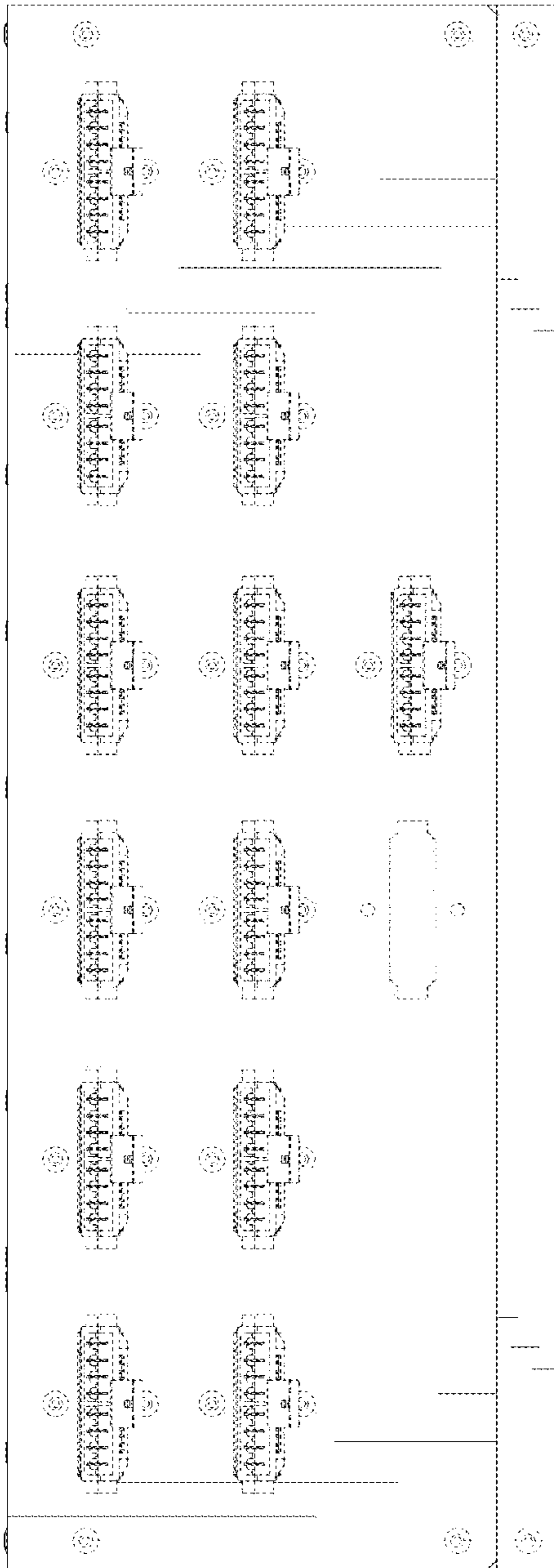

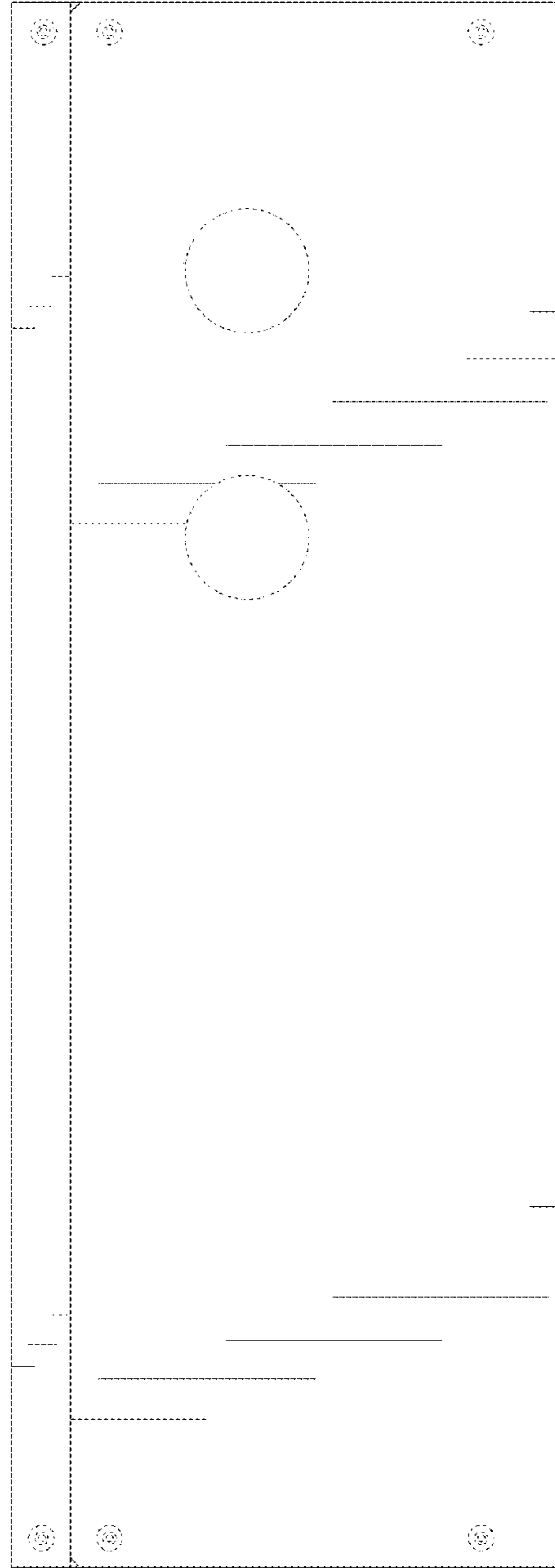
