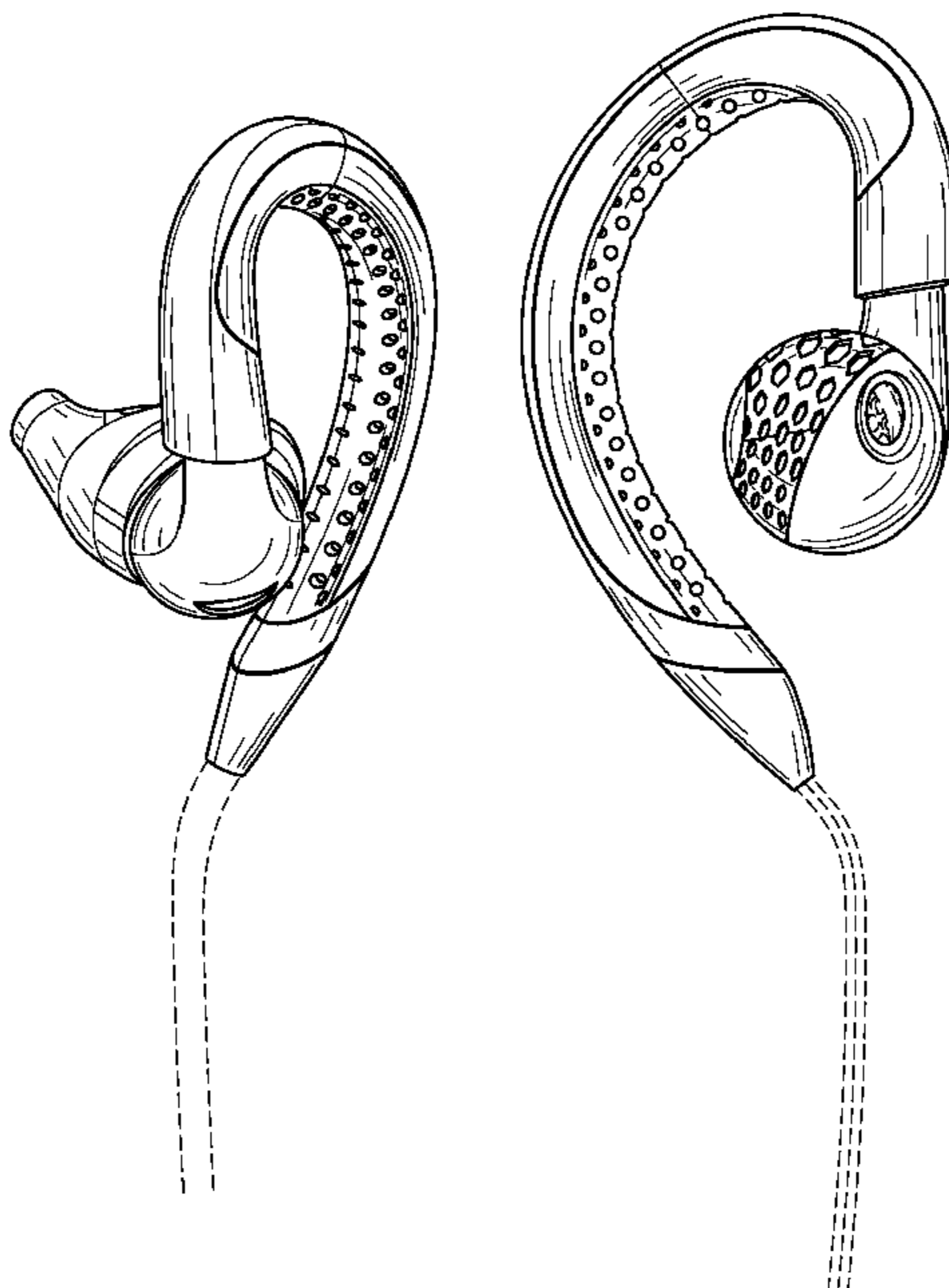
(57) **CLAIM**

The ornamental design for a behind the ear earphone with enhancer, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the behind the ear earphone with enhancer;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left-side elevation view thereof;
FIG. 6 is a right-side elevation view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.
The dashed lines show a wire extending to the earphone, but do not form a part of the claimed design.

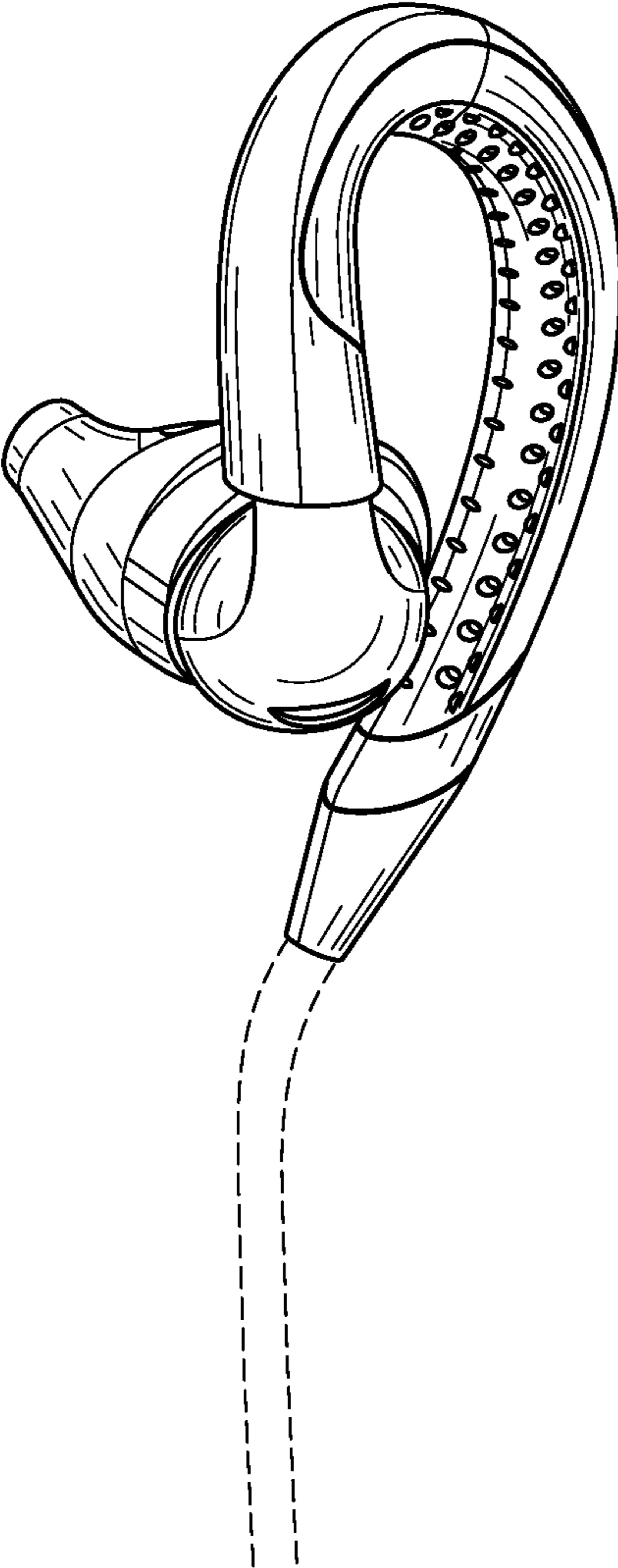

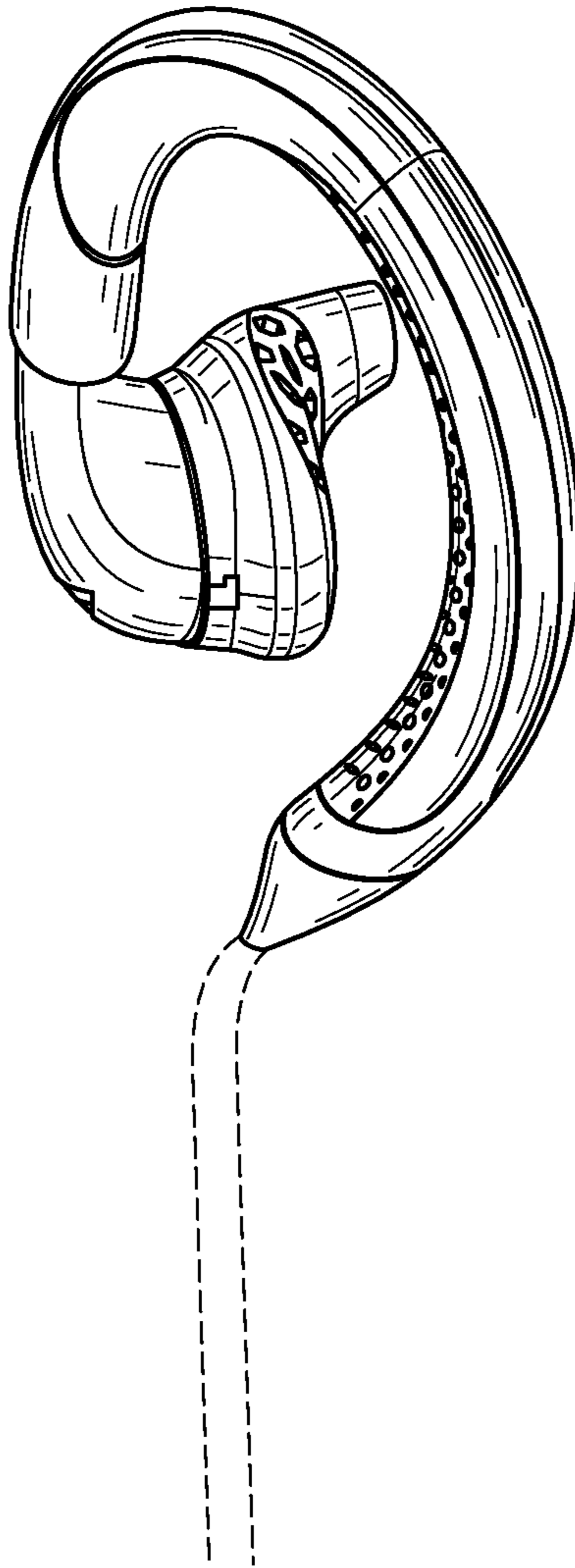

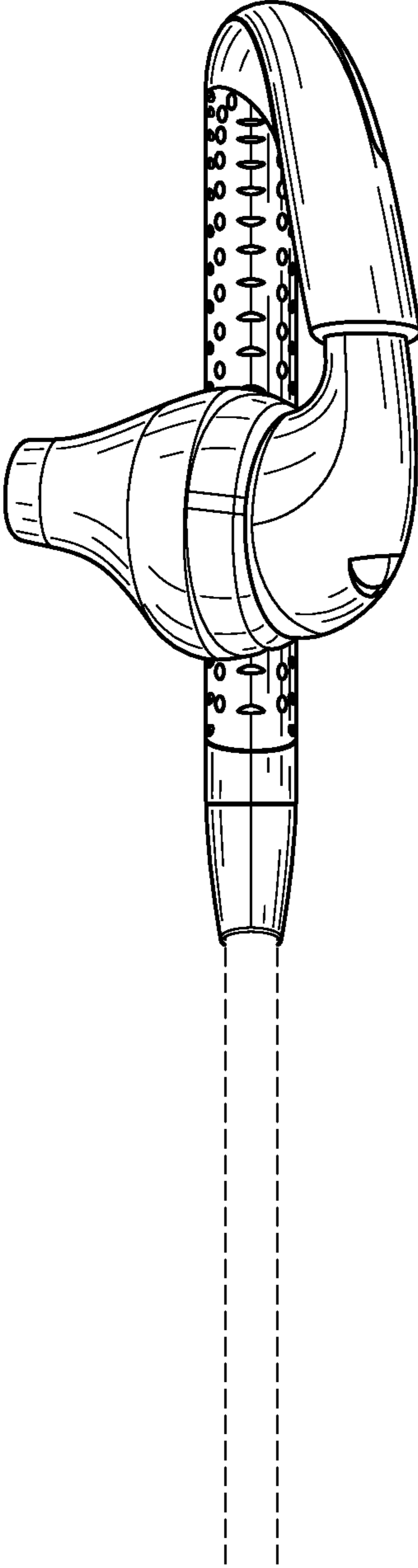

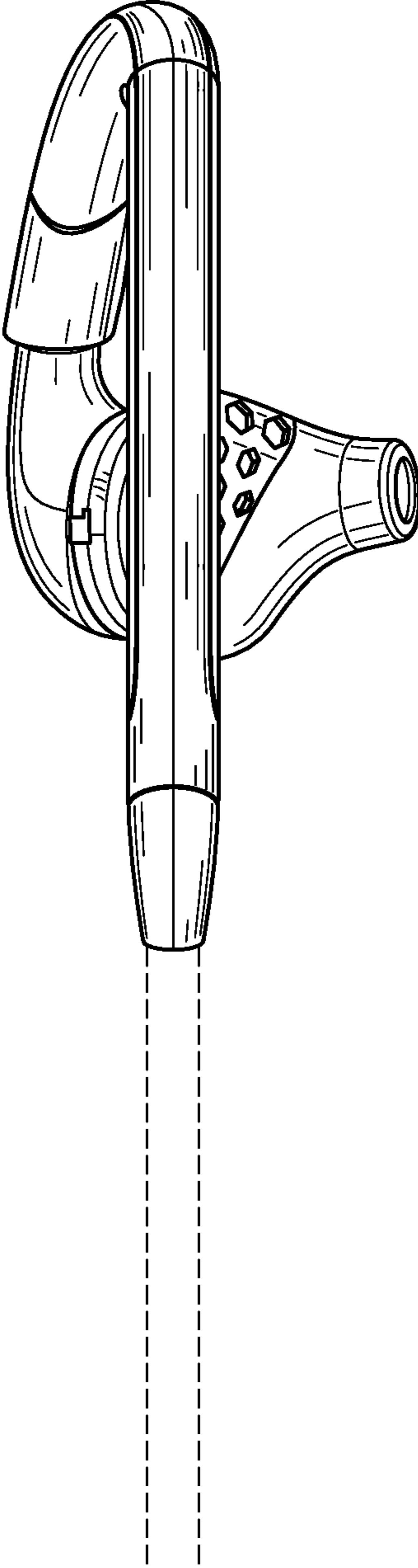

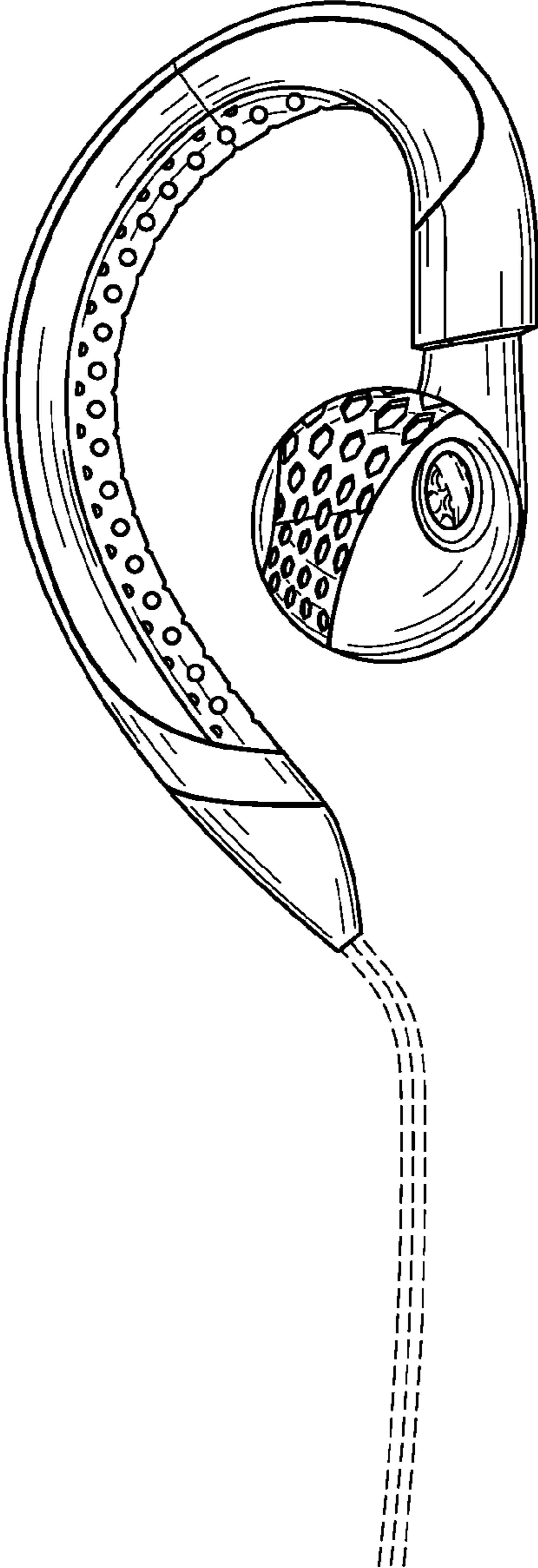

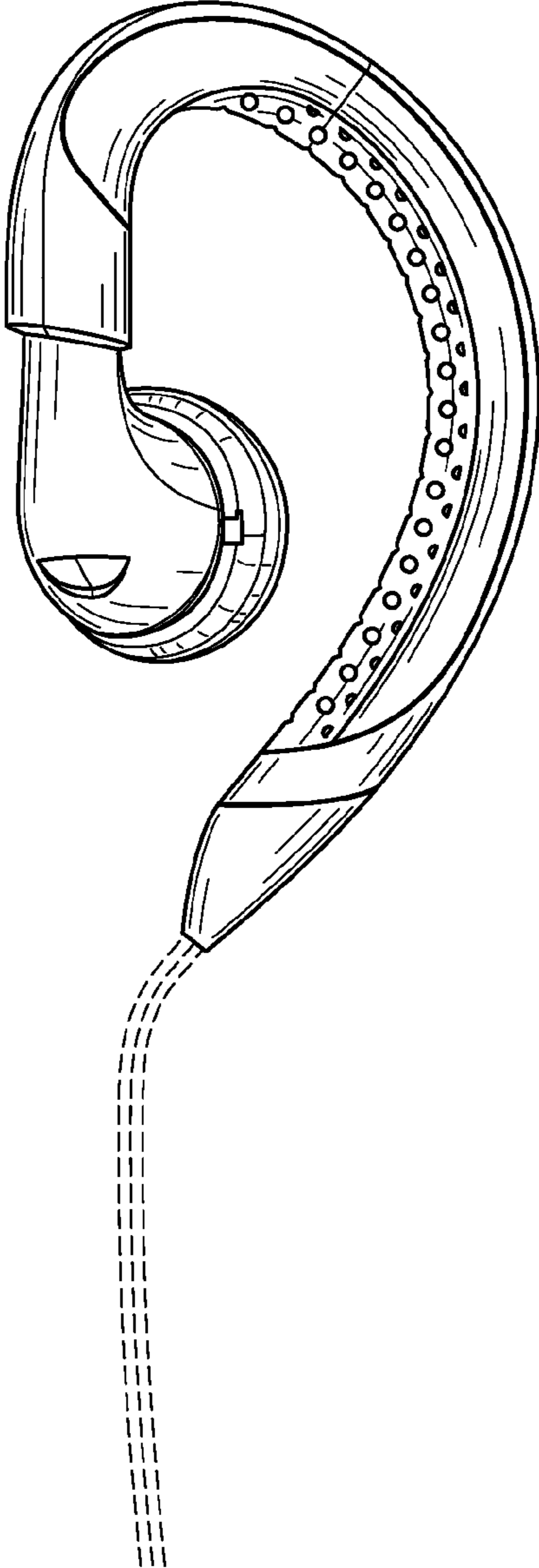

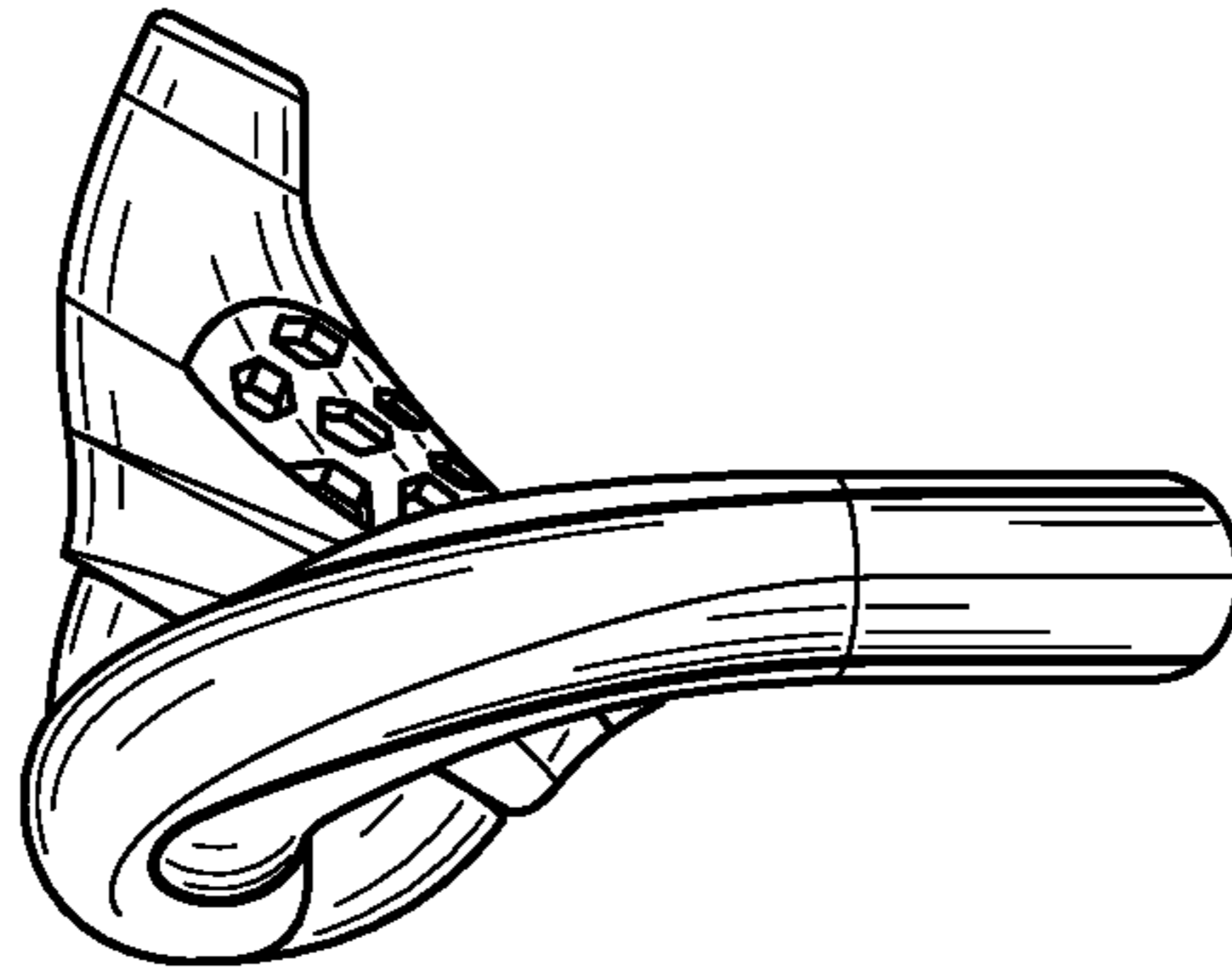

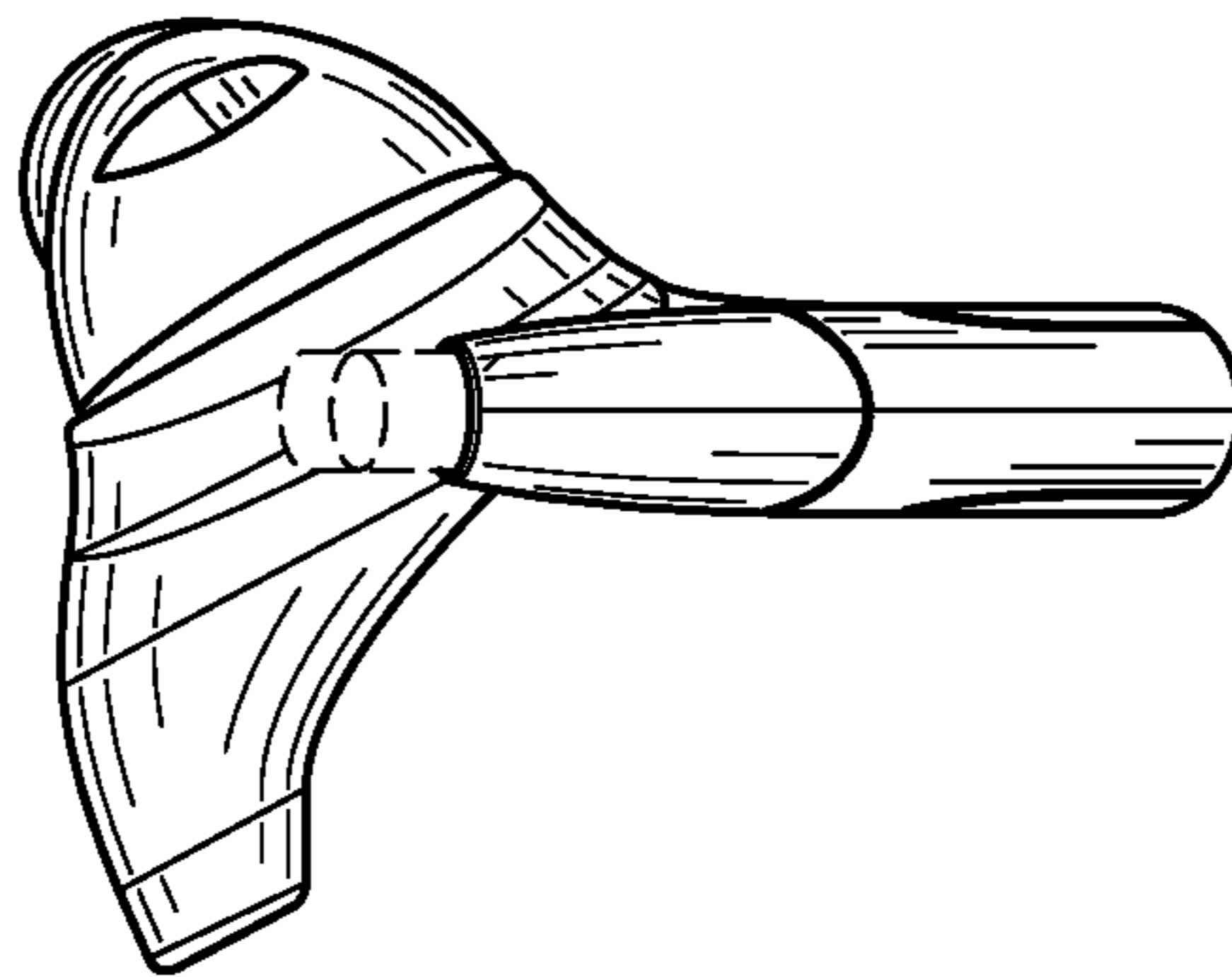
